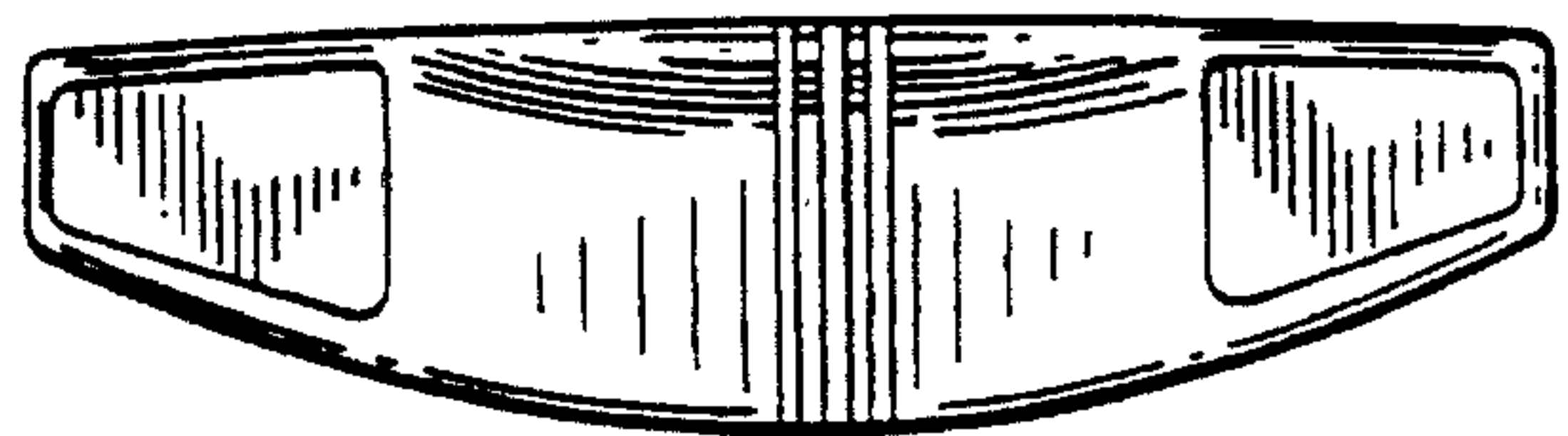
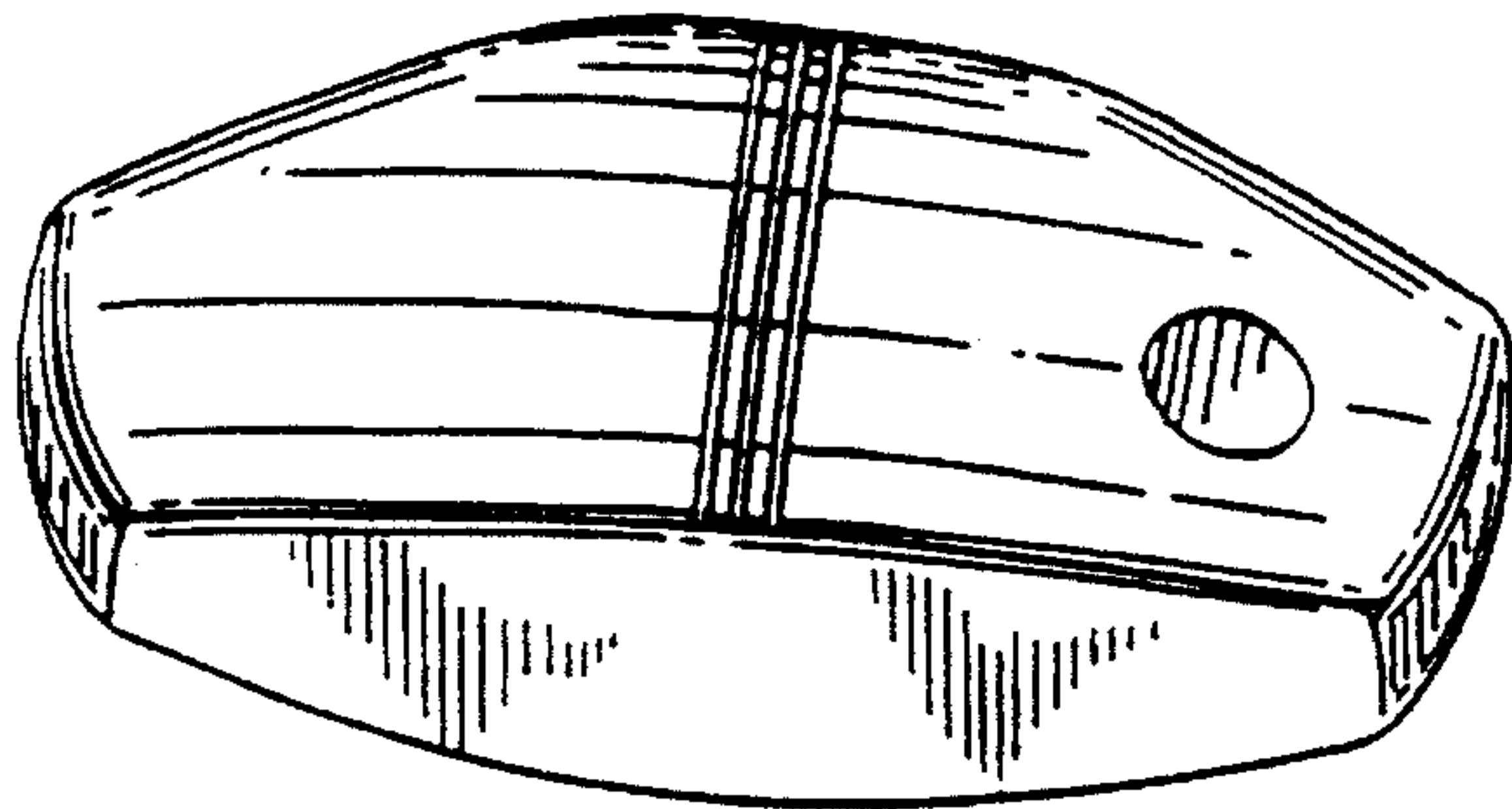
[57] **CLAIM**

The ornamental design for a golf putter head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf putter head showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a perspective view thereof, shown for a left handed person;  
FIG. 4 is a top plan view of FIG. 3;  
FIG. 5 is a front elevation of FIG. 1;  
FIG. 6 is a right side elevational view thereof, the undisclosed opposite side being a mirror image;  
FIG. 7 is a bottom plan view of FIG. 1;  
FIG. 8 is a rear elevational view of FIG. 1; and,  
FIG. 9 is a cross section taken on line 9—9 of FIG. 7.

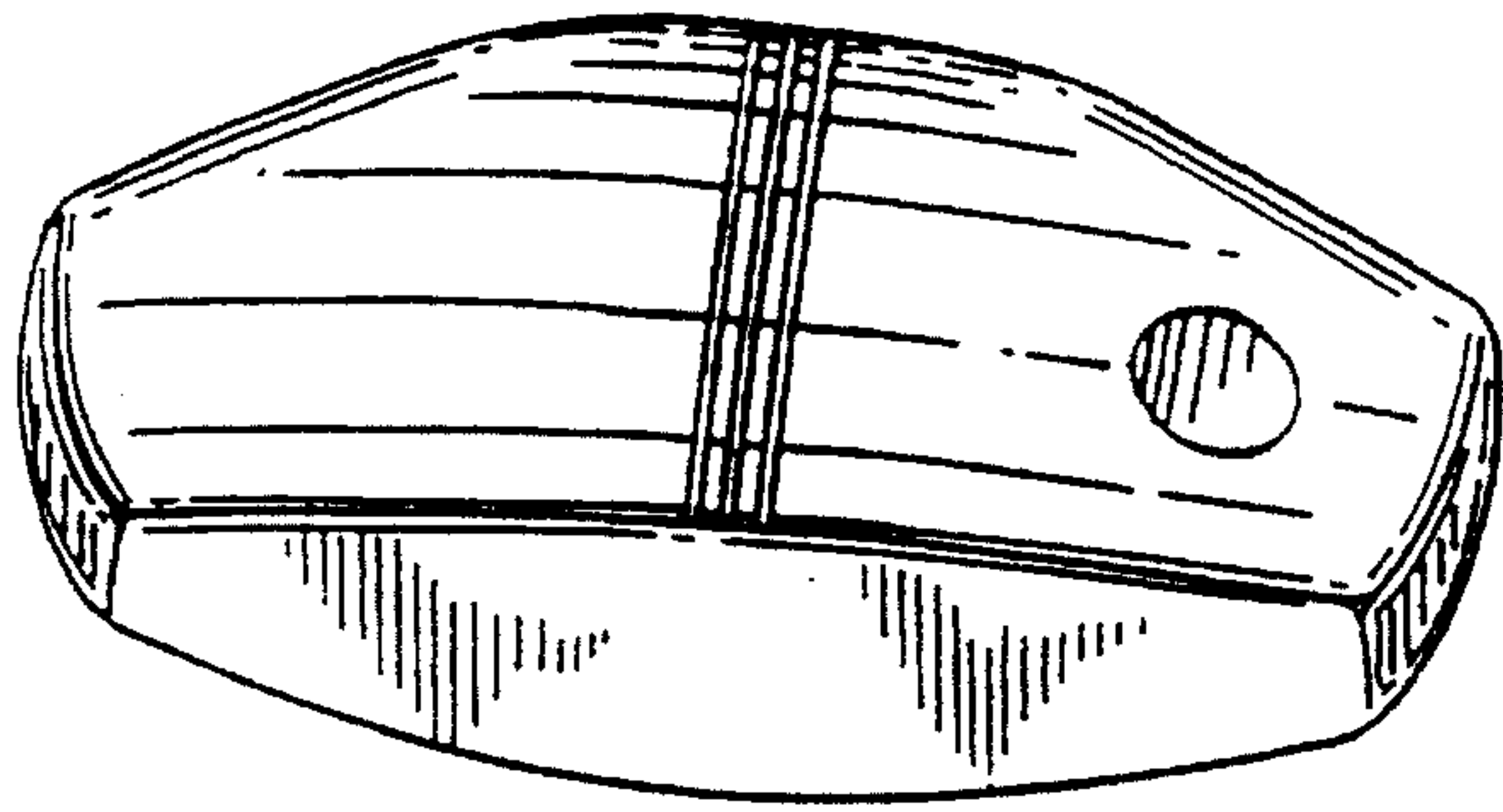

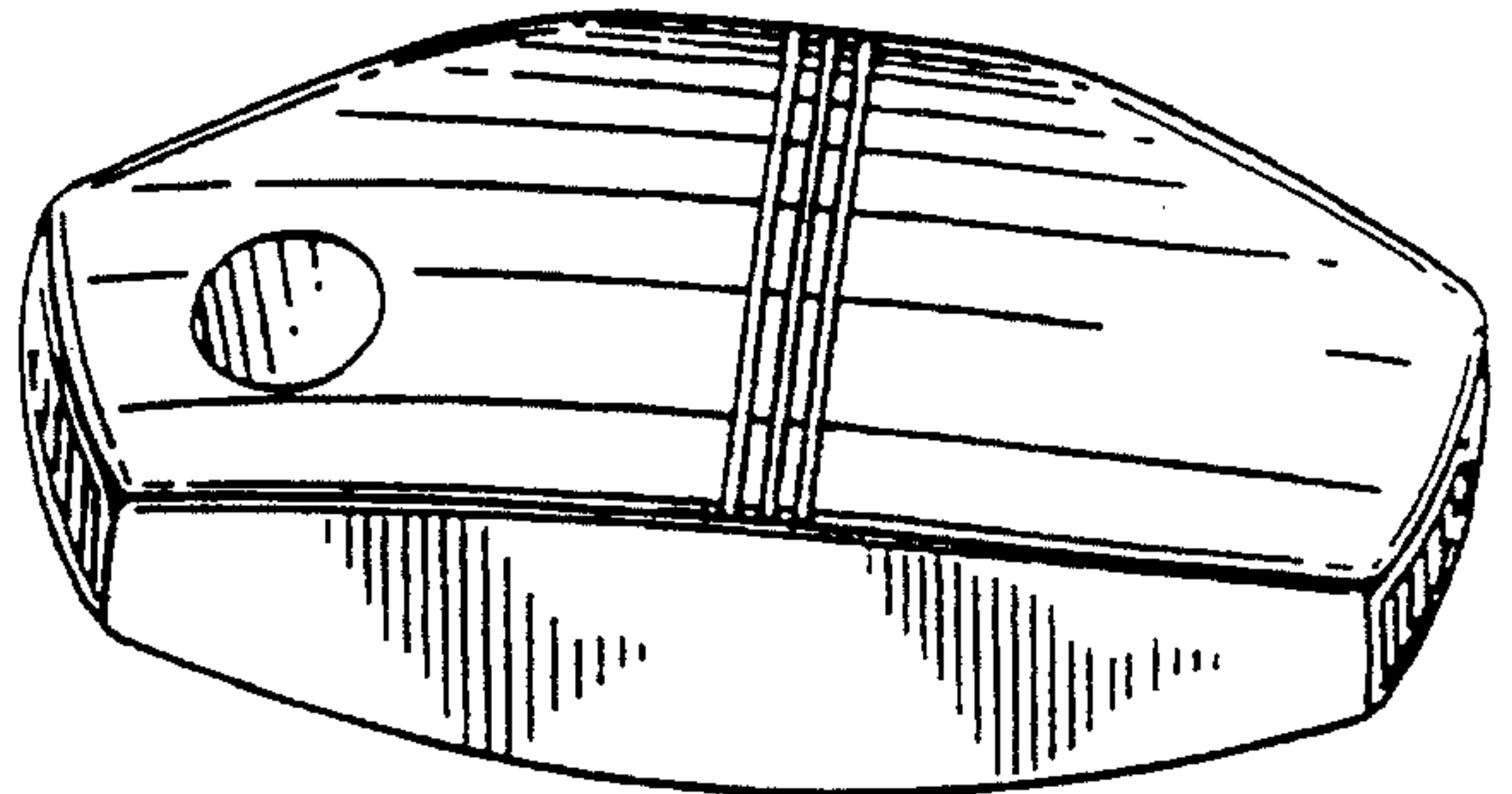

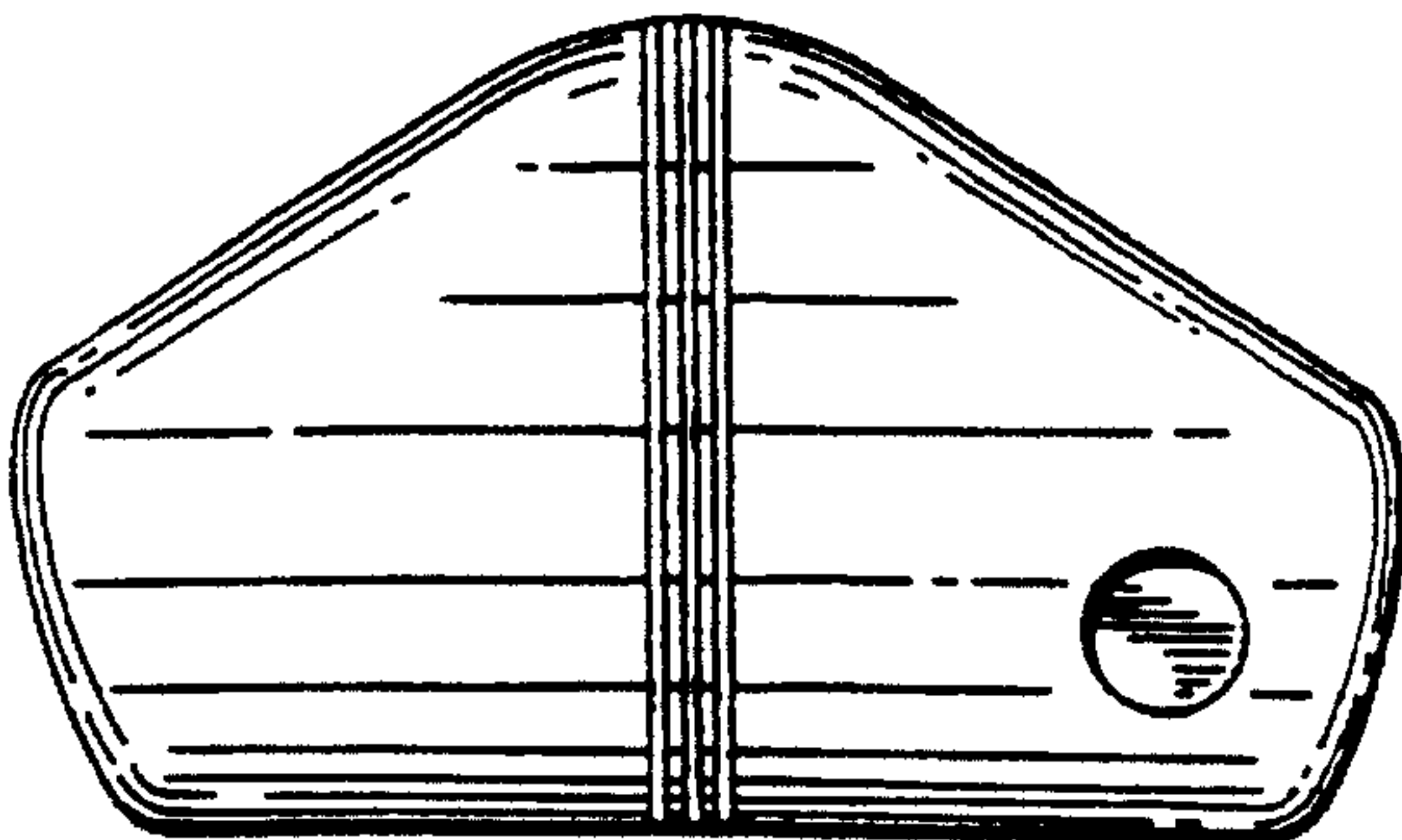

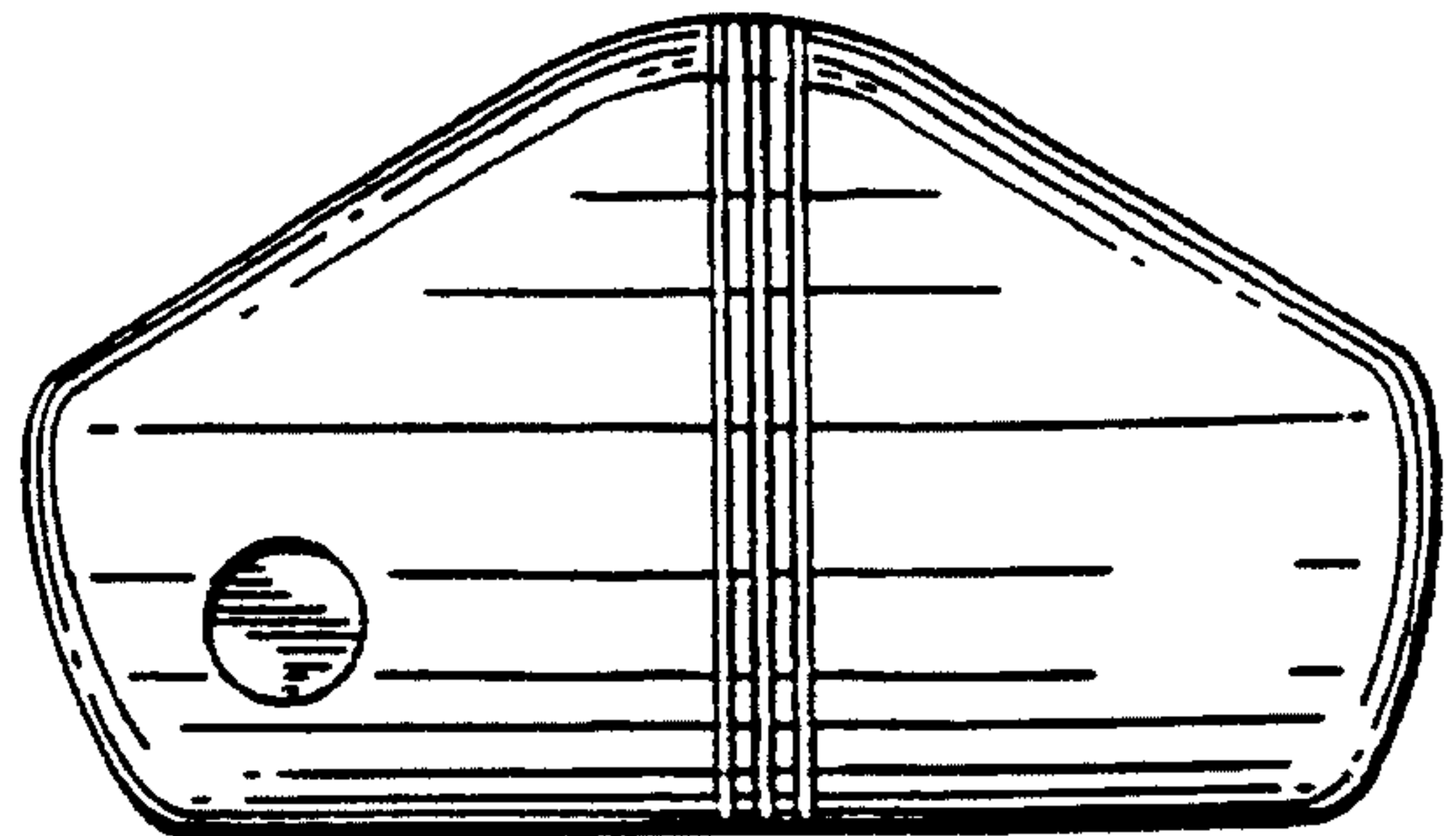

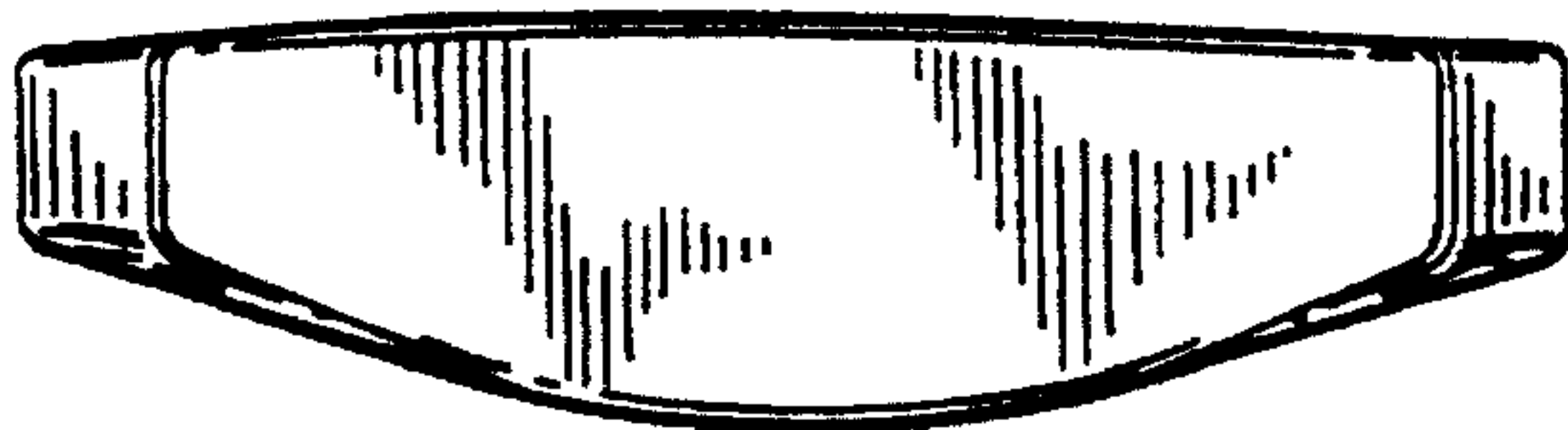

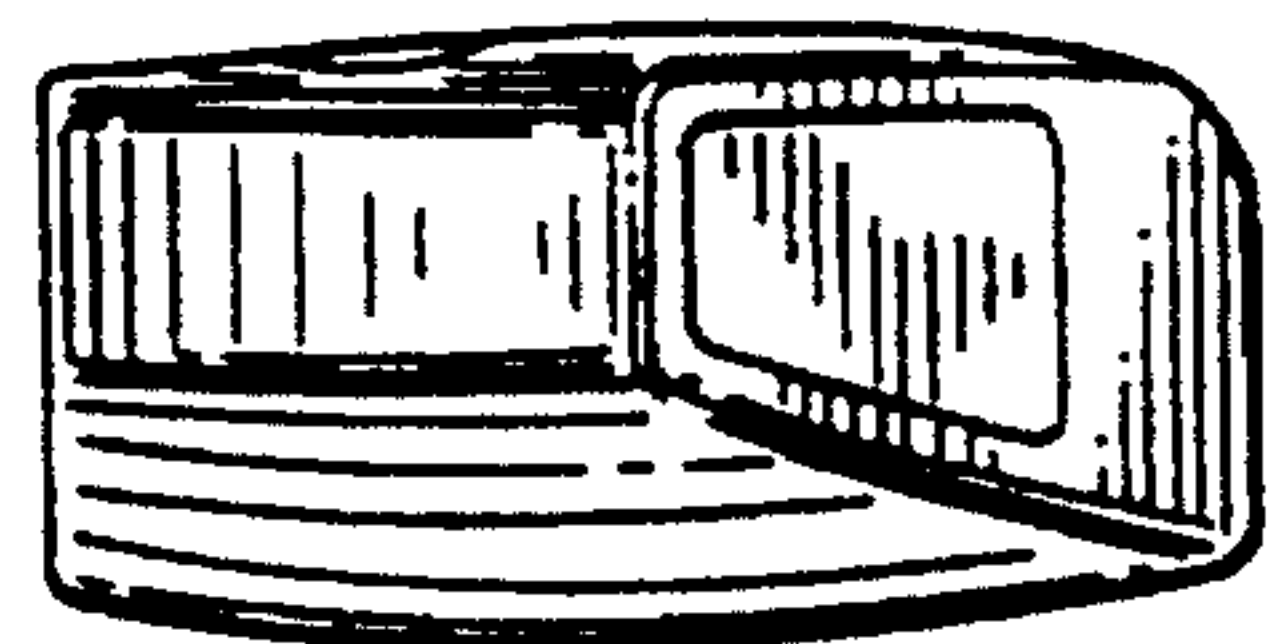

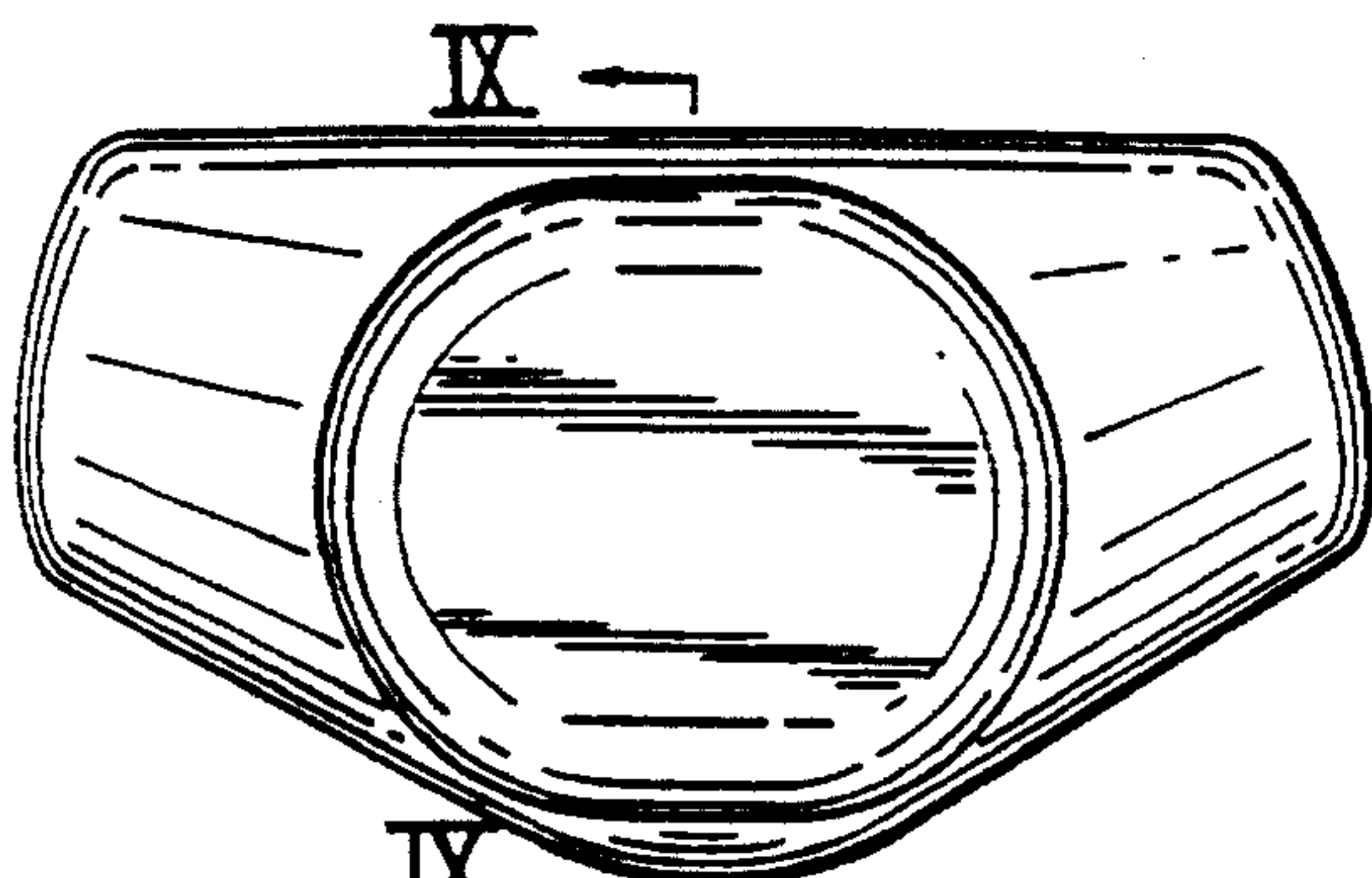

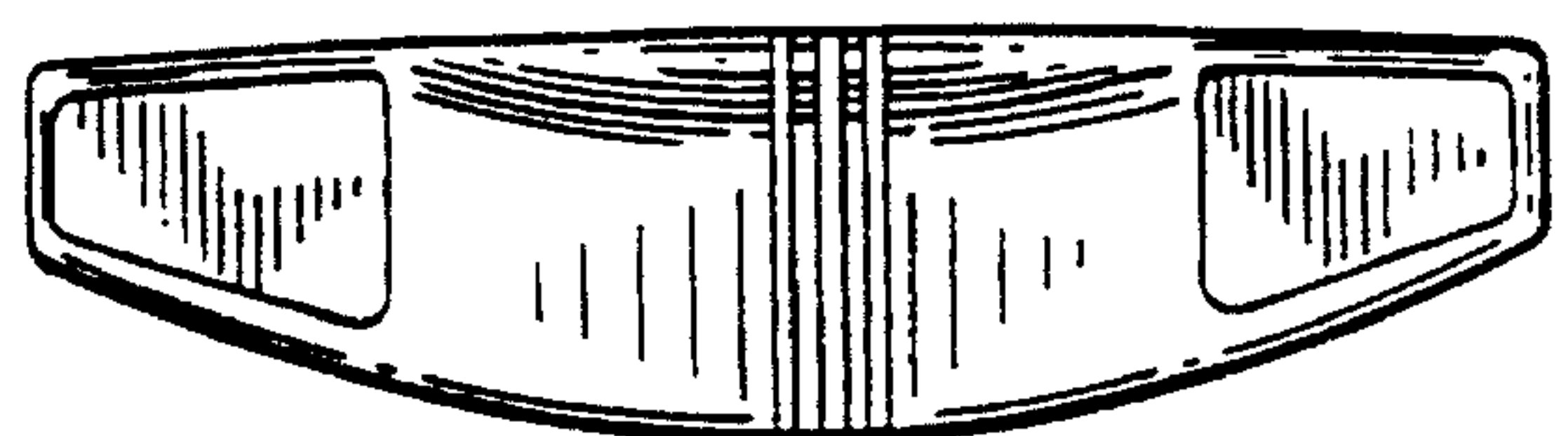

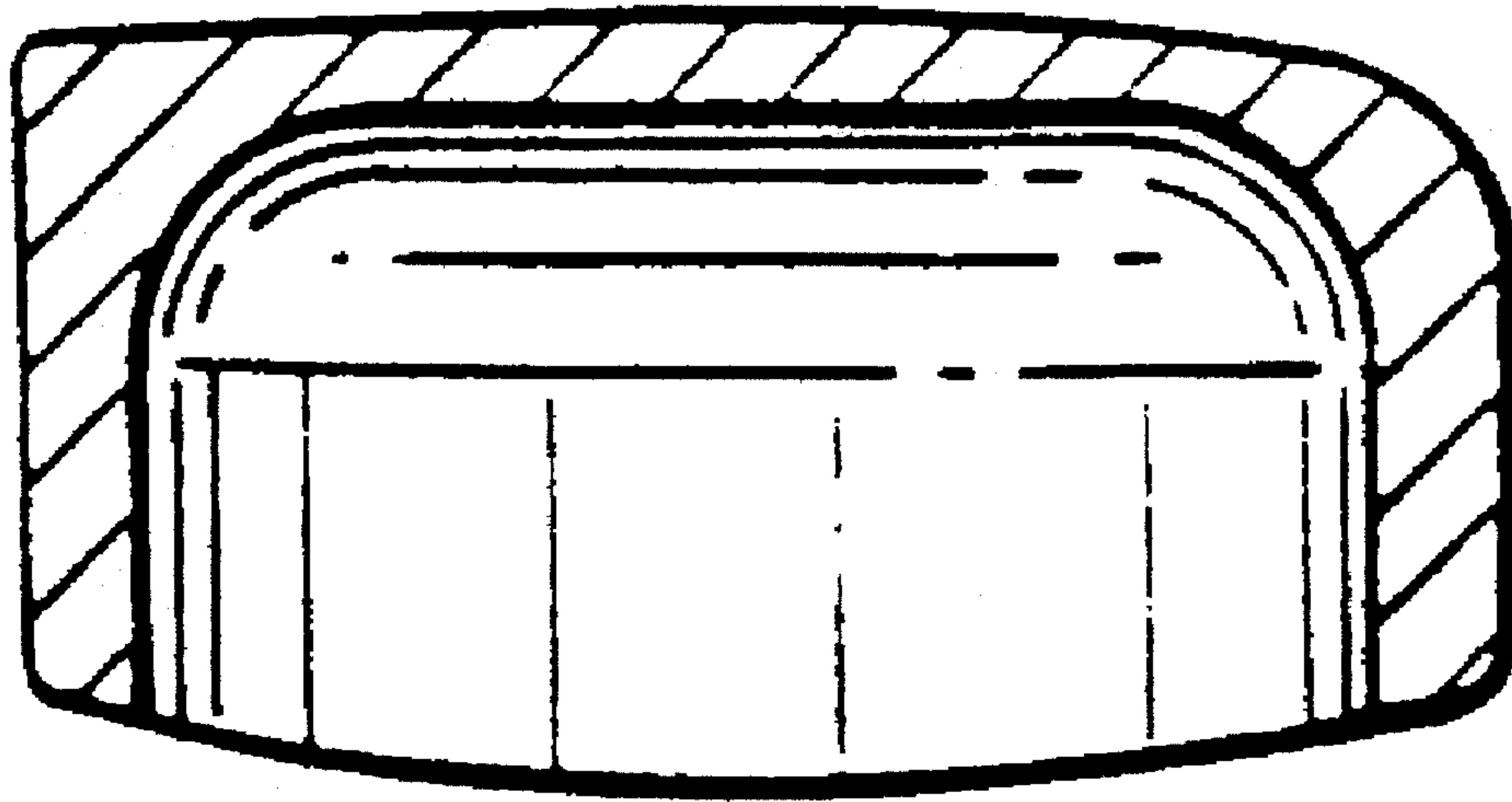
