The ornamental design for a bicycle rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a first embodiment of the bicycle rack of this invention;

FIG. 2 is a front elevational view thereof, the rear elevational view being identical thereto;

FIG. 3 is a left side elevational view thereof, the right side elevational view thereof being identical thereto;

FIG. 4 is an perspective view thereof;

FIG. 5 is an perspective view of an alternative embodiment bicycle rack of this invention;

FIG. 6 is a top plan view thereof;

FIG. 7 is a front elevational view thereof, the rear elevational view being identical thereto;

FIG. 8 is a left side elevational view thereof, the right side elevational view thereof being identical thereto;

FIG. 9 is a top plan view of another alternative embodiment bicycle rack of this invention;

FIG. 10 is a front elevational view thereof, the rear elevational view being identical thereto;

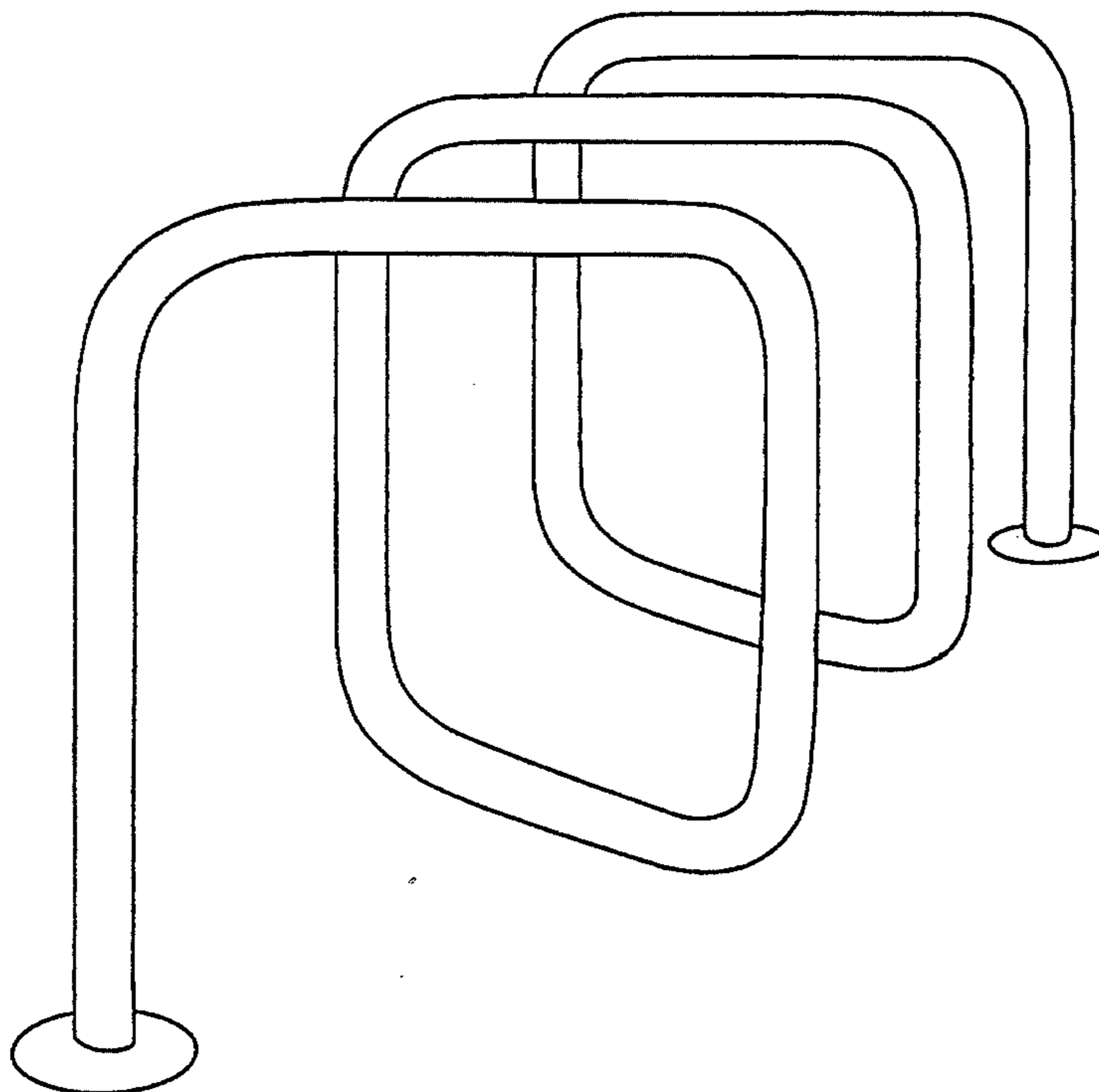
FIG. 11 is a left side elevational view thereof, the right side elevational view thereof being identical thereto;

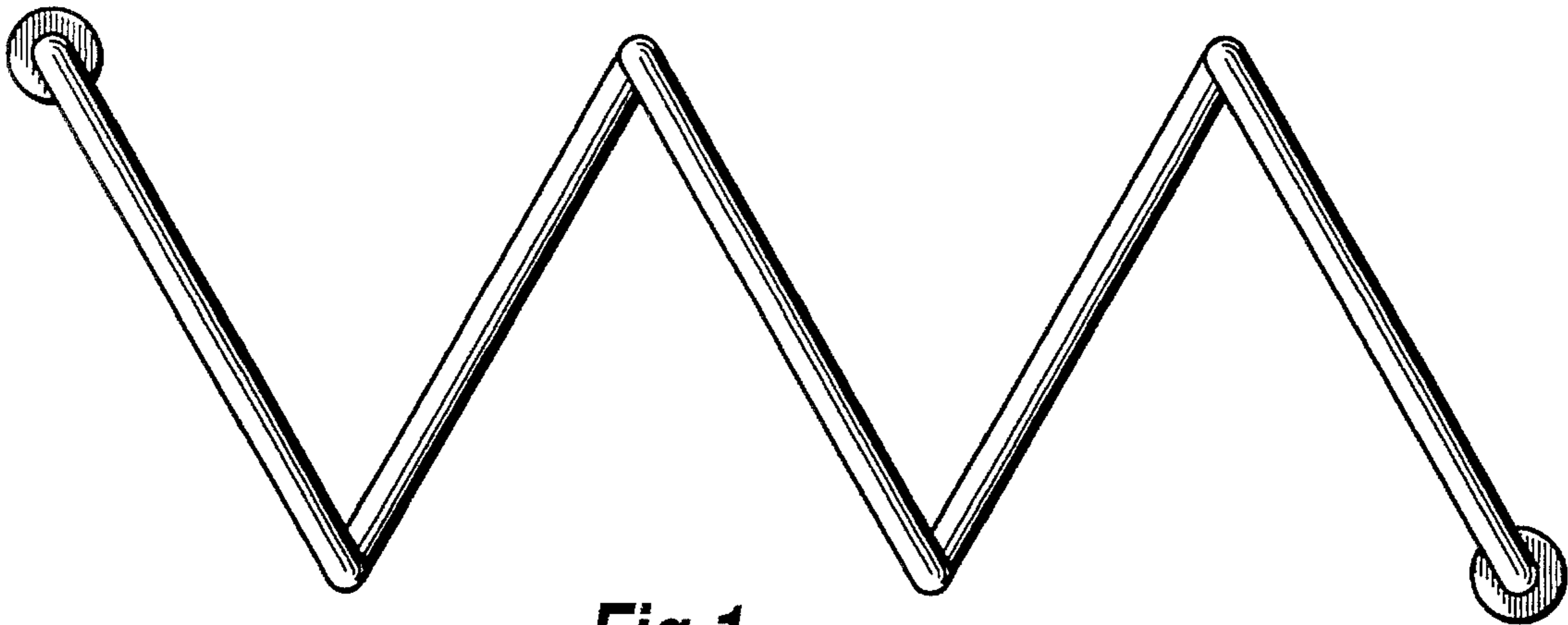
FIG. 12 is a top plan view of yet another alternative embodiment bicycle rack of this invention;

FIG. 13 is a front elevational view thereof, the rear elevational view being identical thereto; and

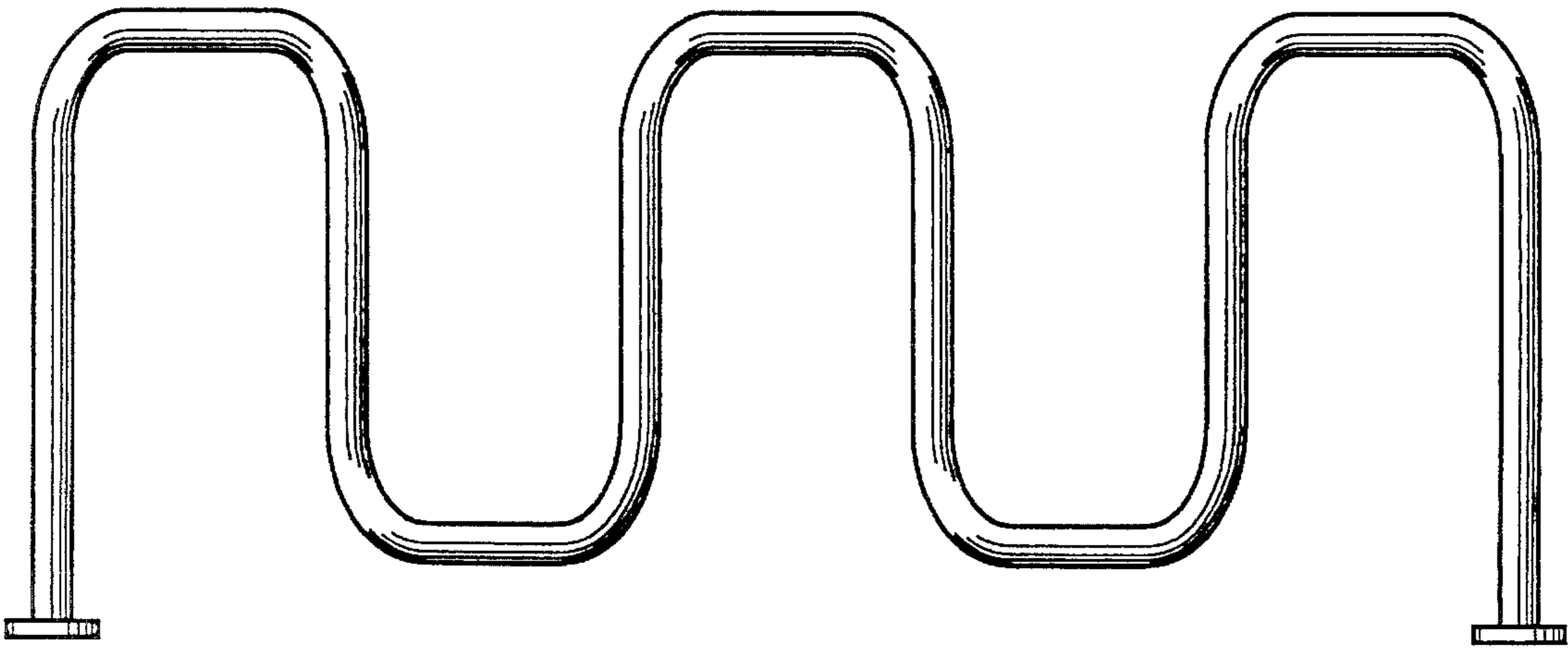
FIG. 14 is a left side elevational view thereof, the right side elevational view thereof being identical thereto.

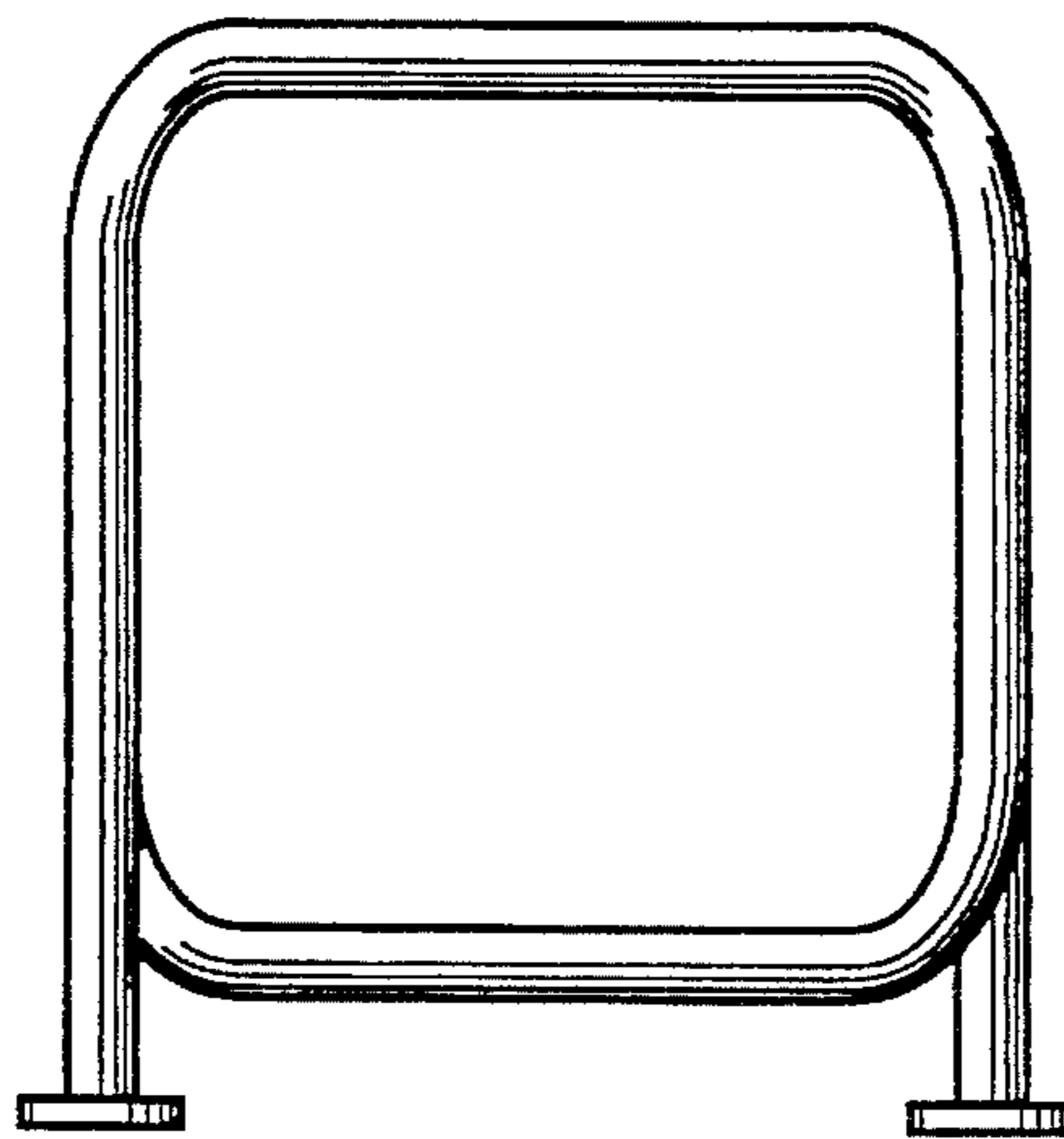

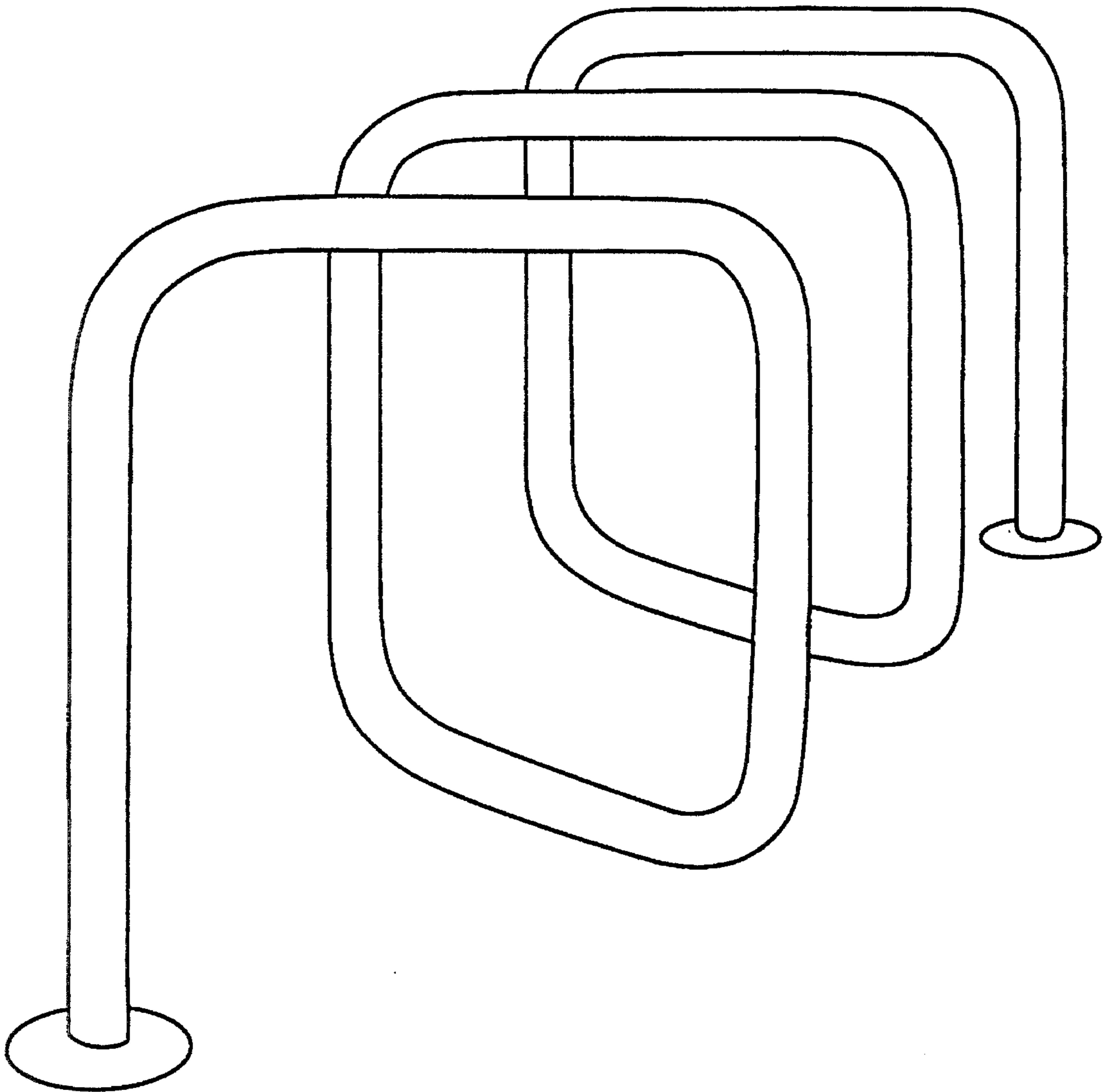
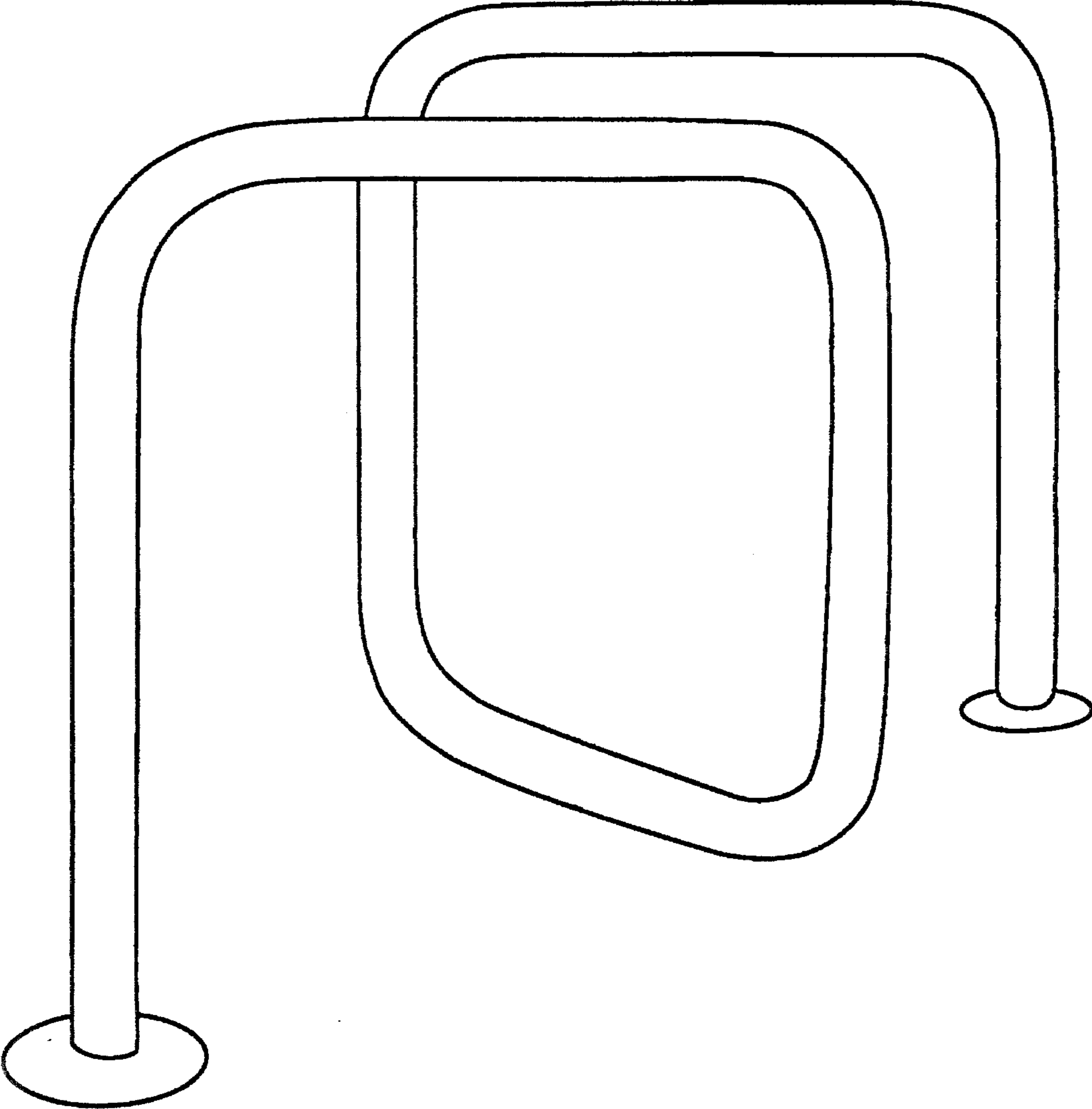
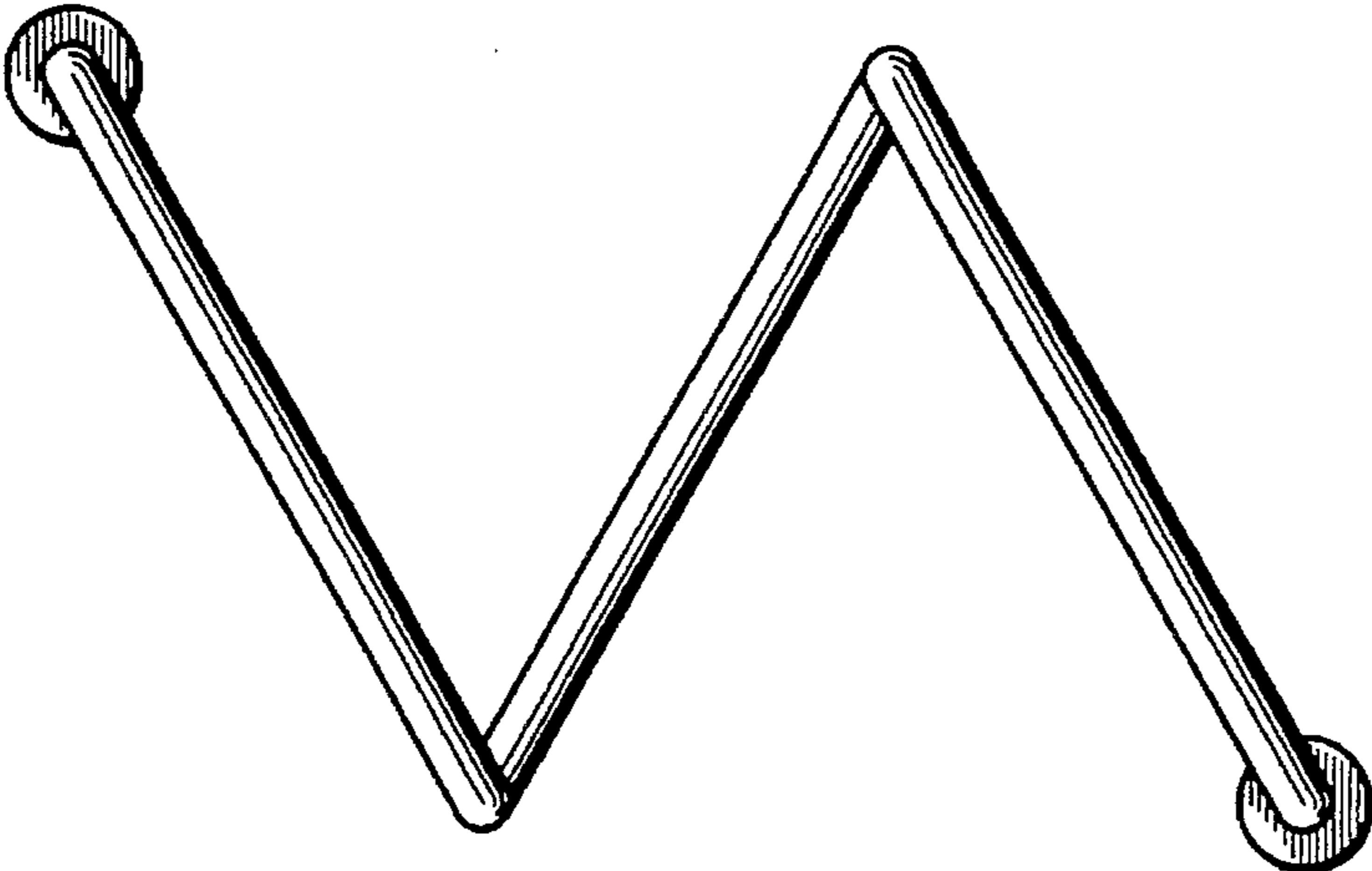


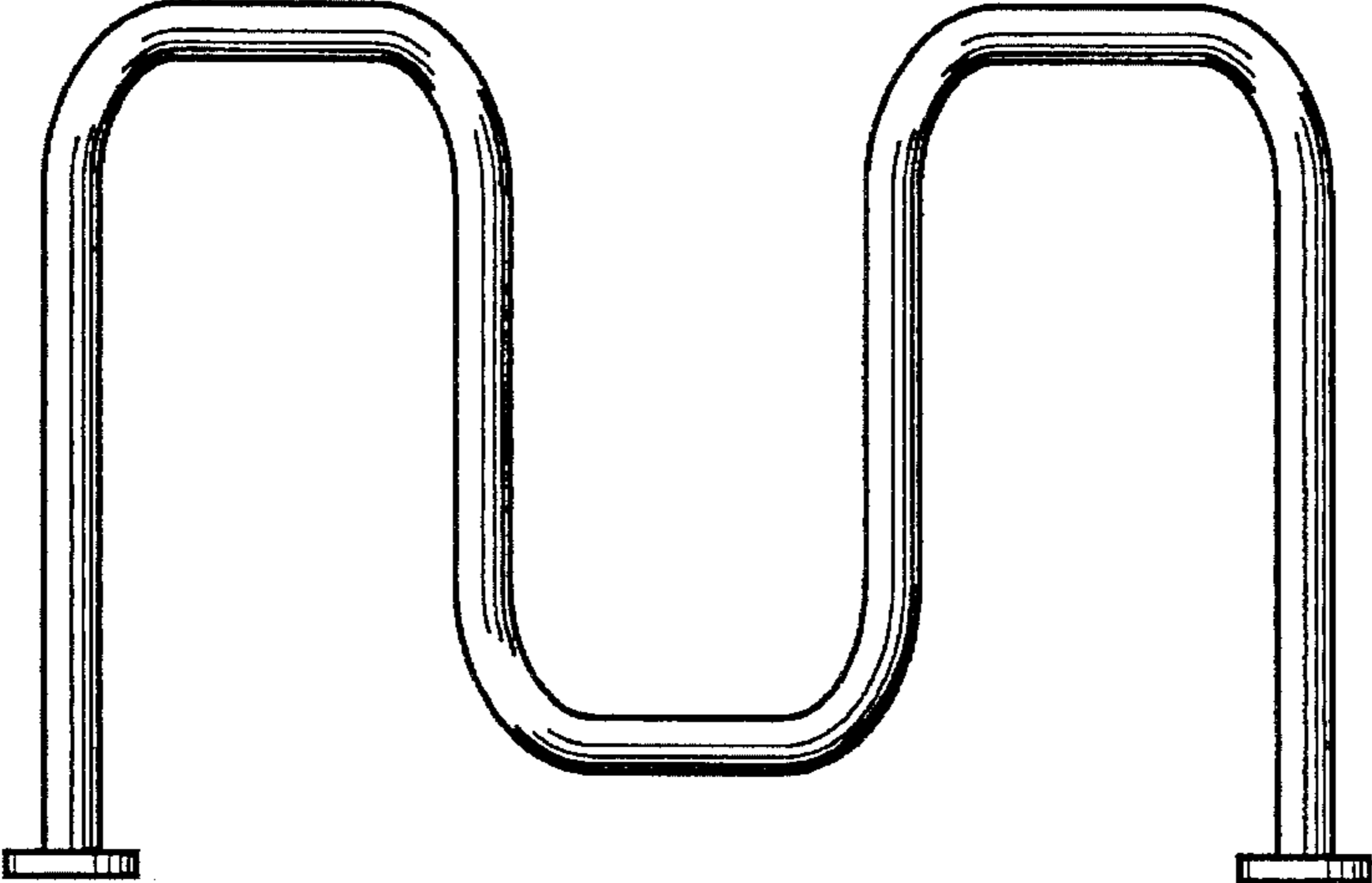

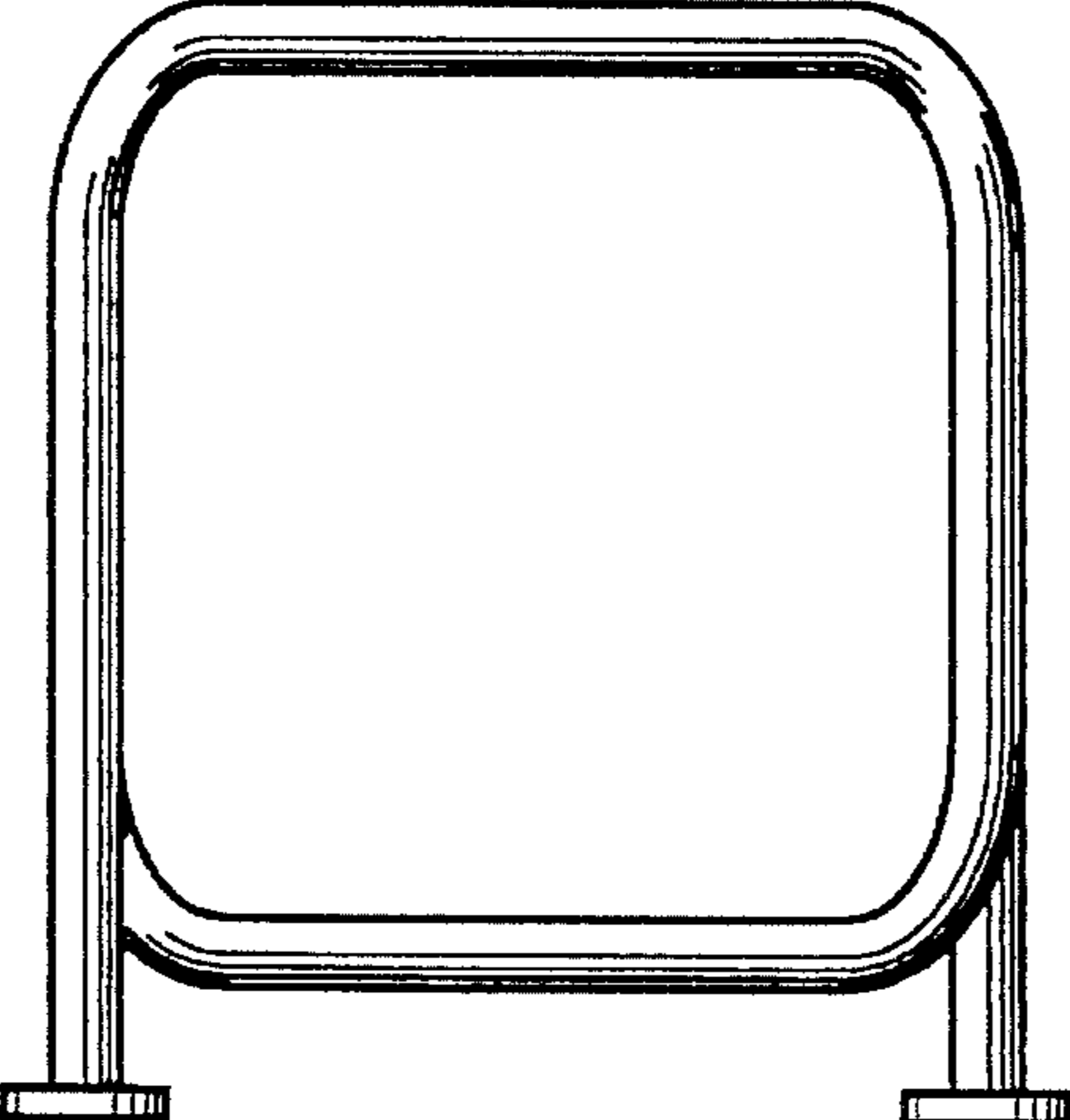

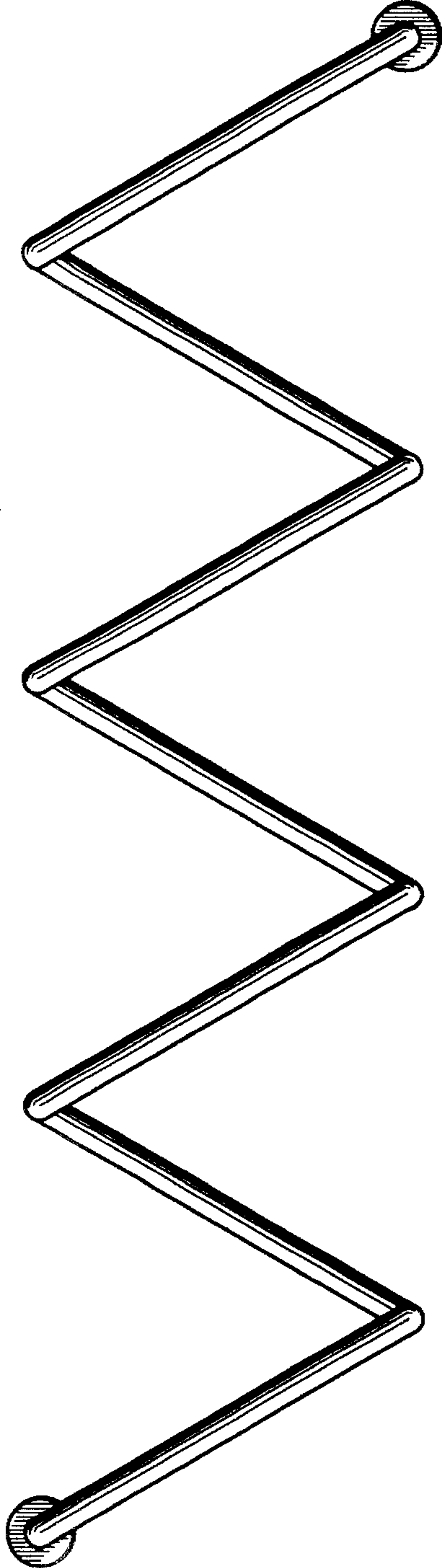

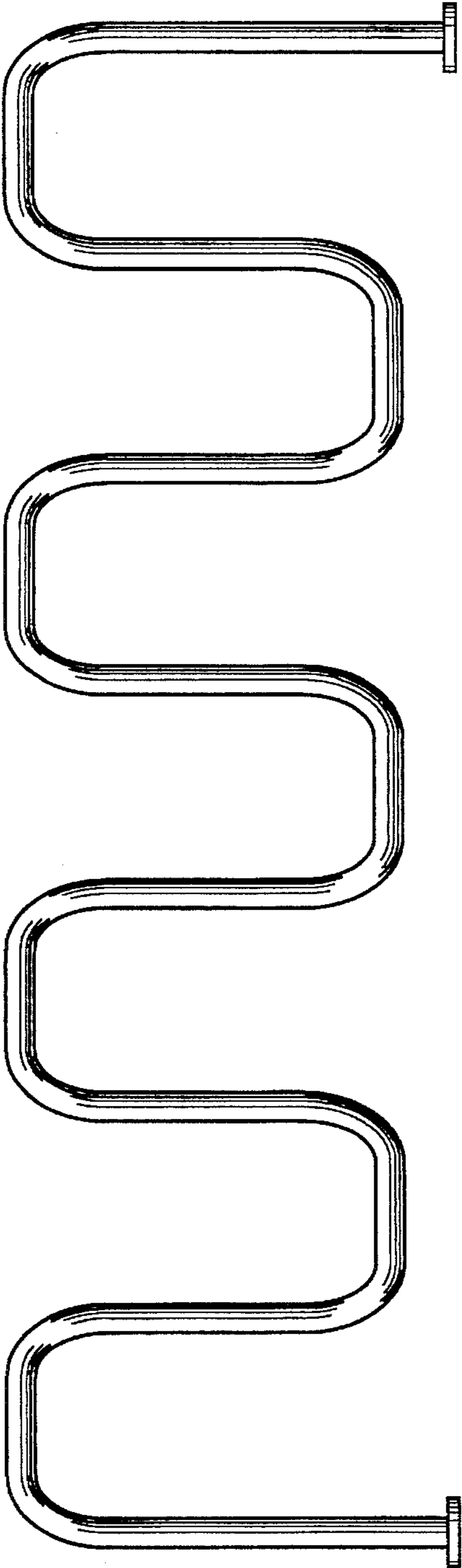

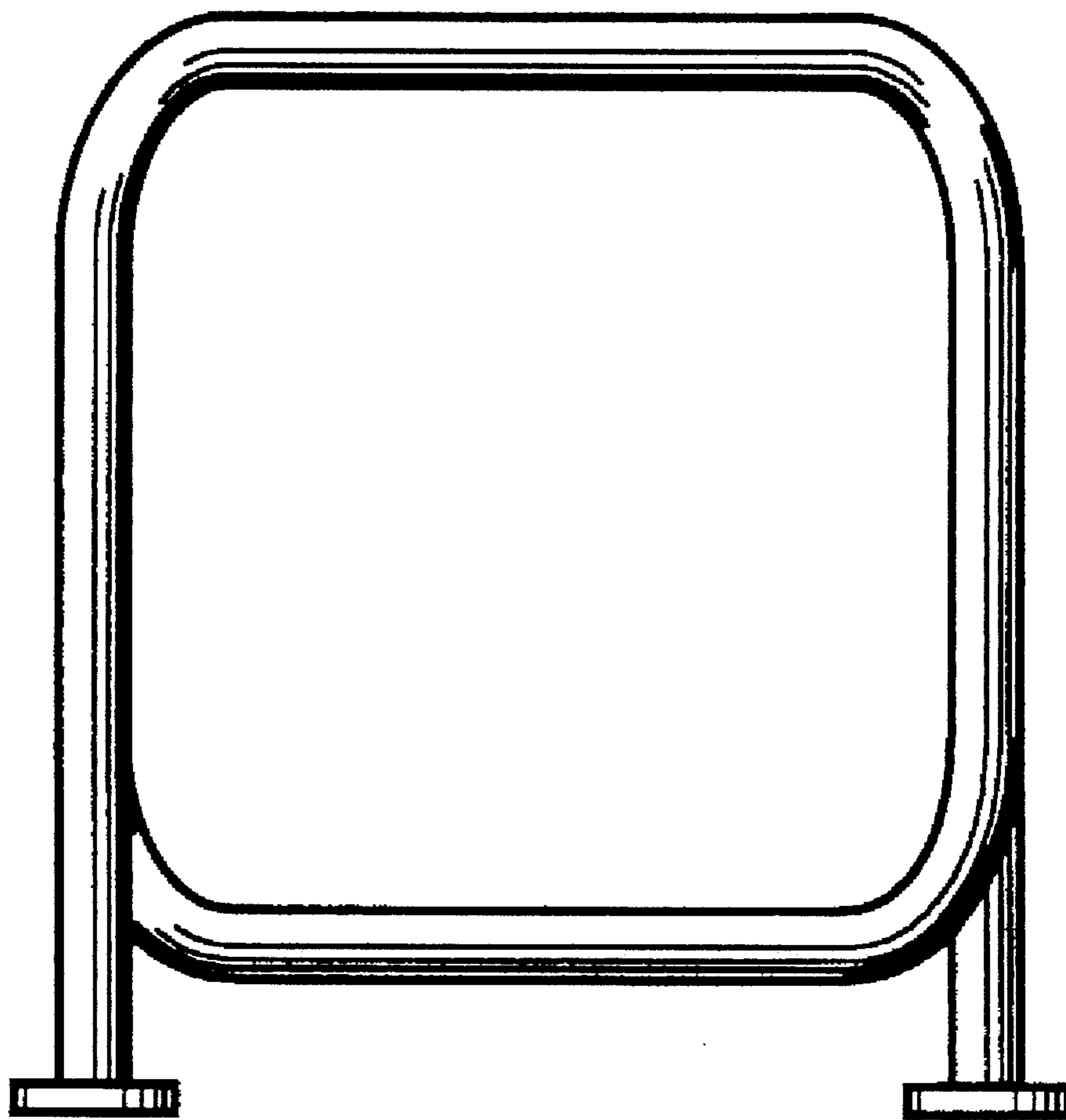

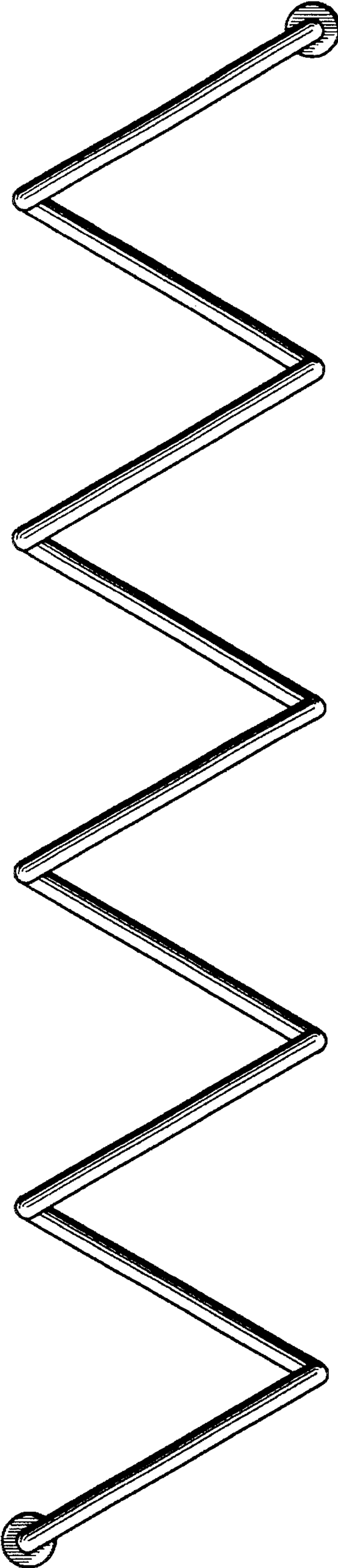

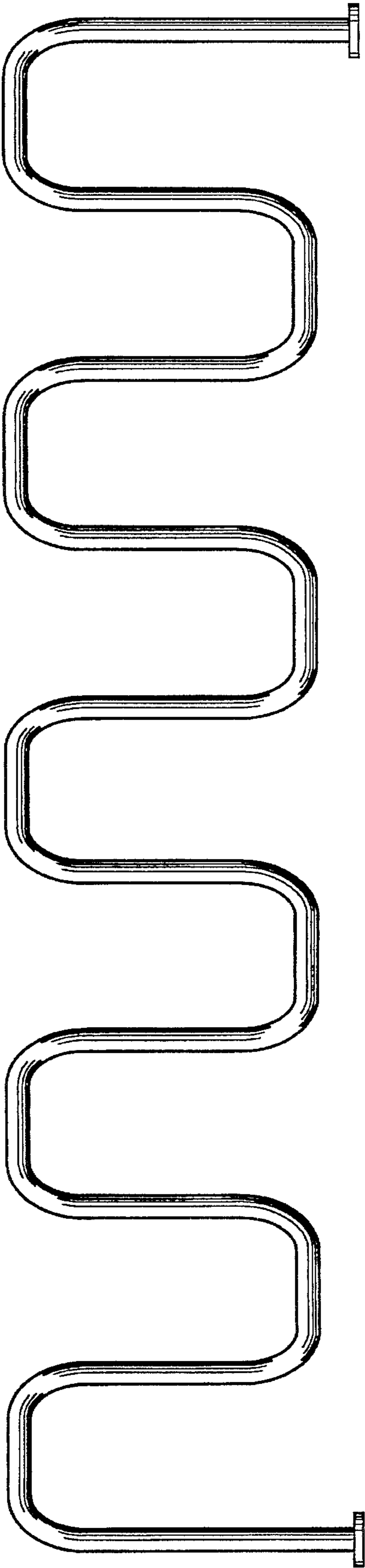

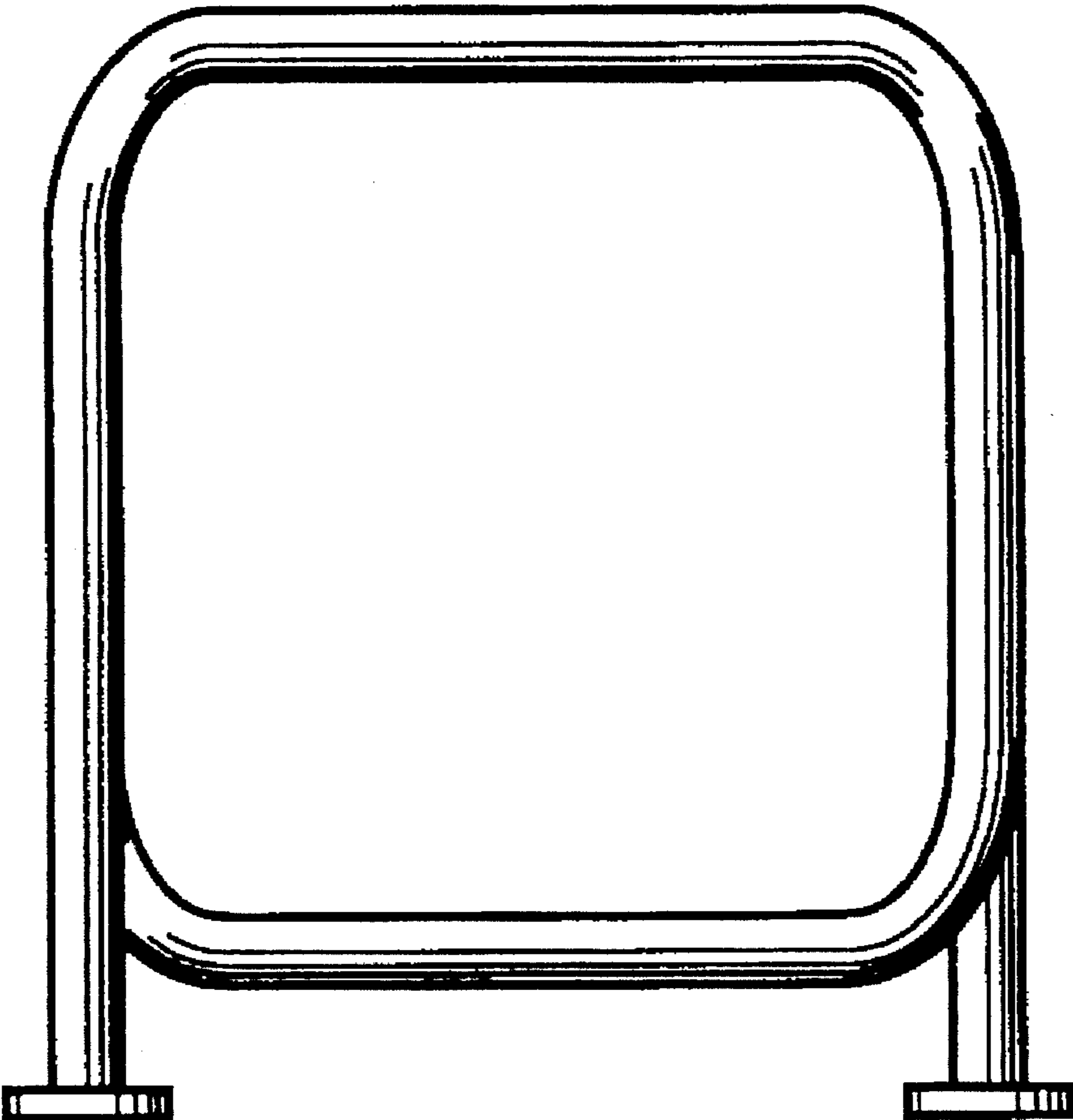
