[57] **CLAIM**

The ornamental design for the toy construction element, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a toy construction element showing my new design, the rear elevational view being identical;

FIG. 2 is a side elevational view thereof, the side opposite being identical;

FIG. 3 is a top plan view thereof, the bottom plan view being identical;

FIG. 4 is a front elevational view of a modified embodiment of the design shown in FIGS. 1-3, the rear elevational view being identical;

FIG. 5 is a side elevational view thereof, the side opposite being identical;

FIG. 6 is a top plan view thereof, the bottom plan view being identical;

FIG. 7 is a front elevational view of a second modified embodiment of the design shown in FIGS. 1-3, the rear elevational view being identical;

FIG. 8 is a side elevational view thereof, the side opposite being identical;

FIG. 9 is a top plan view thereof, the bottom plan view being identical;

FIG. 10 is a front perspective view of the design shown in FIGS. 1-3;

FIG. 11 is a front perspective view of the design shown in FIGS. 4-6; and,

FIG. 12 is a front perspective view of the design shown in FIGS. 7-9.

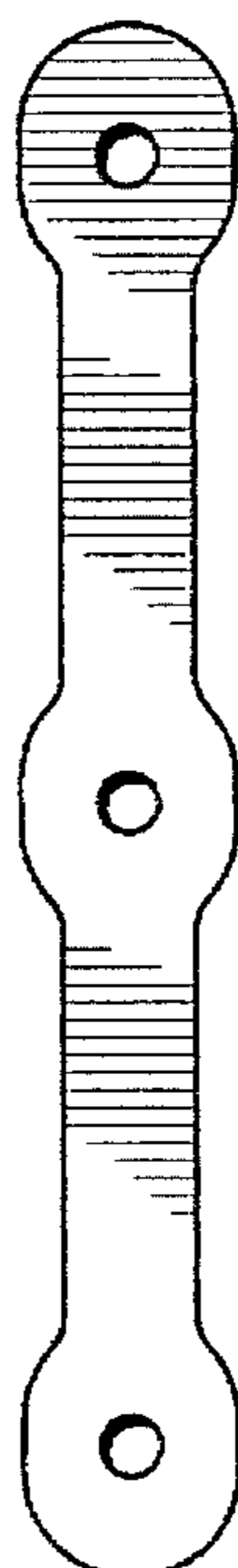

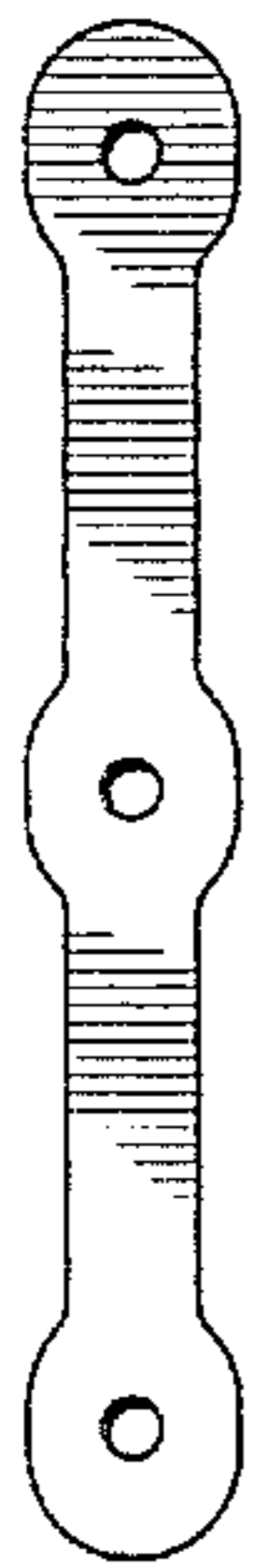

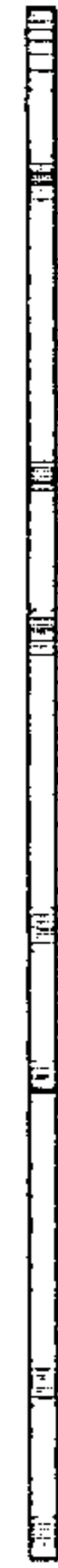

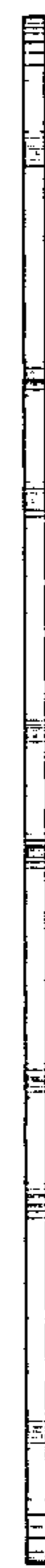

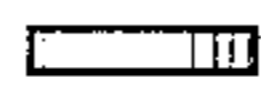

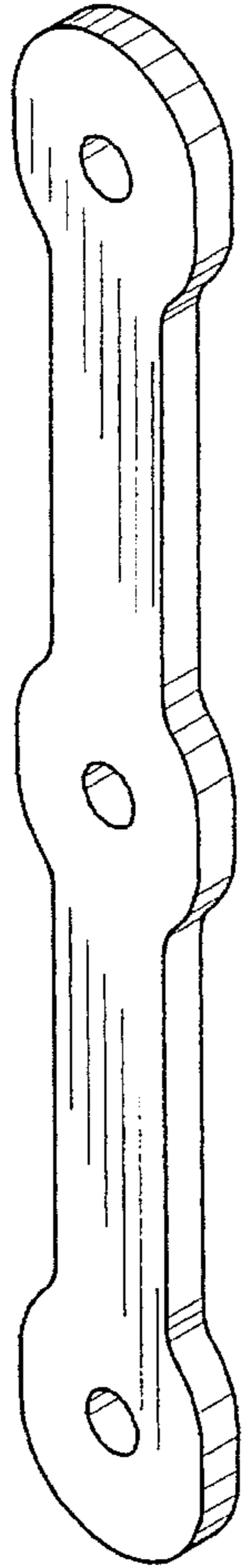

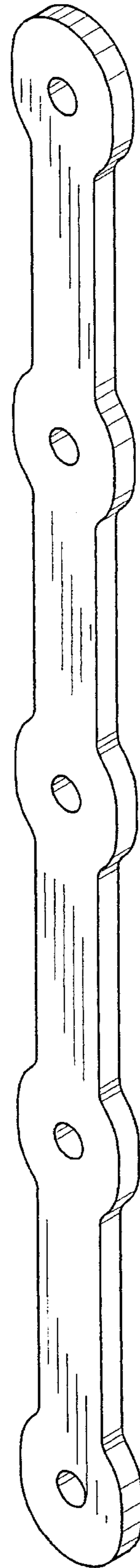
