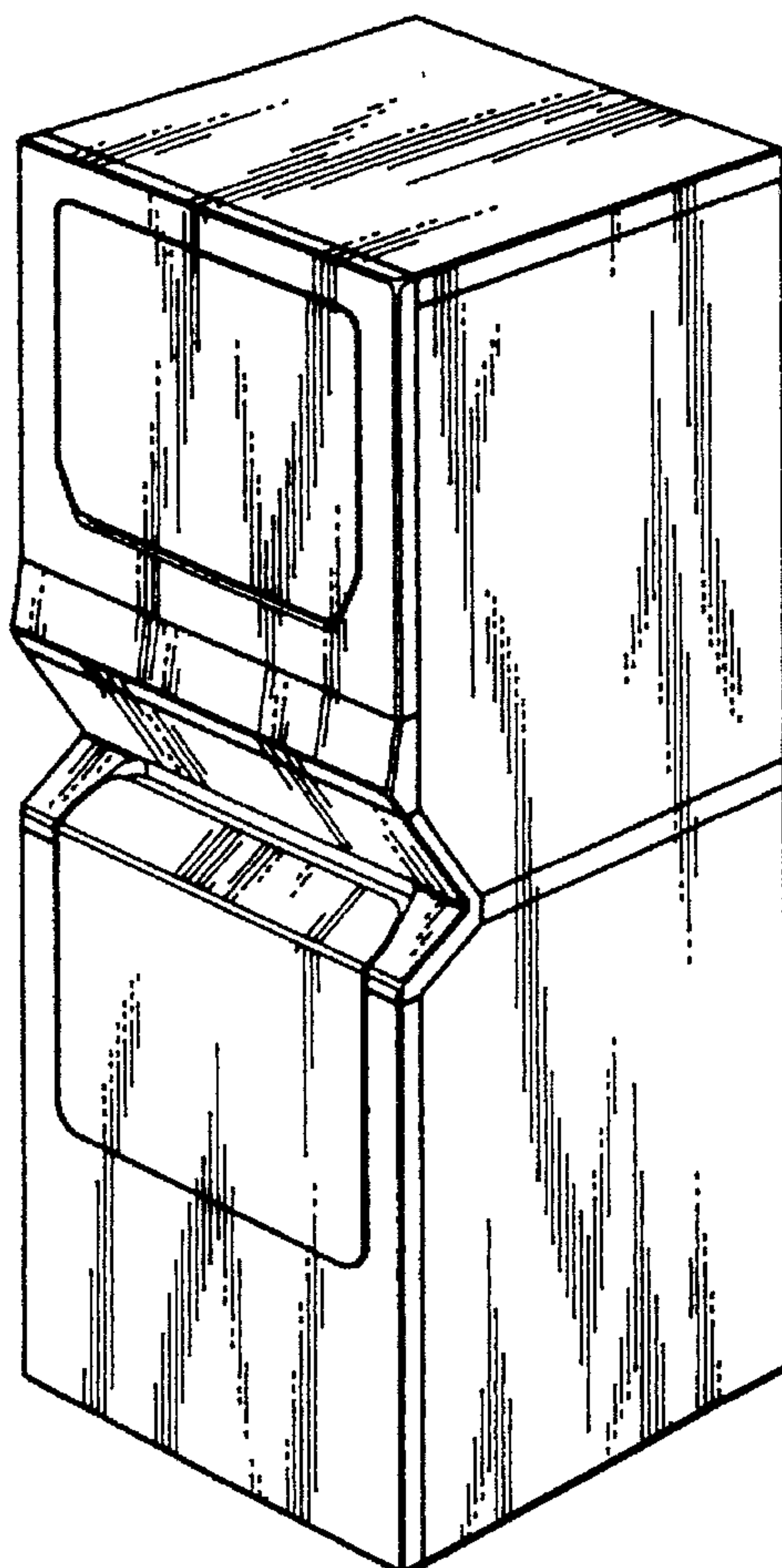

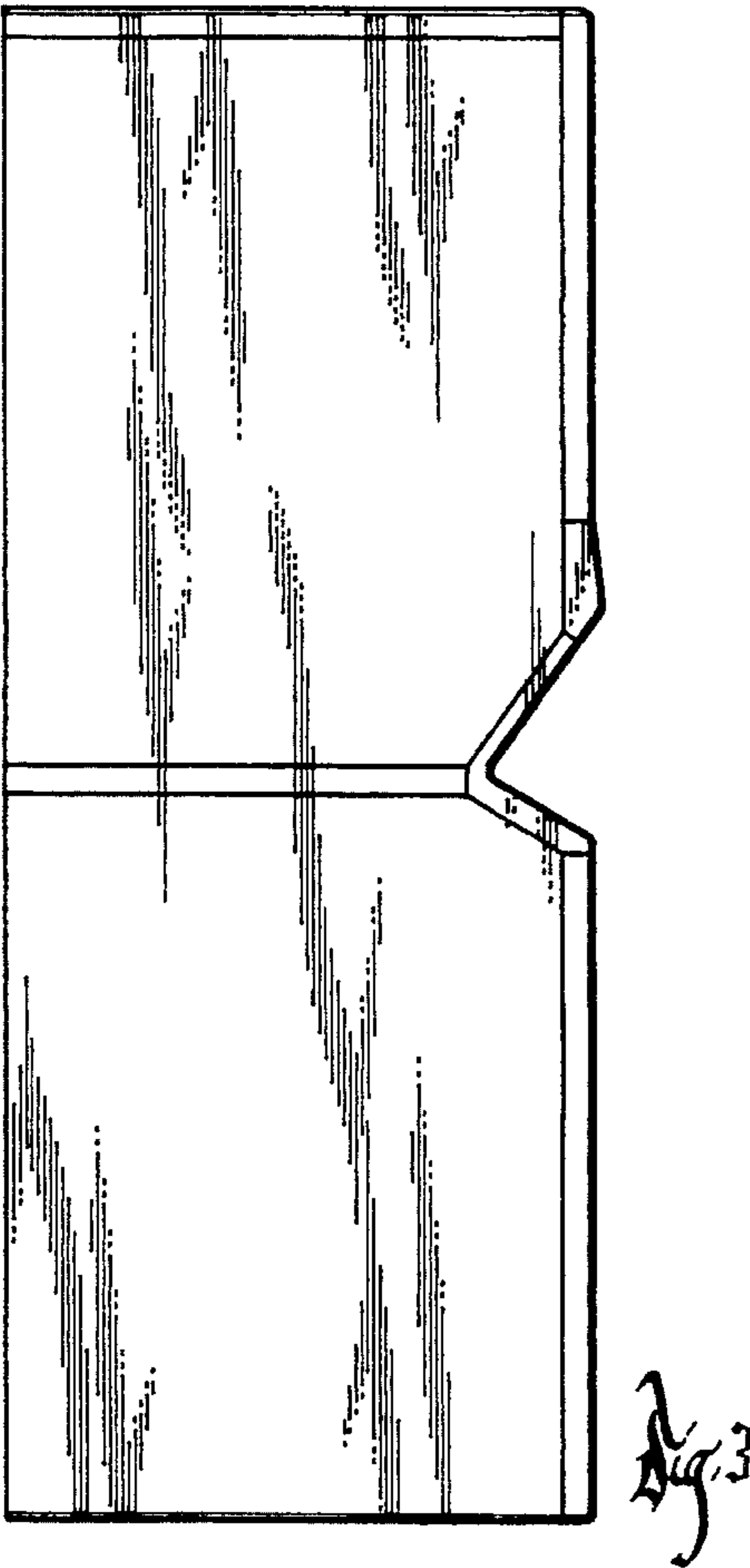
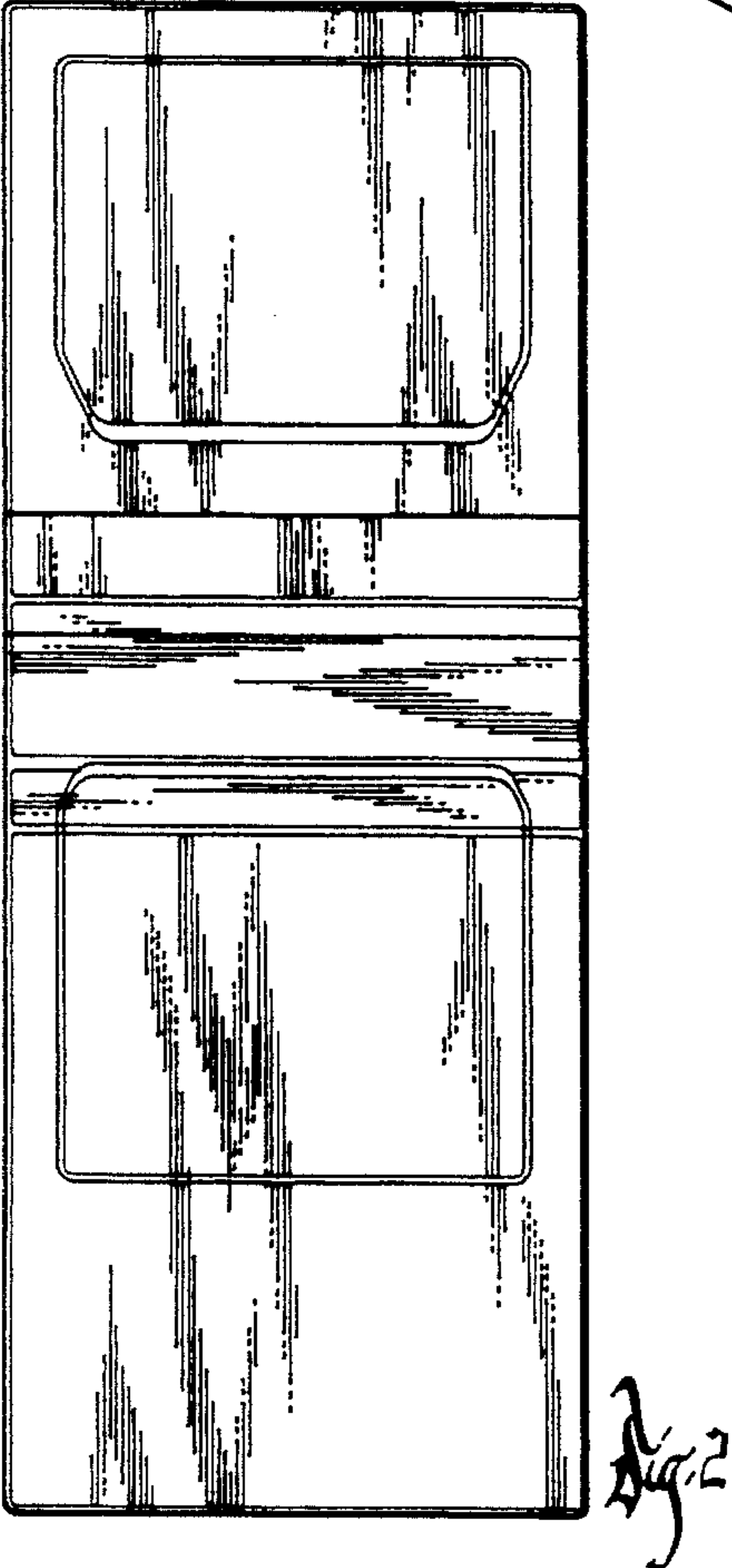
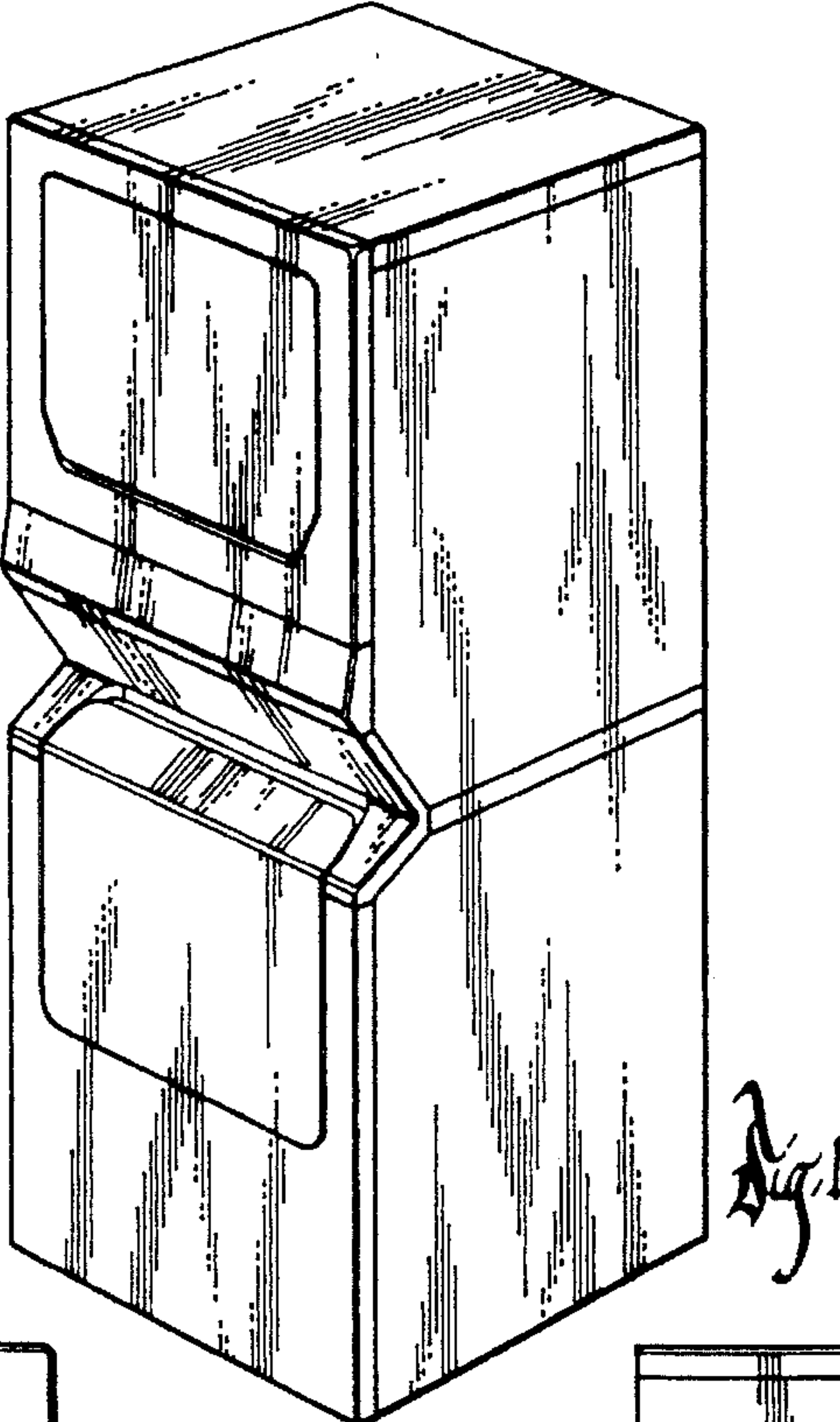

FIG. 1 is a perspective view of a combined washer and dryer showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a side elevational view thereof, the opposite side being a mirror image;

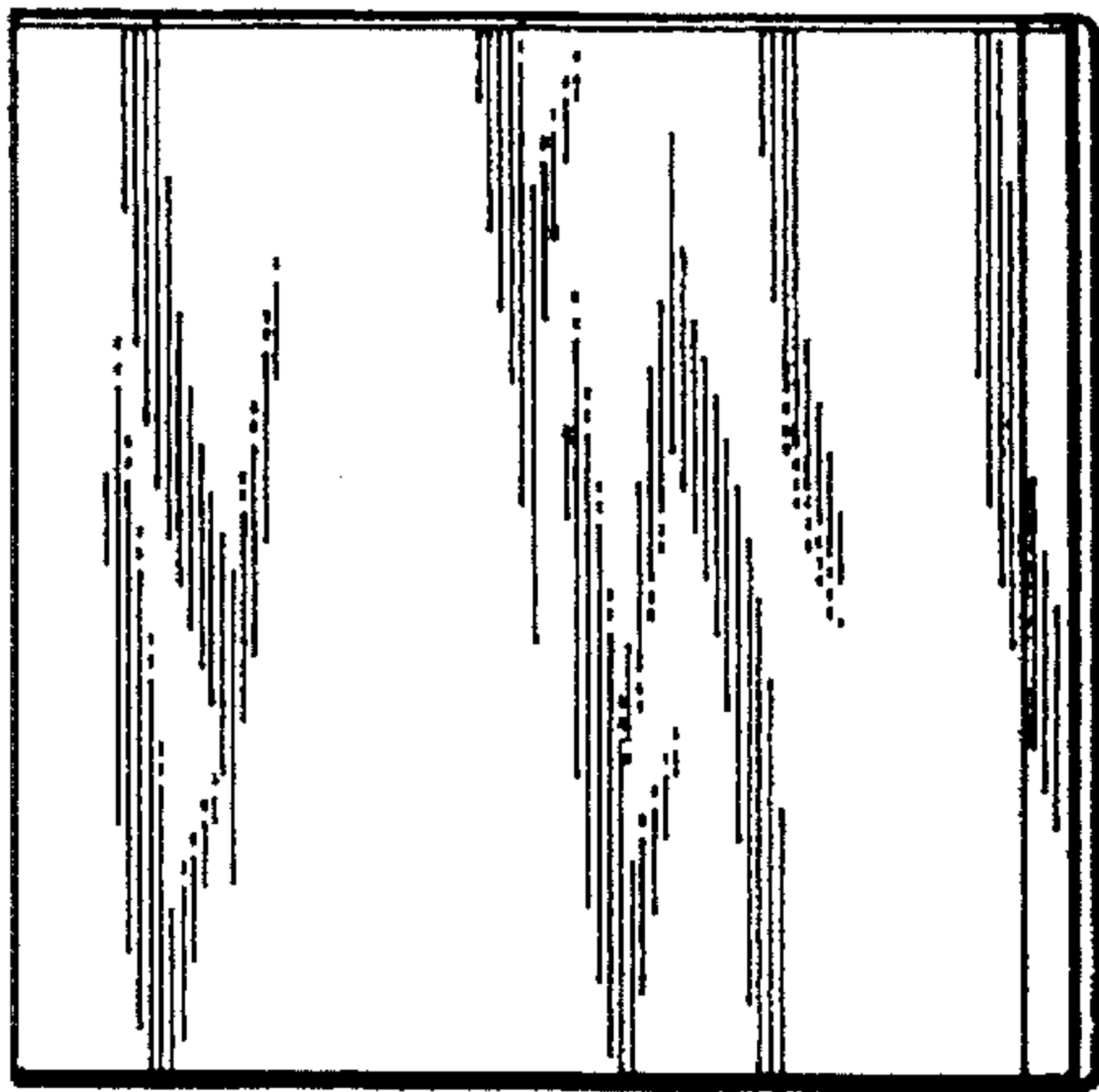

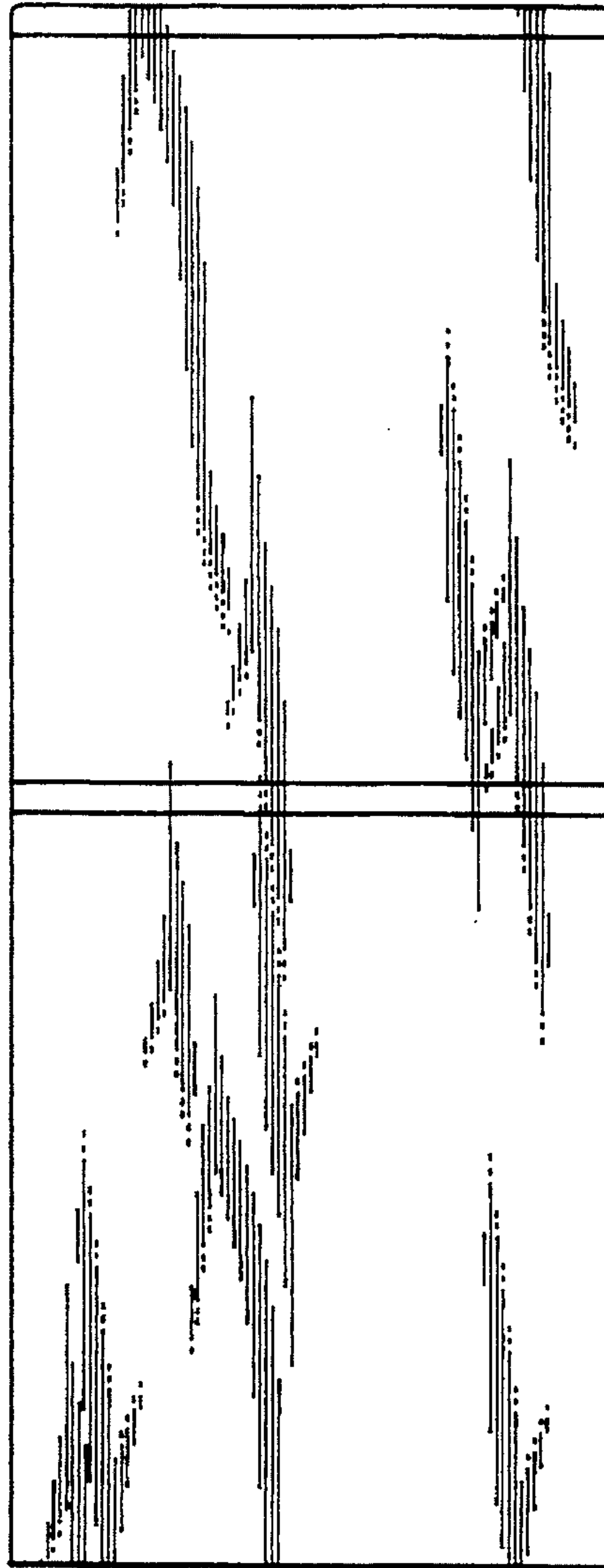
