FIG. 3 is a front elevational view of a sidewall for a jug of FIG. 1;

FIG. 4 is a top view of a sidewall for a jug of FIG. 1;

FIG. 5 is a side elevational view of a second embodiment of the sidewall for a jug, the opposite side elevational view is a mirror image thereof;

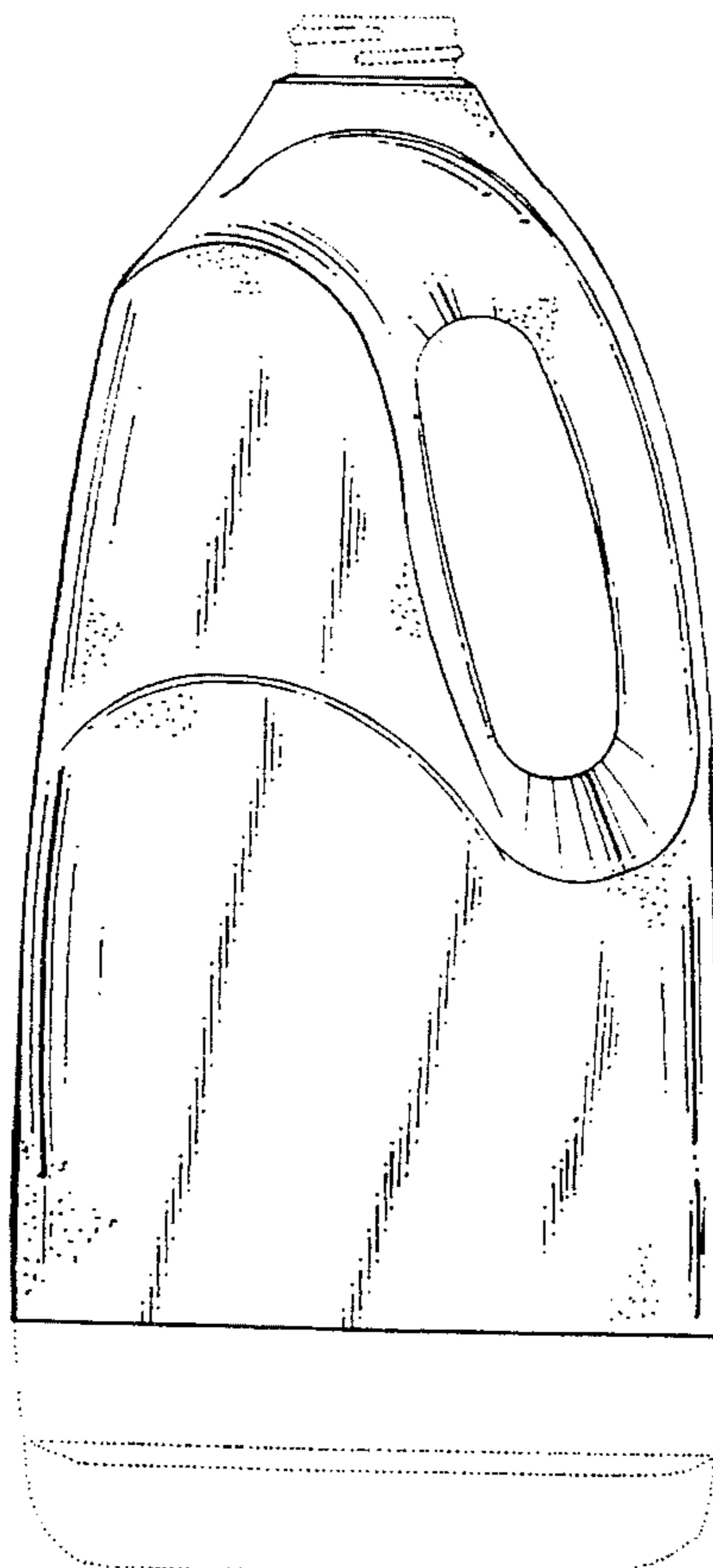
FIG. 6 is a rear elevational view of the sidewall for a jug of FIG. 5;

FIG. 7 is a front elevational view of the sidewall for a jug of FIG. 5; and,

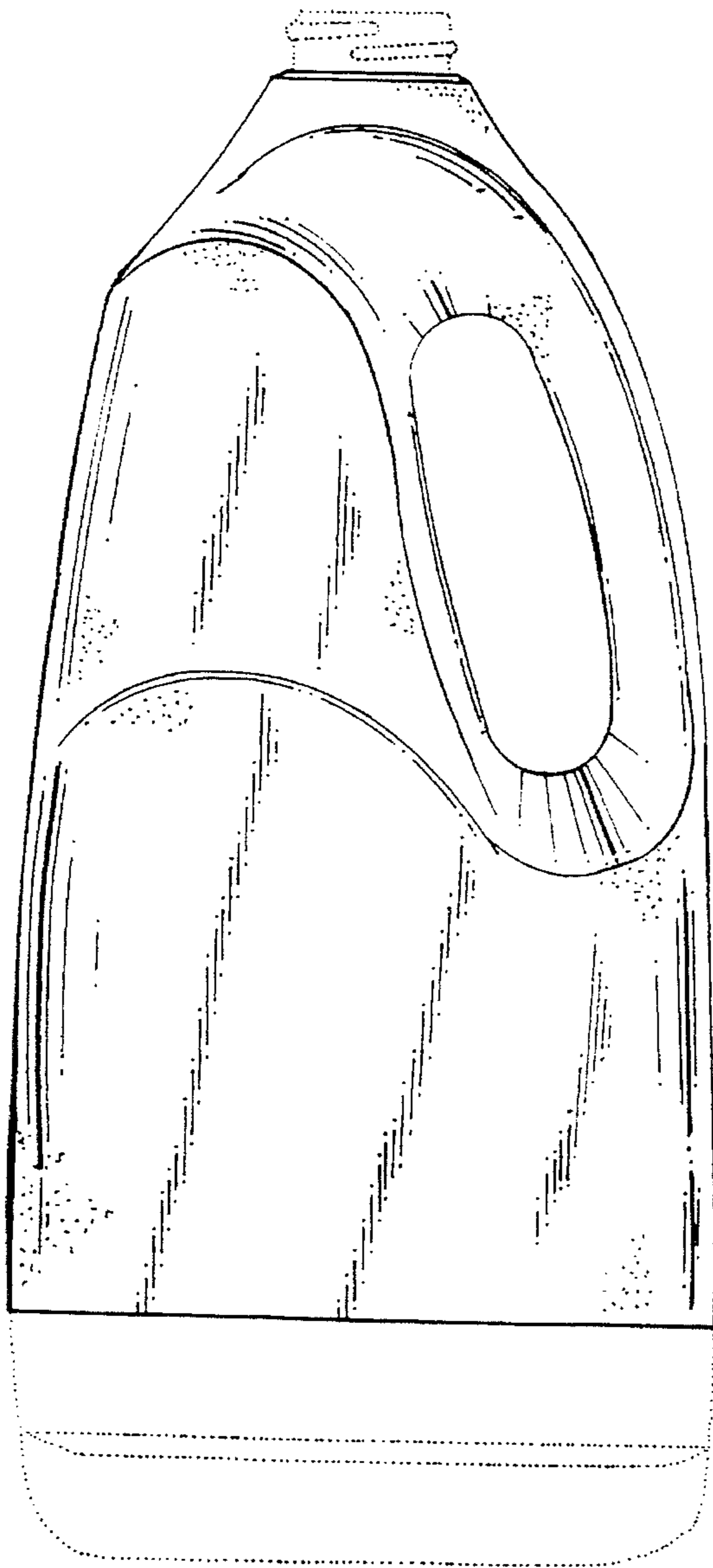

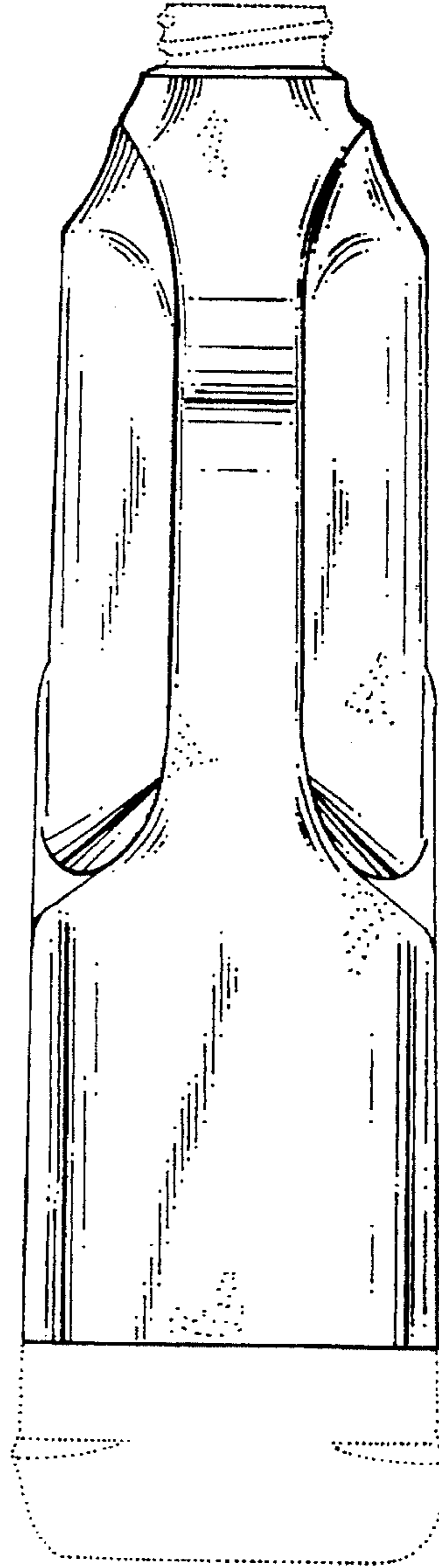

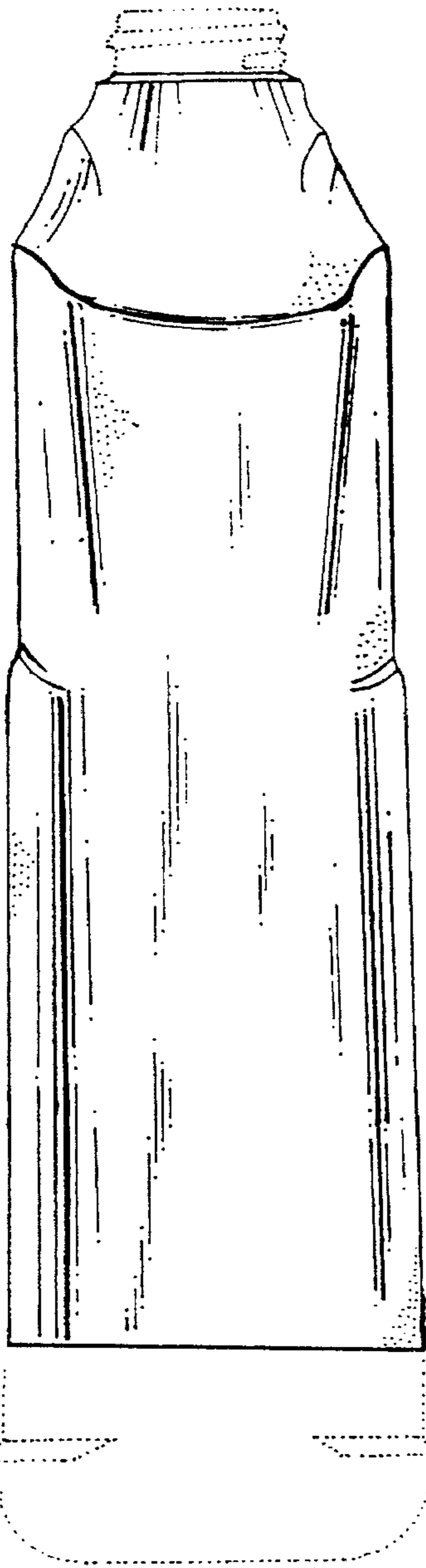

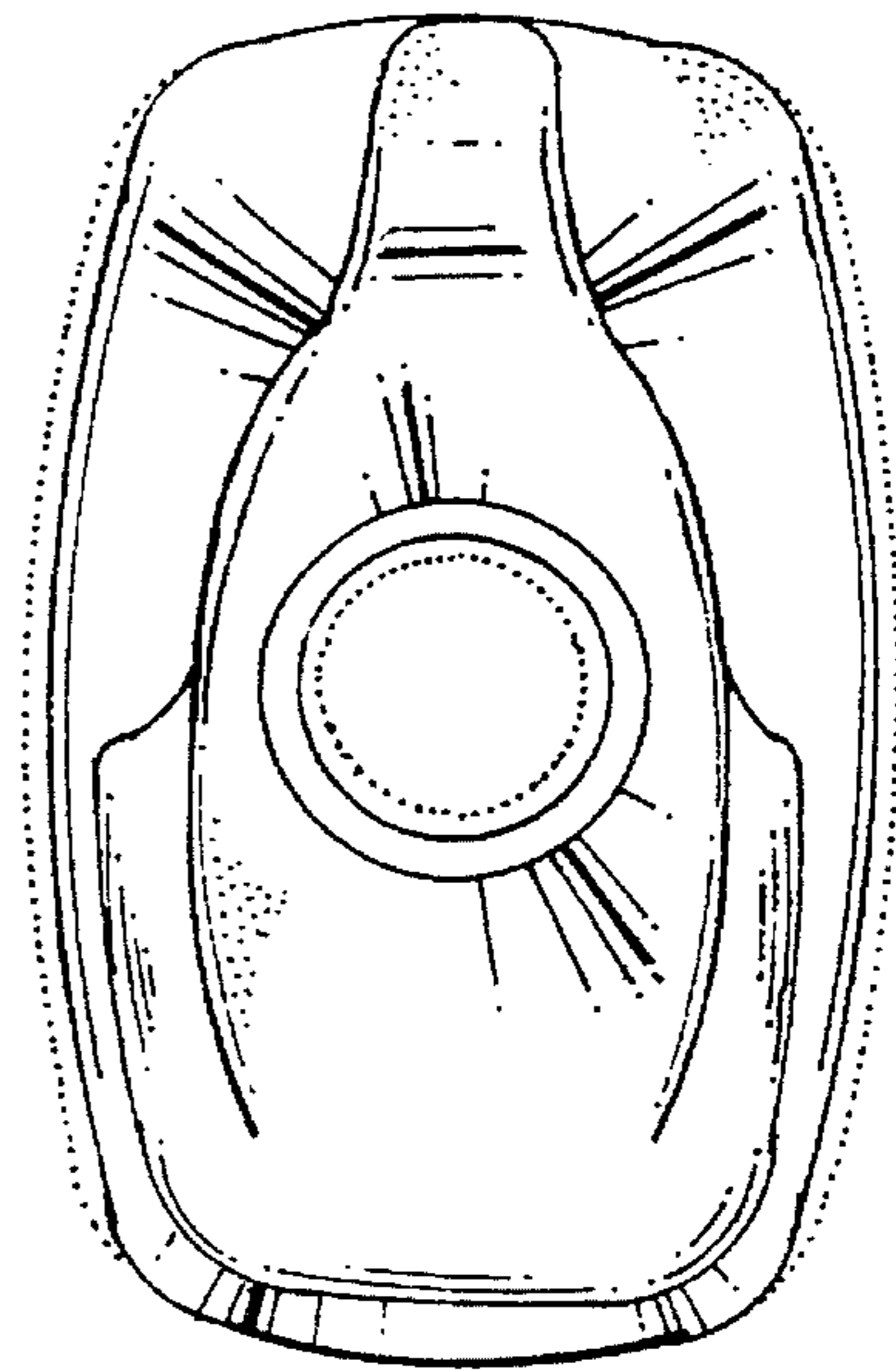

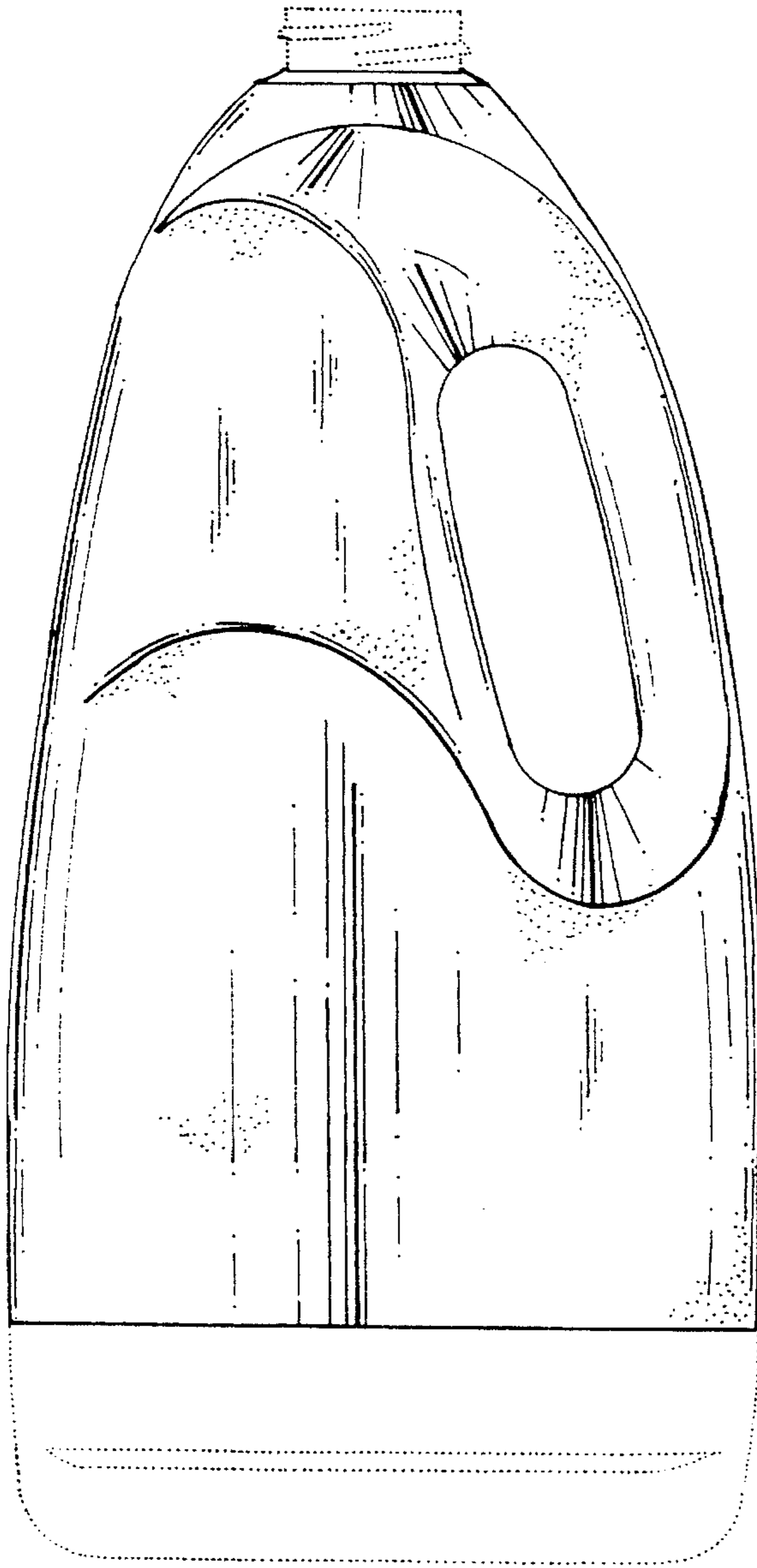

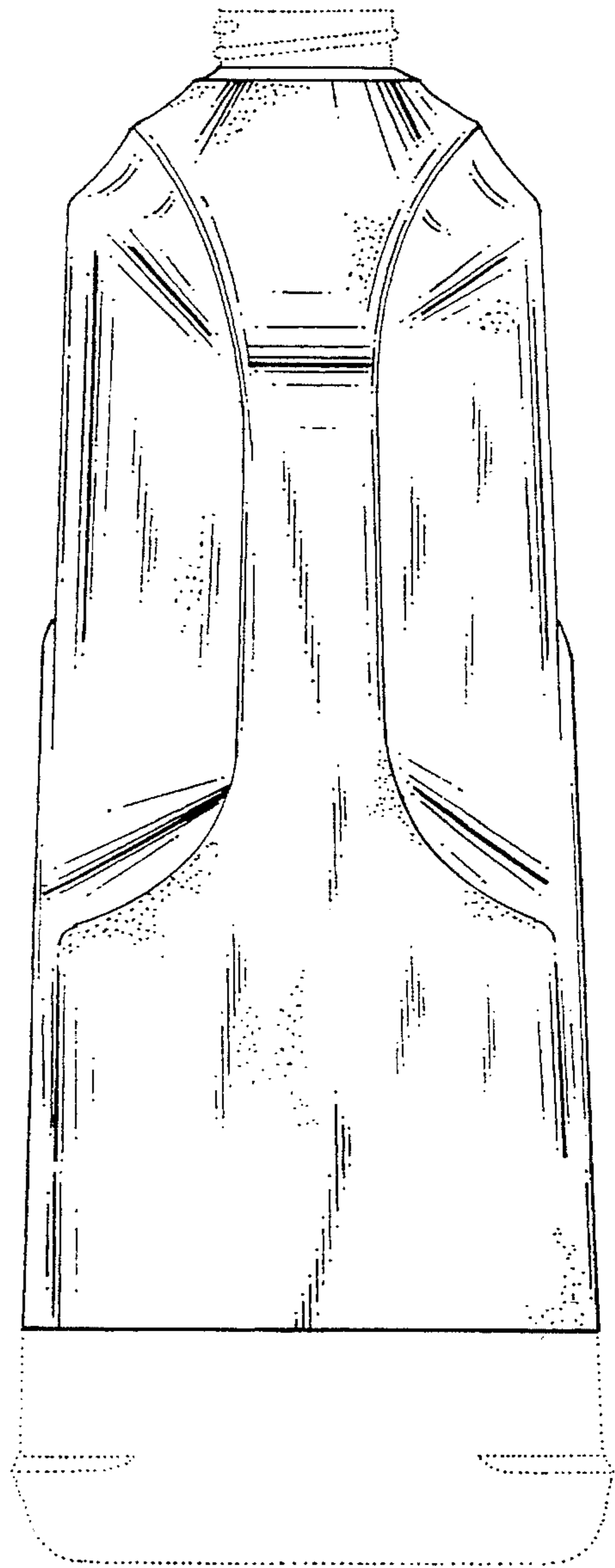

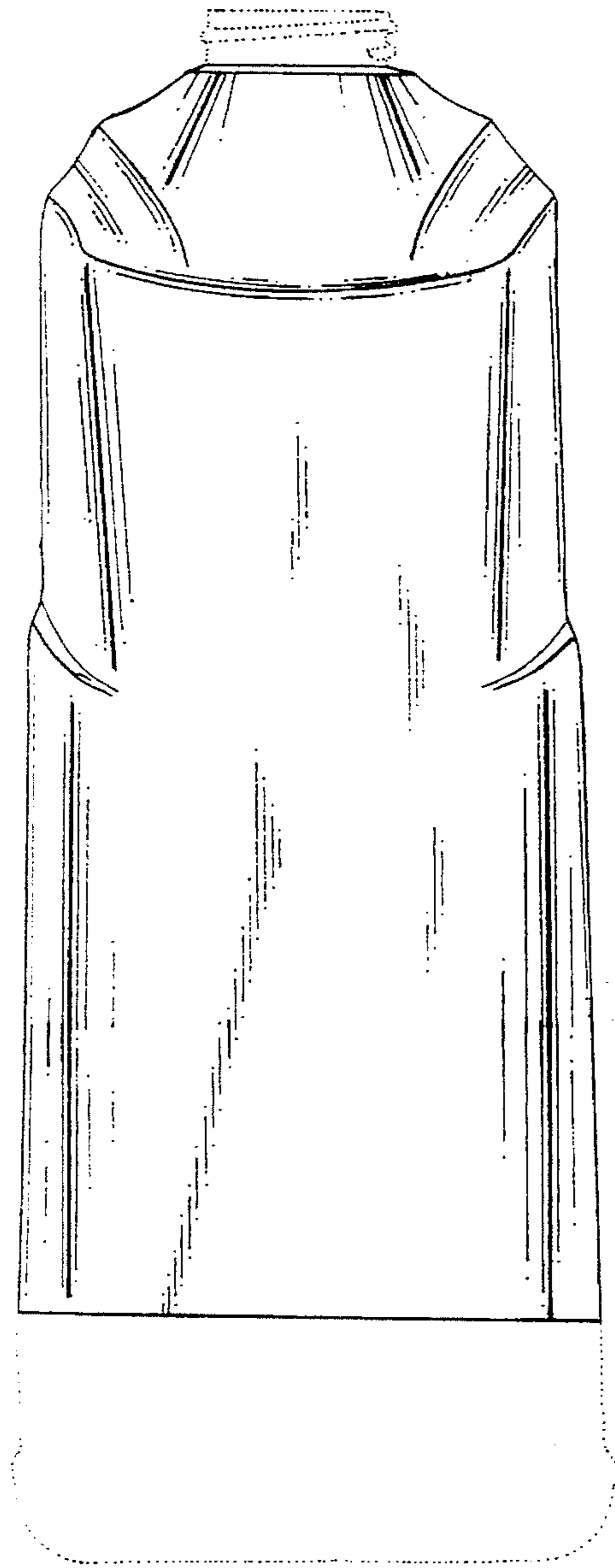
