### [57] CLAIM

The ornamental design for a pregnancy testing stick, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view of a pregnancy testing stick; FIG. 2 is a left side view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front end view thereof; FIG. 5 is a rear end view thereof; FIG. 6 is a top, left side and rear end perspective view thereof; FIG. 7 is a left side view of the inside portion of my new design, shown with the cap removed for ease of illustration; FIG. 8 is a front end view thereof of FIG. 7; FIG. 9 is a rear end view thereof of FIG. 7; FIG. 10 is a top plan view of the cap portion of my new design, shown with the handle removed for ease of illustration; FIG. 11 is a left side view thereof of FIG. 10; FIG. 12 is a bottom plan view thereof of FIG. 10; FIG. 13 is a front end view thereof of FIG. 10; and, FIG. 14 is a rear end view thereof of FIG. 10.

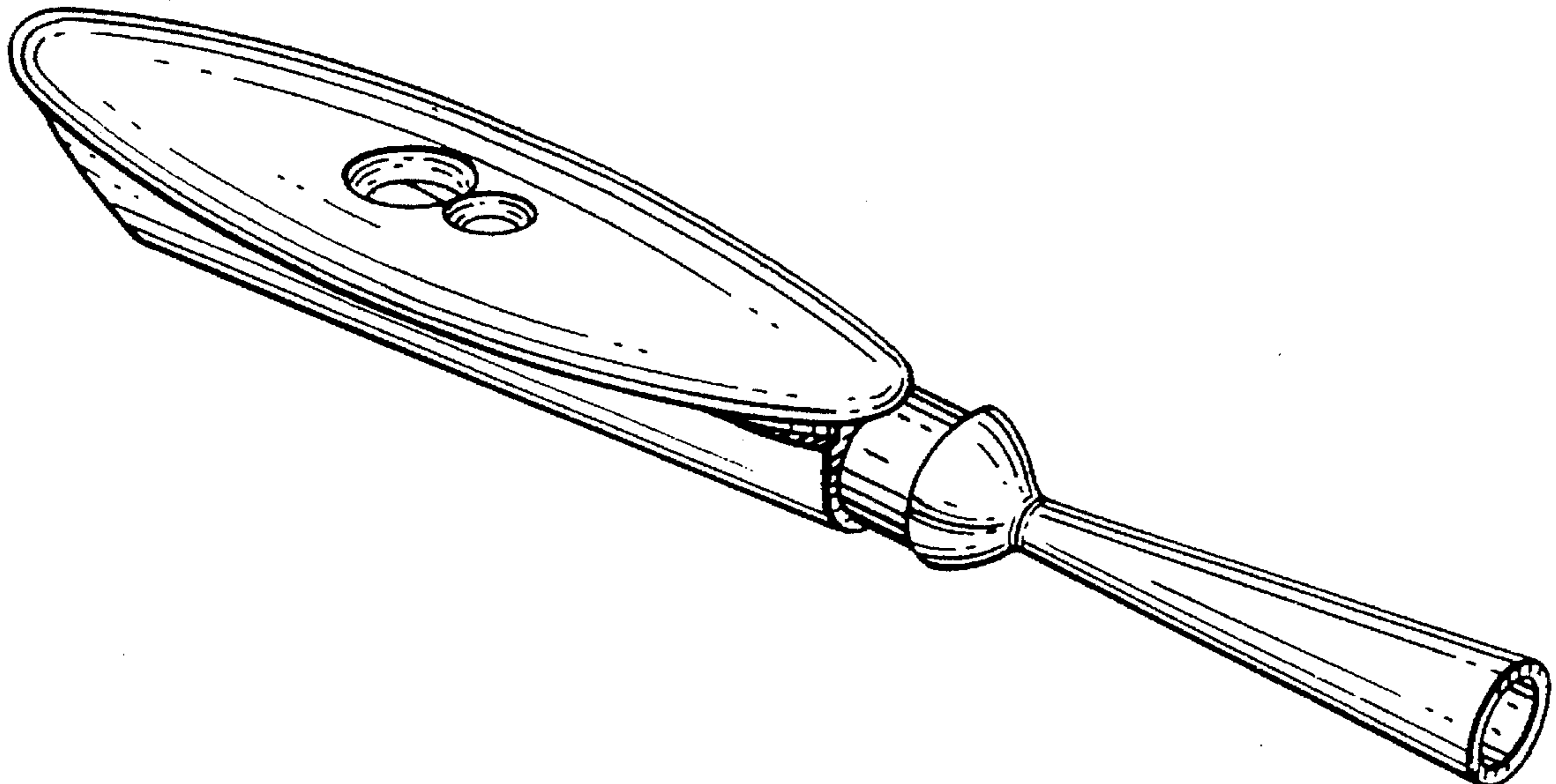

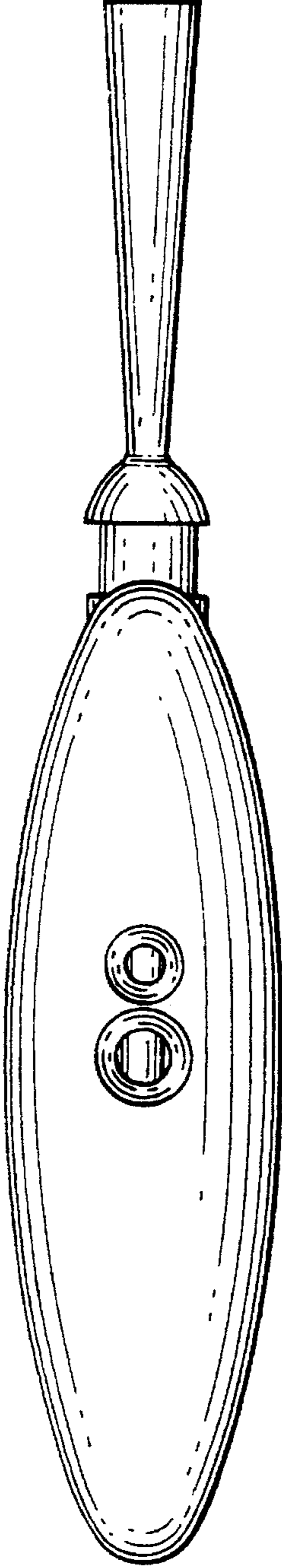

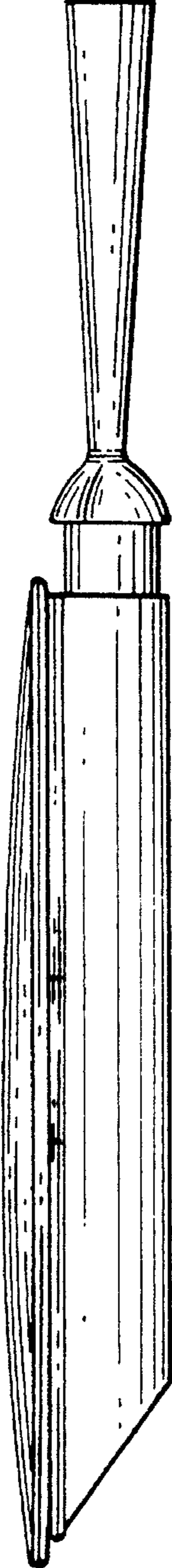
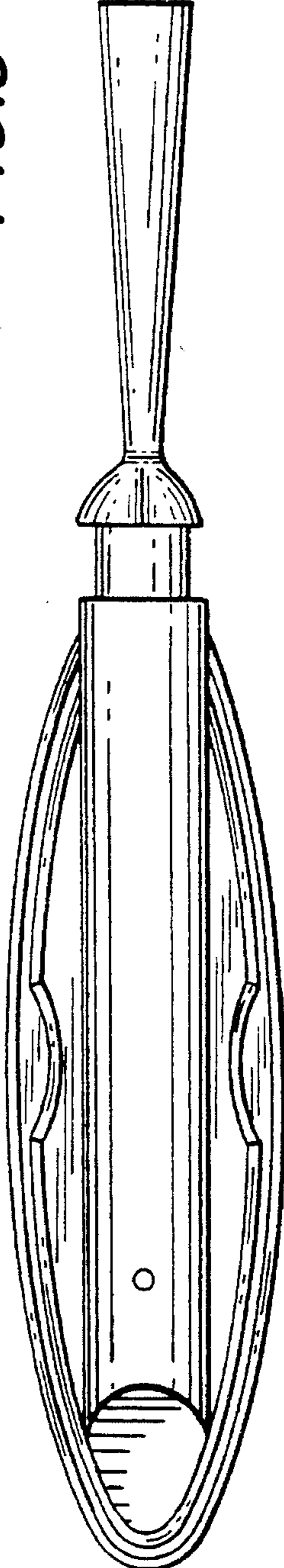
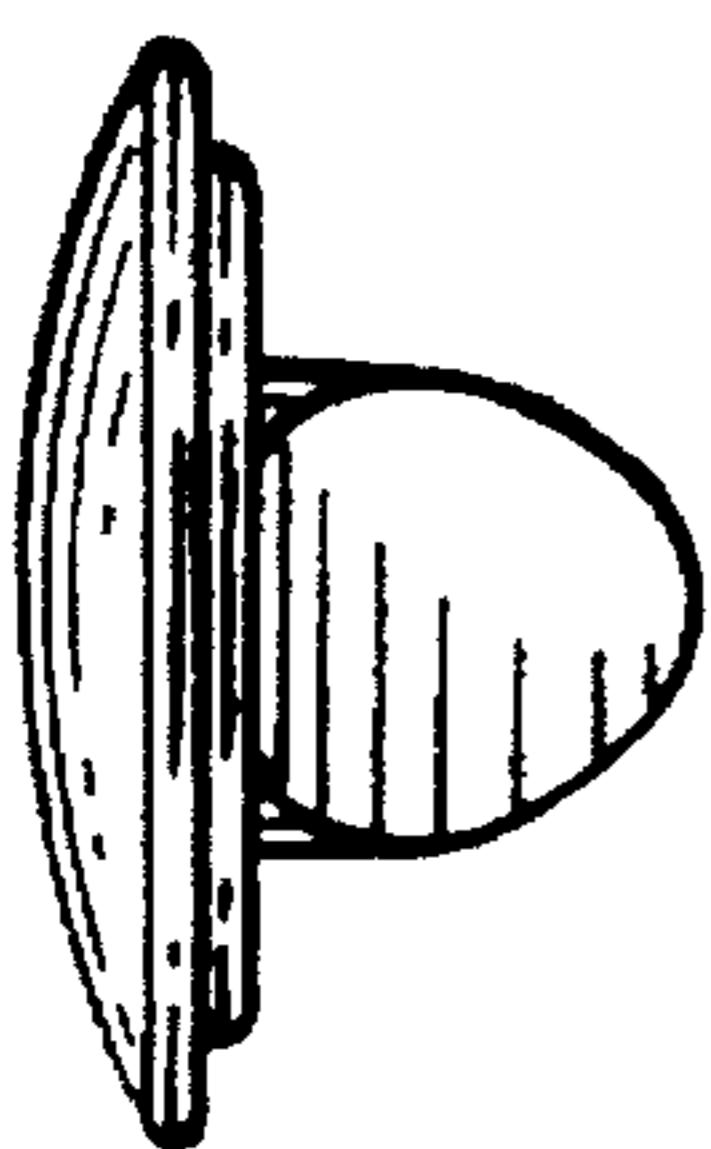


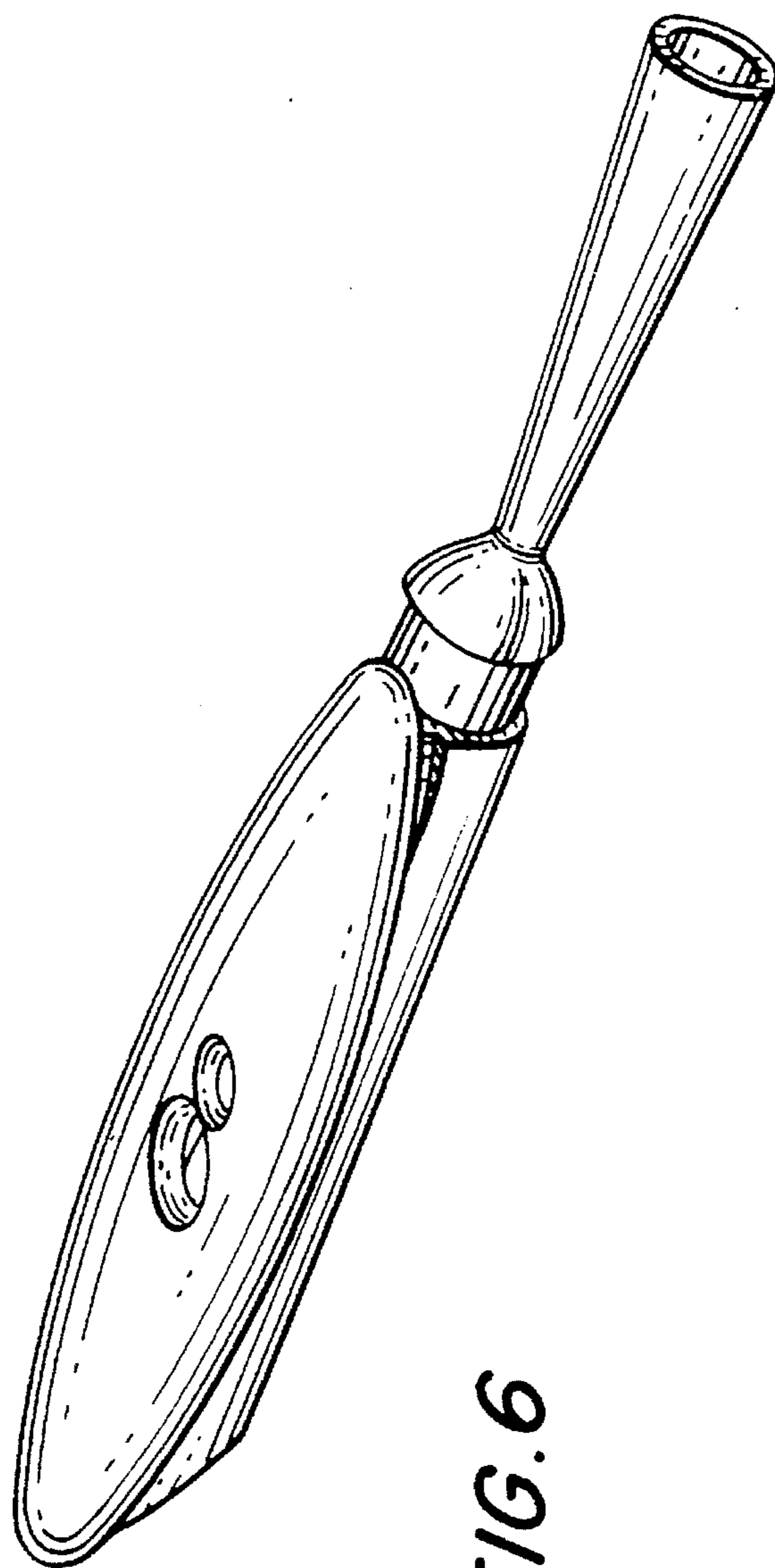
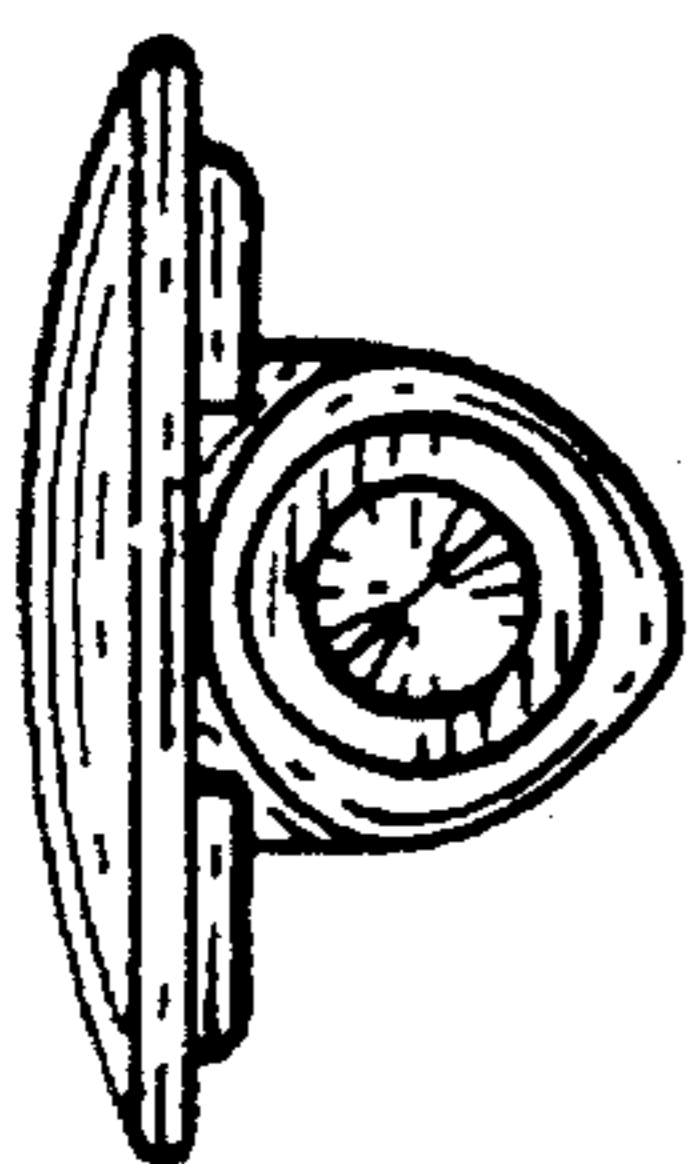

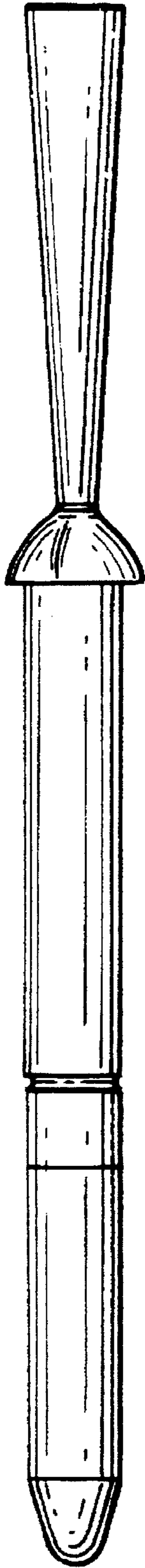

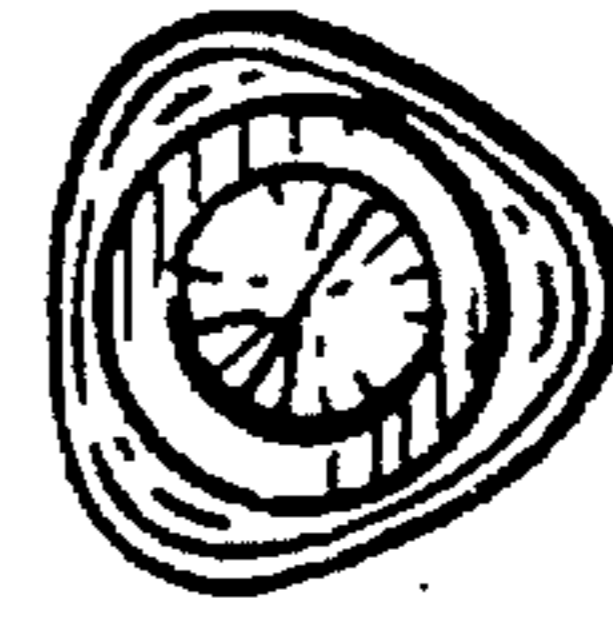

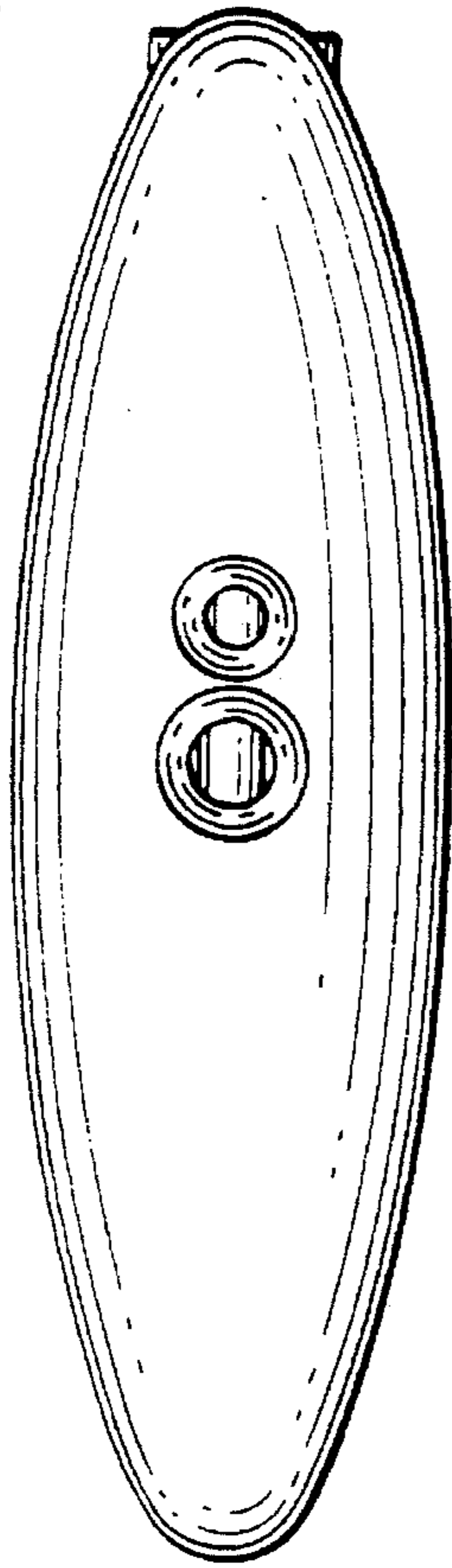

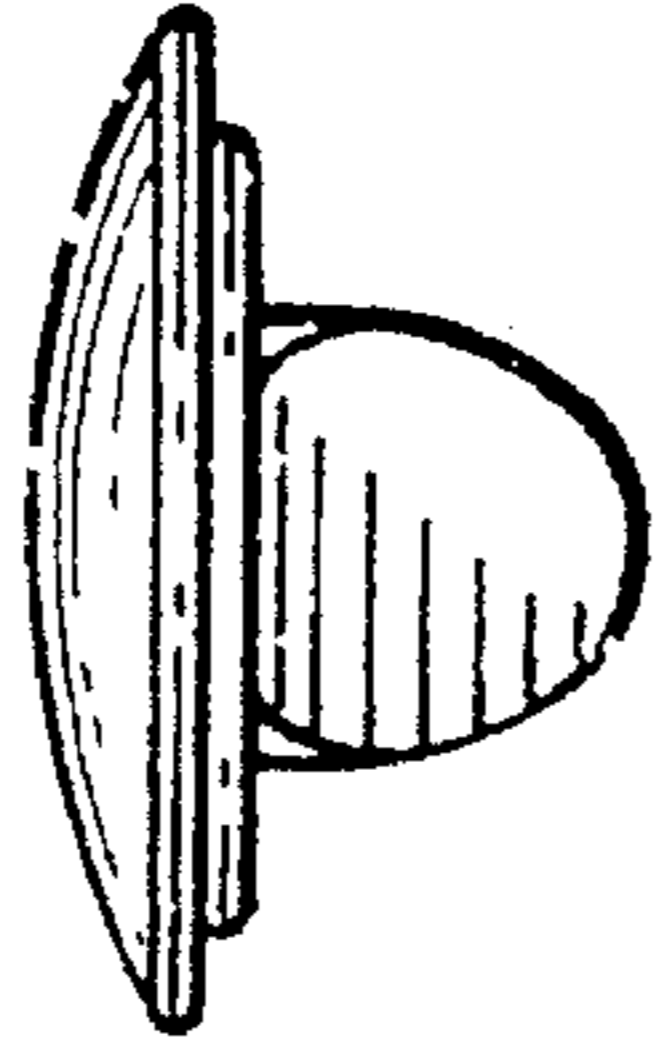

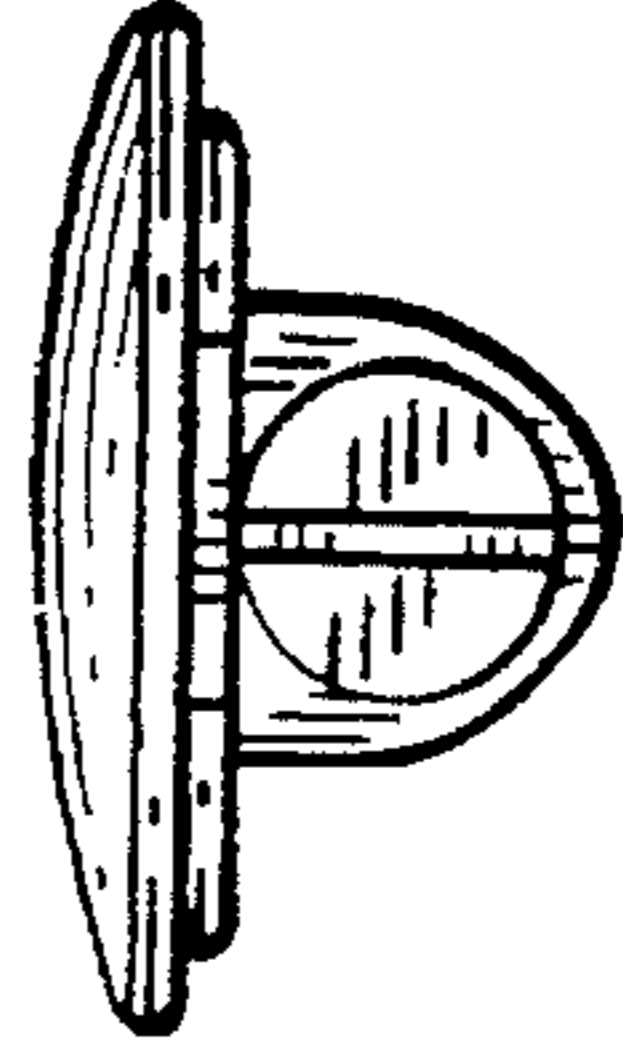

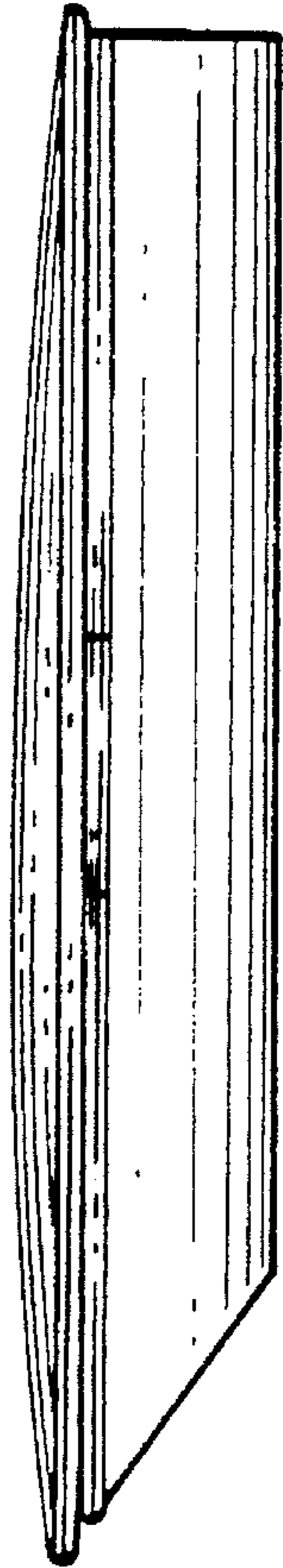
