FIG. 6 is a side elevational view as seen from the right side; and,

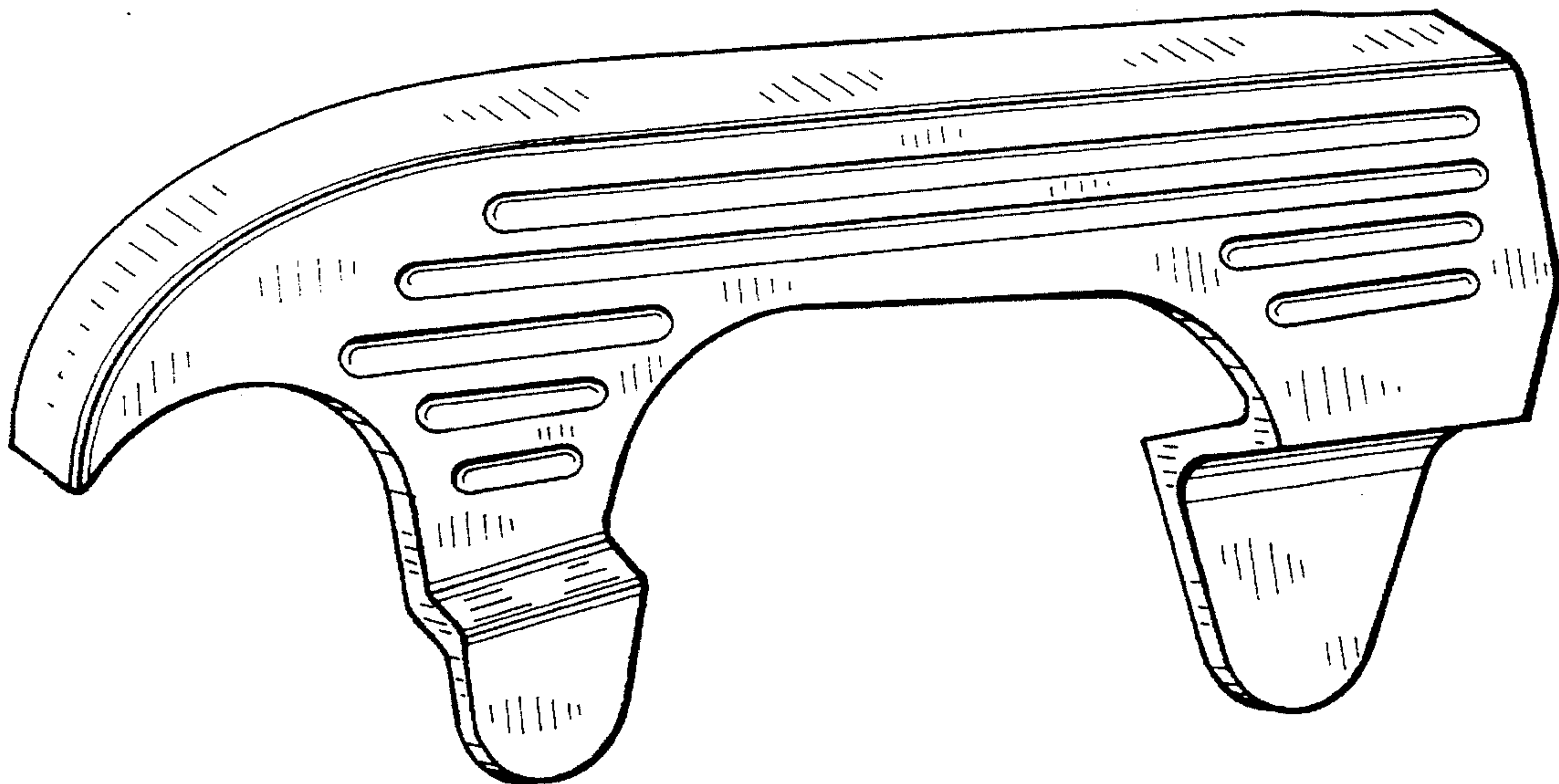
FIG. 7 is a side elevation view as seen from the left side.

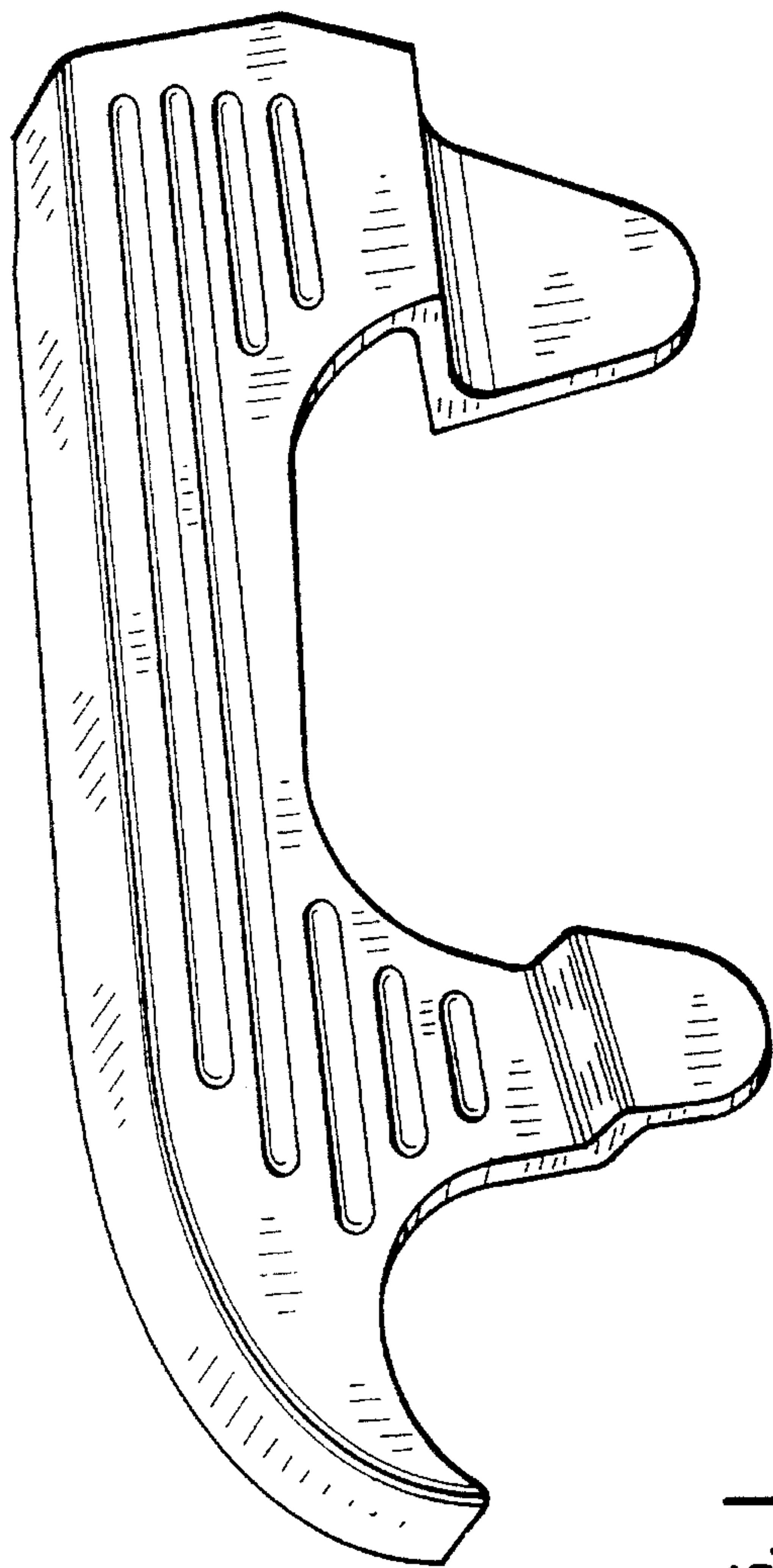

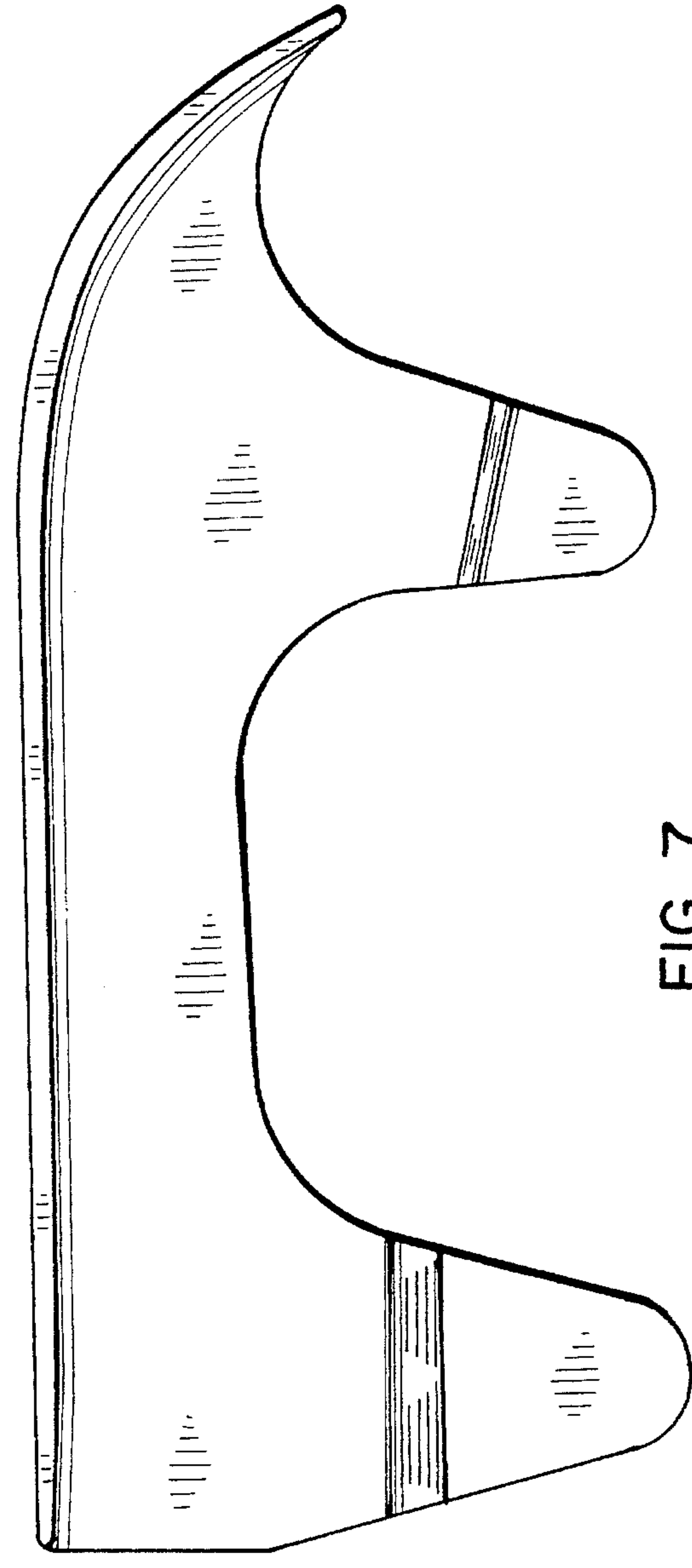

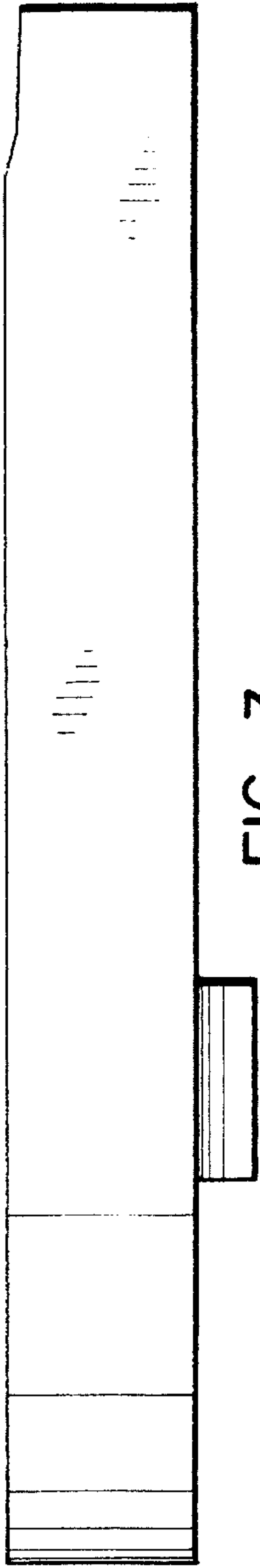

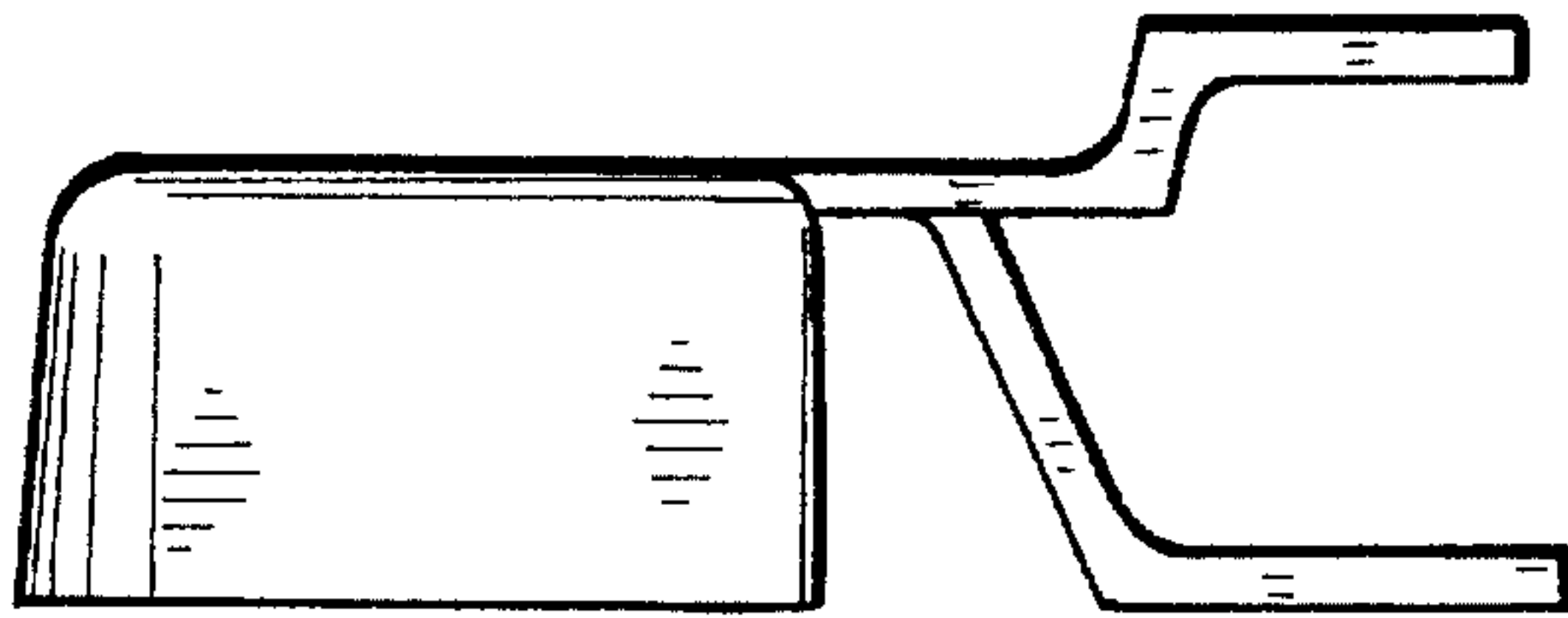

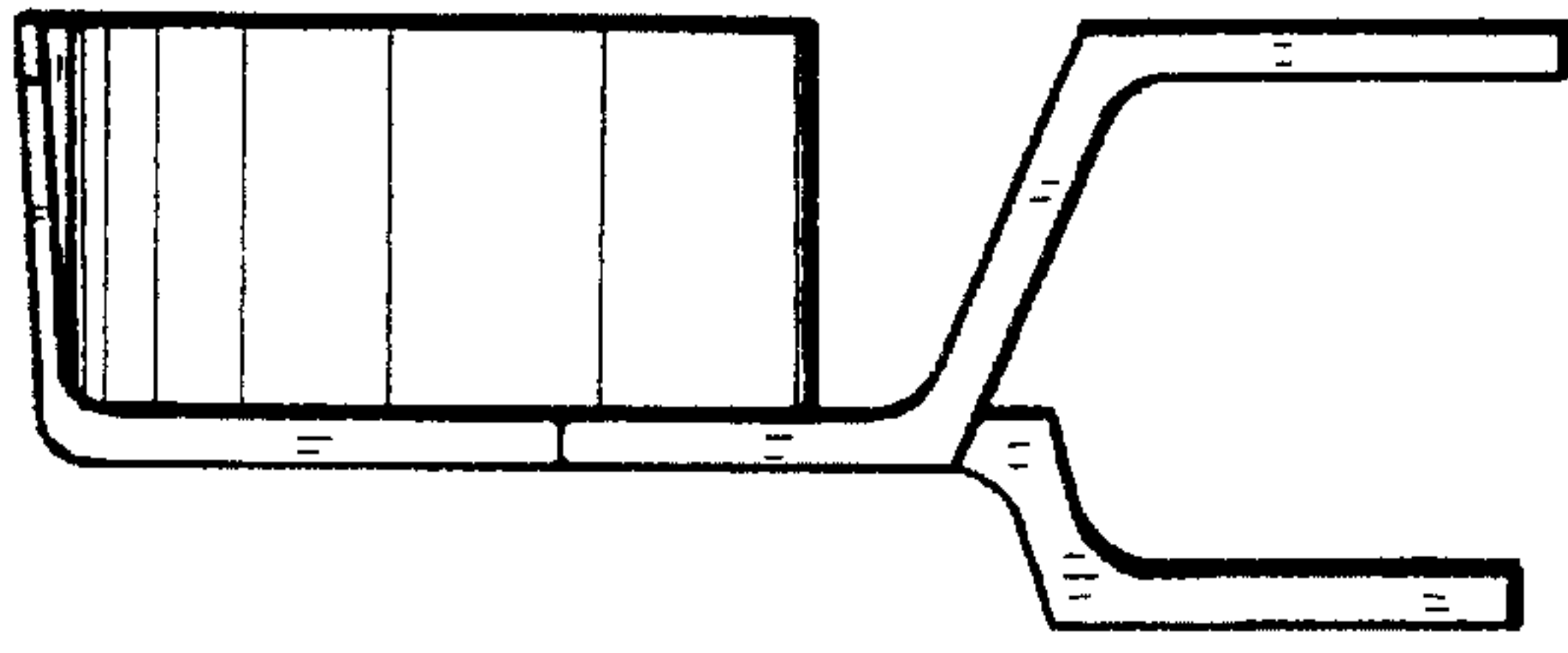

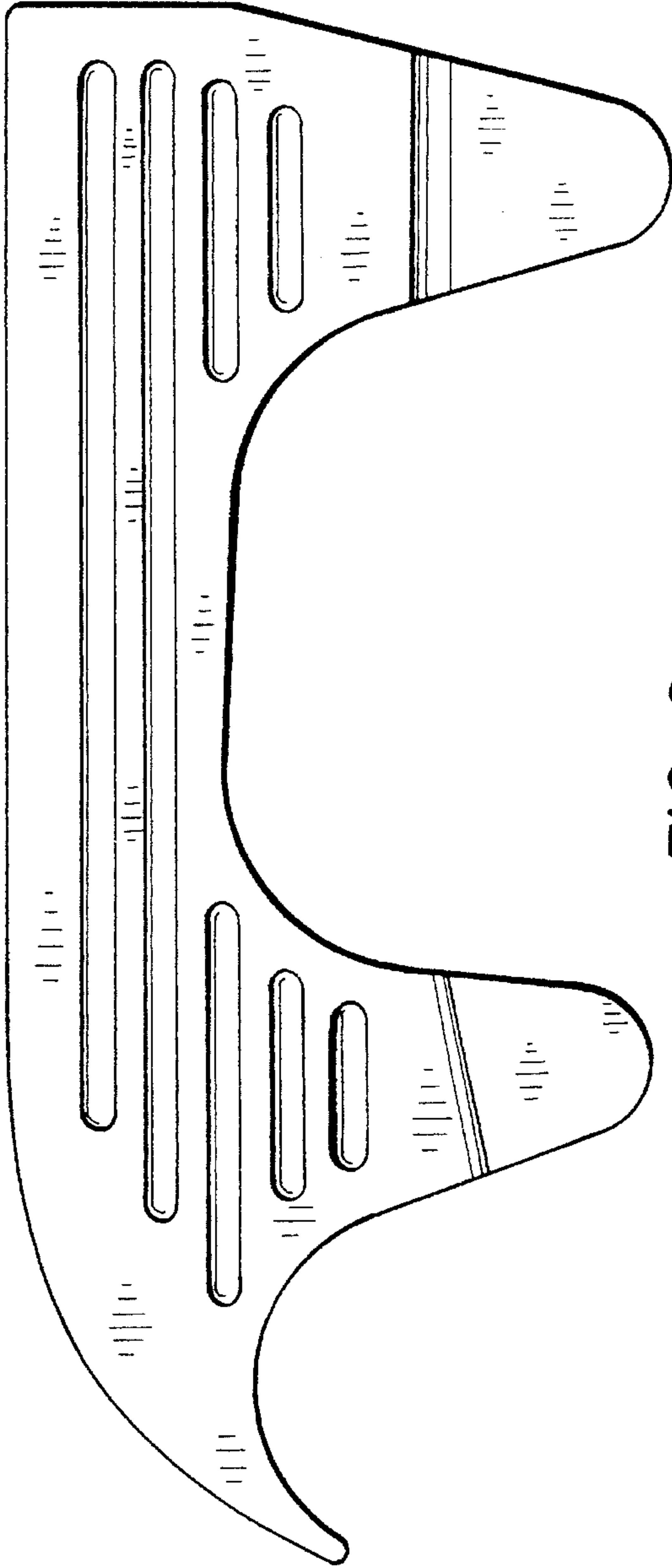

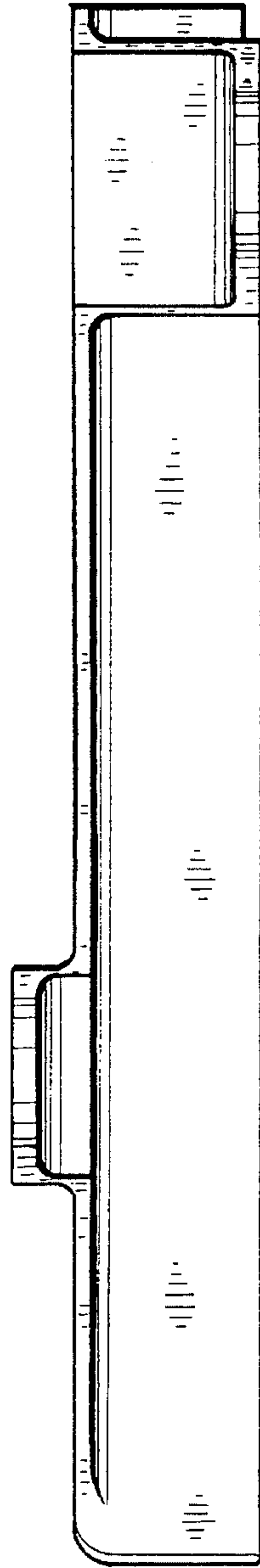

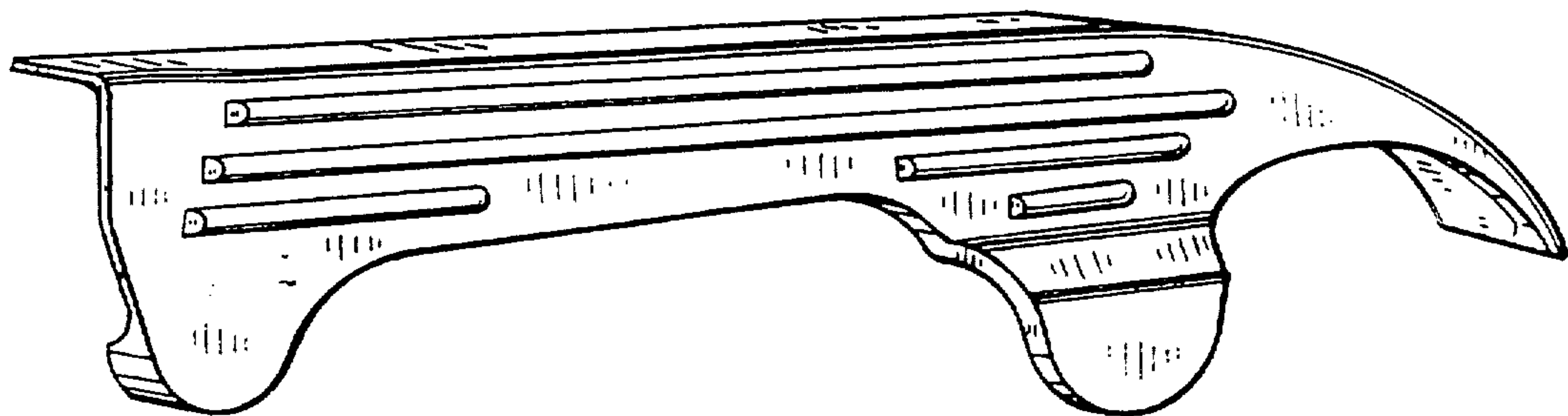

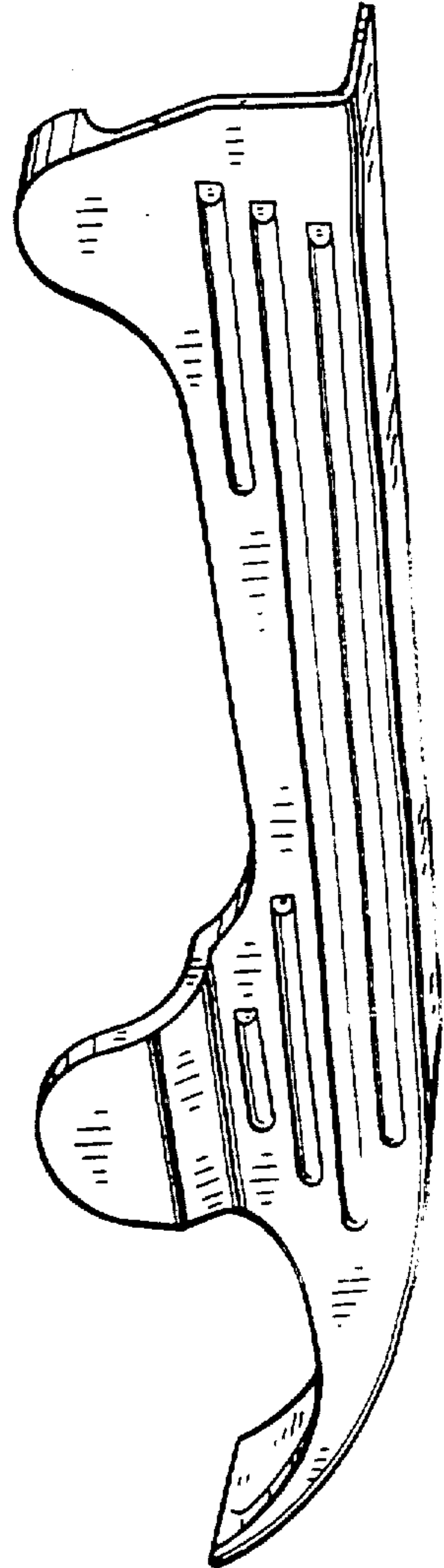

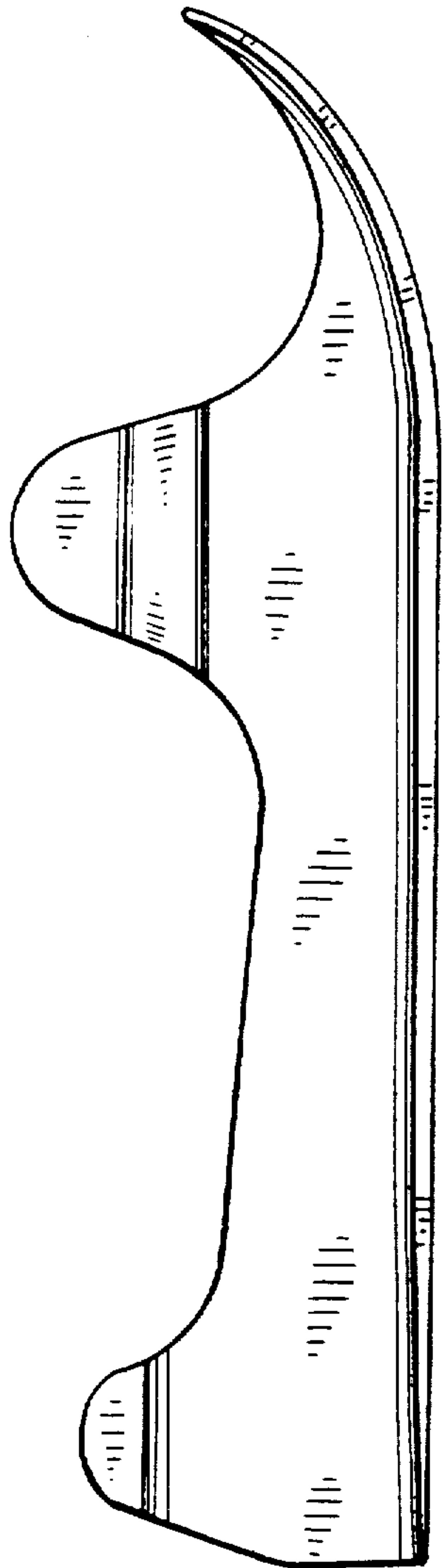

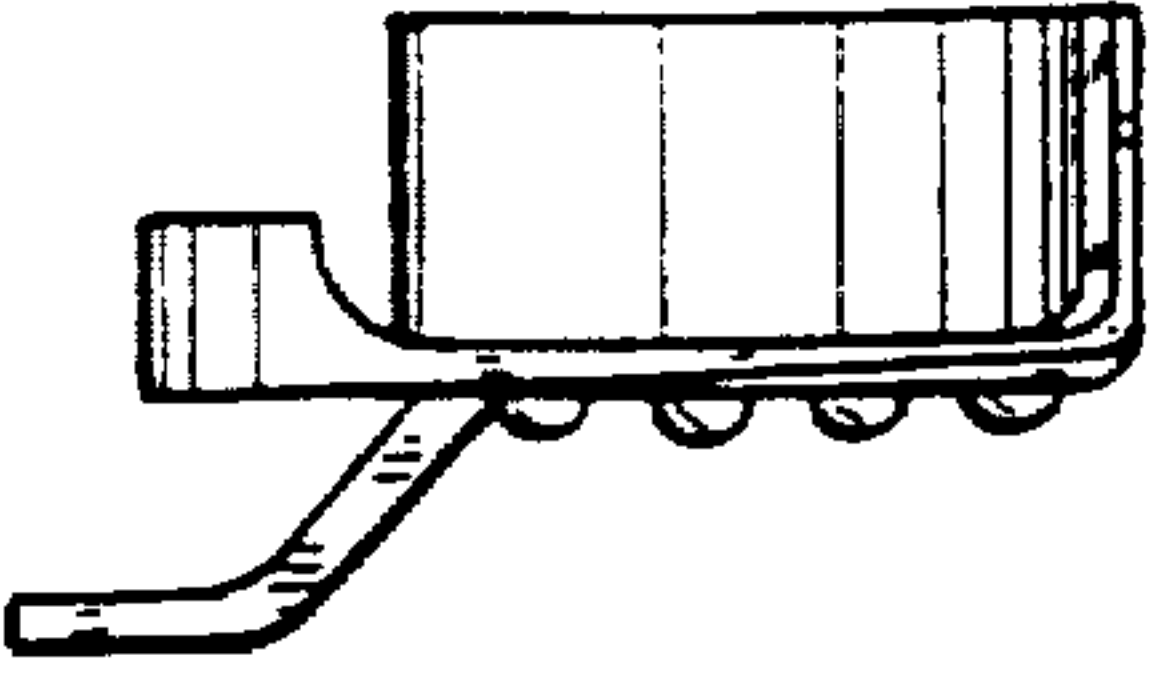

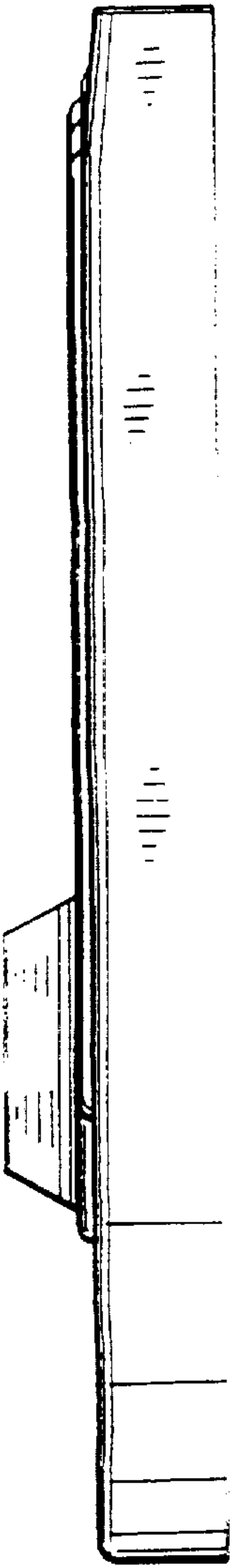

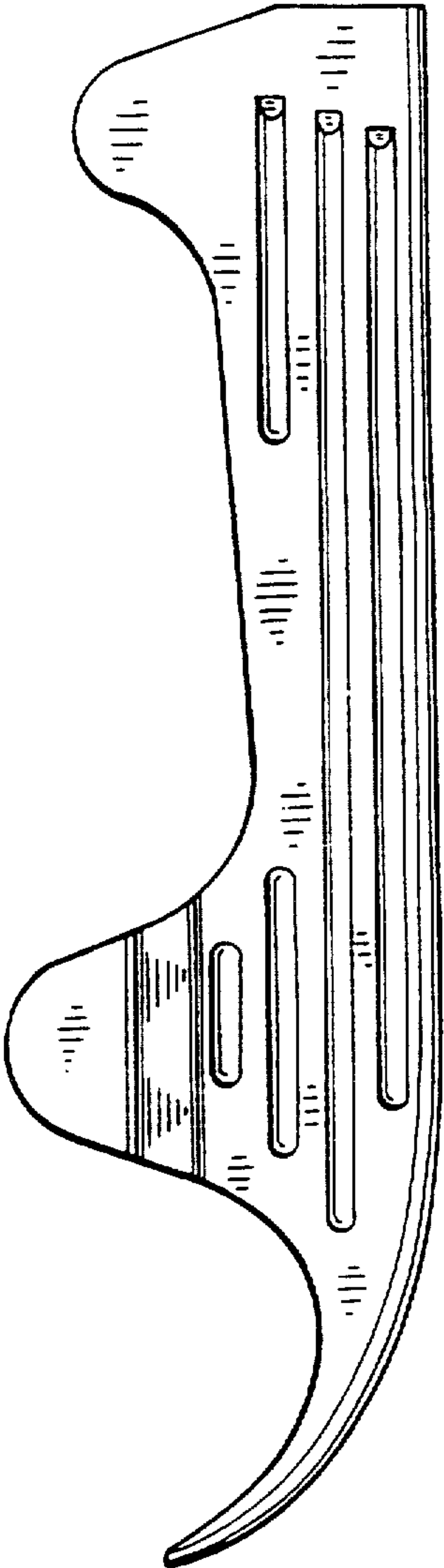

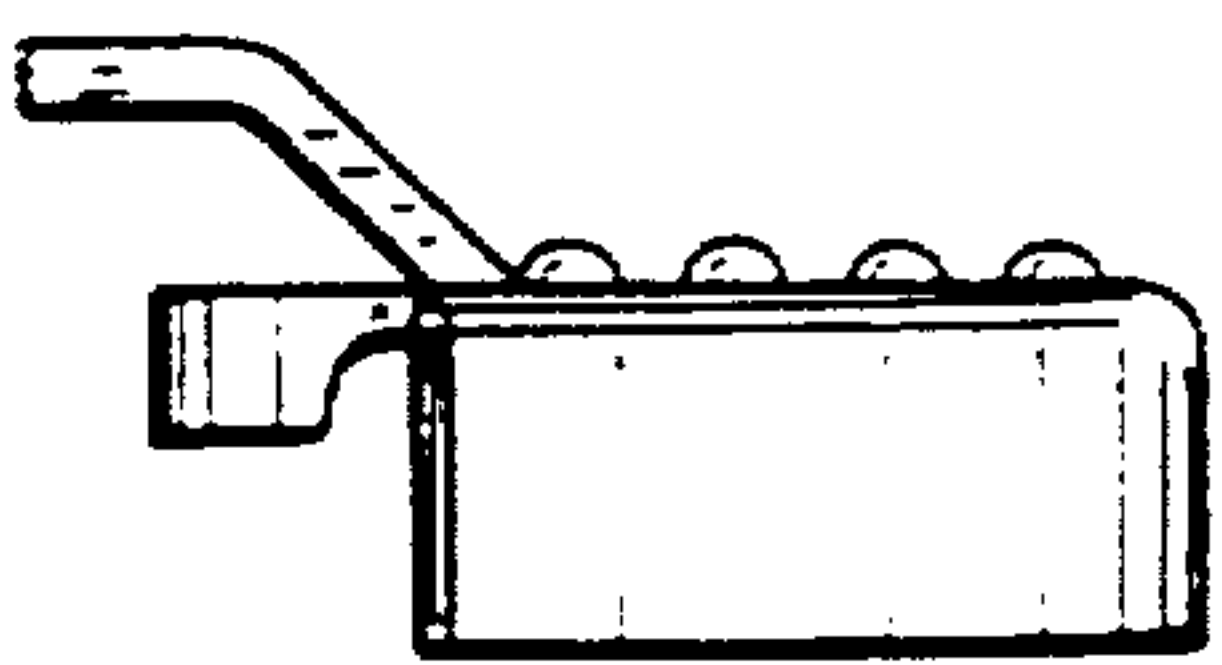

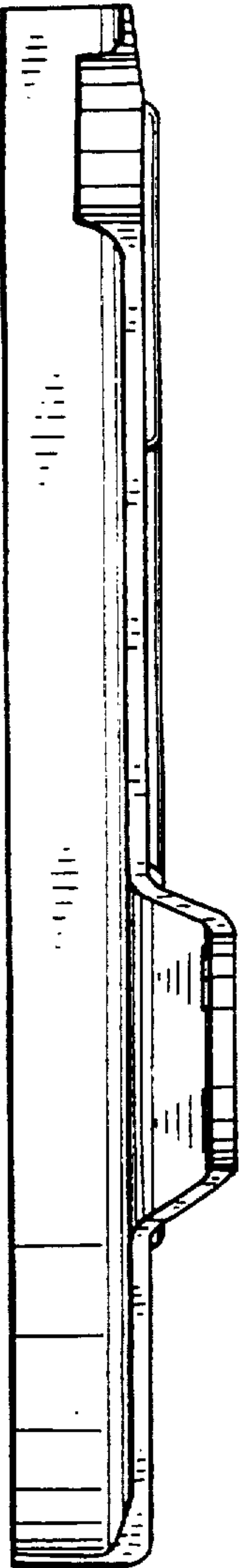
