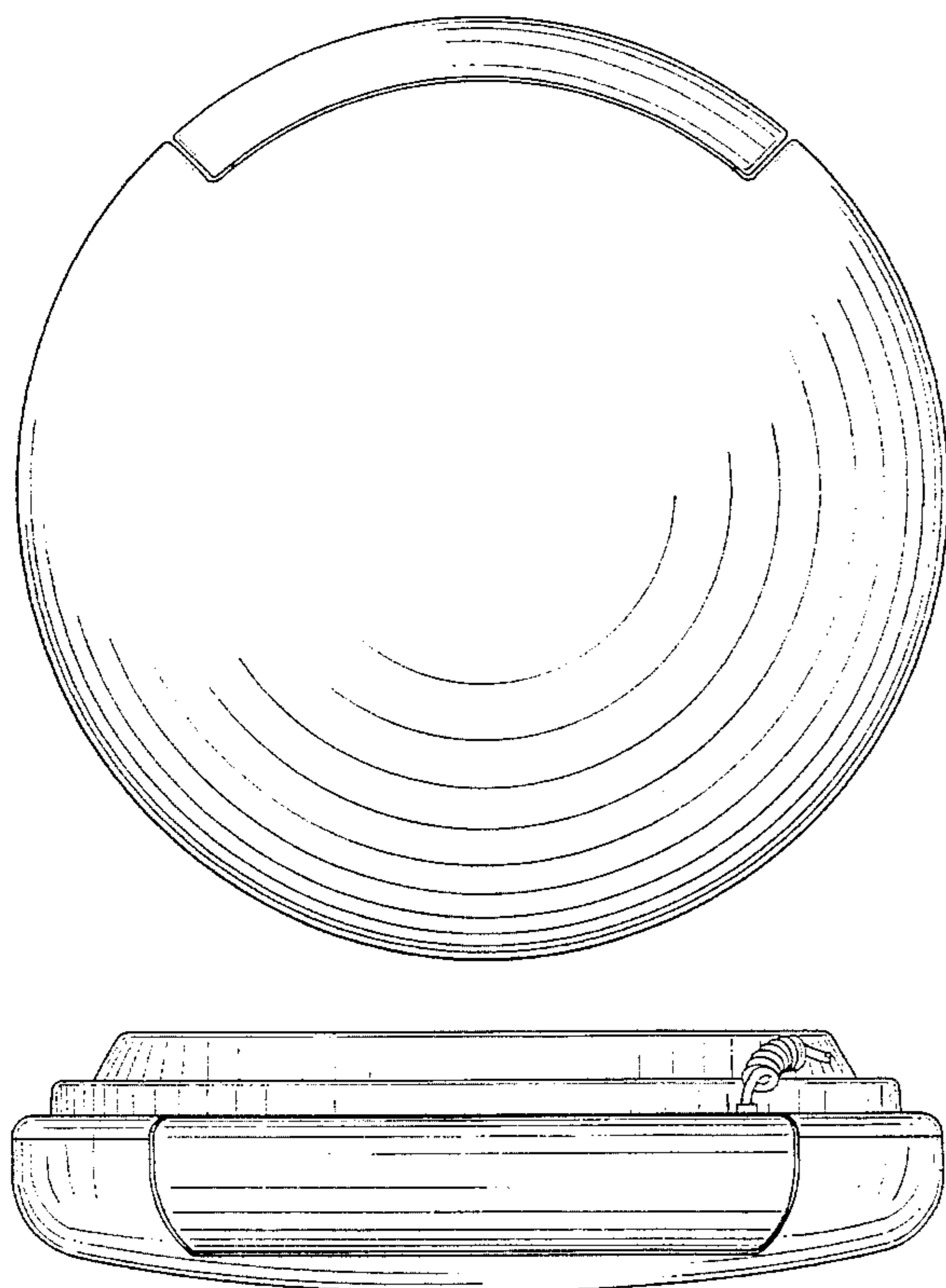
[57] **CLAIM**

The ornamental design for a disc telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a disc telephone showing my new design;  
FIG. 2 is a top plan view thereof, with the telephone cord broken away;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a rear elevational view thereof; and,  
FIG. 6 is a bottom view shown in reference to the rear view.

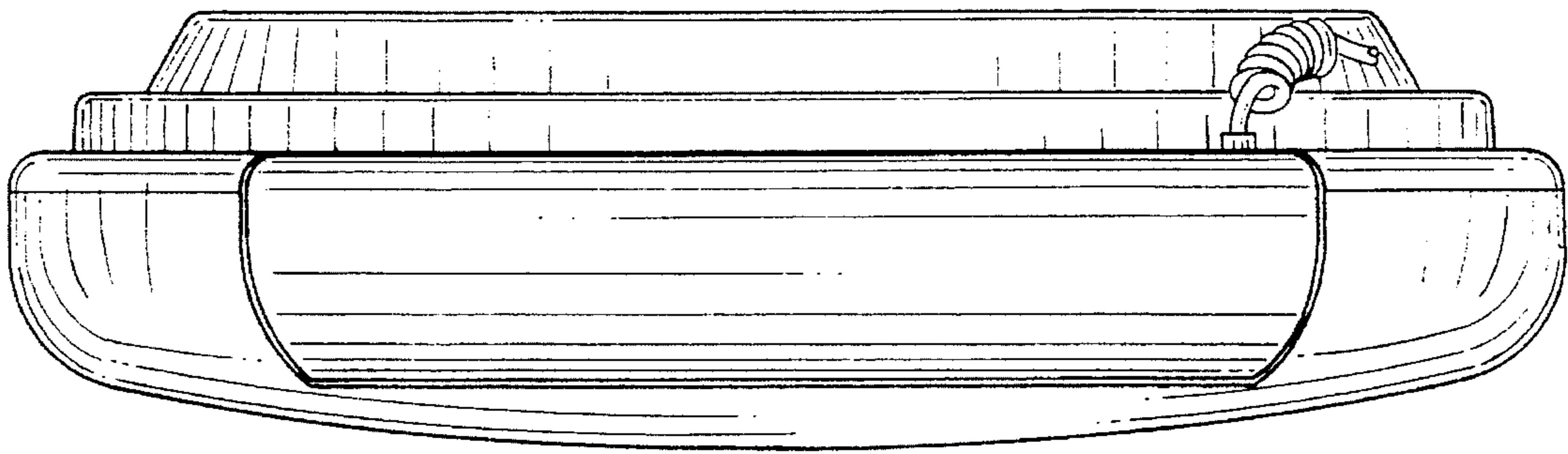

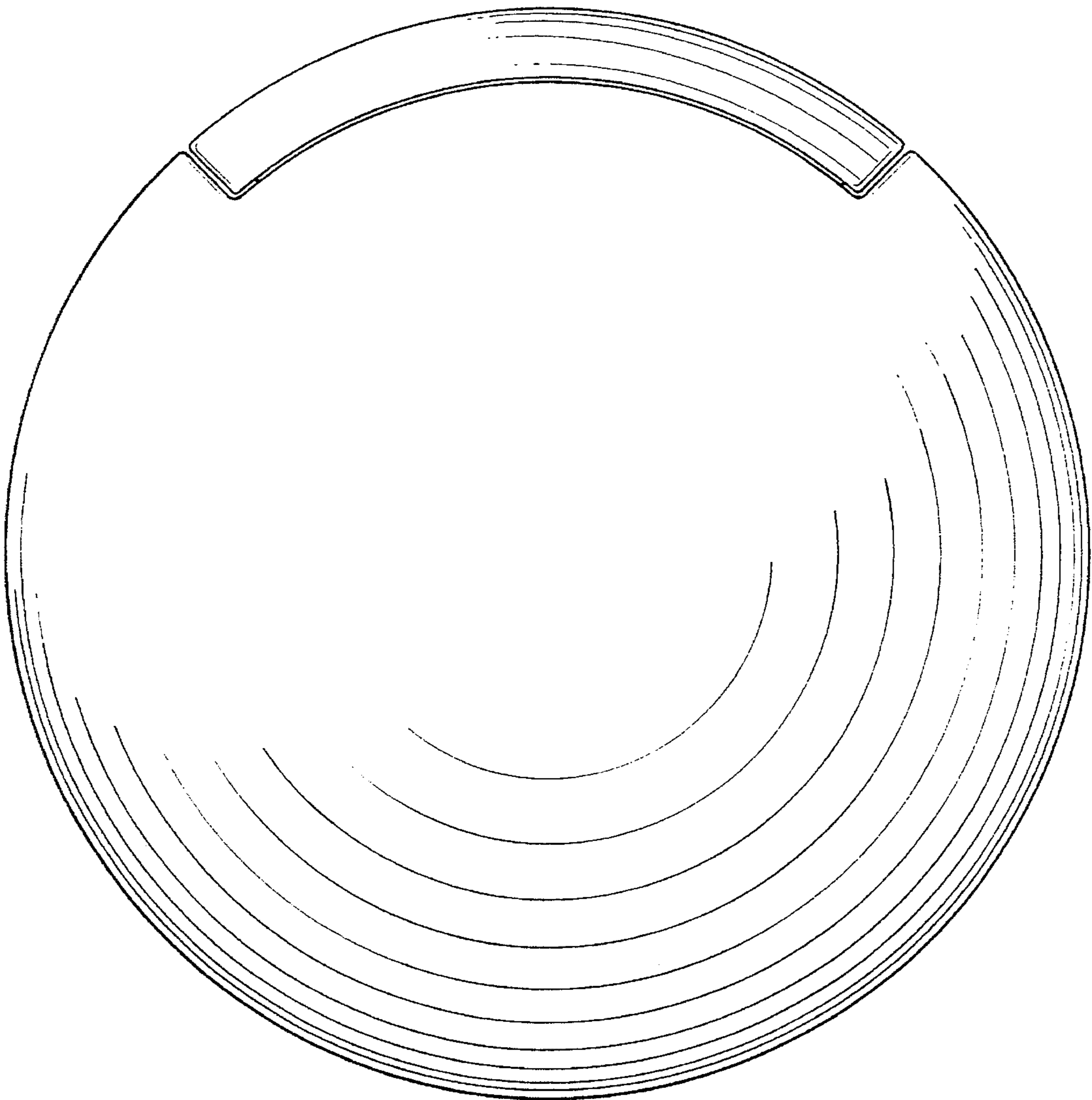

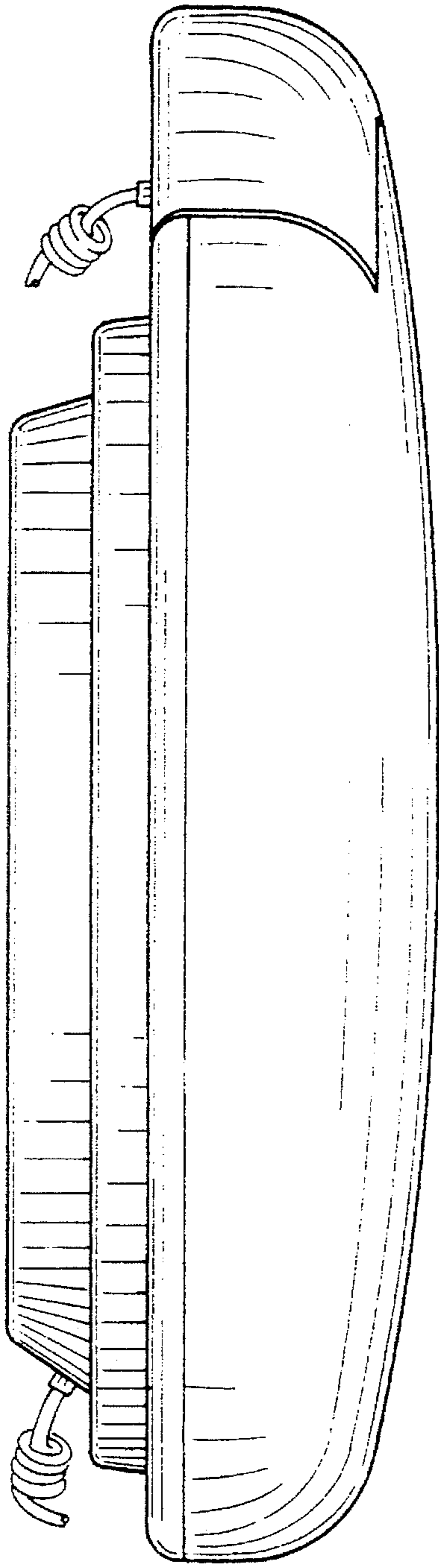

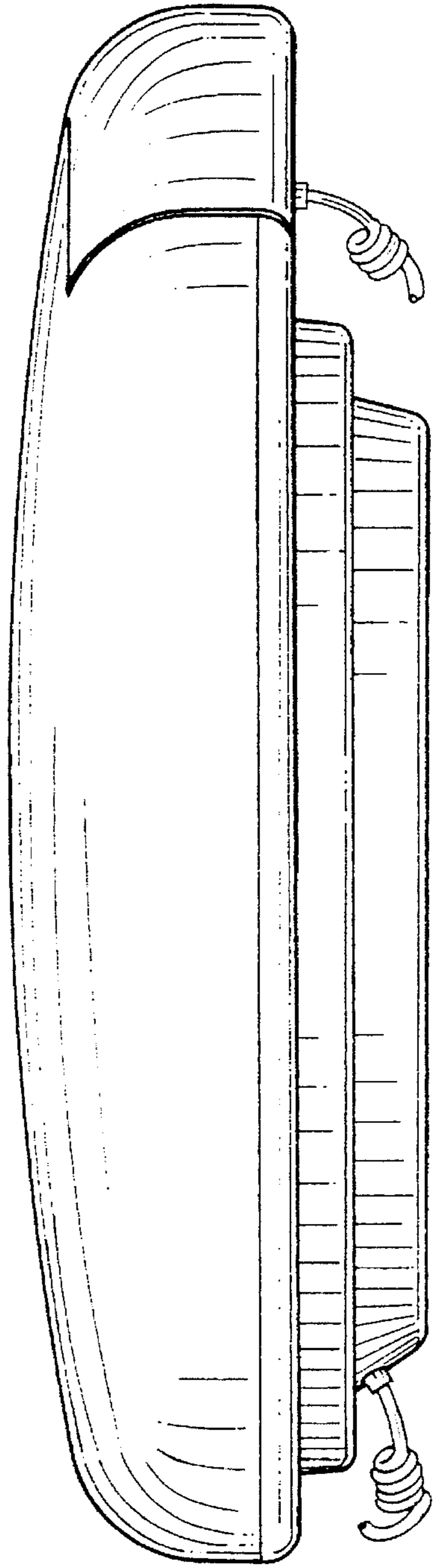

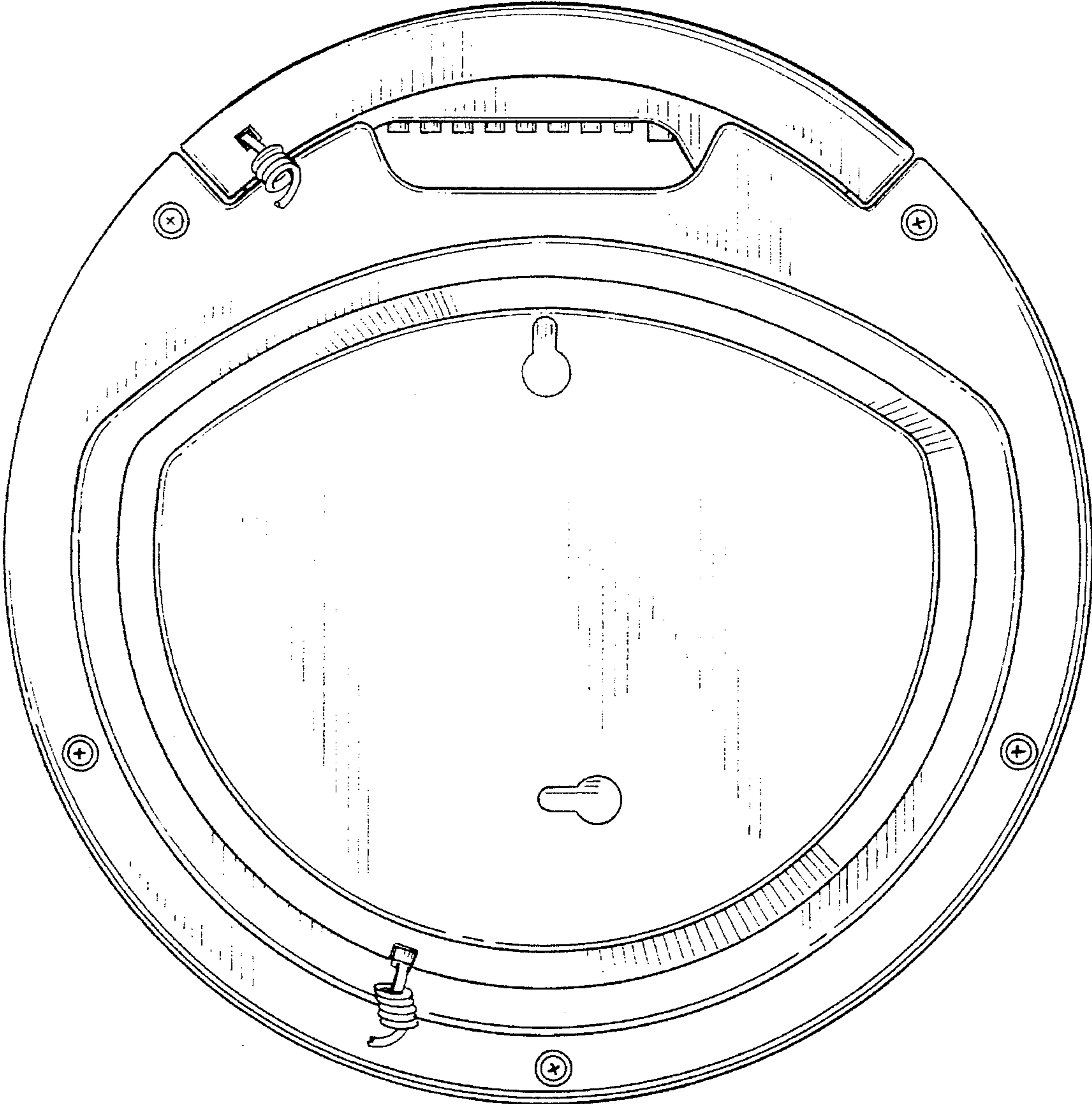

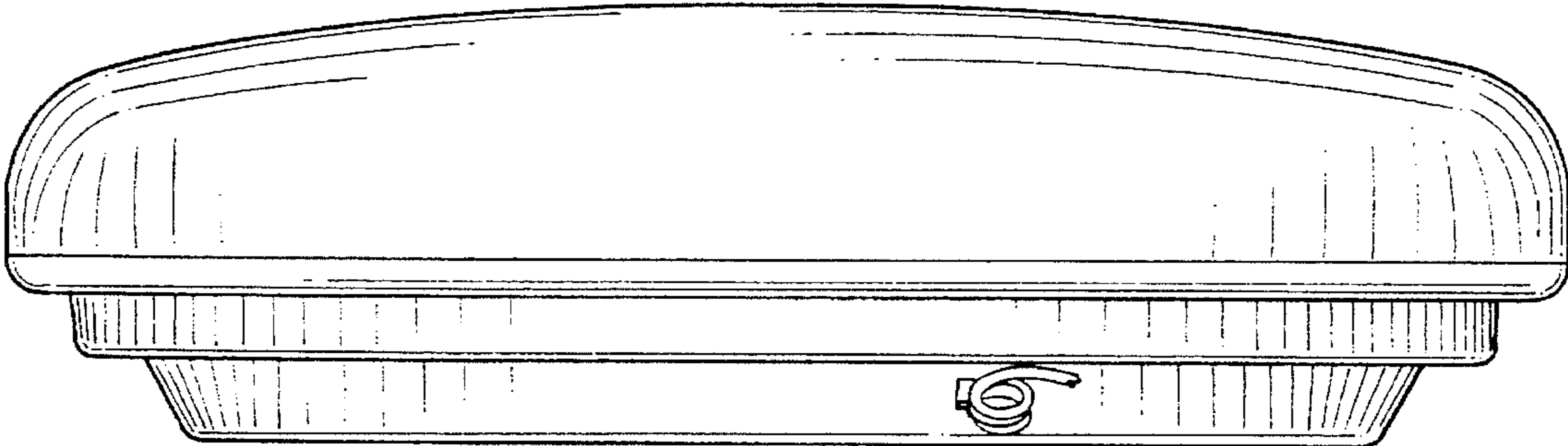
