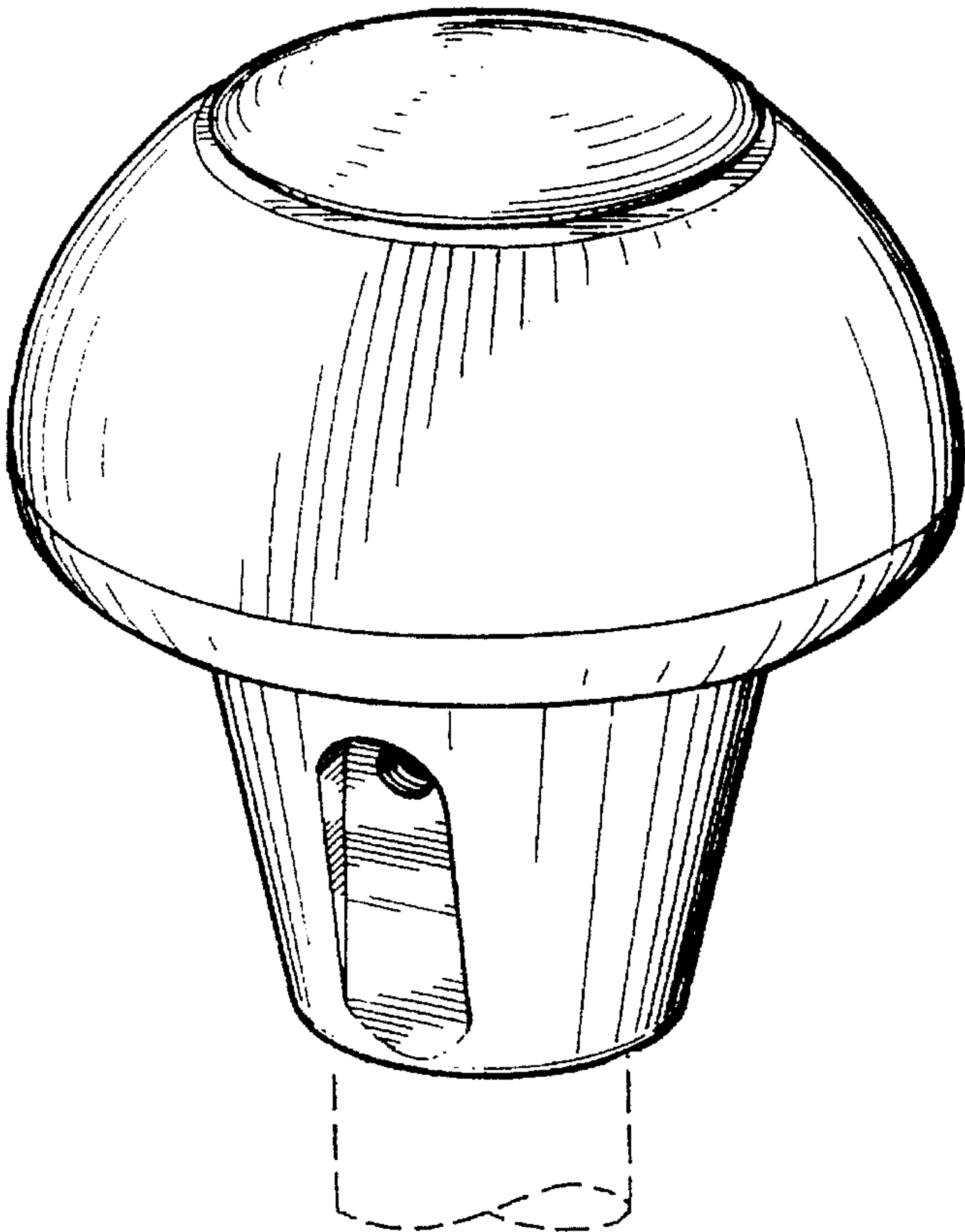
[57] **CLAIM**

The ornamental design for the marine pole light, as shown
and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the marine pole light
showing our new design;
FIG. 2 is a right side elevational view of FIG. 1, the left side
elevational view being a mirror image of that shown;
FIG. 3 is a rear elevational view of FIG. 1;
FIG. 4 is a front elevational view of FIG. 1;
FIG. 5 is a top plan view of FIG. 1; and,
FIG. 6 is a bottom plan view of FIG. 1.

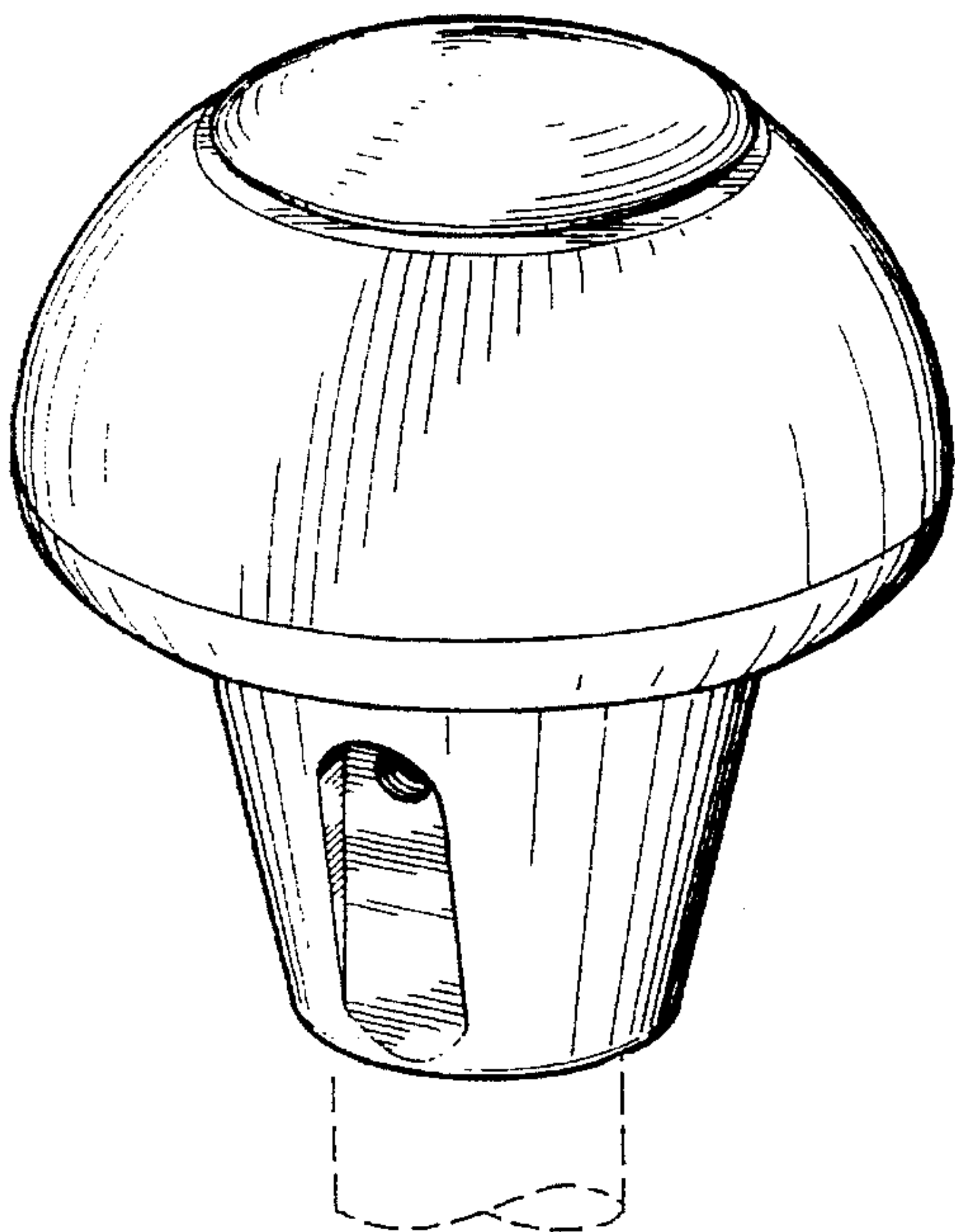

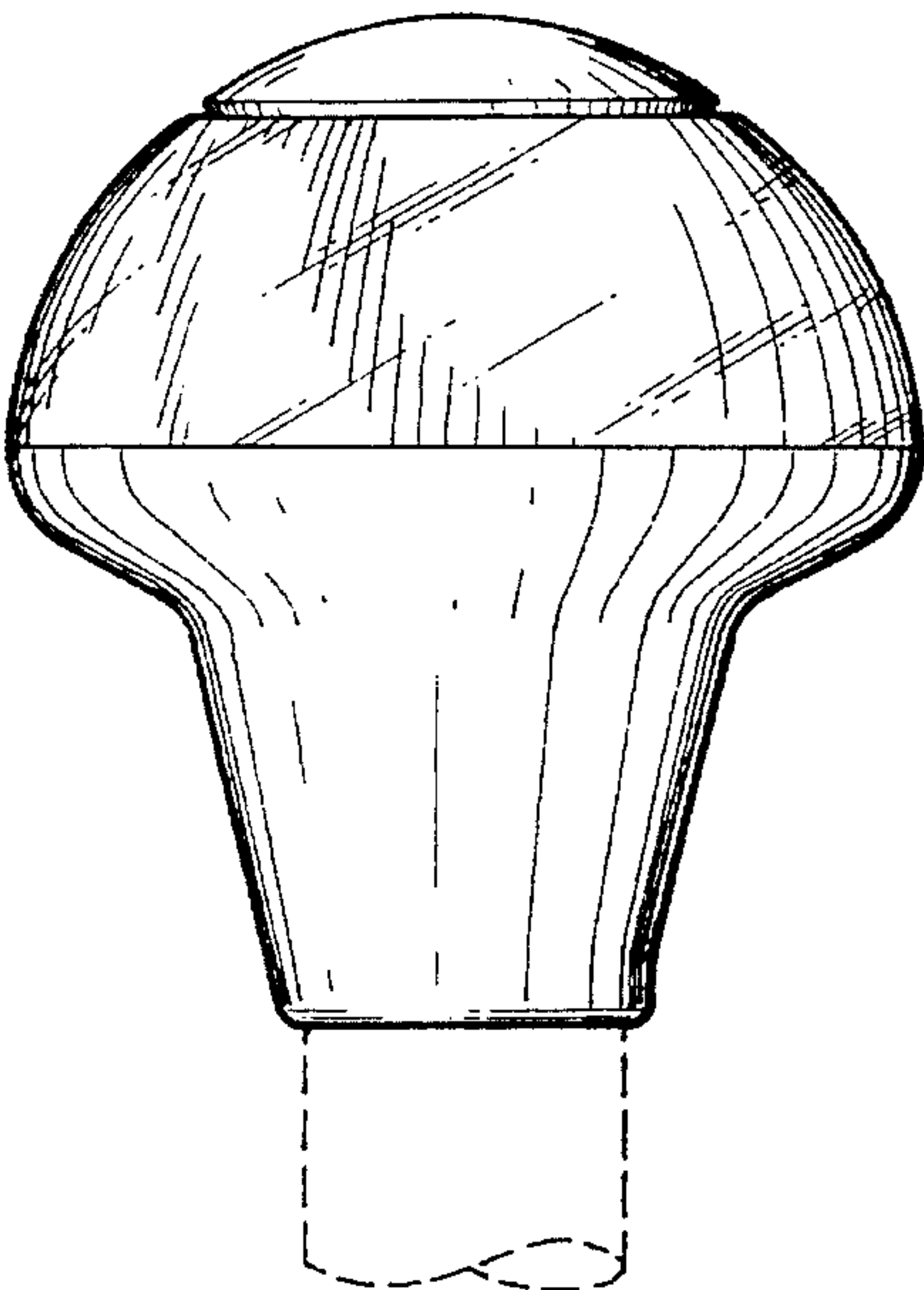

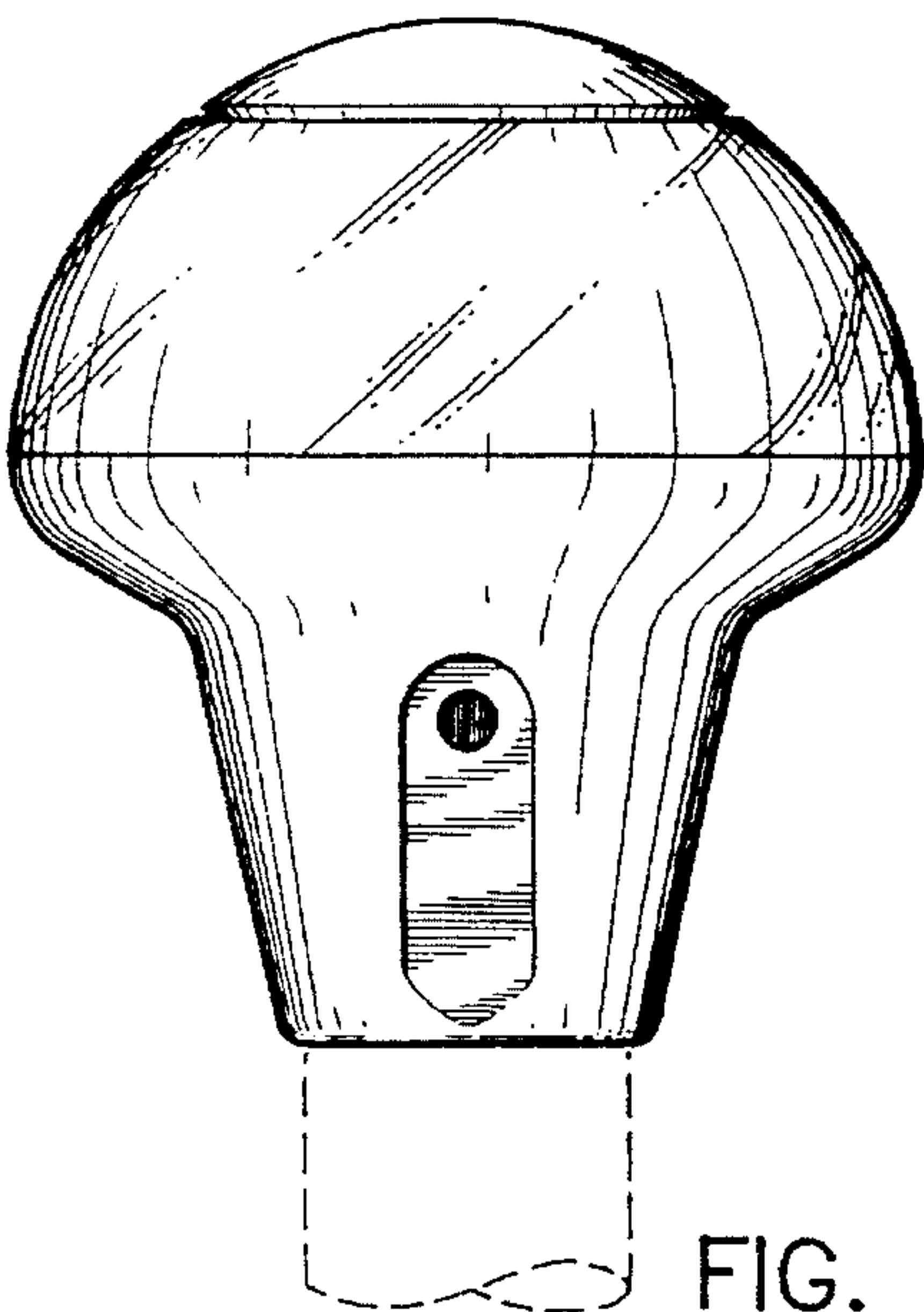

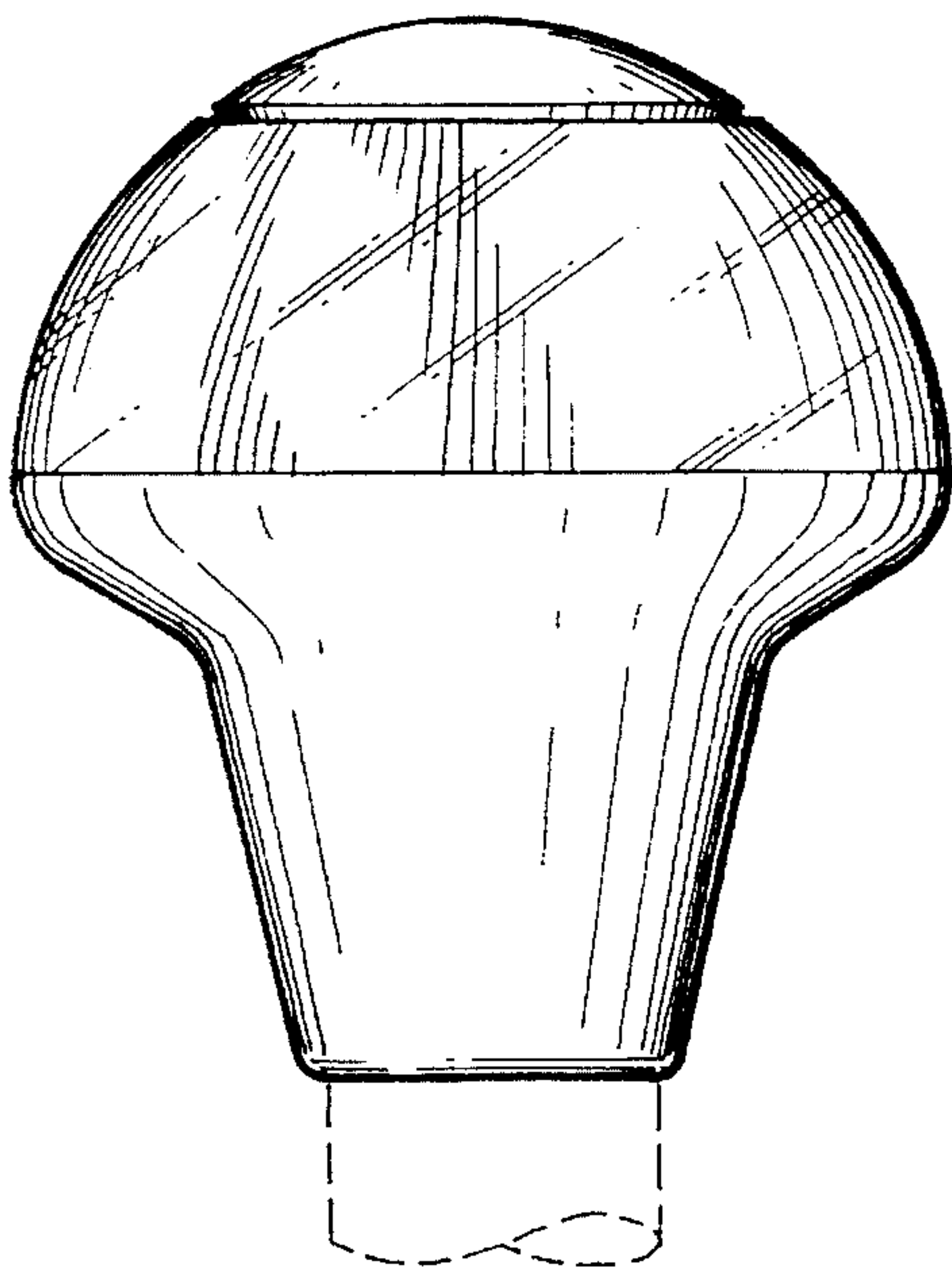

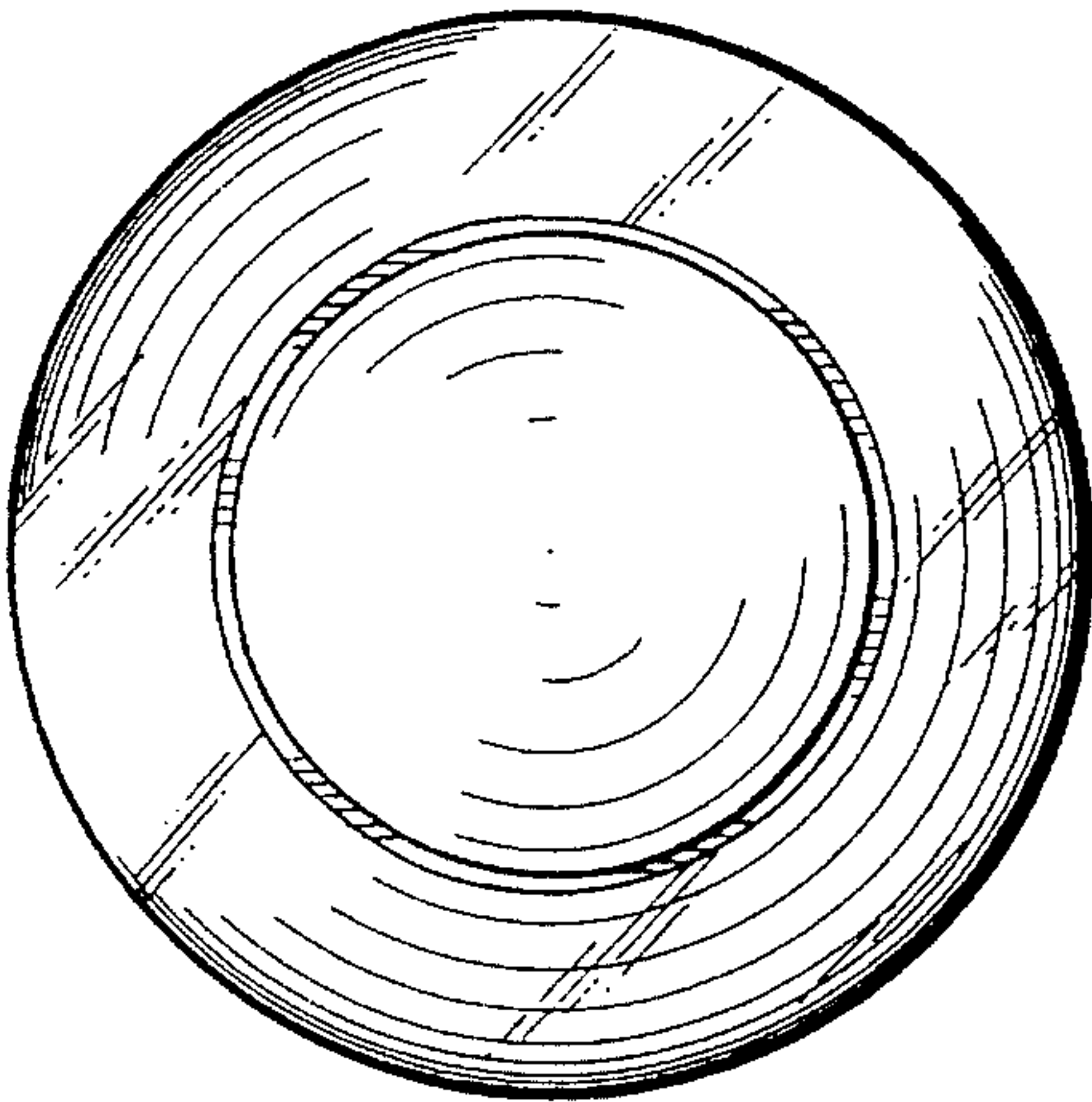

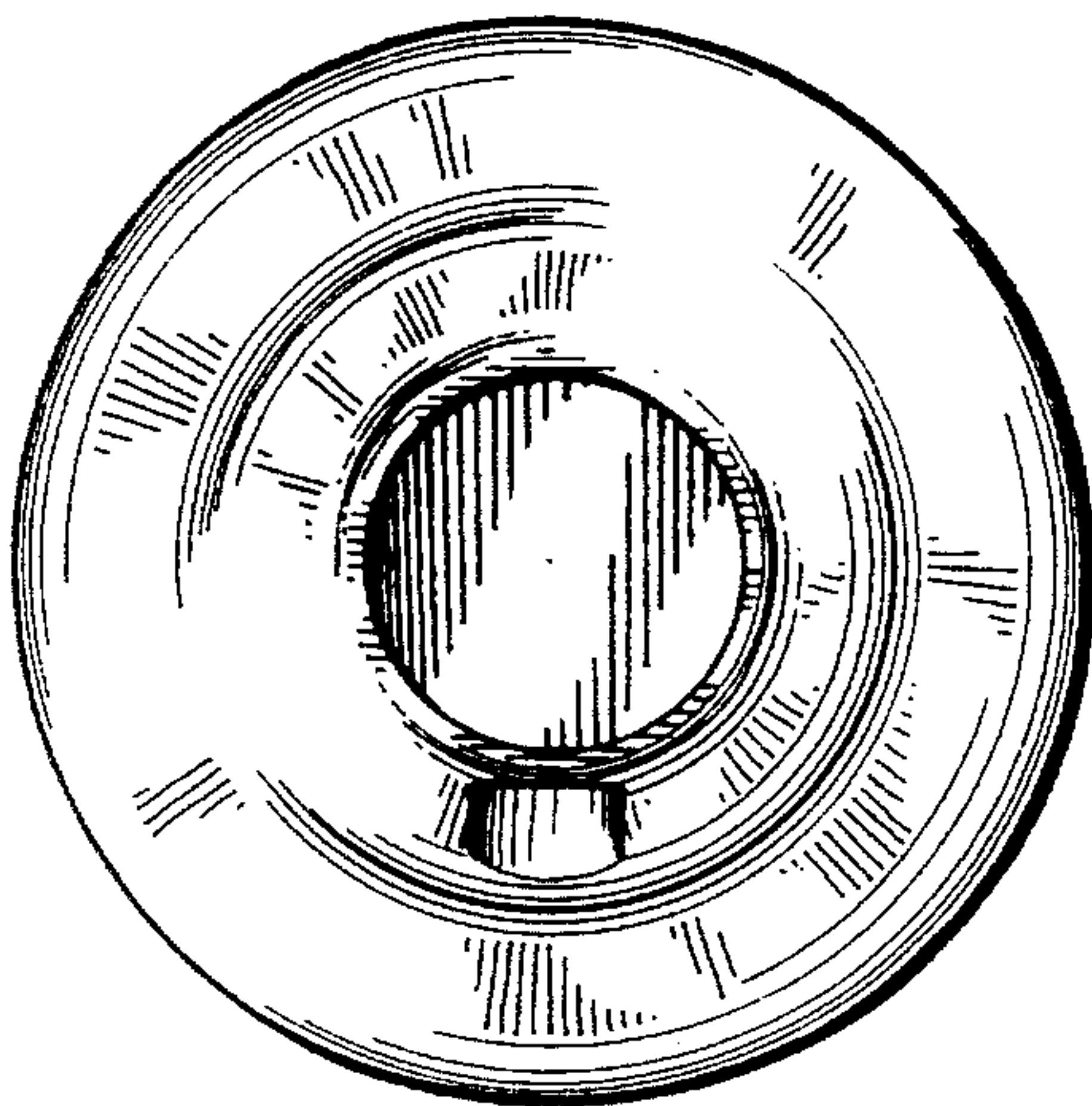
