The ornamental design for food product, as shown and described.

DESCRIPTION

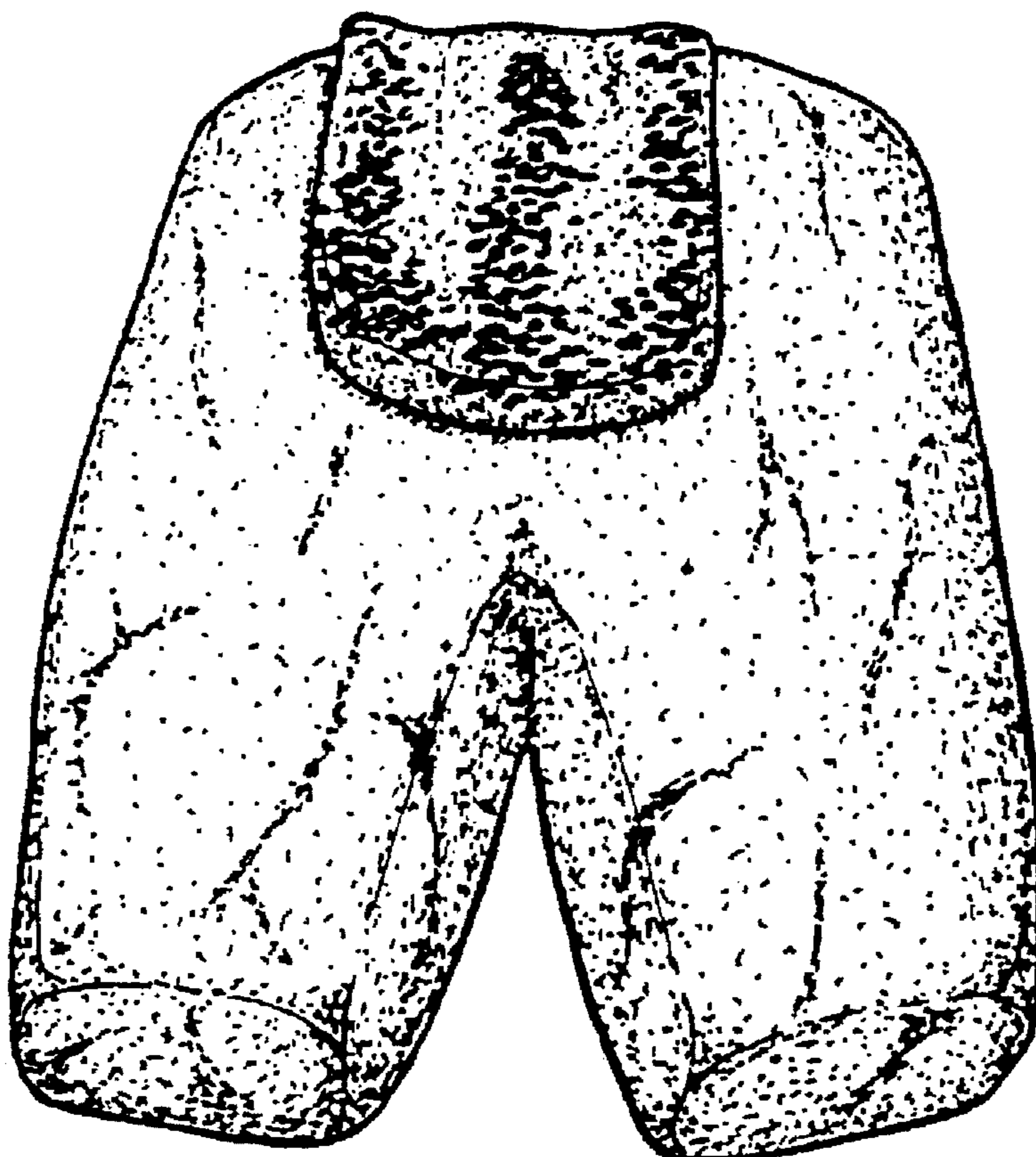

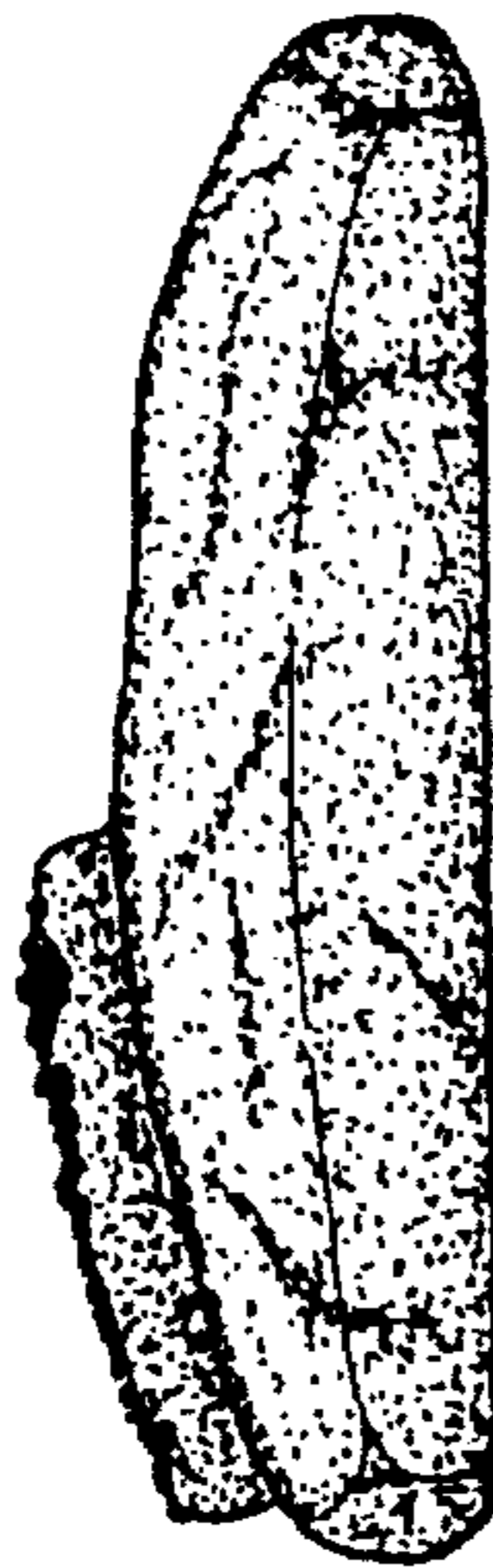

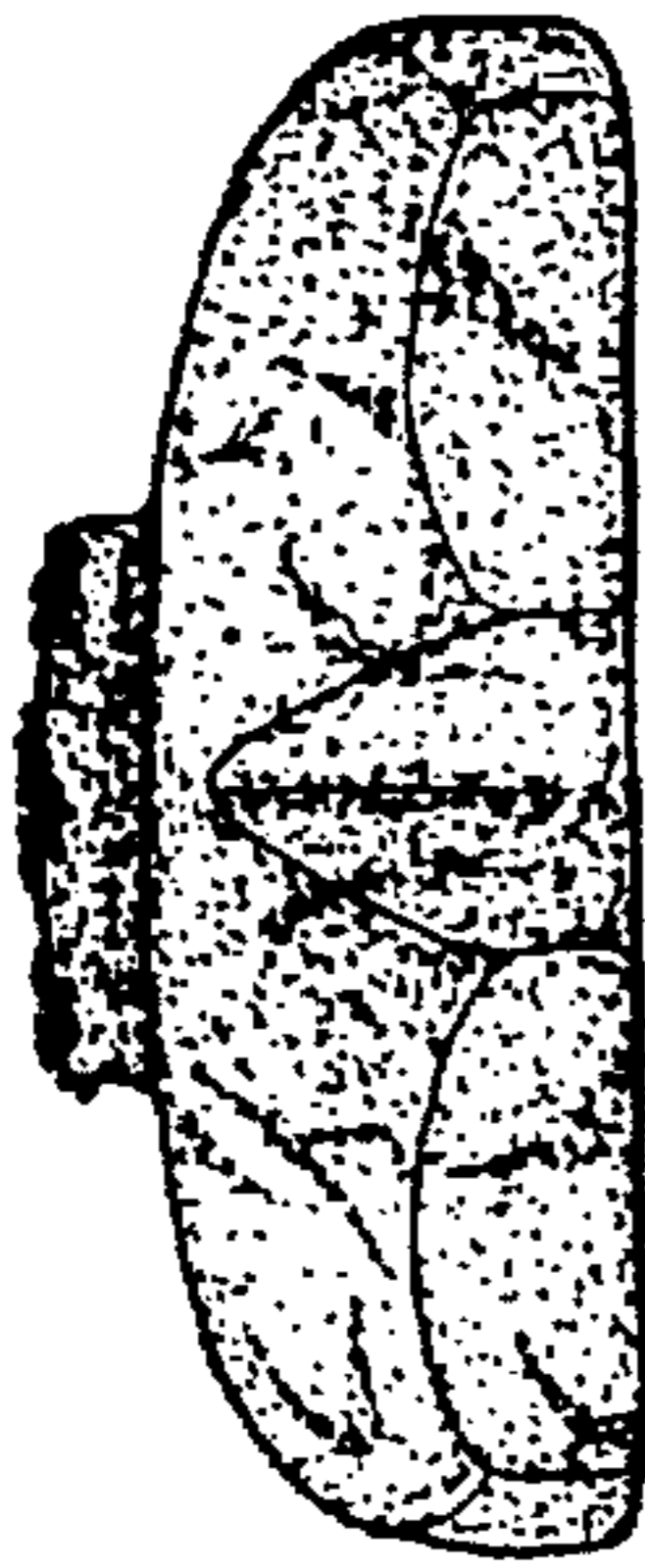

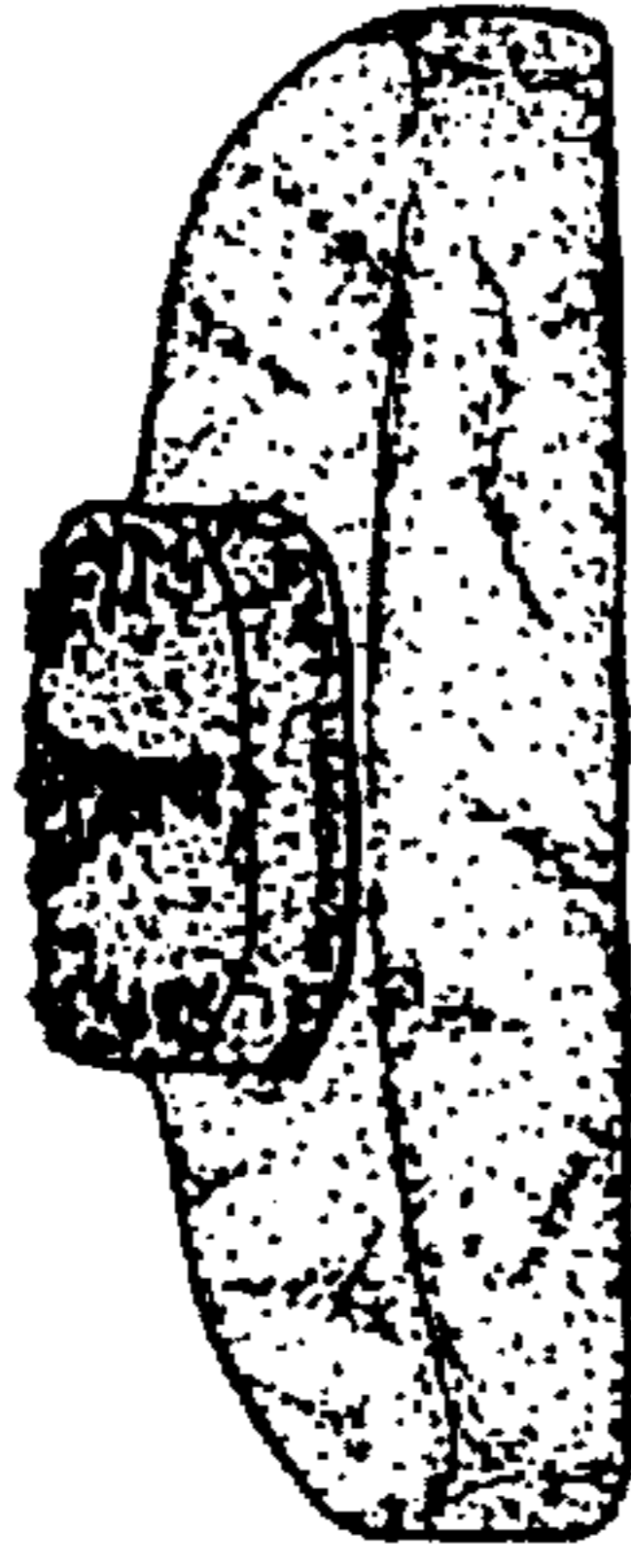

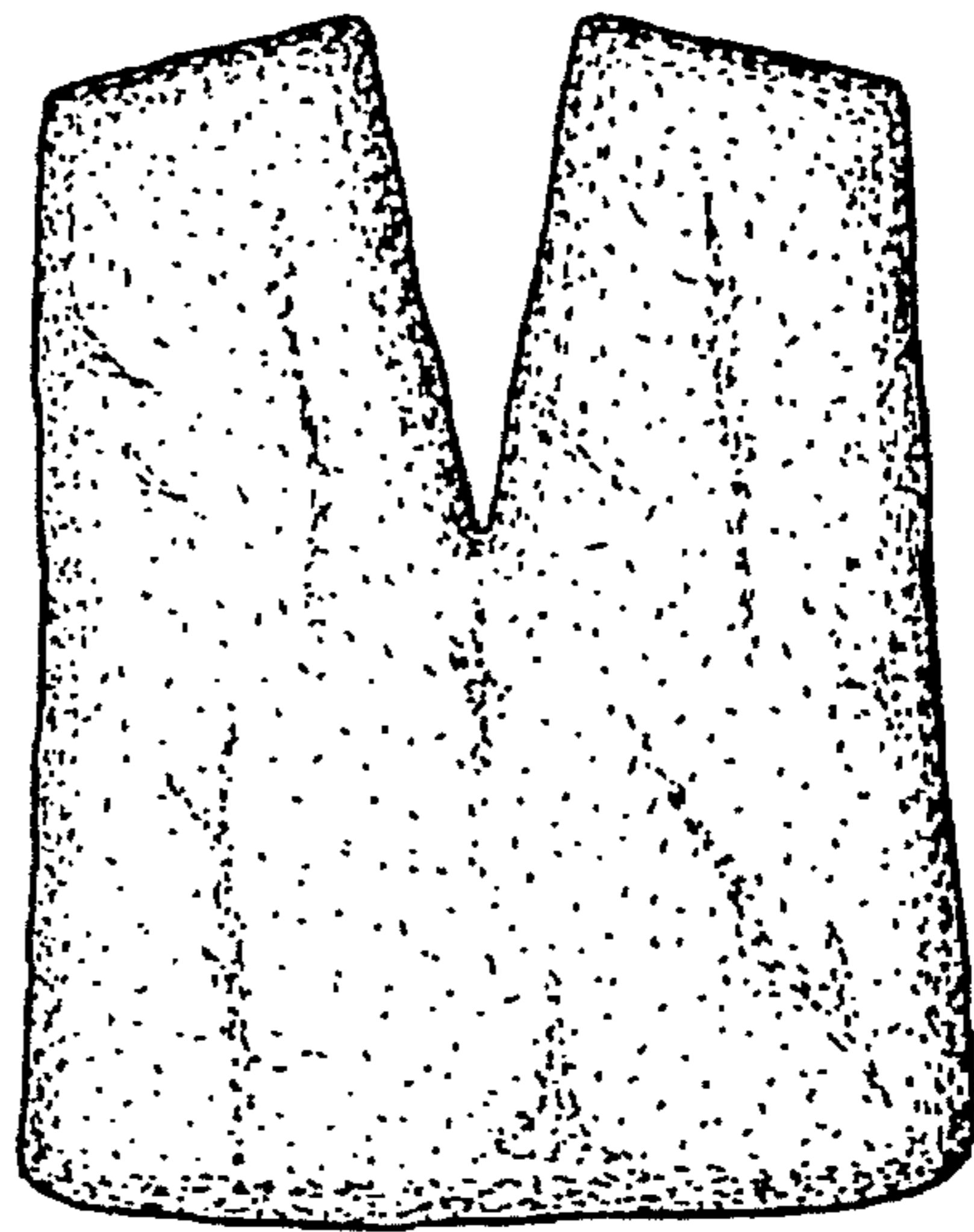
