[57] CLAIM

The ornamental design for a folding seat with bag carrier combination, as shown and described.

FIG. 1 is a top, front and left side perspective view of a folding seat with bag carrier combination showing my new design, the broken-line disclosure of items in the bag being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a reduced top plan view of the combination in its folded position;

FIG. 3 is a reduced top plan view of the combination in its open position;

FIG. 4 is a reduced side elevational view of the combination in its folded position;

FIG. 5 is a reduced side elevational view of the combination in its open position;

FIG. 6 is a perspective view of the combination in its partially folded position;

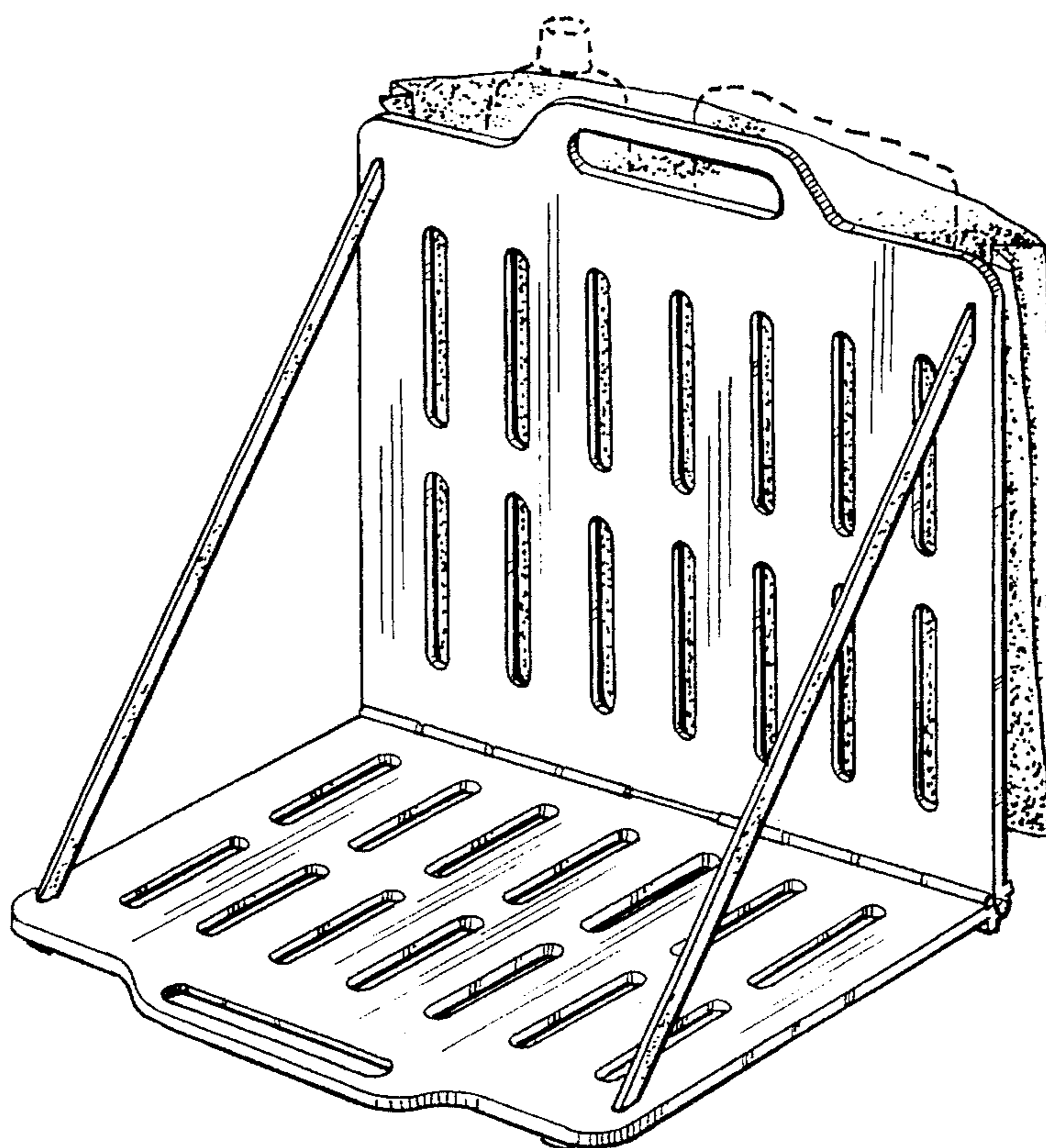
FIG. 7 is a front and left side perspective view, on a reduced scale, showing the folding seat with bag carrier in the folded position with its support straps in the shoulder carrying position;

FIG. 8 is a bottom, rear, right side perspective view of the combination shown in the open position; and,

FIG. 9 is a bottom, rear, and right side perspective view of the combination in its open position, showing an advertisement space on the back of the seat thereof.

The broken line showing of a bottle and a folded paper in FIGS. 1, 6, 8, and 9 and the broken line showing of a person in FIG. 7 are for illustrative purposes only and form no part of the claimed design.

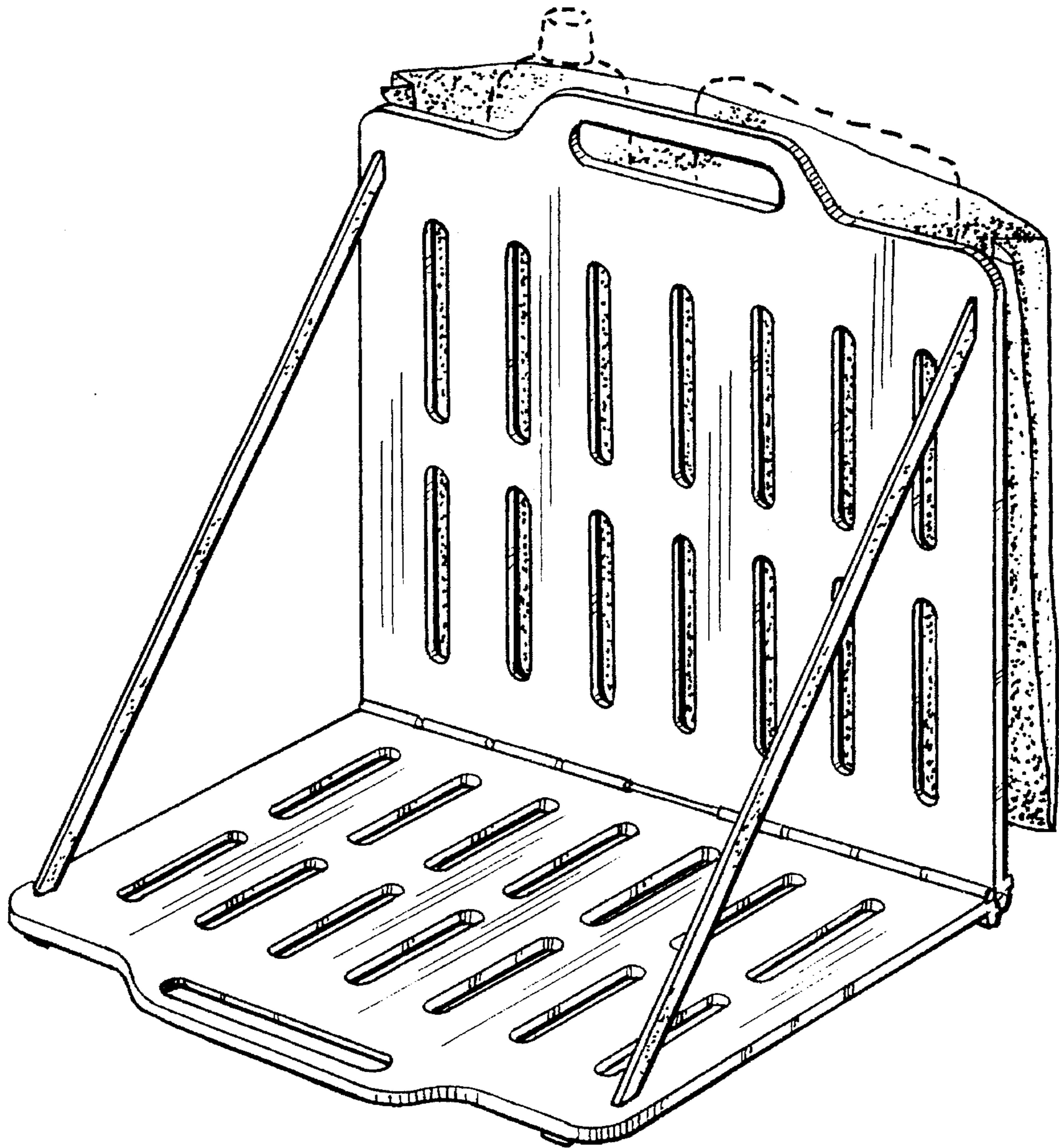

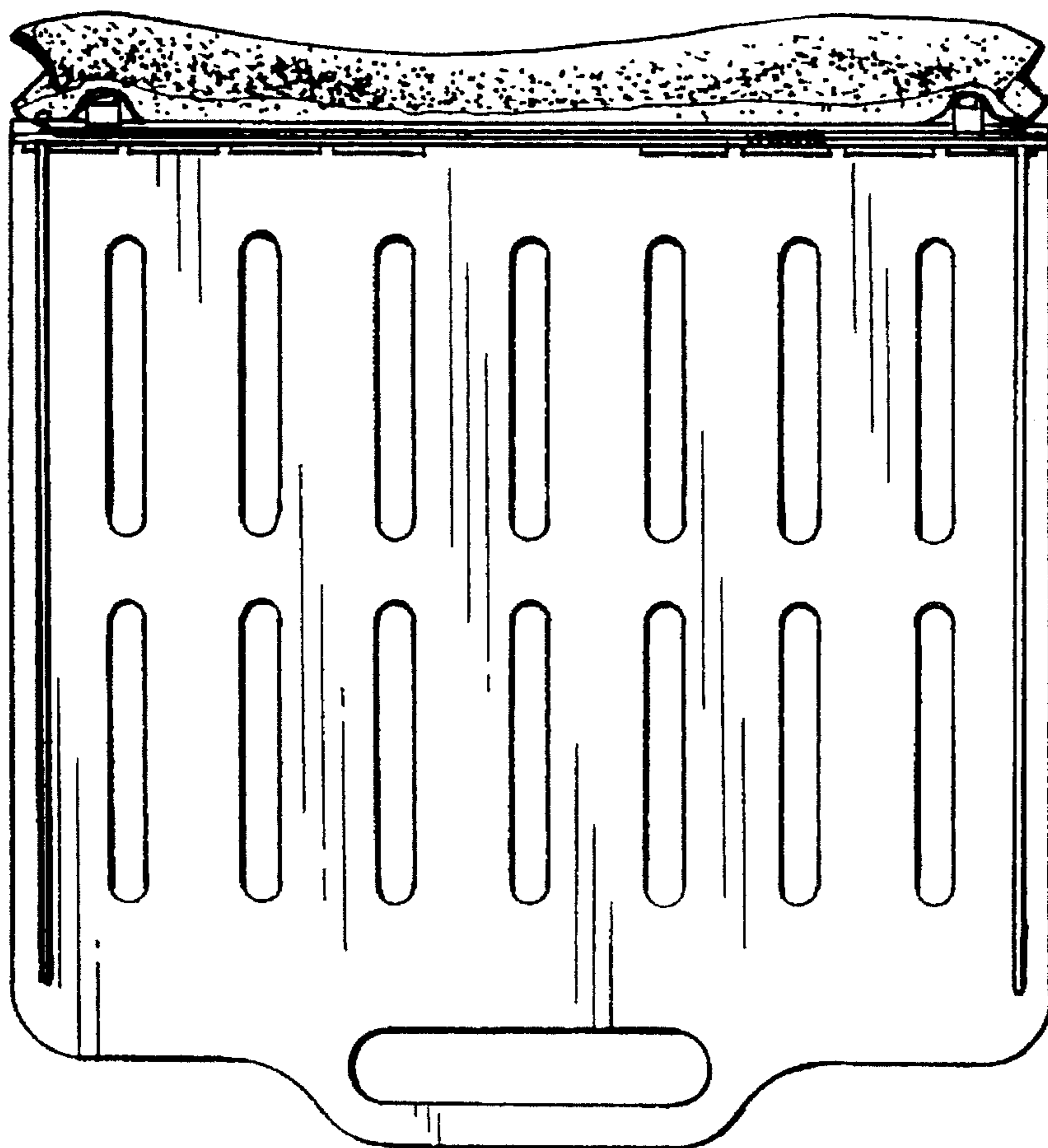
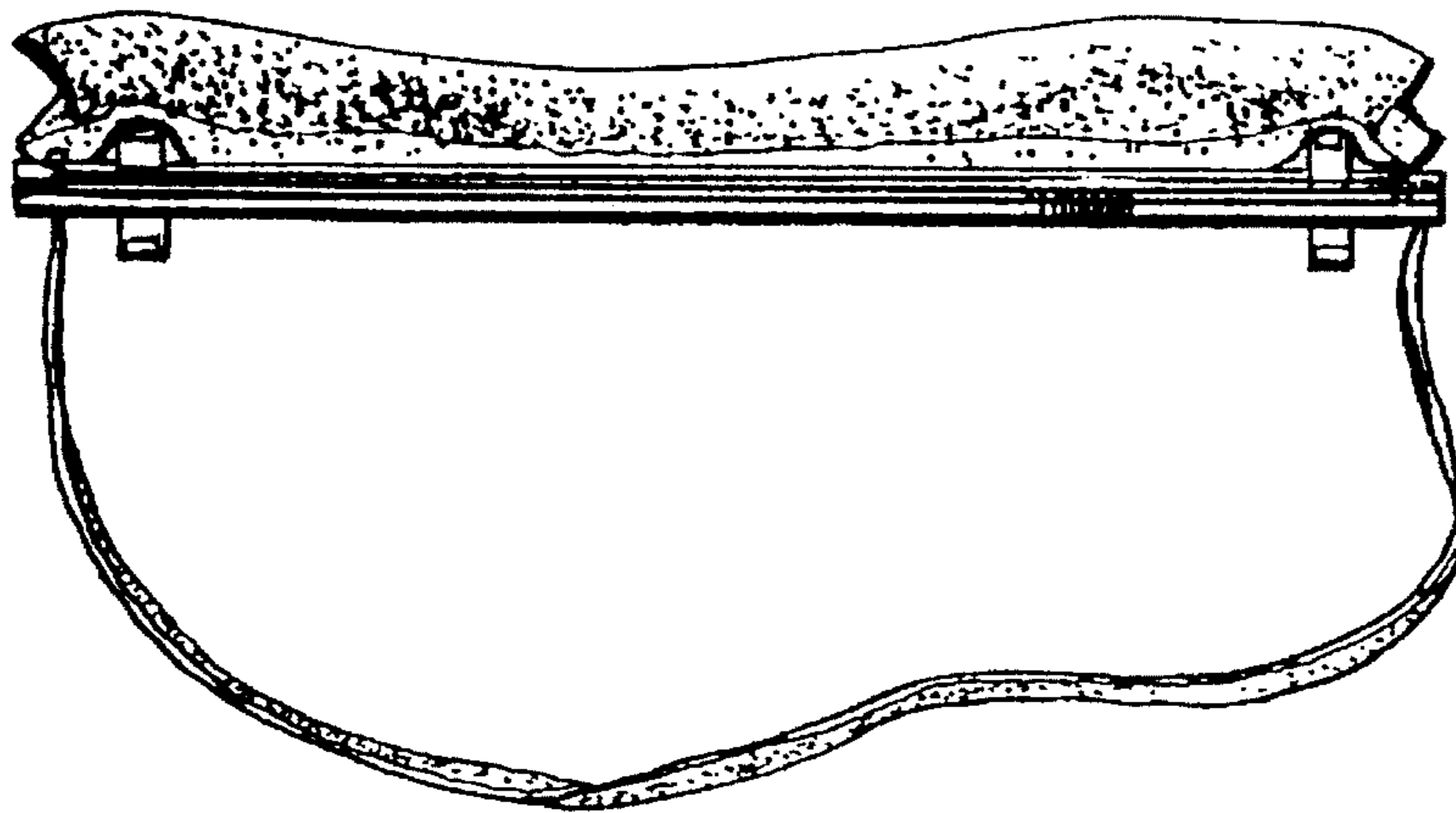

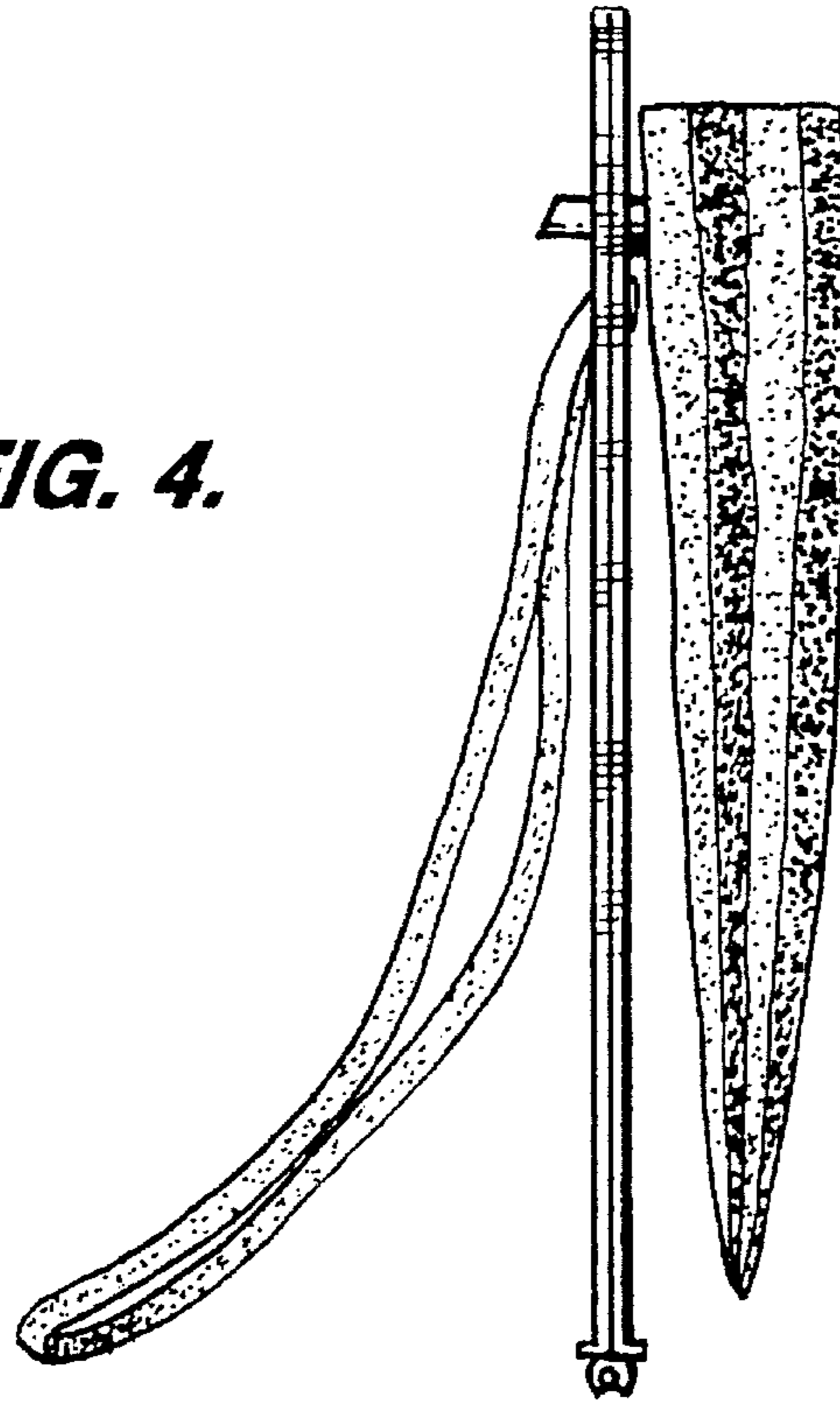
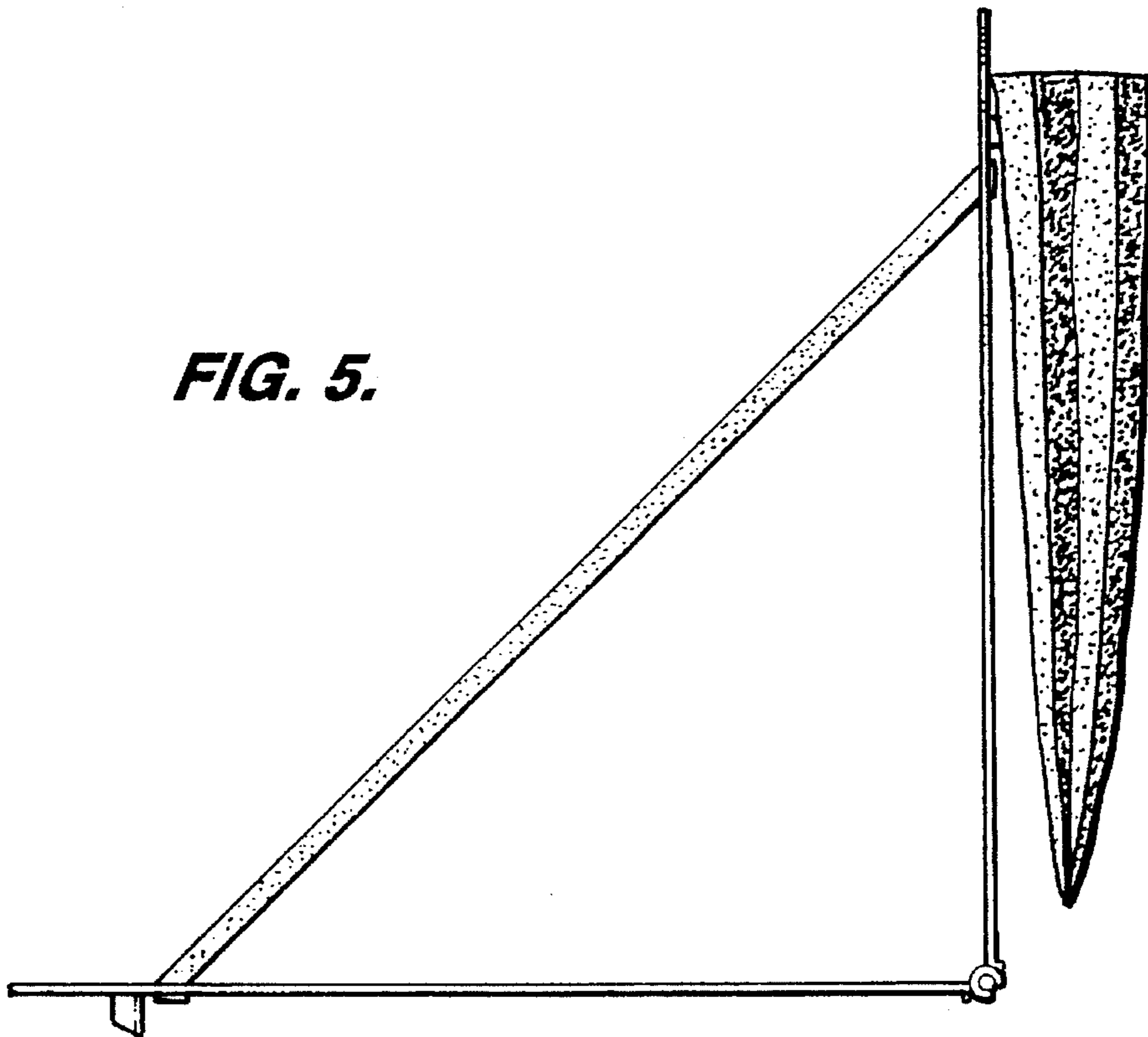

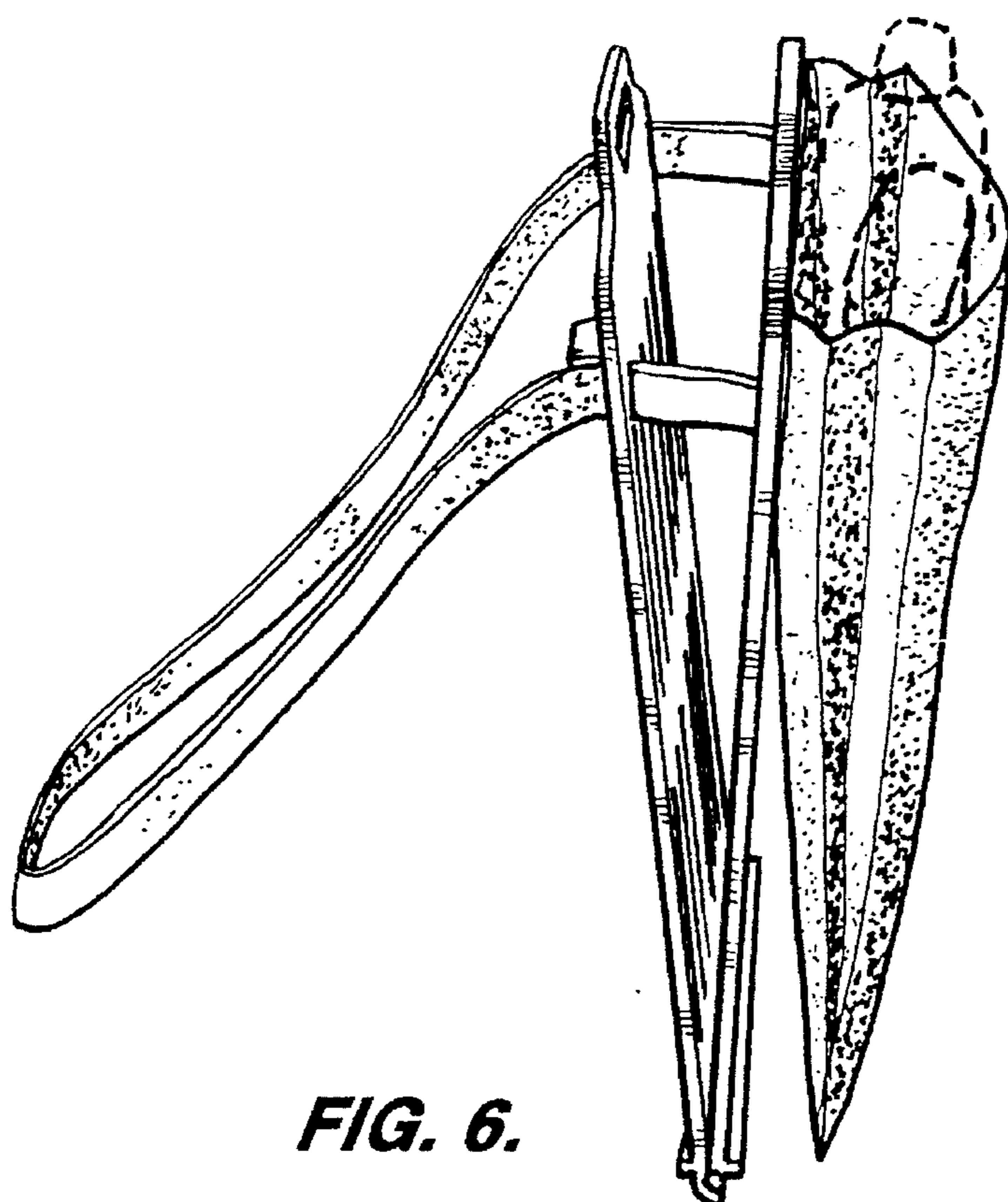

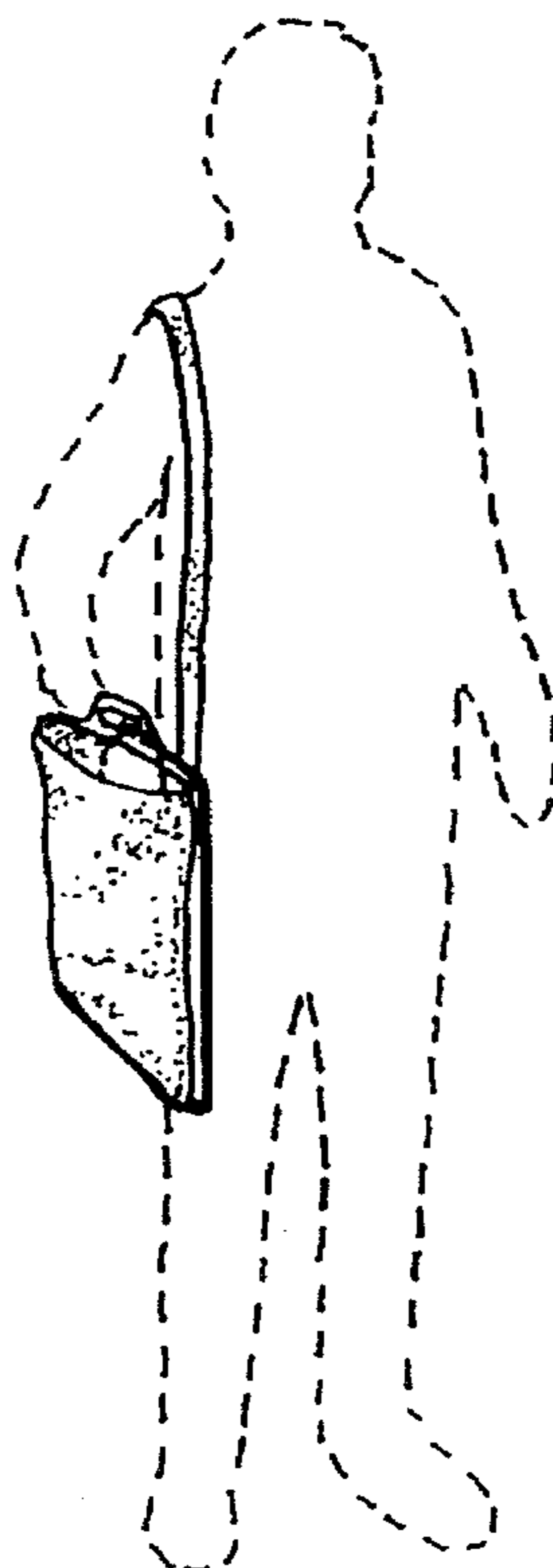

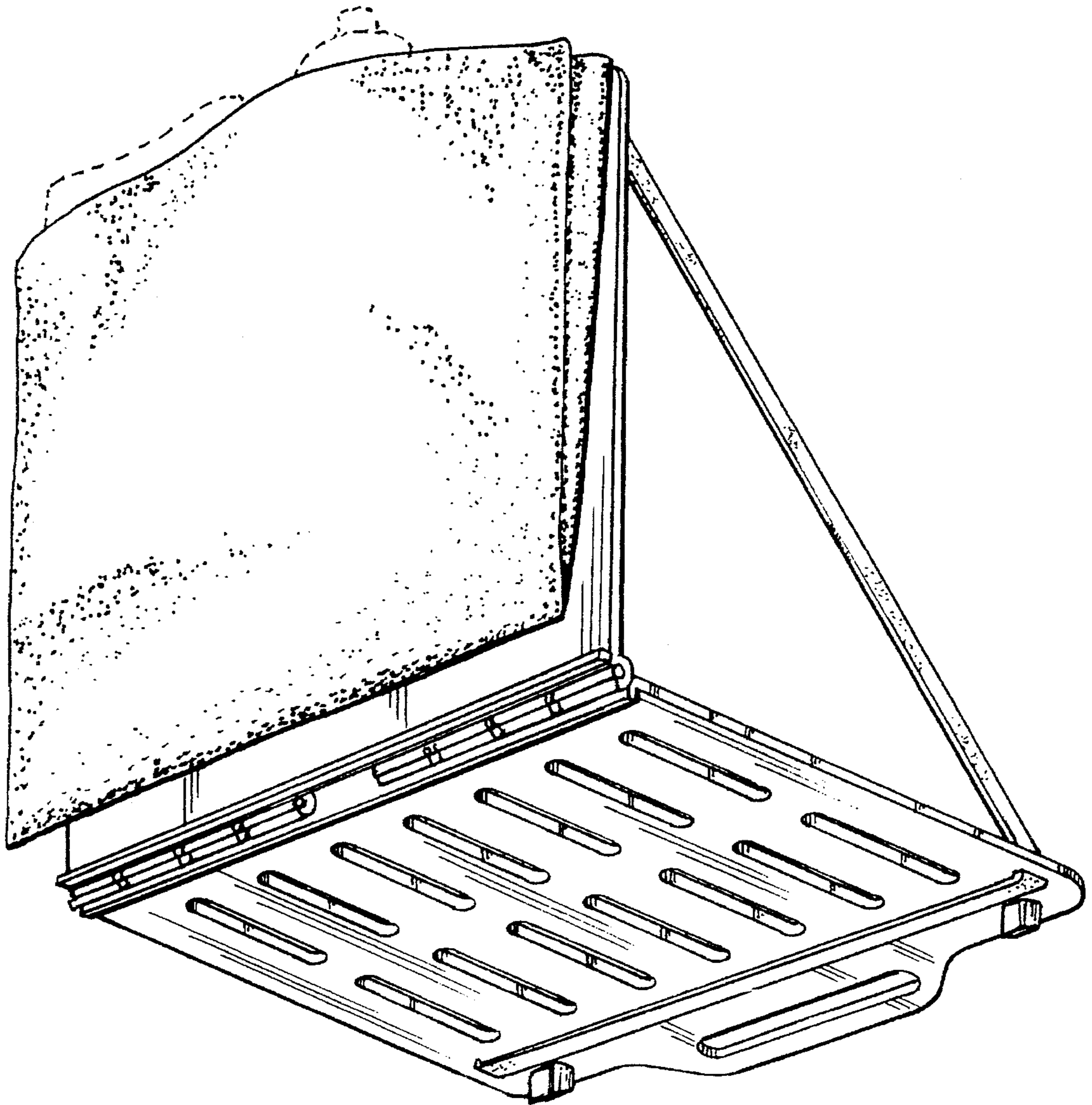

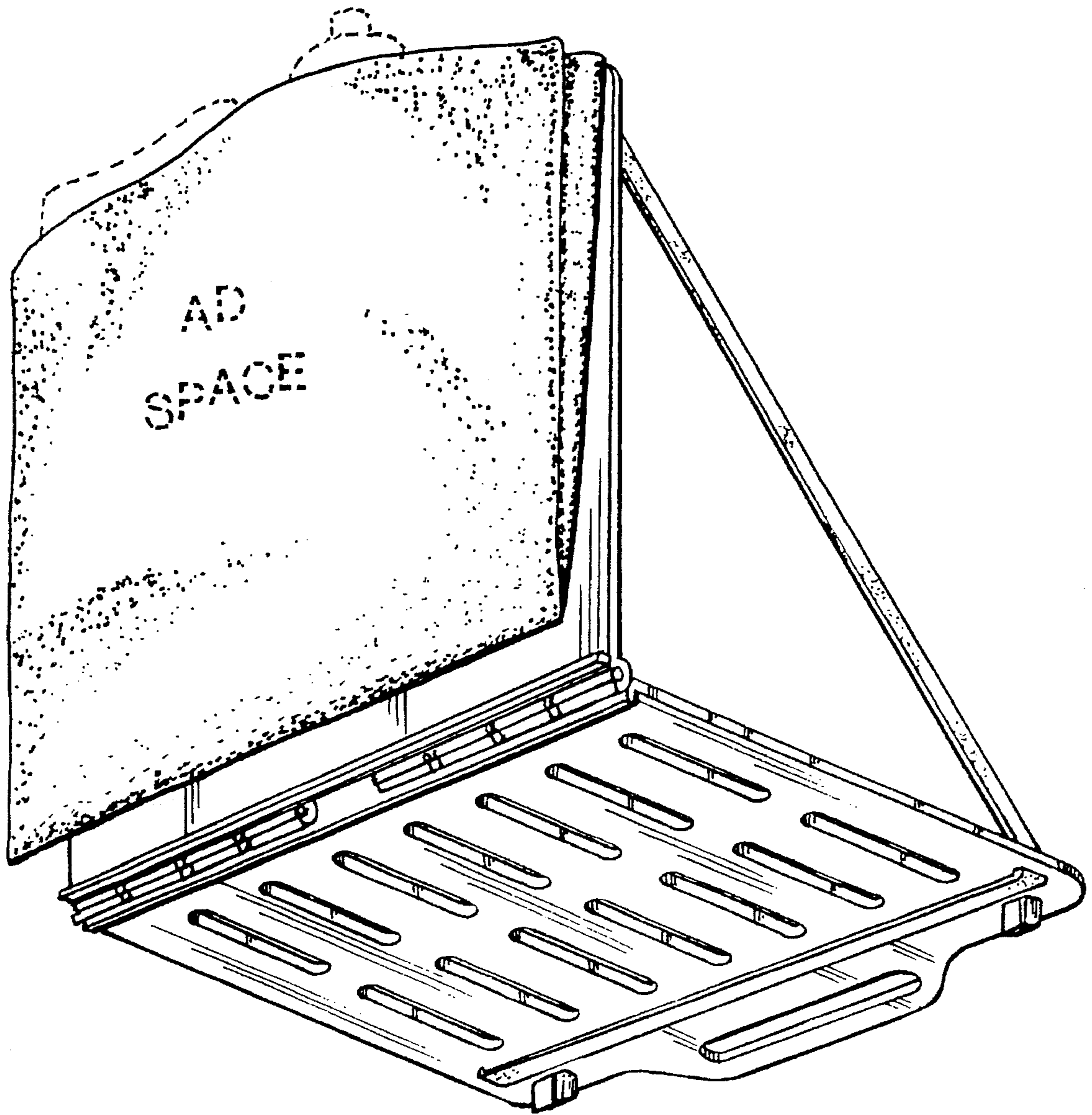
