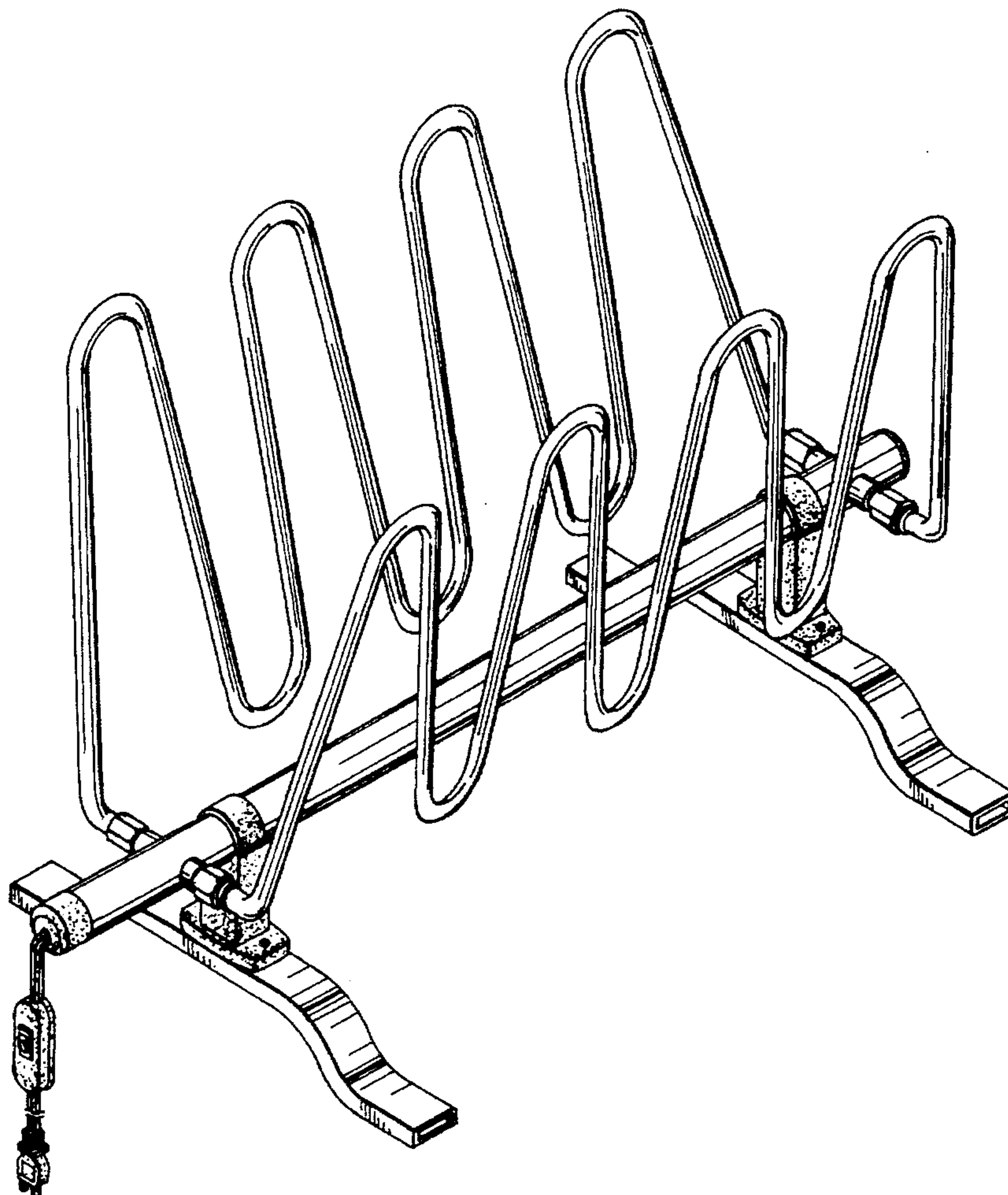
[57] **CLAIM**

### DESCRIPTION

FIG. 1 is a perspective view of electric heating shoe rack showing my new design;  
FIG. 2 is a front elevational view thereof;

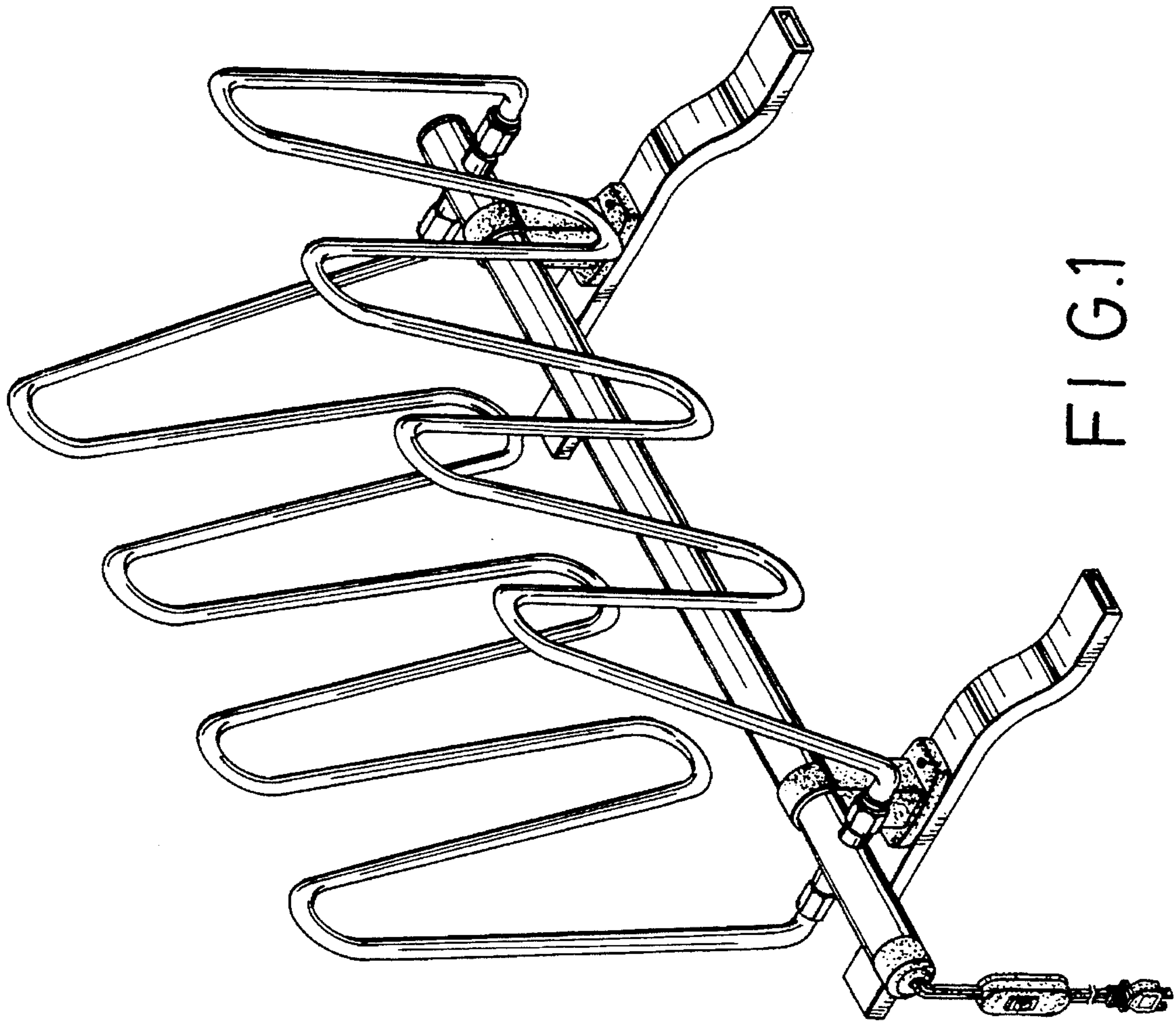

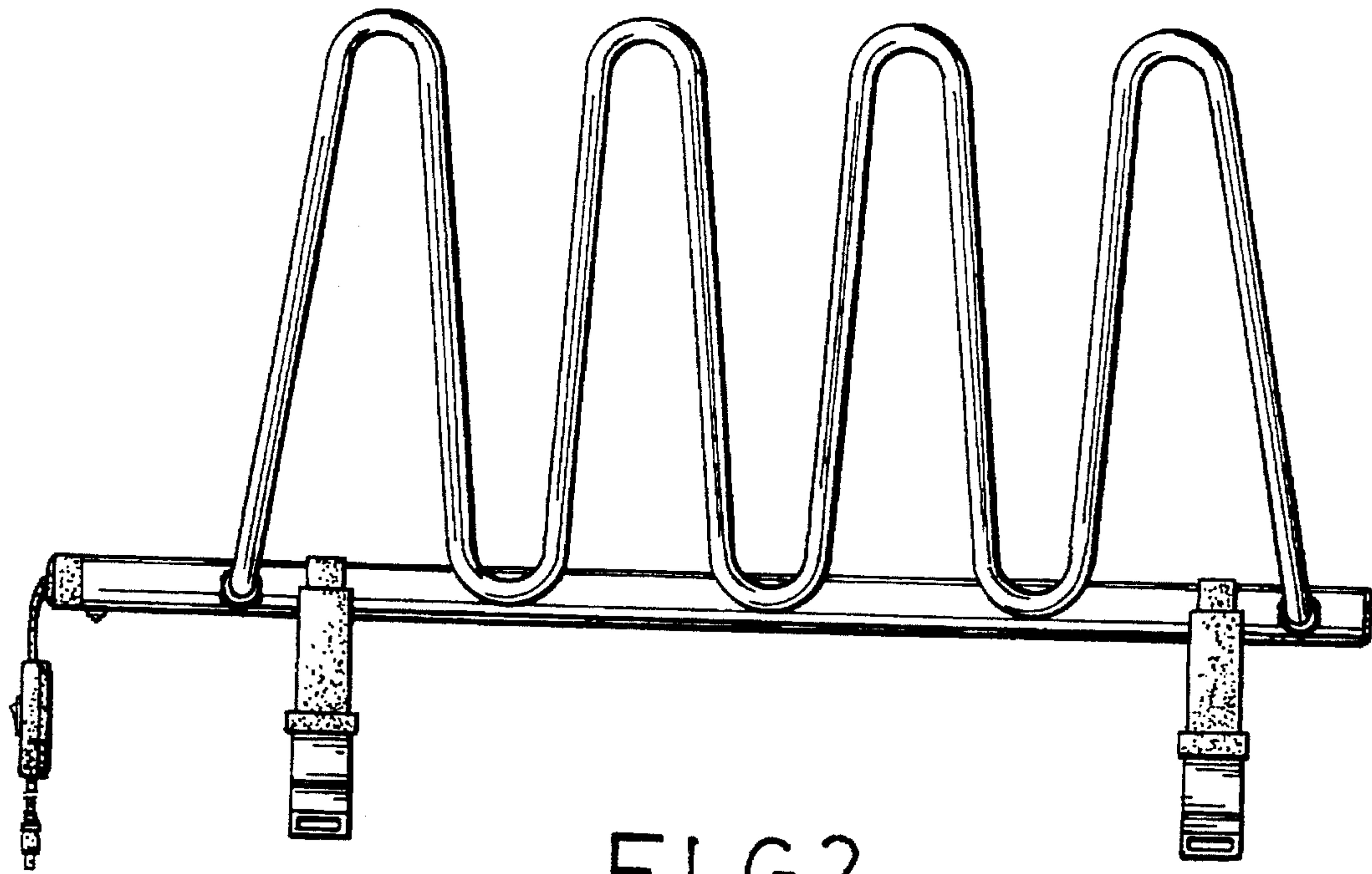

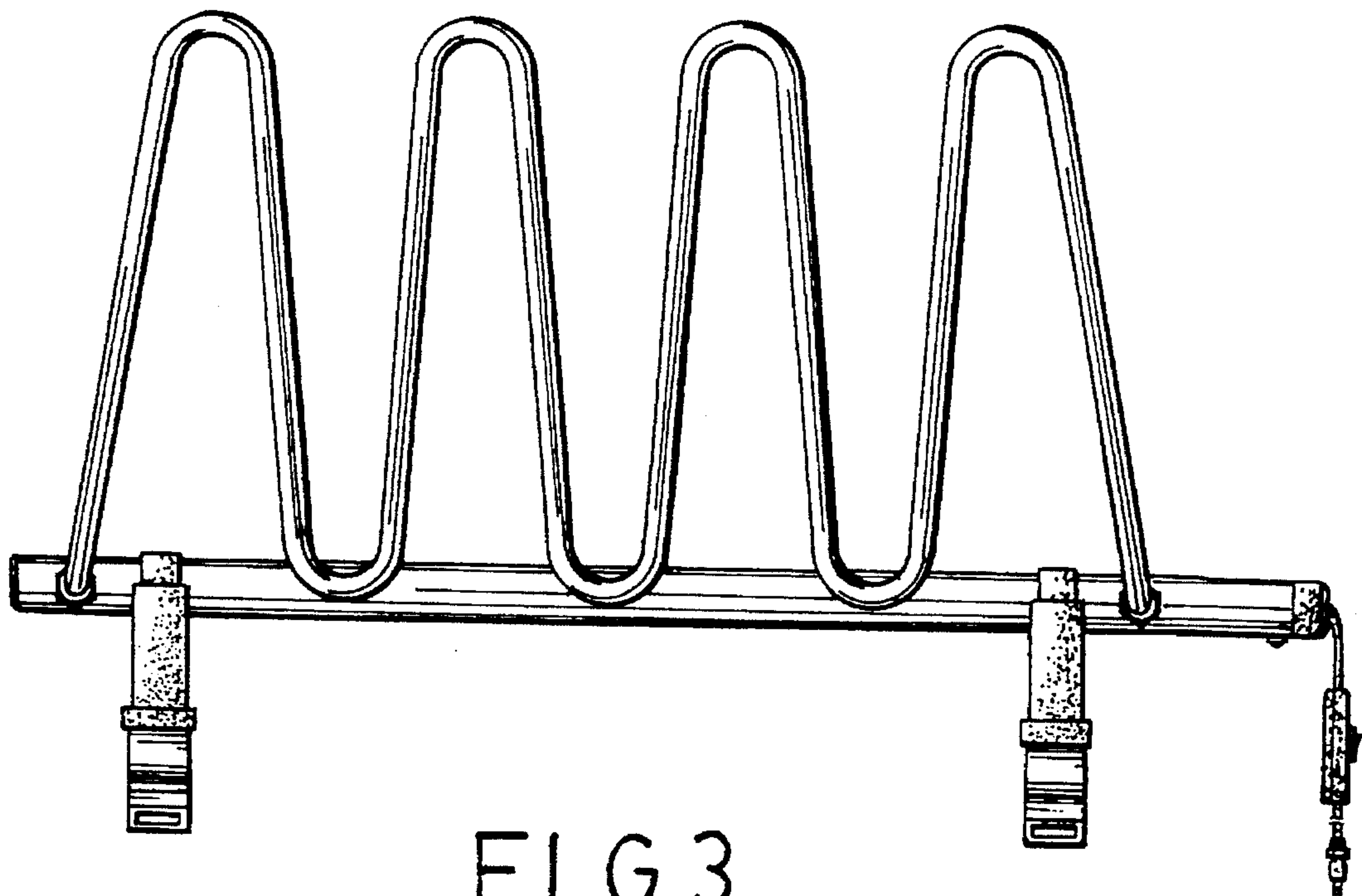

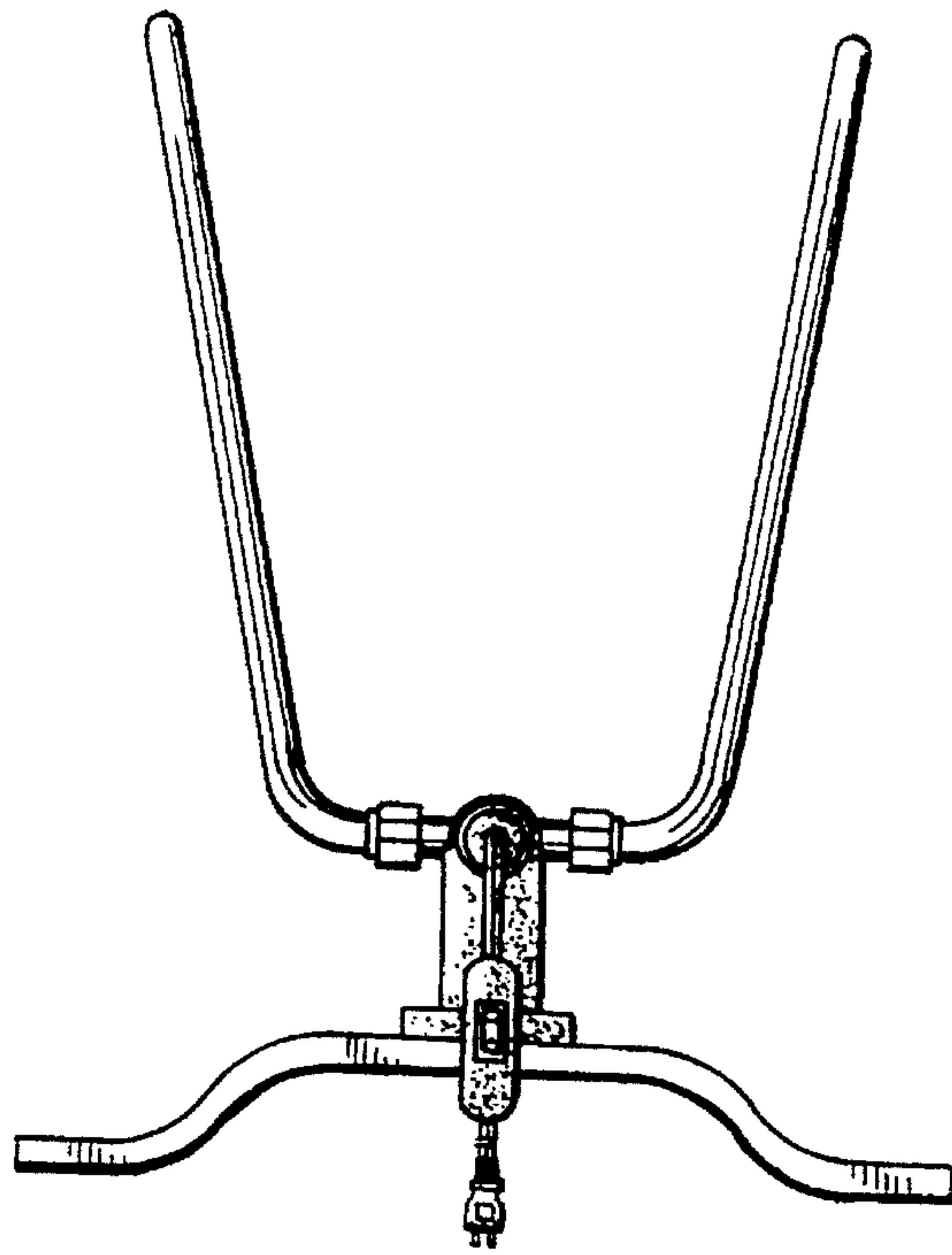

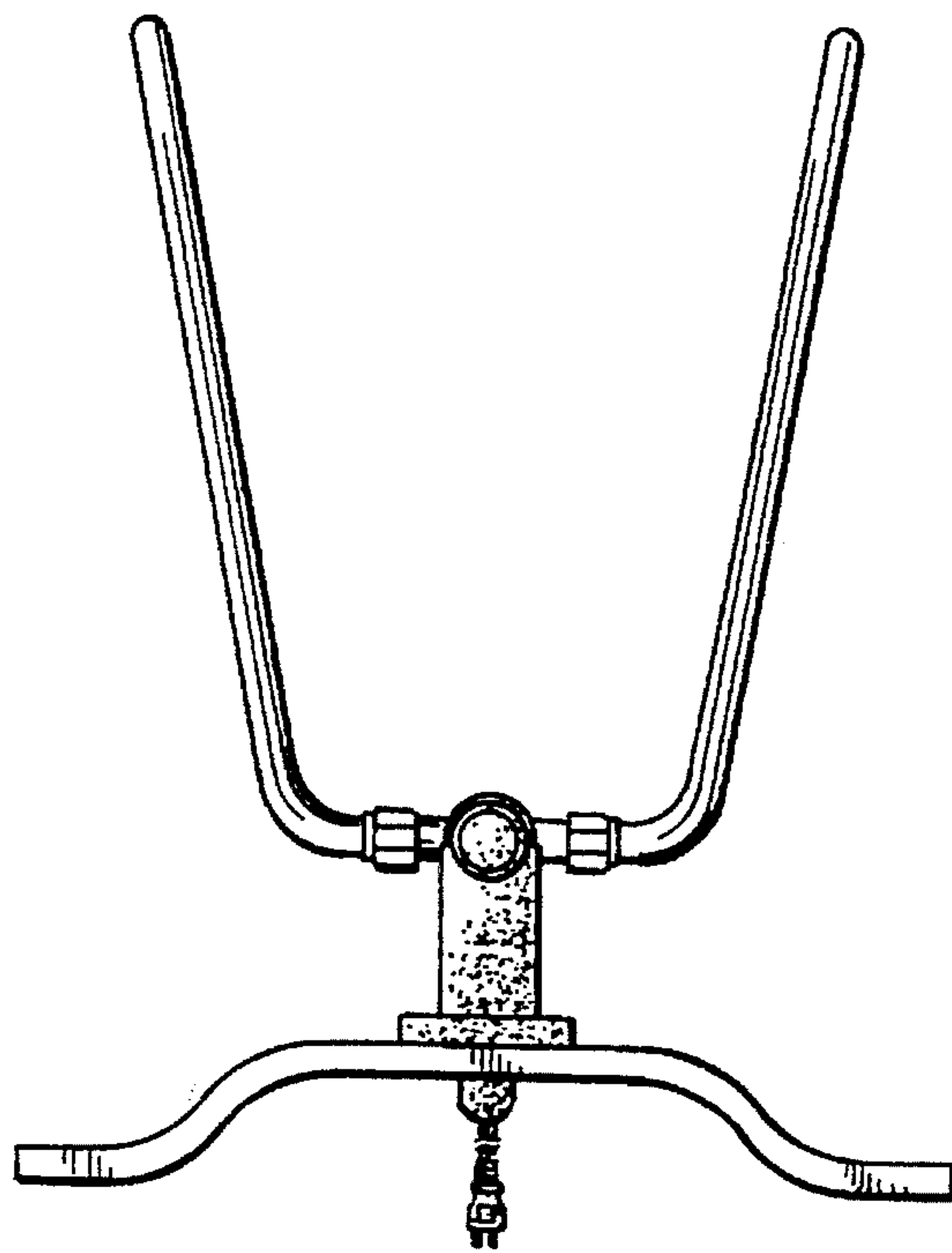

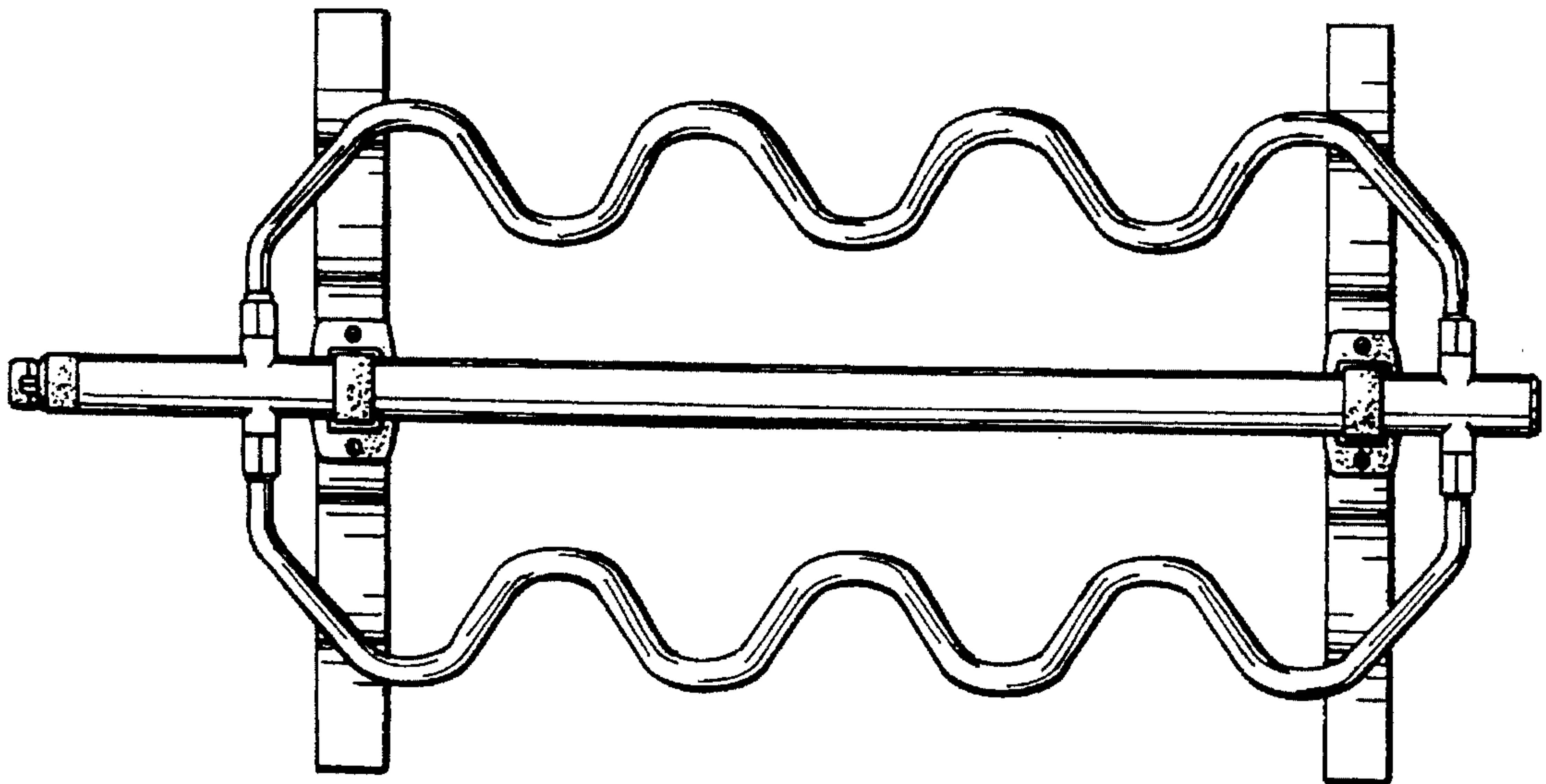

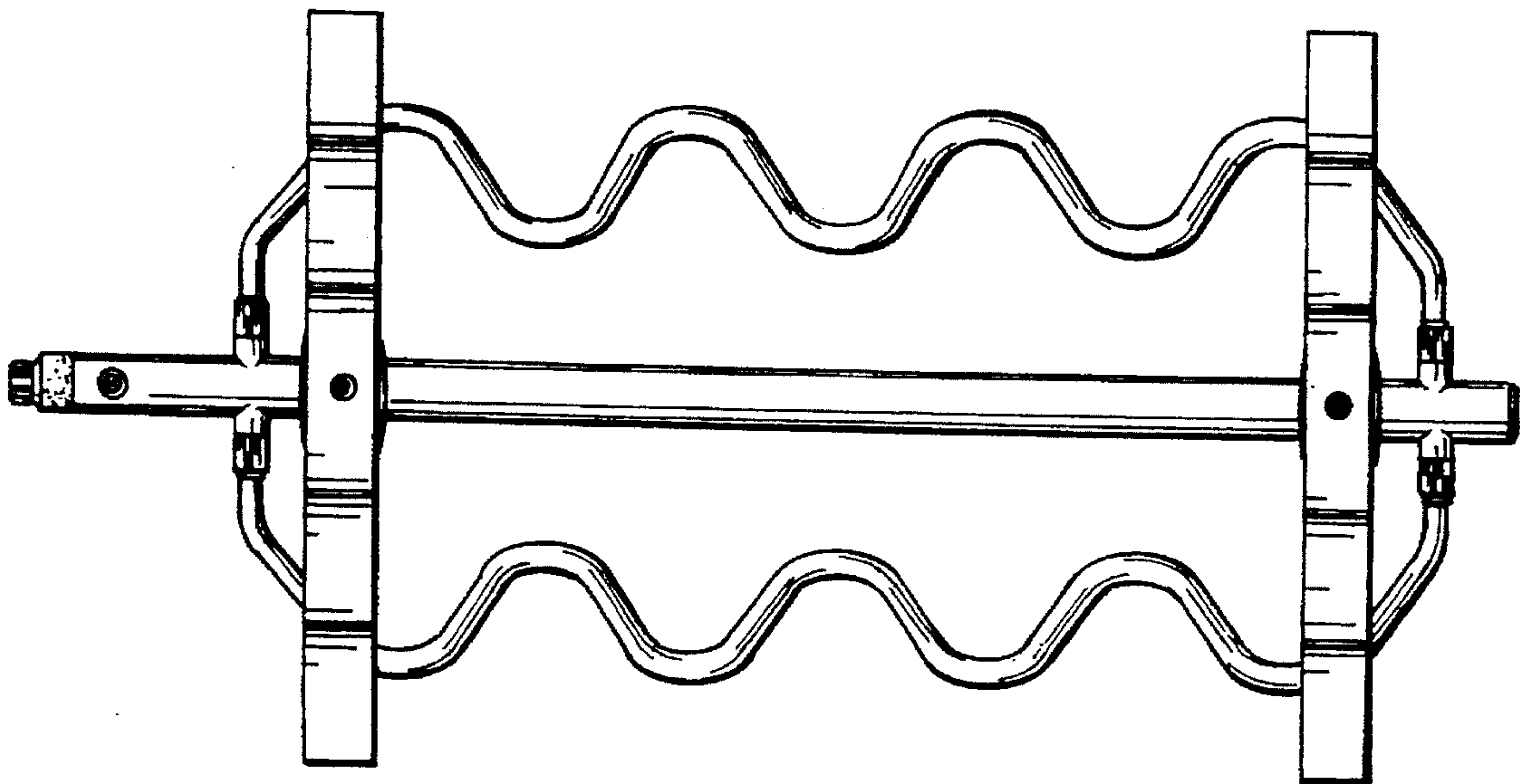
