[57] **CLAIM**

The ornamental design for storage and display cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing my new design for storage and display cabinet;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side view thereof, the left side view being identical;

FIG. 4 is a top plan view thereof;

FIG. 5 is a front perspective view with side doors being opened;

FIG. 6 is a front perspective view illustrating an alternate embodiment of my new design;

FIG. 7 is a front elevation view thereof;

FIG. 8 is a right side view thereof, the left side view being identical;

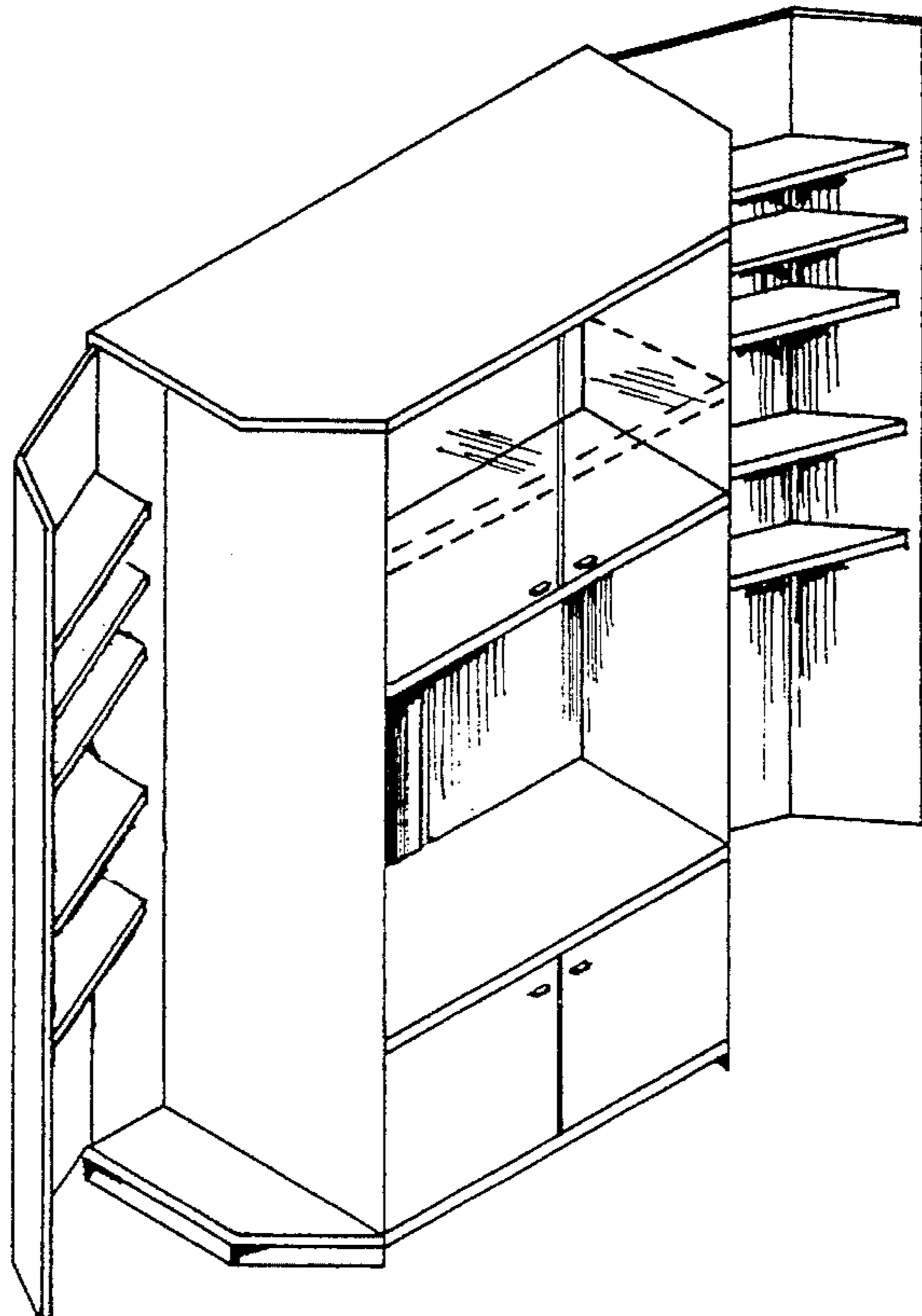
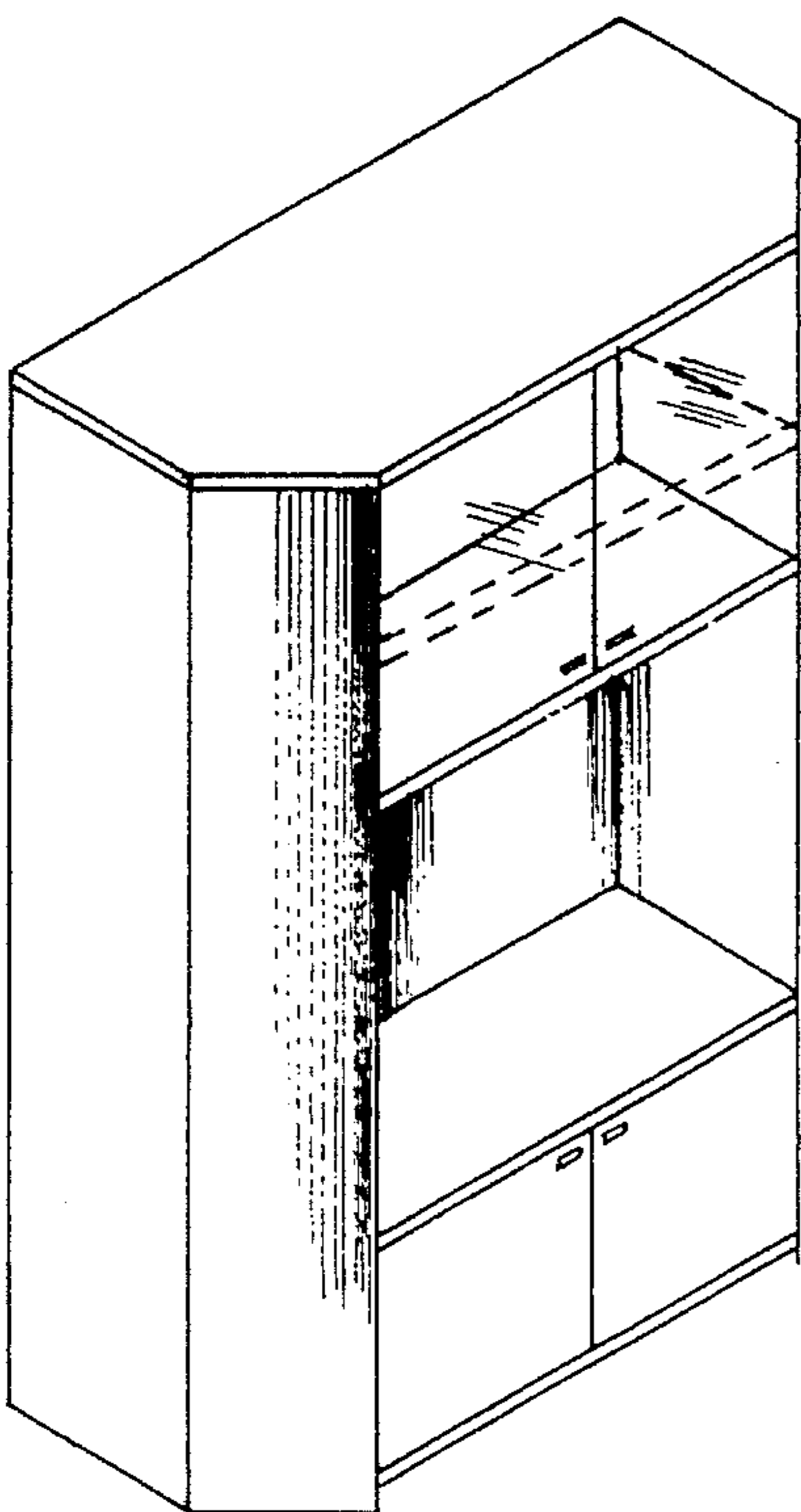
FIG. 9 is a top plan view thereof;

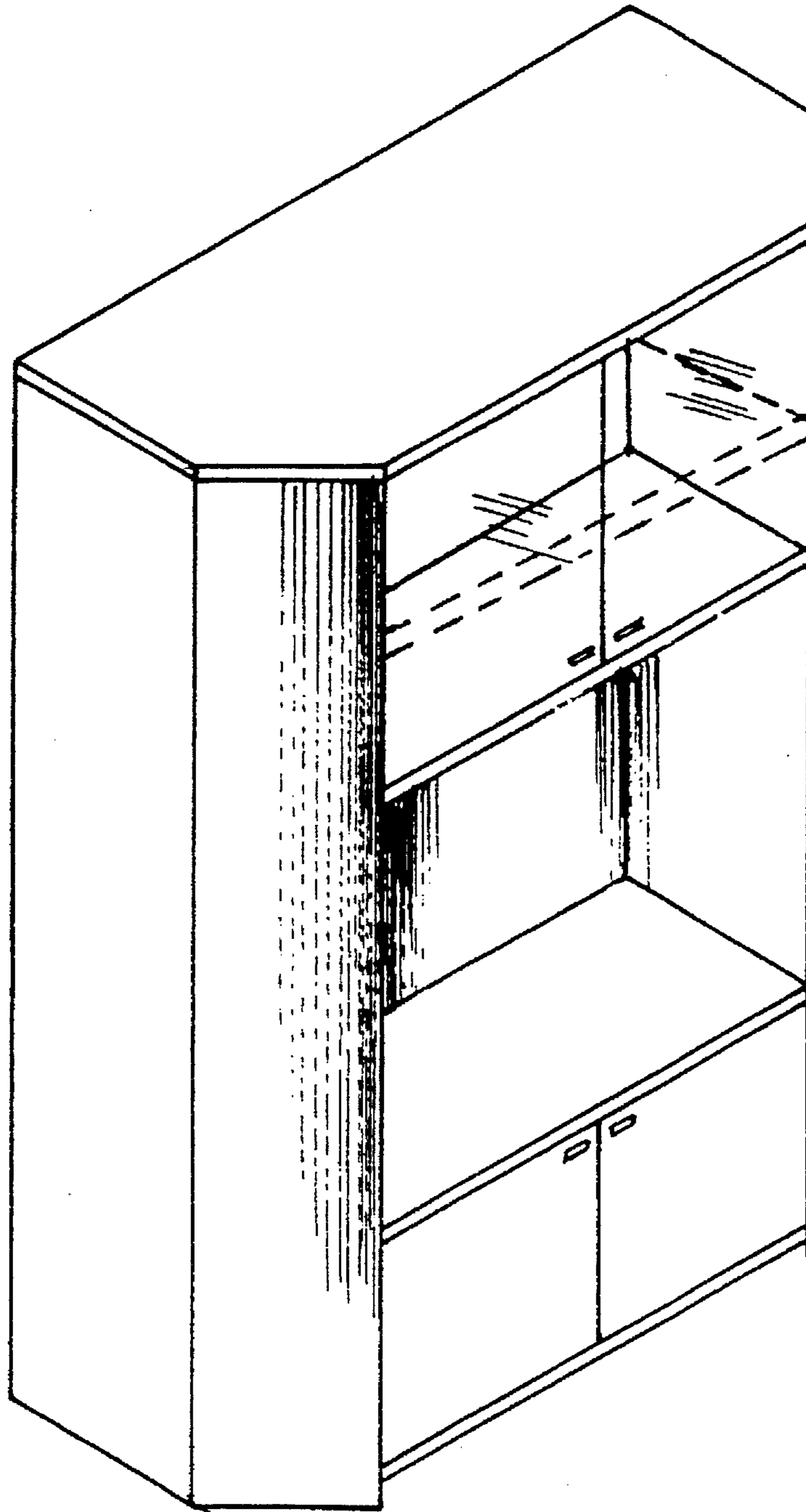

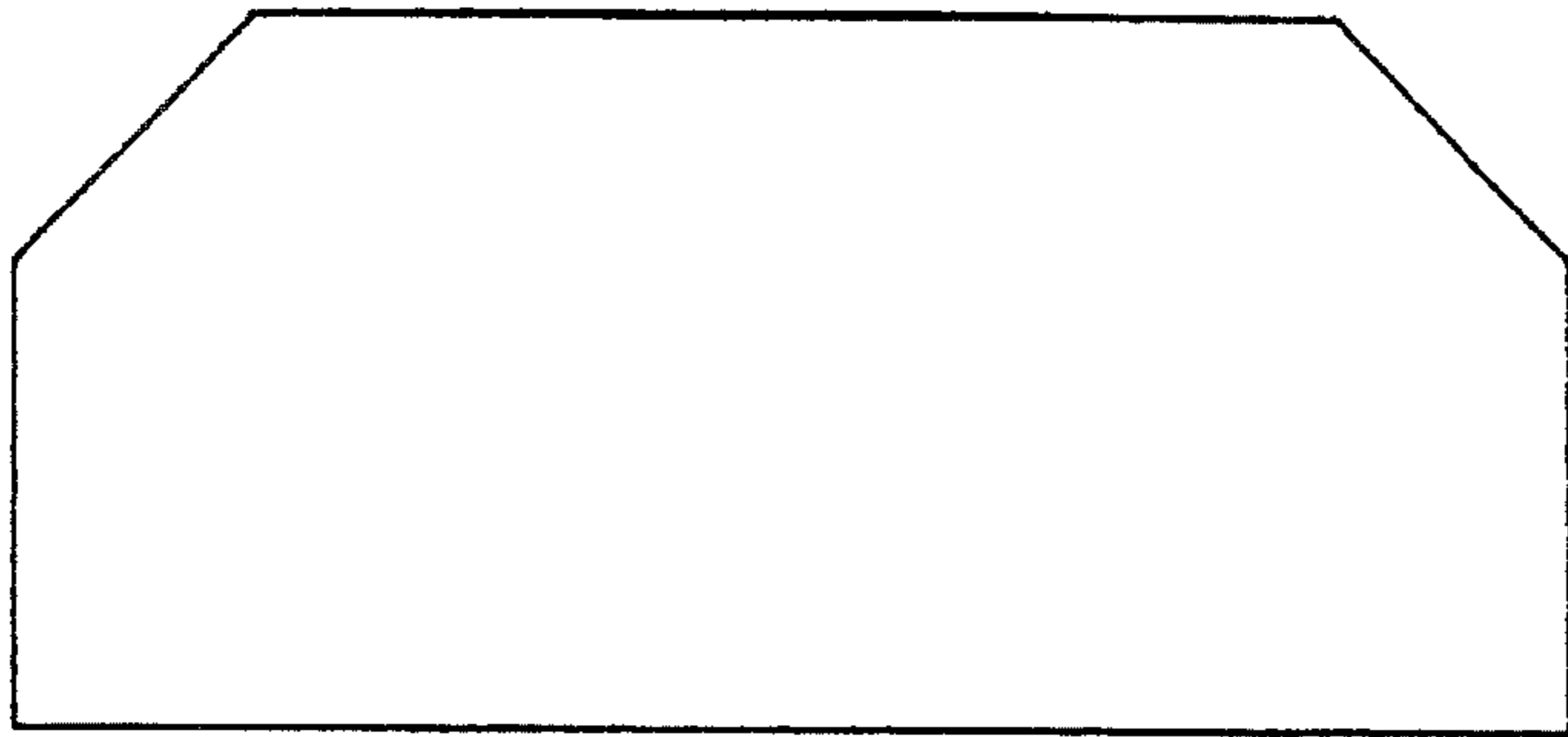

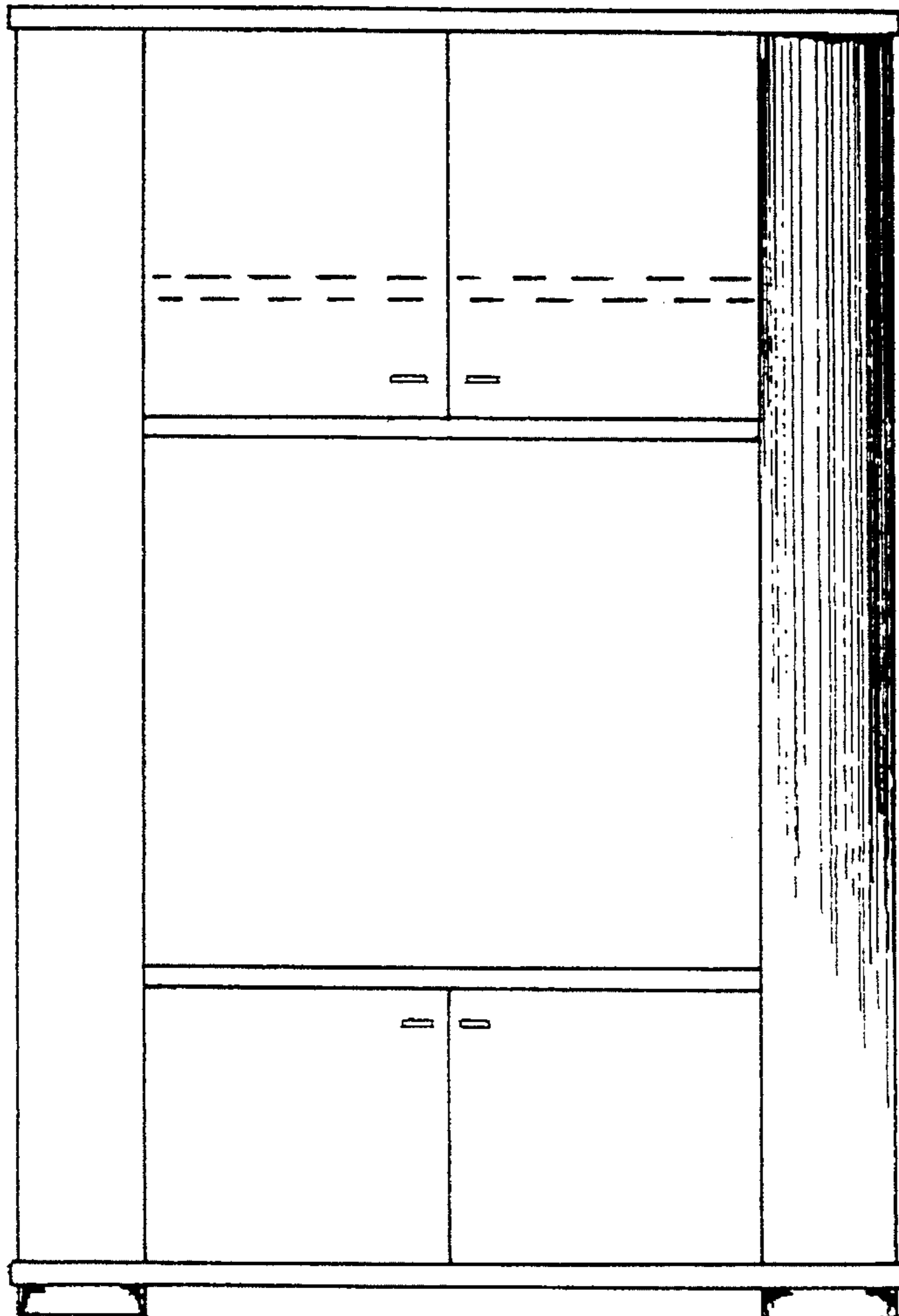

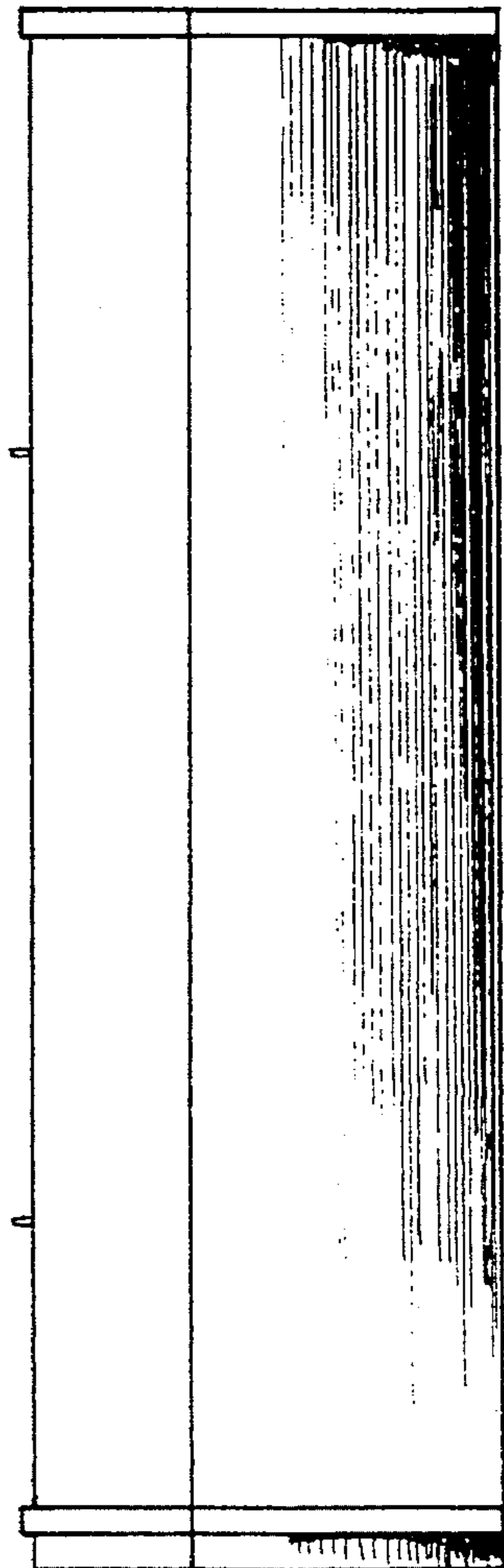

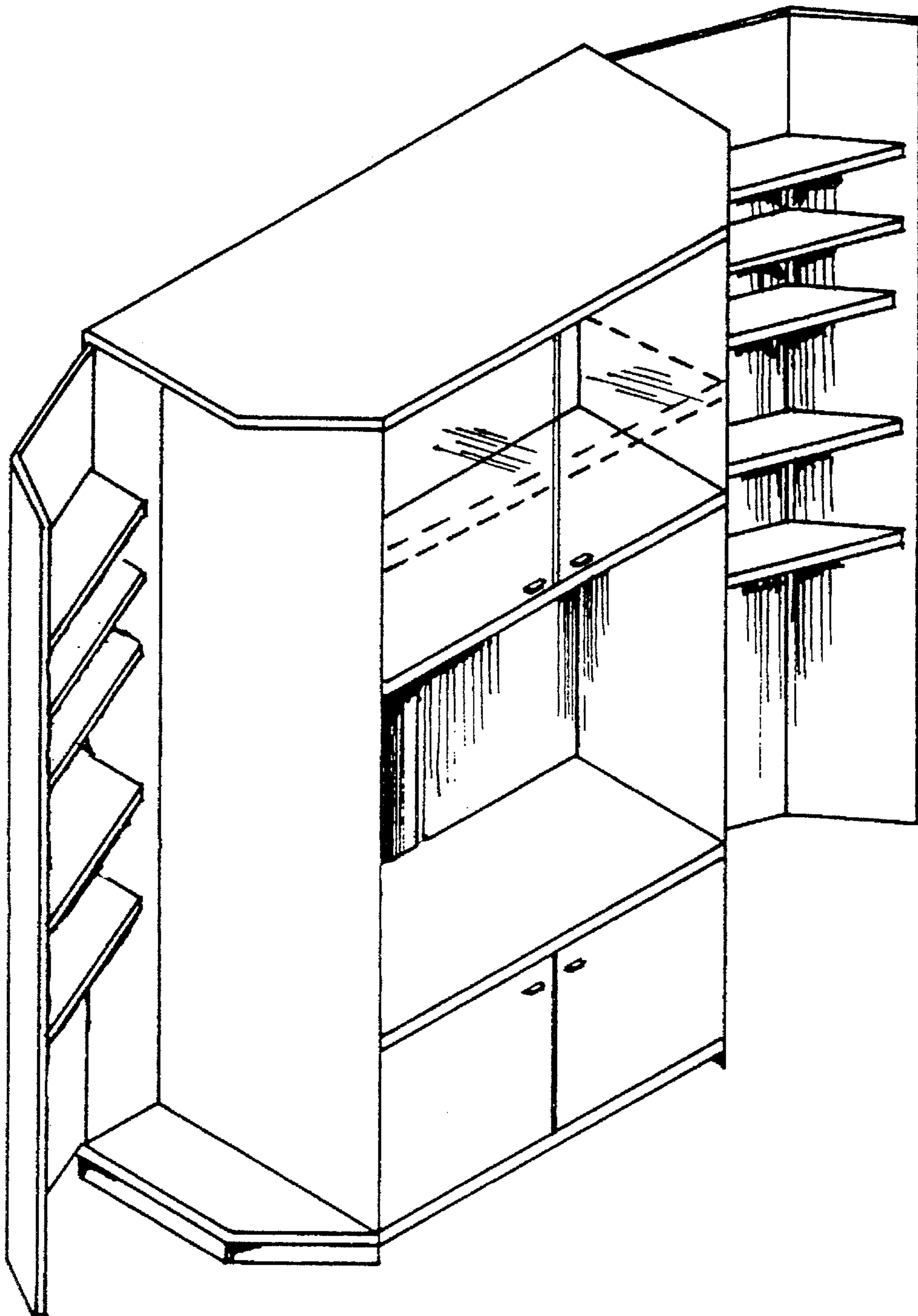

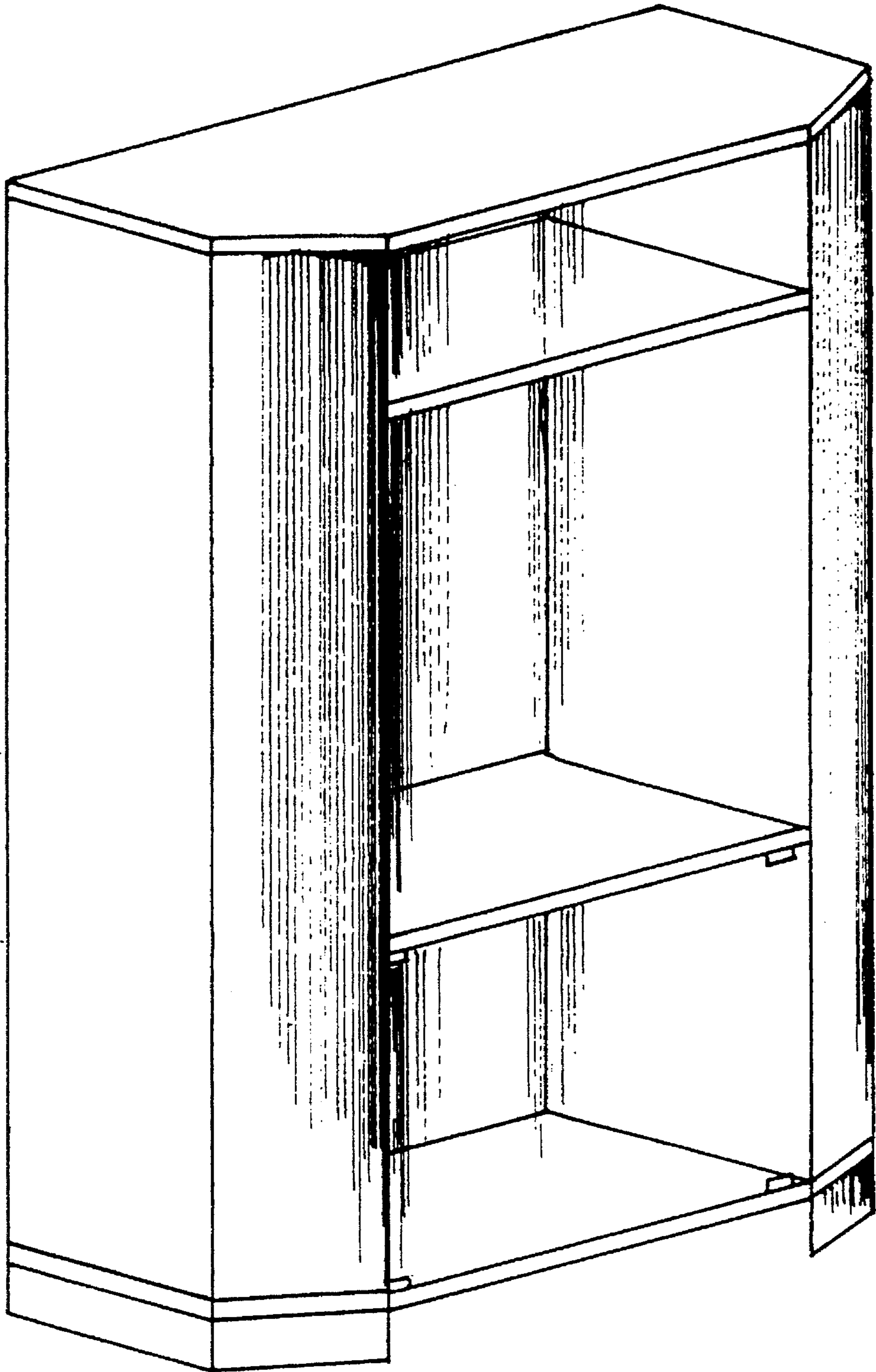

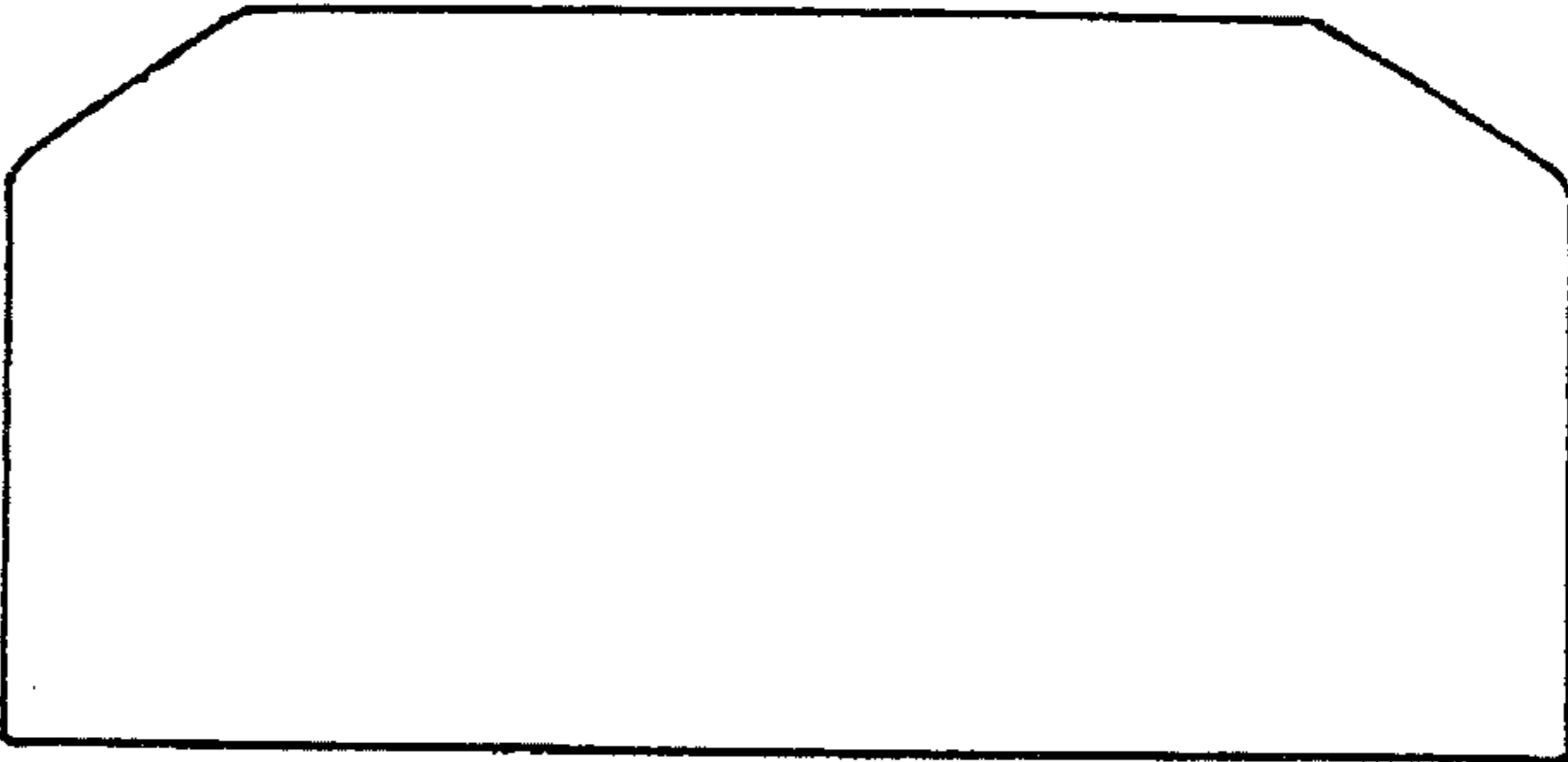

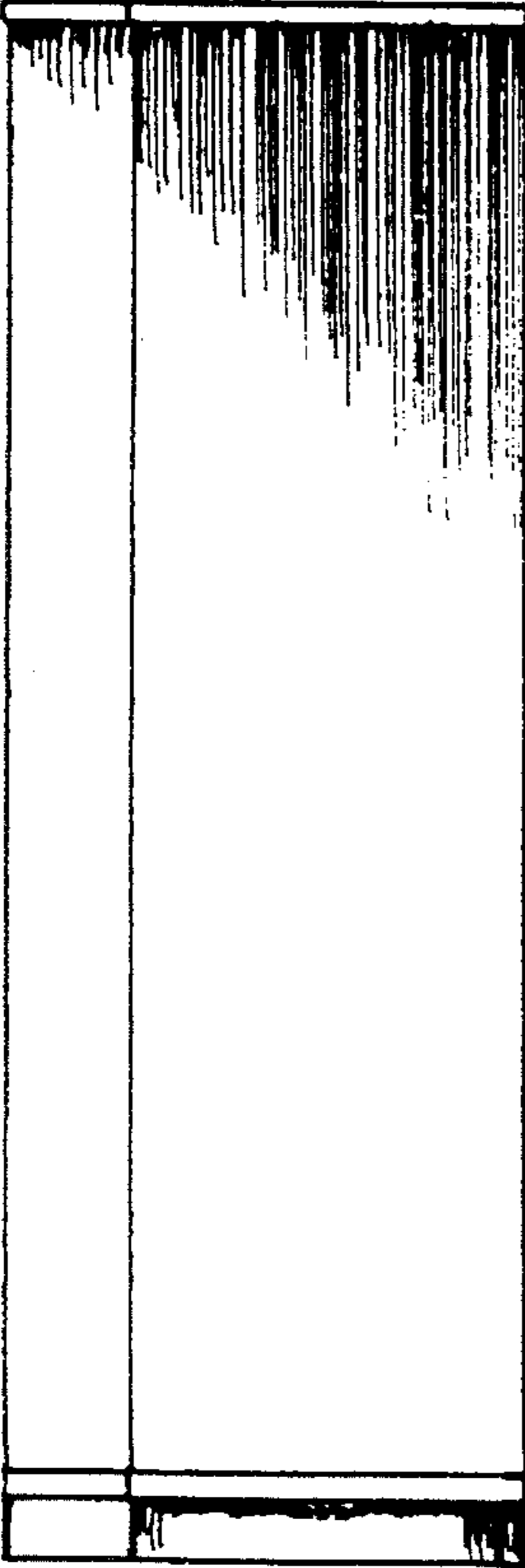

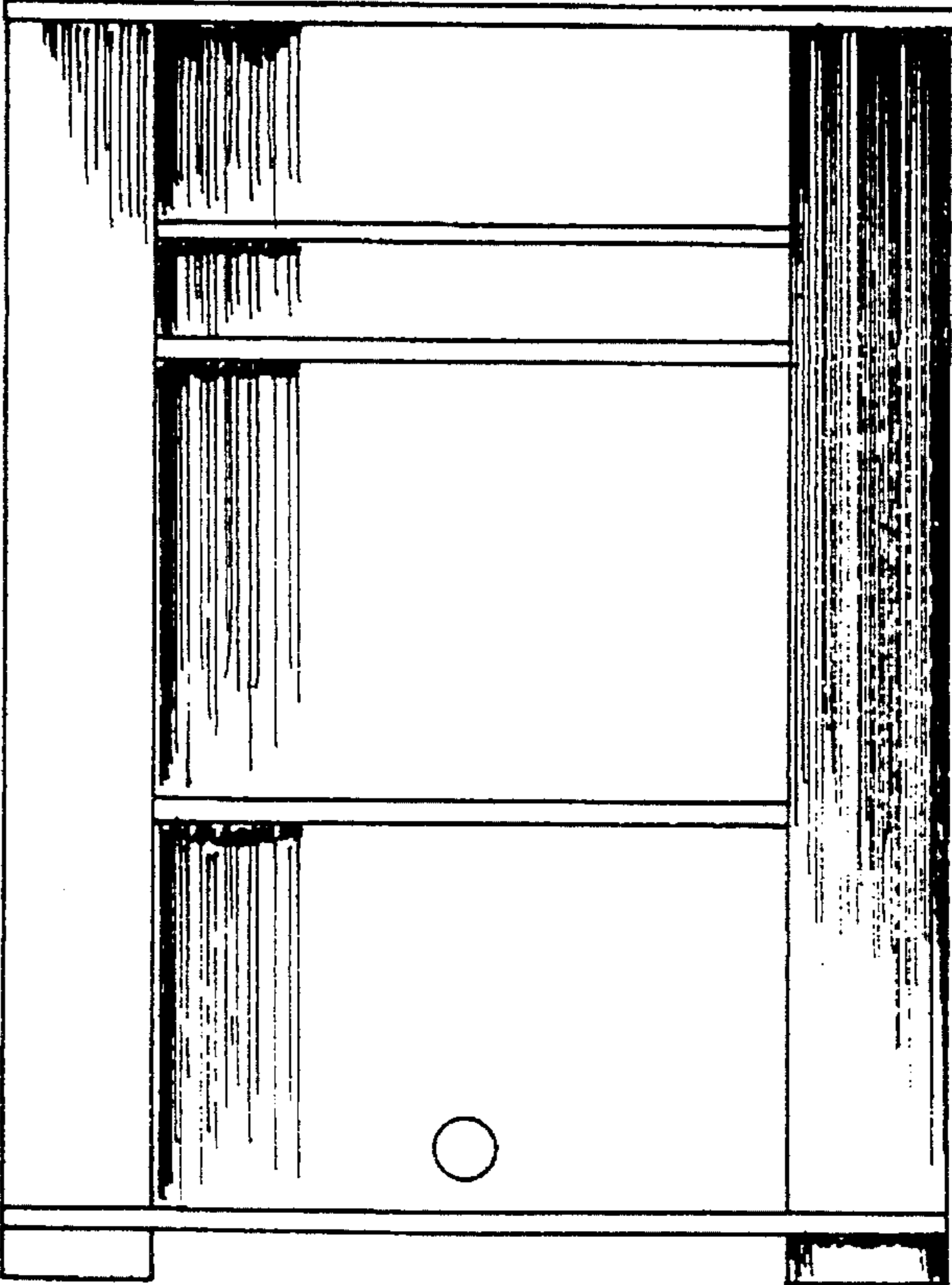

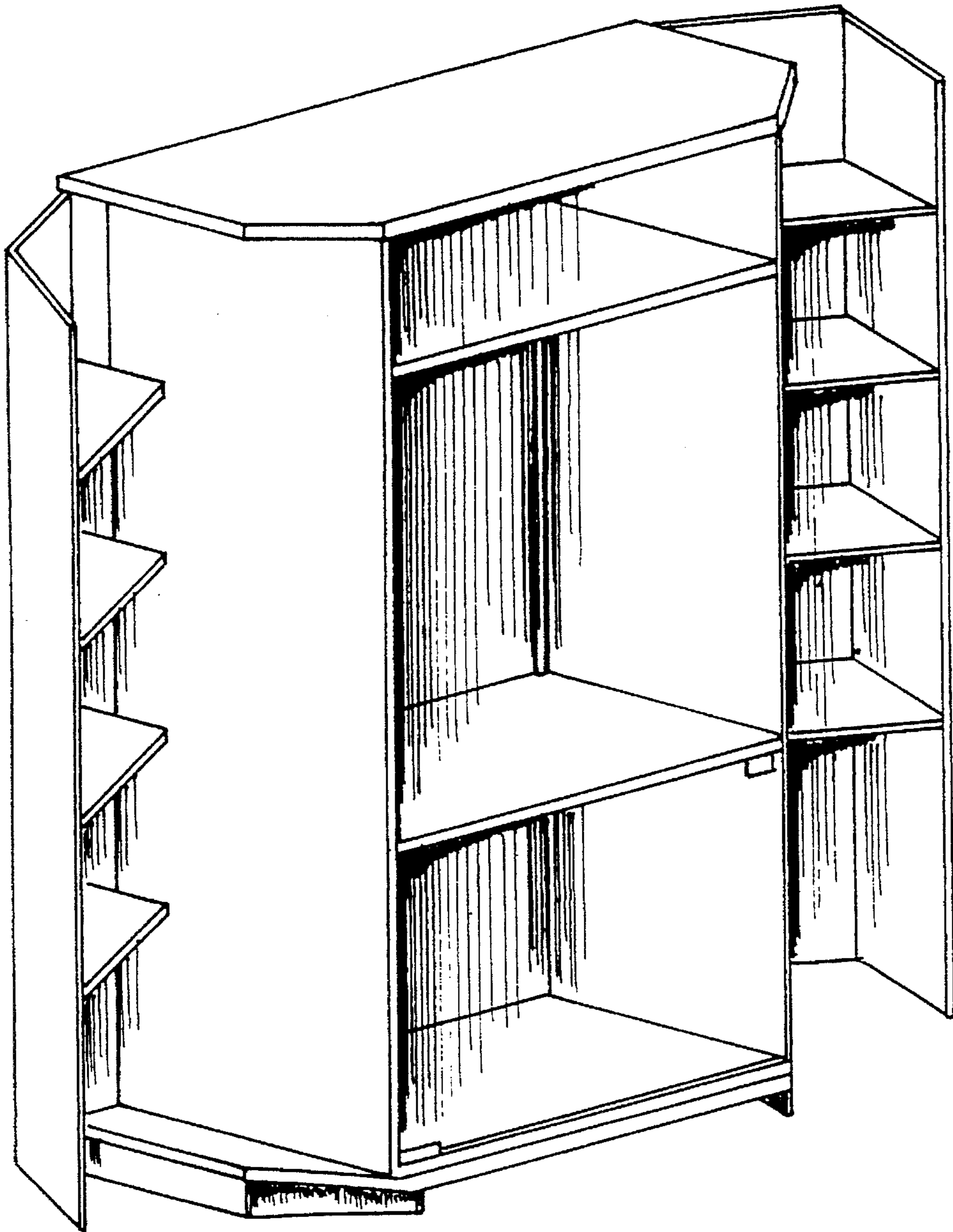

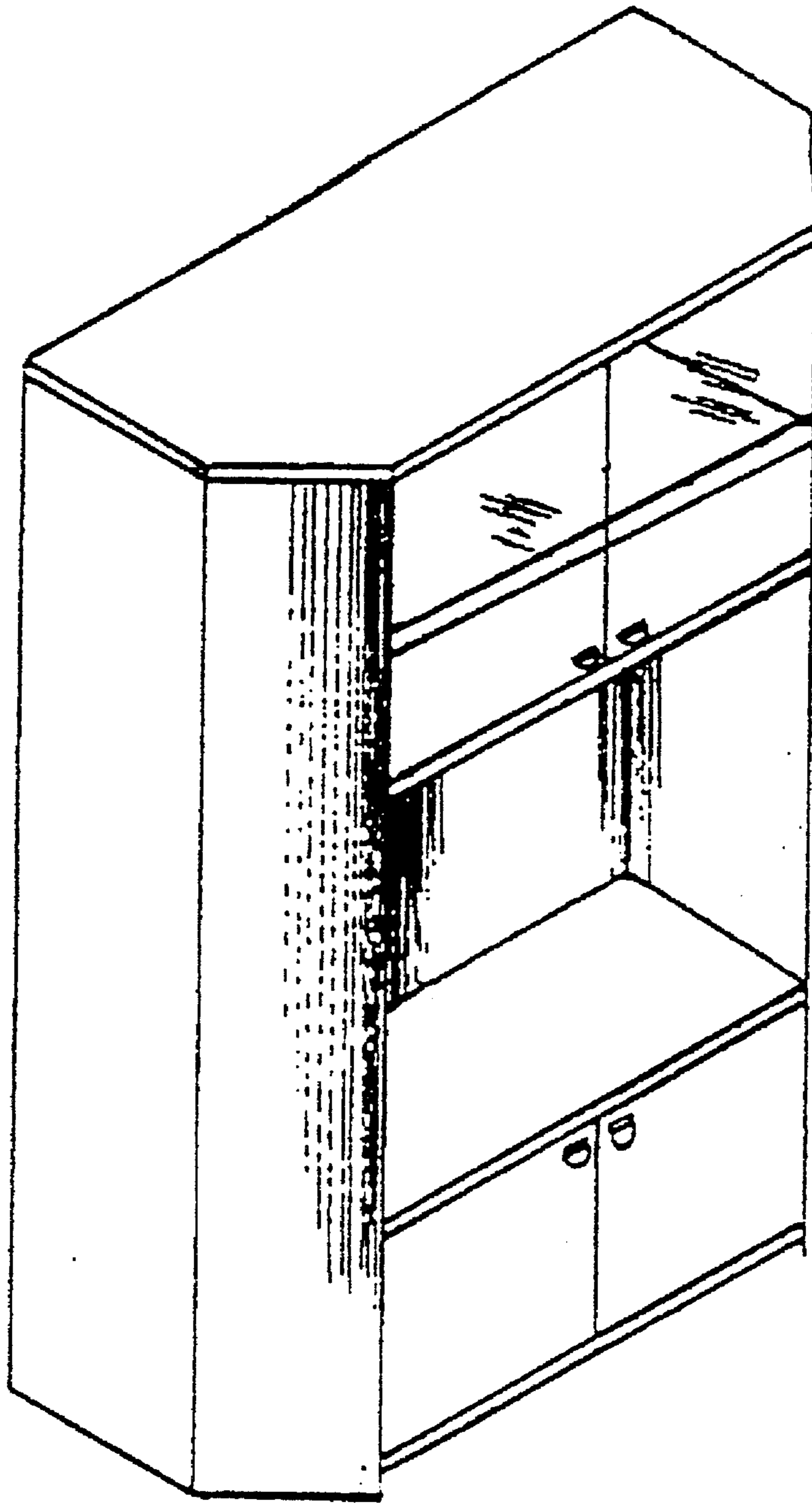
