**DESCRIPTION**

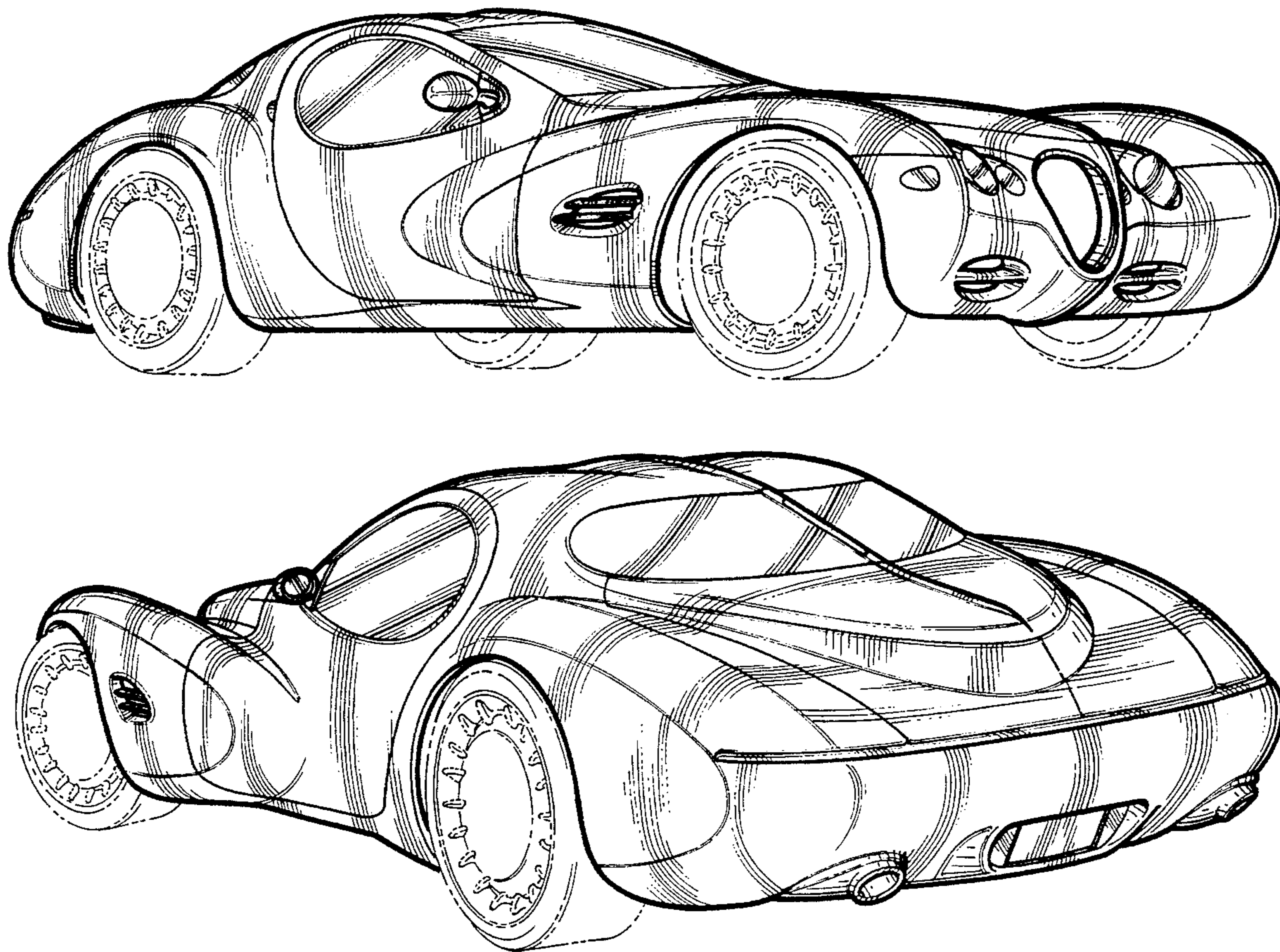
FIG. 1 is a front and left side perspective view of a vehicle body showing my new design;

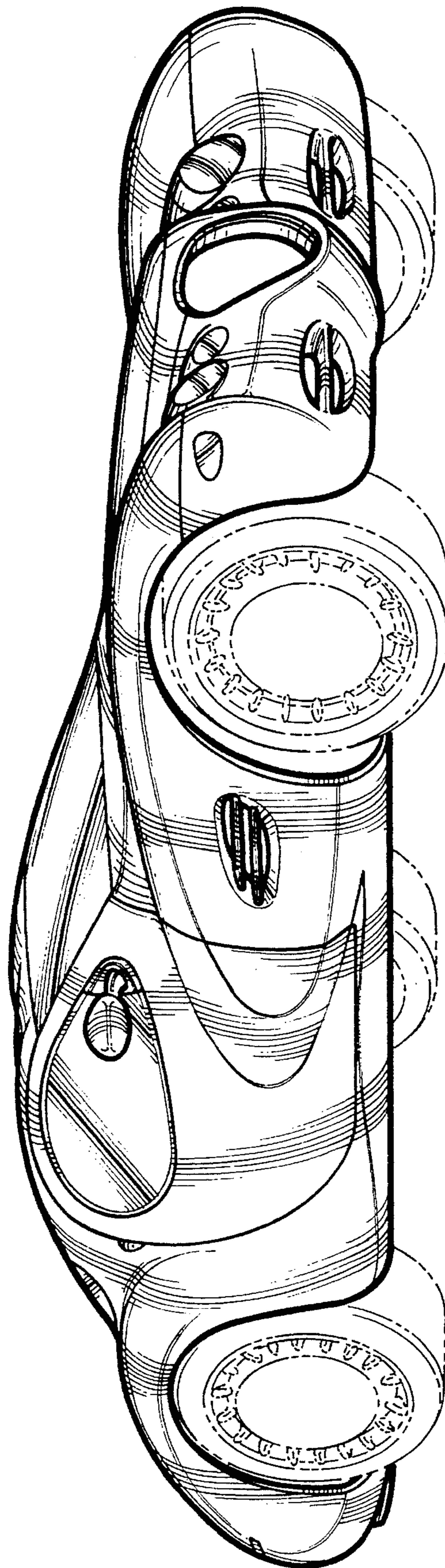

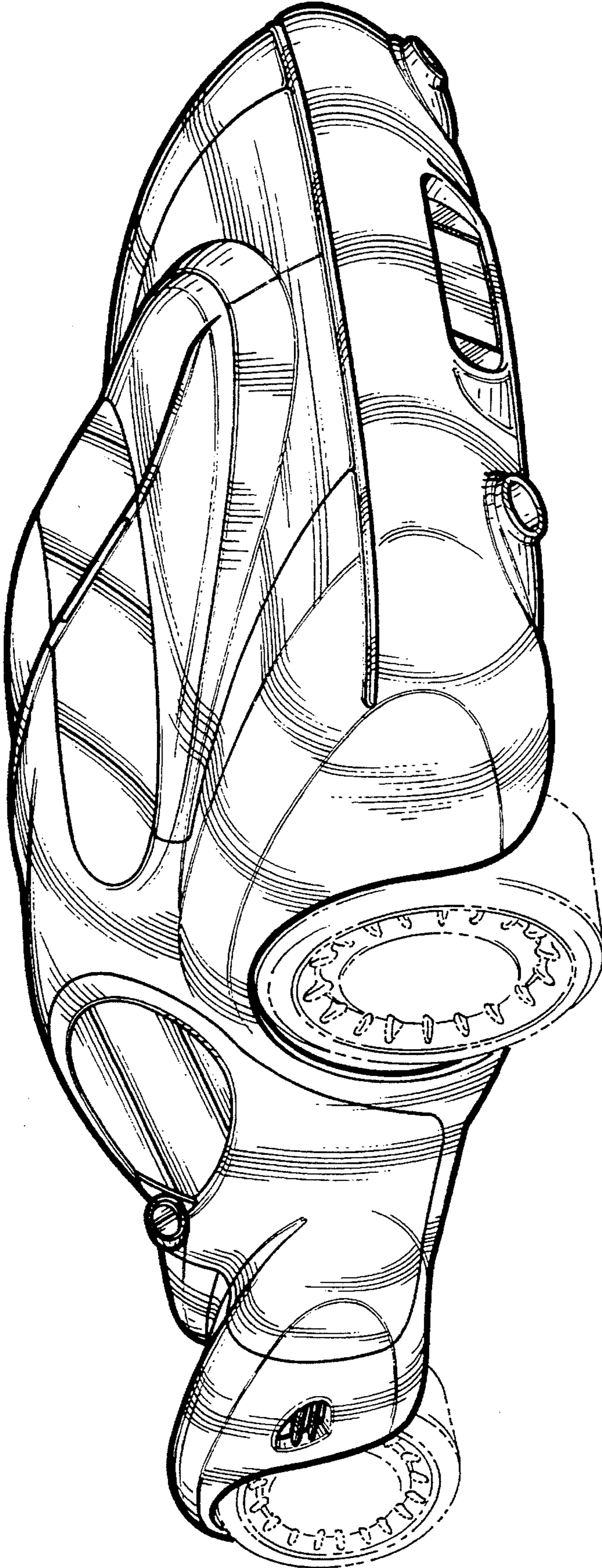

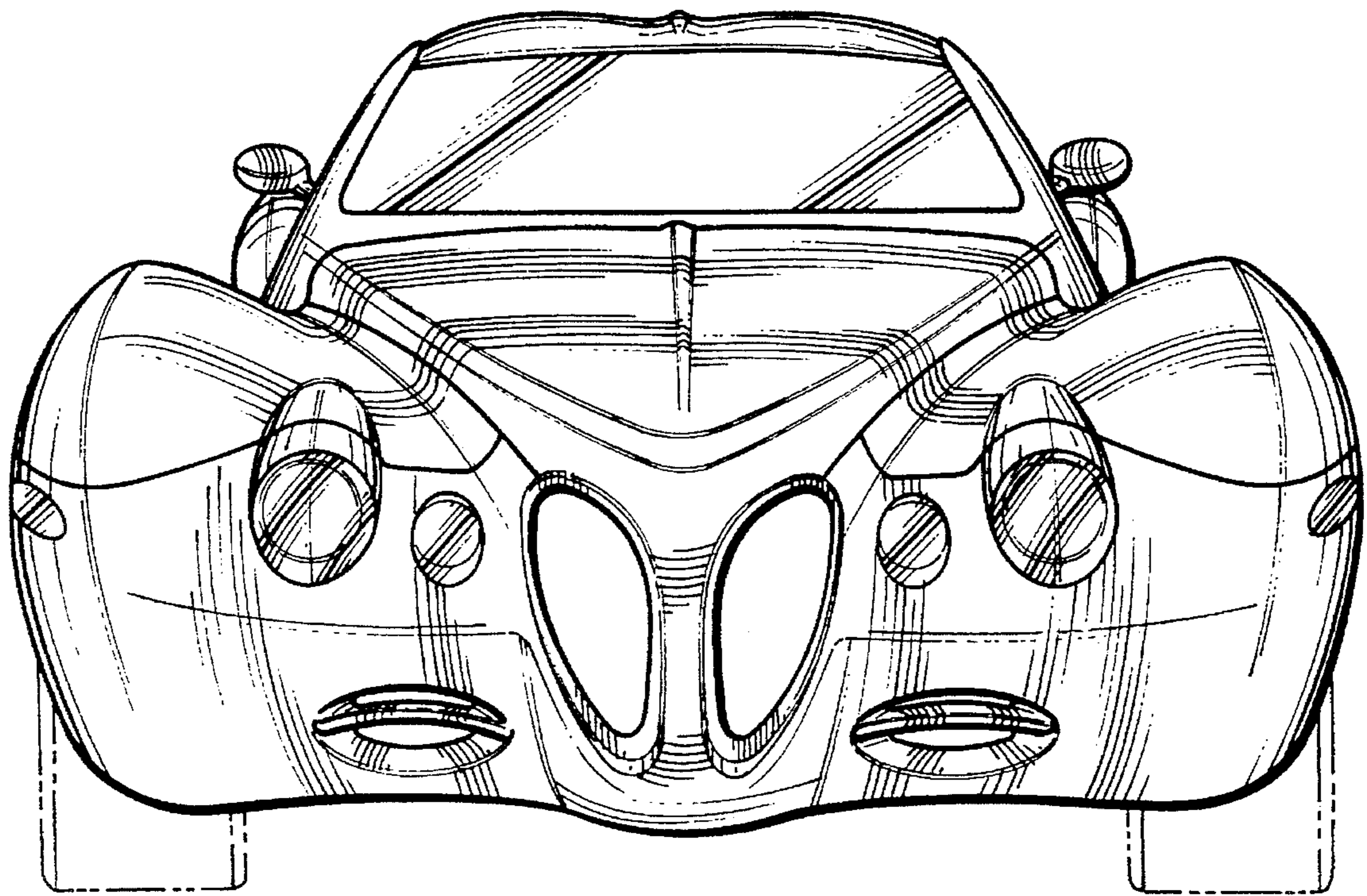
