[57] CLAIM

An ornamental design for a dental floss dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dental floss dispenser on a reduced scale, the broken line drawing of dental floss is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a front elevational view;

FIG. 3 is a rear elevational view;


FIG. 4 is a first side elevational view;



FIG. 1**FIG. 5**



FIG. 4***FIG. 2***



