[57] **CLAIM**

The ornamental design for an archer's shirt, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an archer's shirt showing our new design, the broken lines partially showing a human form in FIGS. 1 through 3 being for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a perspective view thereof, the flap being shown open; FIG. 3 is a front elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The broken lines shown on the various edges of the claimed article throughout the views are understood to represent conventional stitching.

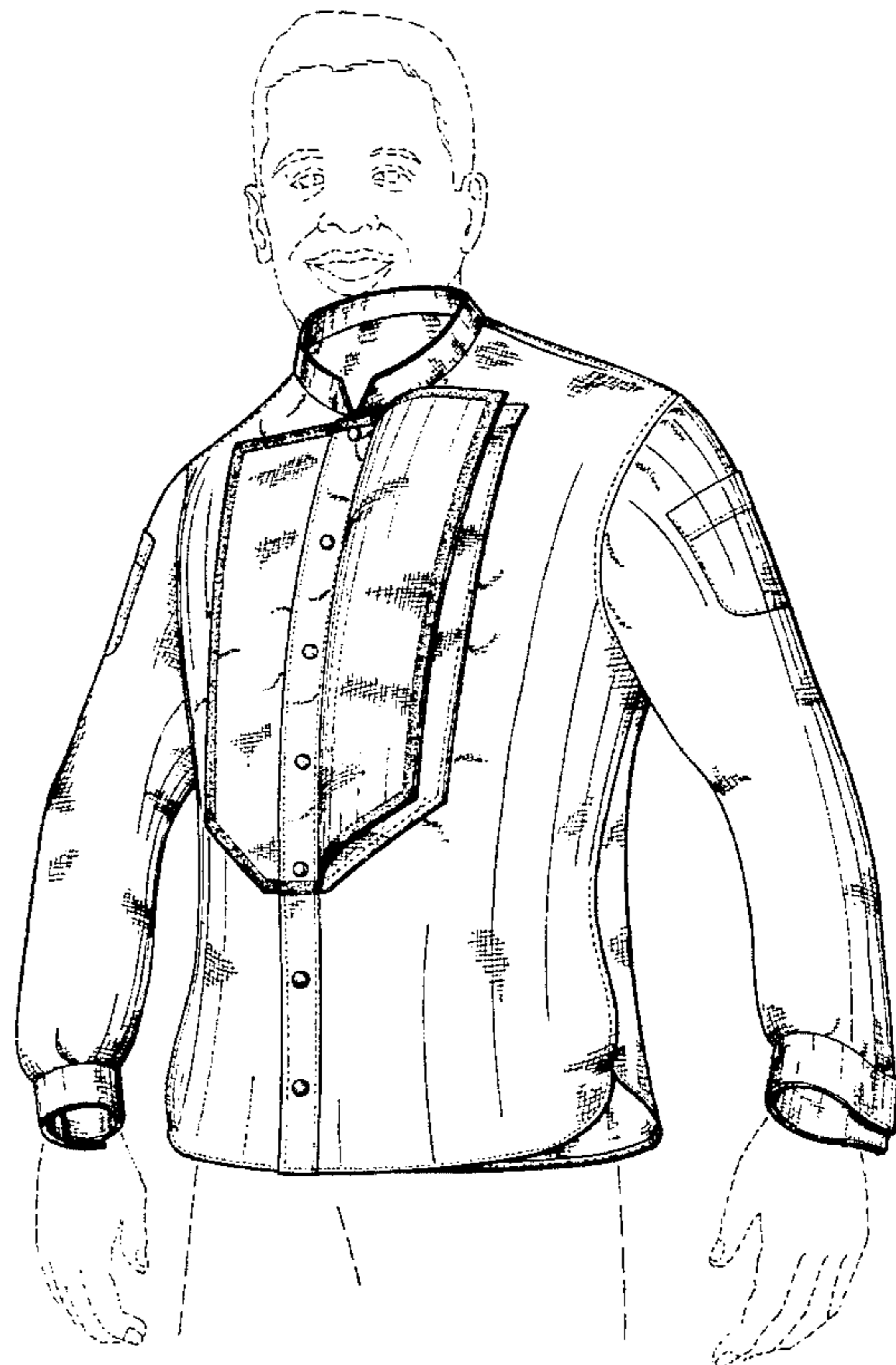
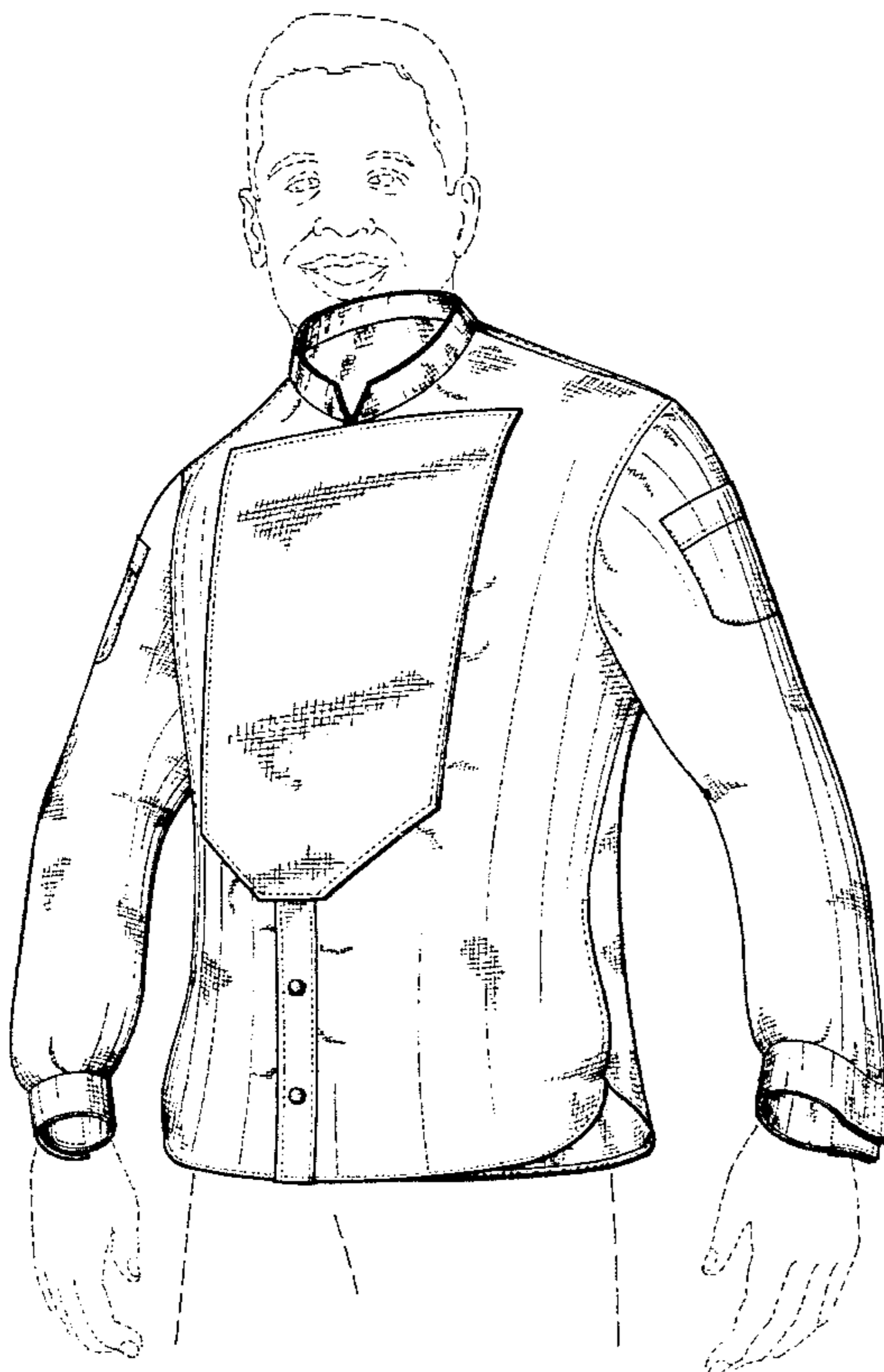

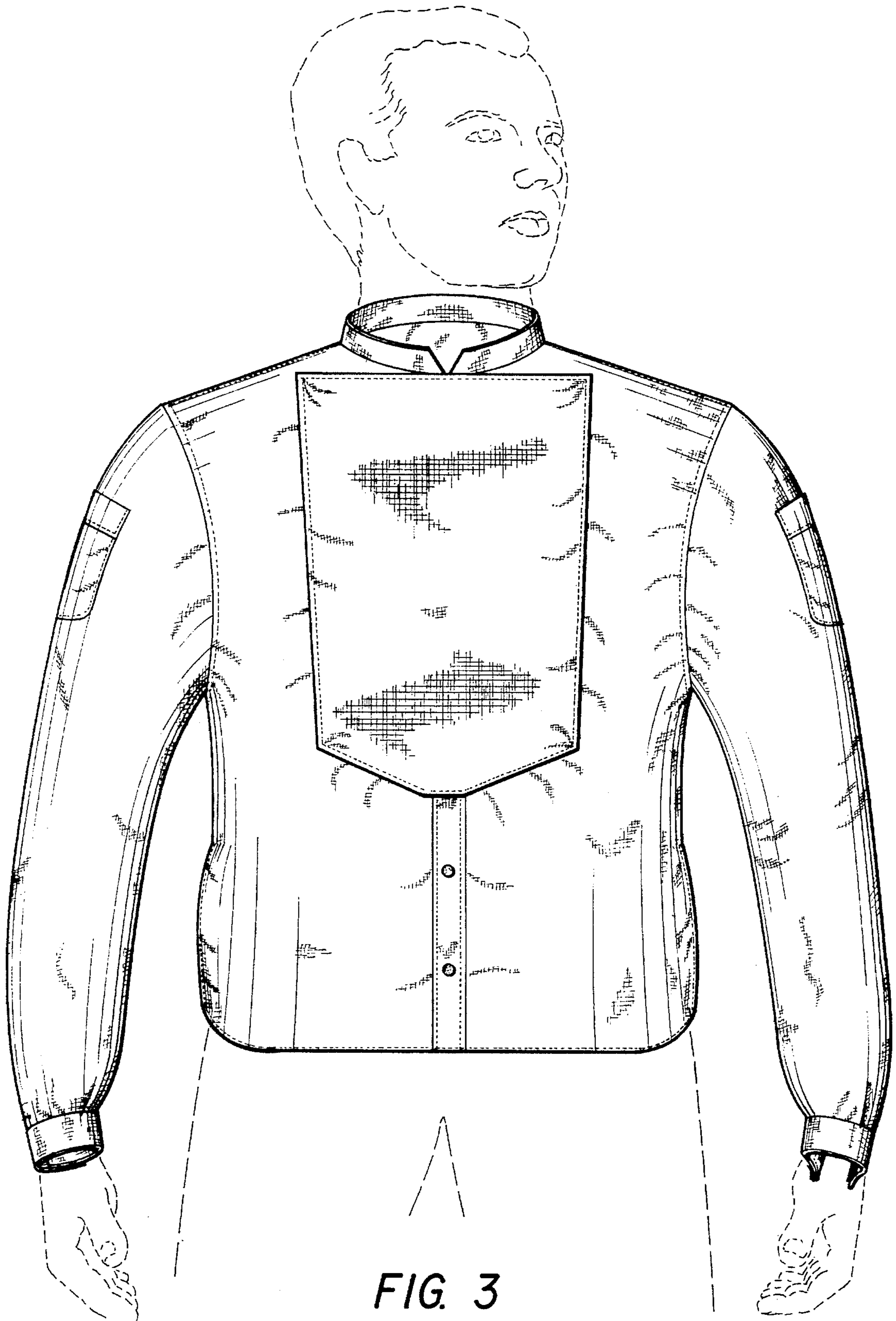

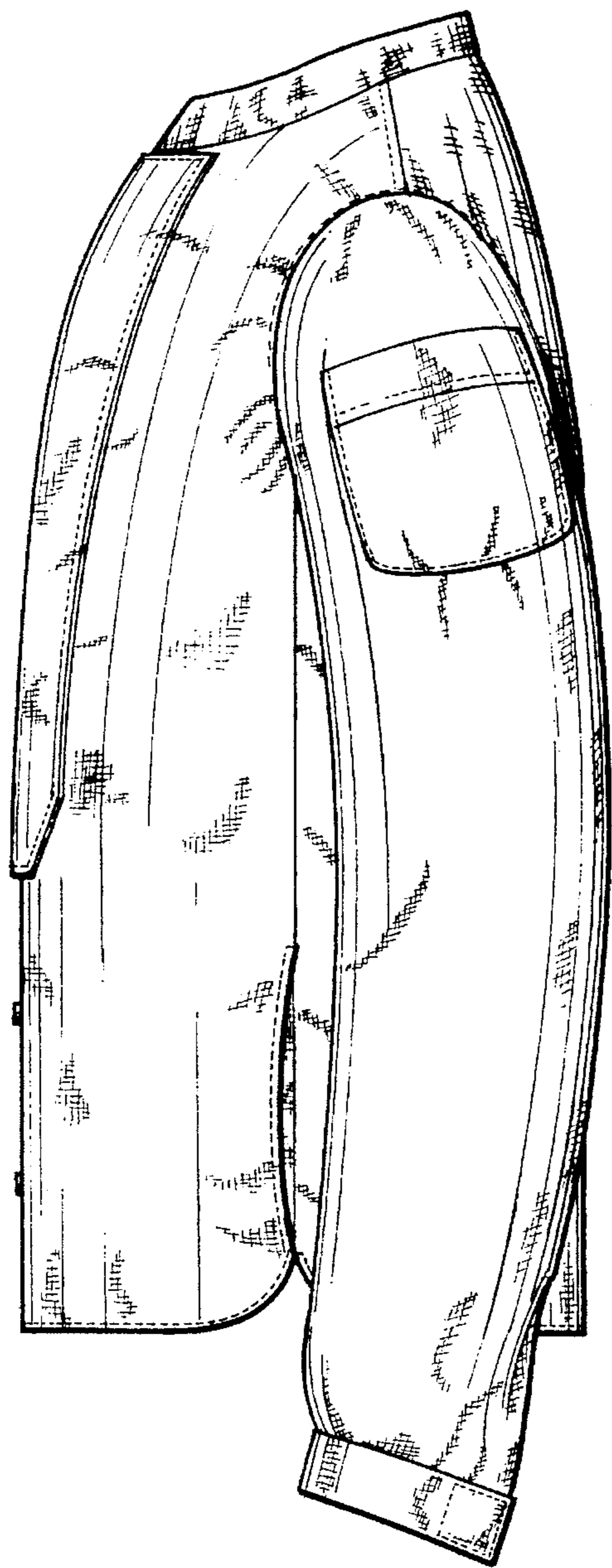

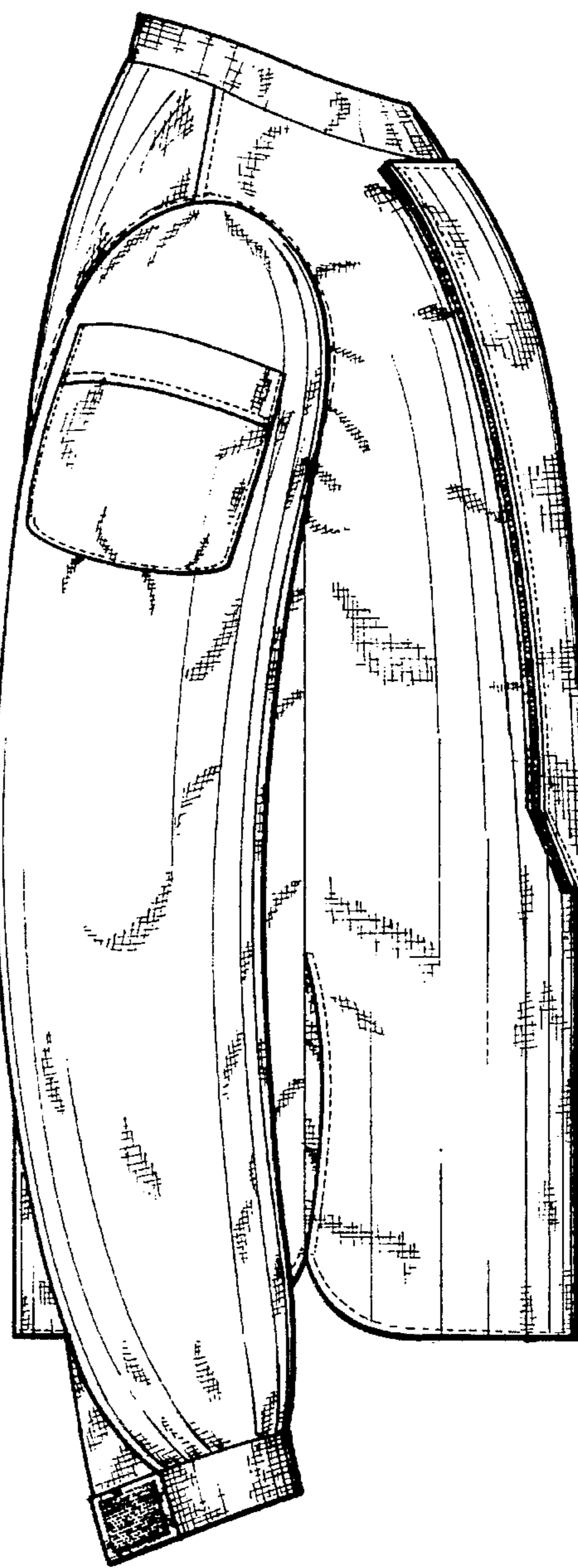

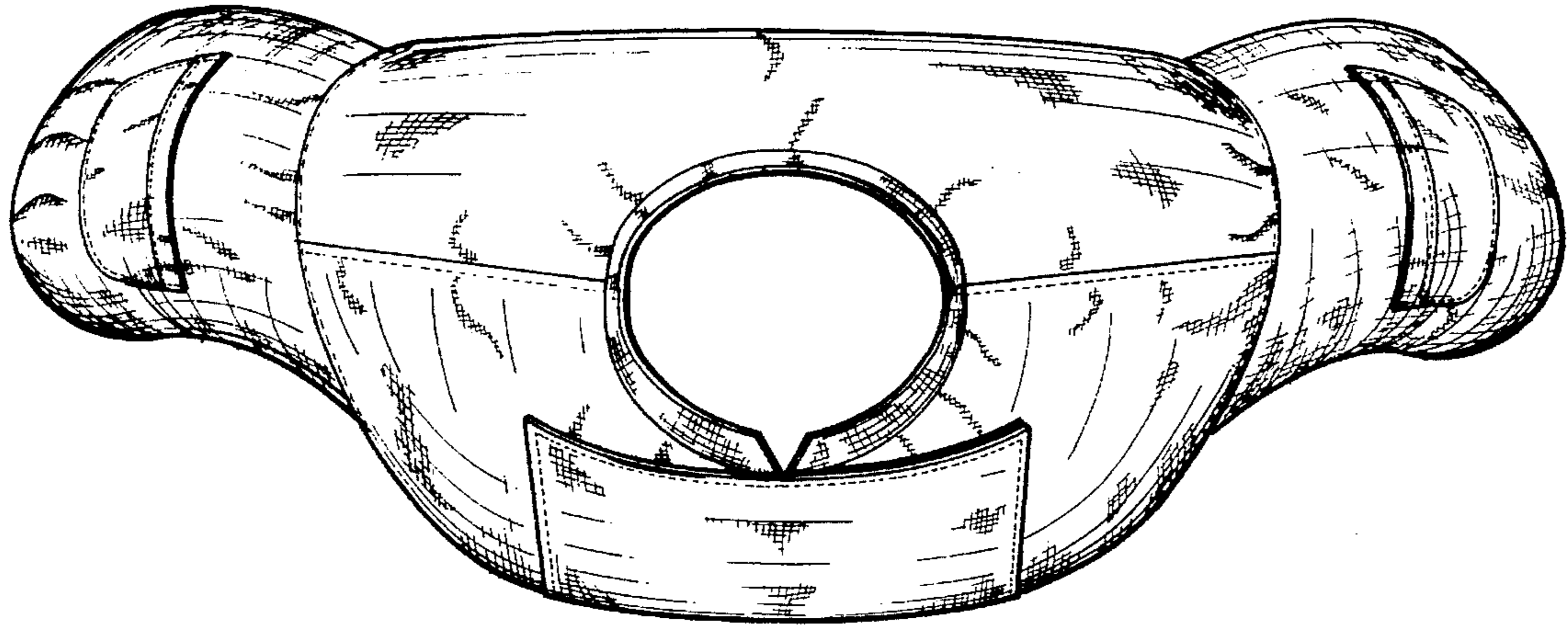

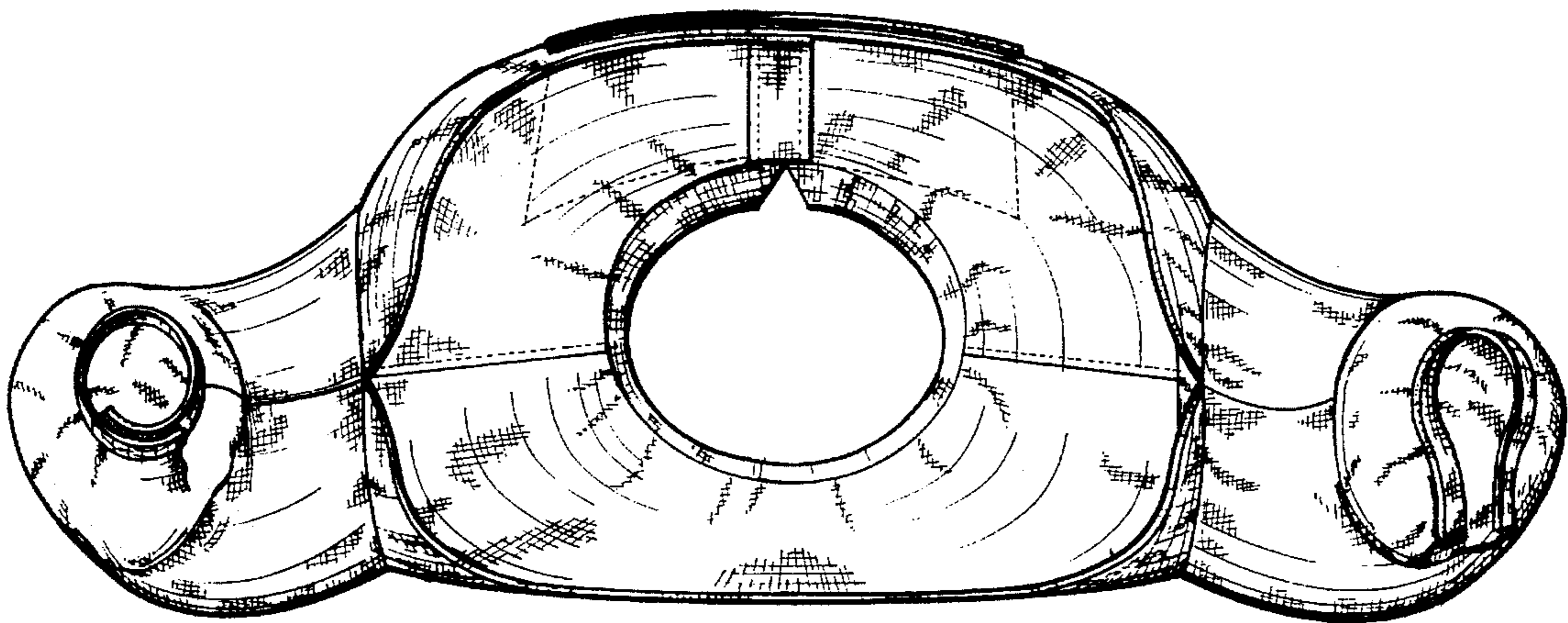
