[57] **CLAIM**

The ornamental design for the handle for a kitchen utensil, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for a kitchen utensil showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a perspective view of a second embodiment of the handle for a kitchen utensil;

FIG. 9 is a top plan view thereof;

FIG. 10 is a front elevational view thereof;

FIG. 11 is a left side elevational view thereof;

FIG. 12 is a bottom plan view thereof;

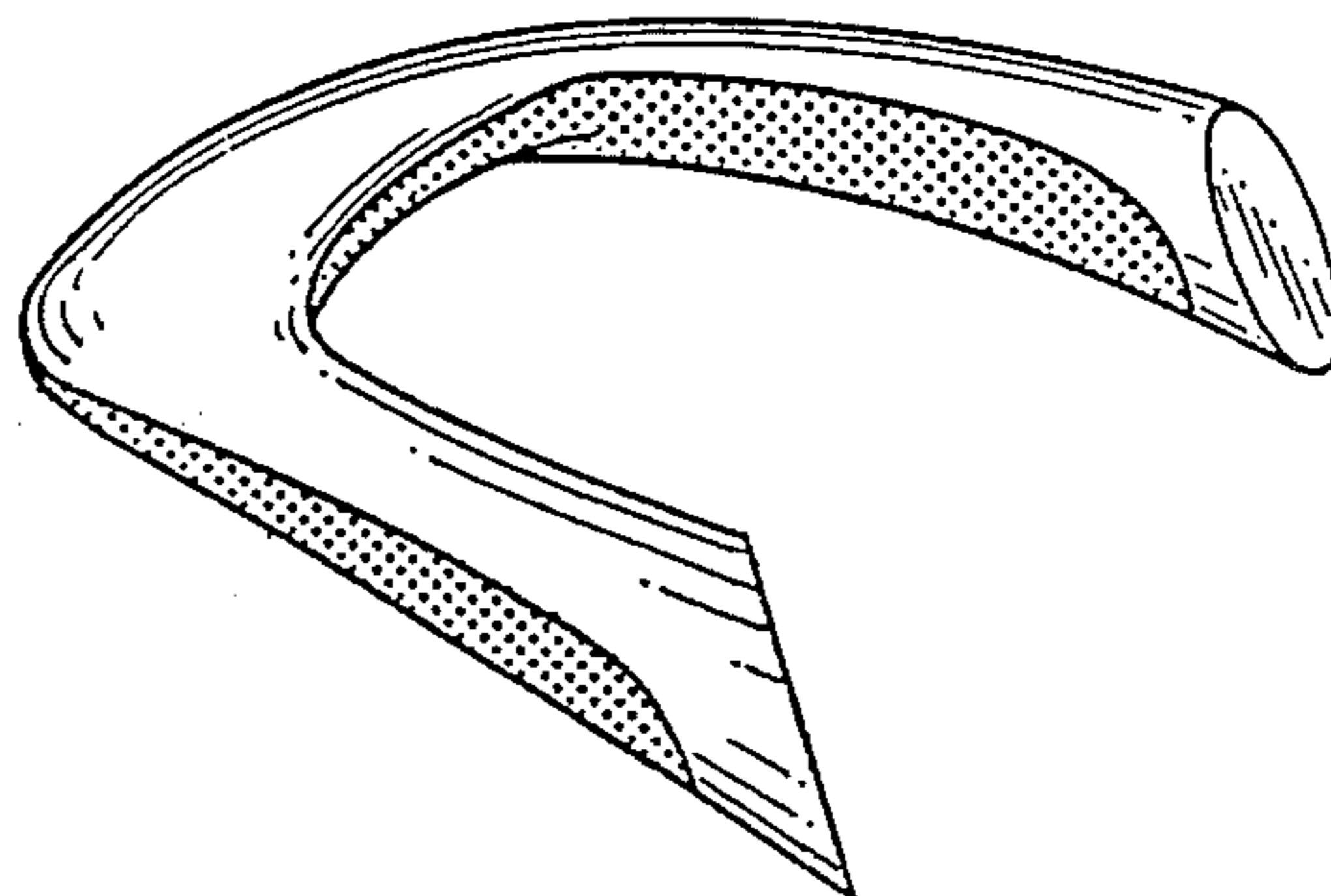
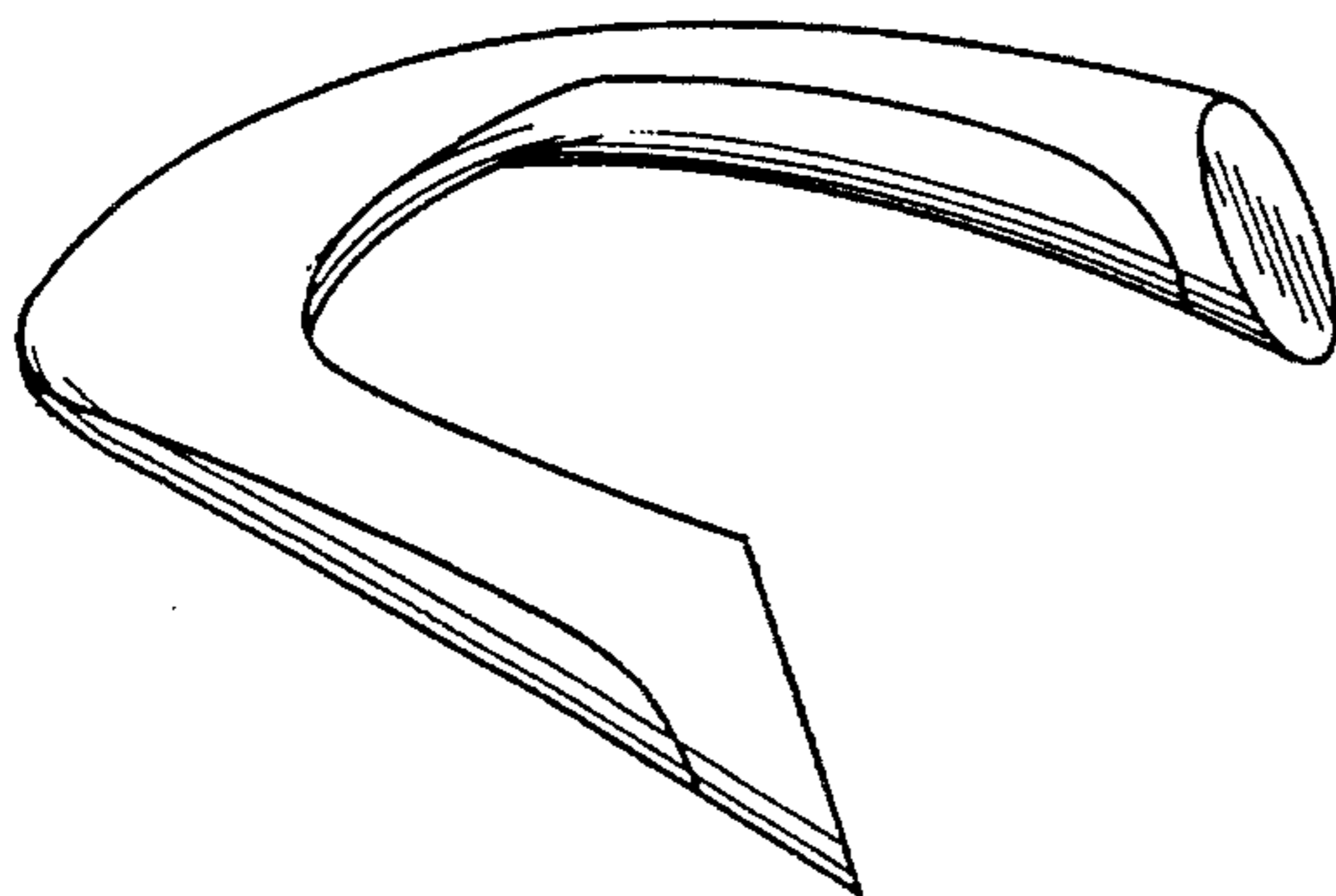
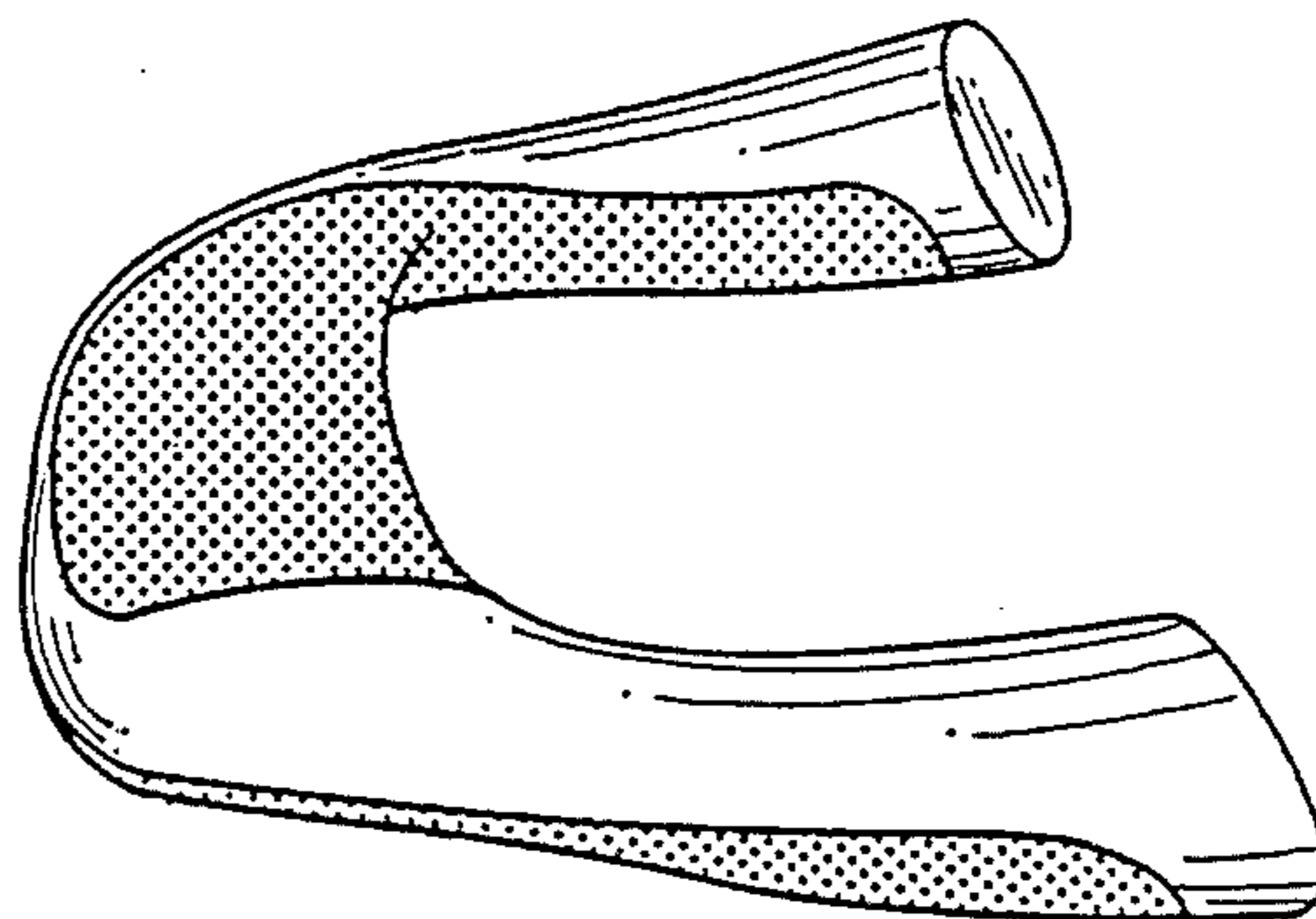
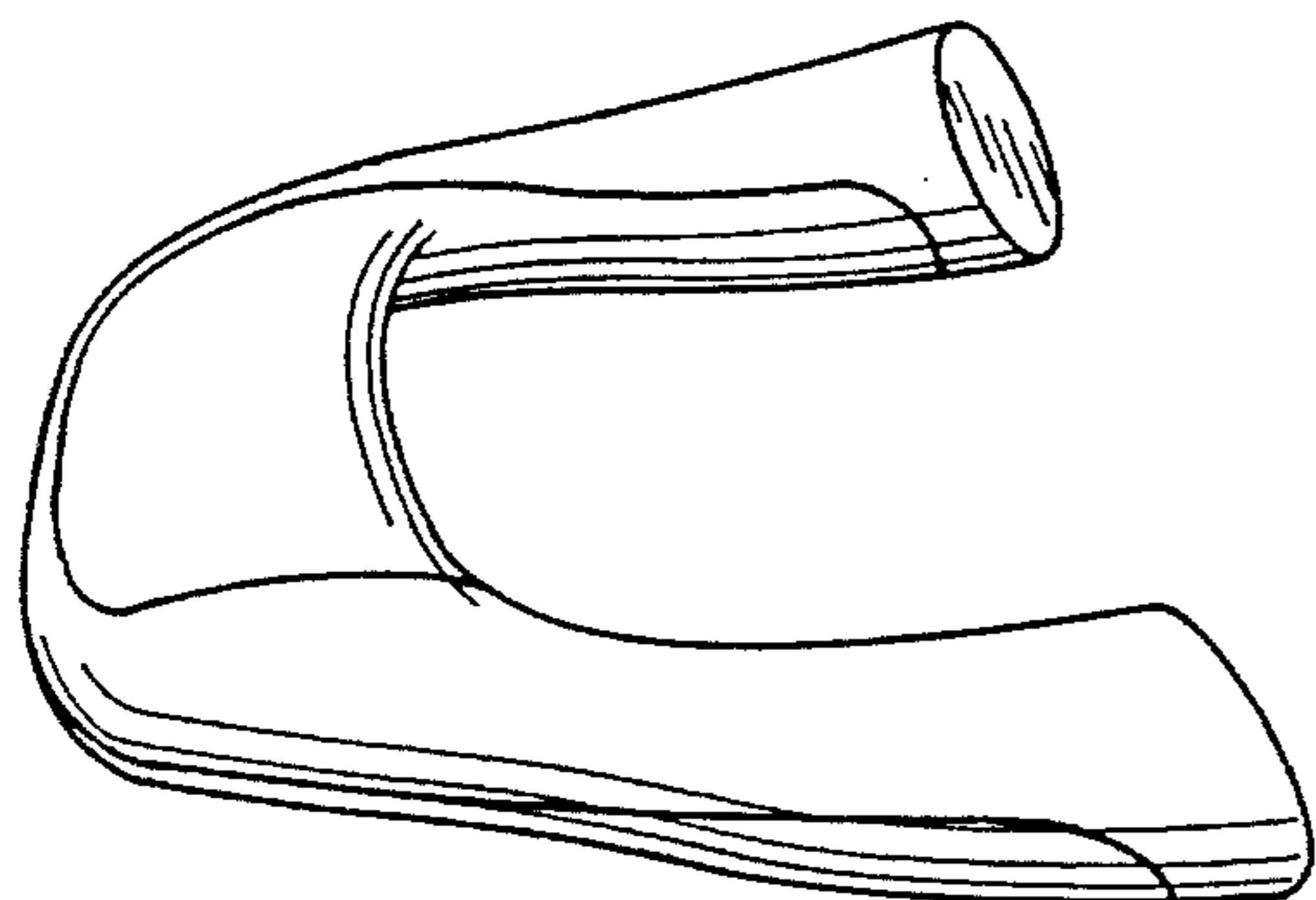
FIG. 13 is a rear elevational view thereof;

FIG. 16 is a perspective view of a fourth embodiment of a handle for a kitchen utensil identical to the handle shown in FIGS. 8-14. The only difference being the stippling which represents an area of different color.

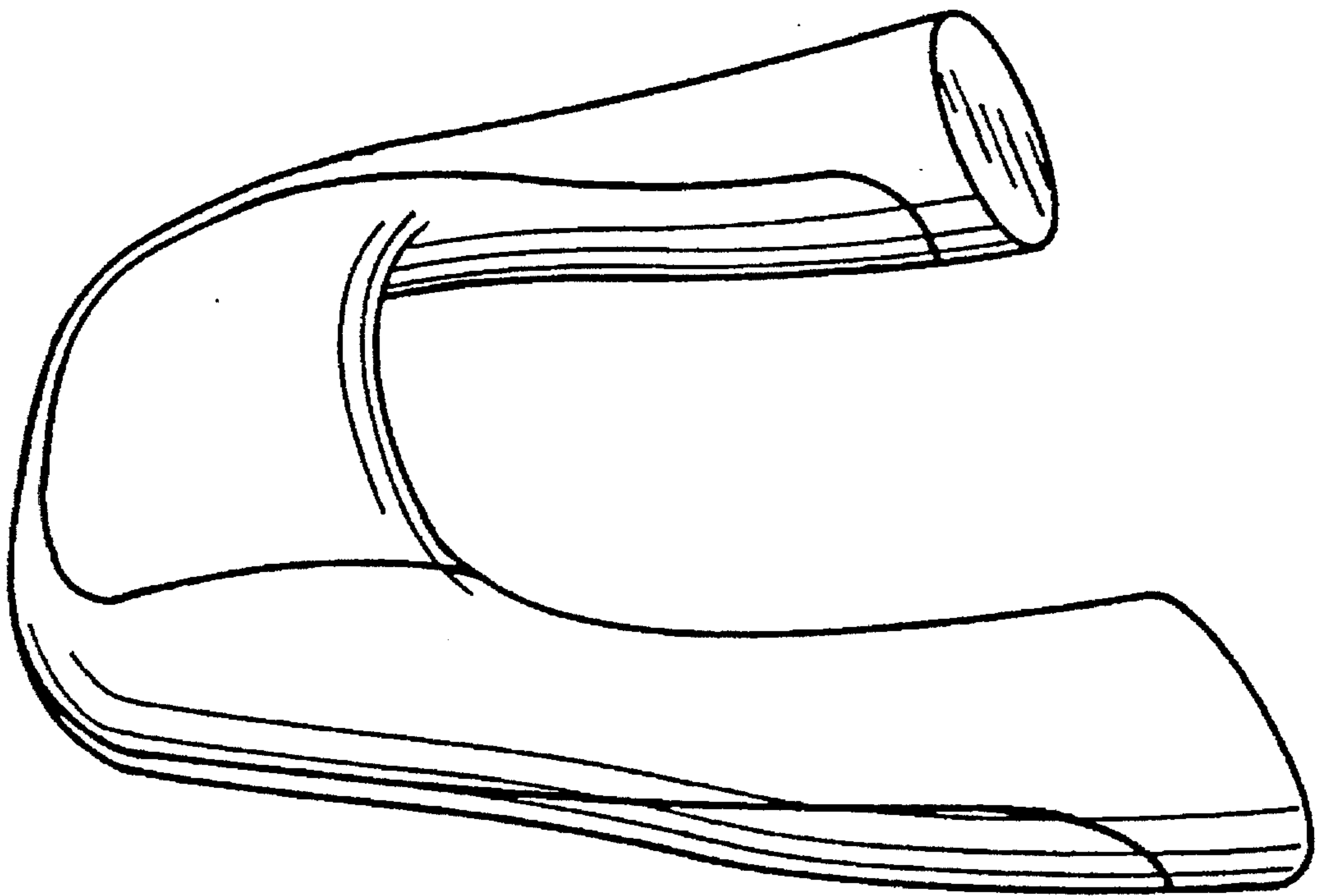

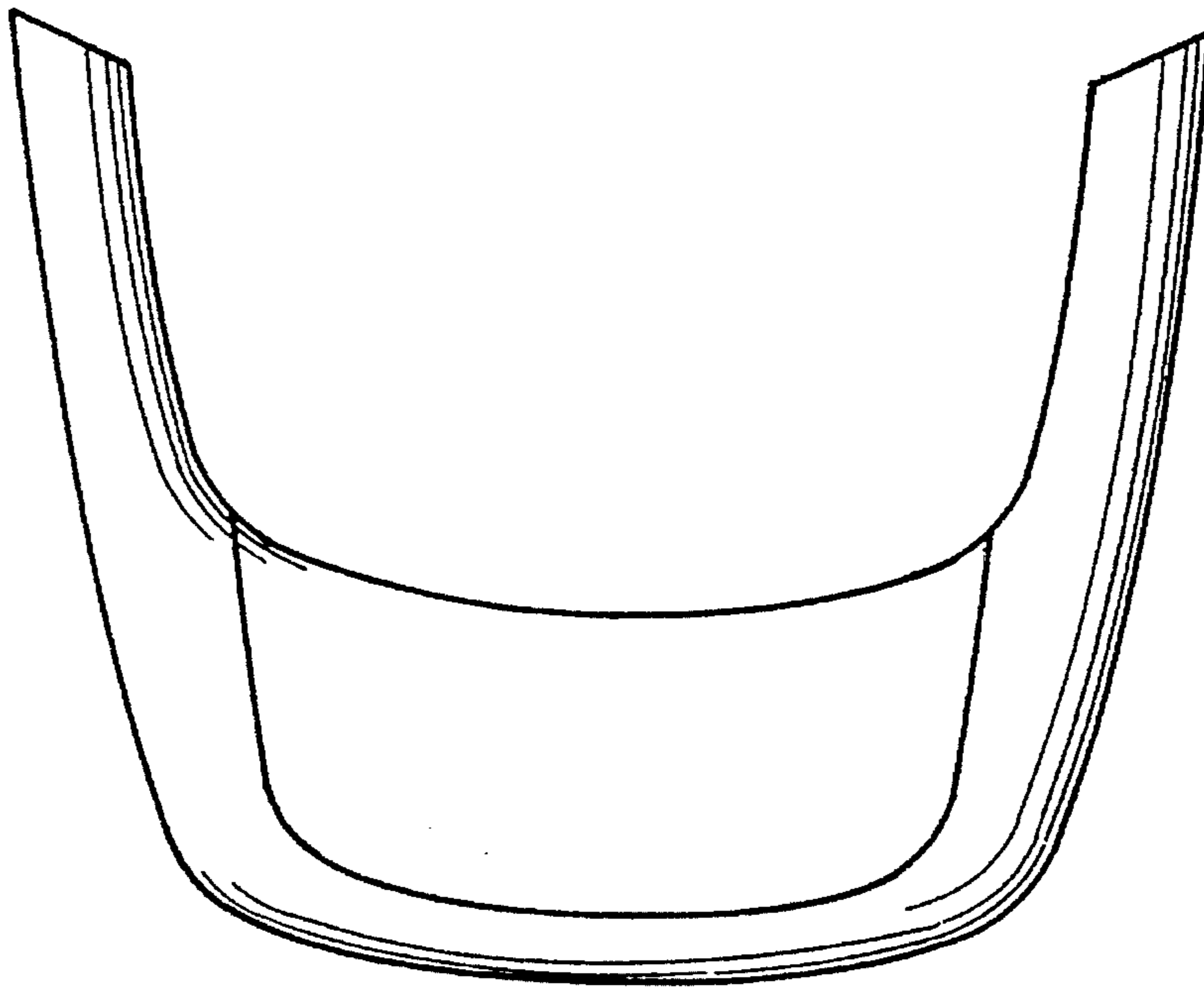

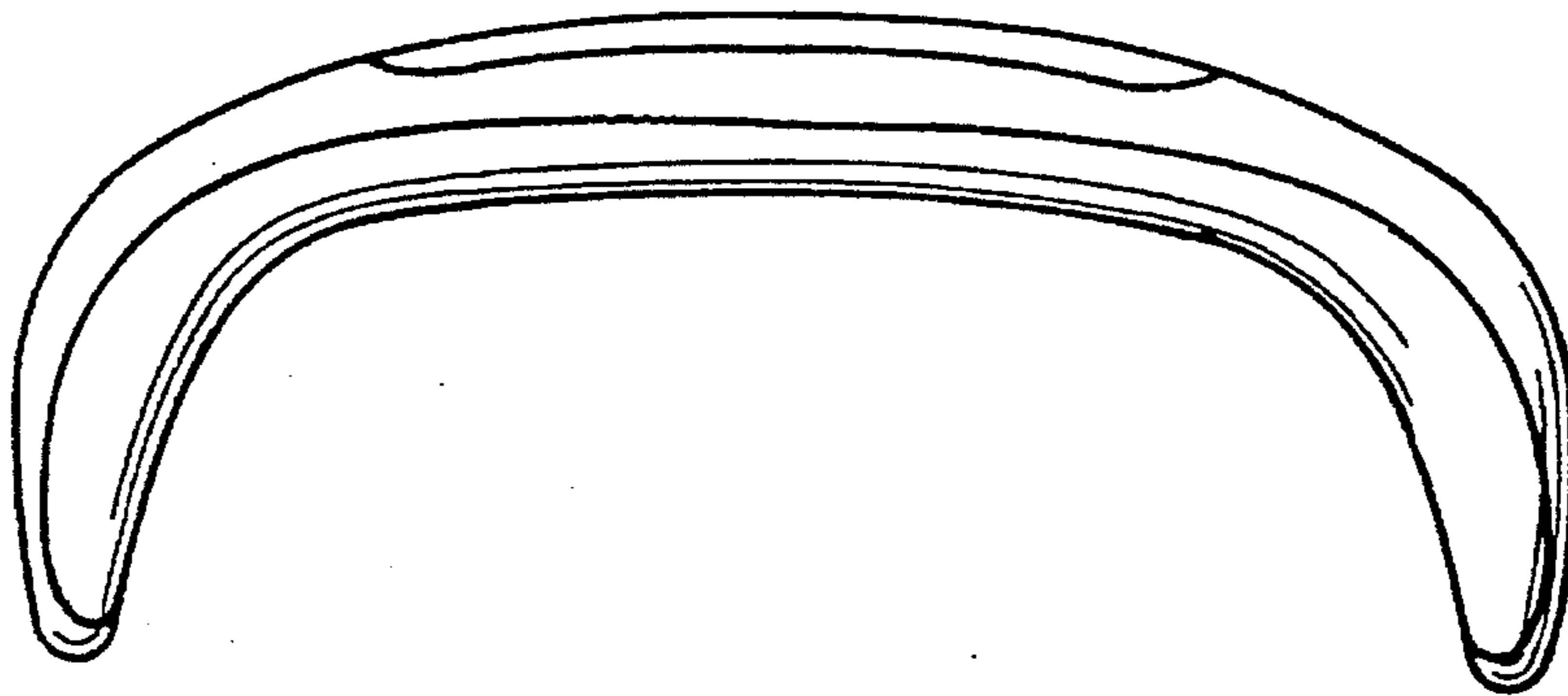

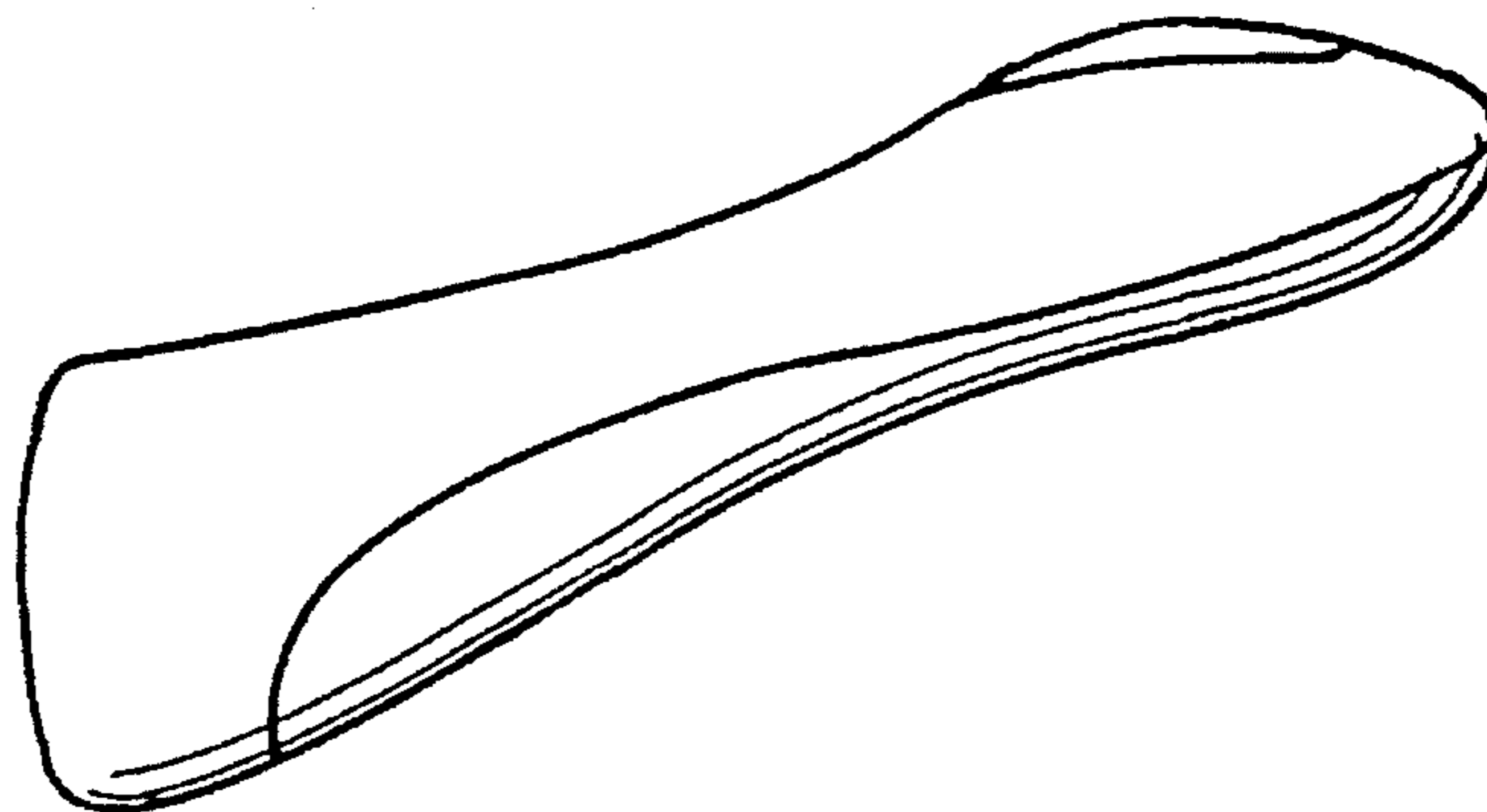

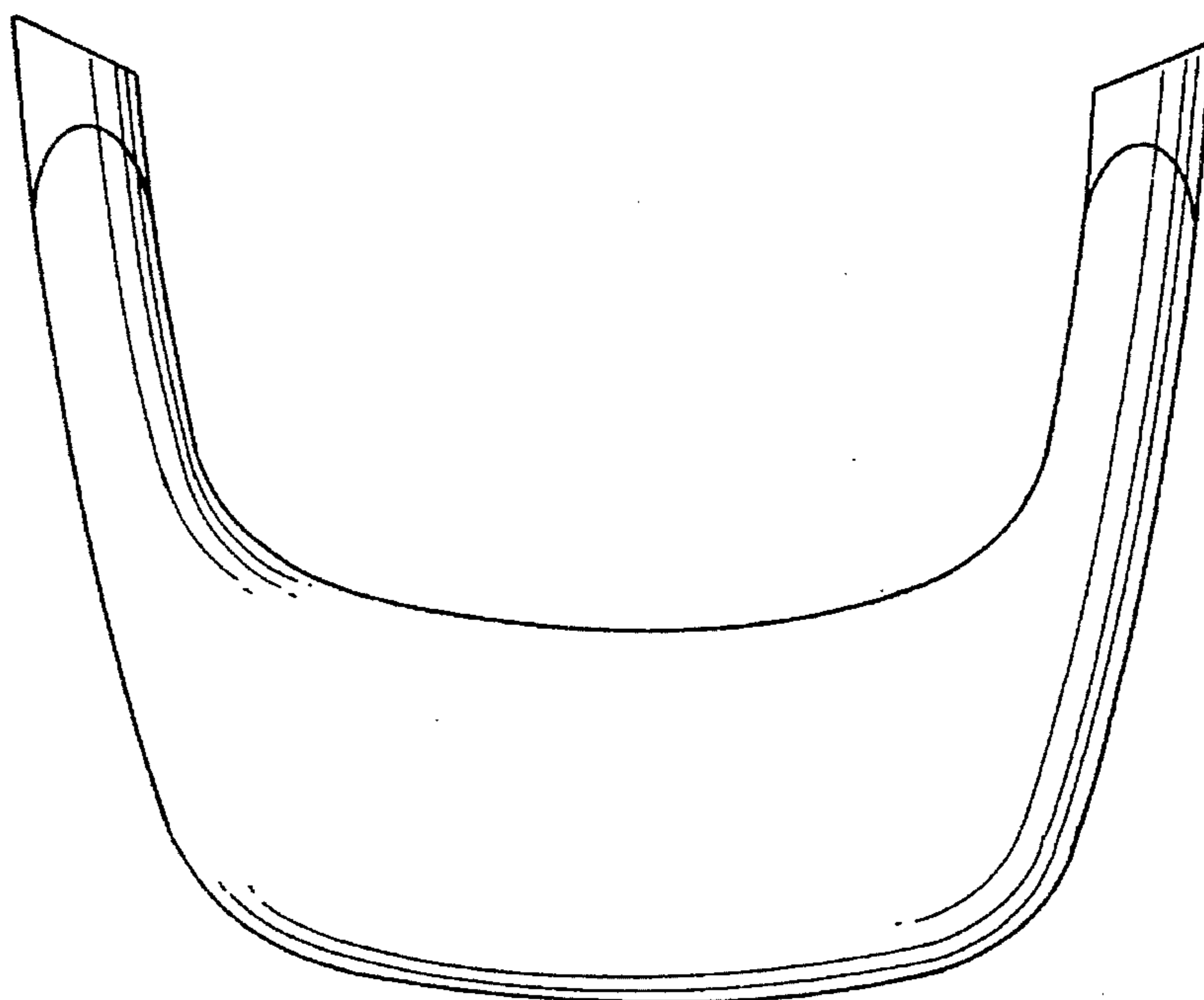

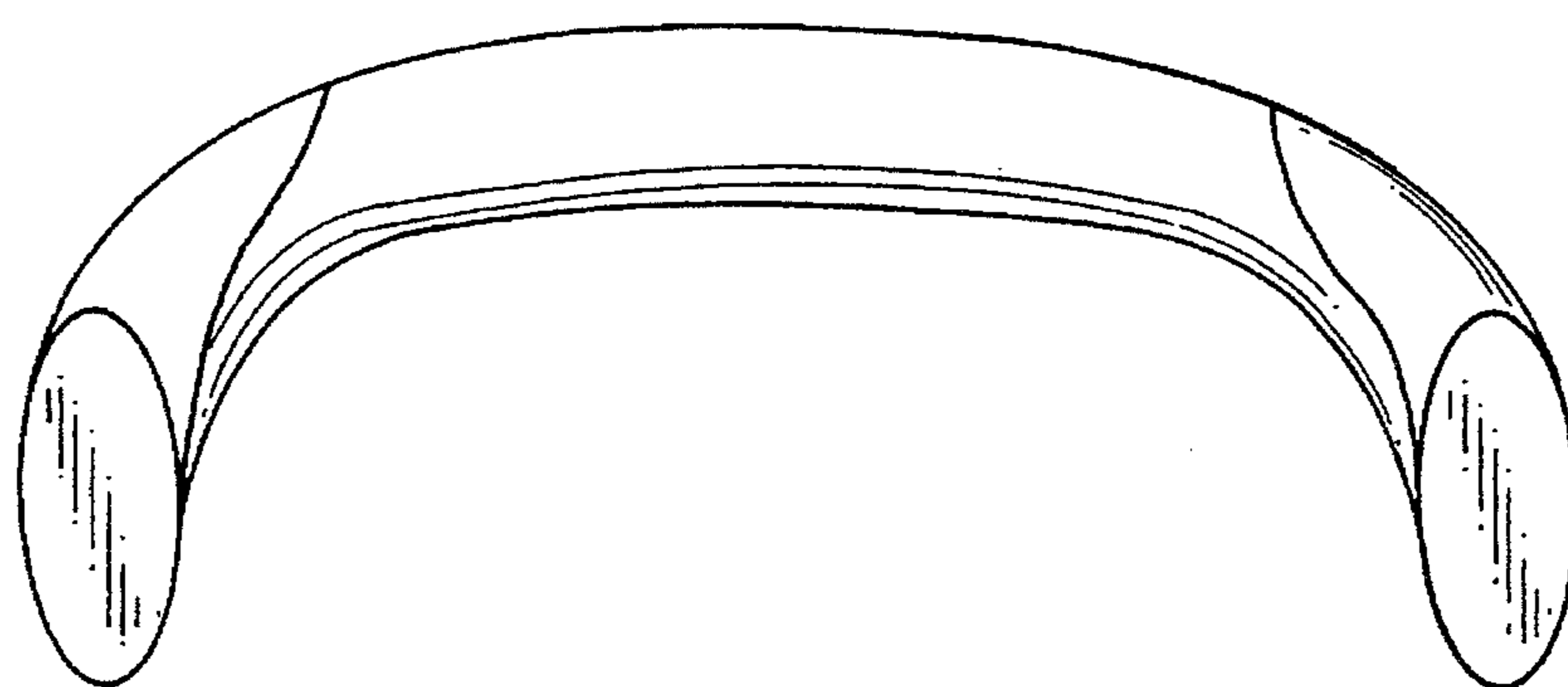

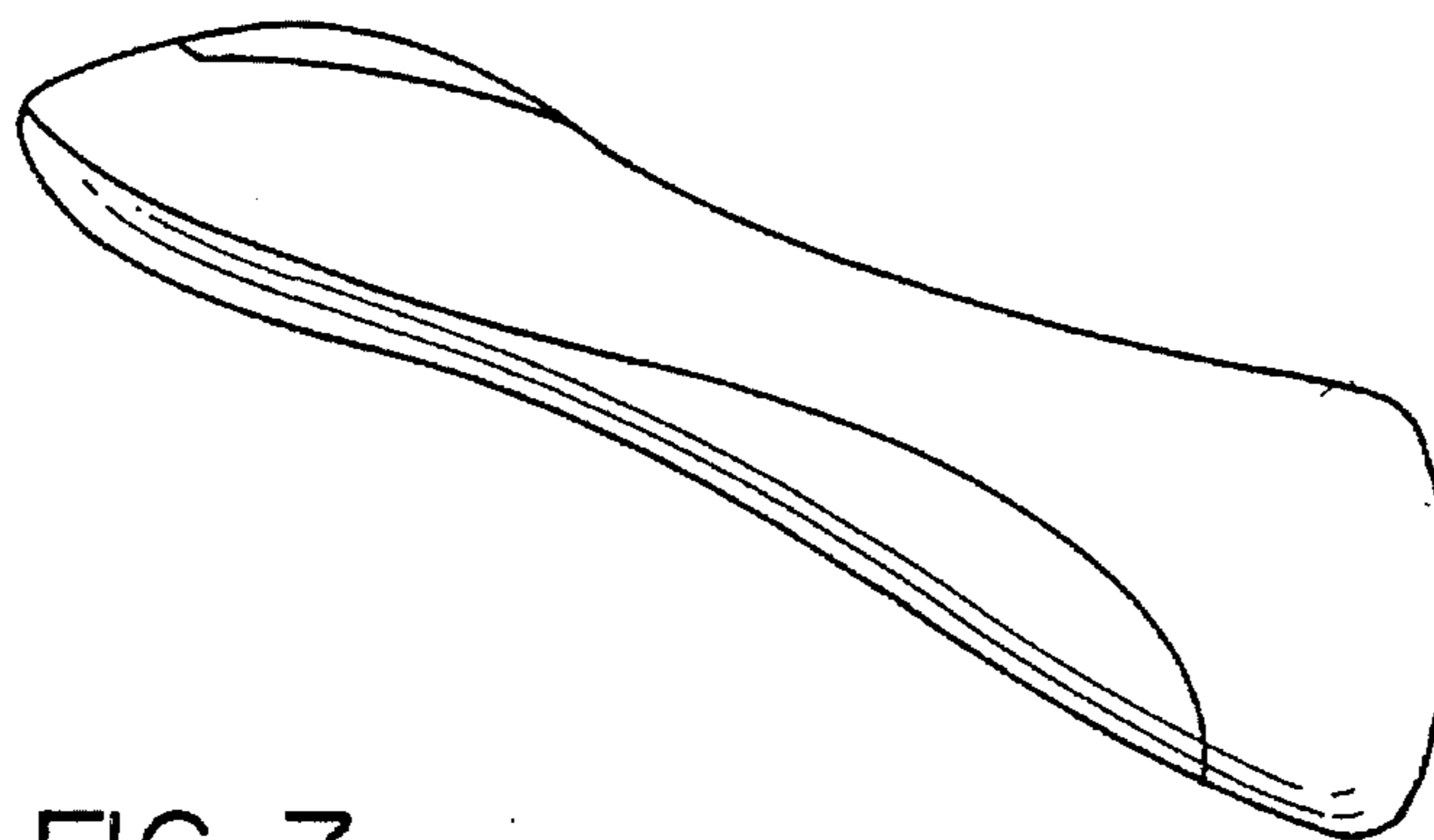

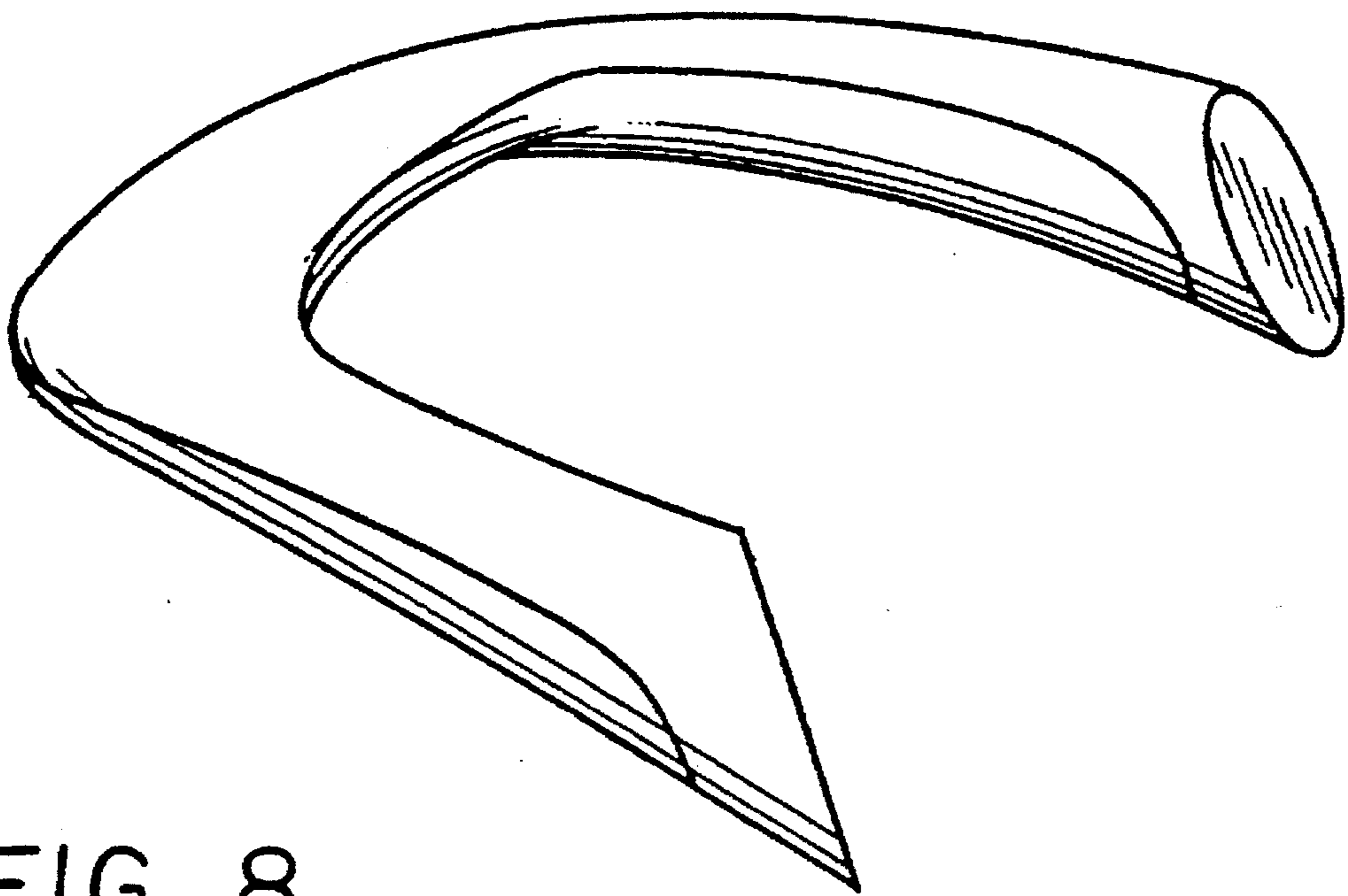

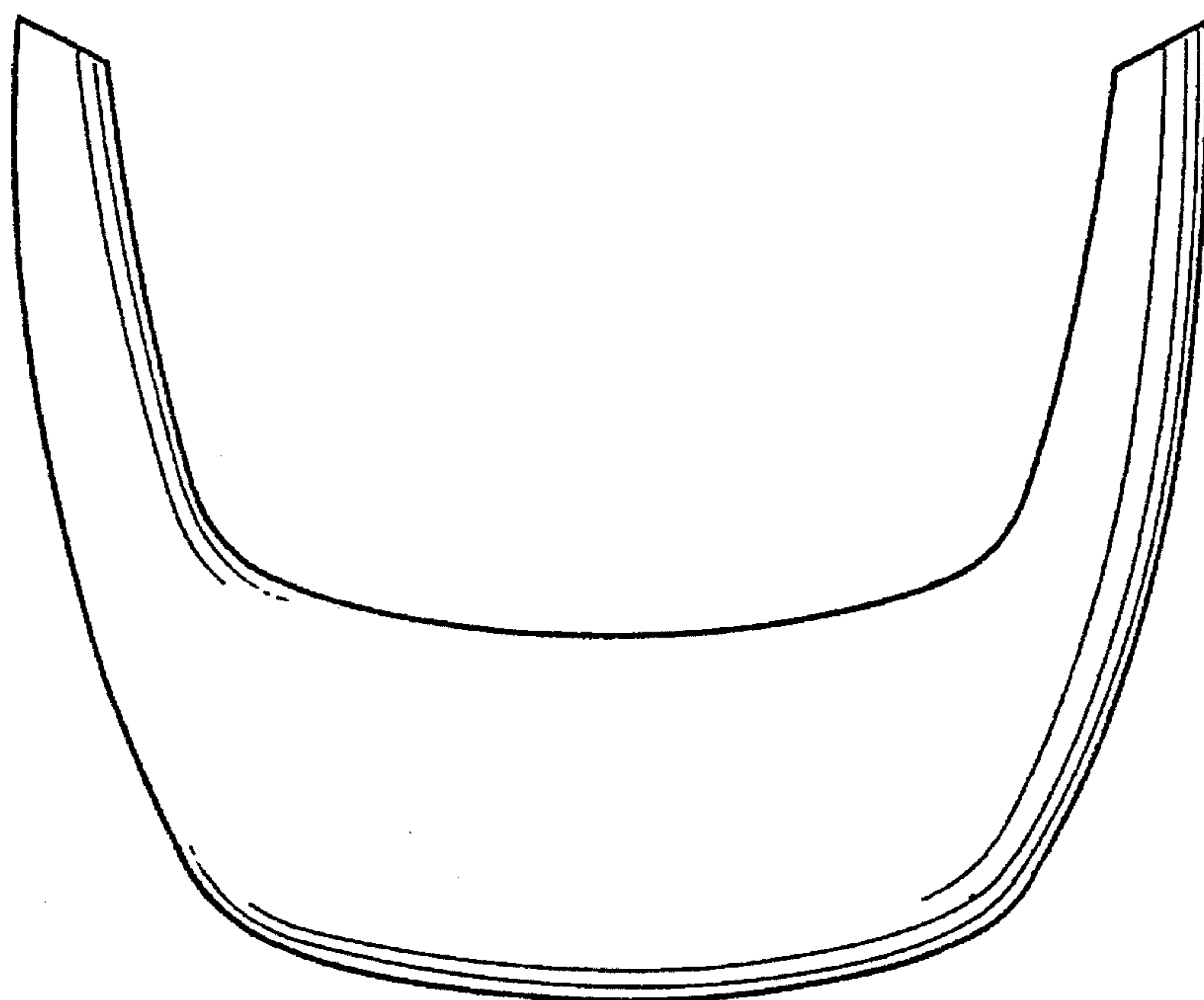

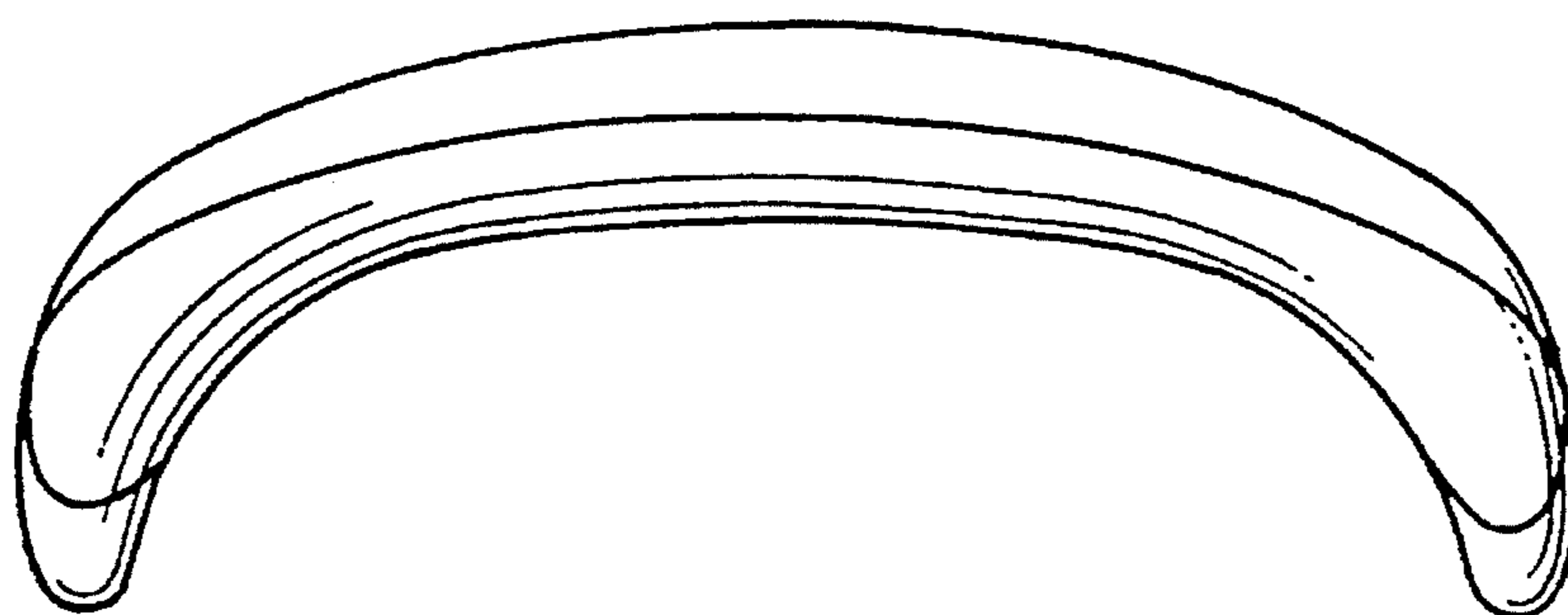

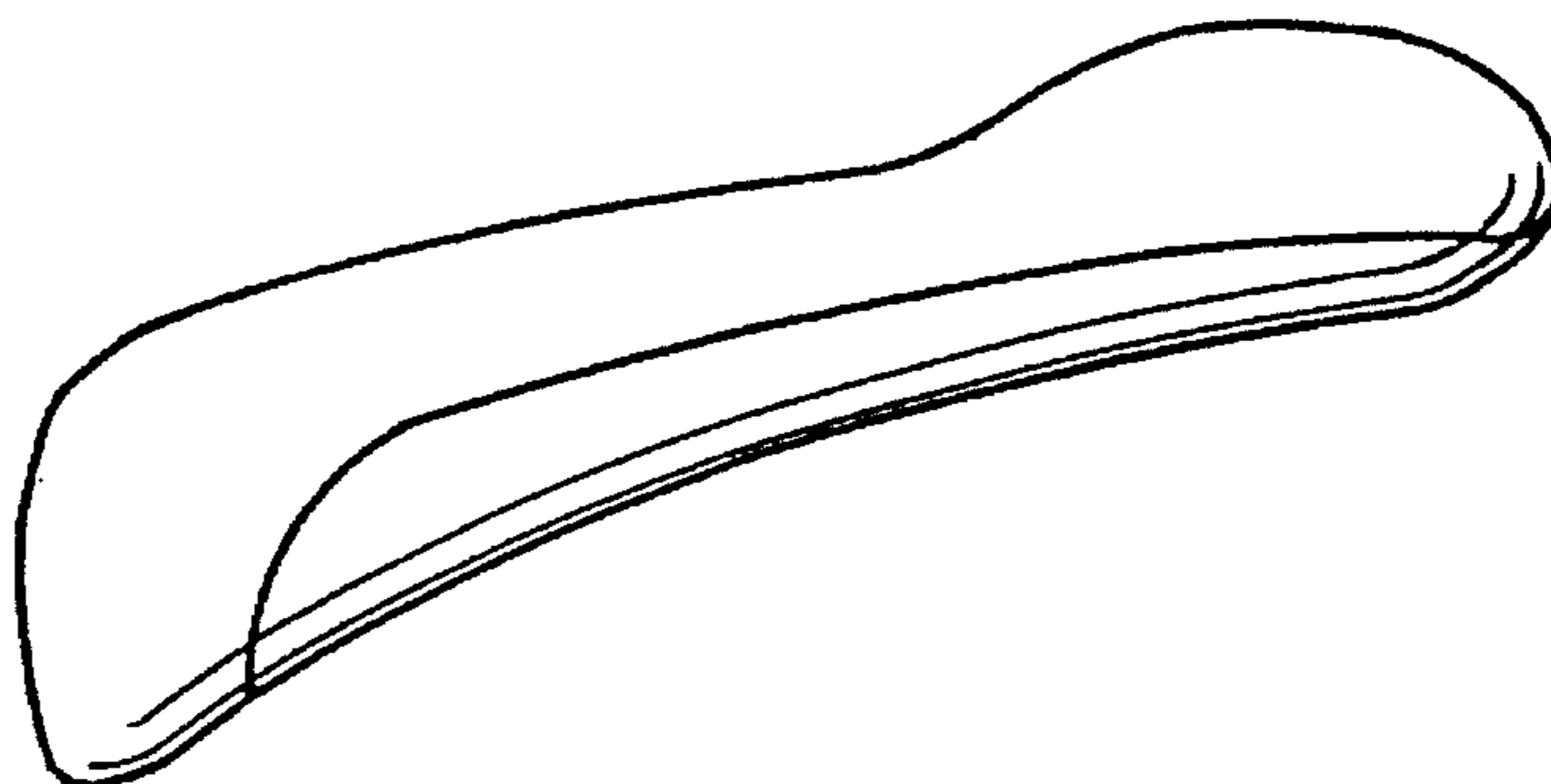

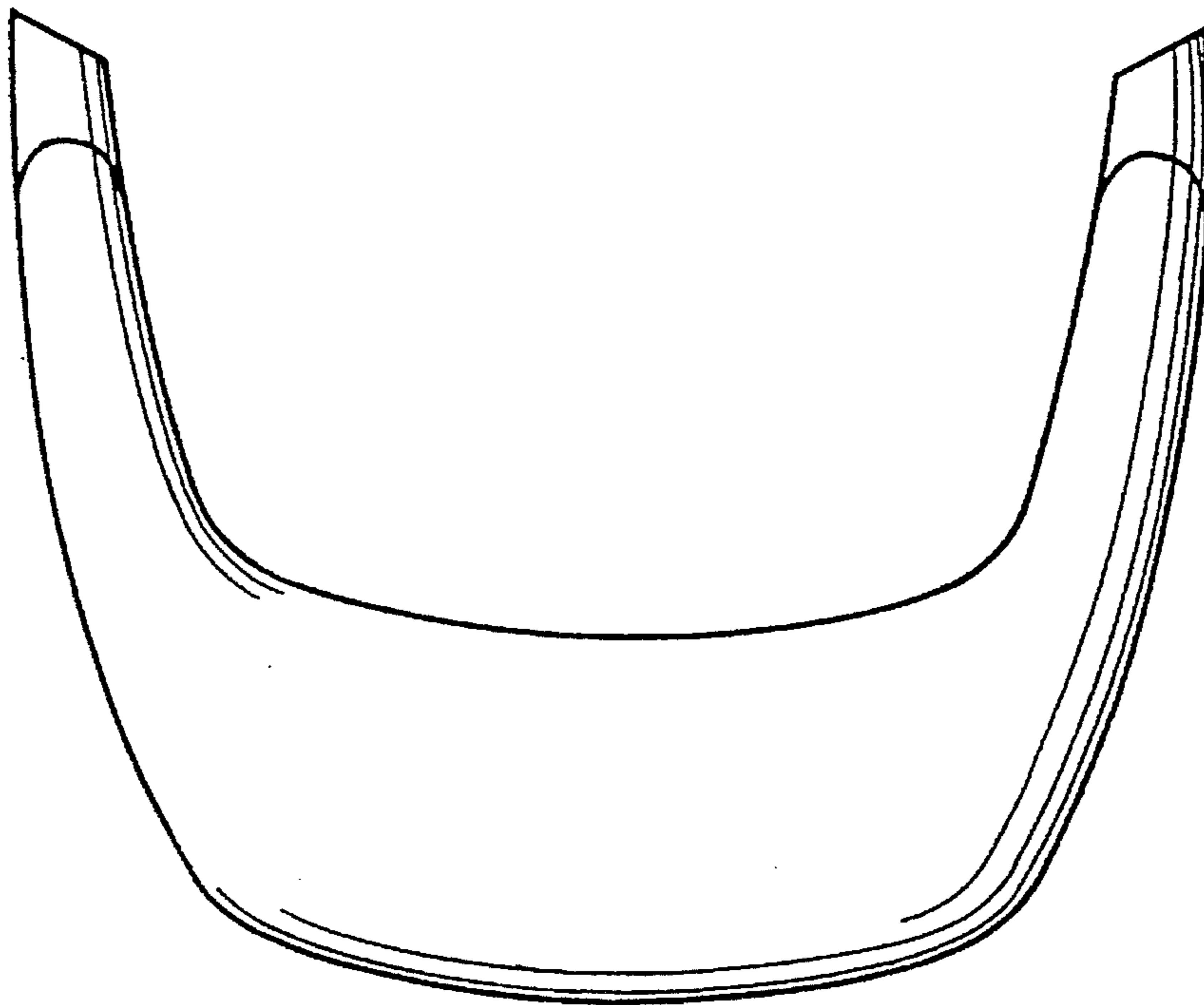

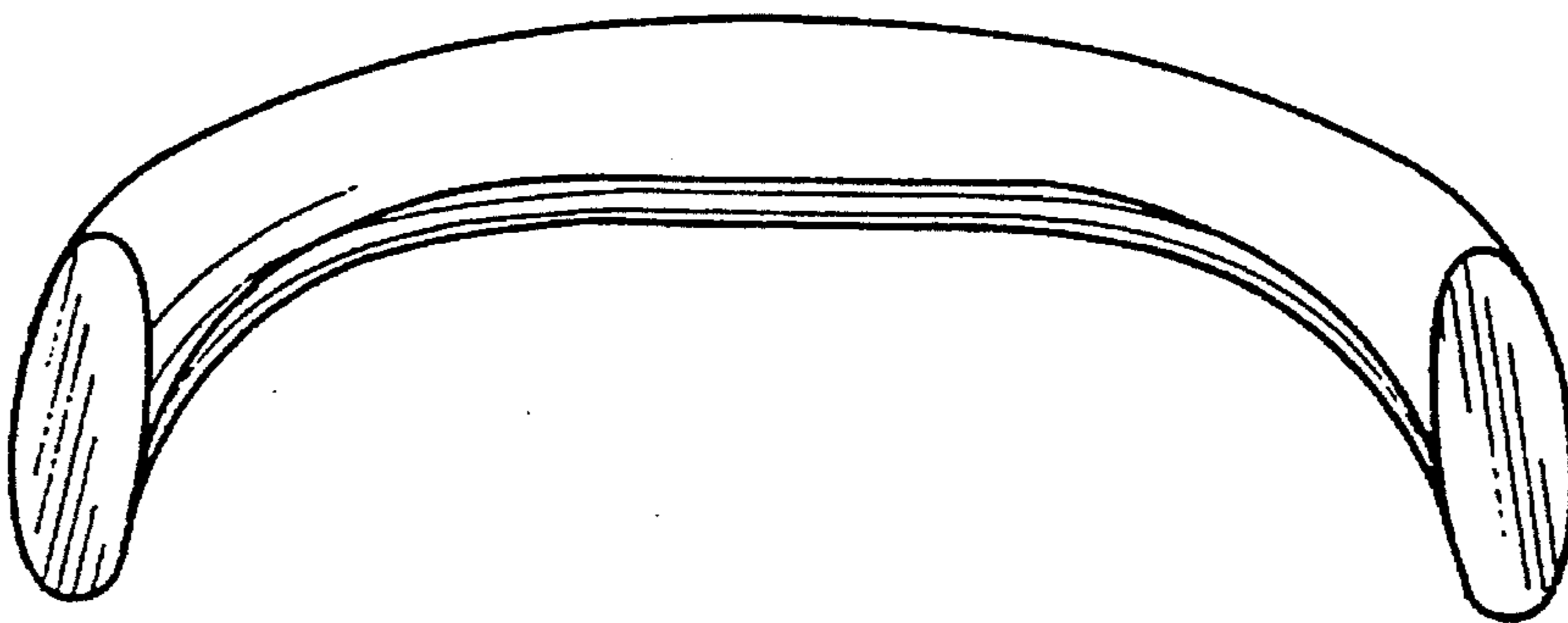

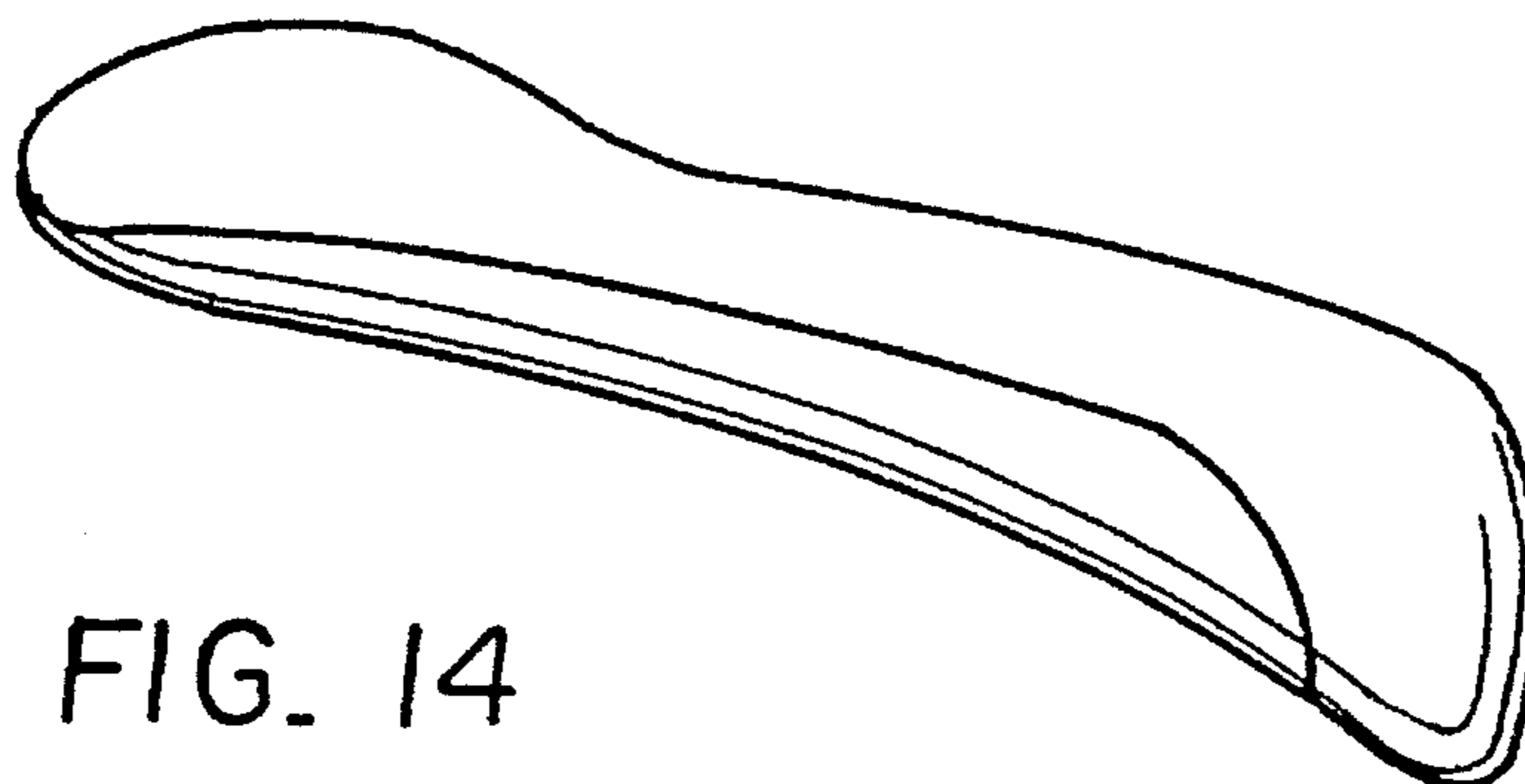

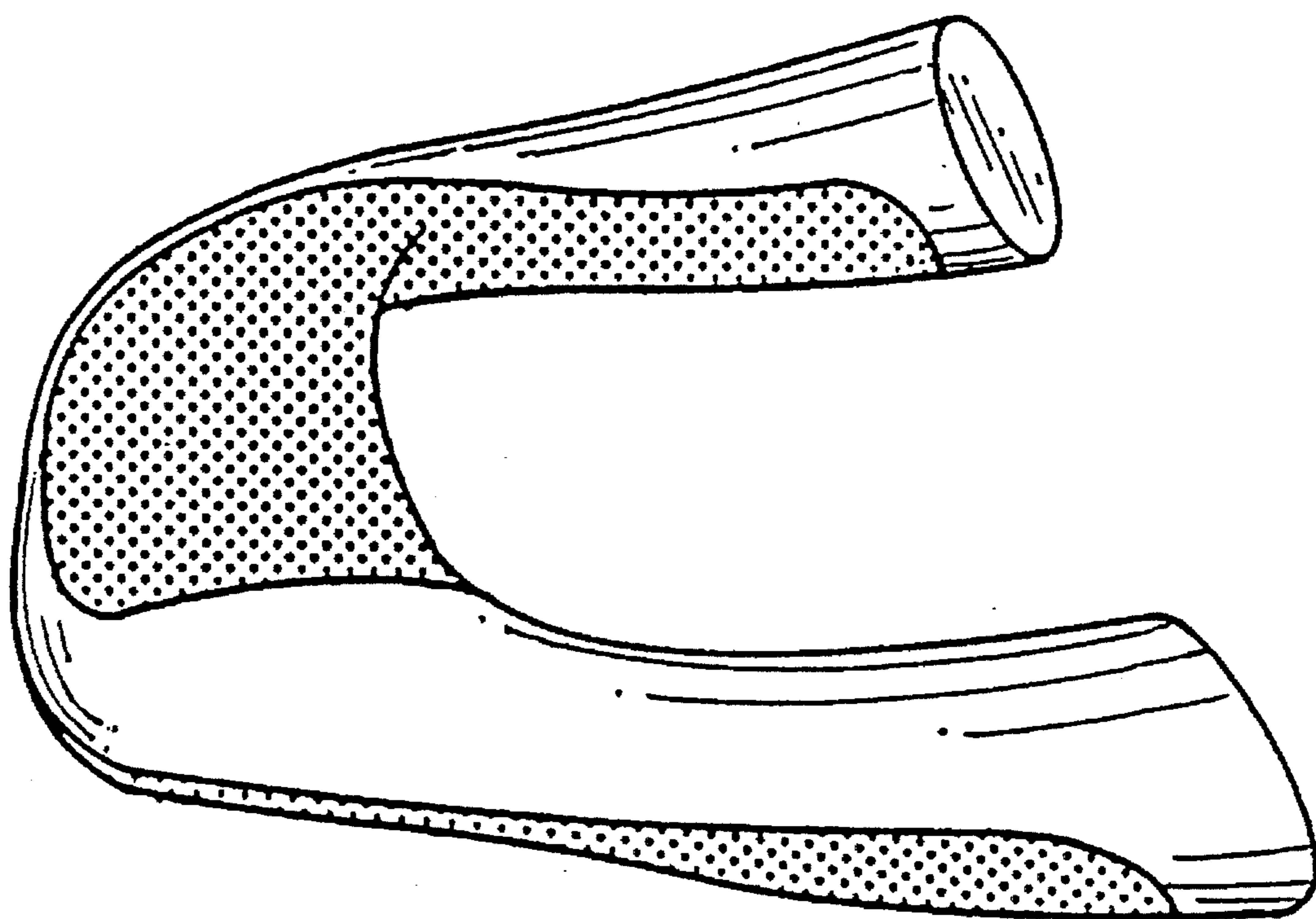

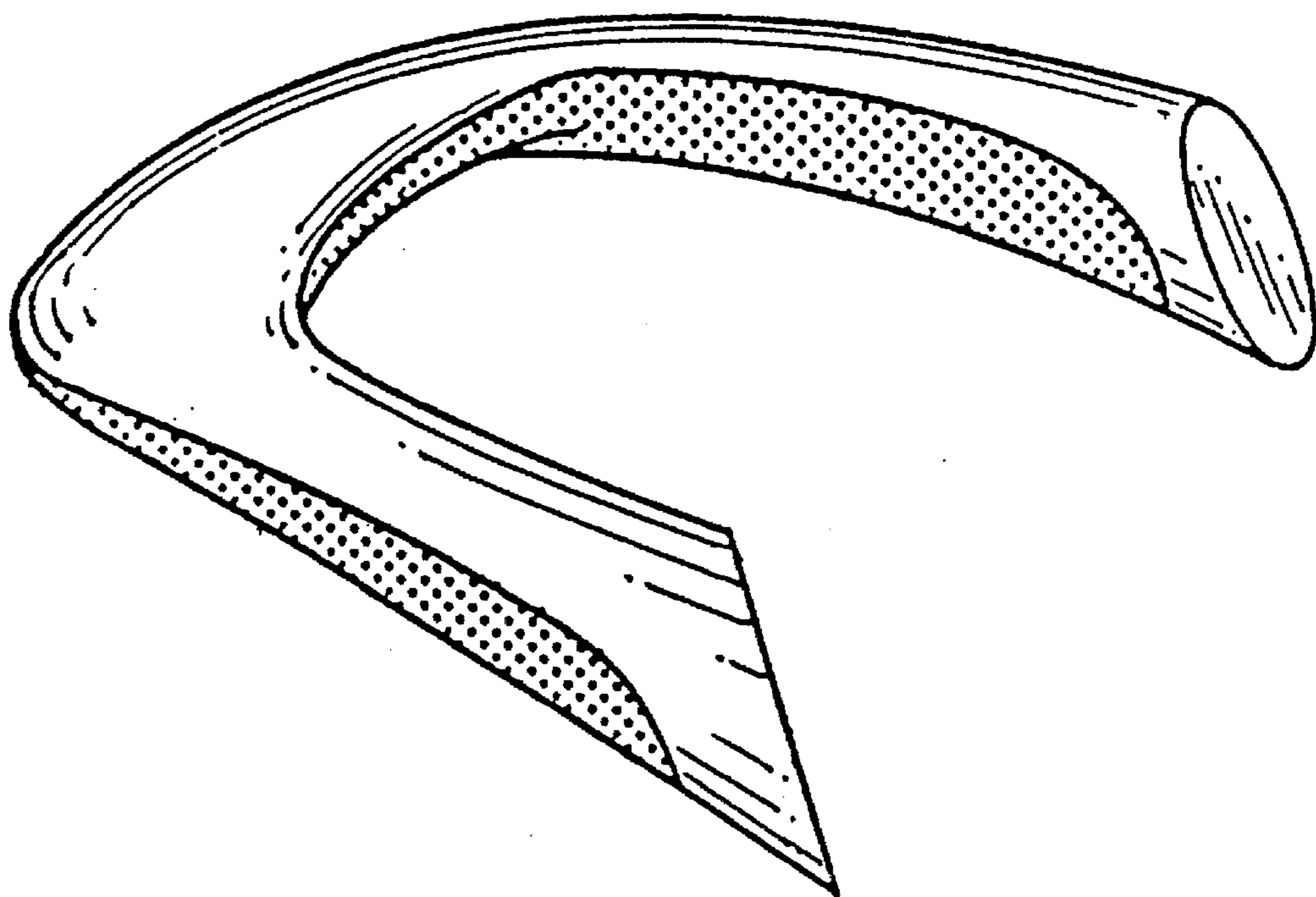
