[57] **CLAIM**

The ornamental design for a knife, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a knife in the opened position showing my new design;

FIG. 2 is a front elevational view thereof, in a closed position;

FIG. 3 is a rear elevational view thereof, in a closed position;

FIG. 4 is a top plan view thereof, in a closed position;

FIG. 5 is a bottom plan view thereof, in a closed position;

FIG. 6 is a front elevational view thereof, in an opened position;

FIG. 7 is a rear elevational view thereof, in the opened position;

FIG. 8 is a top plan view thereof, in the opened position;

FIG. 9 is a bottom plan view thereof, in the opened position;

FIG. 10 is a front perspective view of a modified embodiment of the knife, shown in an open position;

FIG. 11 is a rear perspective view thereof, in the opened position;

FIG. 12 is a front elevational view thereof, in an opened position;

FIG. 13 is a rear elevational view thereof, in the opened position;

FIG. 14 is a top plan view thereof, in the opened position; and,

FIG. 15 is a bottom plan view thereof, in the opened position.

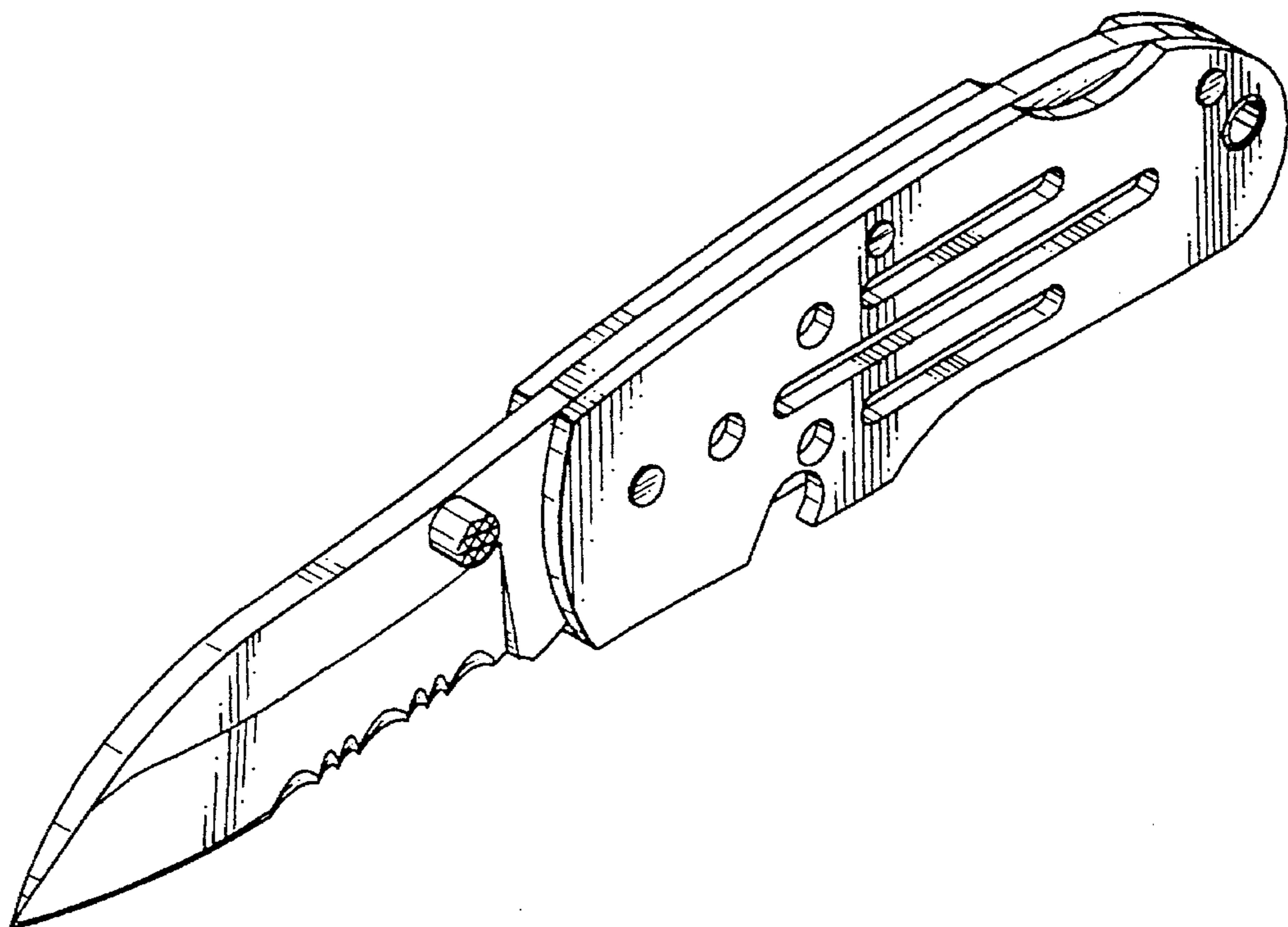

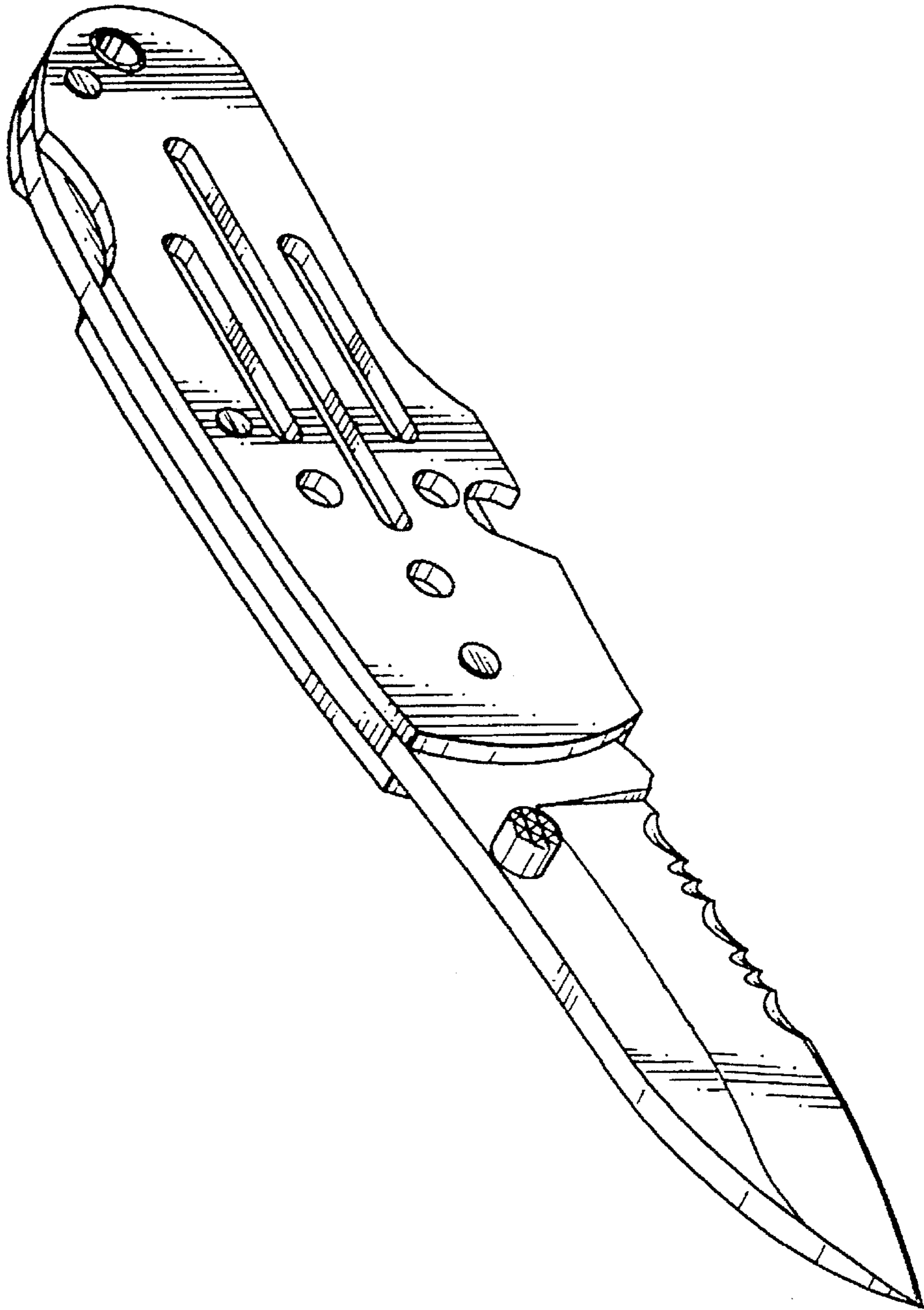

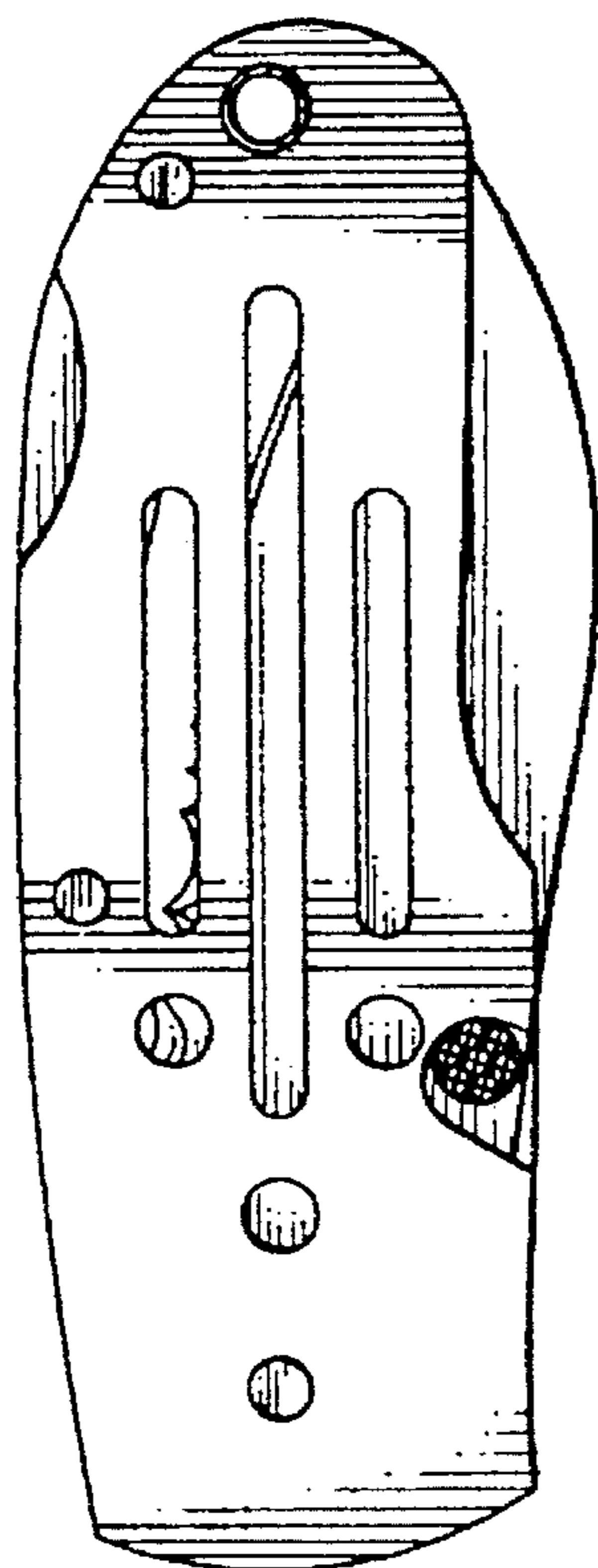

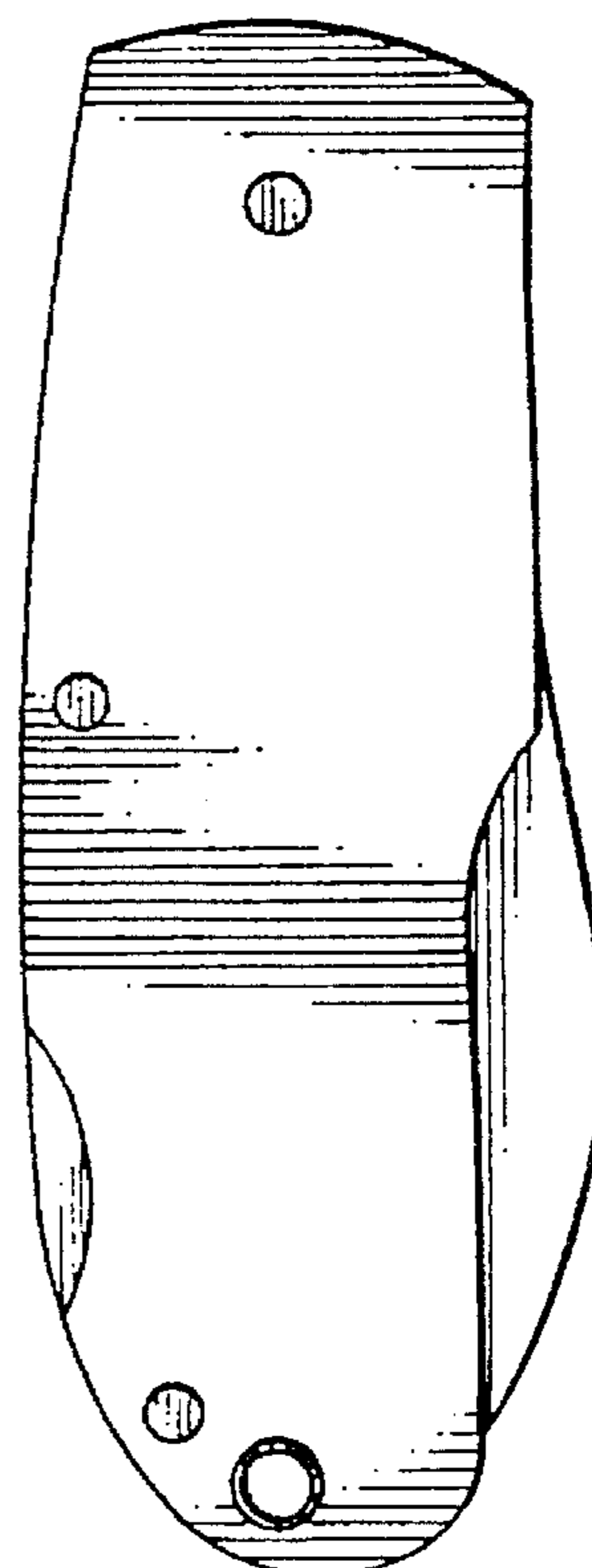

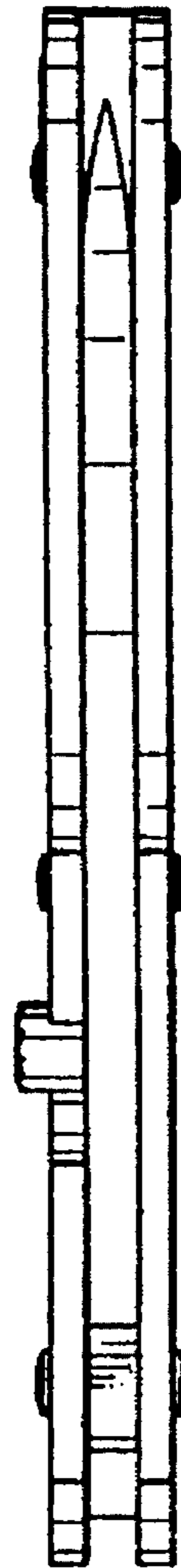

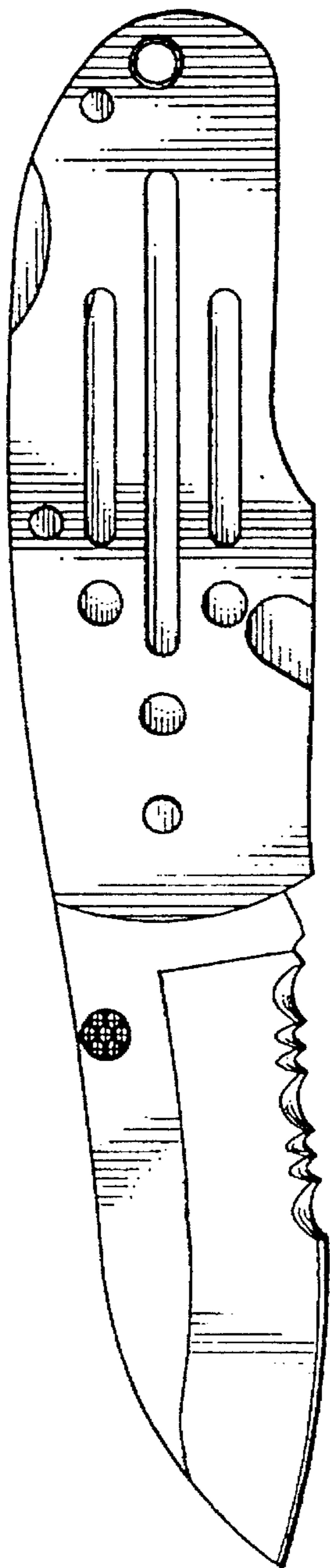

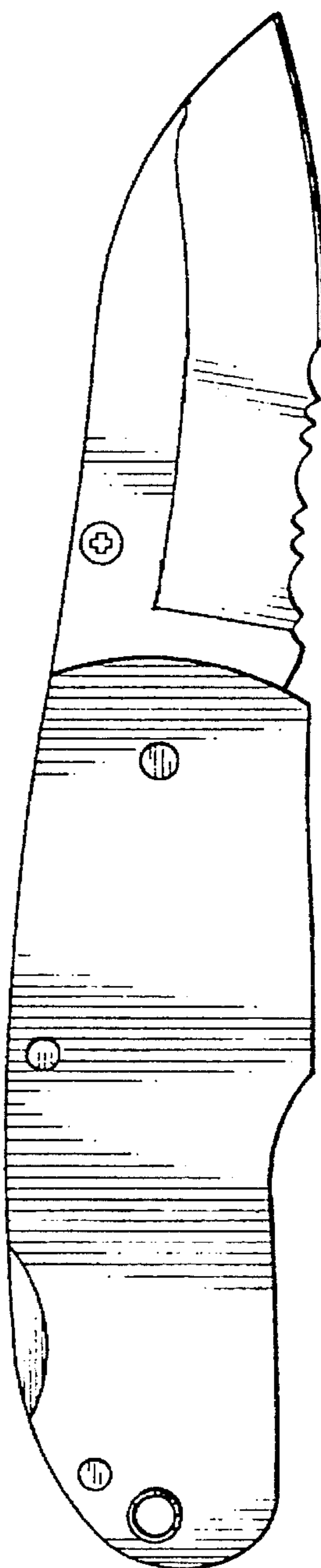

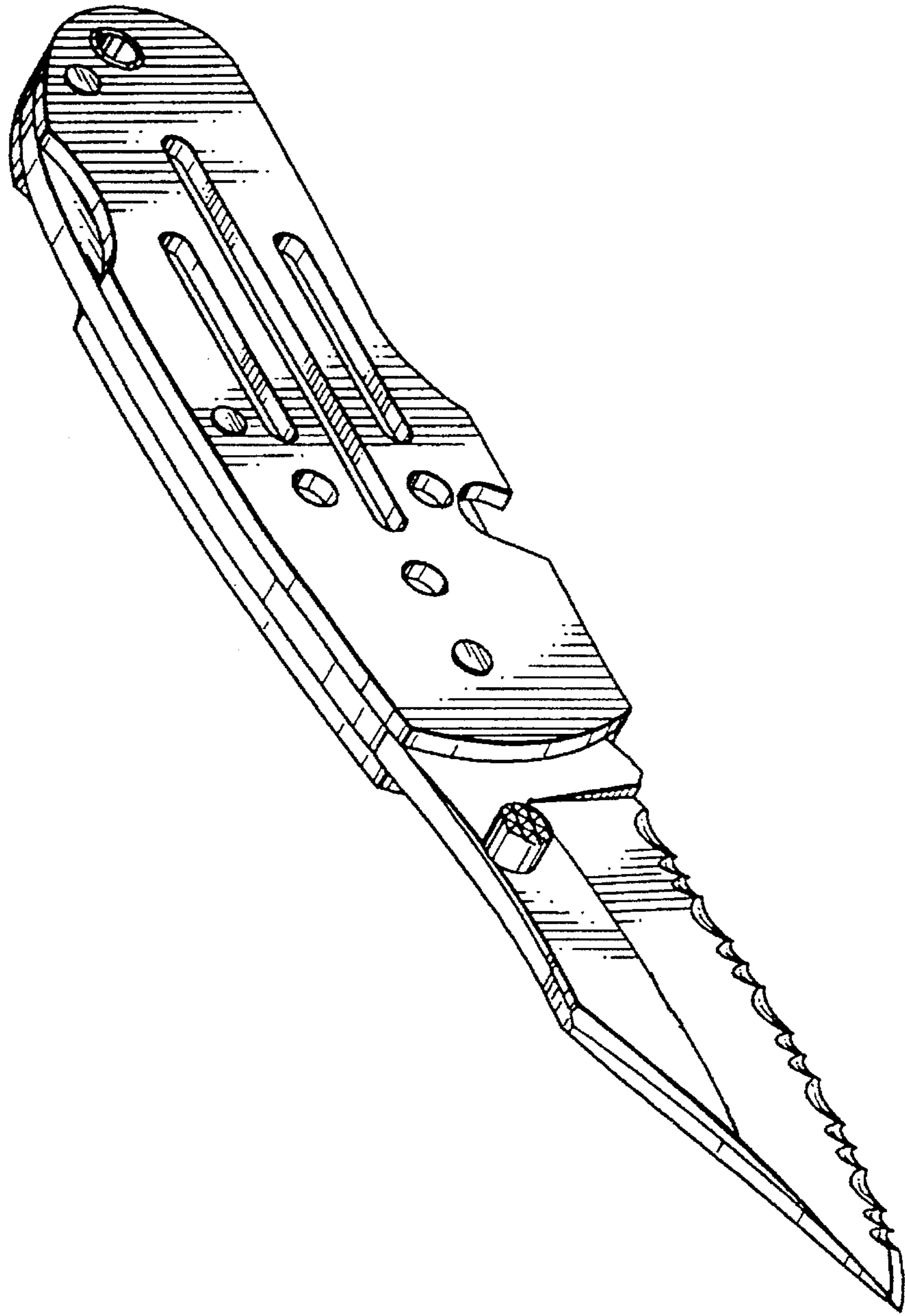

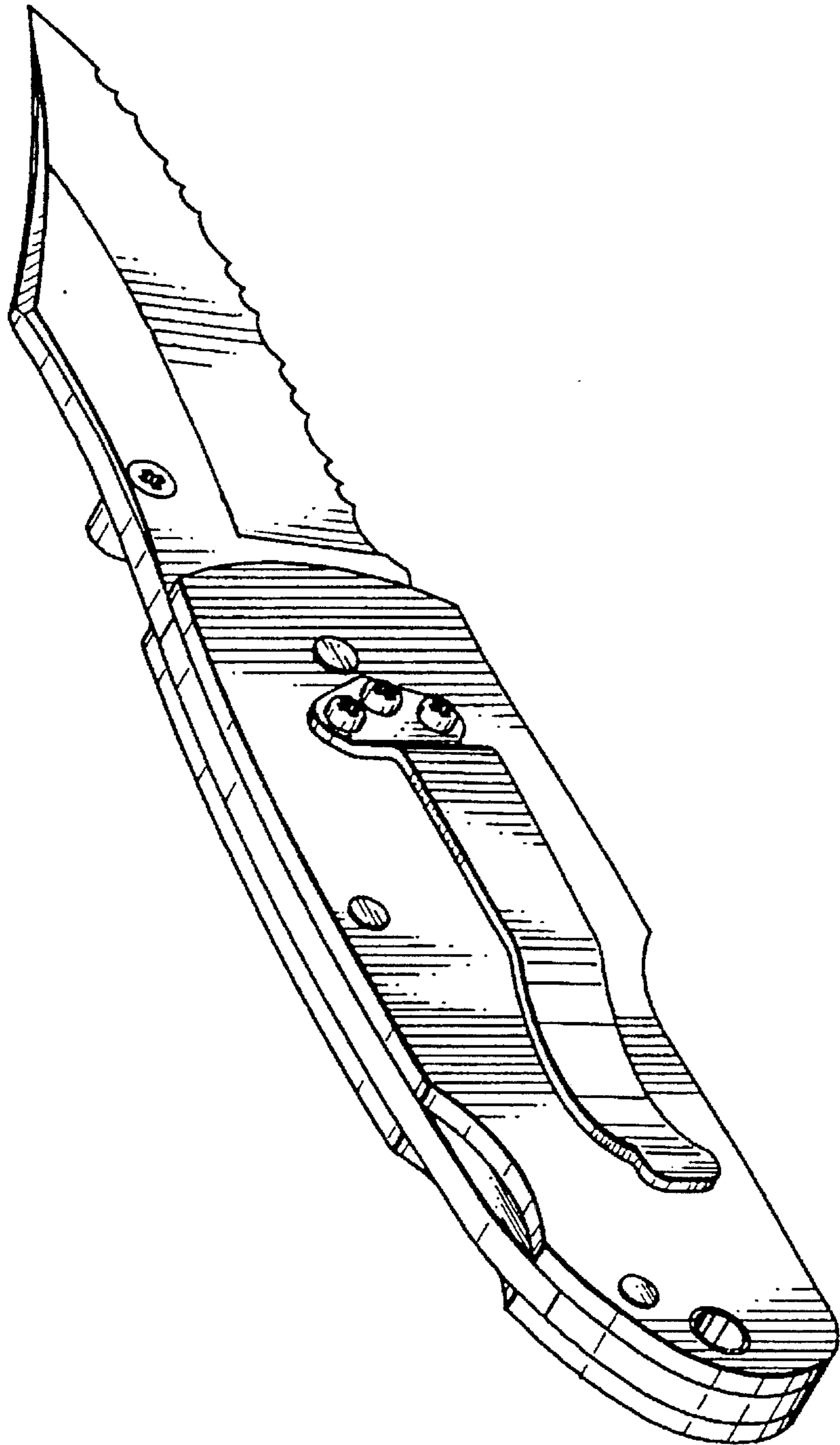

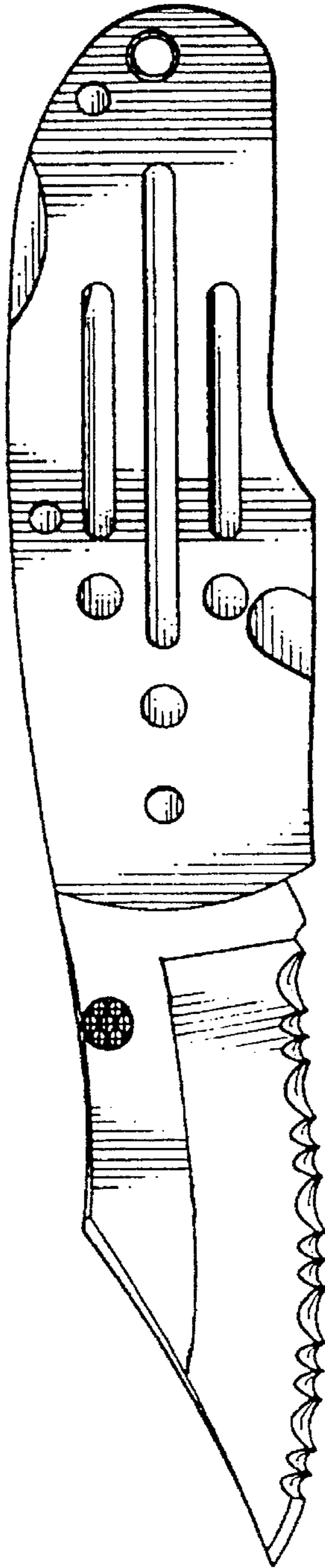

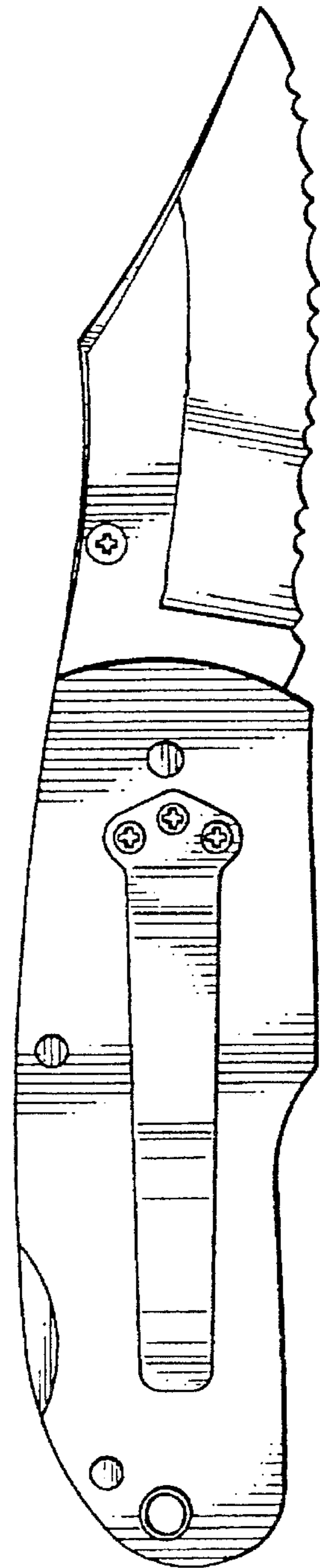

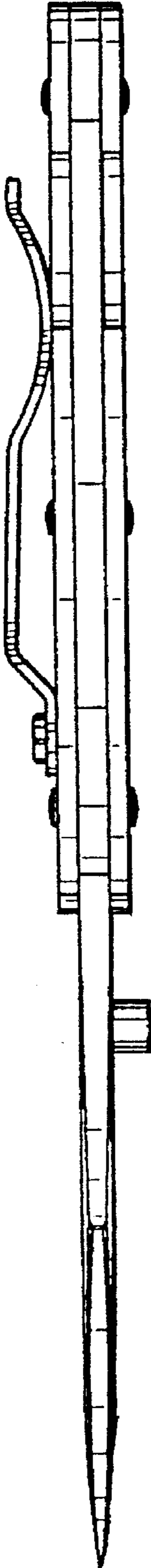
