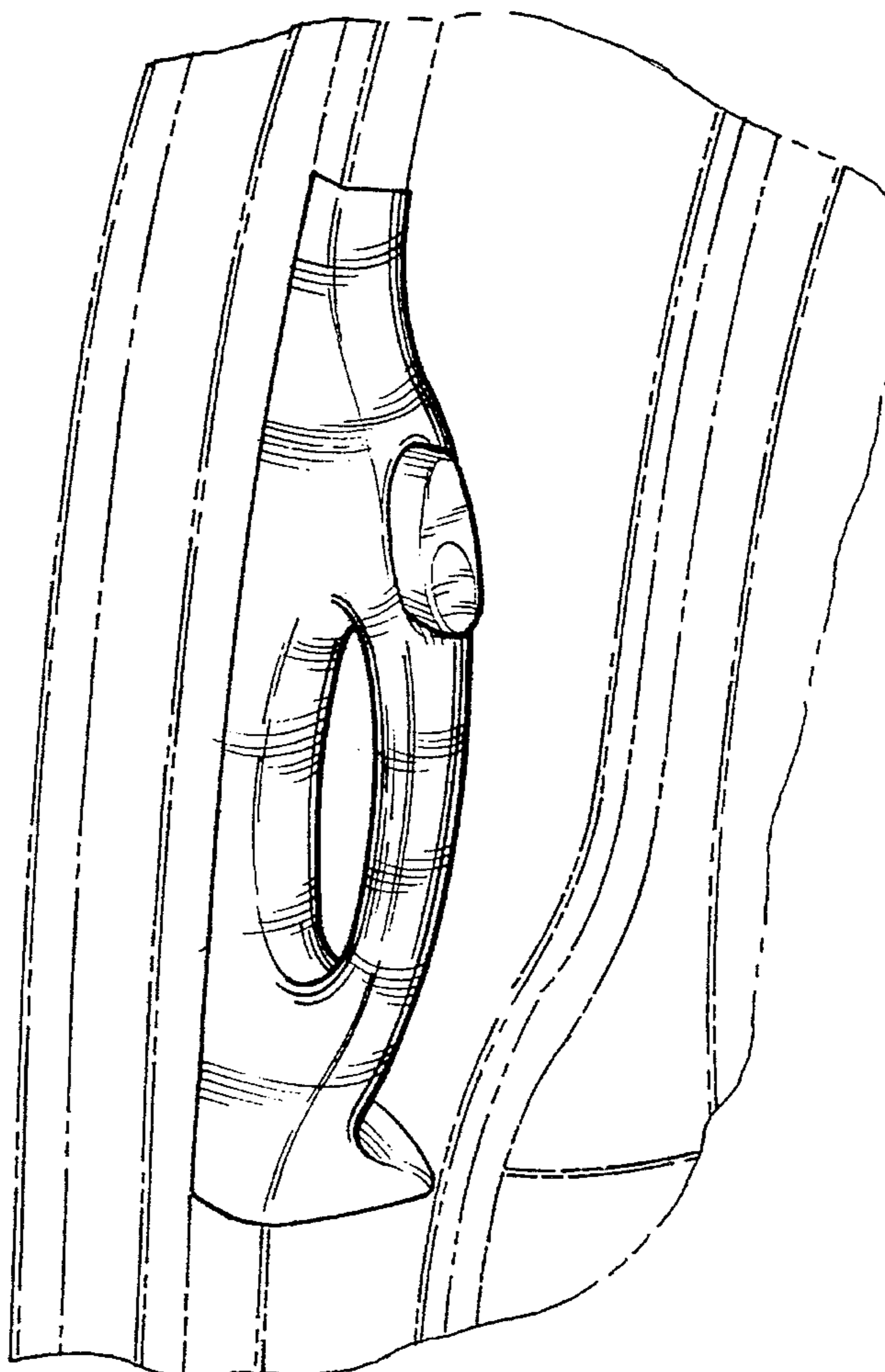
FIG. 2 is a front elevational view thereof;

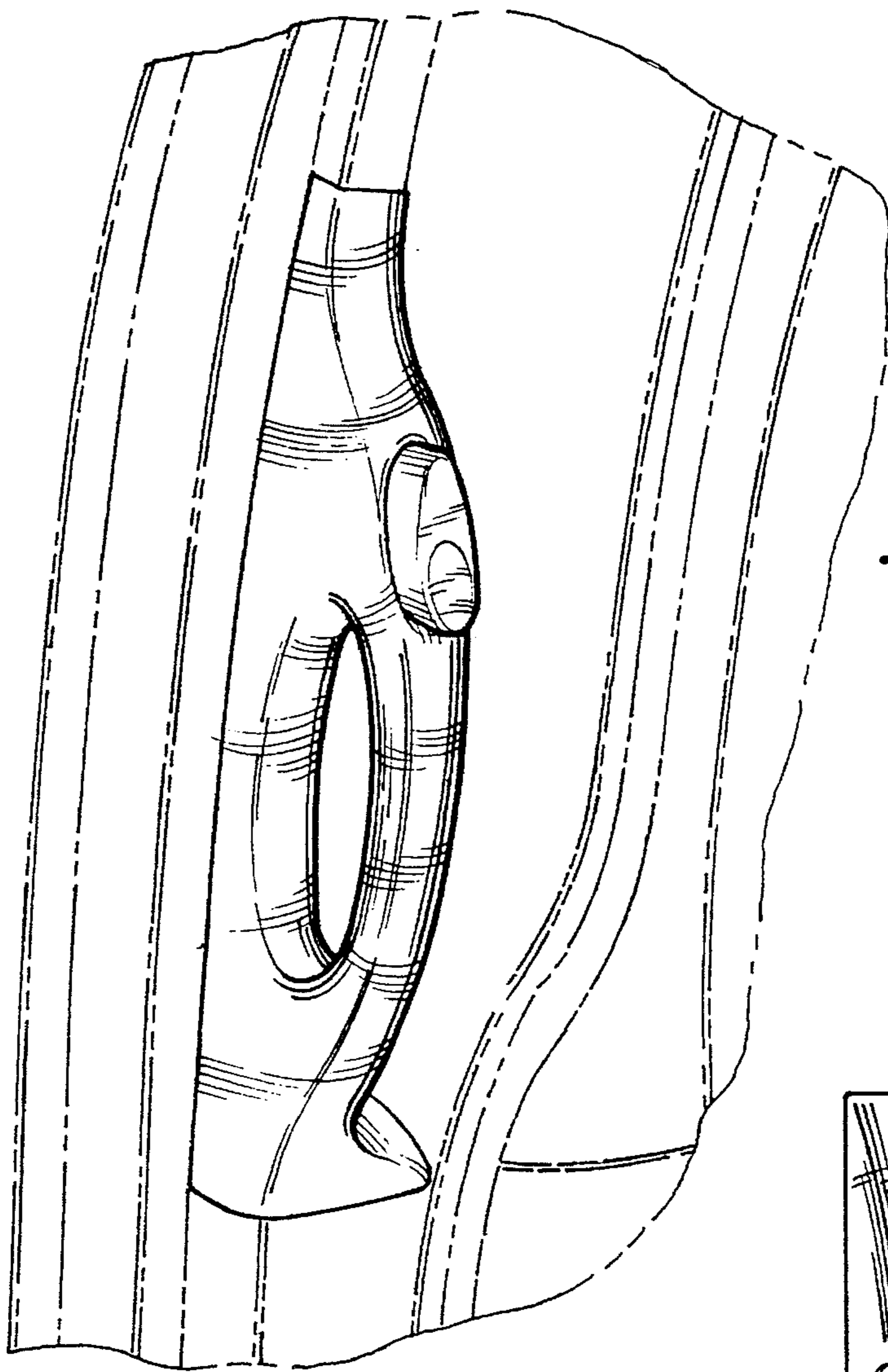
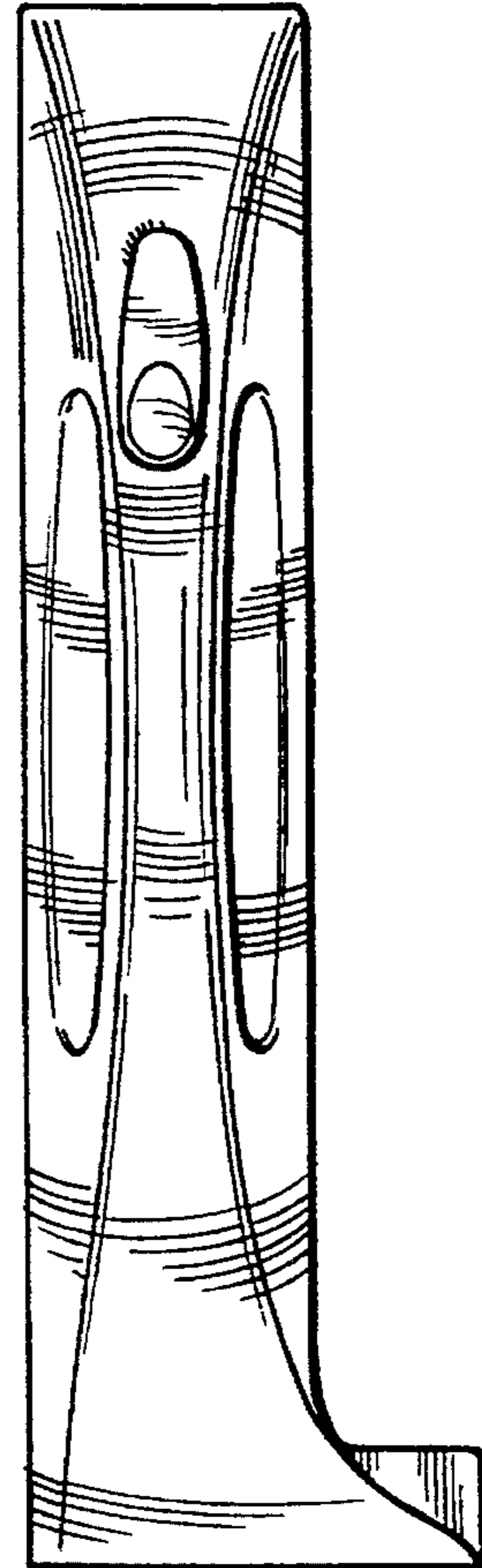

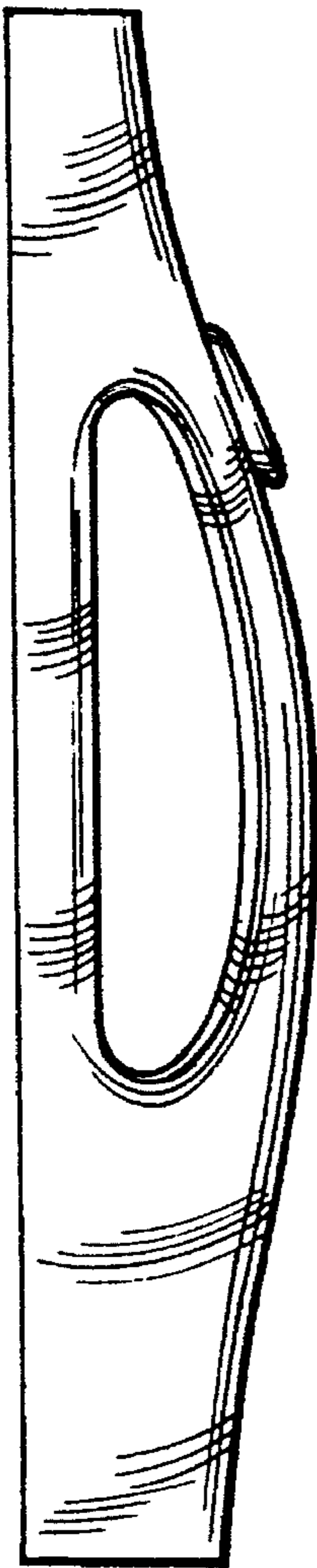

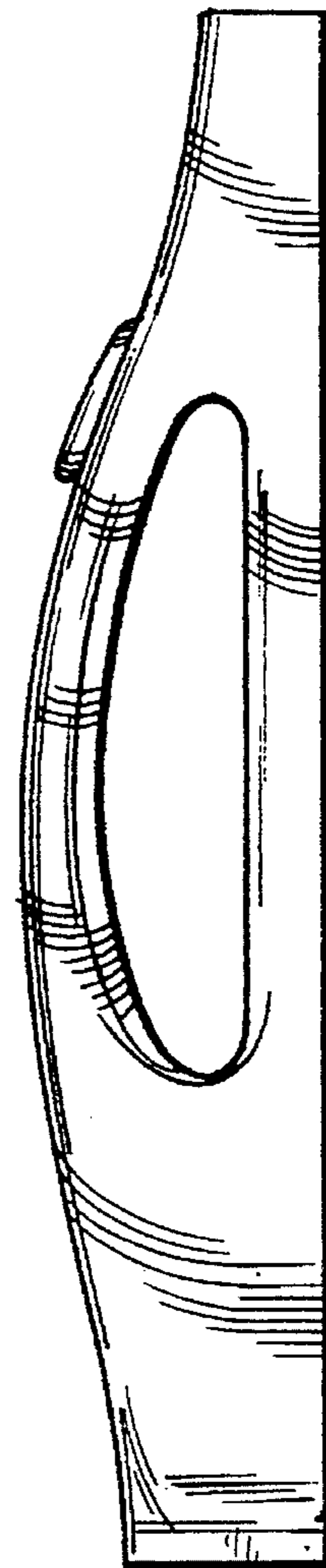
