The ornamental design for a housing for a portable radio/phone, as shown and described.

DESCRIPTION

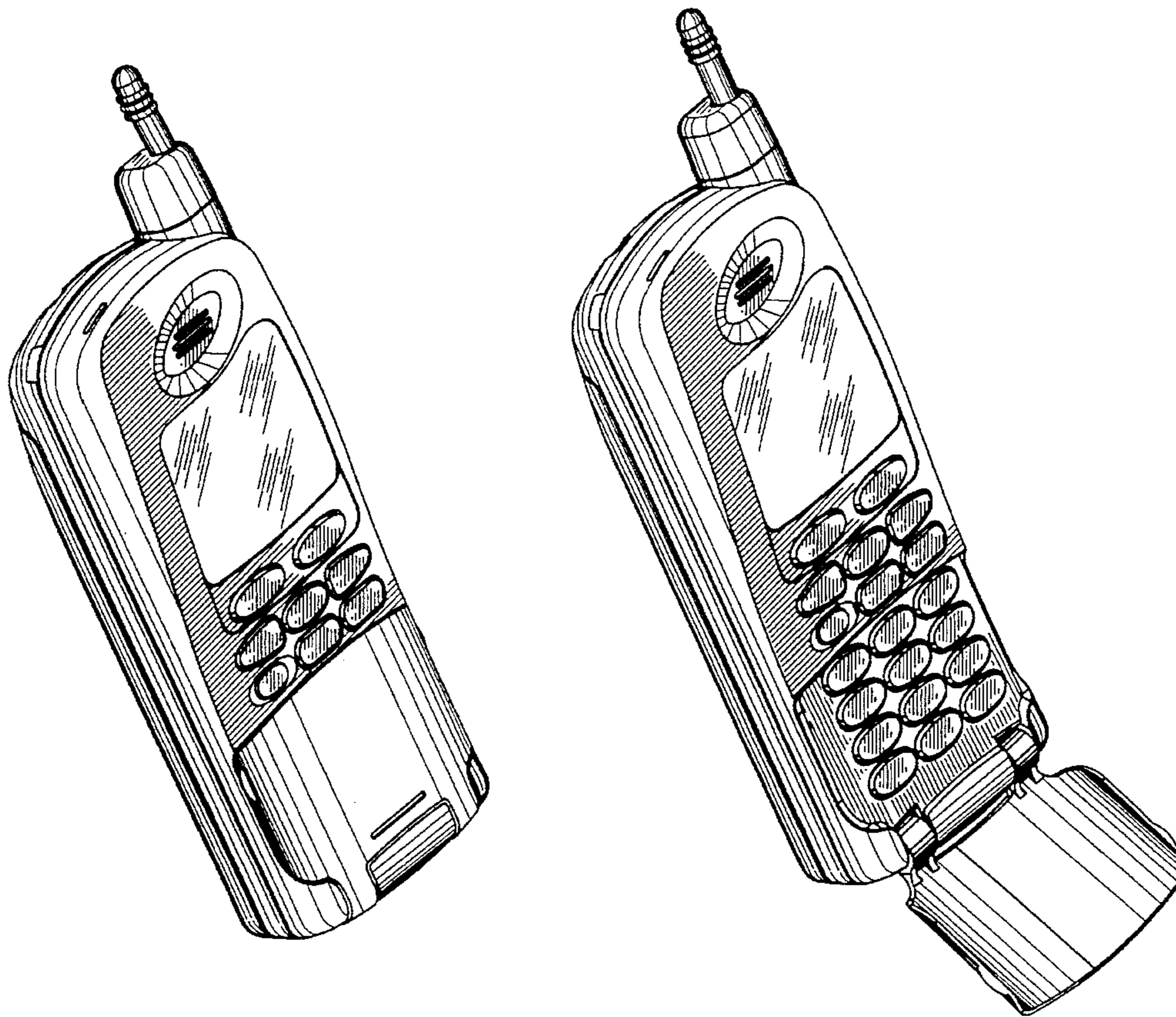

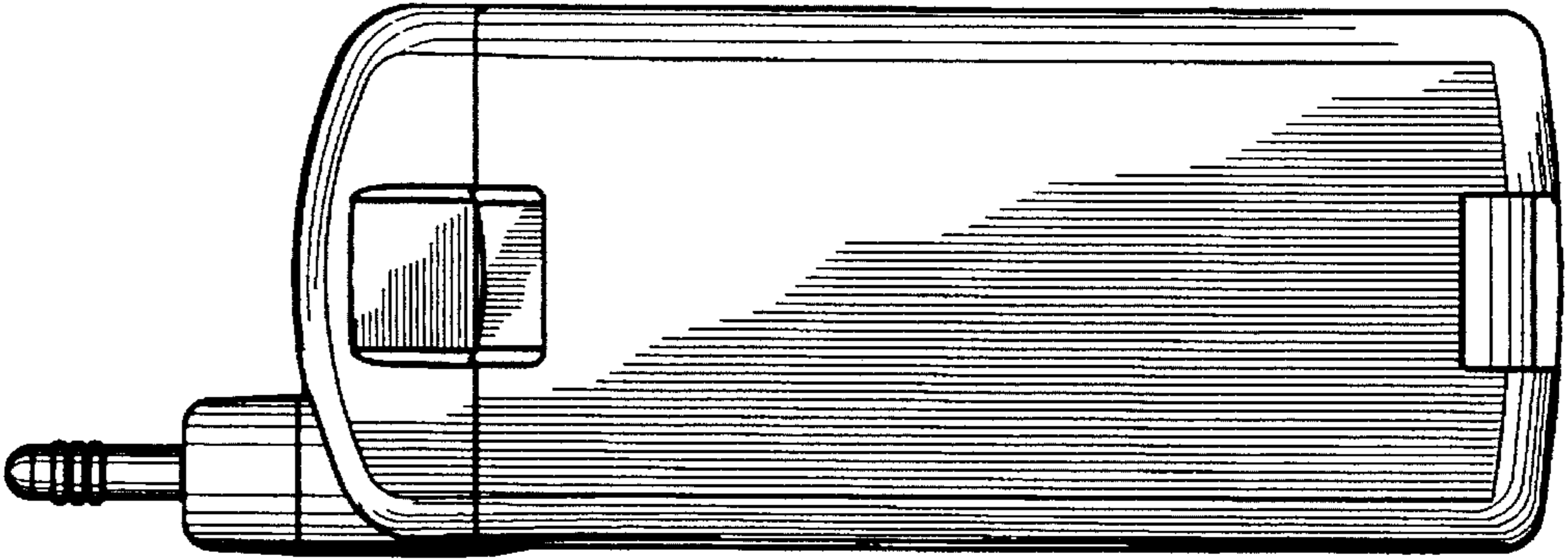

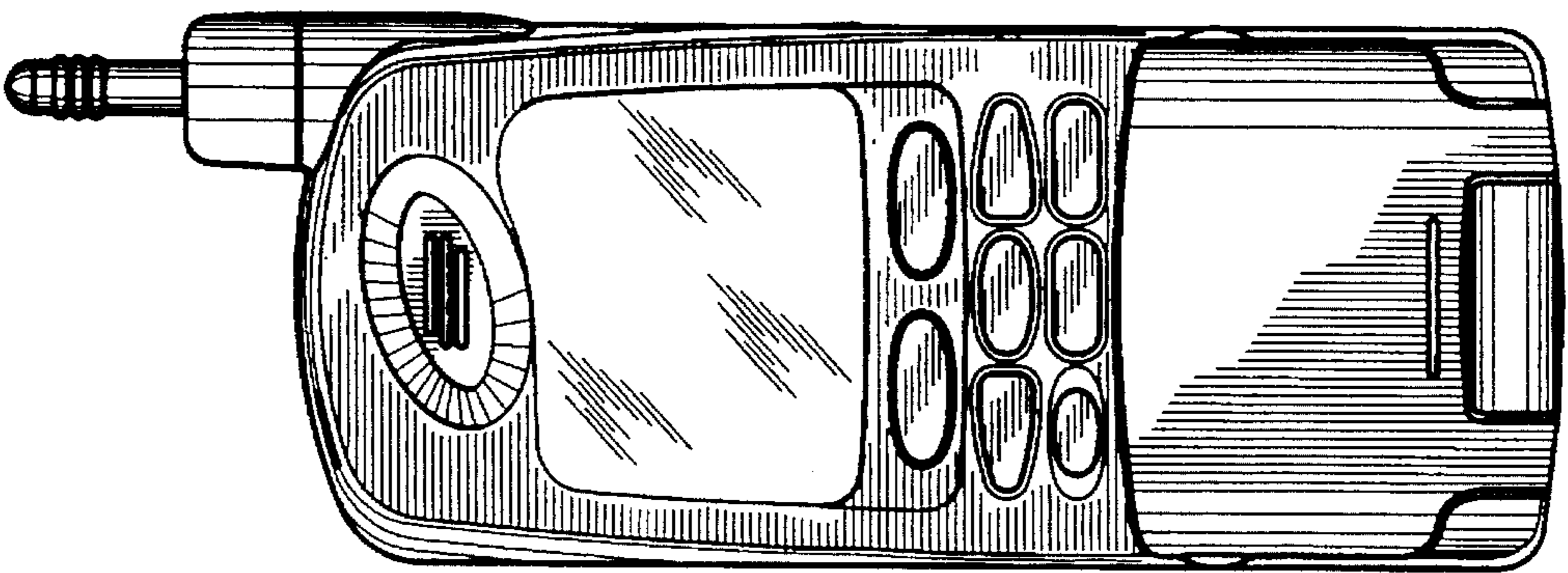

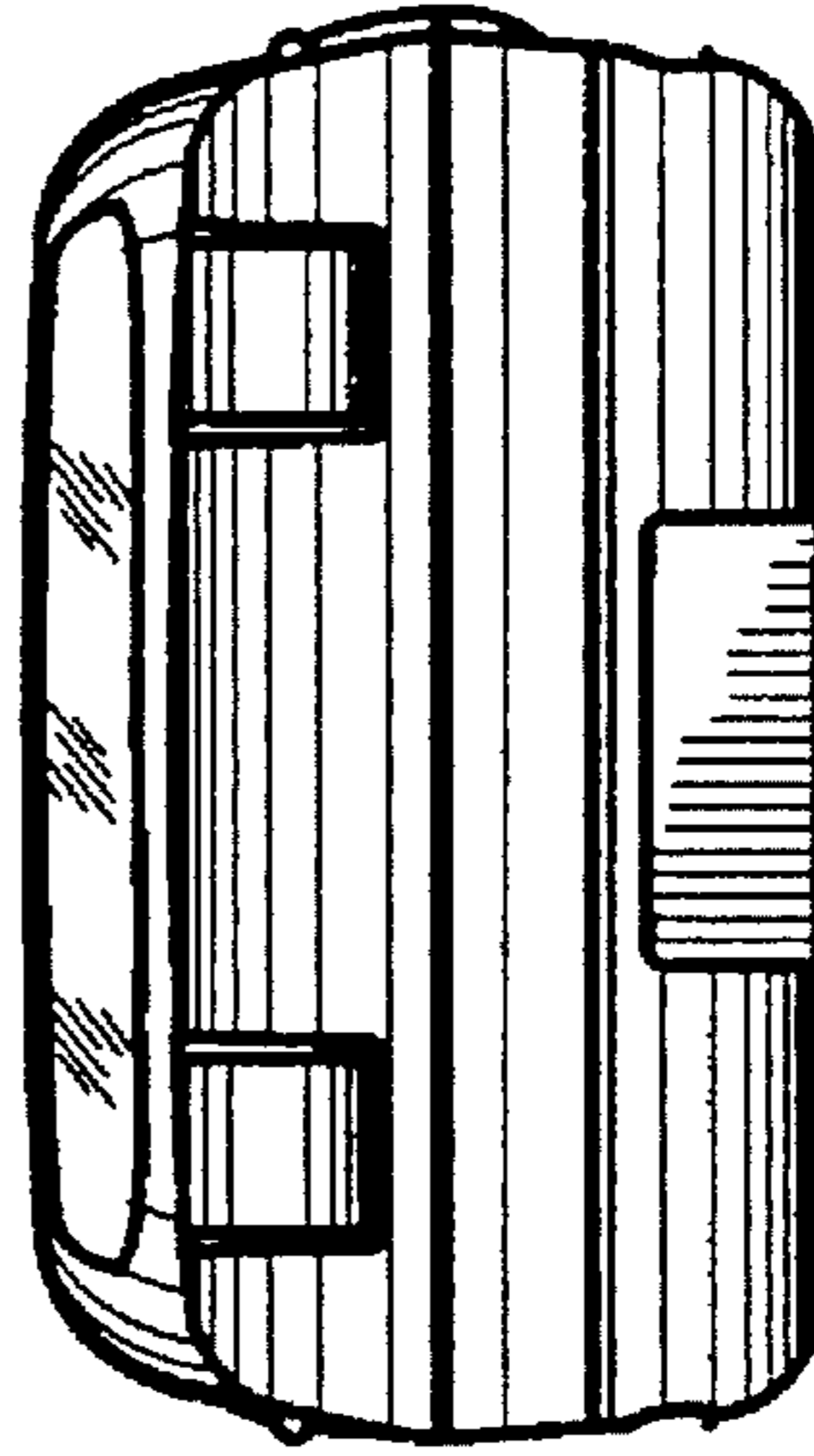

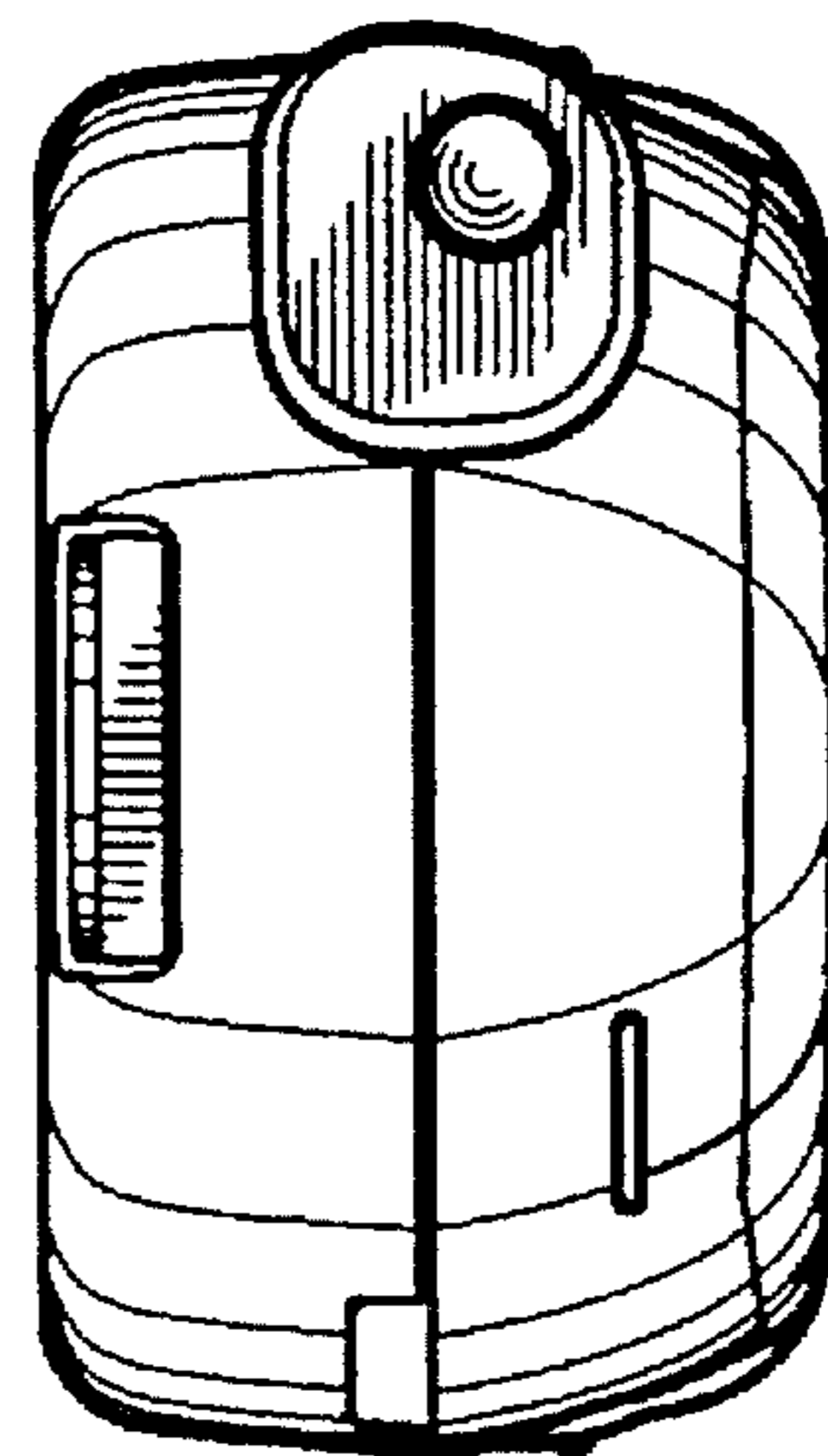

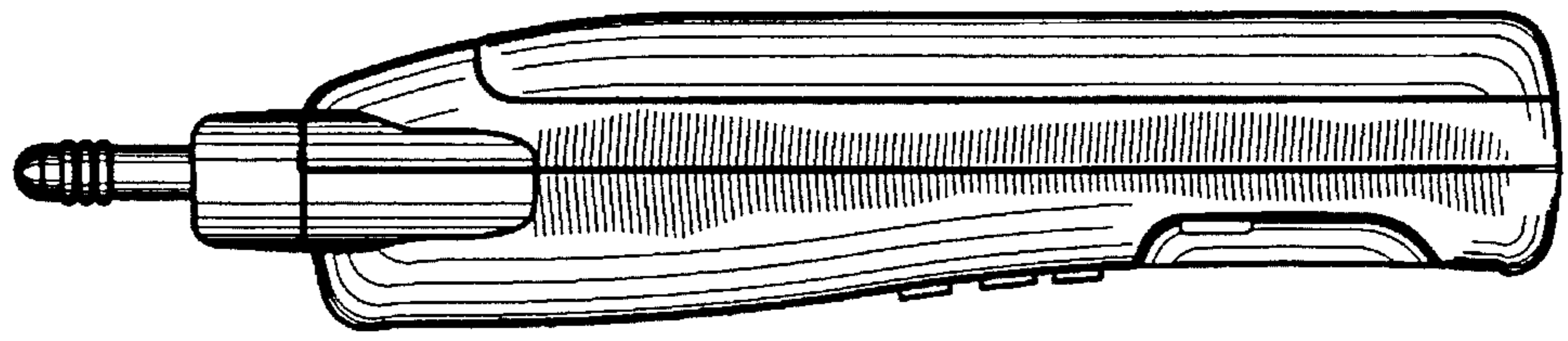

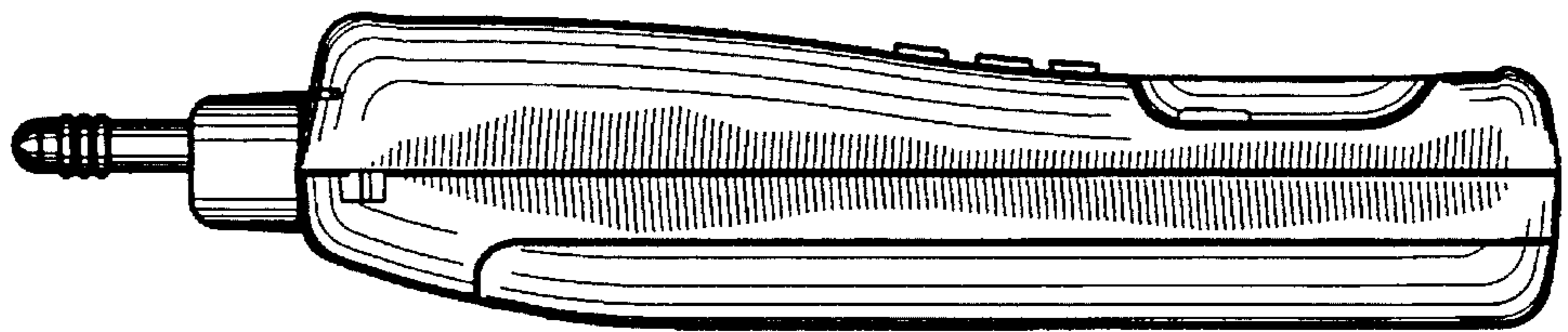

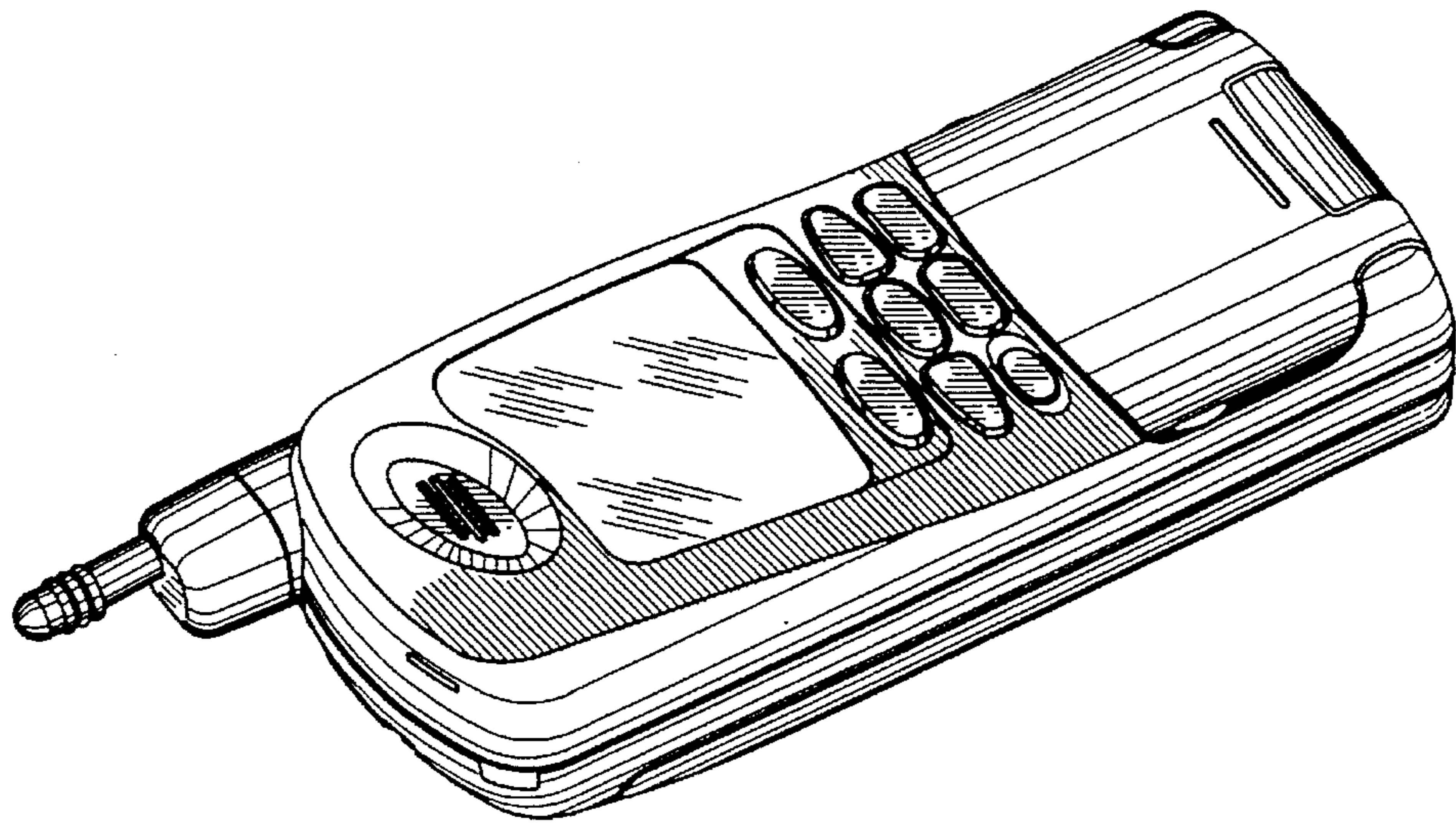

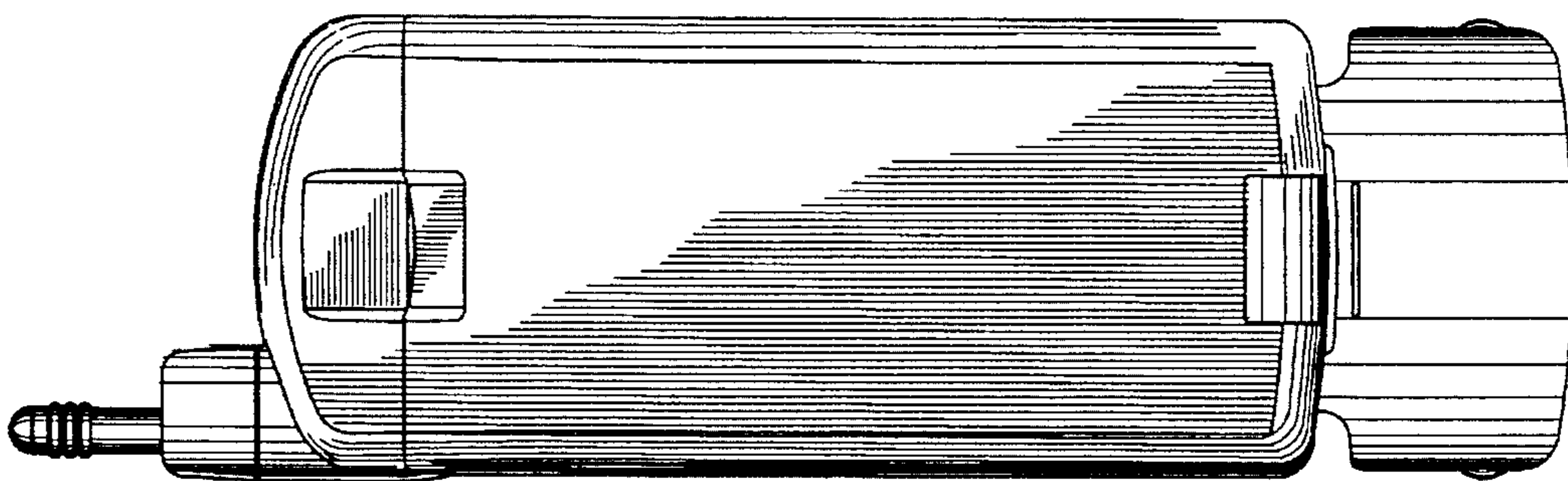

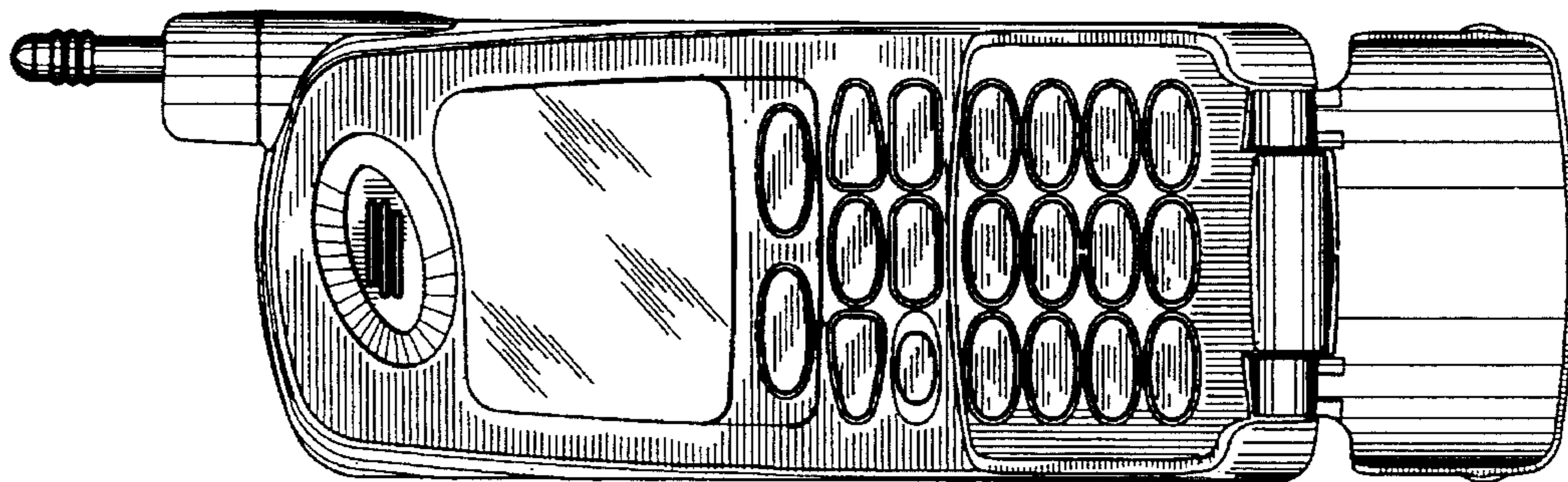

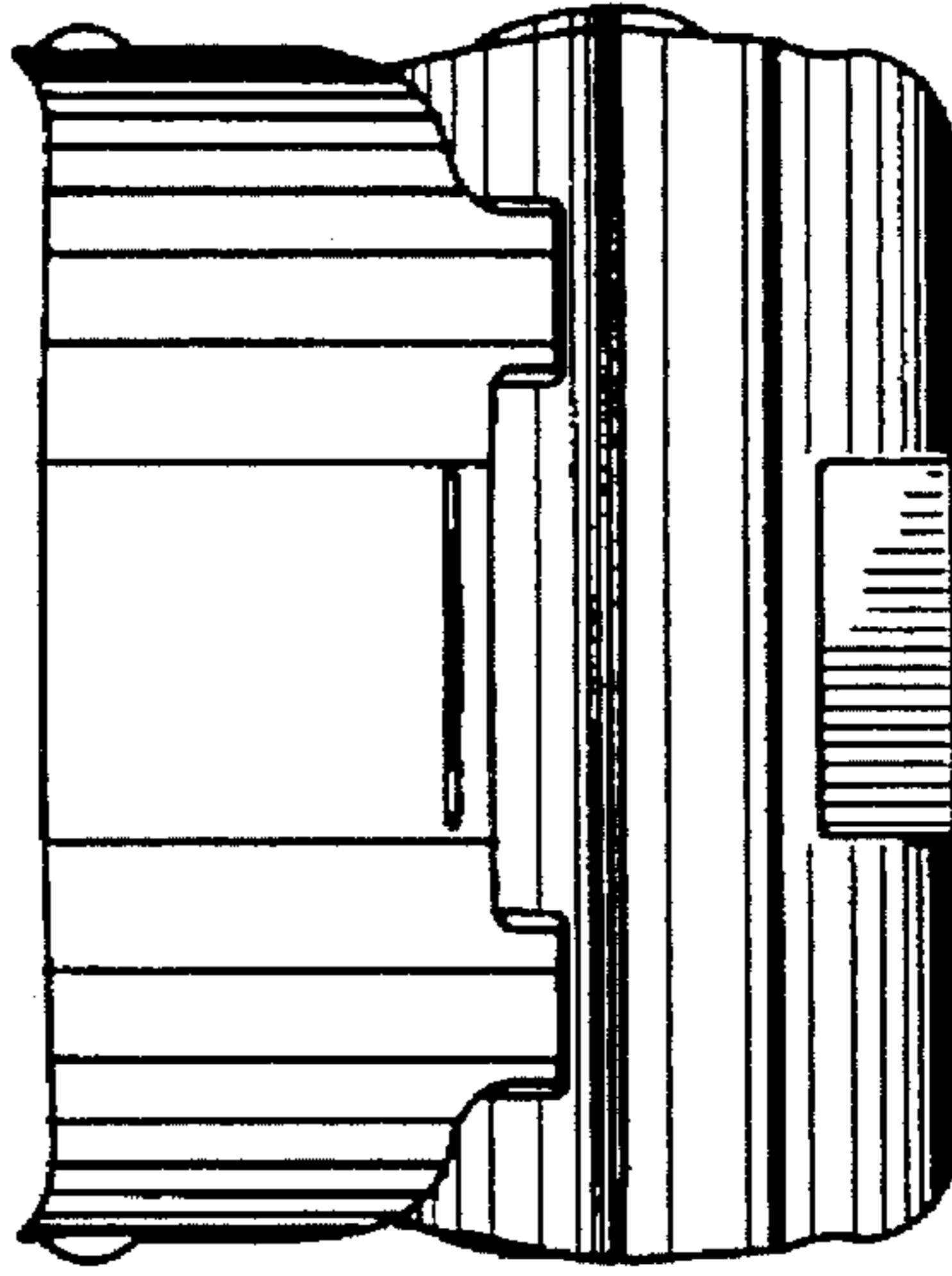

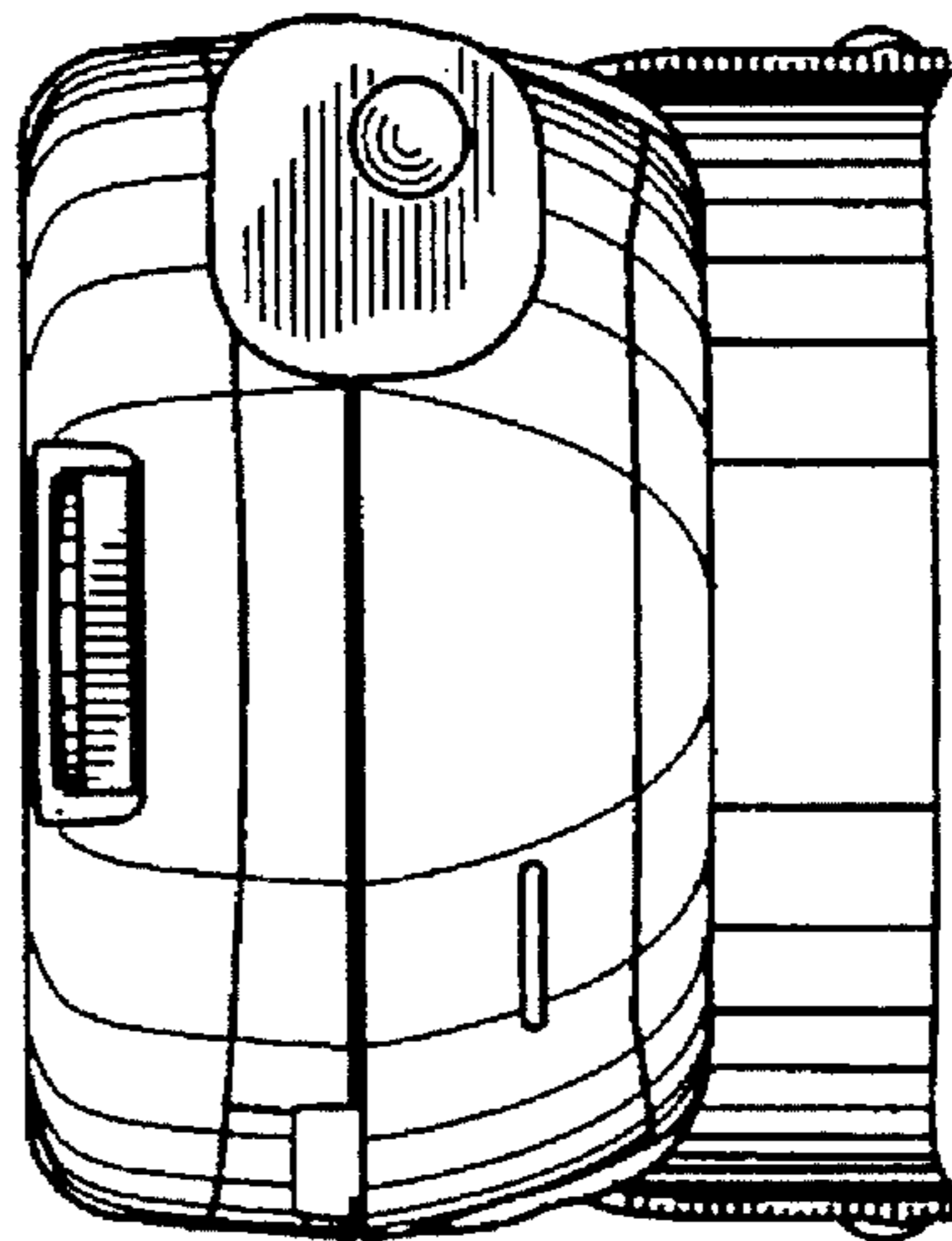

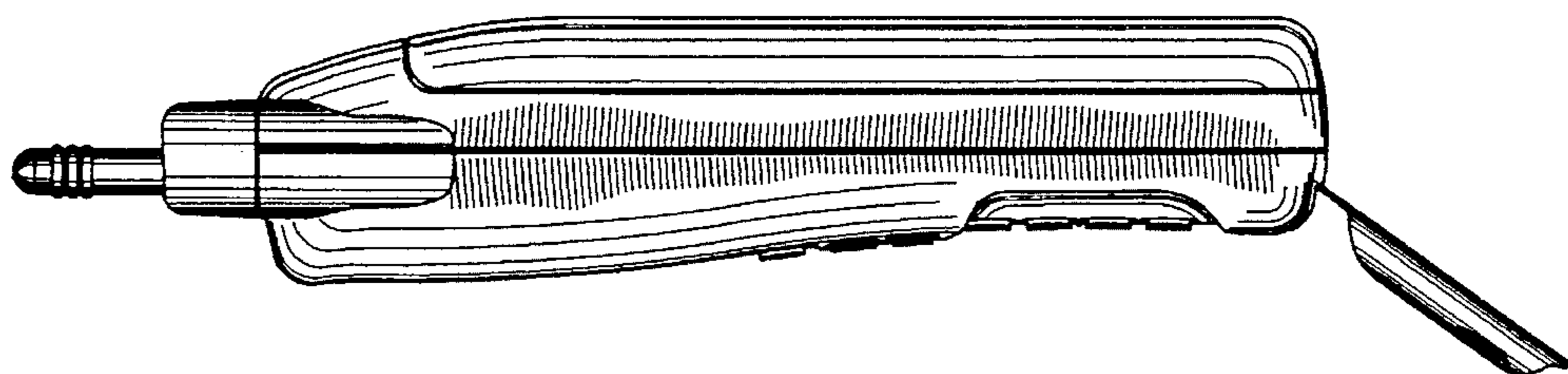

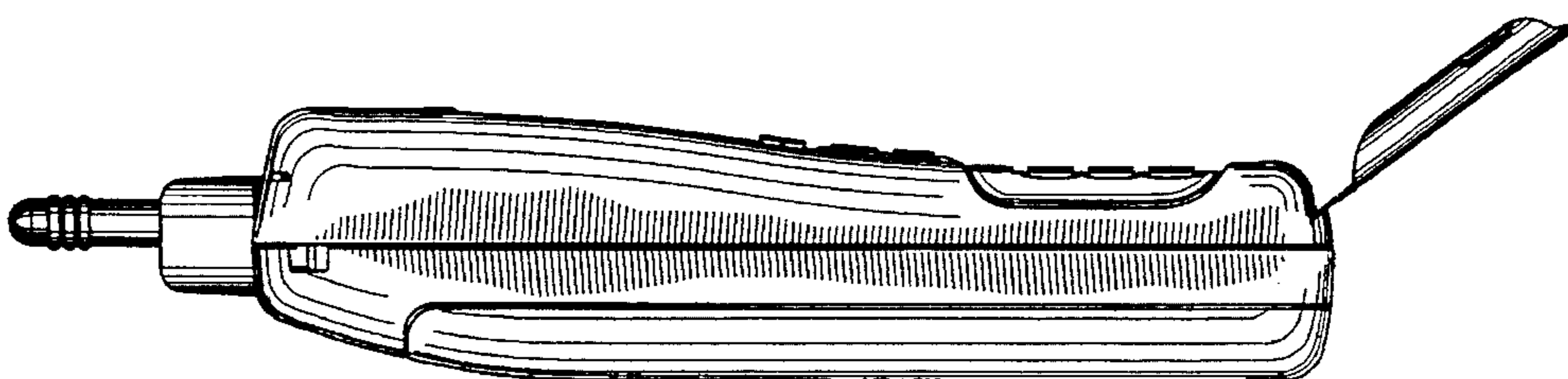
