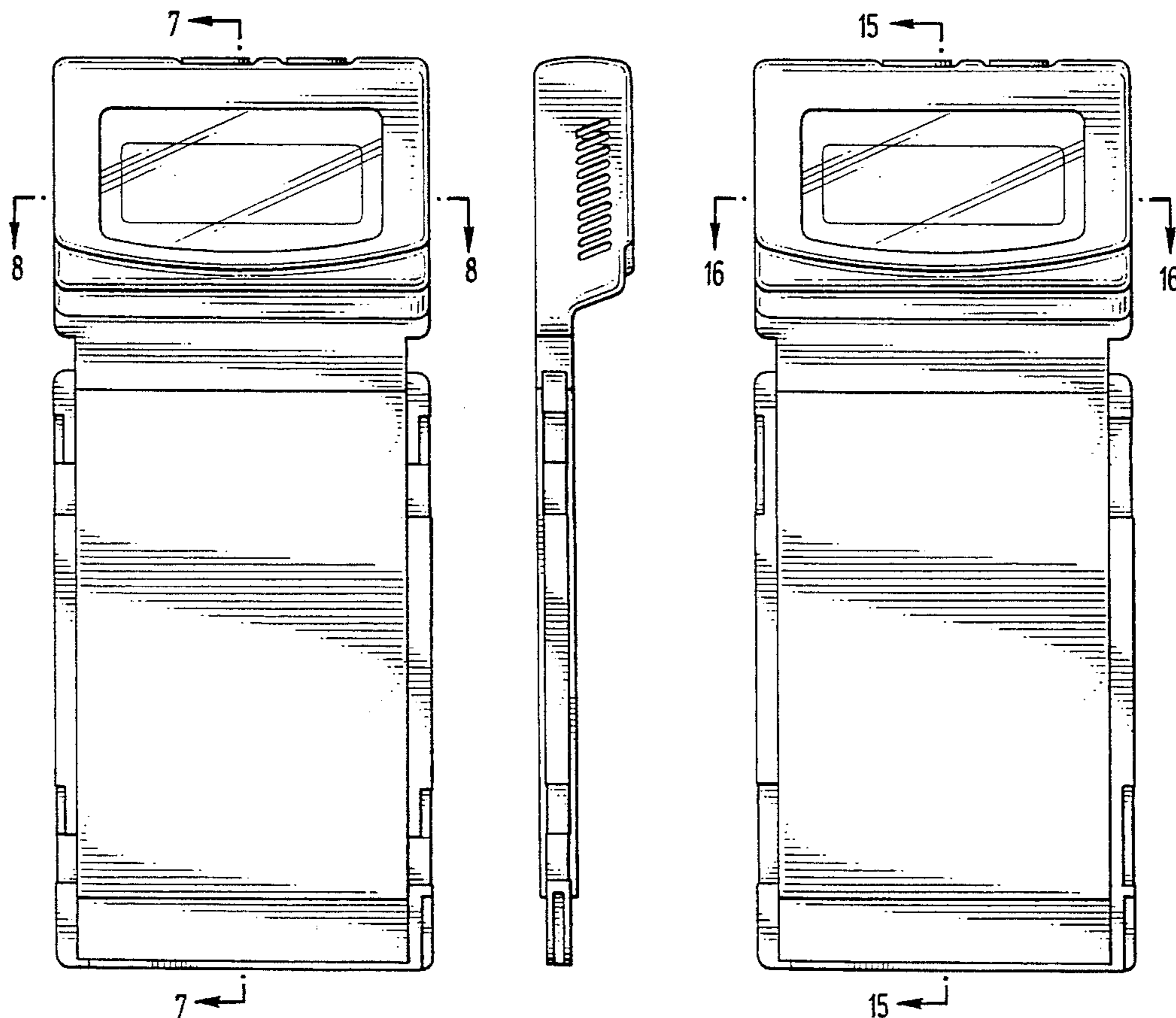
[57] **CLAIM**

The ornamental design for a message decoder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a message decoder showing my new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a cross-sectional view along line A—A of FIG. 1, with internal components removed;  
FIG. 8 is a cross-sectional view along line B—B of FIG. 1, with the internal components removed;  
FIG. 9 is a front elevational view of an alternate embodiment of FIG. 1;  
FIG. 10 is a left side elevational view of FIG. 9;  
FIG. 11 is a right side elevational view FIG. 9;  
FIG. 12 is a top plan view FIG. 9;  
FIG. 13 is a bottom plan view FIG. 9;  
FIG. 14 is a rear elevational view FIG. 9;  
FIG. 15 is a cross-sectional view along line A—A of FIG. 9, with internal components removed; and,  
FIG. 16 is a cross-sectional view along line B—B of FIG. 9, with internal components removed.

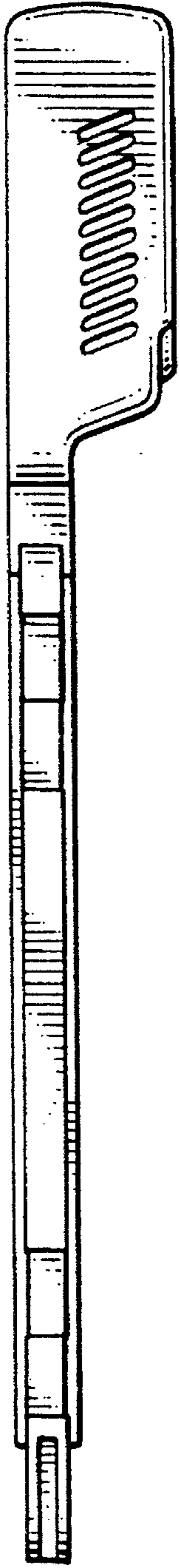

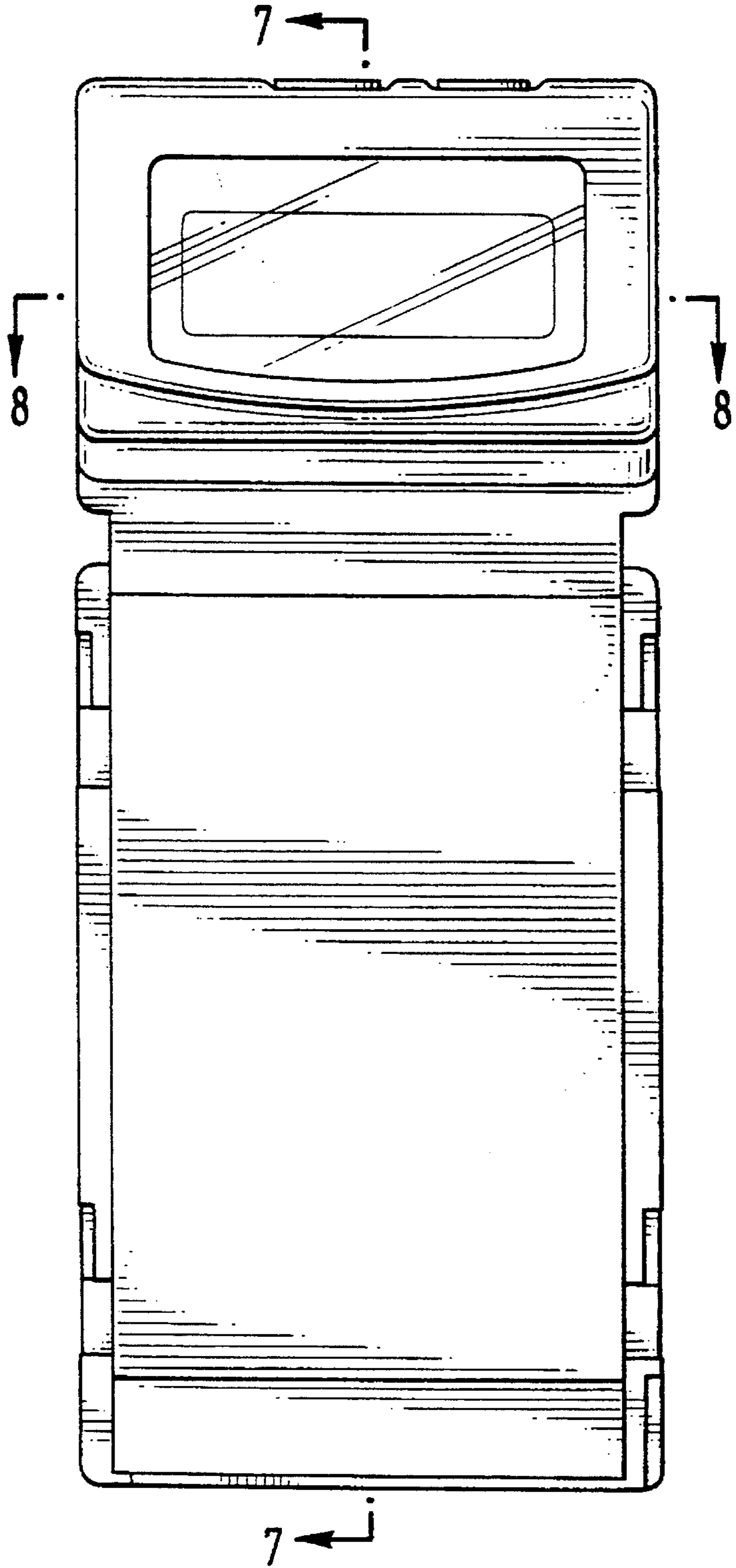

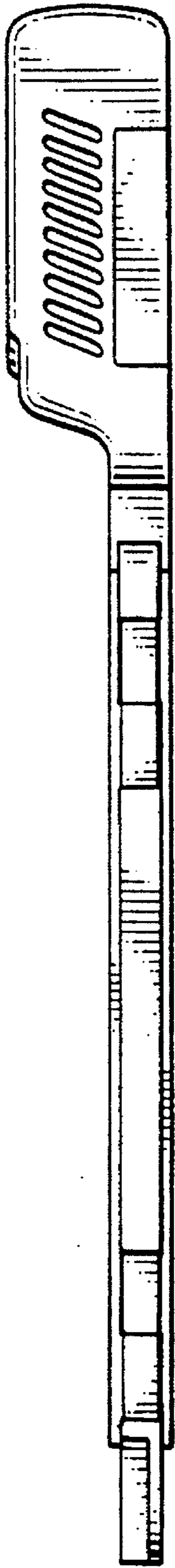

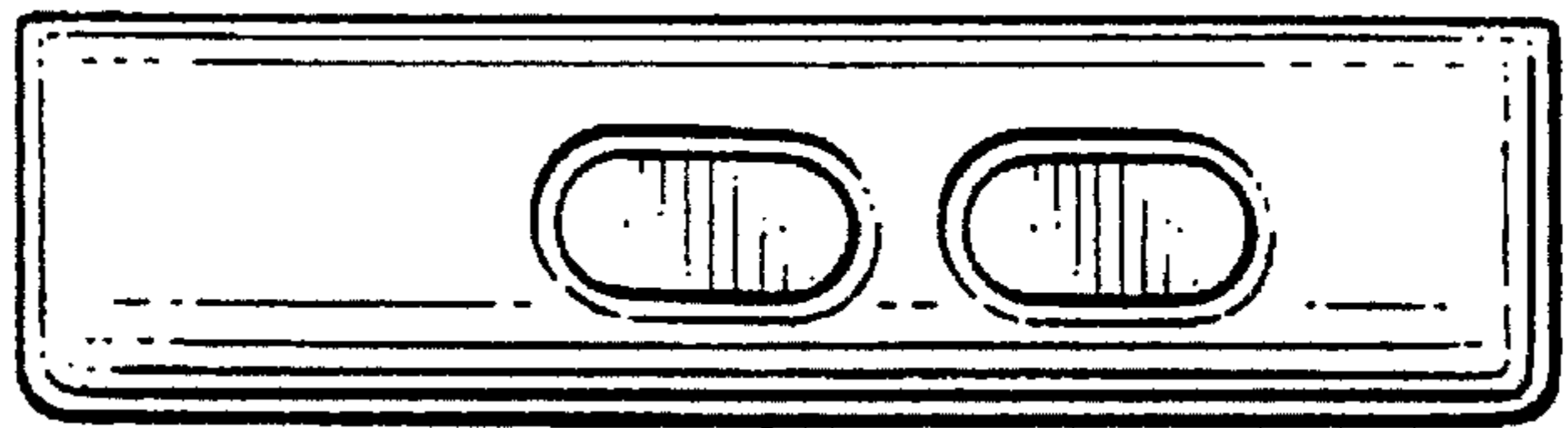

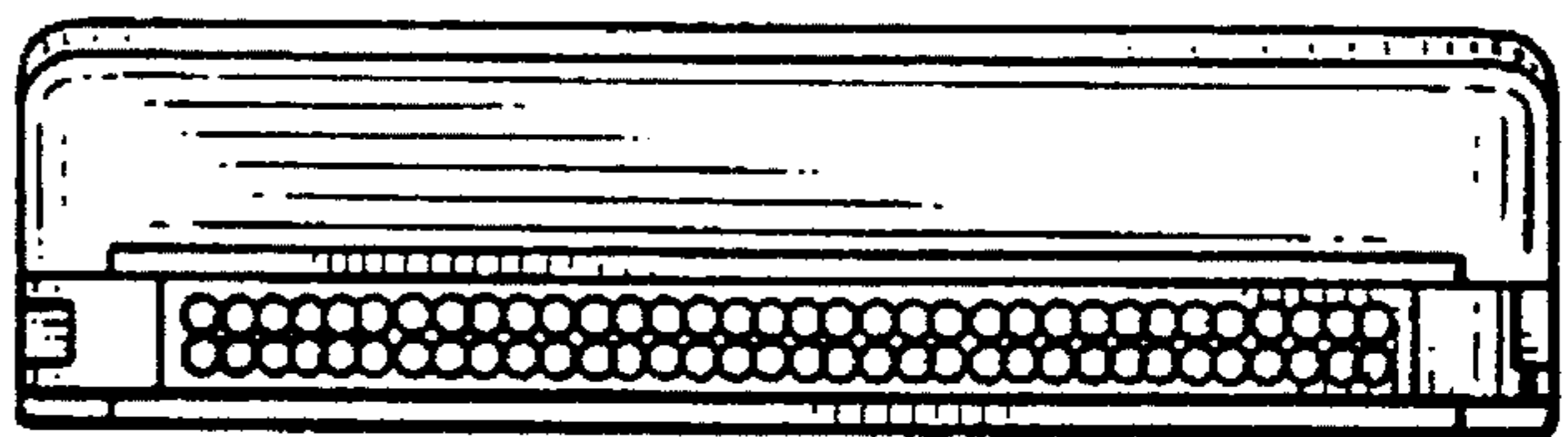

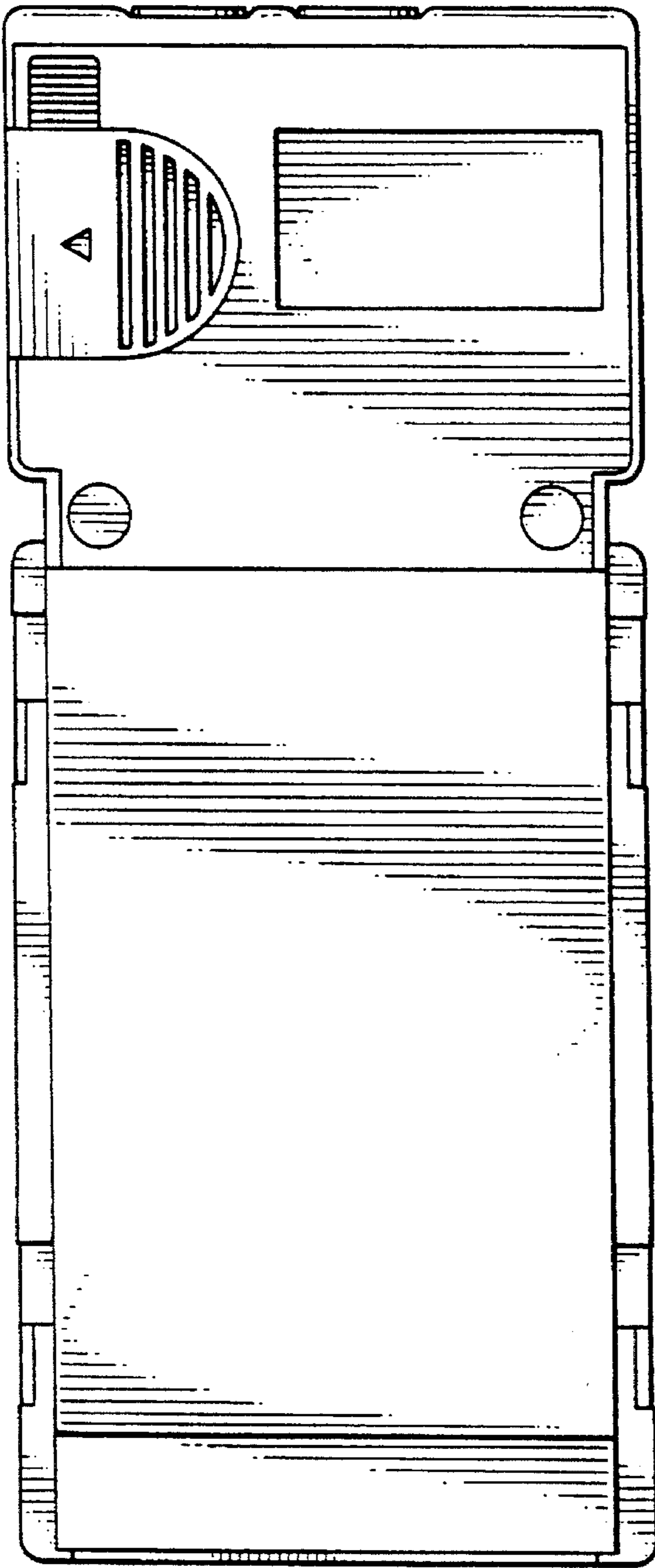

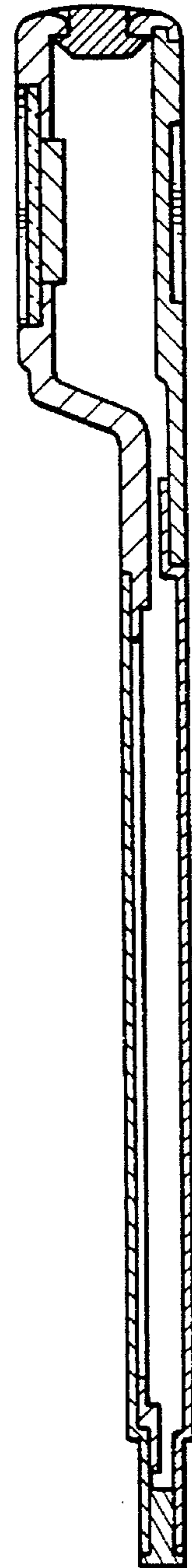

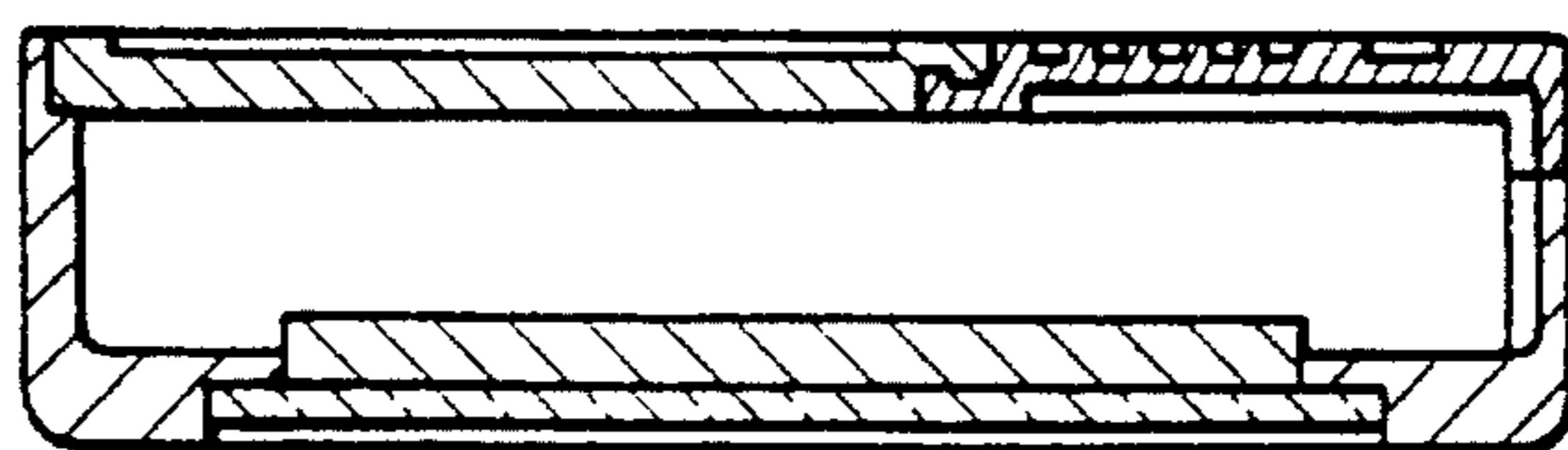

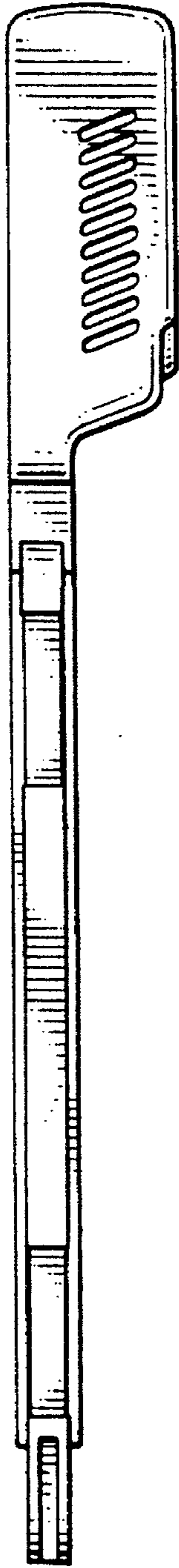

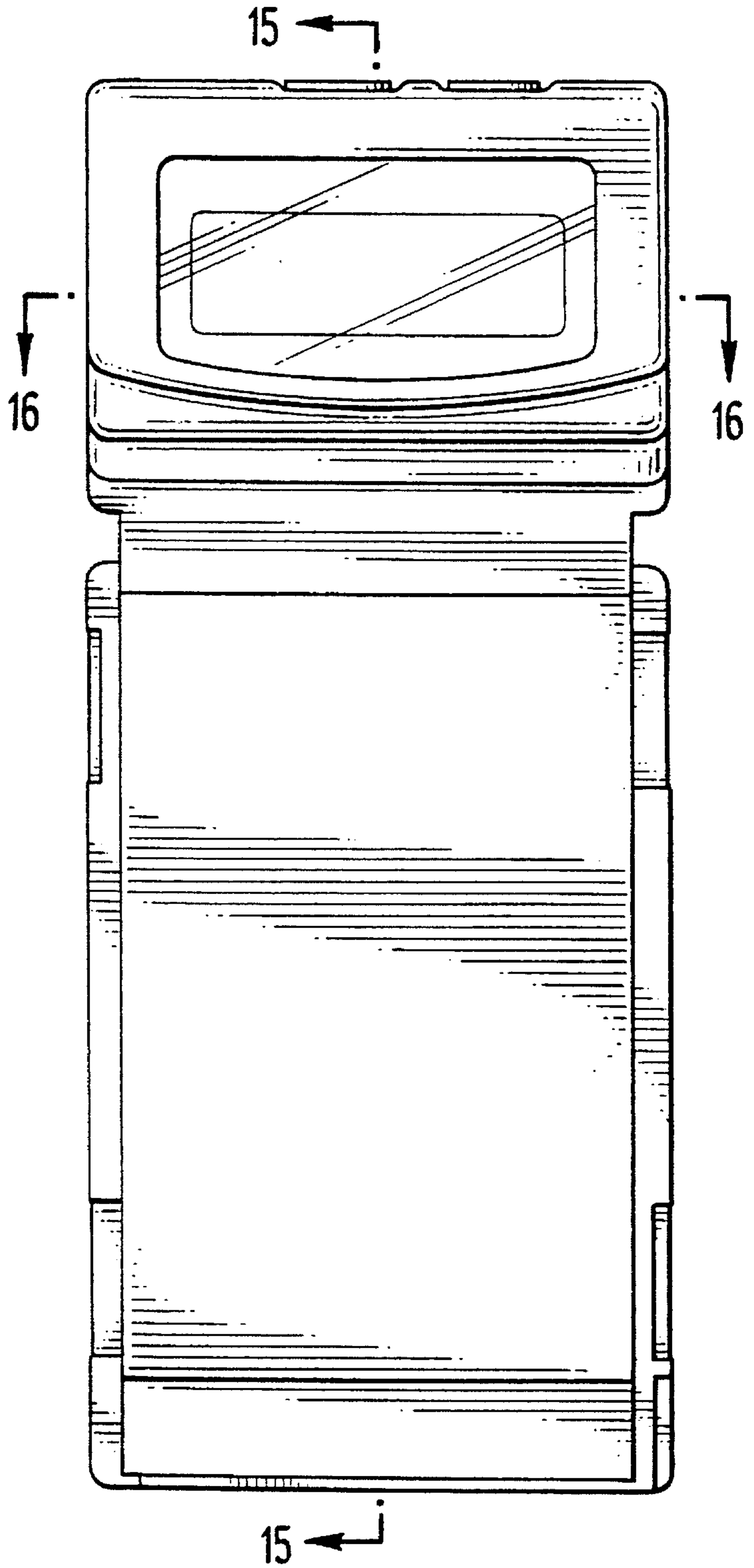

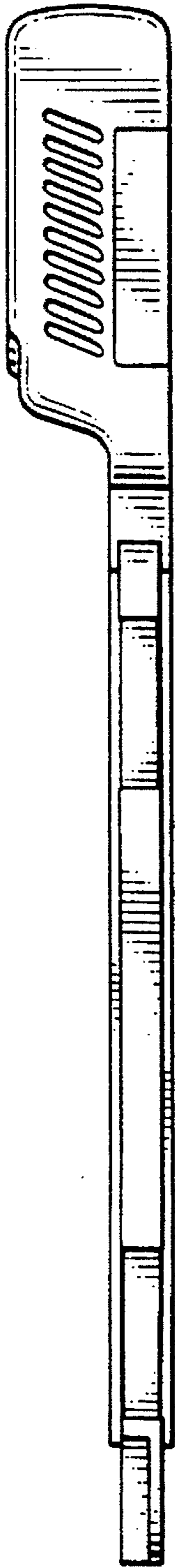

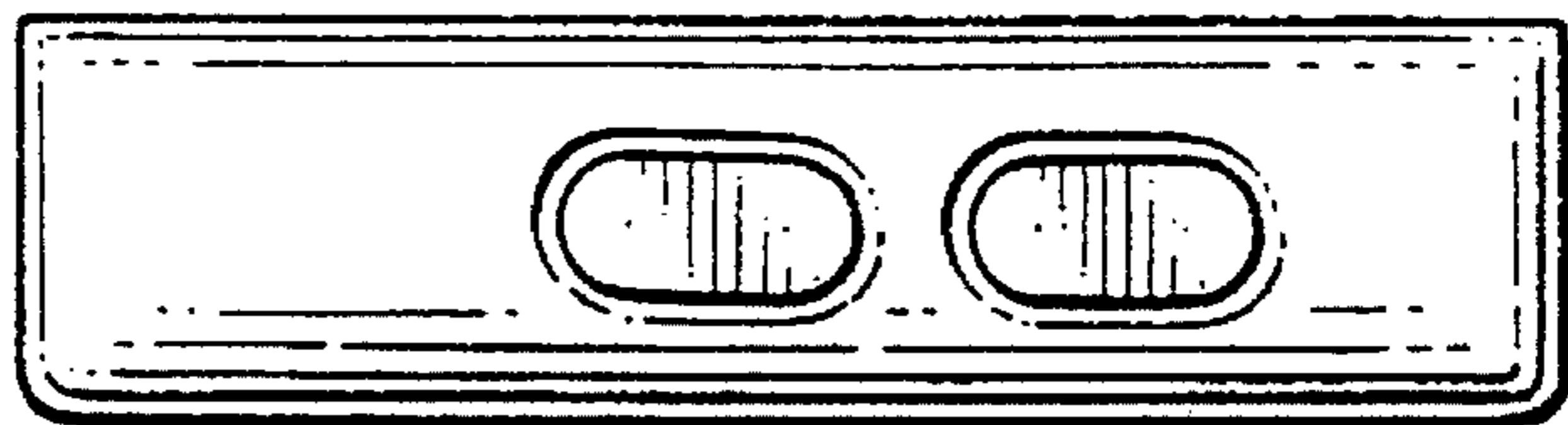

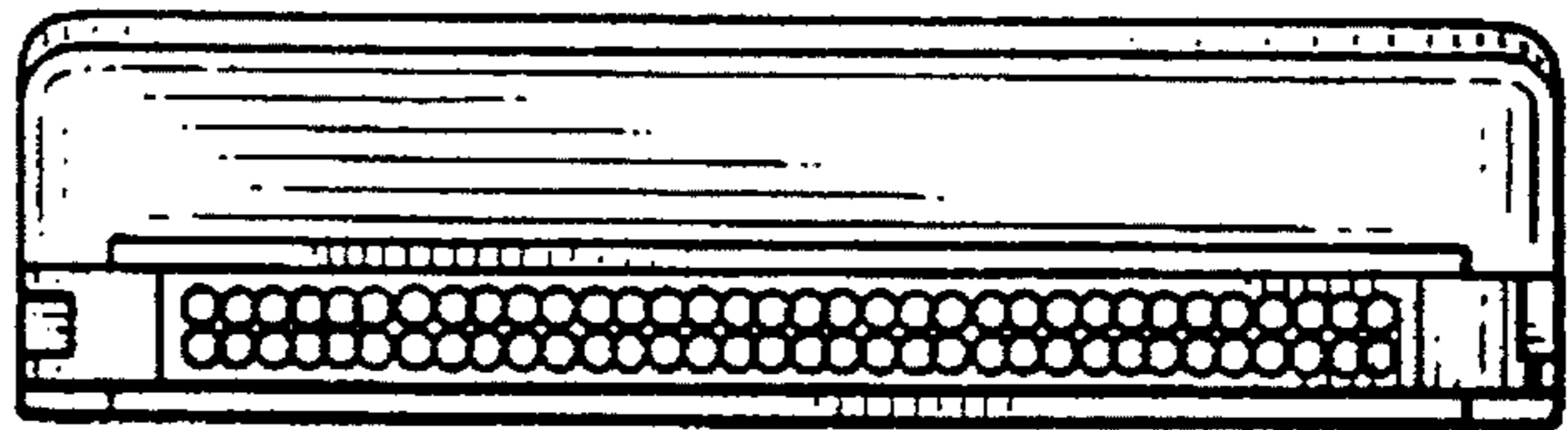

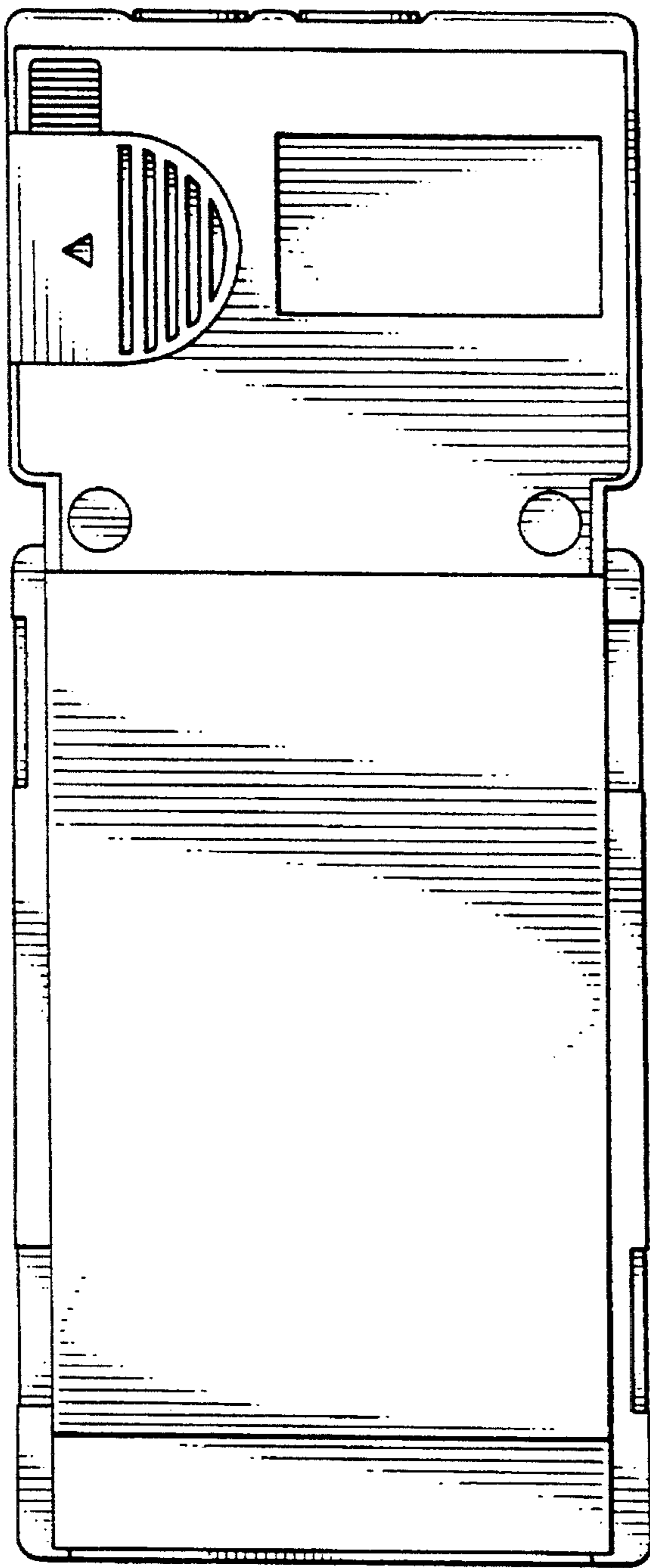

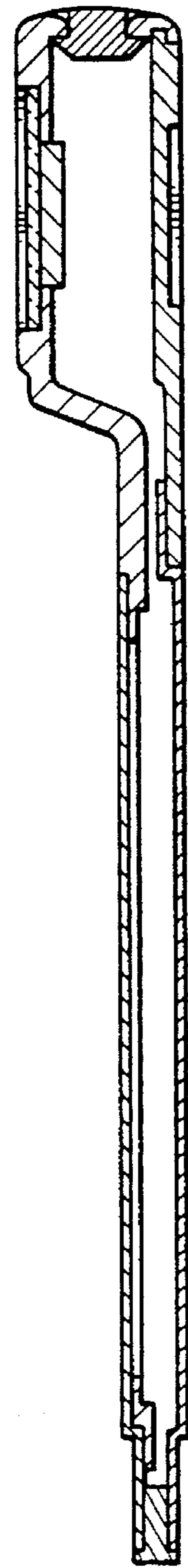

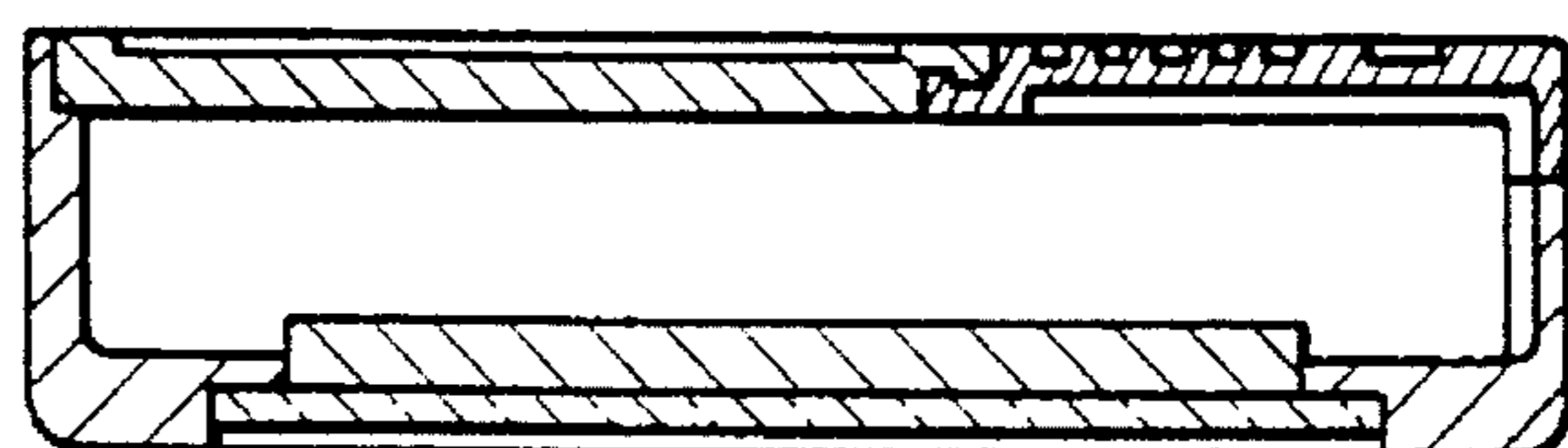
