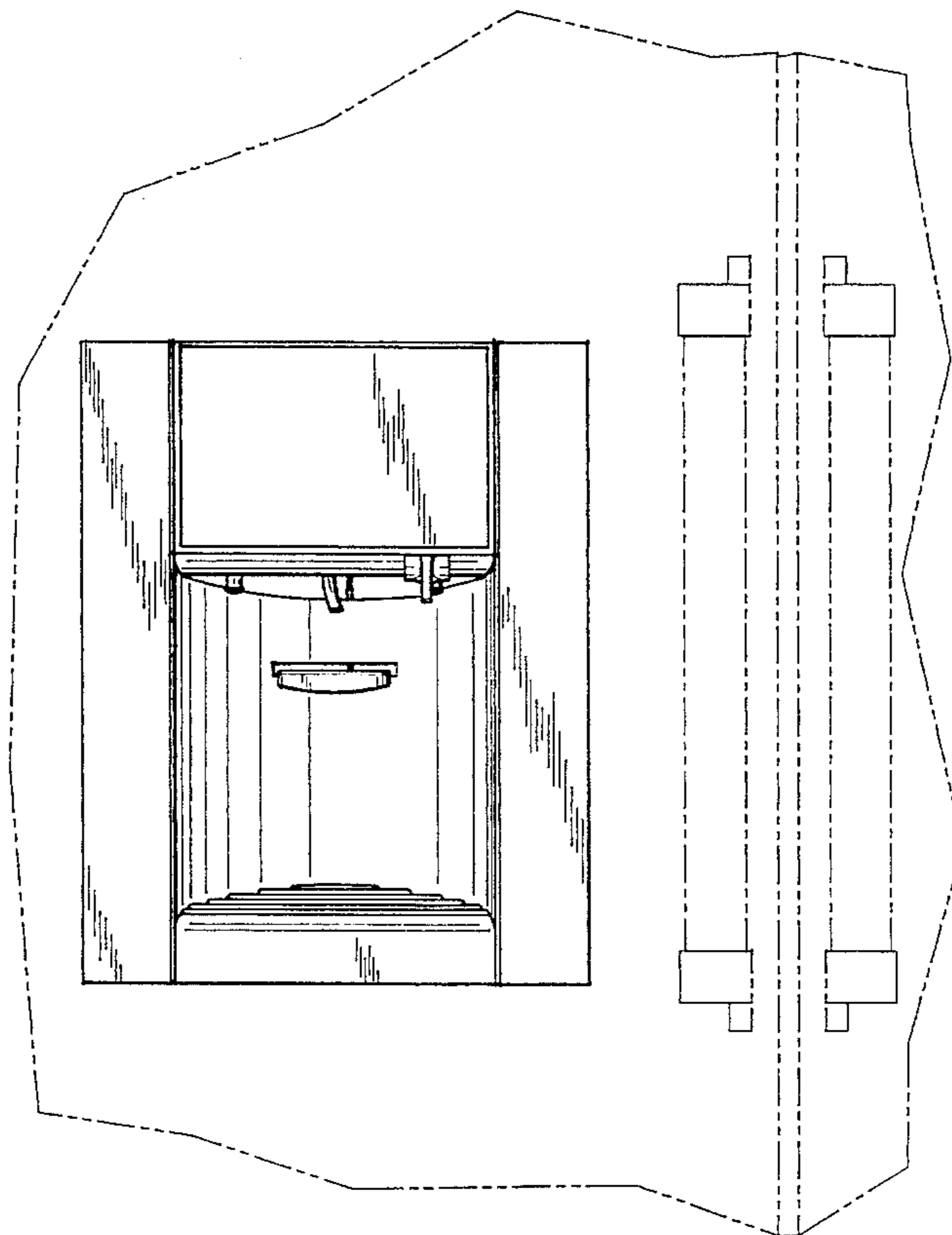
FIG. 2 is a top perspective view thereof;

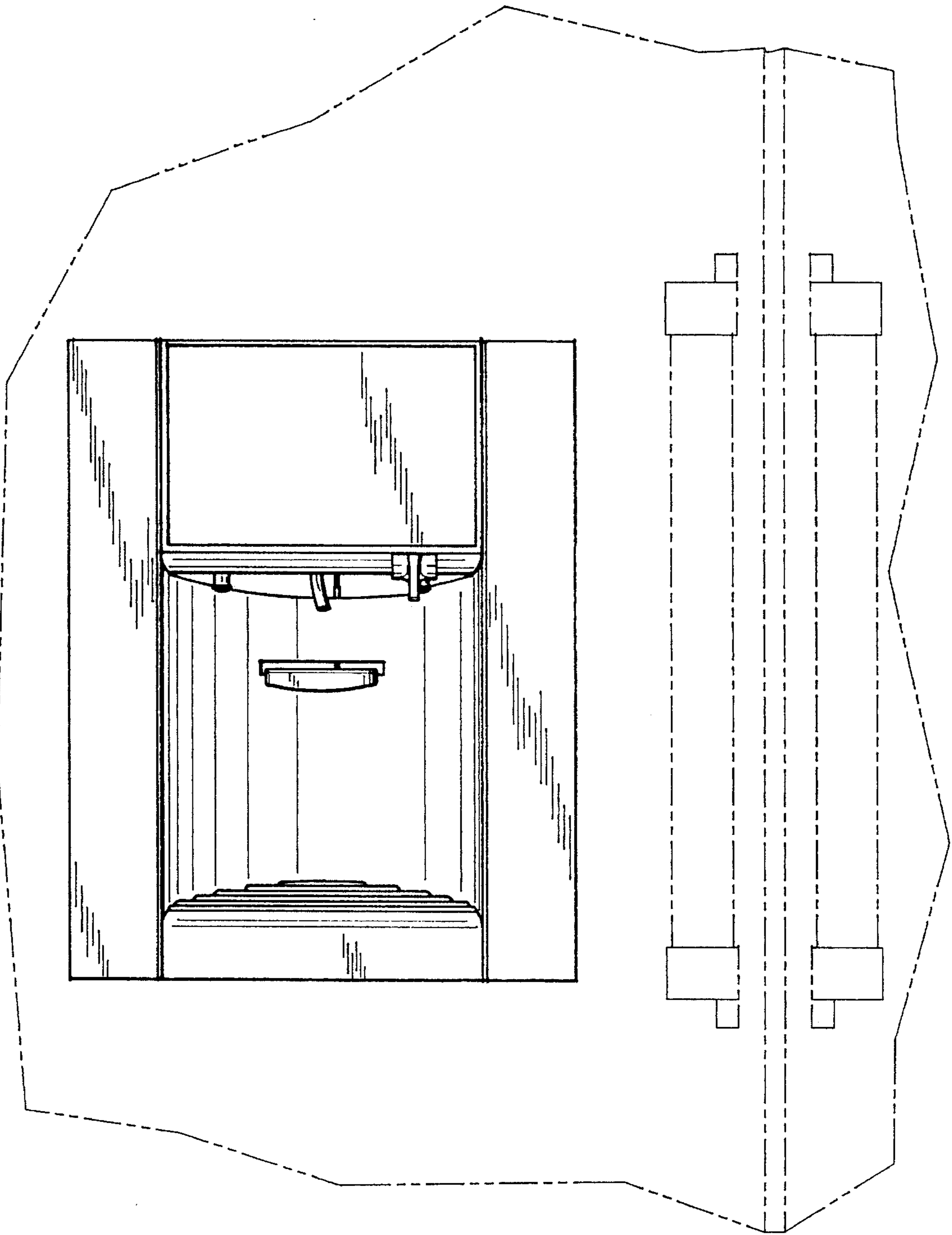

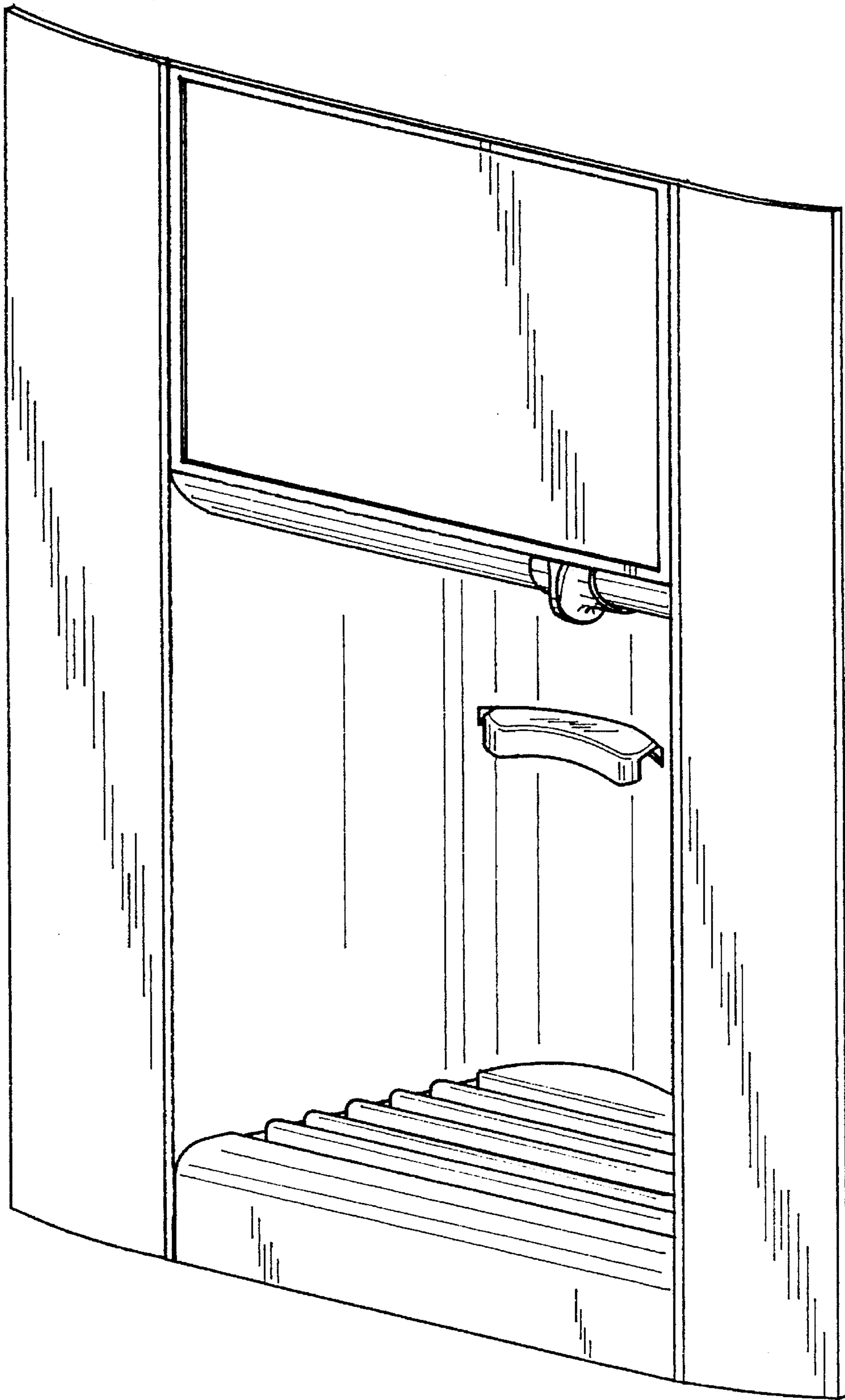

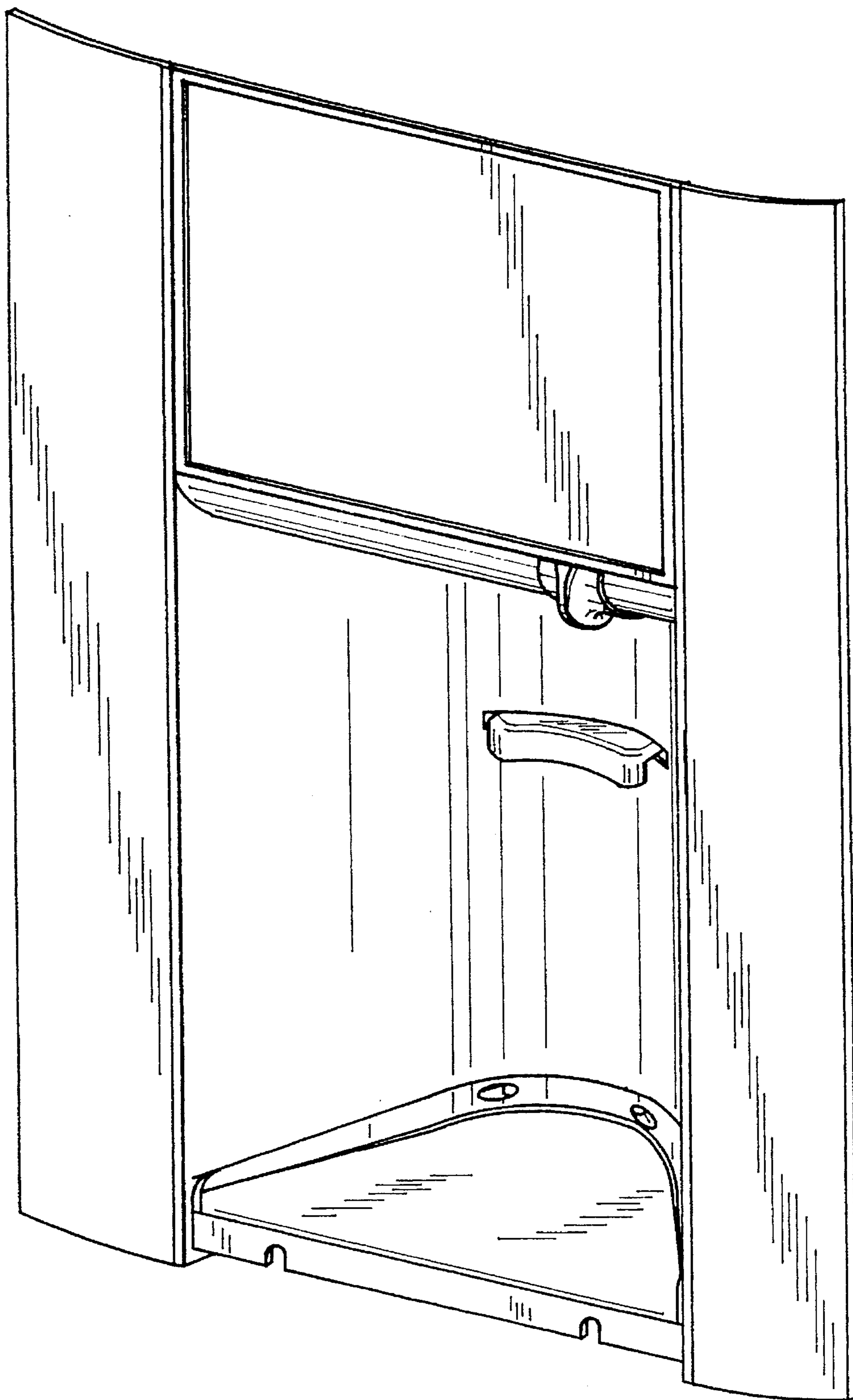

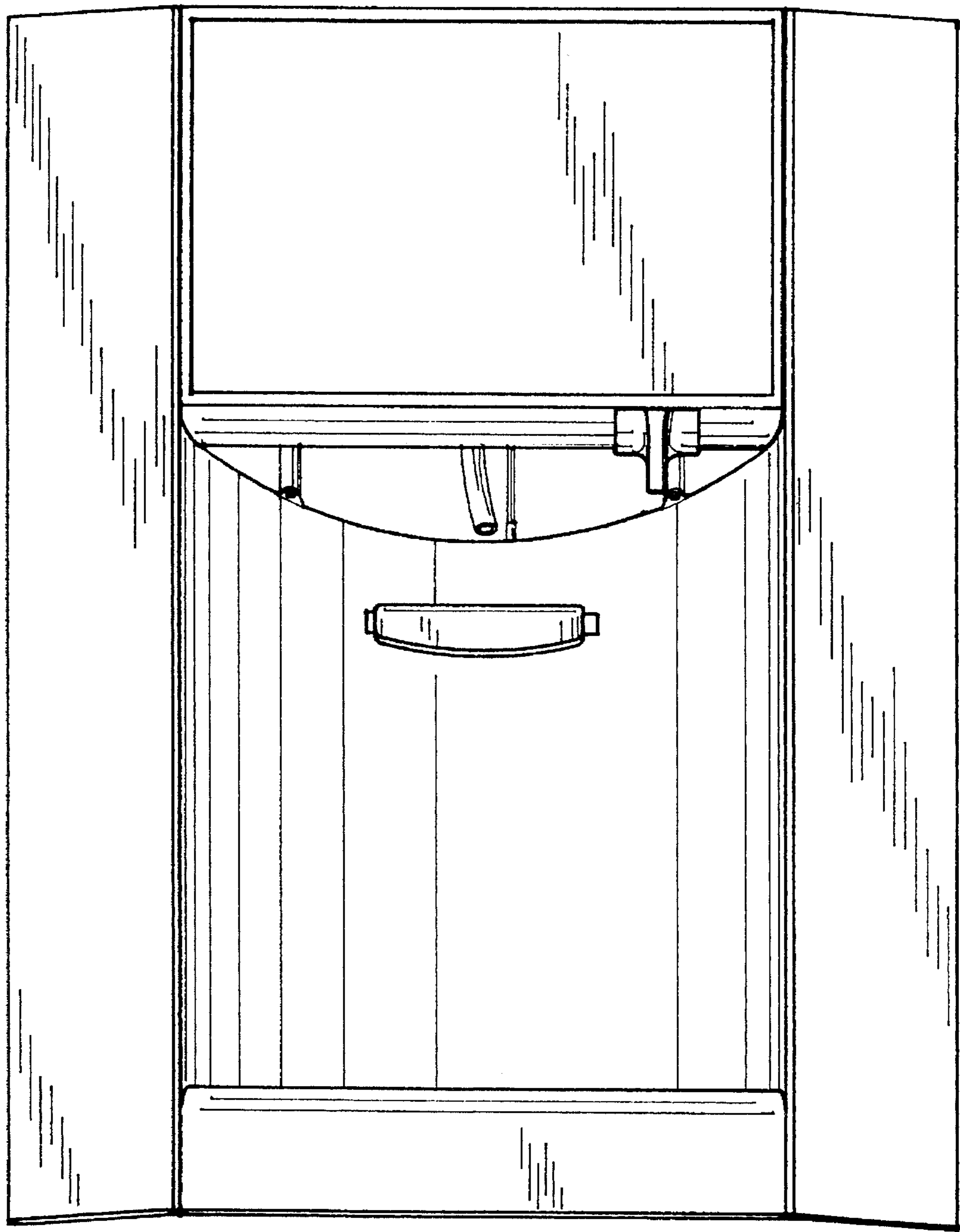
