[57] **CLAIM**

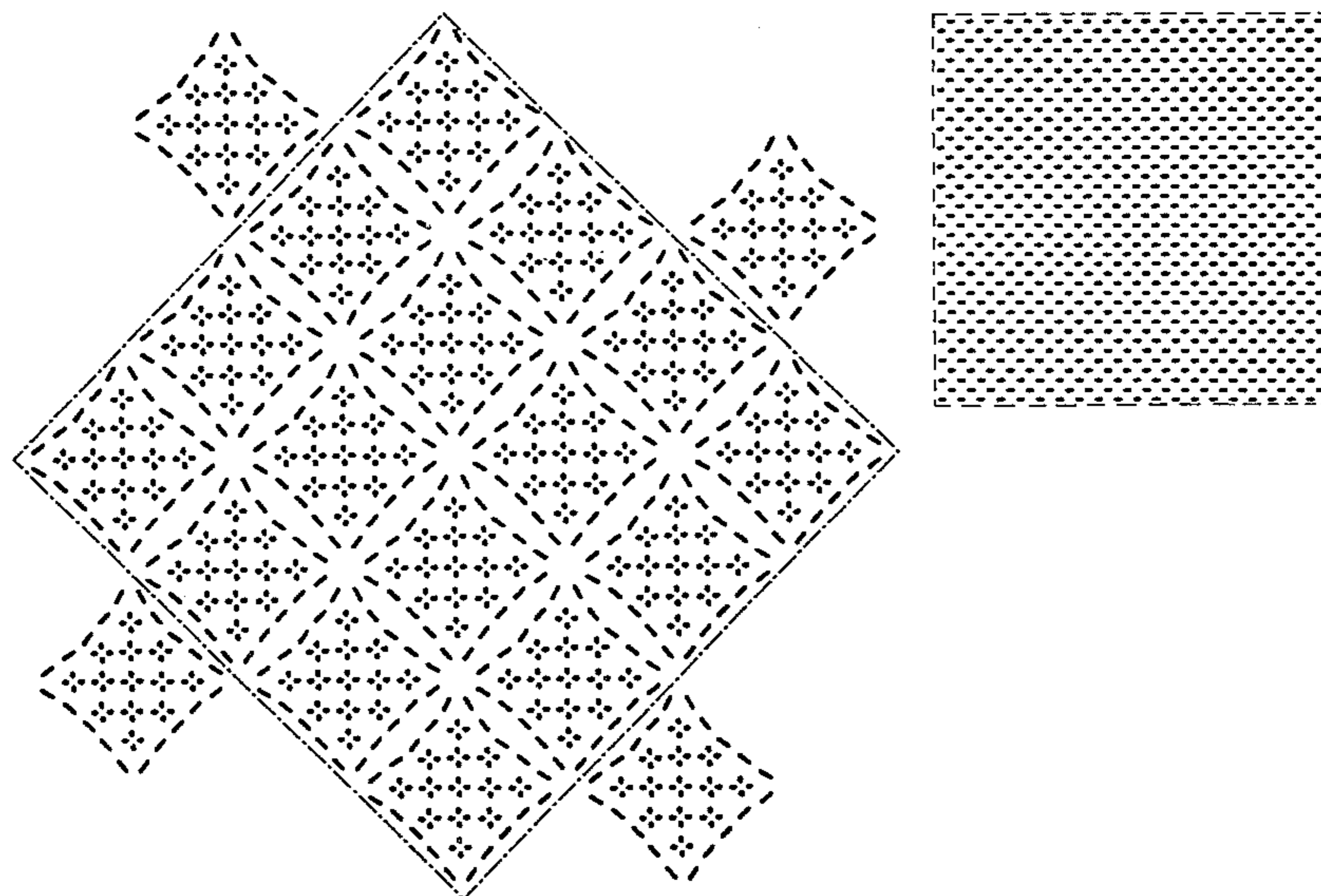
The ornamental design for an embossed paper product, as shown and described above.

**DESCRIPTION**

FIG. 1 is a top plan view of an embossed paper product embodying our design; and, FIG. 2 is a bottom plan view of an embossed paper product embodying our design.

The broken line shown along the border of the figures depicts the boundaries of the repeat units of the embossed paper product.

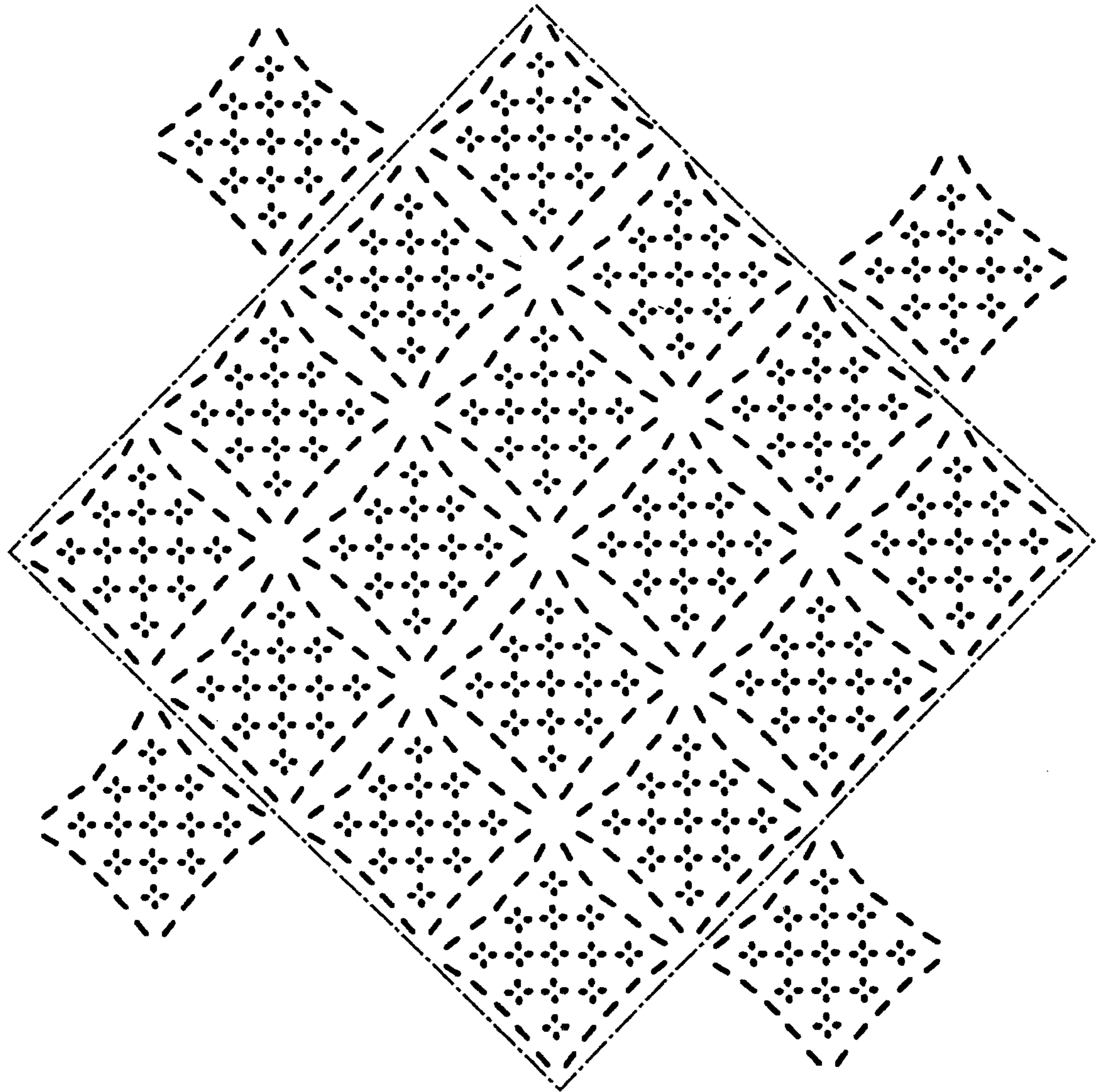
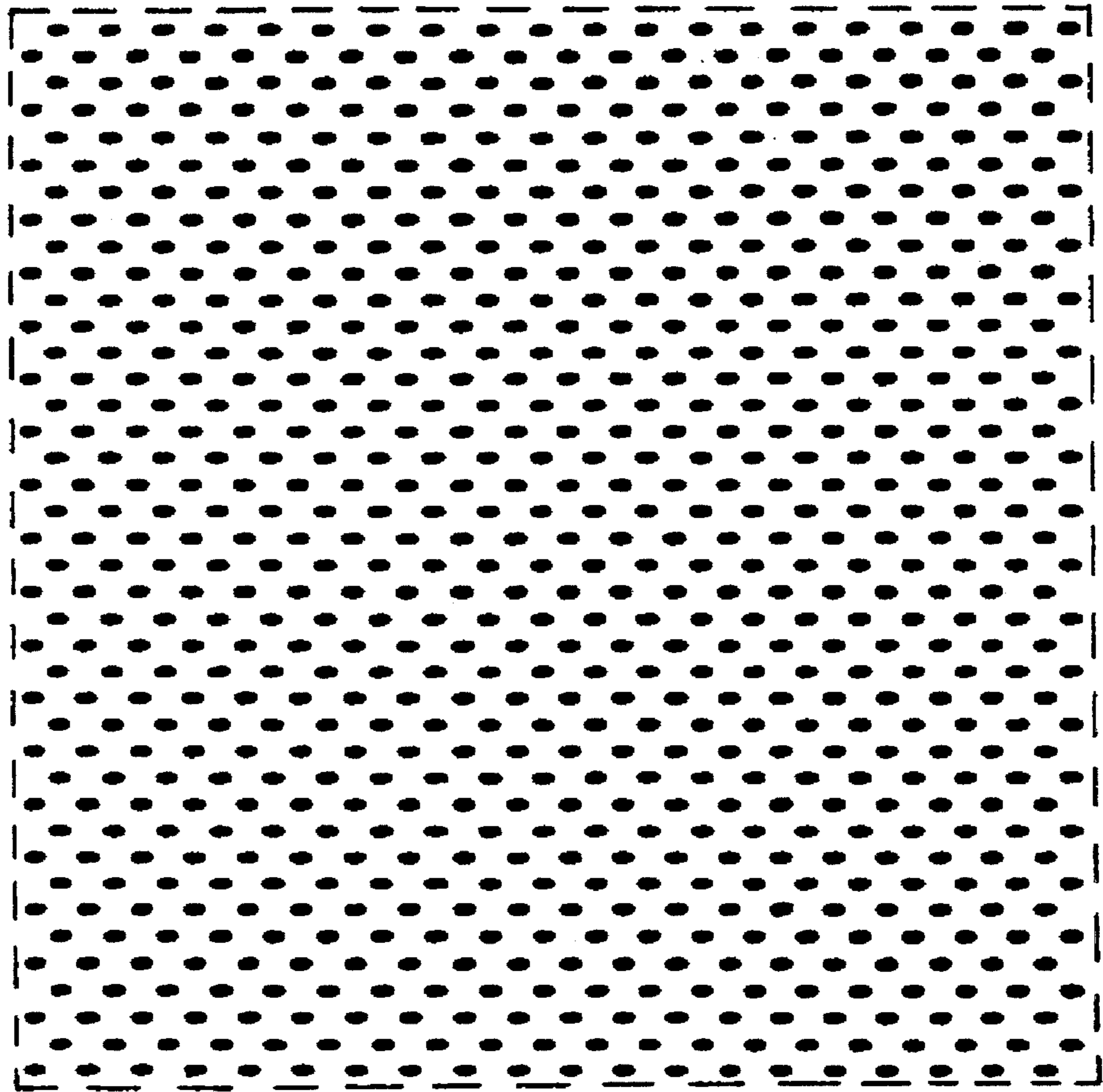
