[57] **CLAIM**

The ornamental design for a garment hanger body, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a garment hanger body showing our new design; a proposed hook and hook boss for the garment hanger body is shown in phantom and is not part of the design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof, the left side elevational view being the same in appearance;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front perspective view of a second embodiment of FIG. 1, the hook and hook boss shown in phantom is not part of the design;

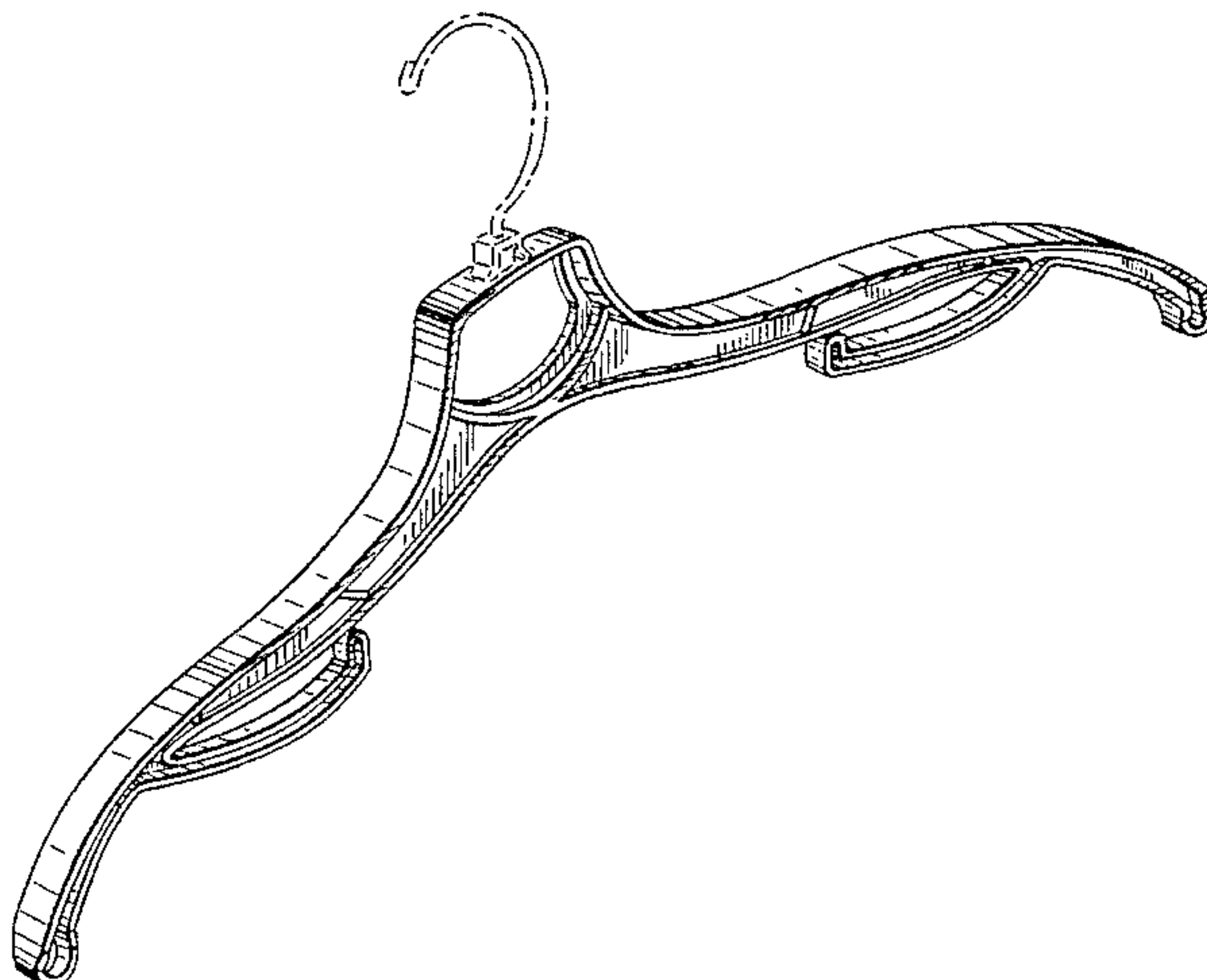
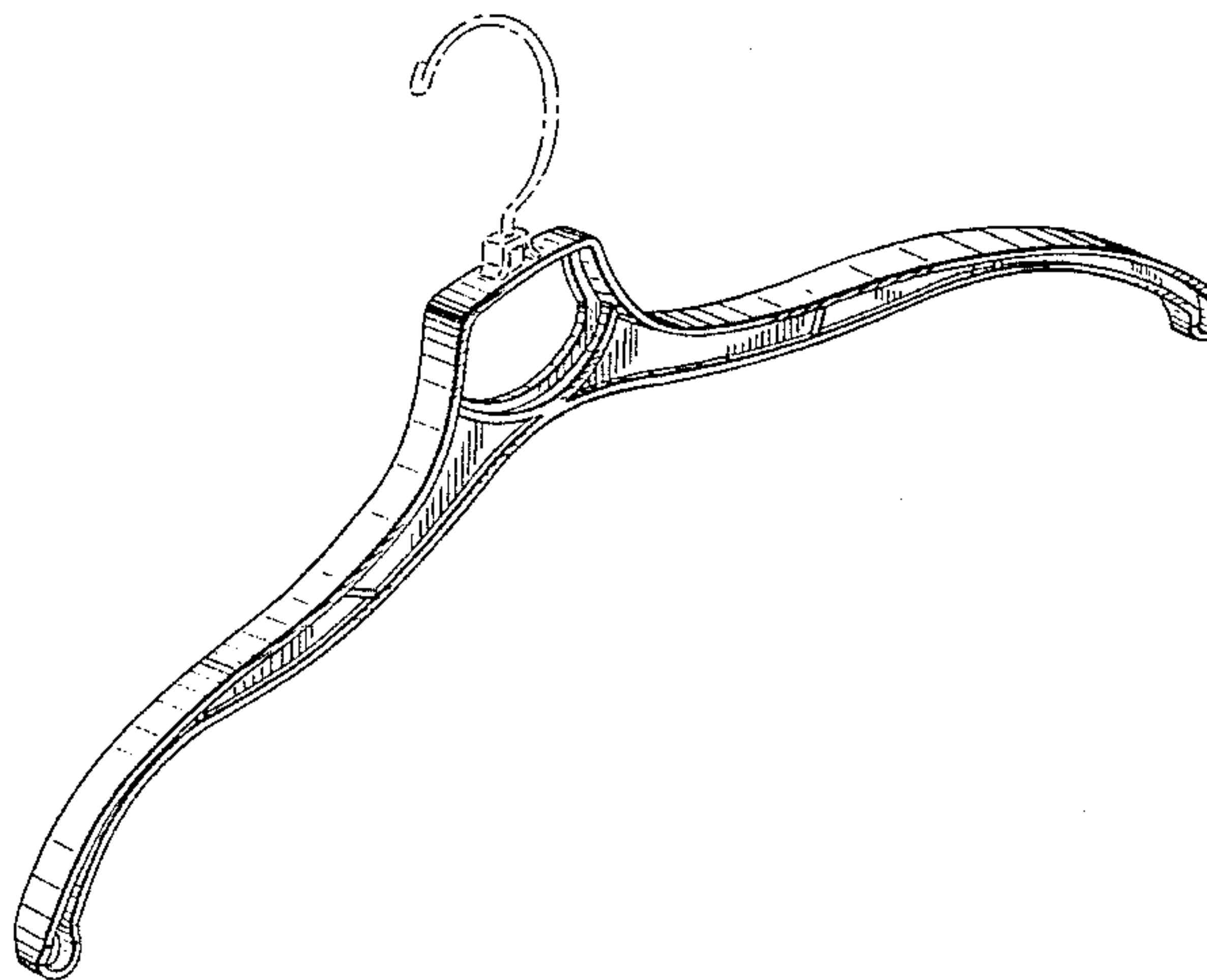
FIG. 7 is a top plan view of FIG. 6;

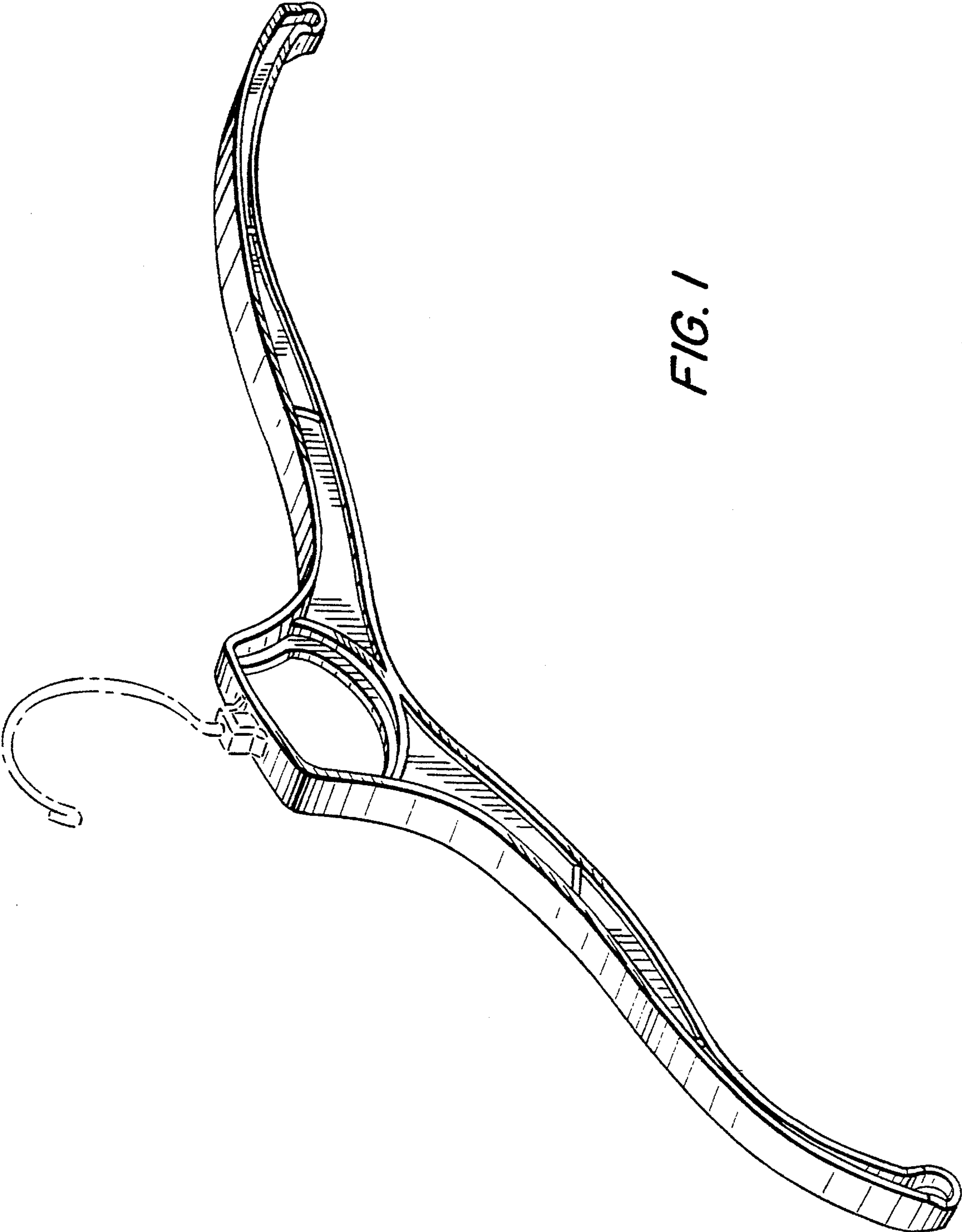

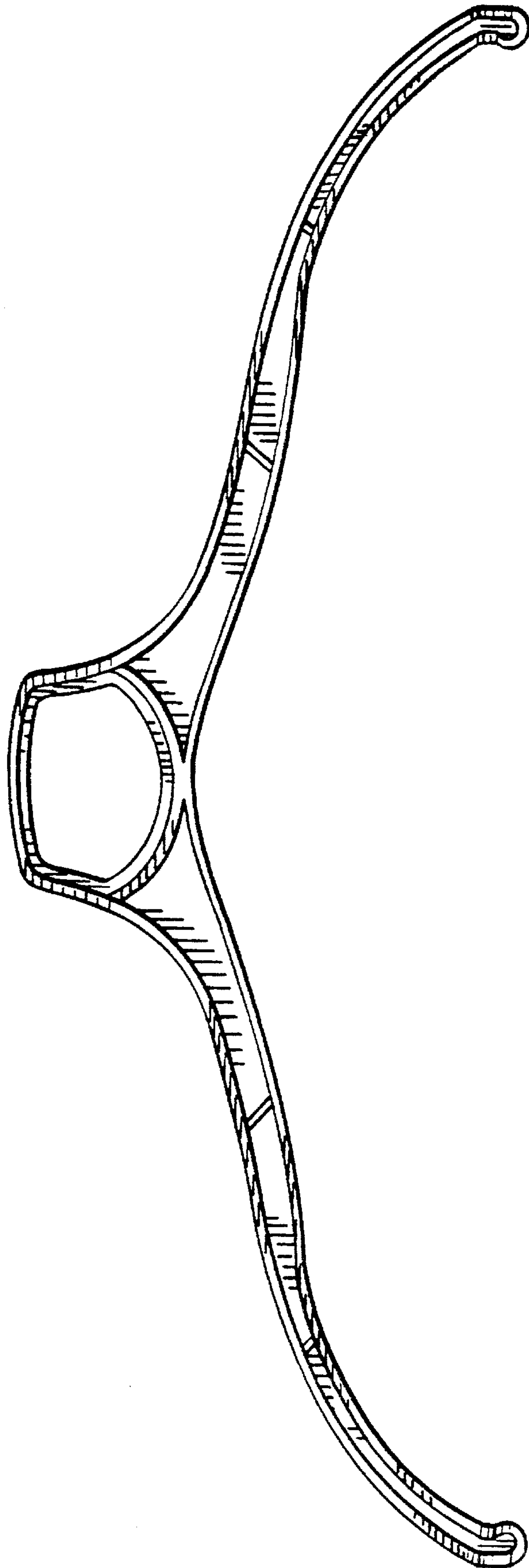

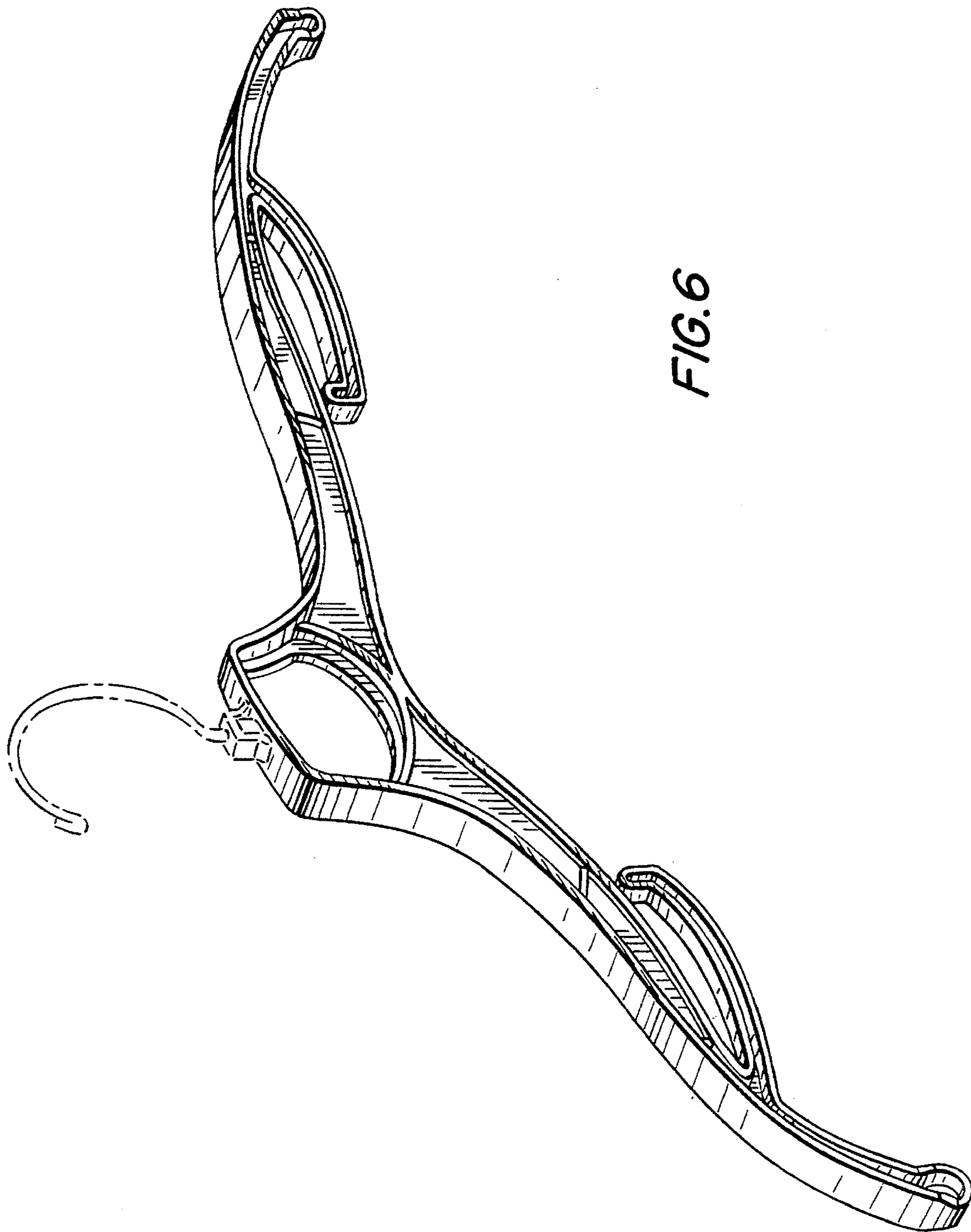

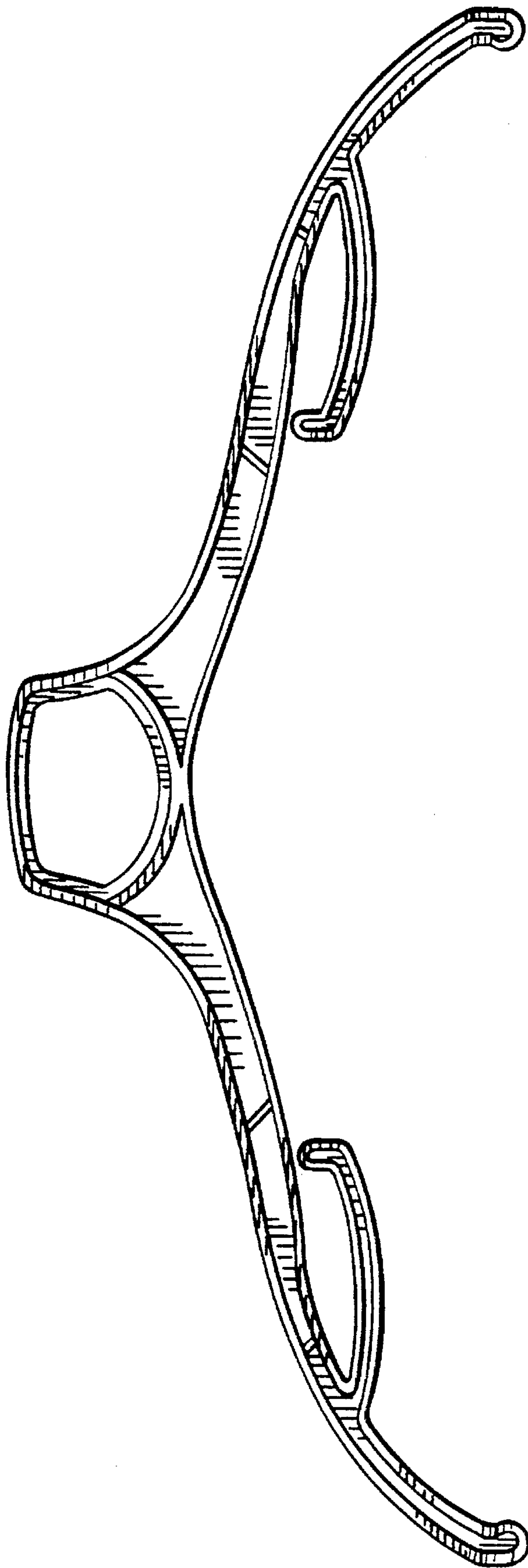
