[57] **CLAIM**

The ornamental design for an electric shaver, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of an electric shaver embodying our new design;  
 FIG. 2 is a right side elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a cross section taken along line 6—6 of FIG. 1, the internal mechanisms being omitted;  
 FIG. 7 is a cross section taken along line 7—7 of FIG. 1, the internal mechanisms being omitted; and,  
 FIG. 8 is a perspective view thereof.

A left side elevational view of the shaver of FIG. 1 is identical with the right side elevational view thereof.

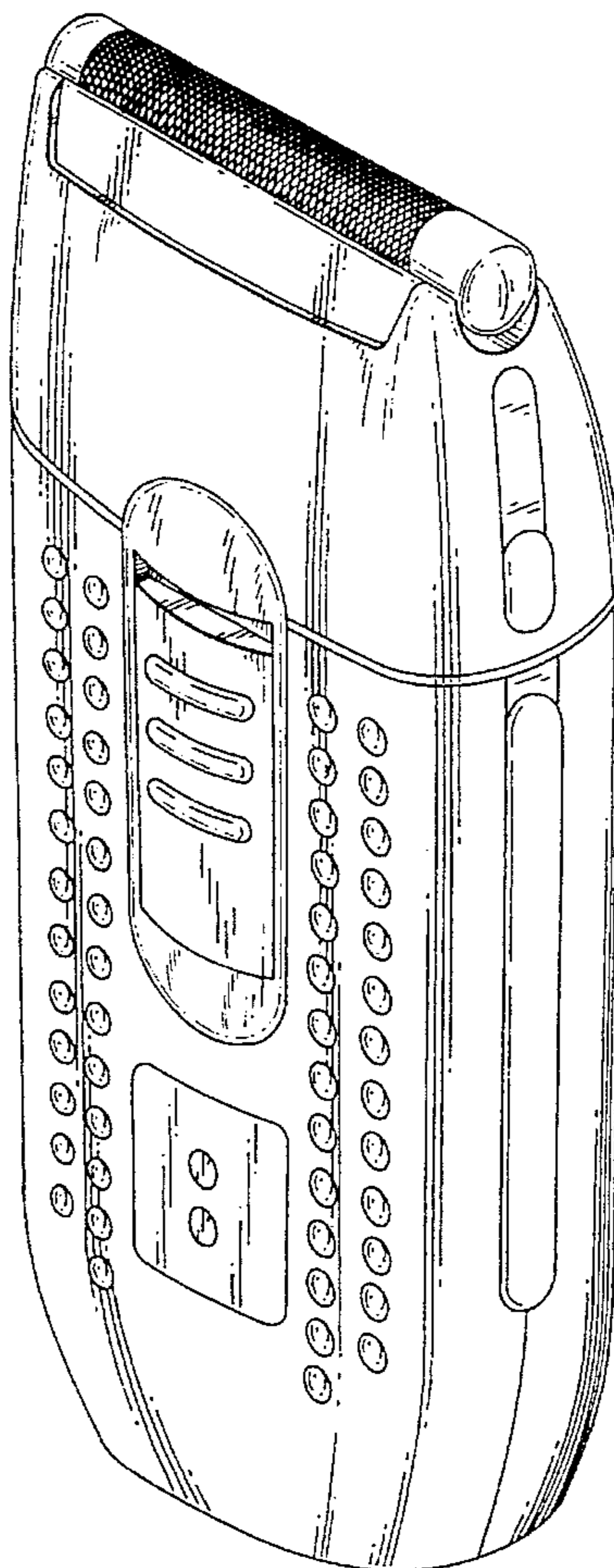

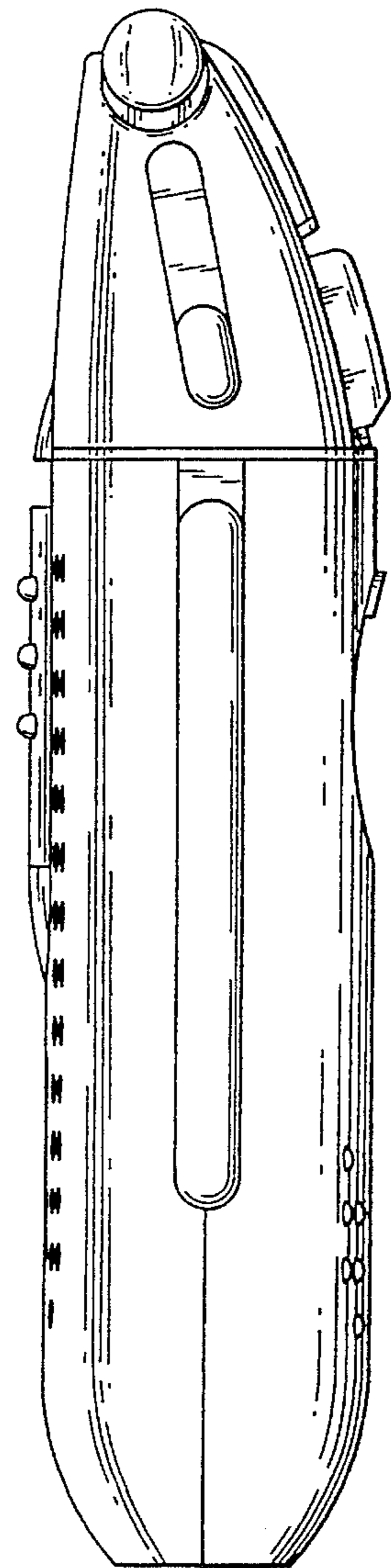
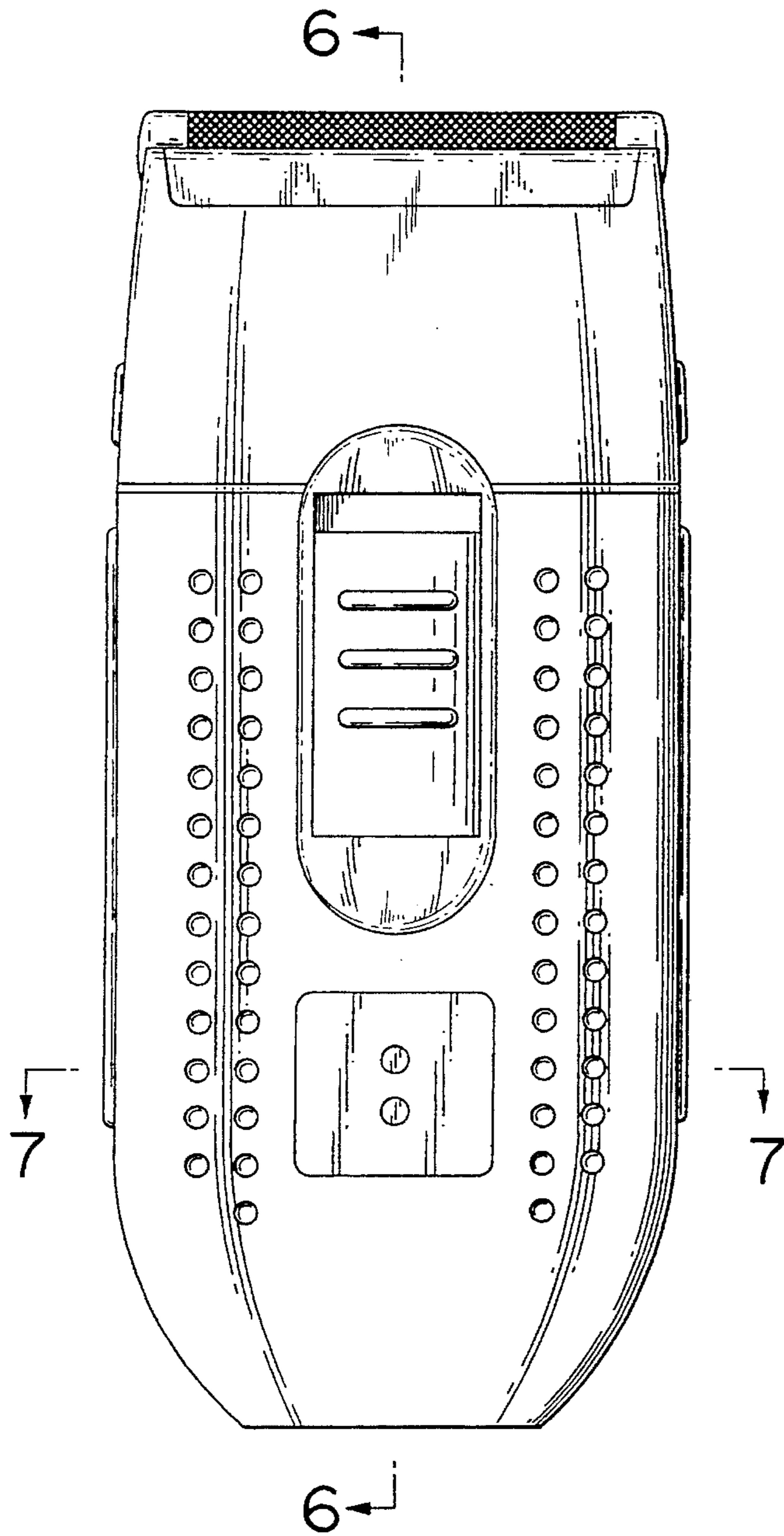

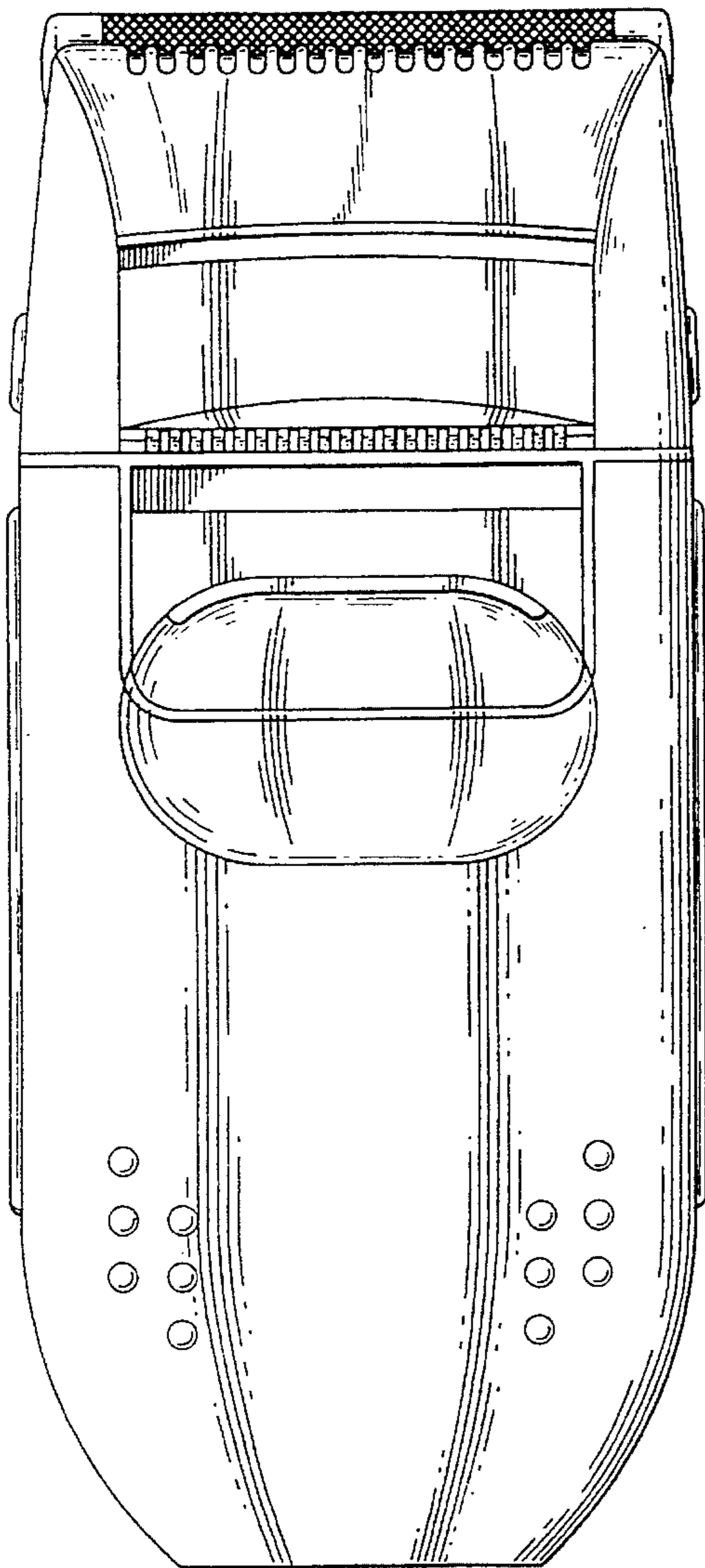

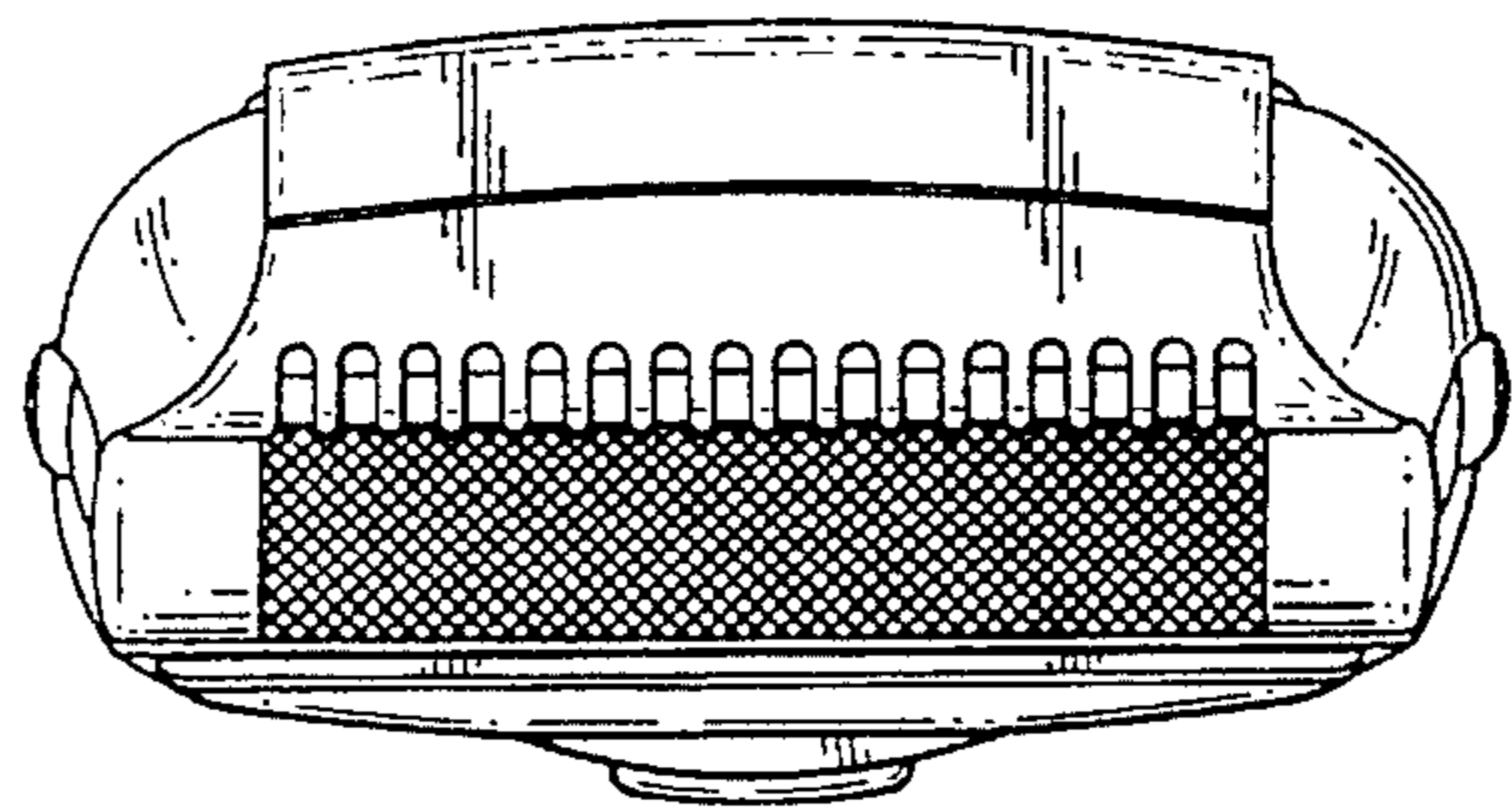

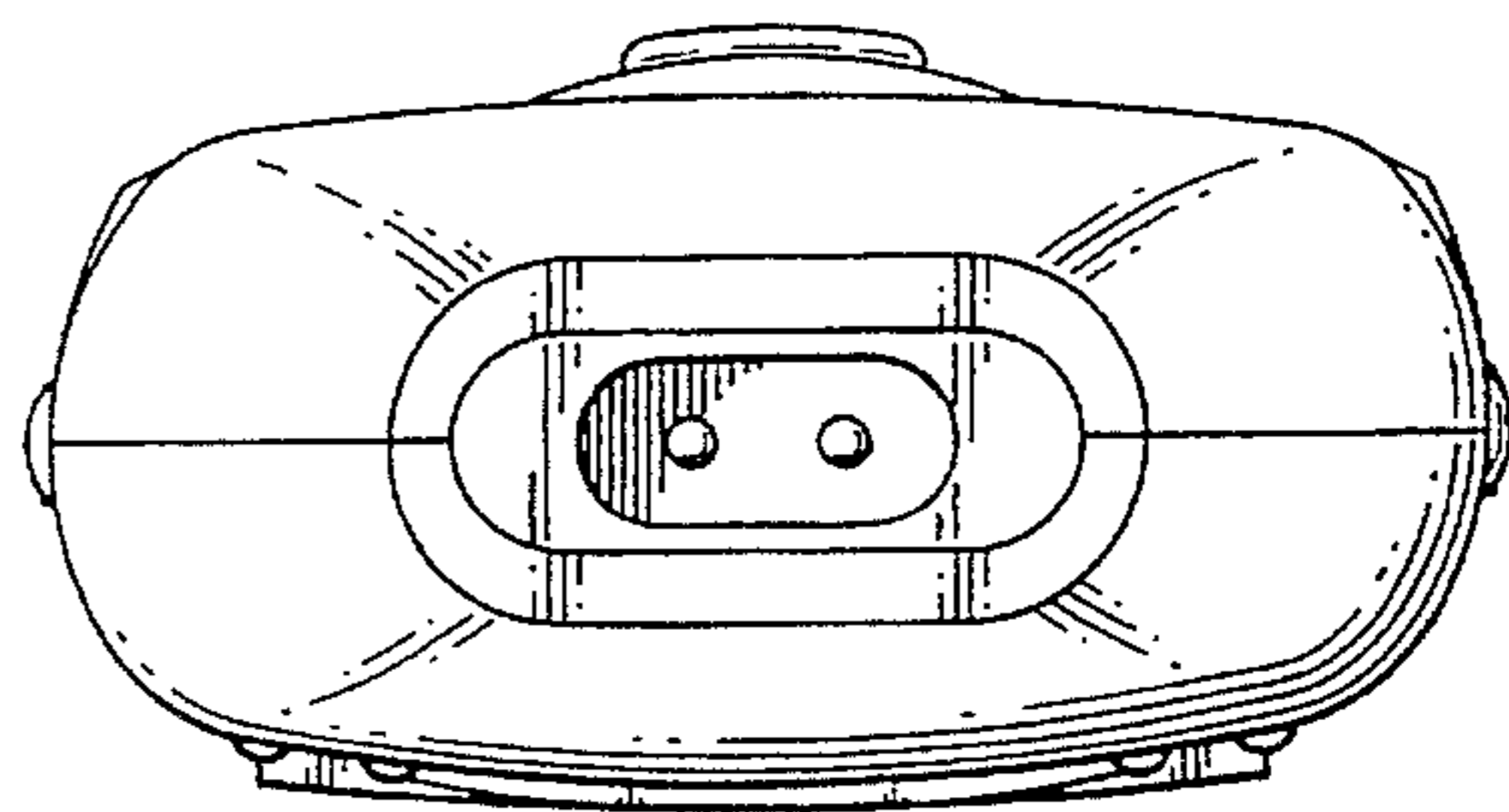

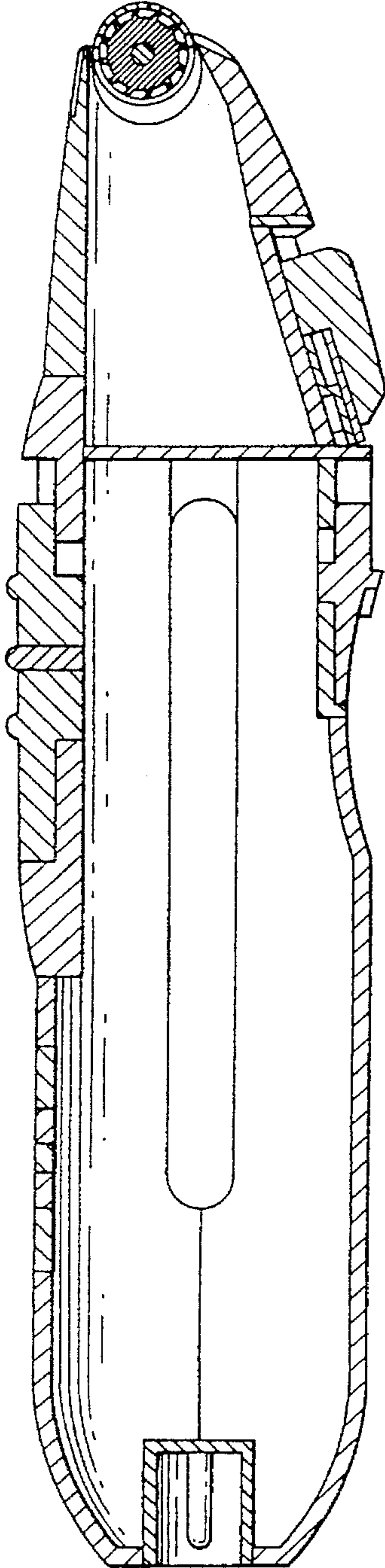

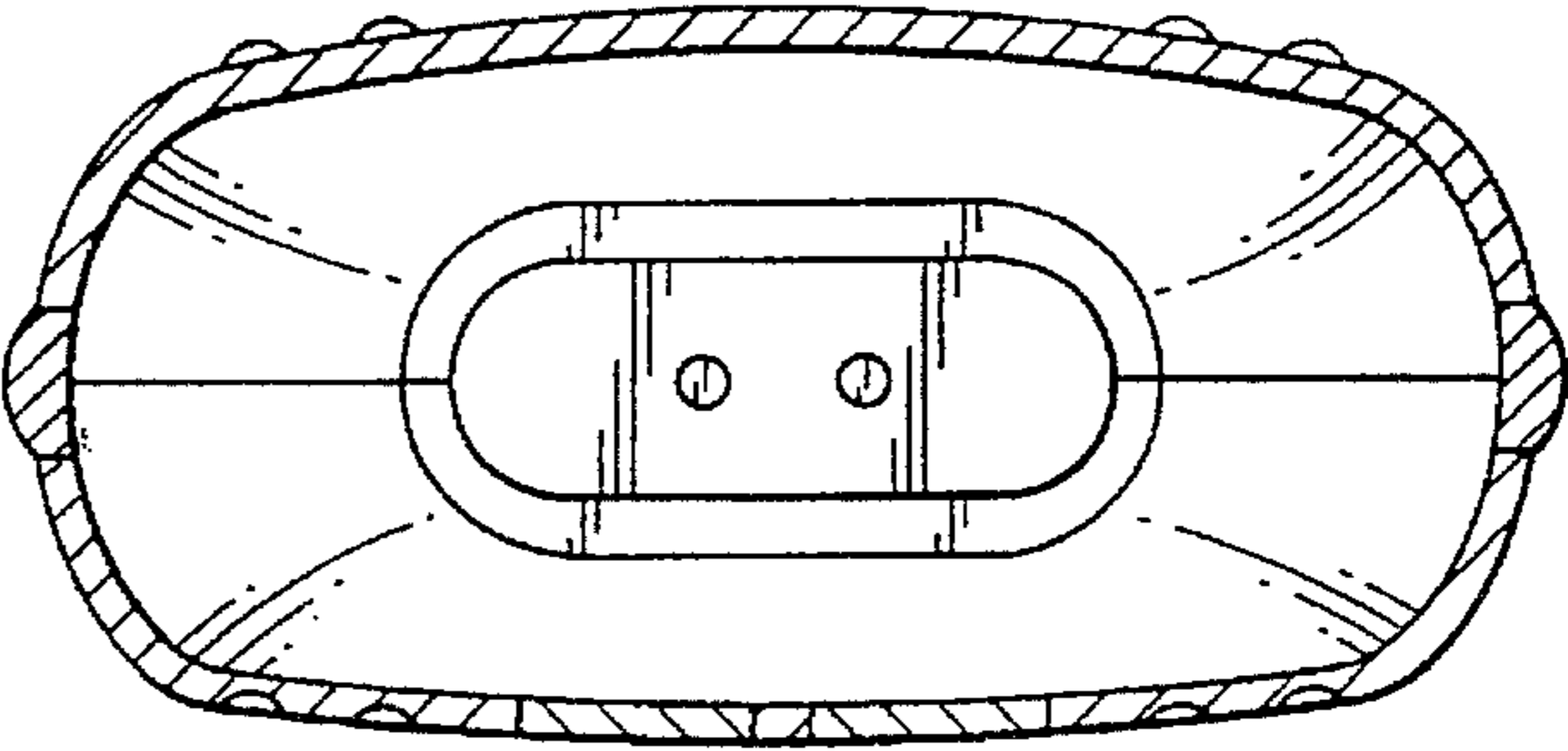
