[57] CLAIM

The ornamental design for a storage bin, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a storage bin showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a top right front perspective view of the storage bin showing one of the bins thereof in a partially open position;

FIG. 8 is a rear elevational view thereof, shown with the environmental unclaimed features removed, and

FIG. 9 is a right side elevational view thereof, shown with the environmental unclaimed features removed; the left side elevational view being a mirror image.

The broken line portions of FIGS. 4 and 5 are for illustrative purposes only and forms no part of the claimed design.

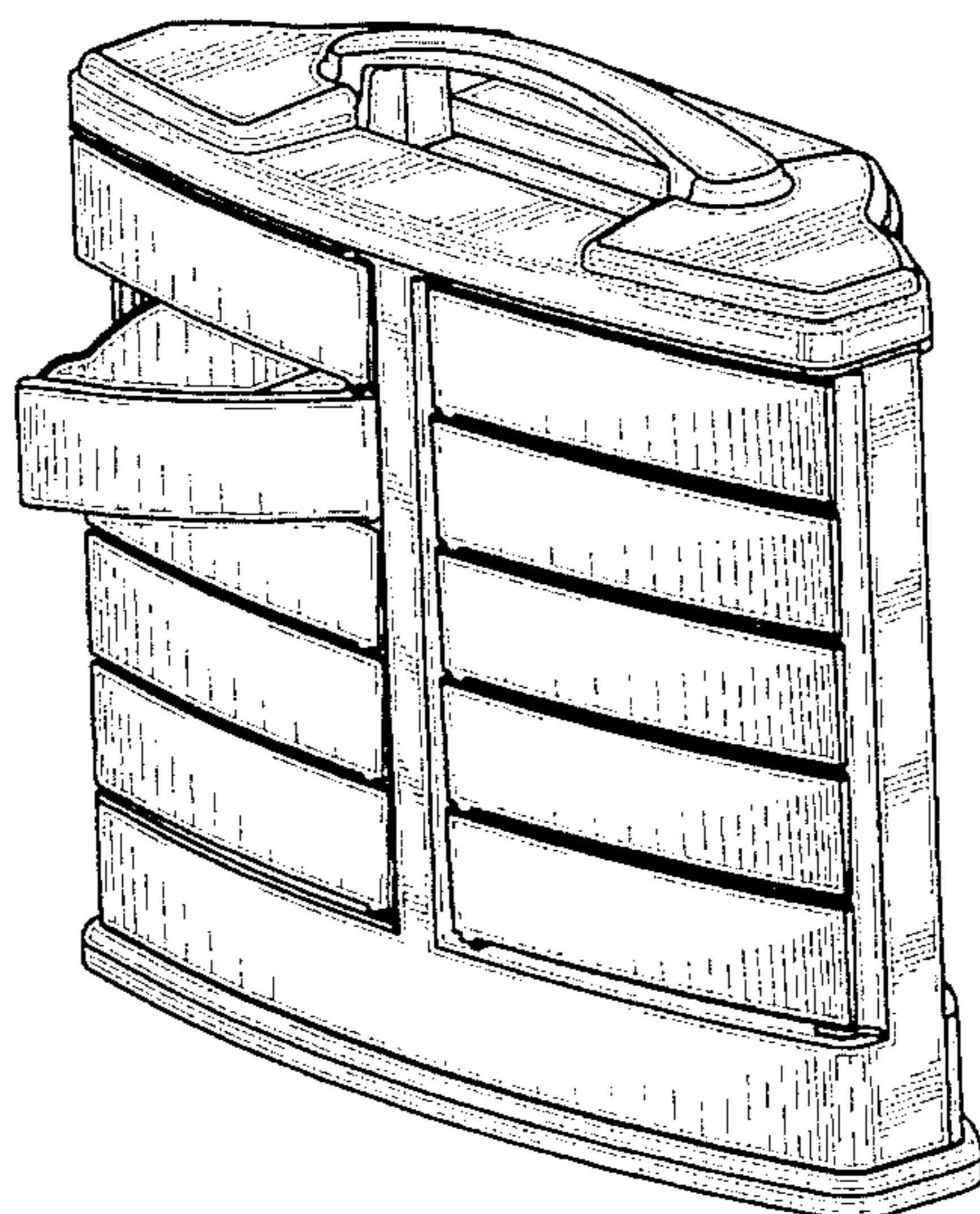

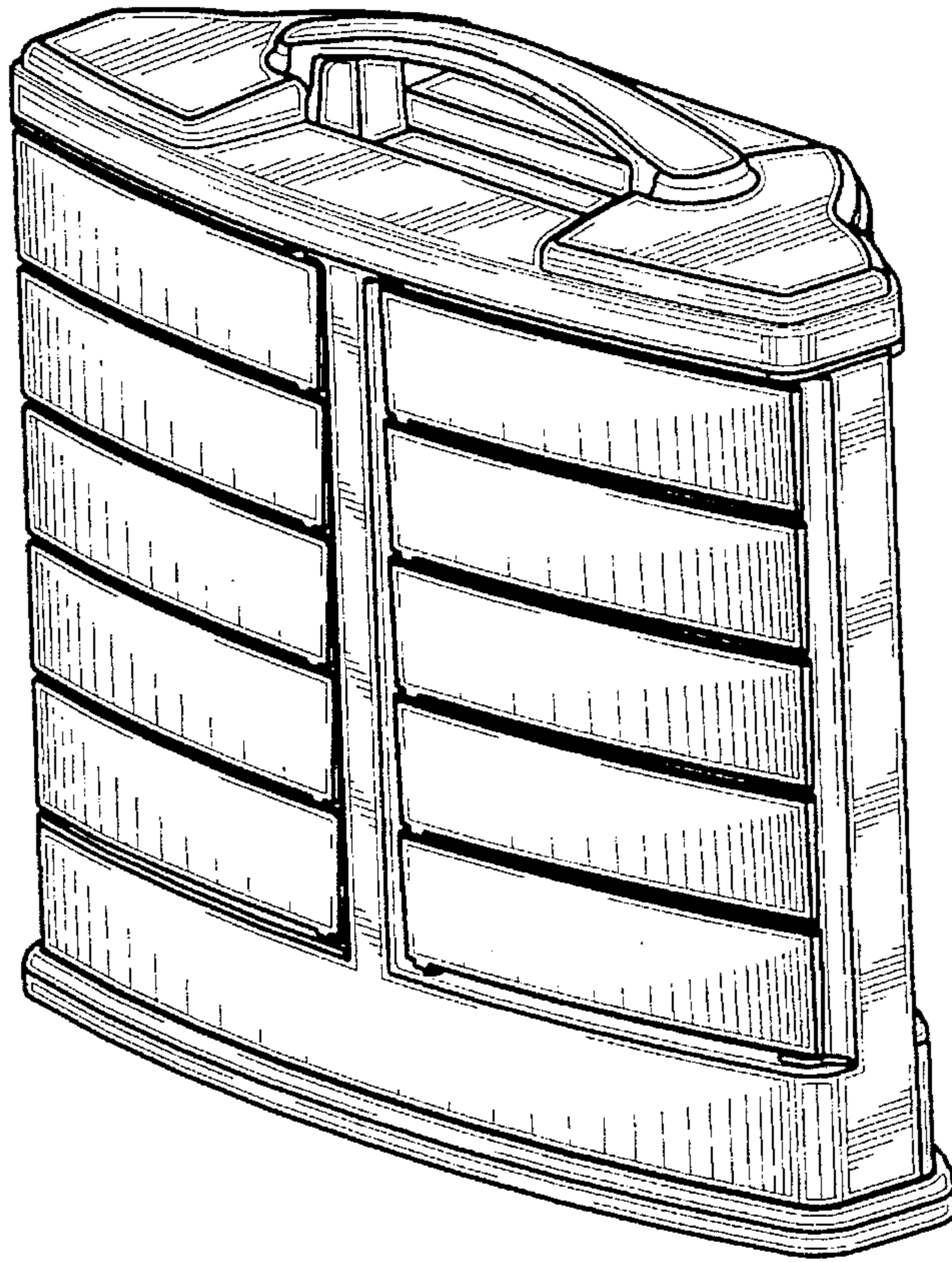

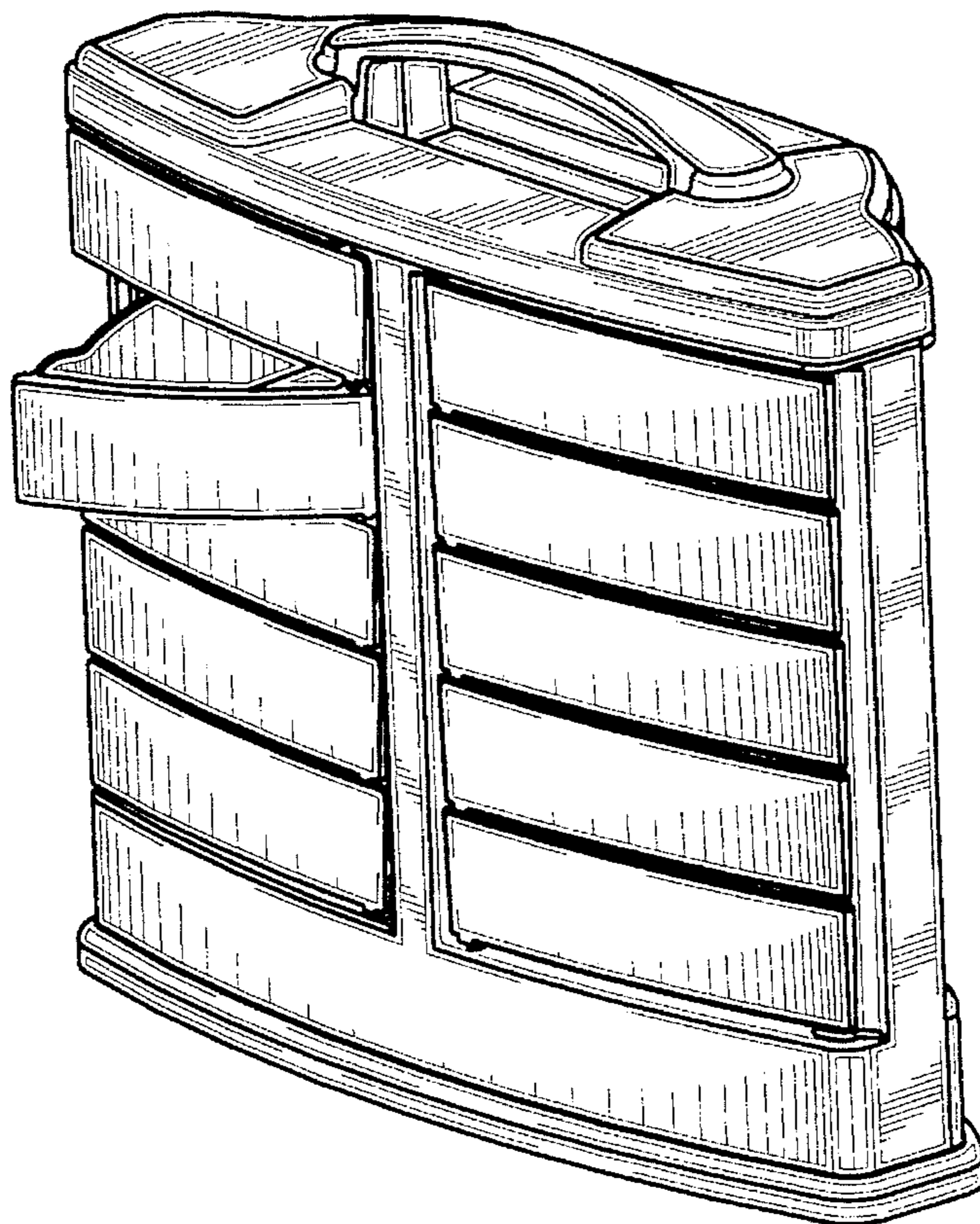

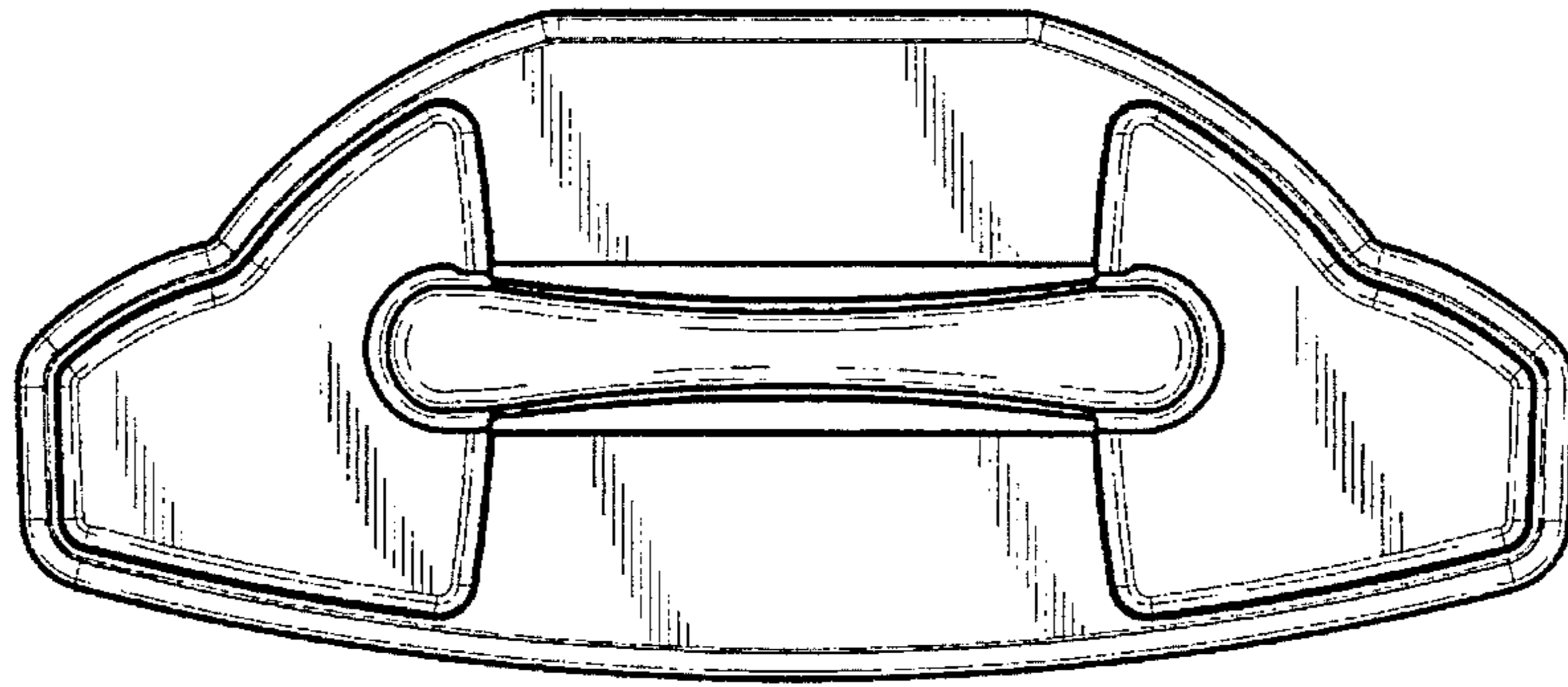

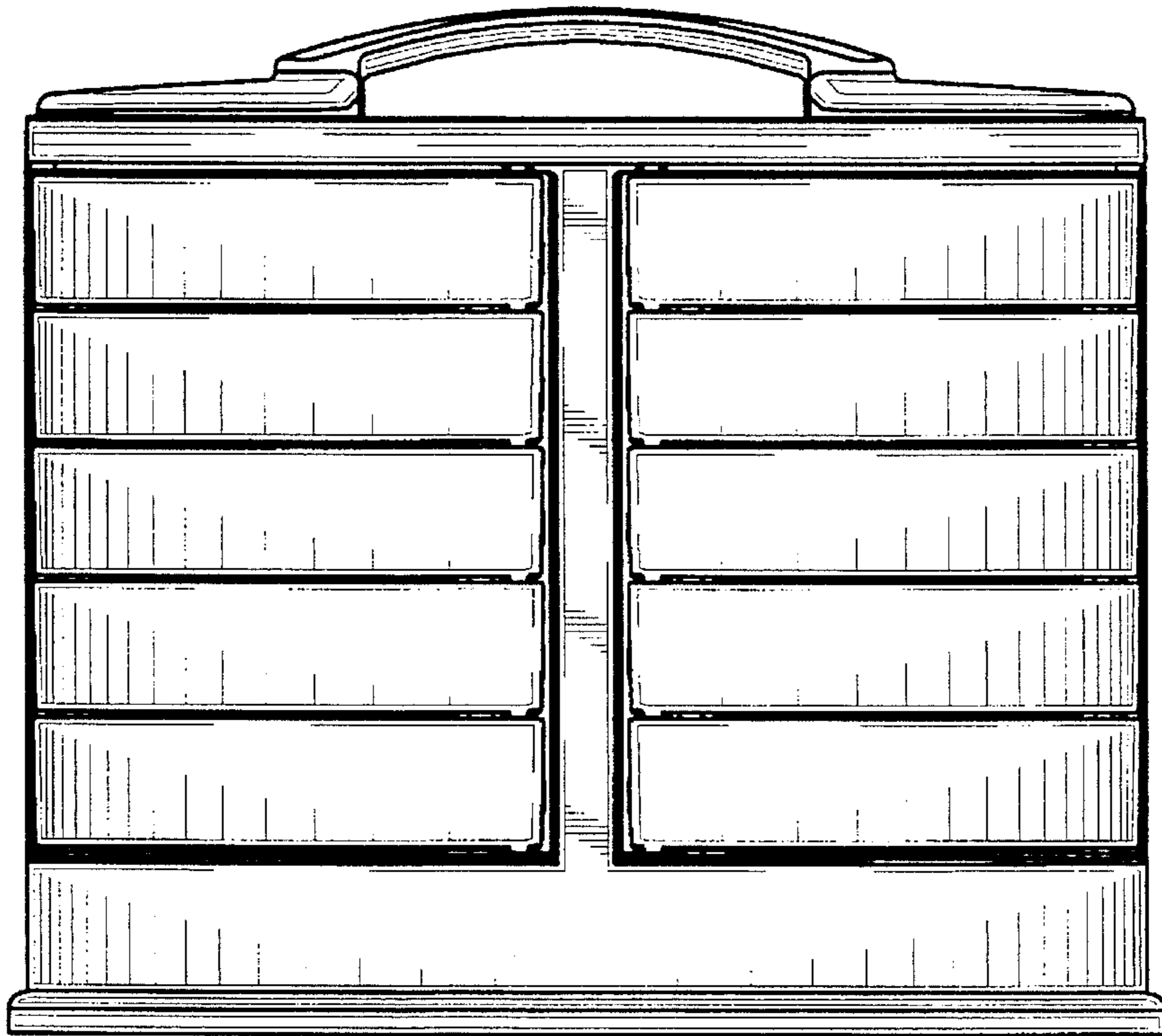

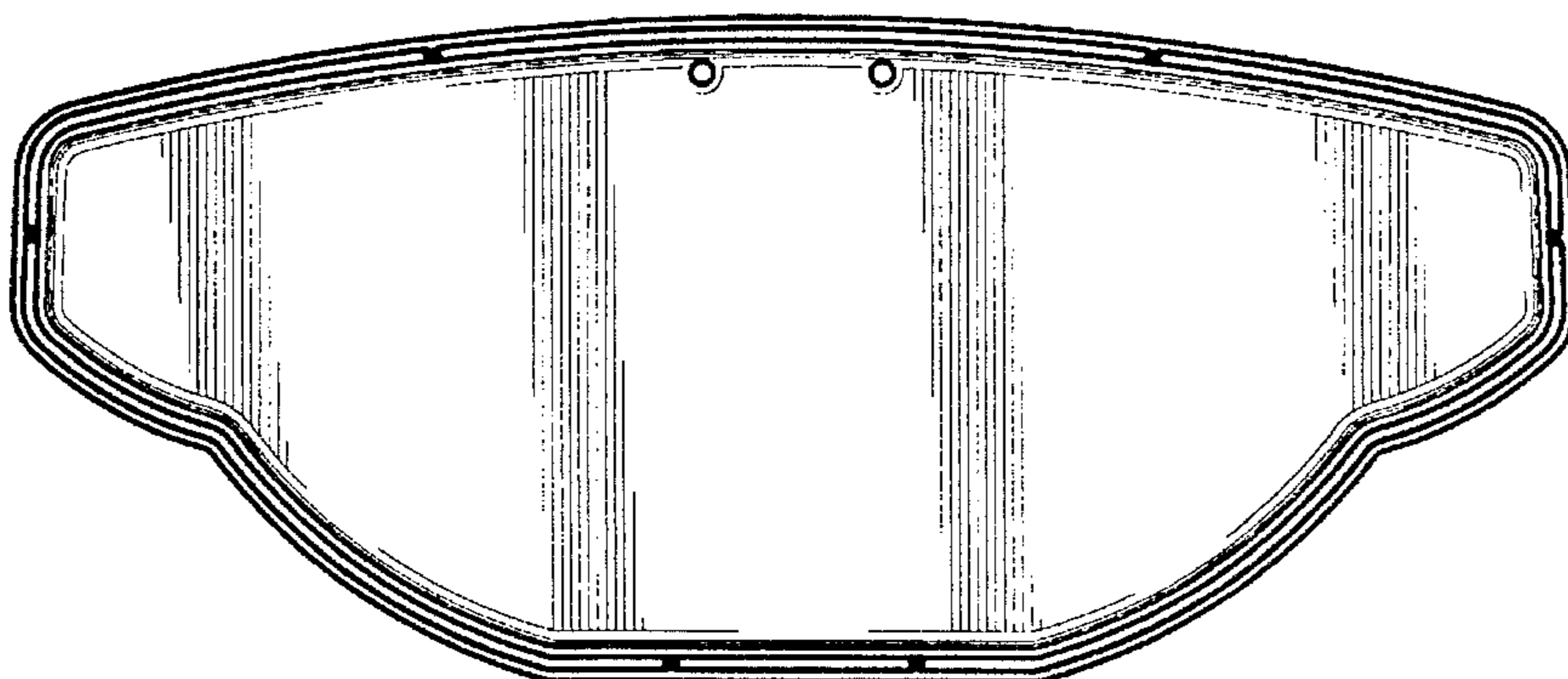

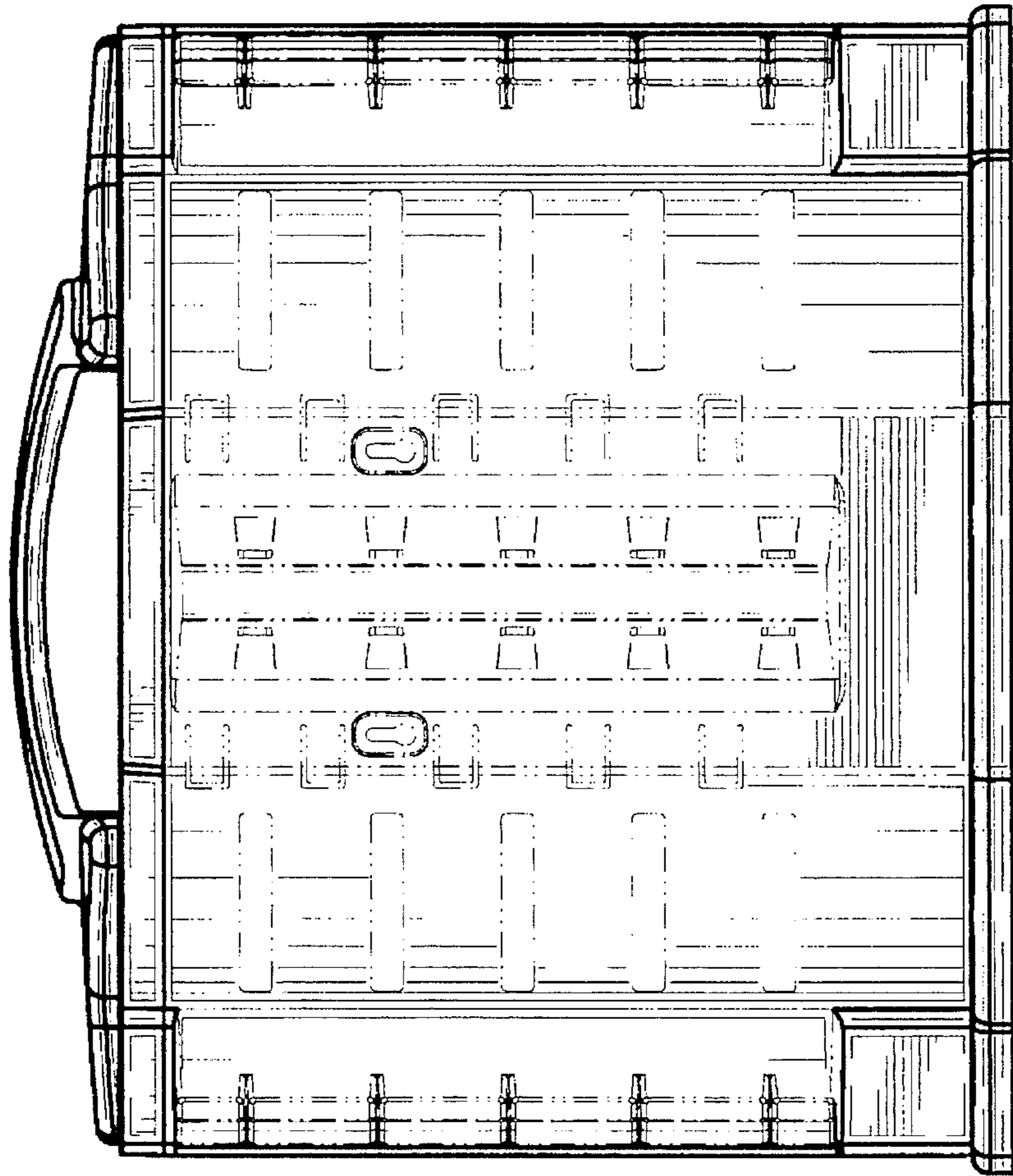

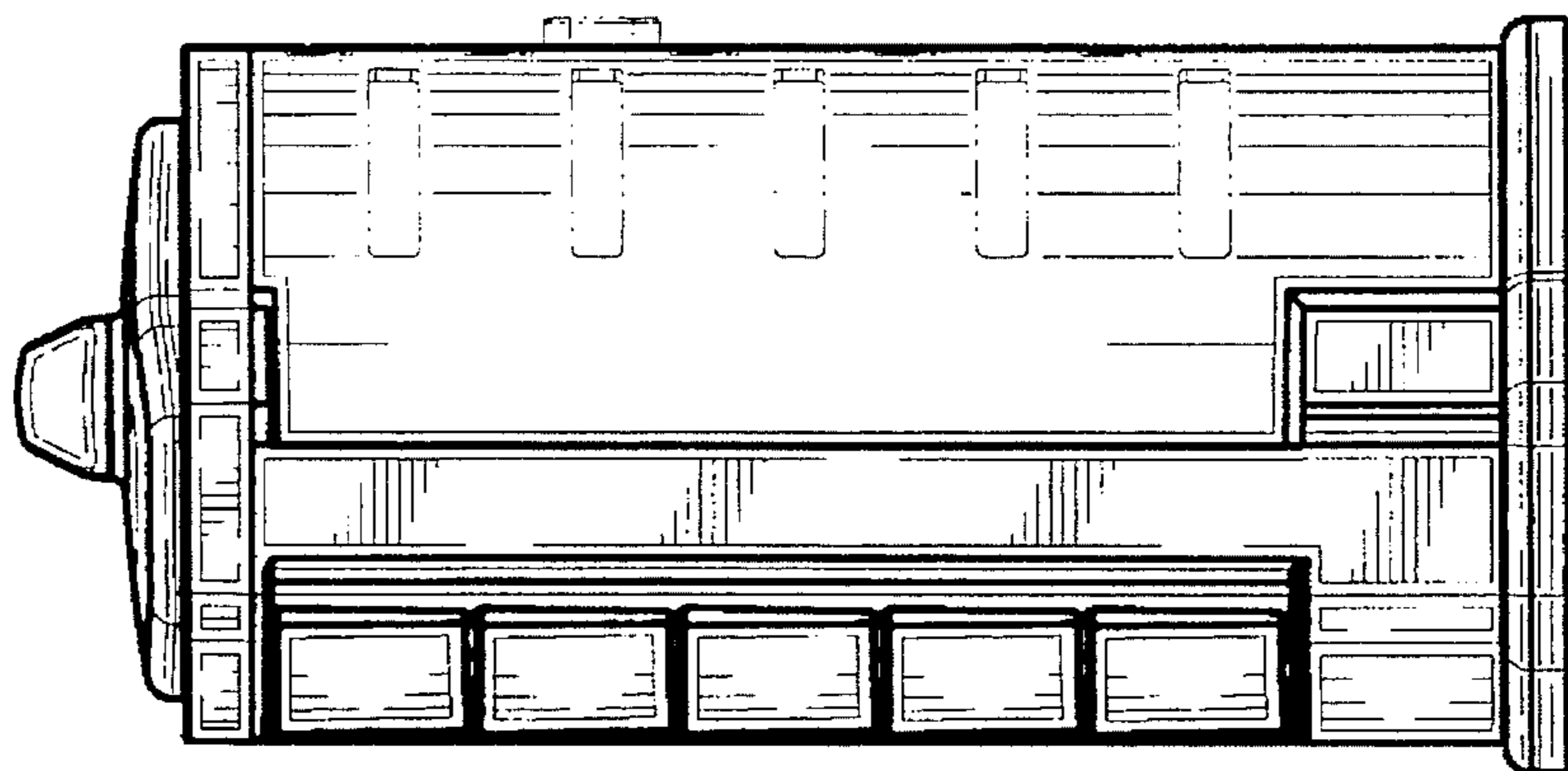

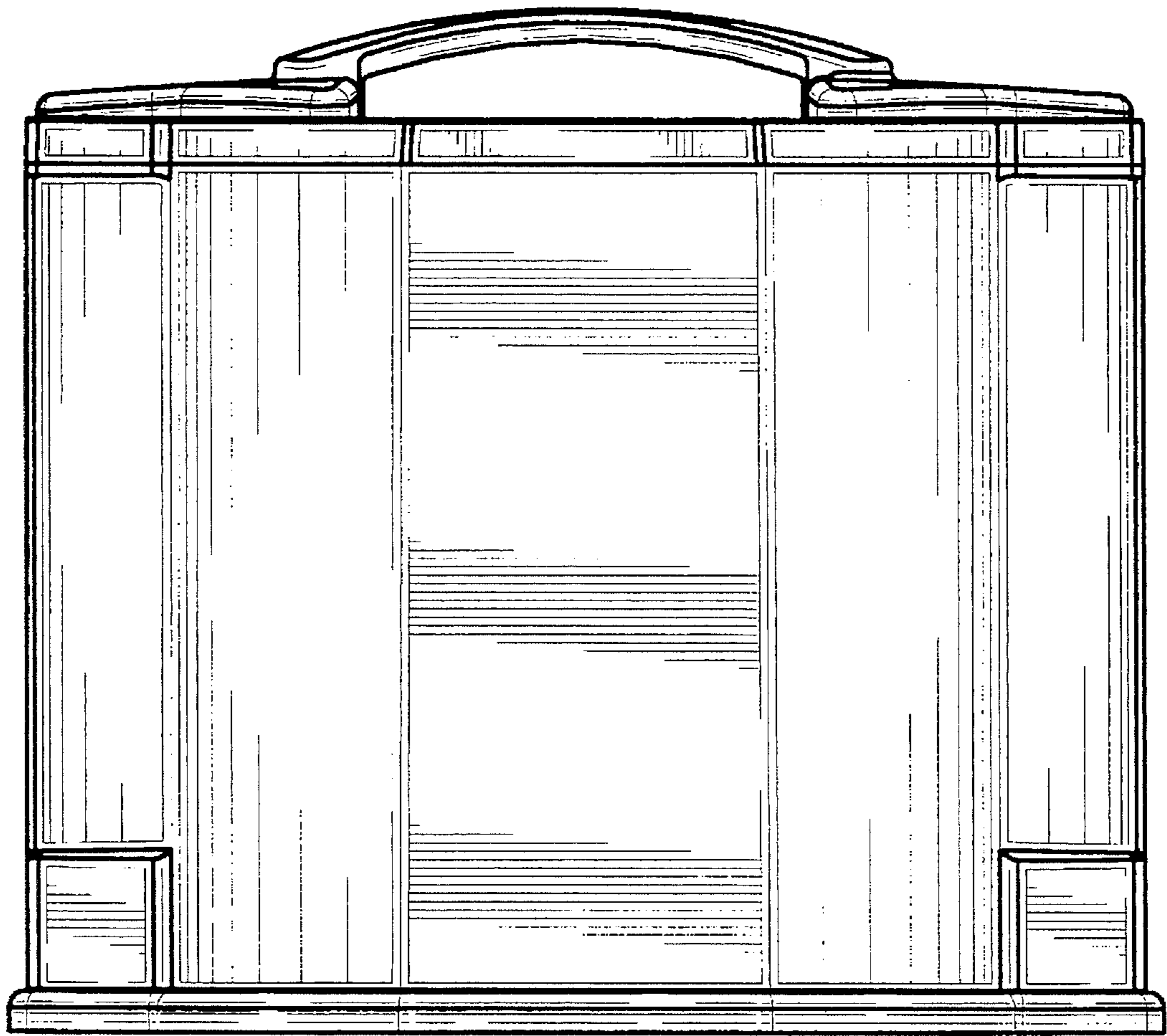
