[57] **CLAIM**  
The ornamental design for a seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and side perspective view of a first embodiment of a seat showing my new design;  
FIG. 2 is a front perspective view thereof;  
FIG. 3 is a side perspective view thereof from the left of FIG. 2, the side perspective view from the right of FIG. 2 being the mirror image thereof;  
FIG. 4 is a rear perspective view thereof;  
FIG. 5 is a top perspective view thereof;  
FIG. 6 is a bottom perspective view thereof;  
FIG. 7 is a view similar to FIG. 1 but showing the same with a loose cover;  
FIG. 8 is a view similar to FIG. 7, but showing a modified embodiment thereof;  
FIG. 9 is a front perspective view of the embodiment of FIG. 8;  
FIG. 10 is a side perspective view thereof from the right of FIG. 9, the side perspective view from the left of FIG. 9 being the mirror image of FIG. 10;  
FIG. 11 is a rear perspective view thereof;  
FIG. 12 is a top perspective view thereof;  
FIG. 13 is a bottom perspective view thereof; and,  
FIG. 14 is a view similar to FIG. 10 but showing the same in an alternate position.

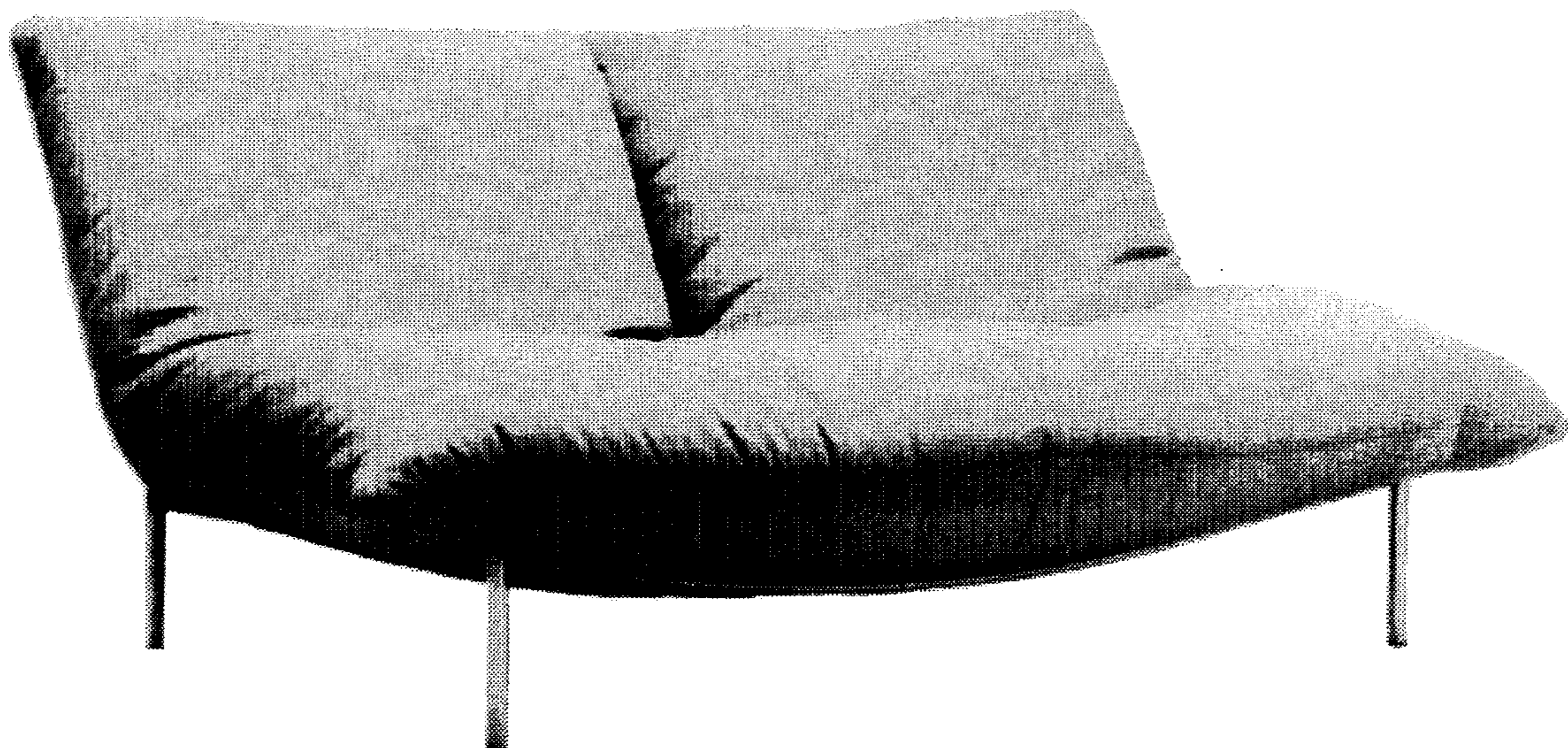
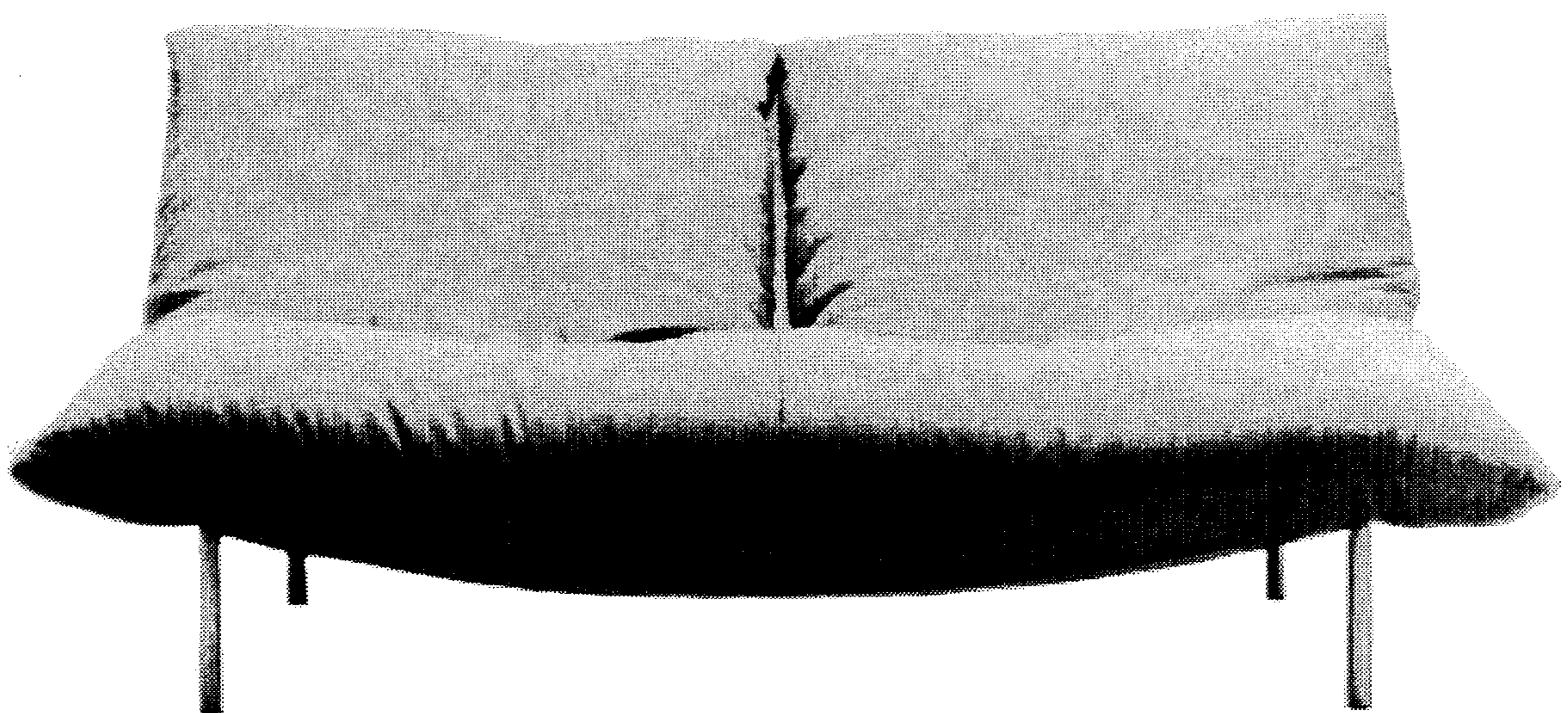

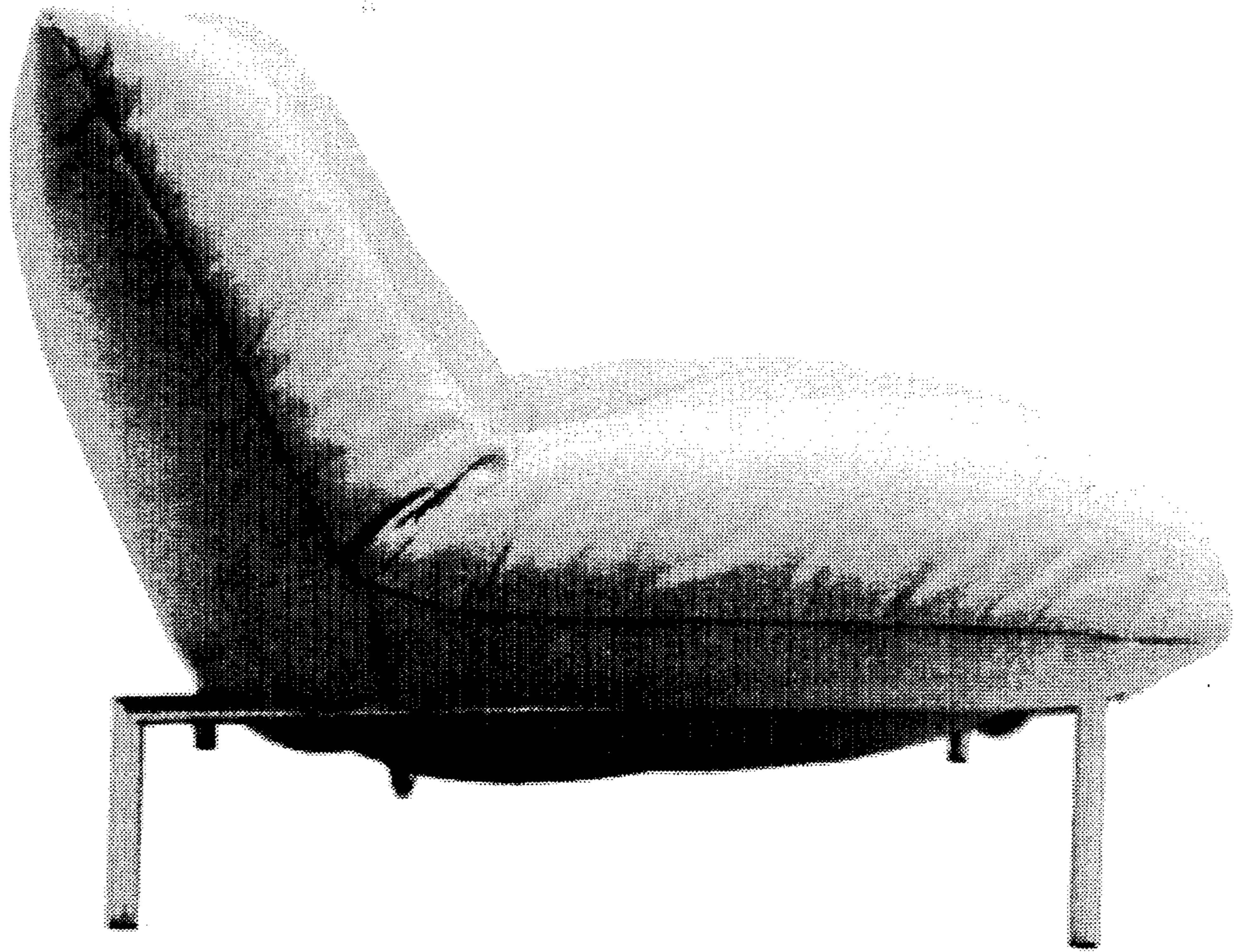
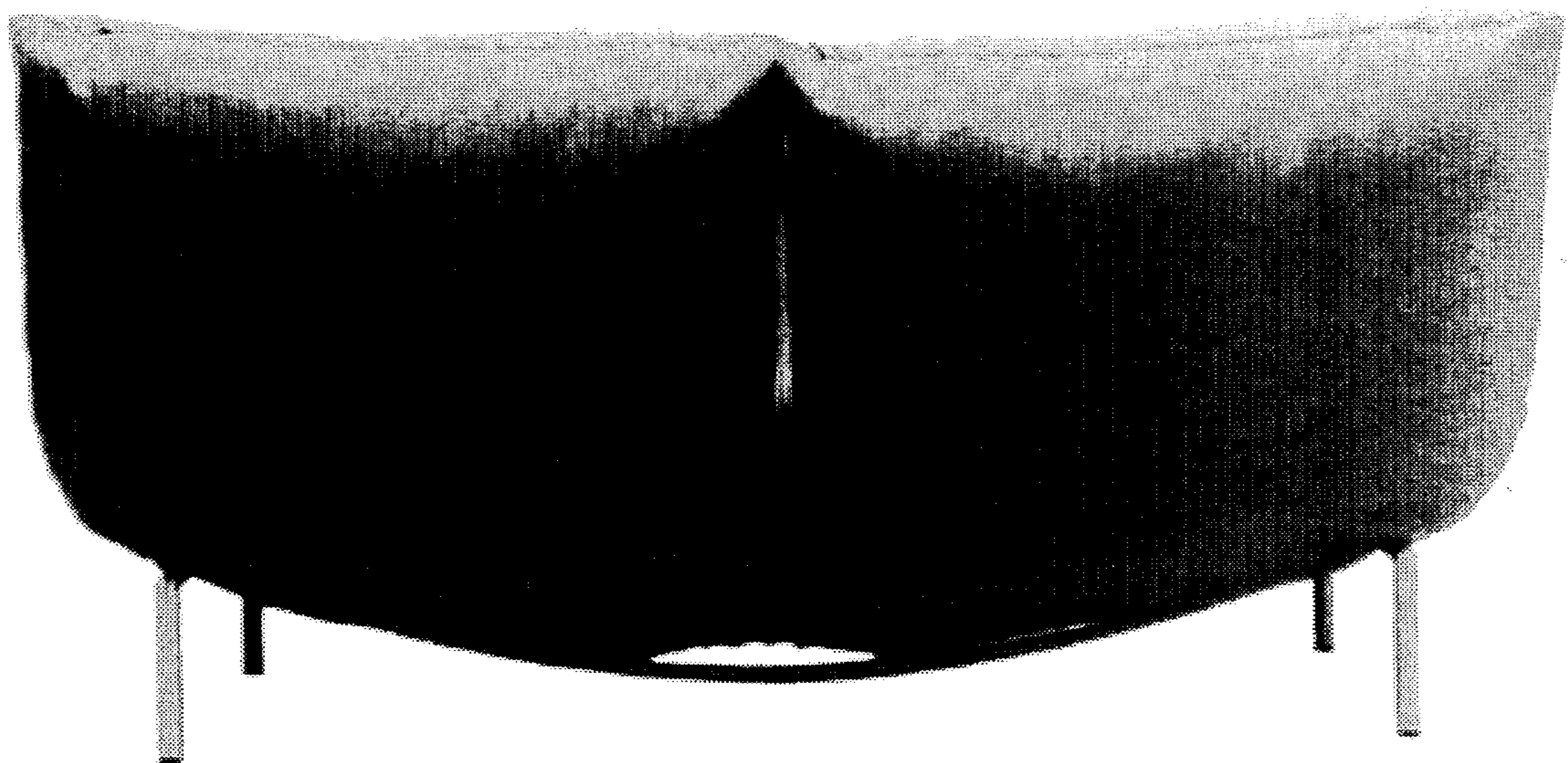

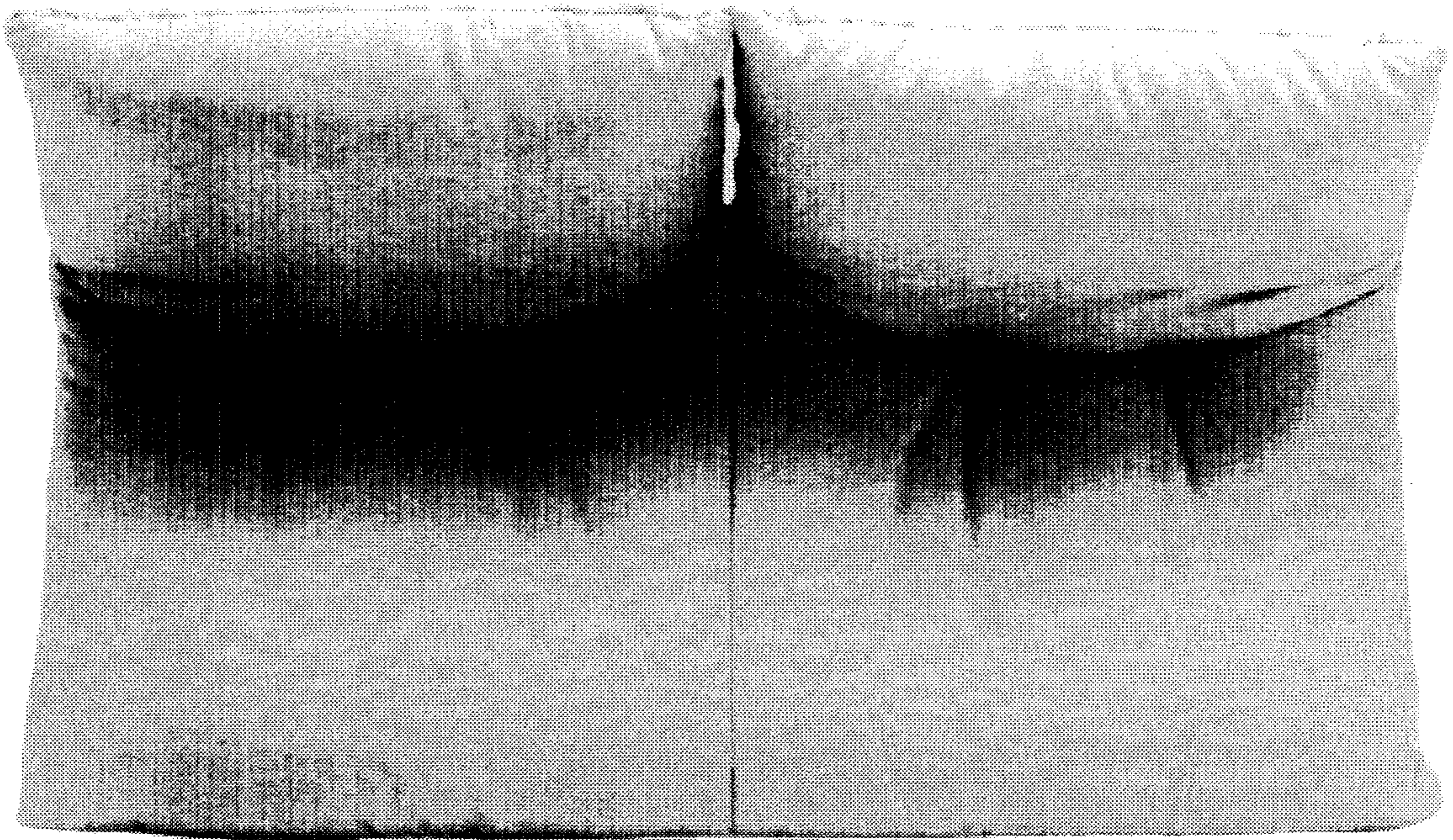
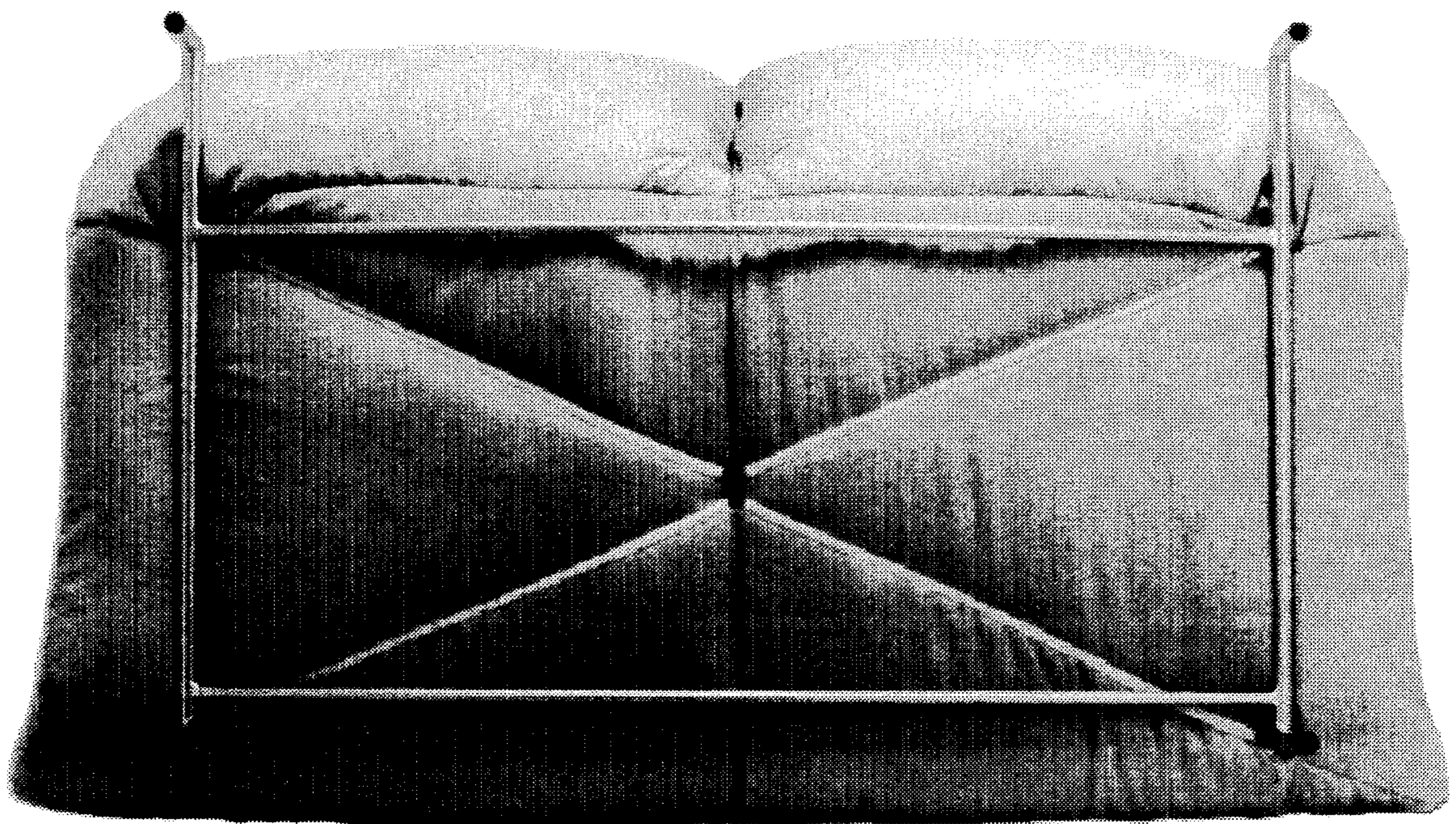

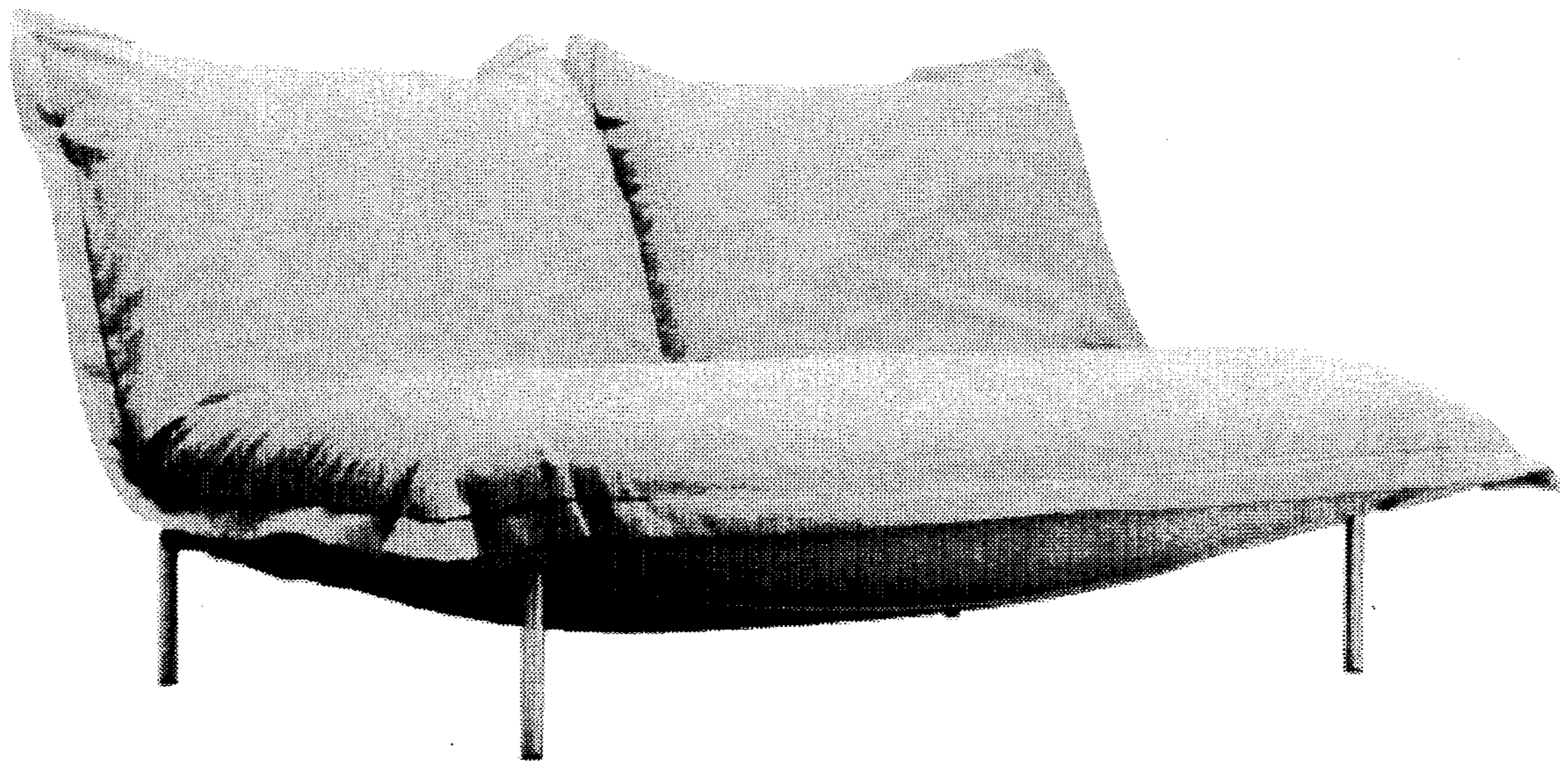
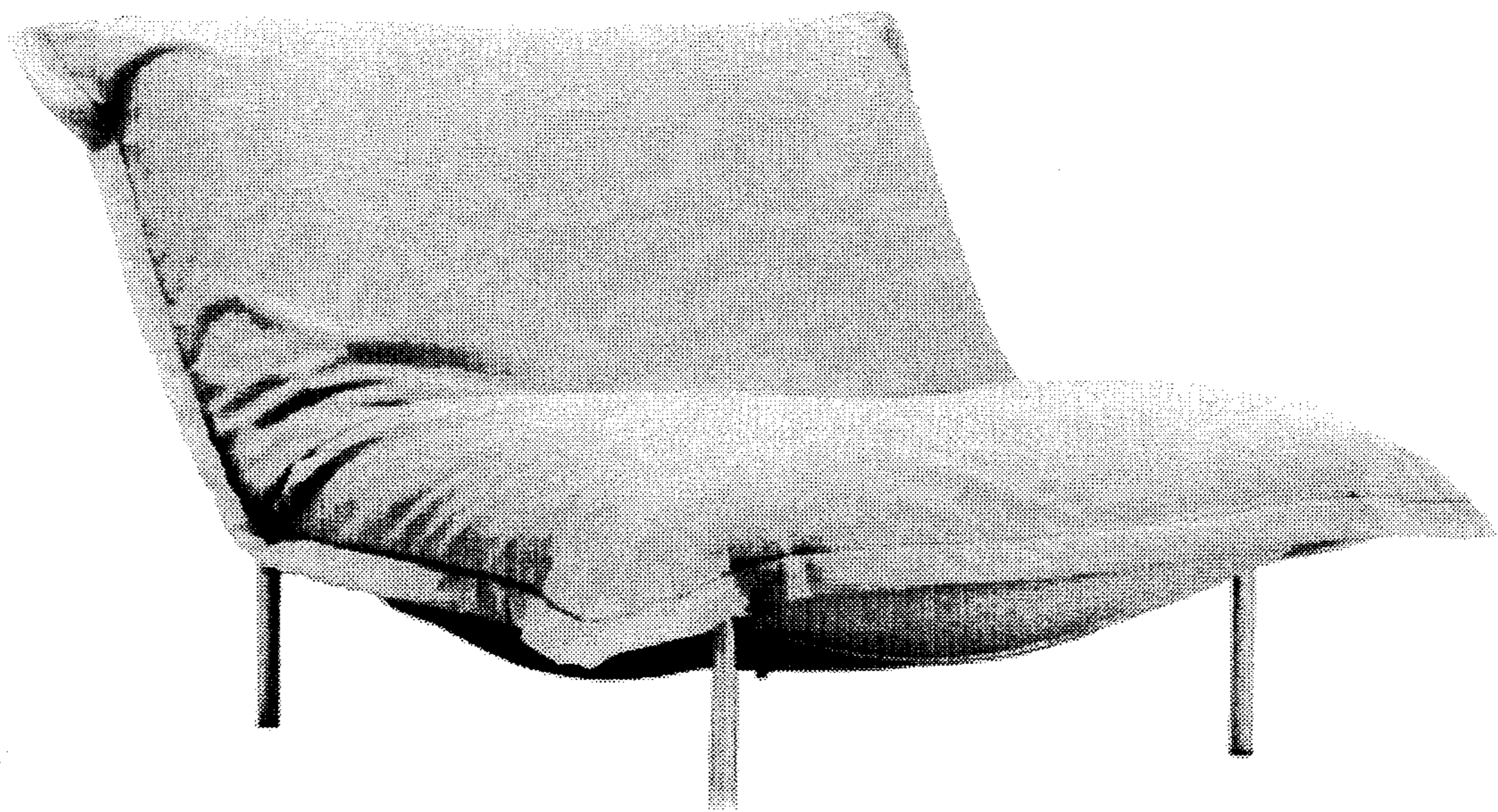

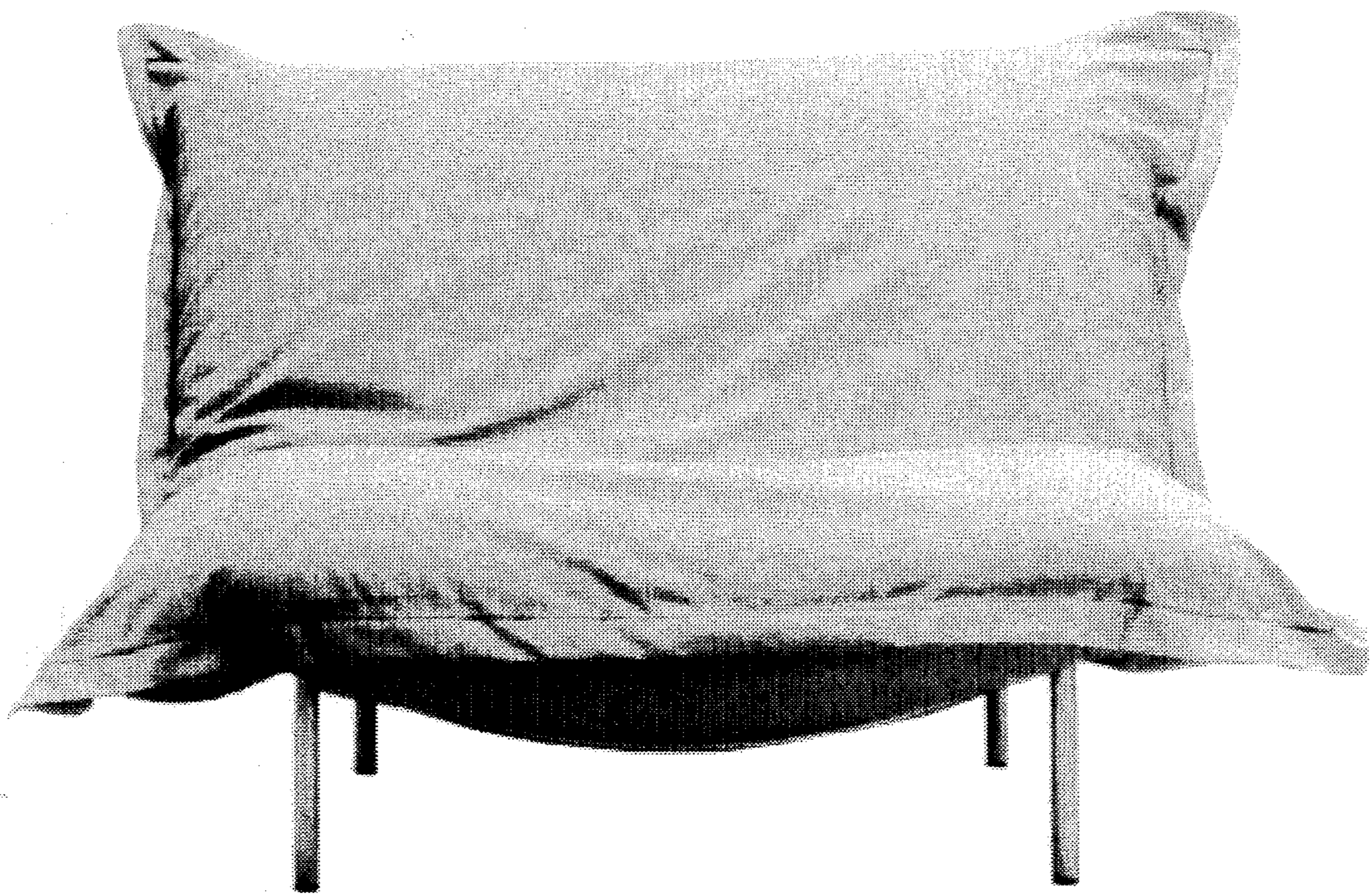
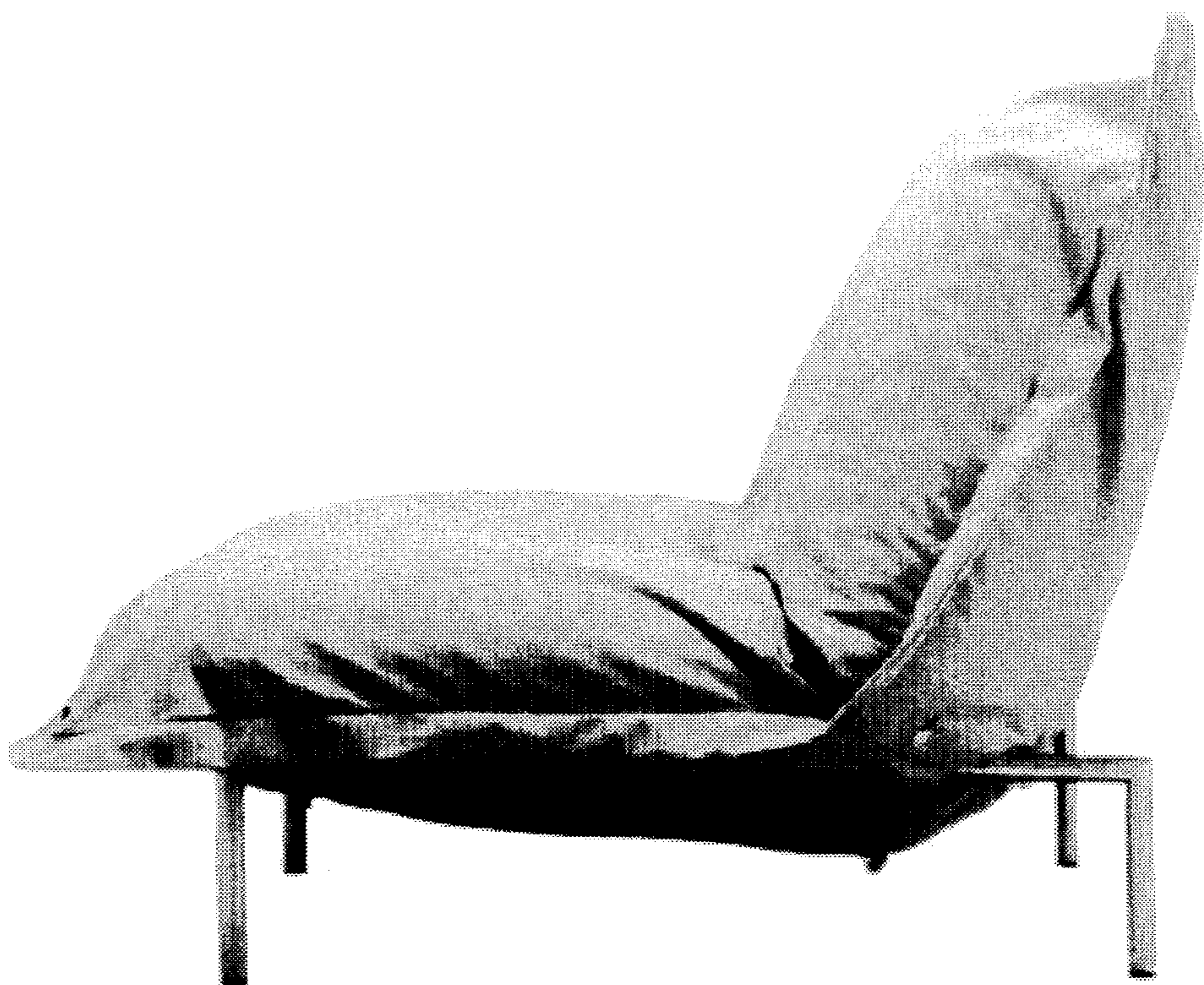

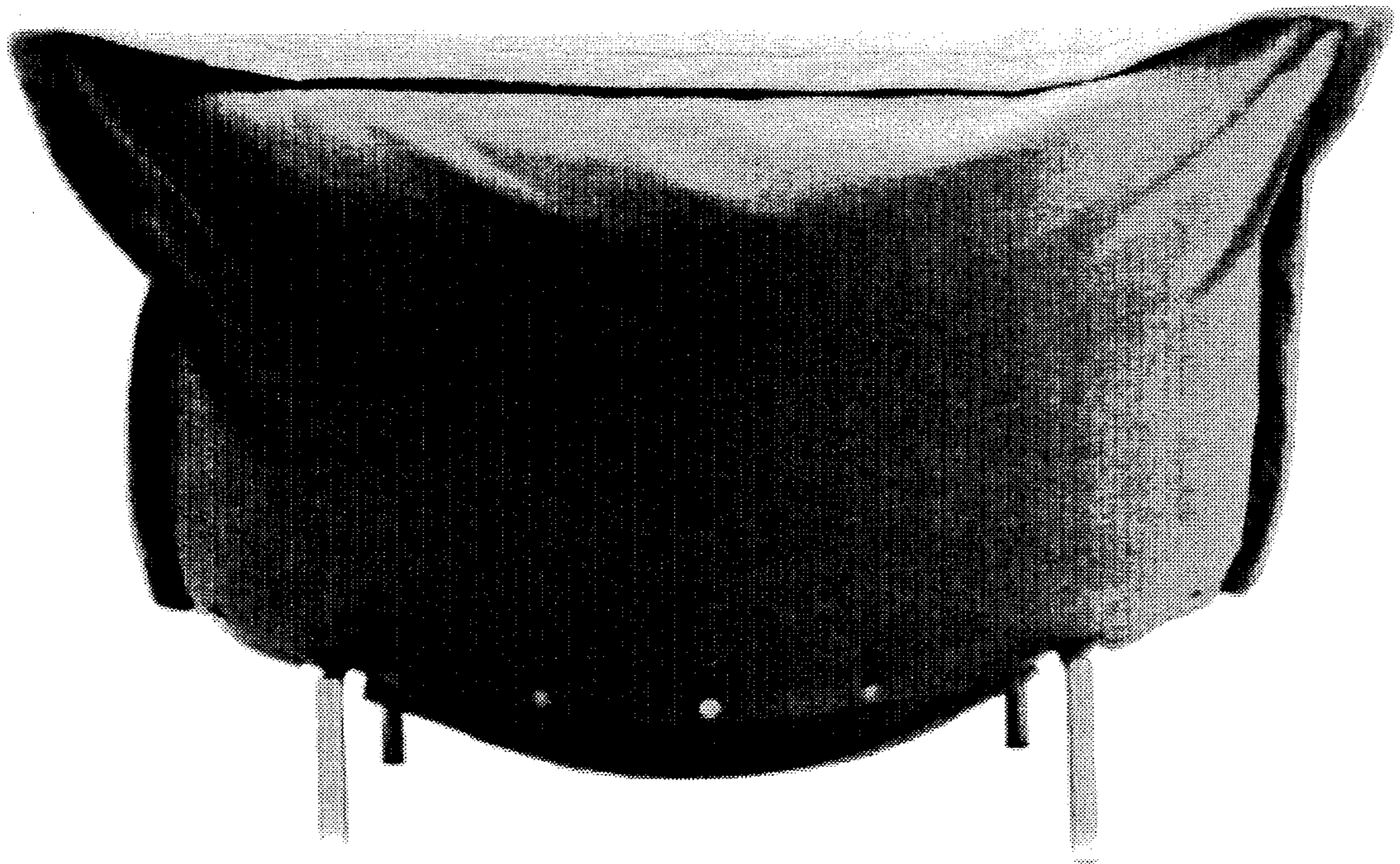
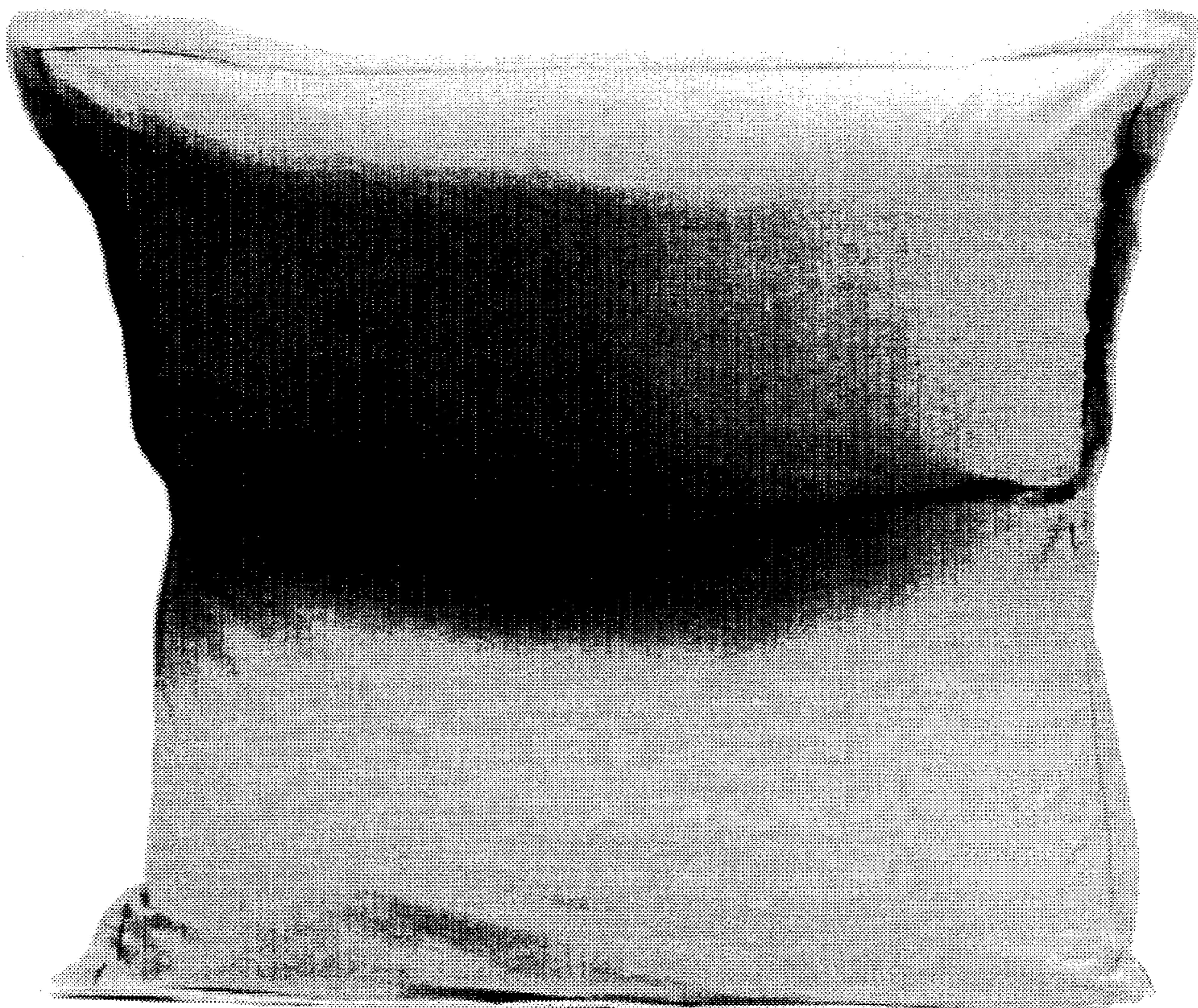

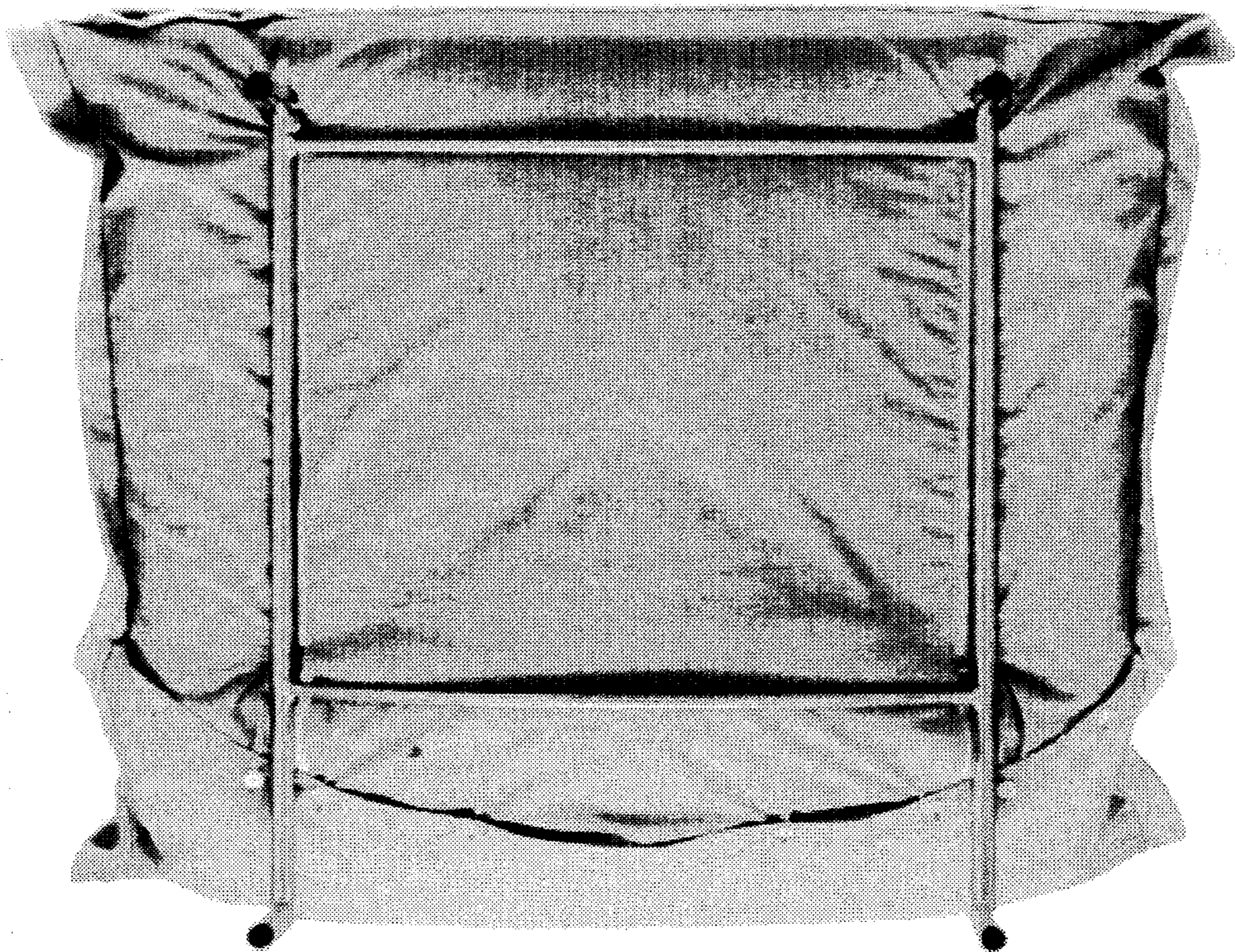
