The ornamental design for a toy ride-in truck, as shown and described.

### DESCRIPTION

FIG. 1 is a top left front perspective view of a toy ride-in truck showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof; the right side elevational view being a mirror image;

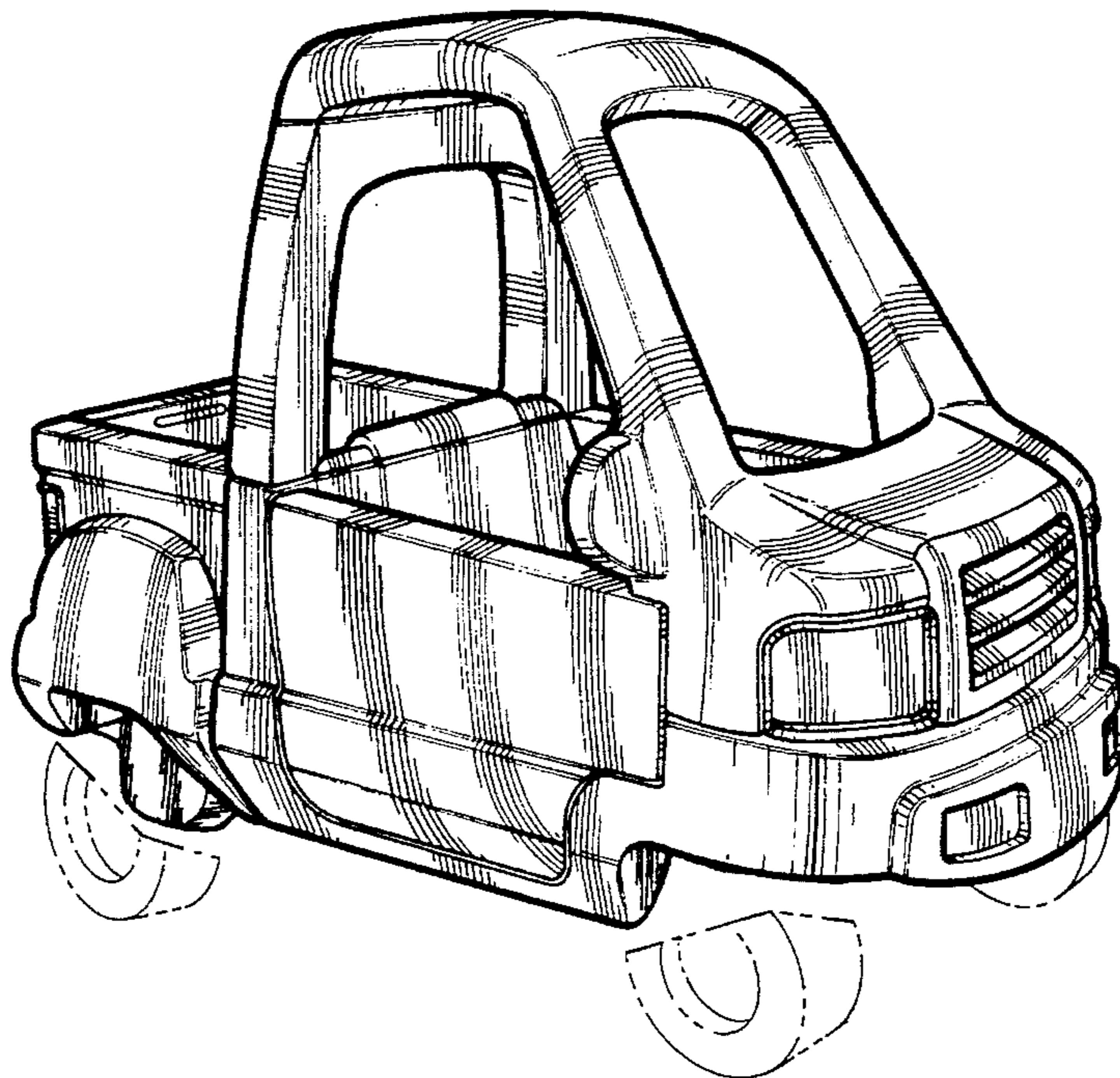
FIG. 4 is a bottom plan view thereof;

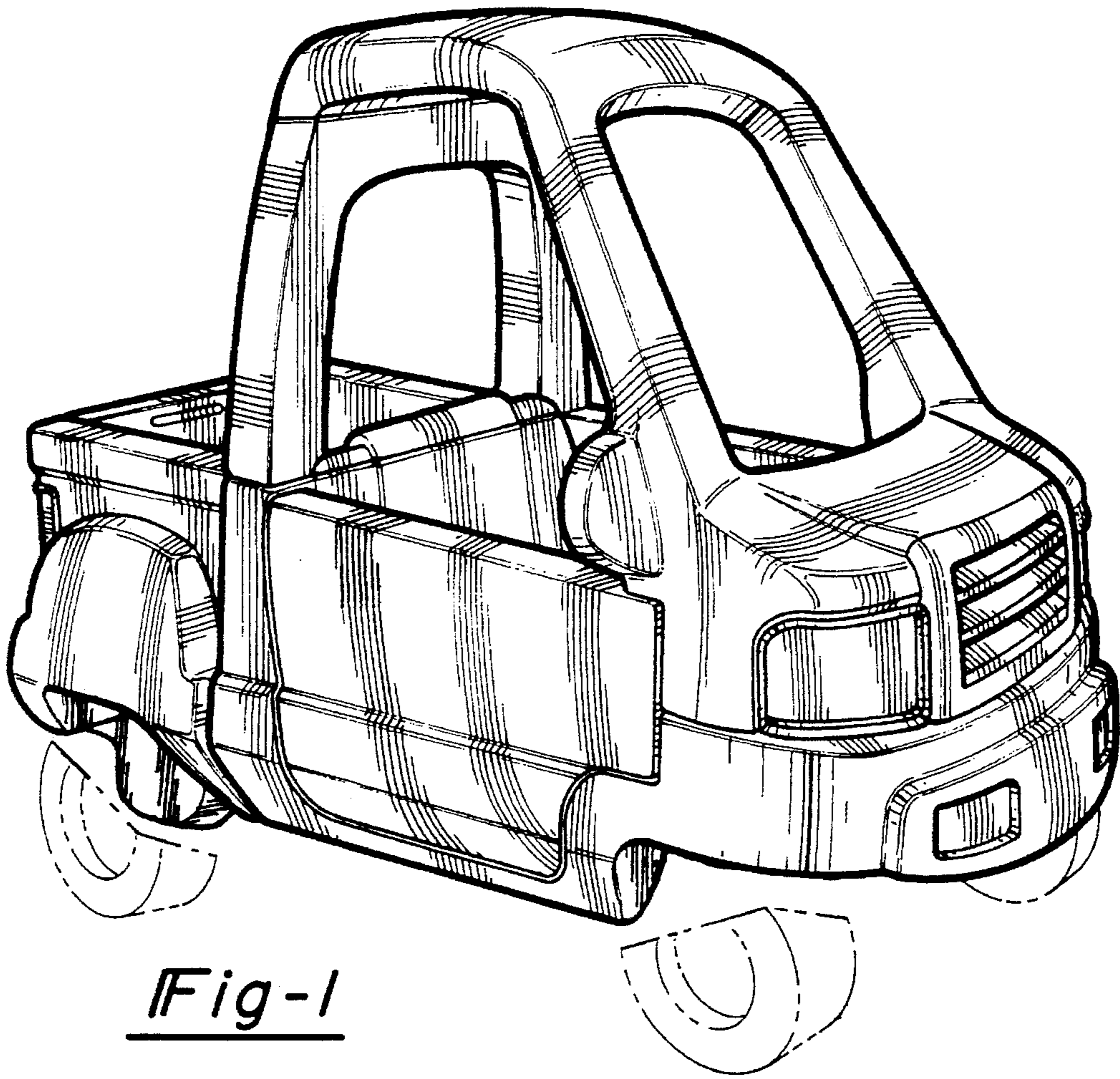

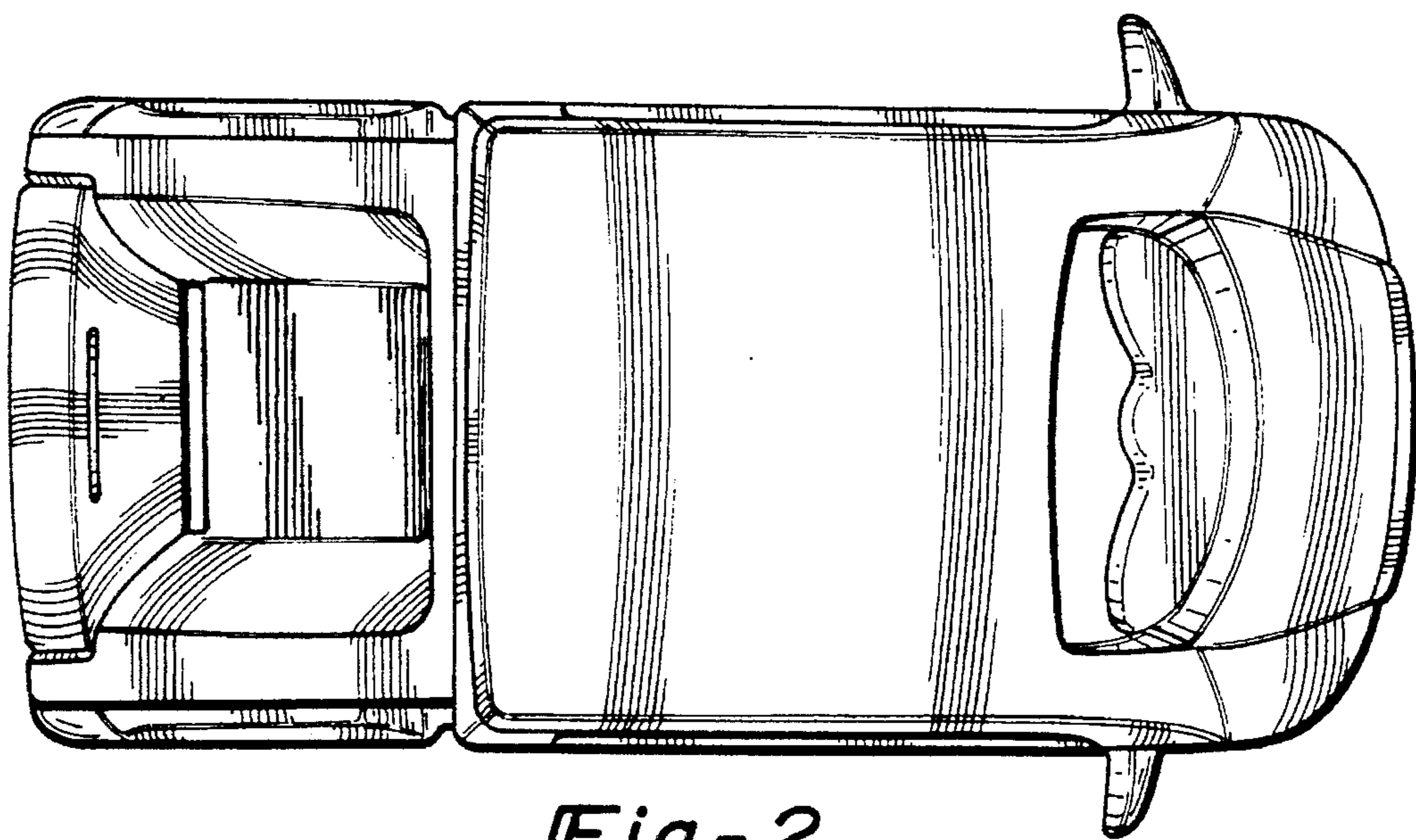

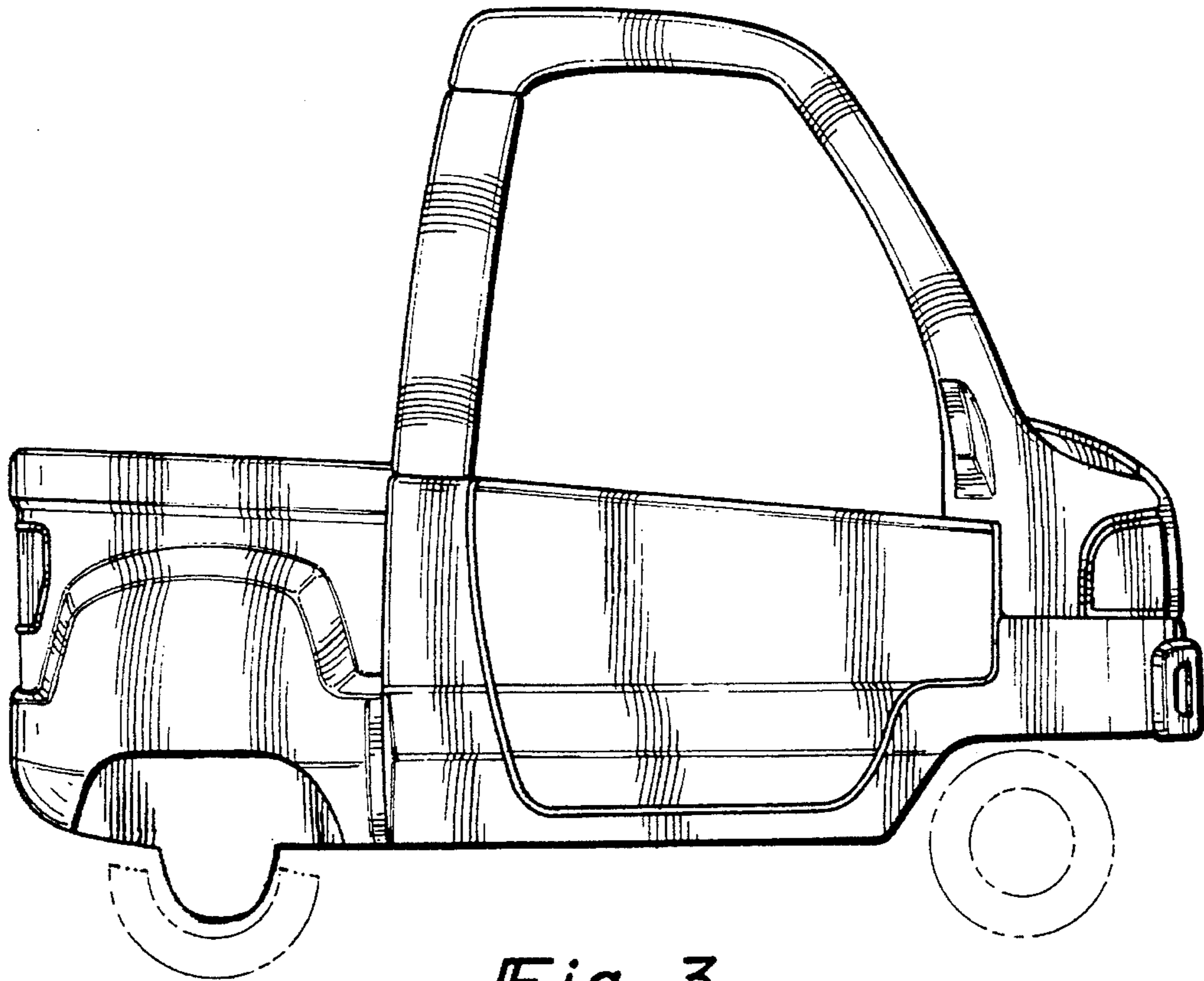

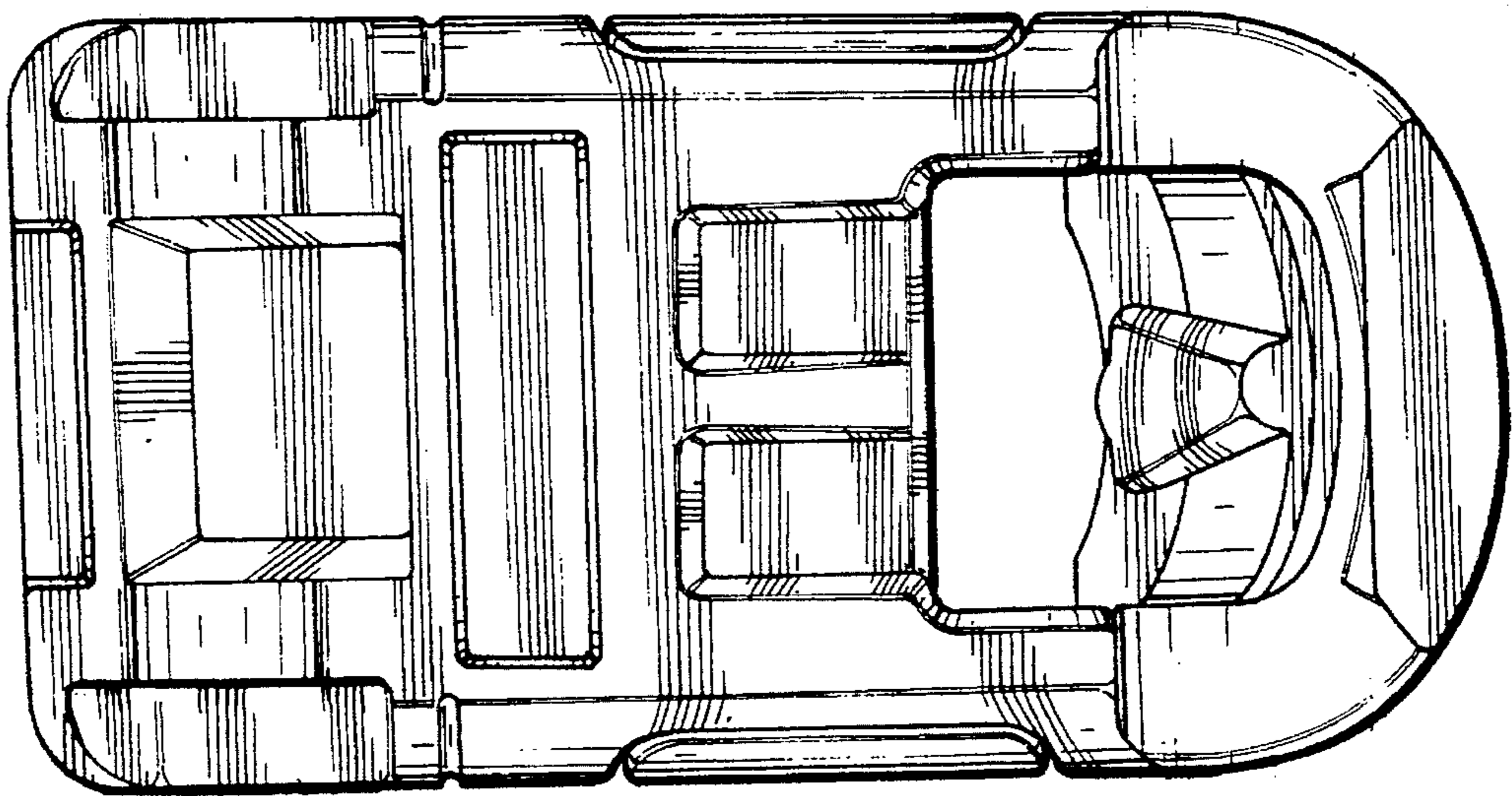

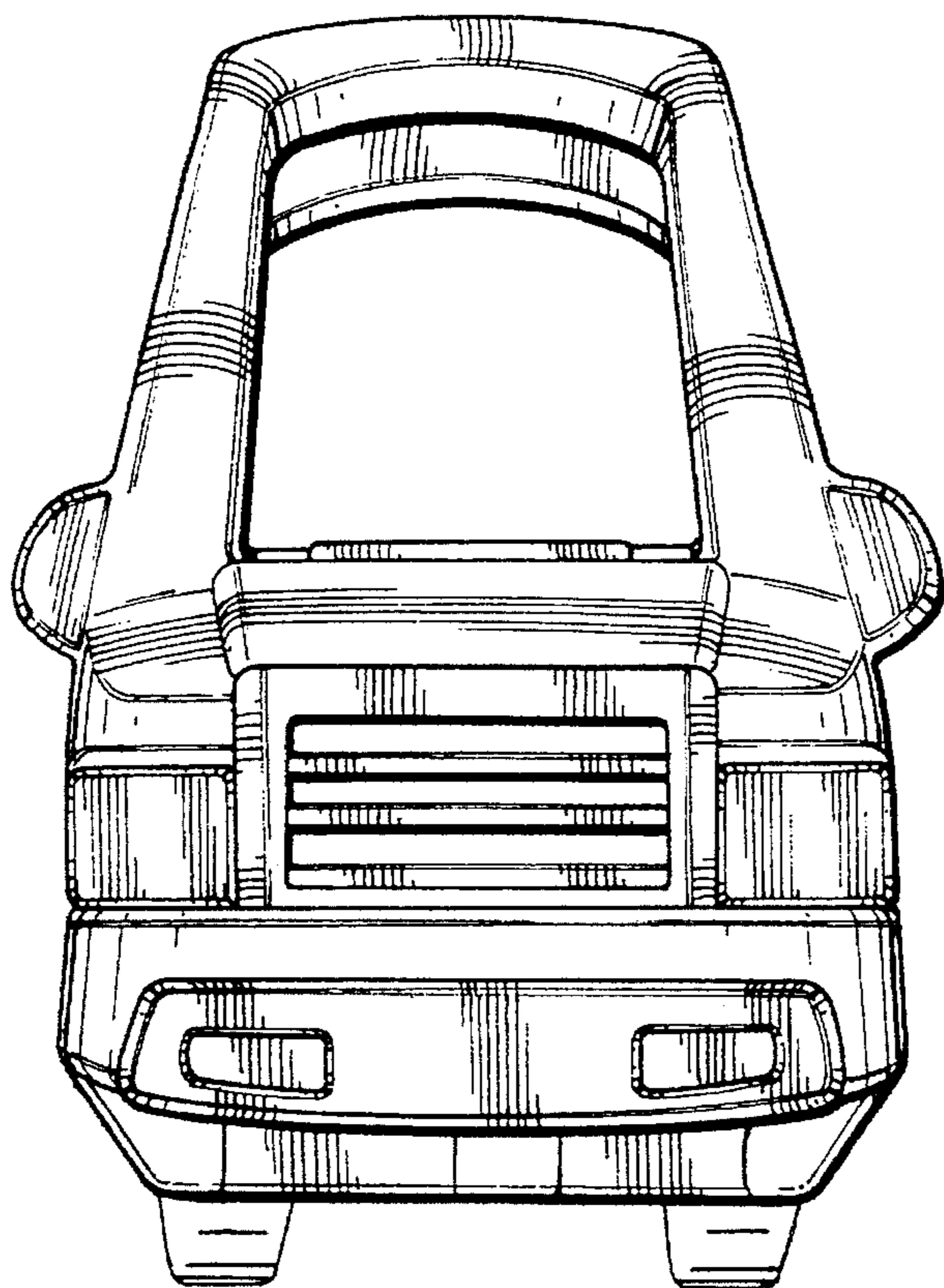

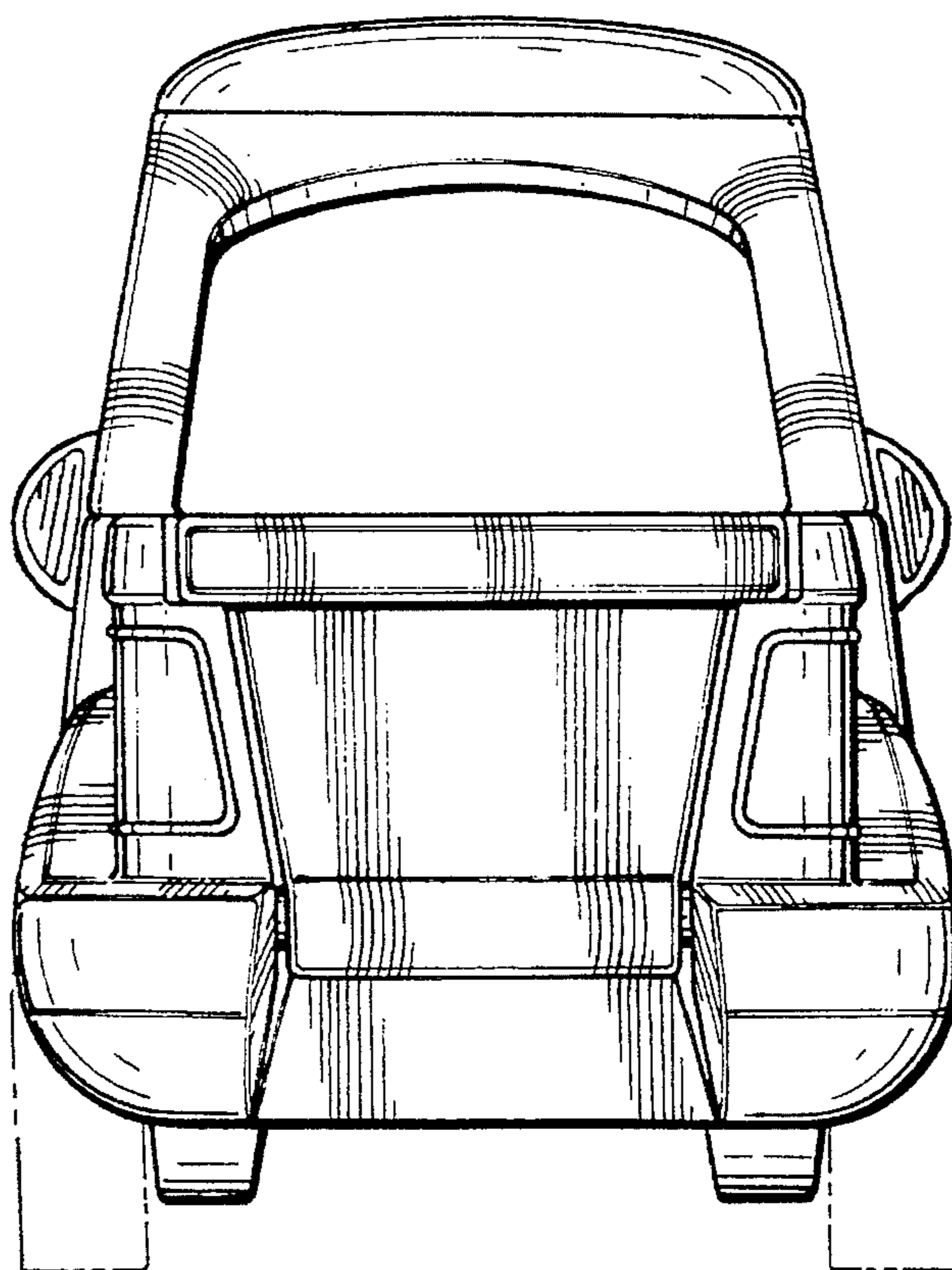
