## **DESCRIPTION**

FIG. 16 is a top plan view of a fourth embodiment showing my new design;

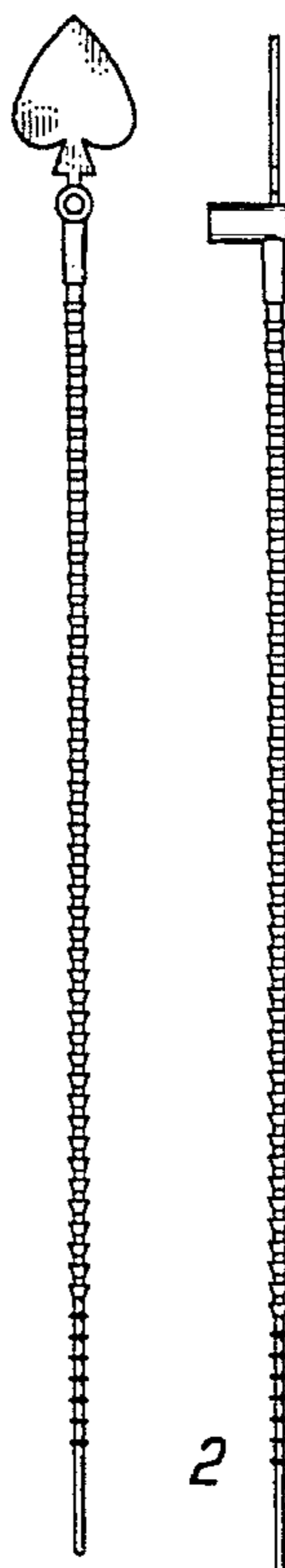
FIG. 17 is a right side elevational view, the left side elevational view being a mirror image thereof;

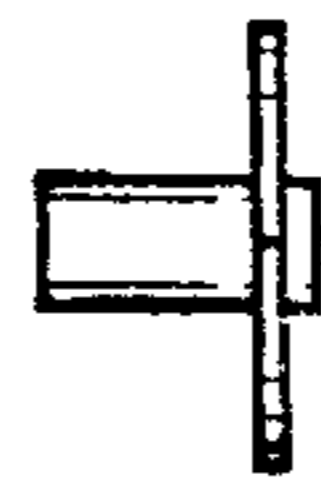

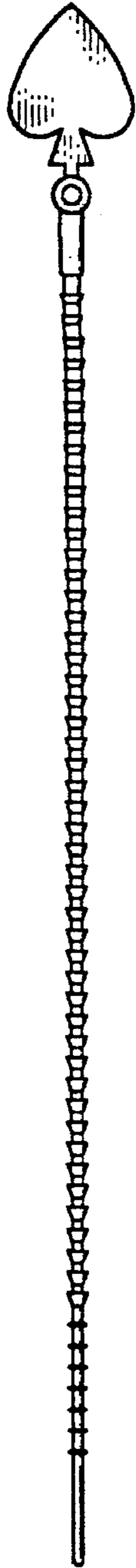

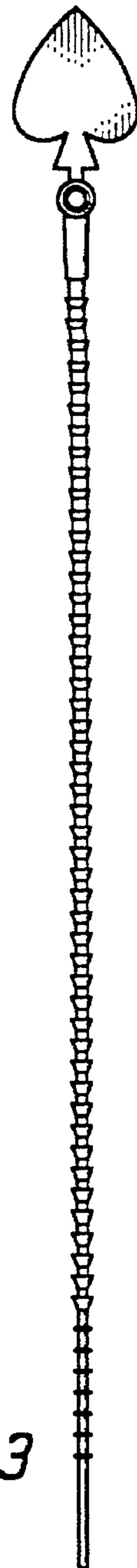

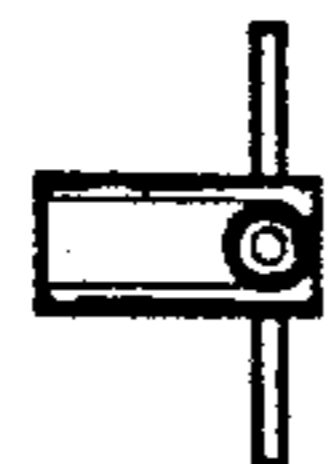

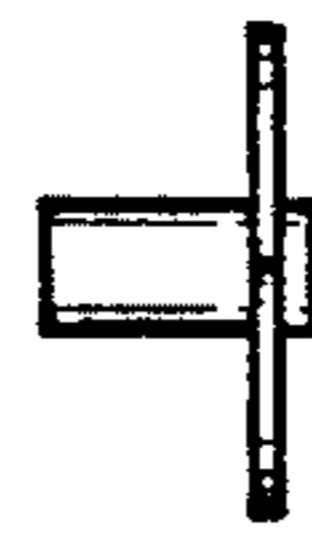

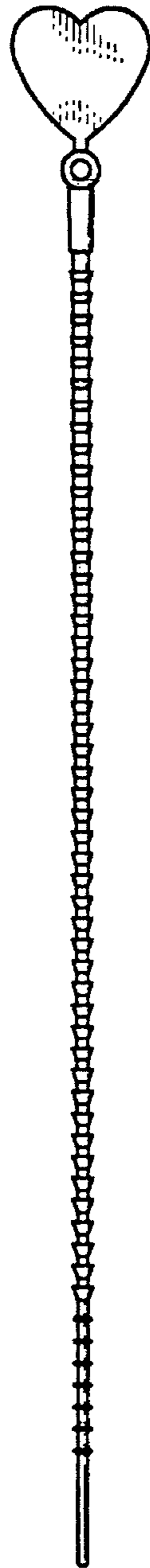

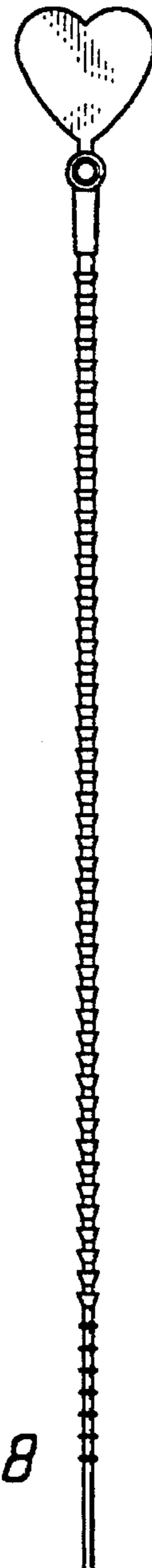

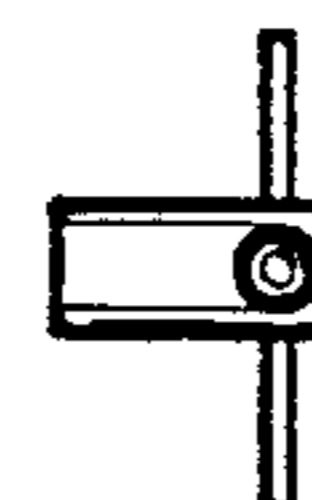

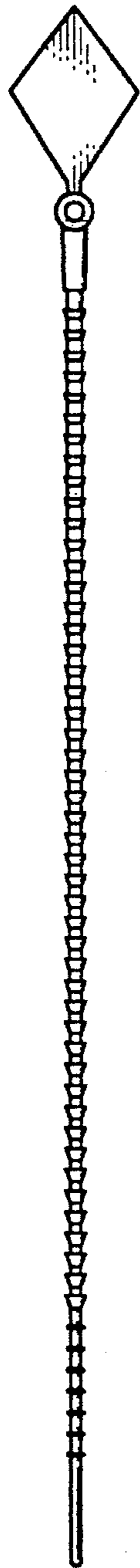

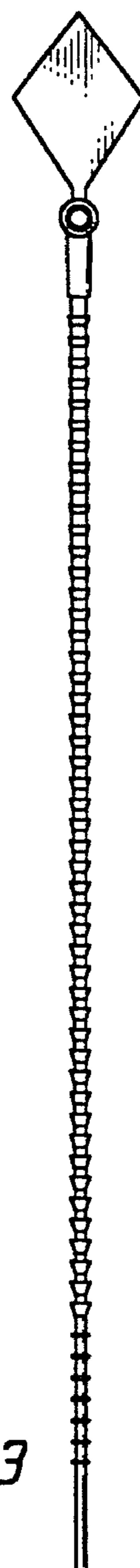

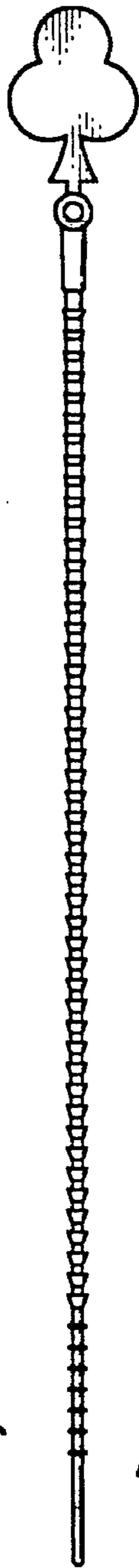

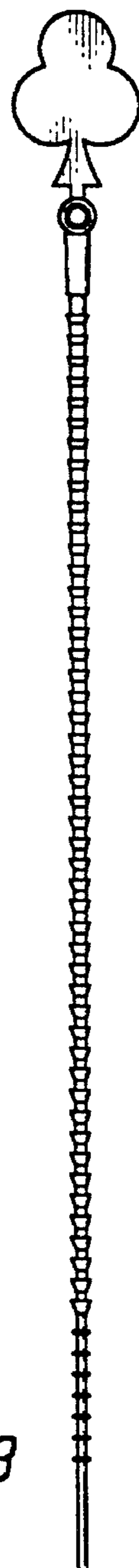
