[57] **CLAIM**

The ornamental design for a book cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the interior of the book cover in a fully opened position;

FIG. 2 is a front elevational view of the exterior thereof;

FIG. 3 is an enlarged top plan view thereof;

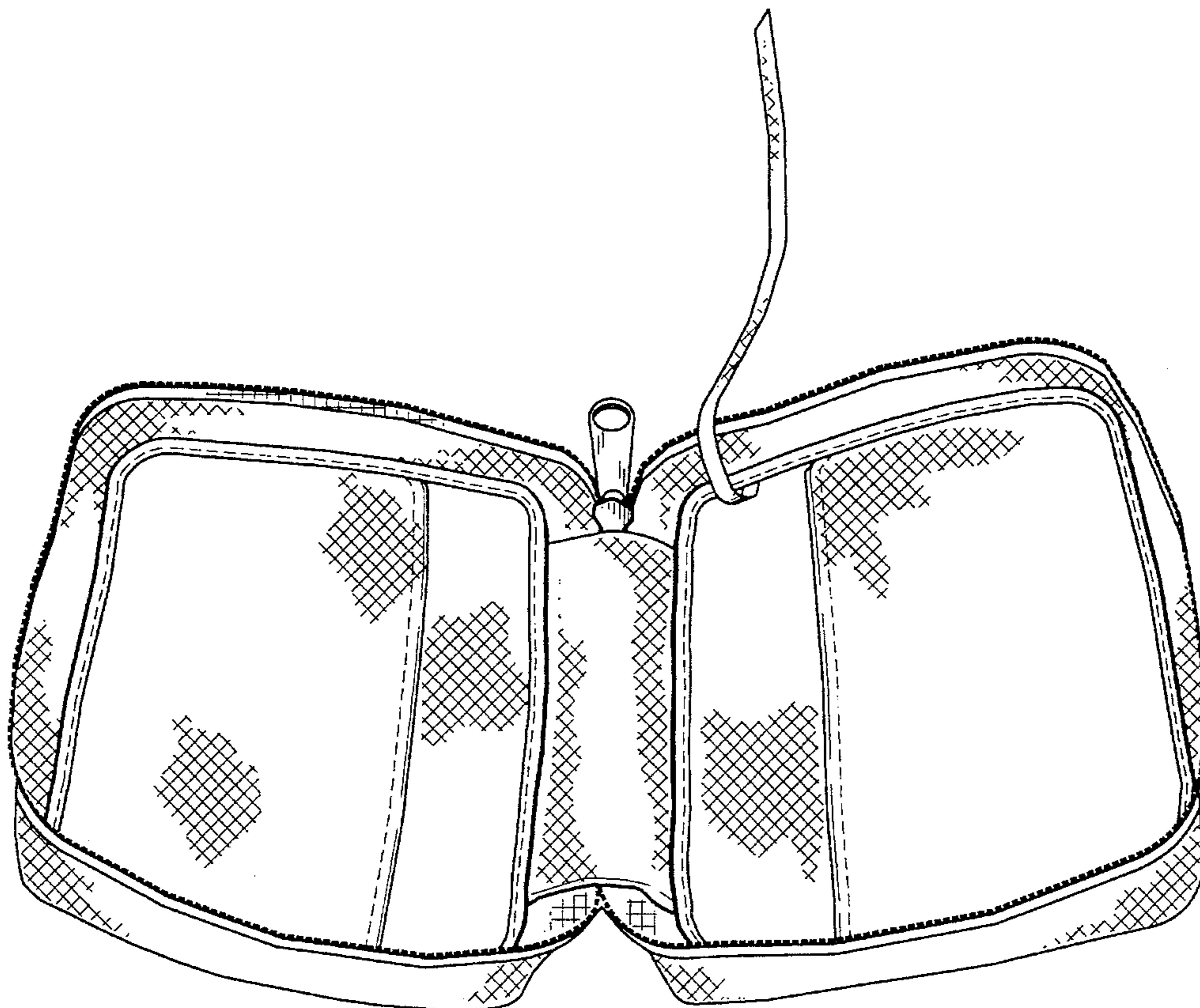
FIG. 4 is an enlarged bottom plan view thereof;

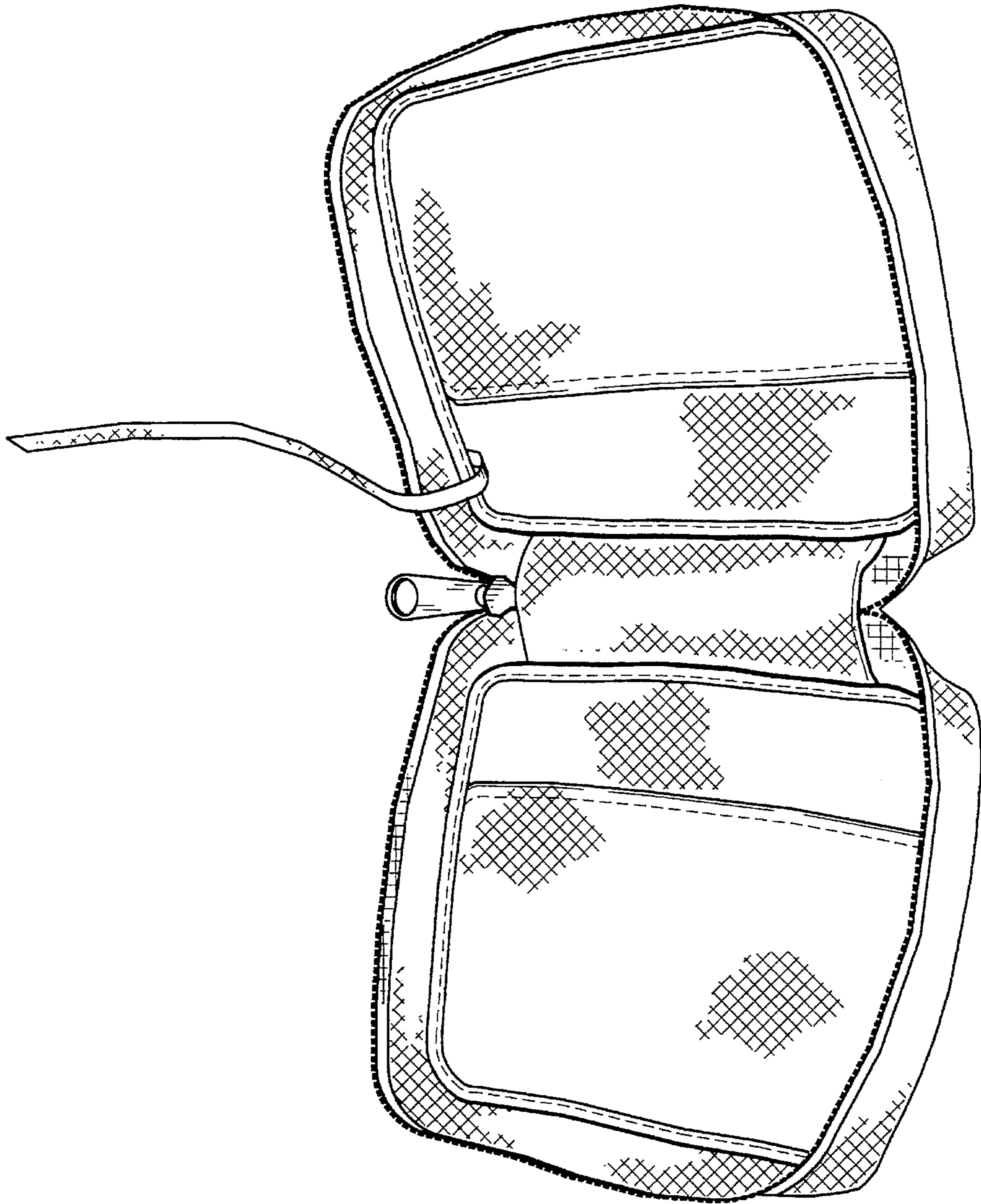

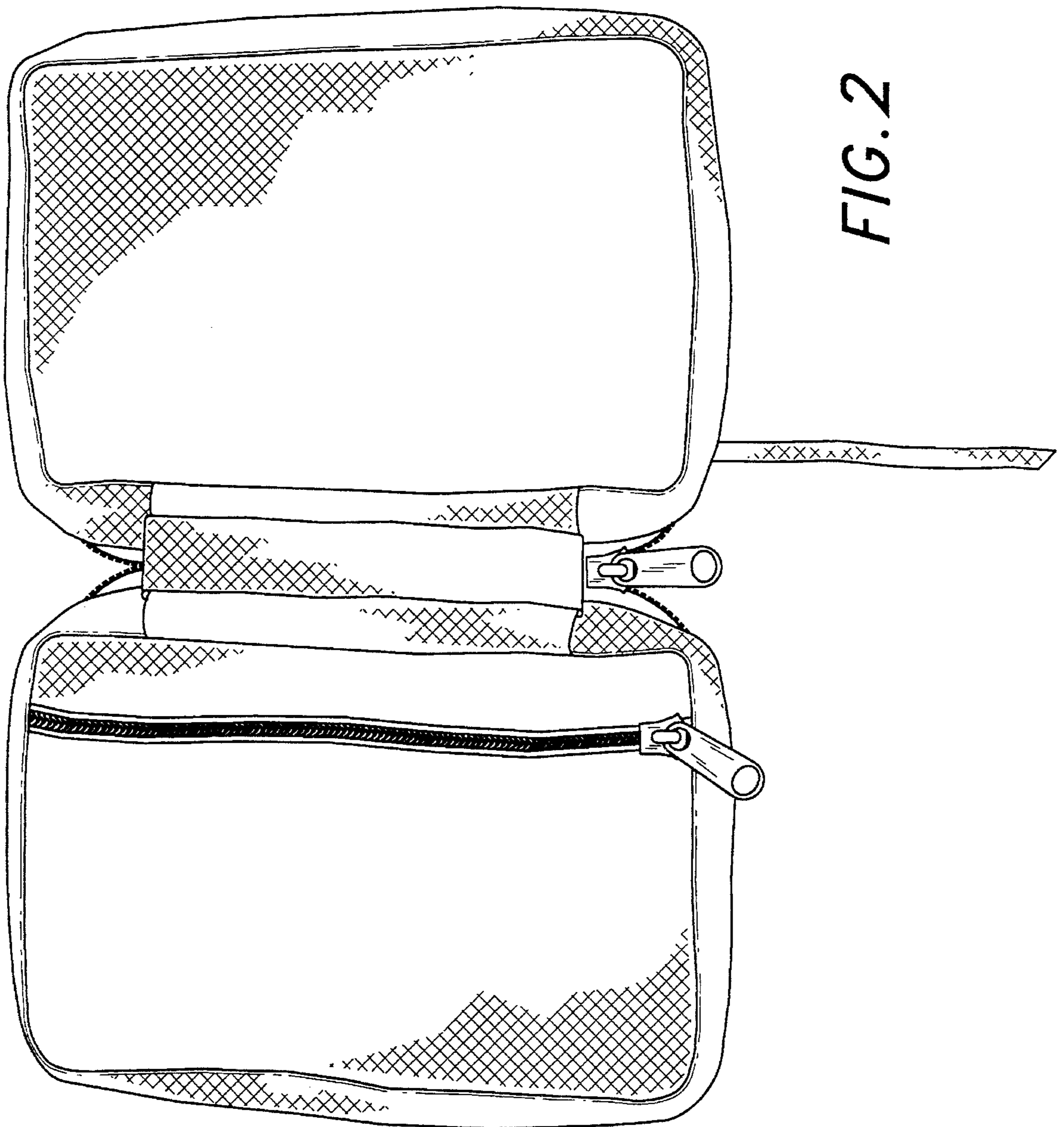

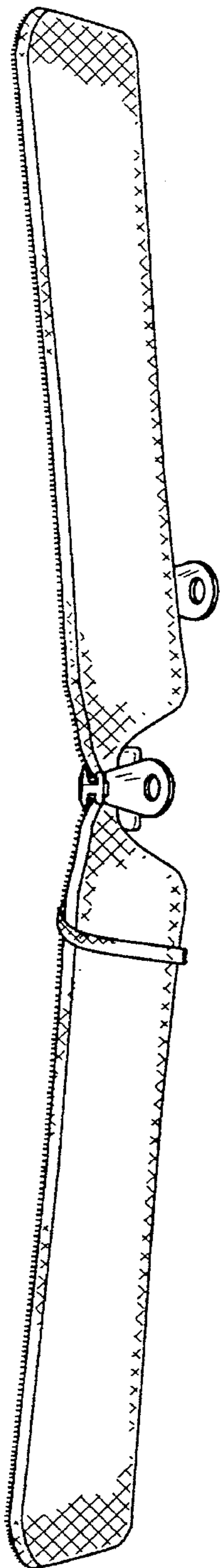

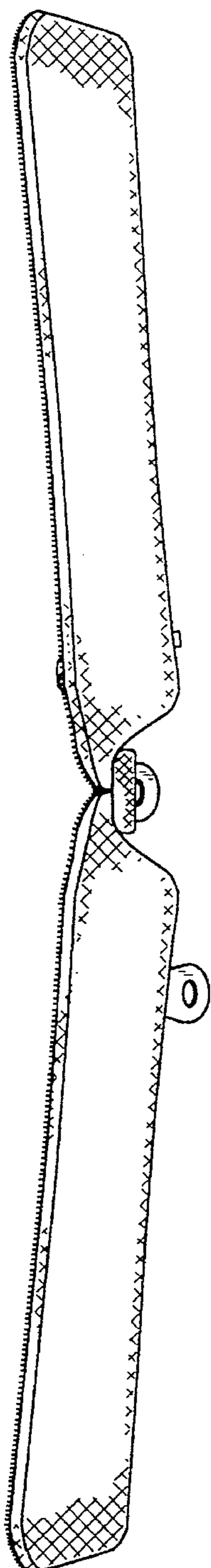

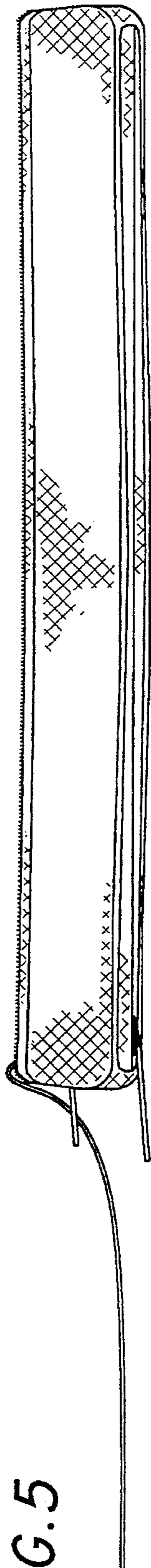

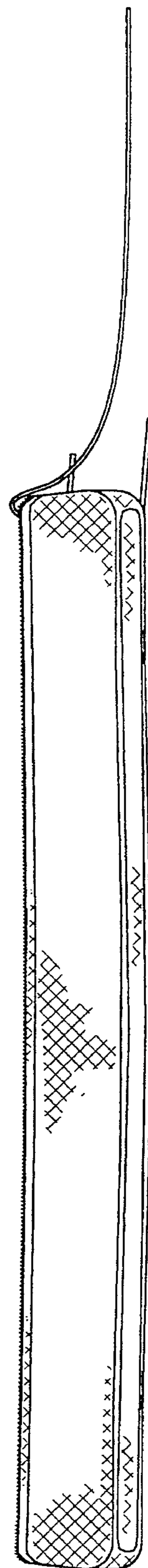

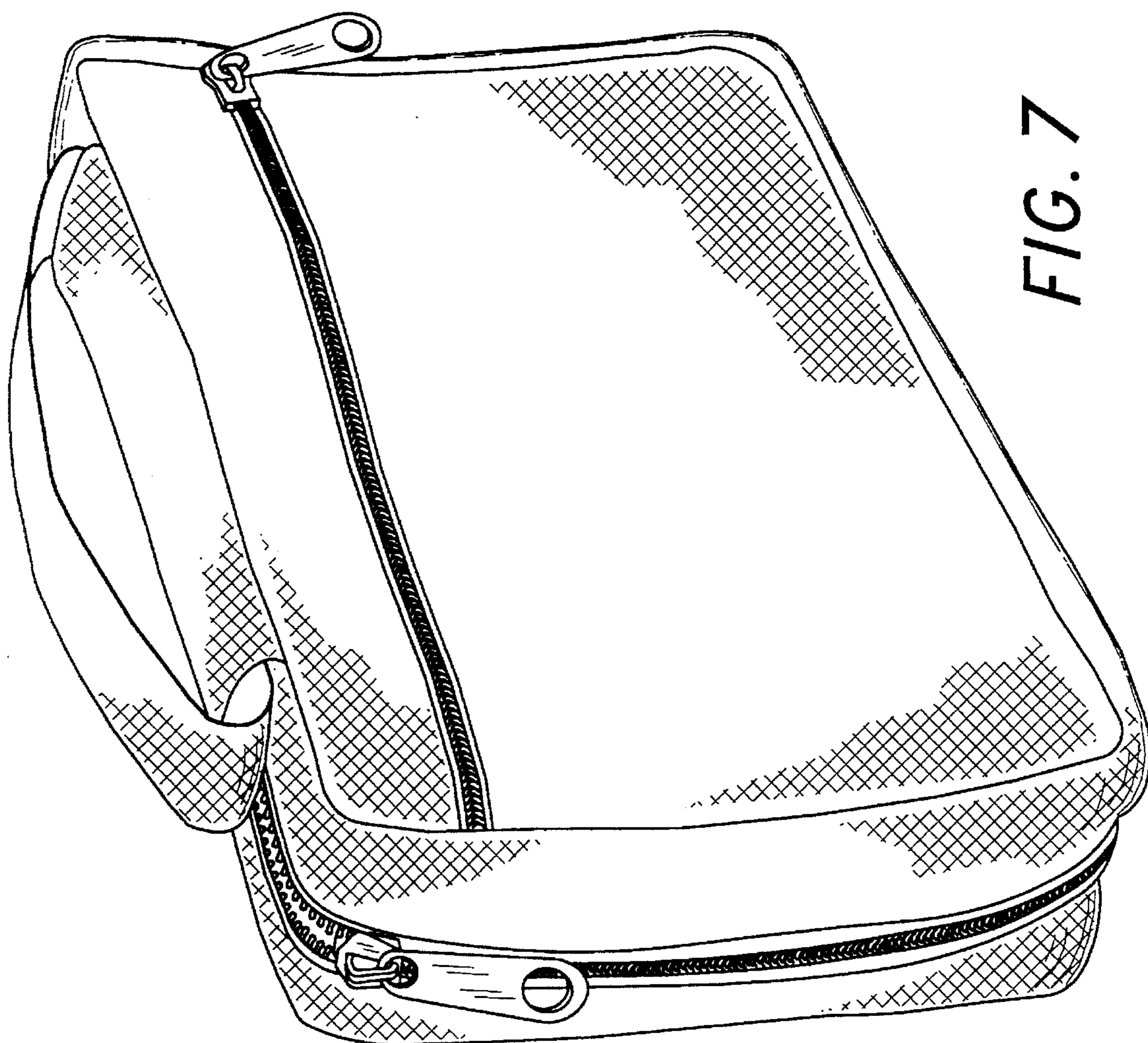
