[57] CLAIM

The ornamental design for a lipstick case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lipstick case showing my new design with the cap removed for completeness of disclosure; the undisclosed sides of the lipstick tube being identical to the sides shown;
FIG. 2 is a front elevational view thereof, the side opposite being a identical to the side shown;
FIG. 3 is a side elevational view thereof, the side opposite being identical to the side shown;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.

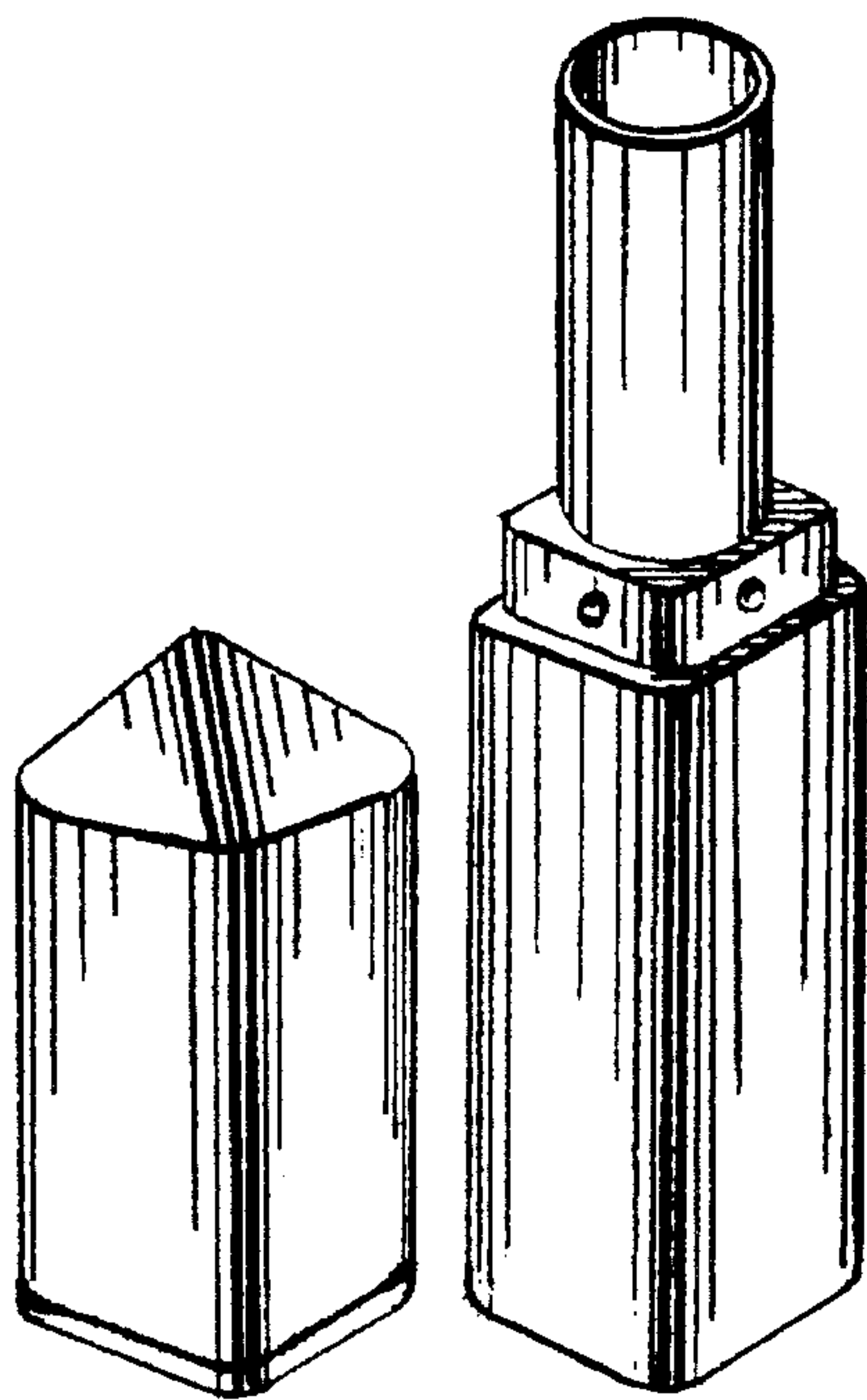

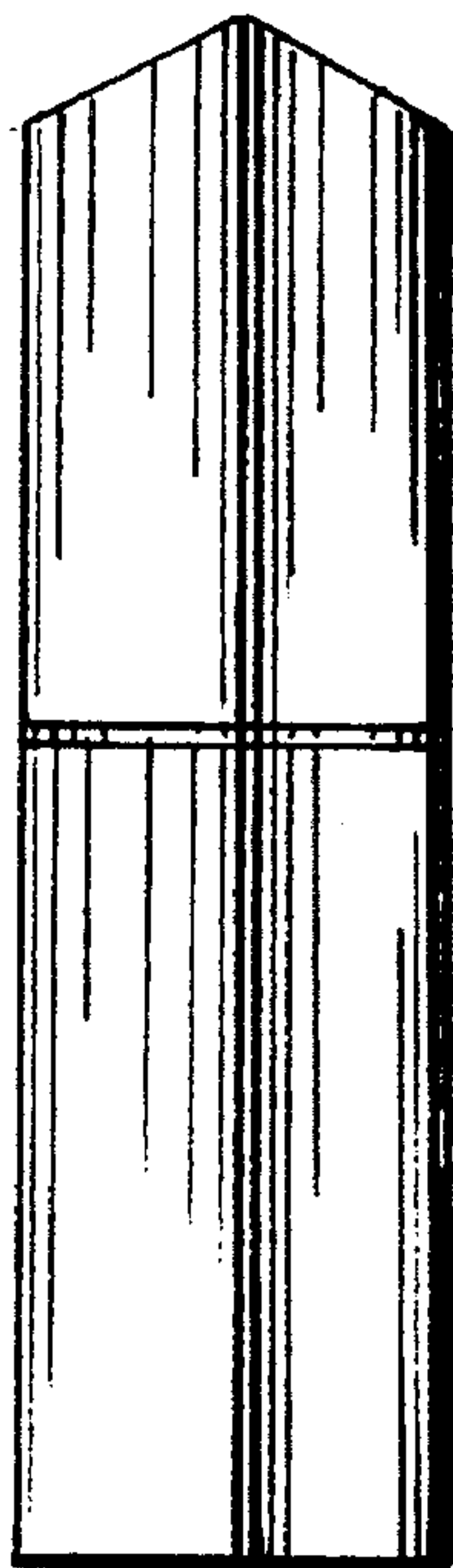

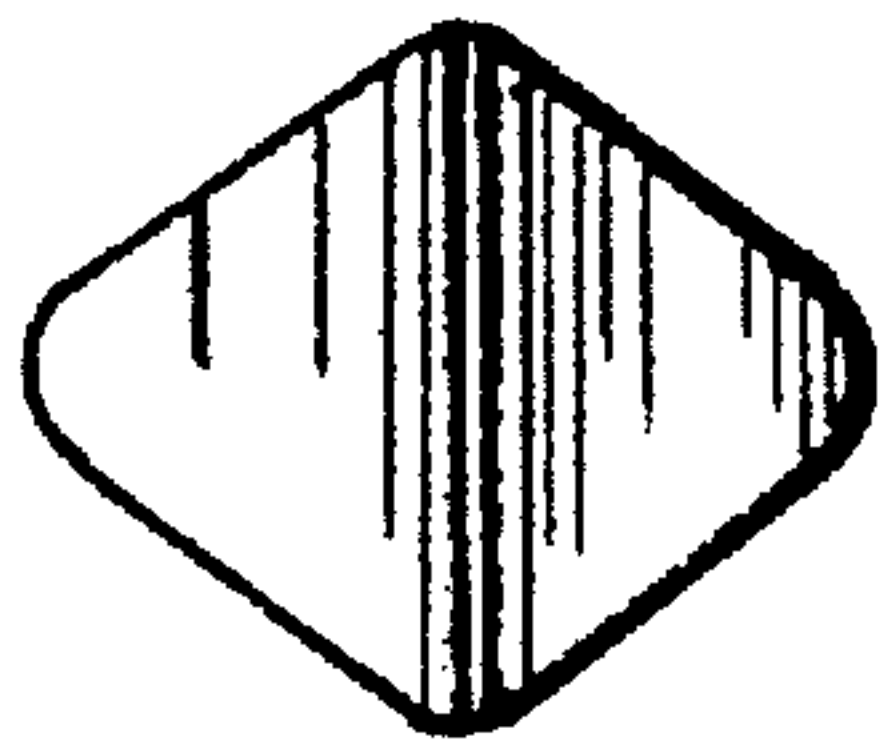

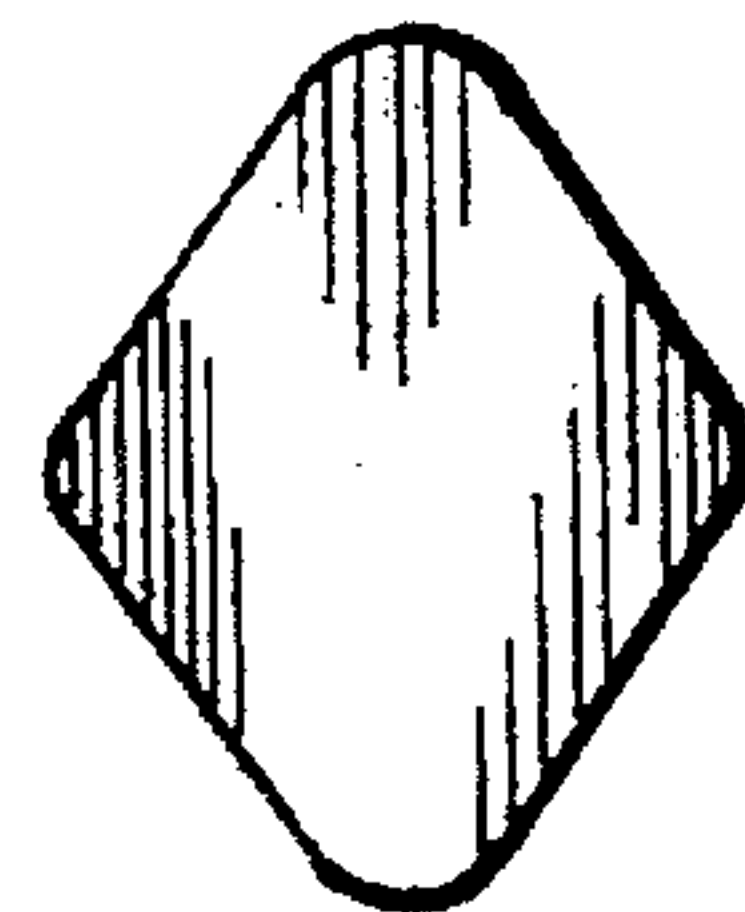
