[57] **CLAIM**

The ornamental design for a projection television, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a projection television showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front elevational view of a second embodiment thereof, the other elevational and plan views being identical to the first embodiment; and

FIG. 9 is a front elevational view of a third embodiment thereof, the other elevational and plan views being identical to the first embodiment;

FIG. 10 is an alternative top, front and right side perspective view of the vertically oriented projection television apparatus showing an embodiment with side vents;

FIG. 11 is a left side elevational view of the alternative embodiment of FIG. 10; and,

FIG. 12 is a right side elevational view of the alternative embodiment of FIG. 10.

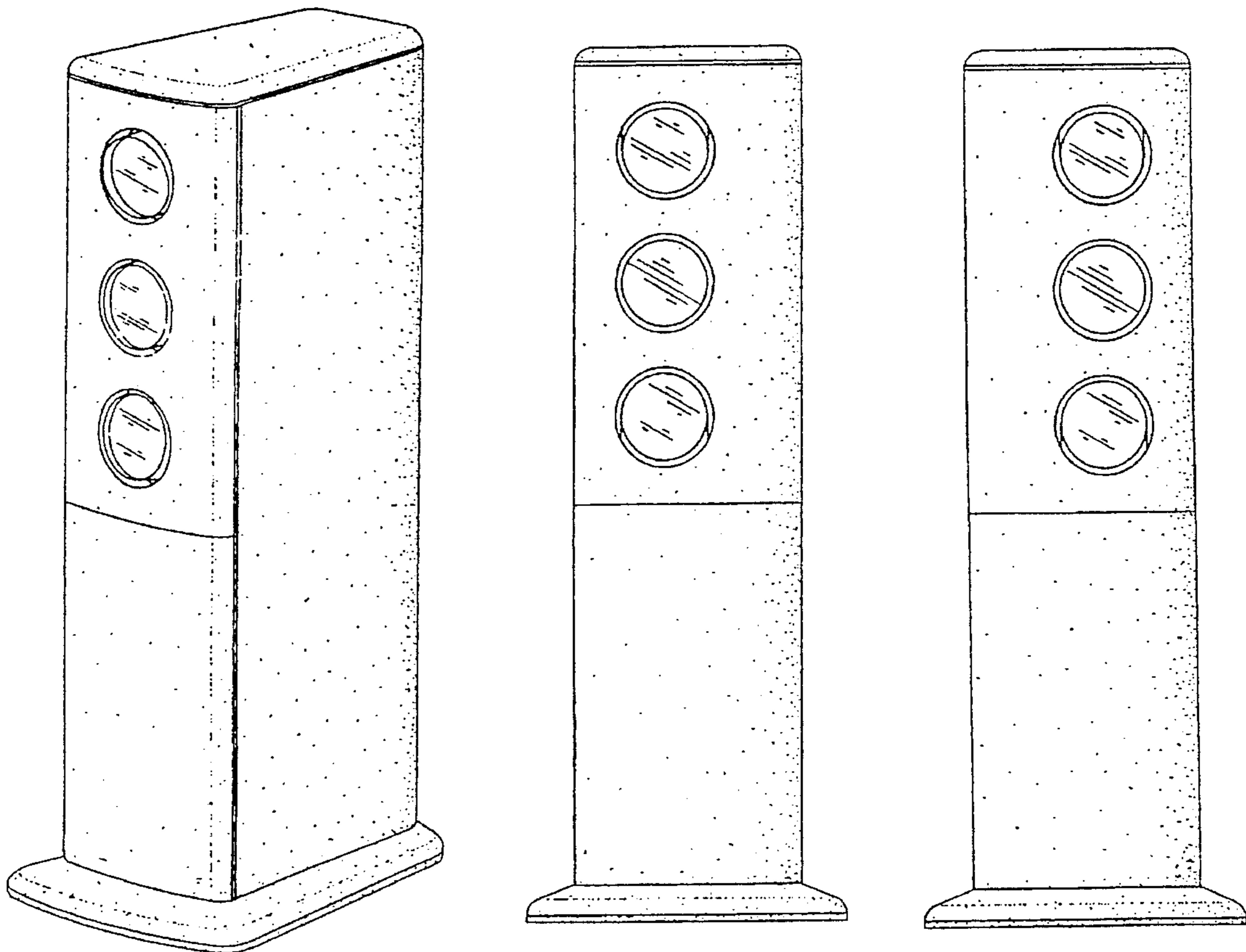

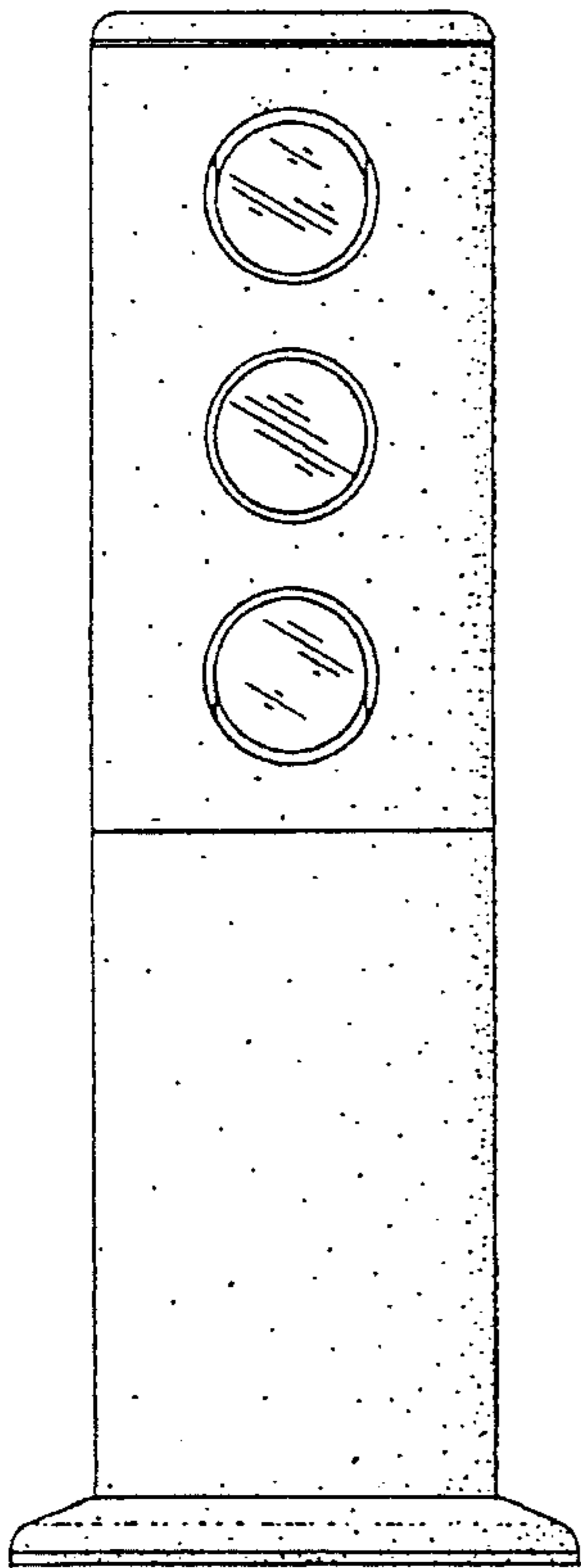
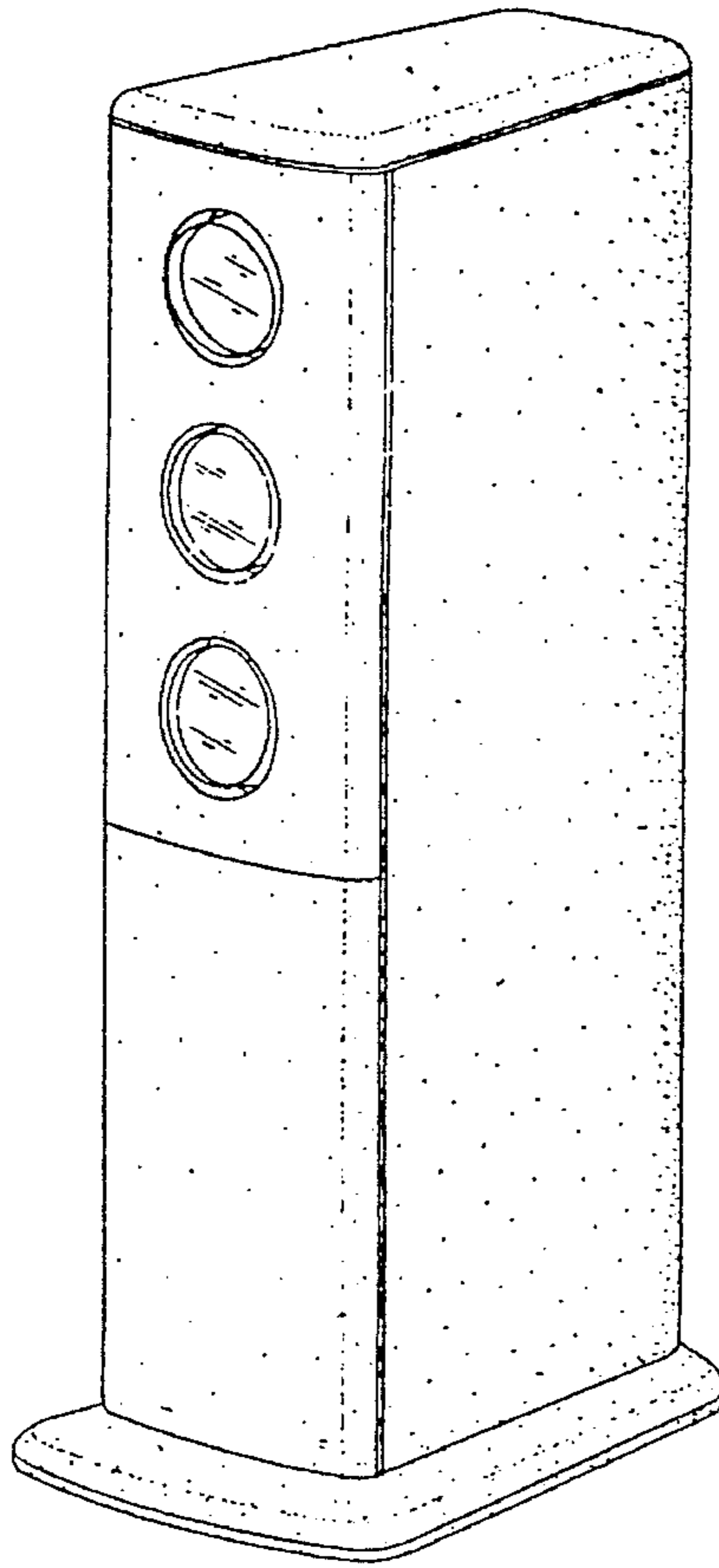

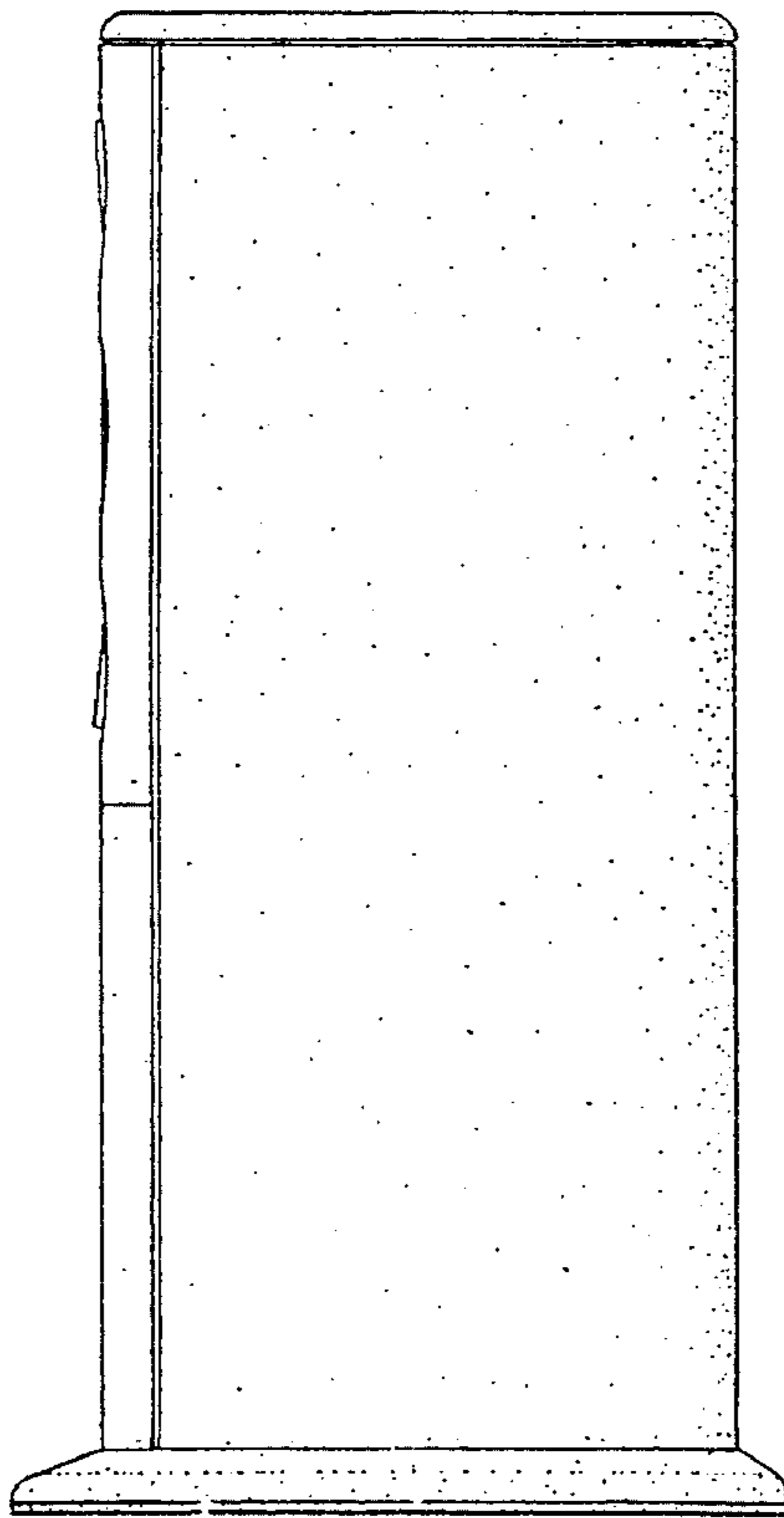

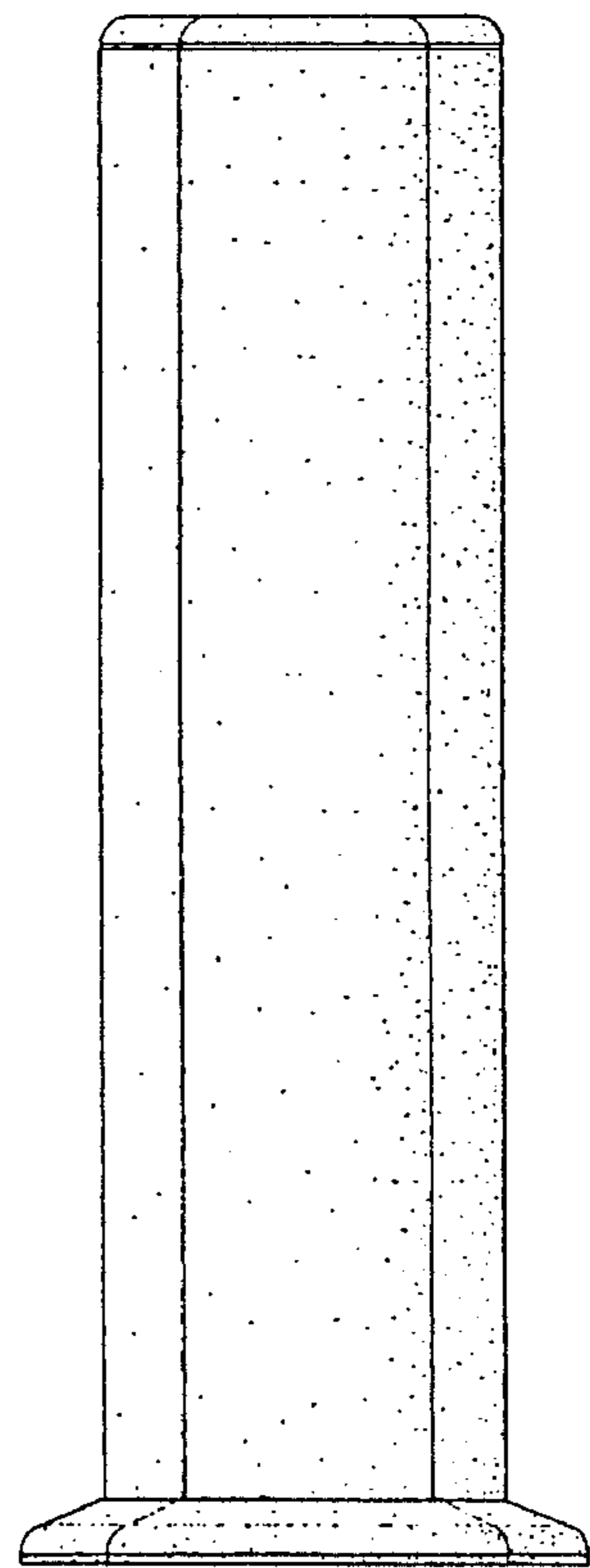

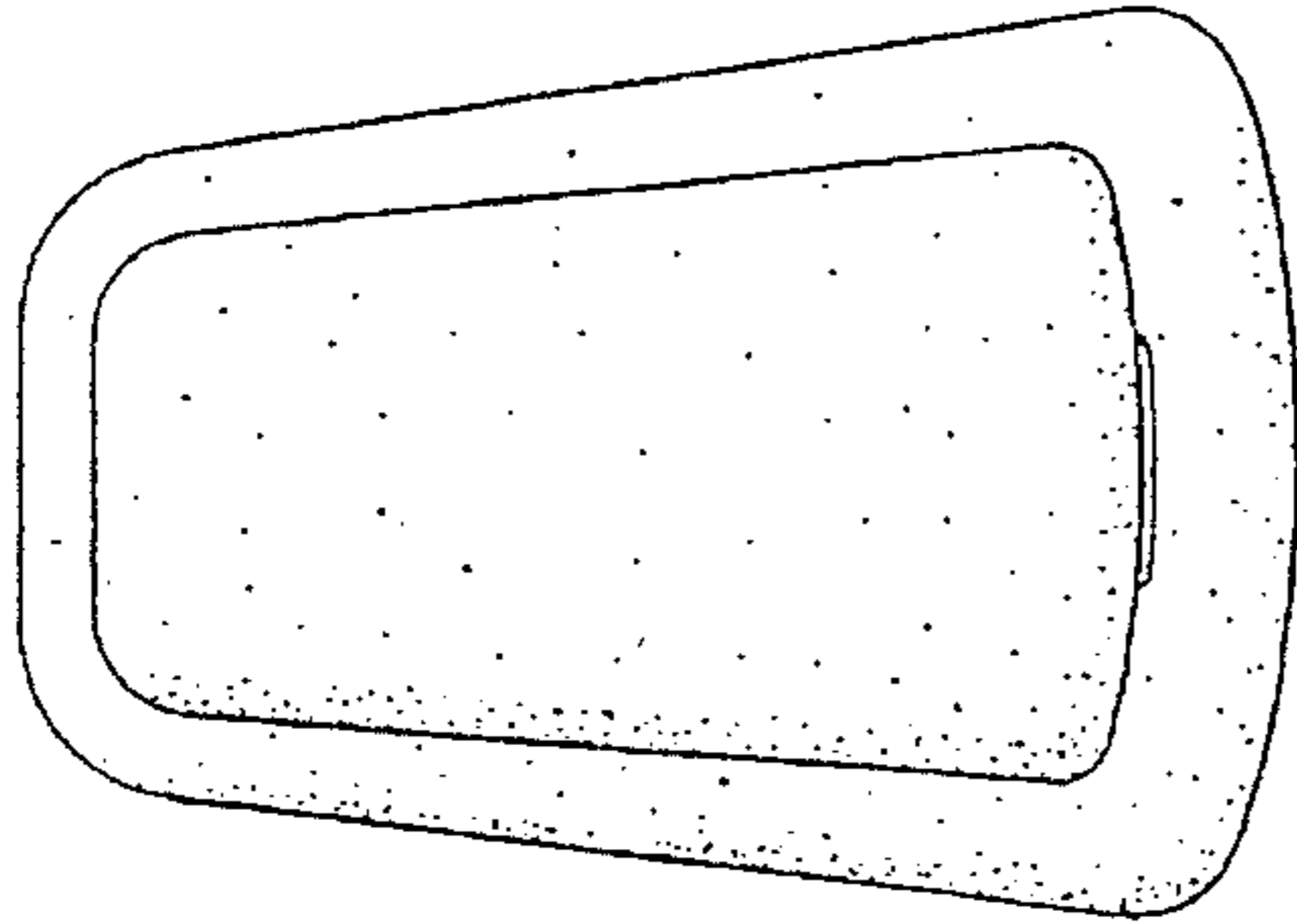

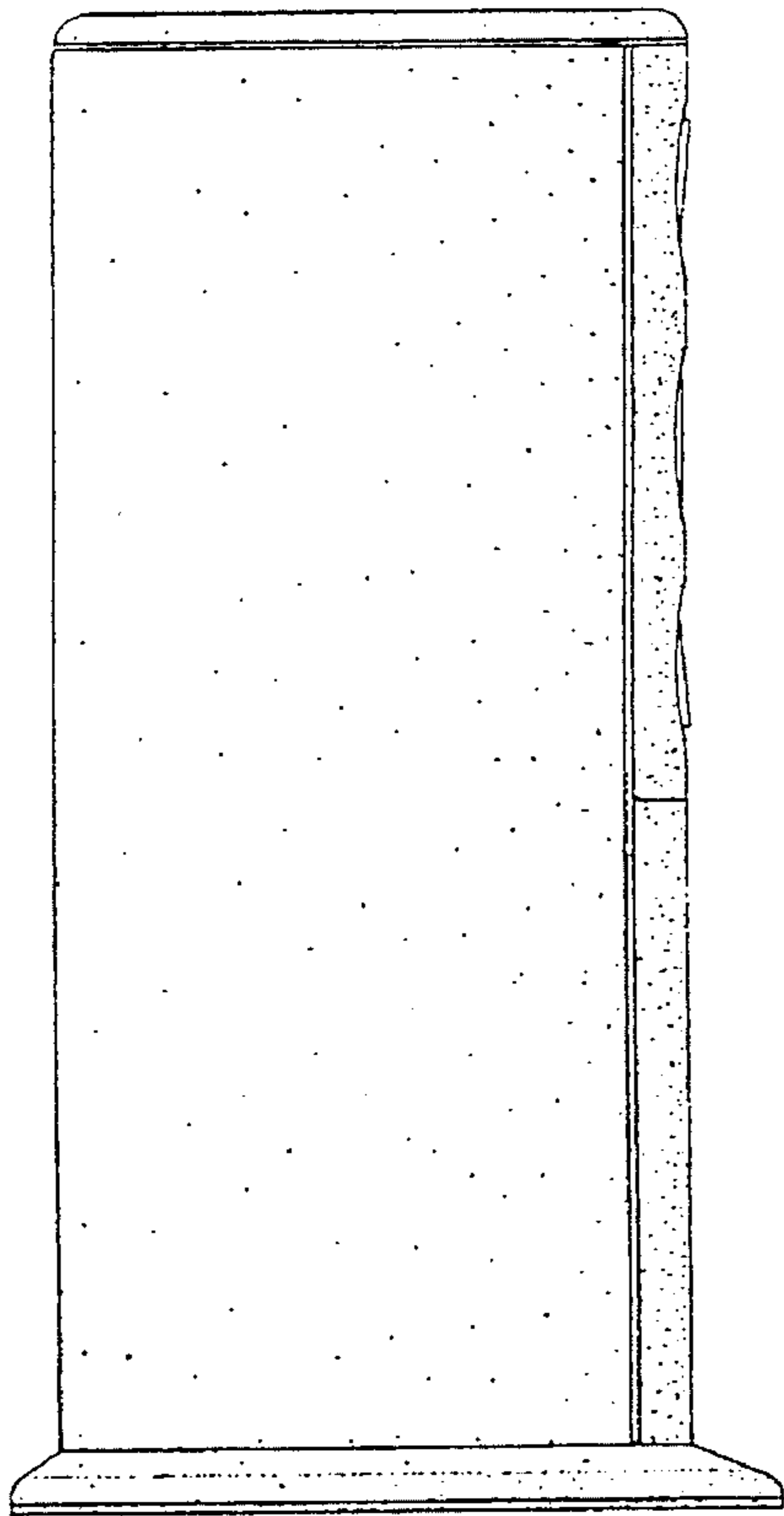
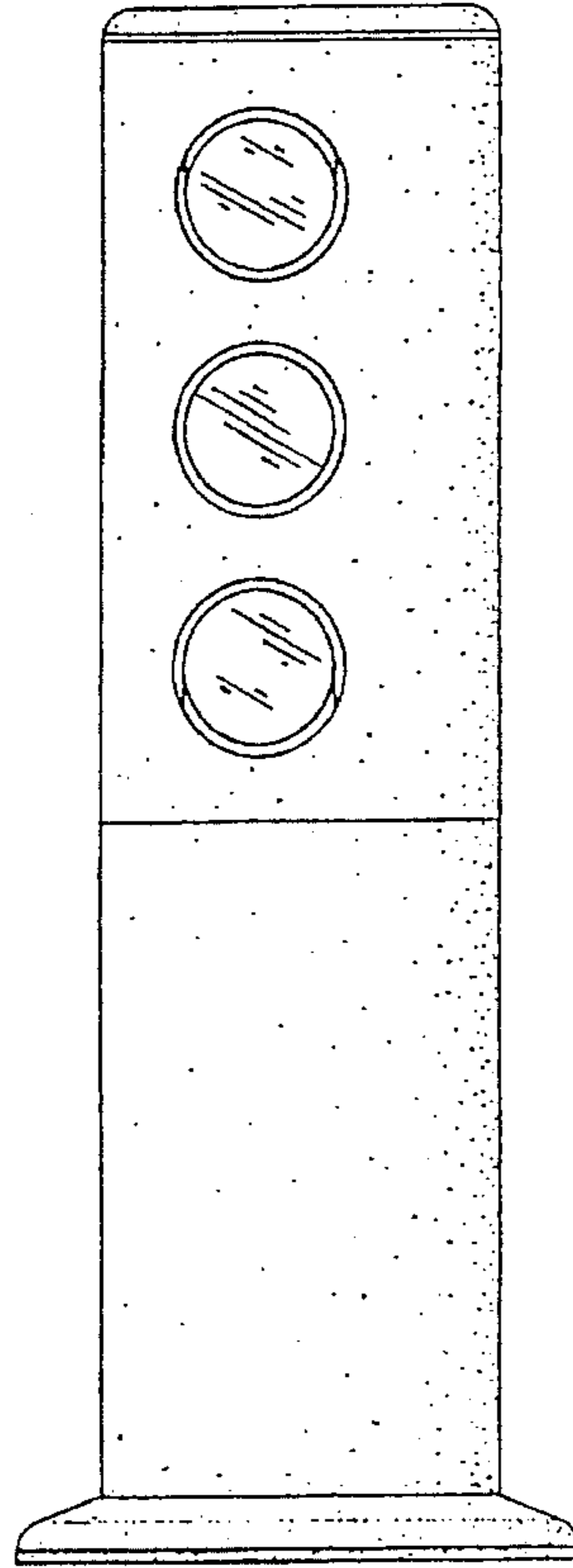

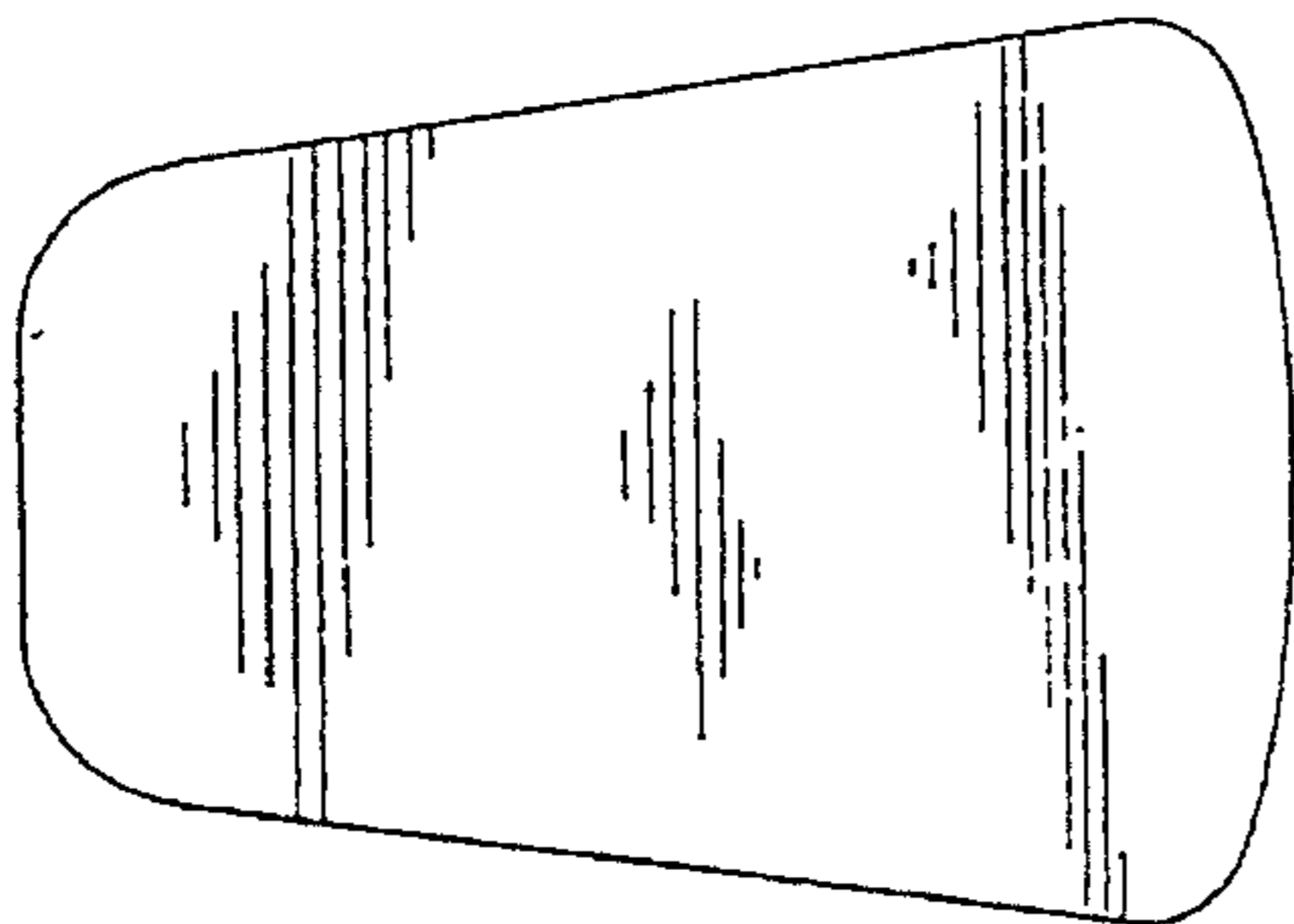

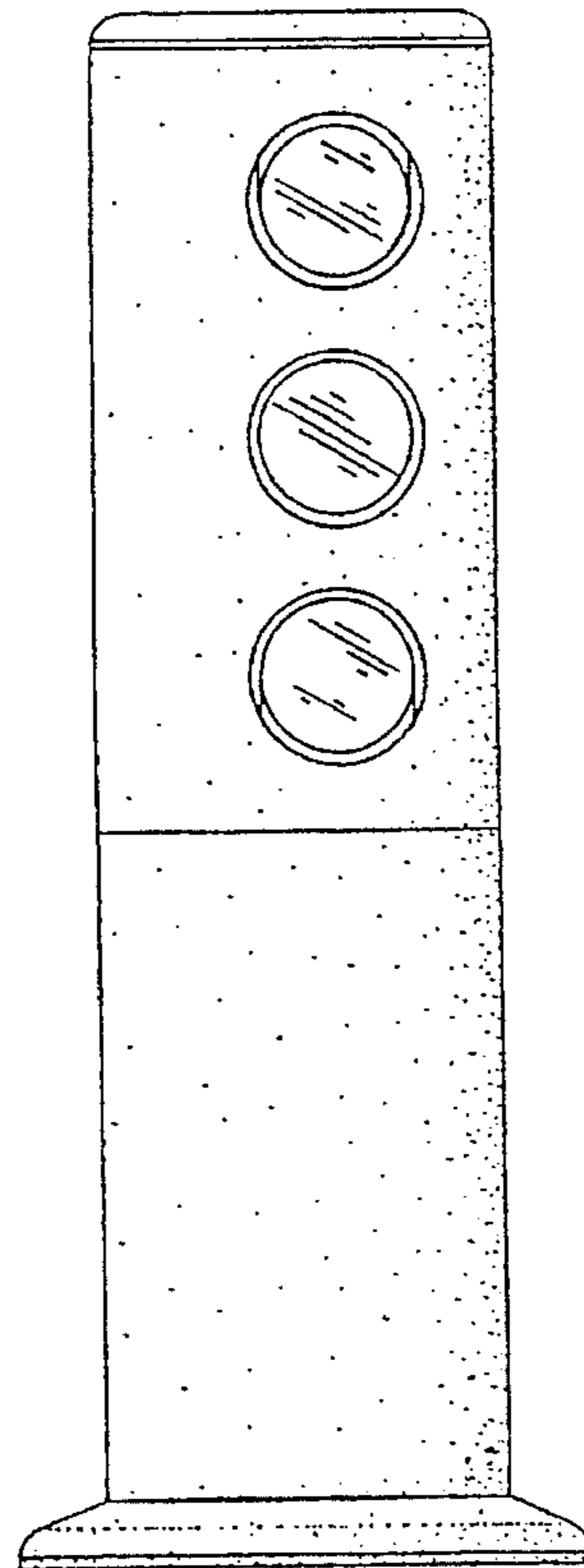

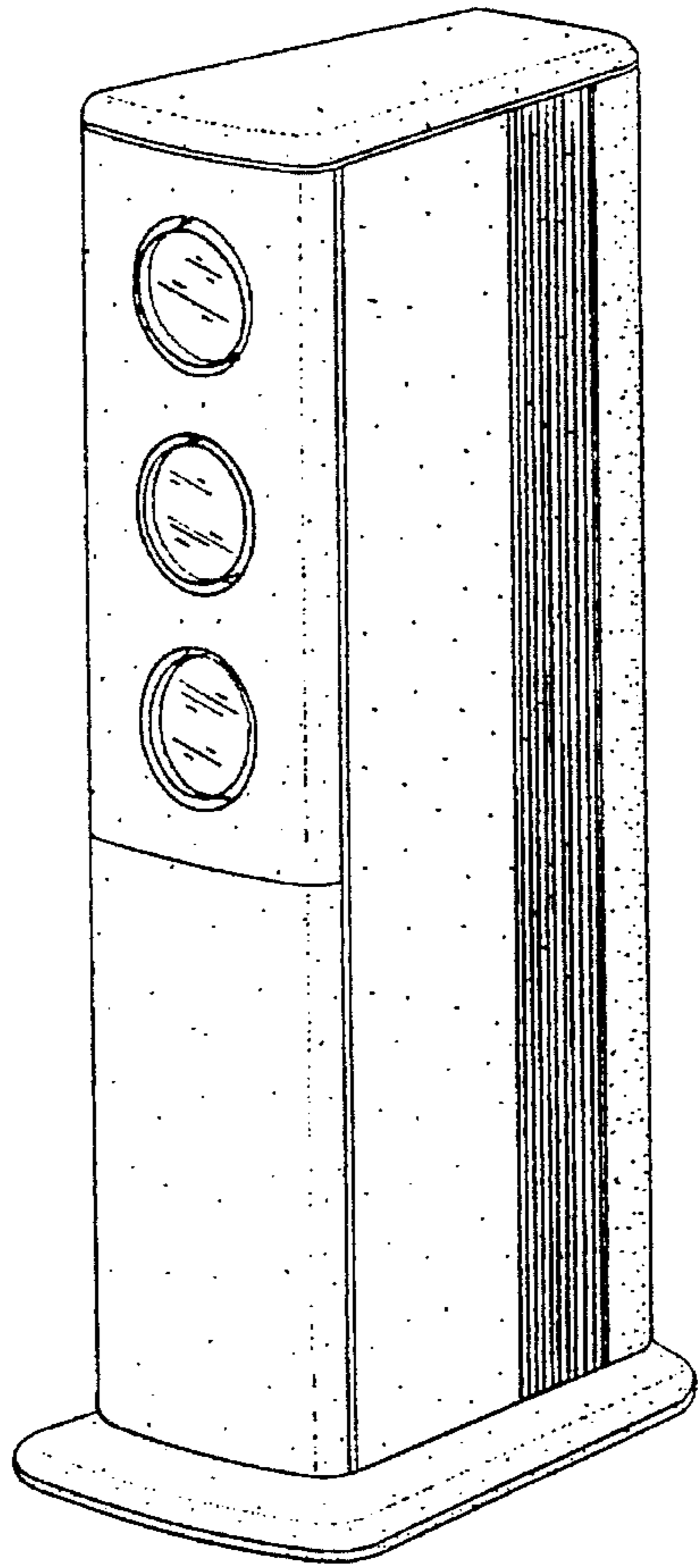

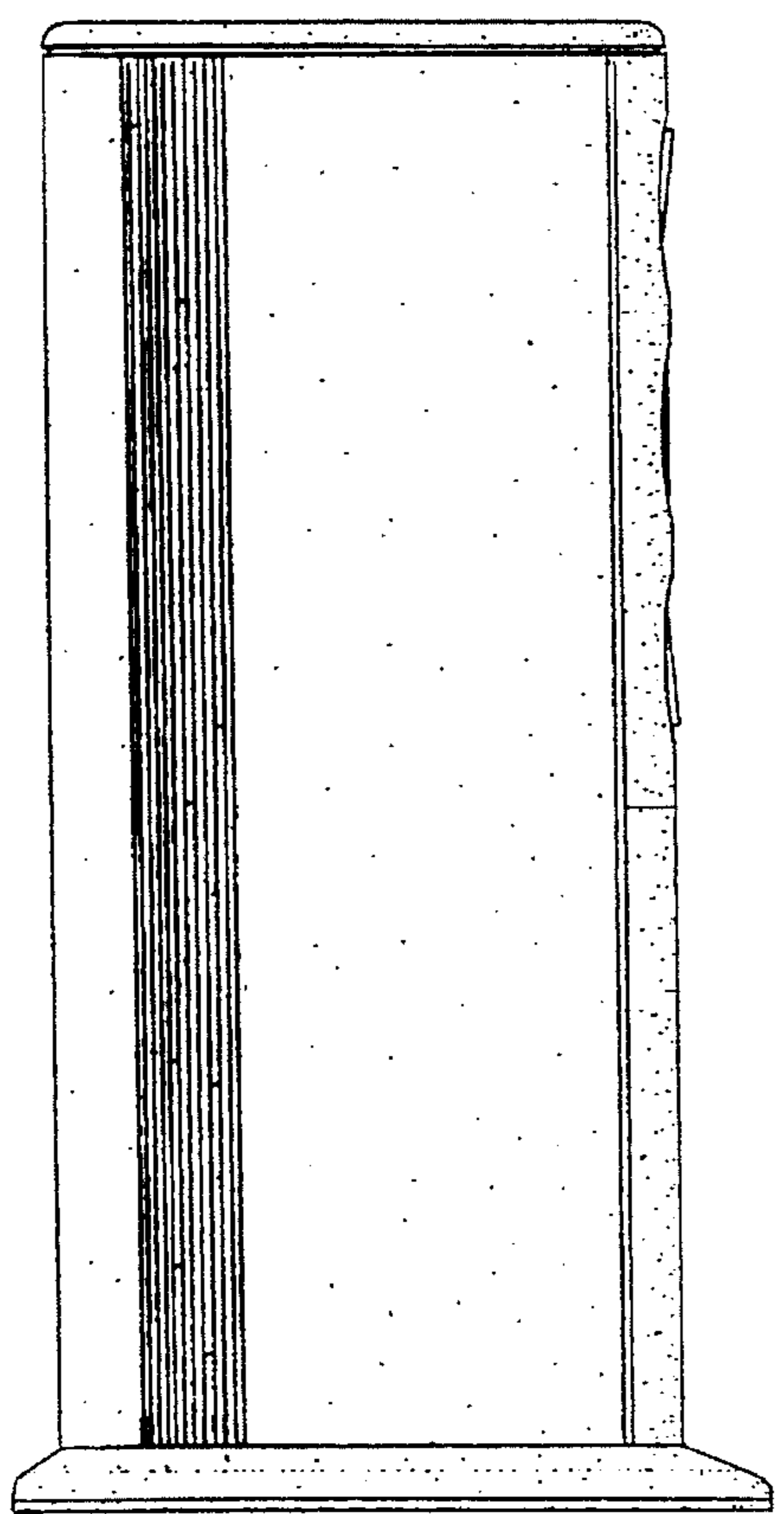
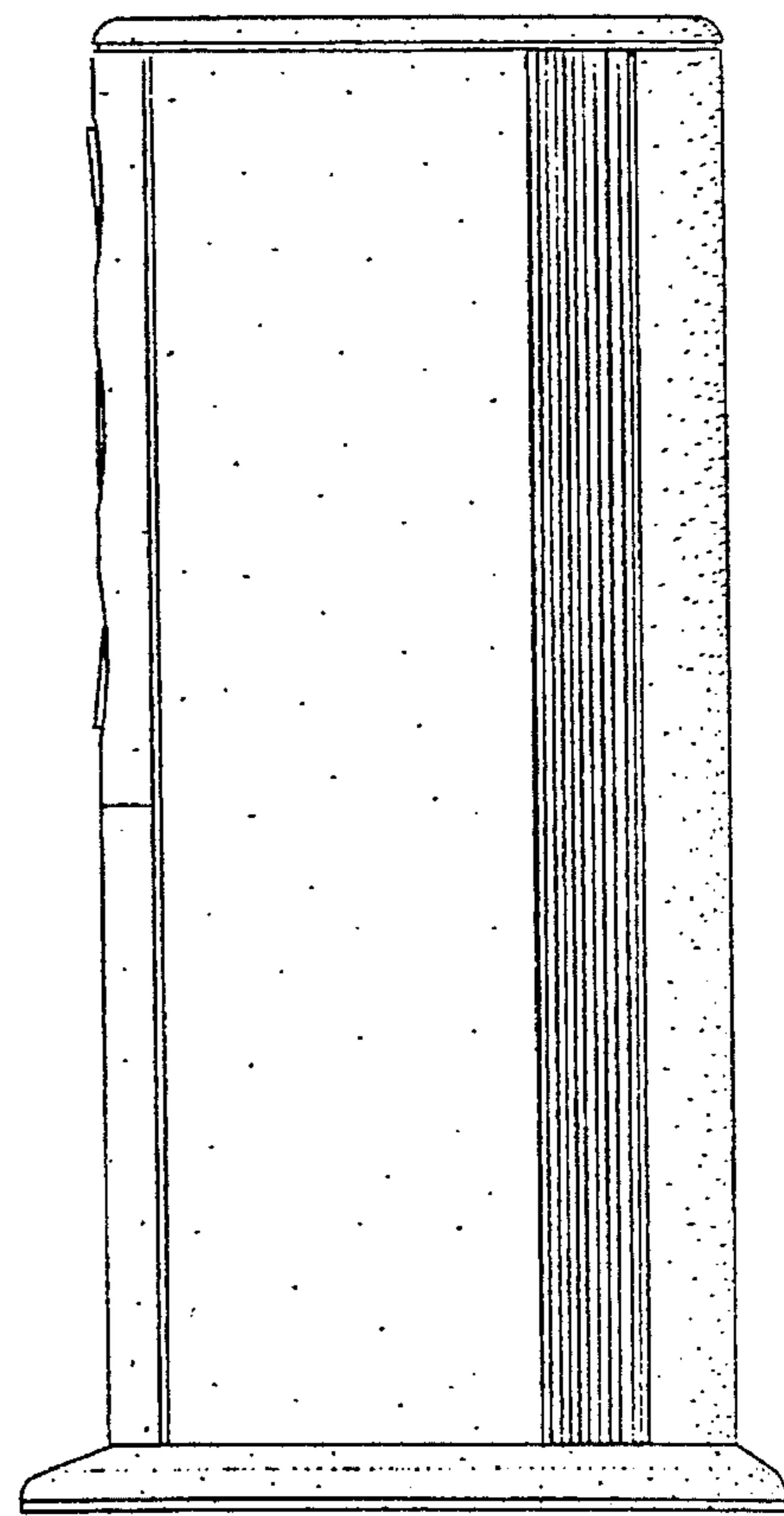
