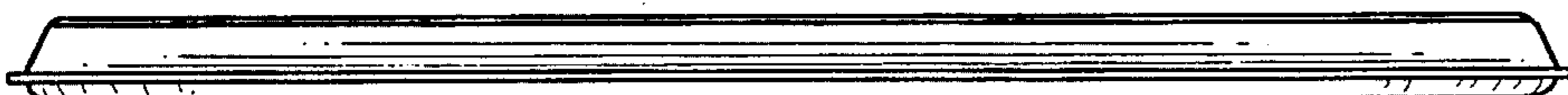
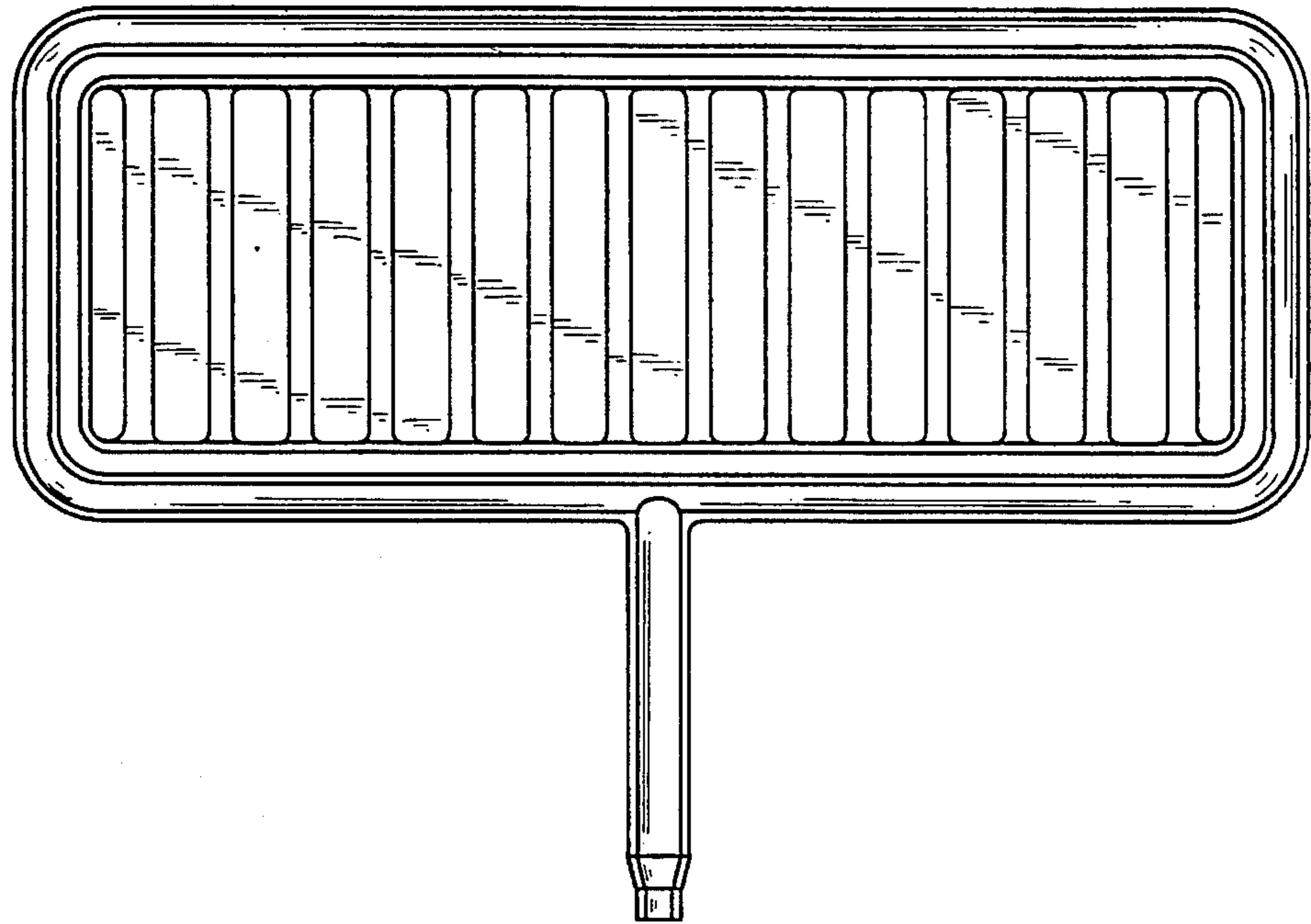
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a top elevational view of the gas burner; FIG. 2 is a bottom elevational view of the gas burner; FIG. 3 is a left side elevational view of the gas burner; FIG. 4 is a right side elevational view of the gas burner; FIG. 5 is a front plan view of the gas burner; and, FIG. 6 is a rear plan view of the gas burner.

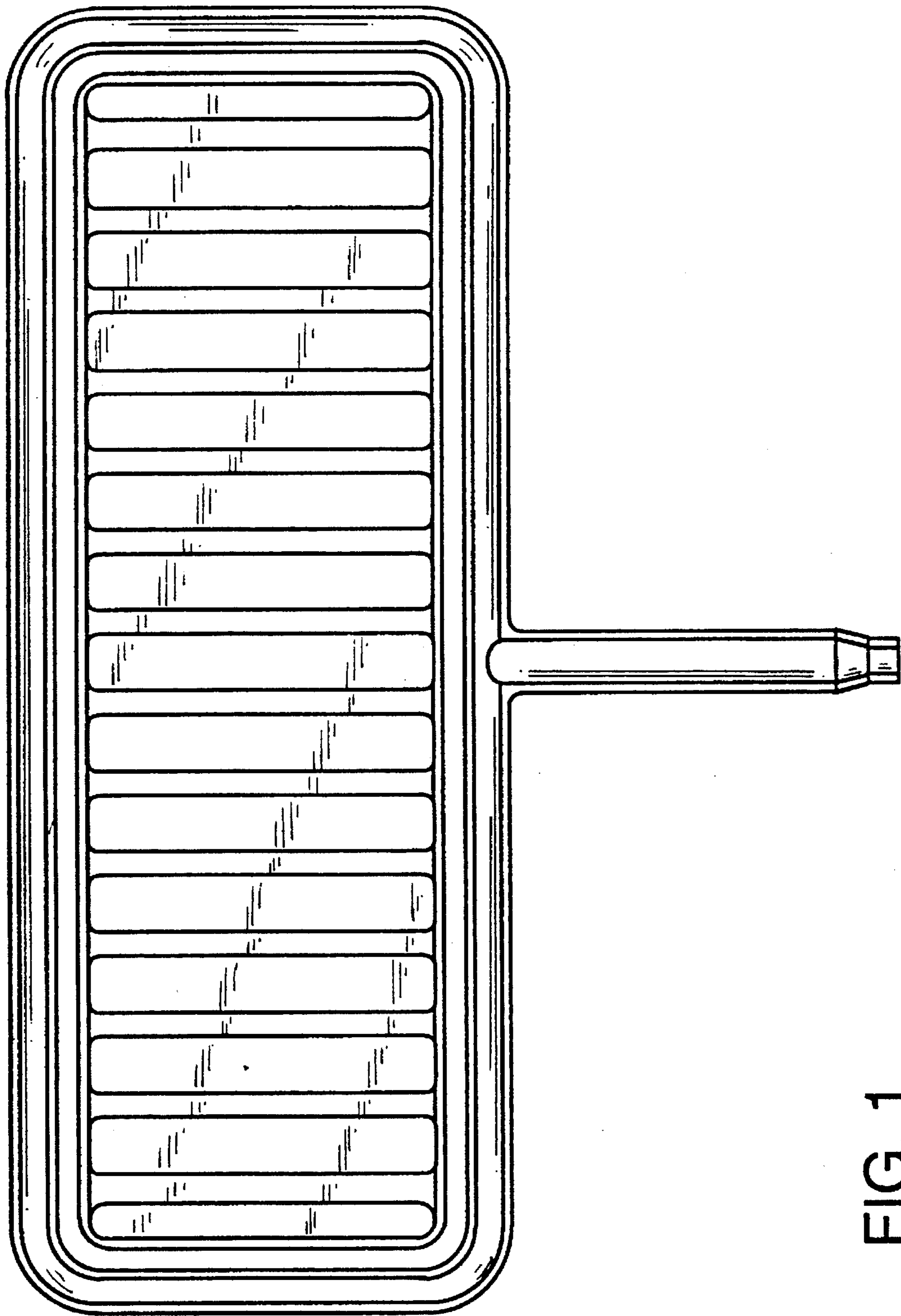

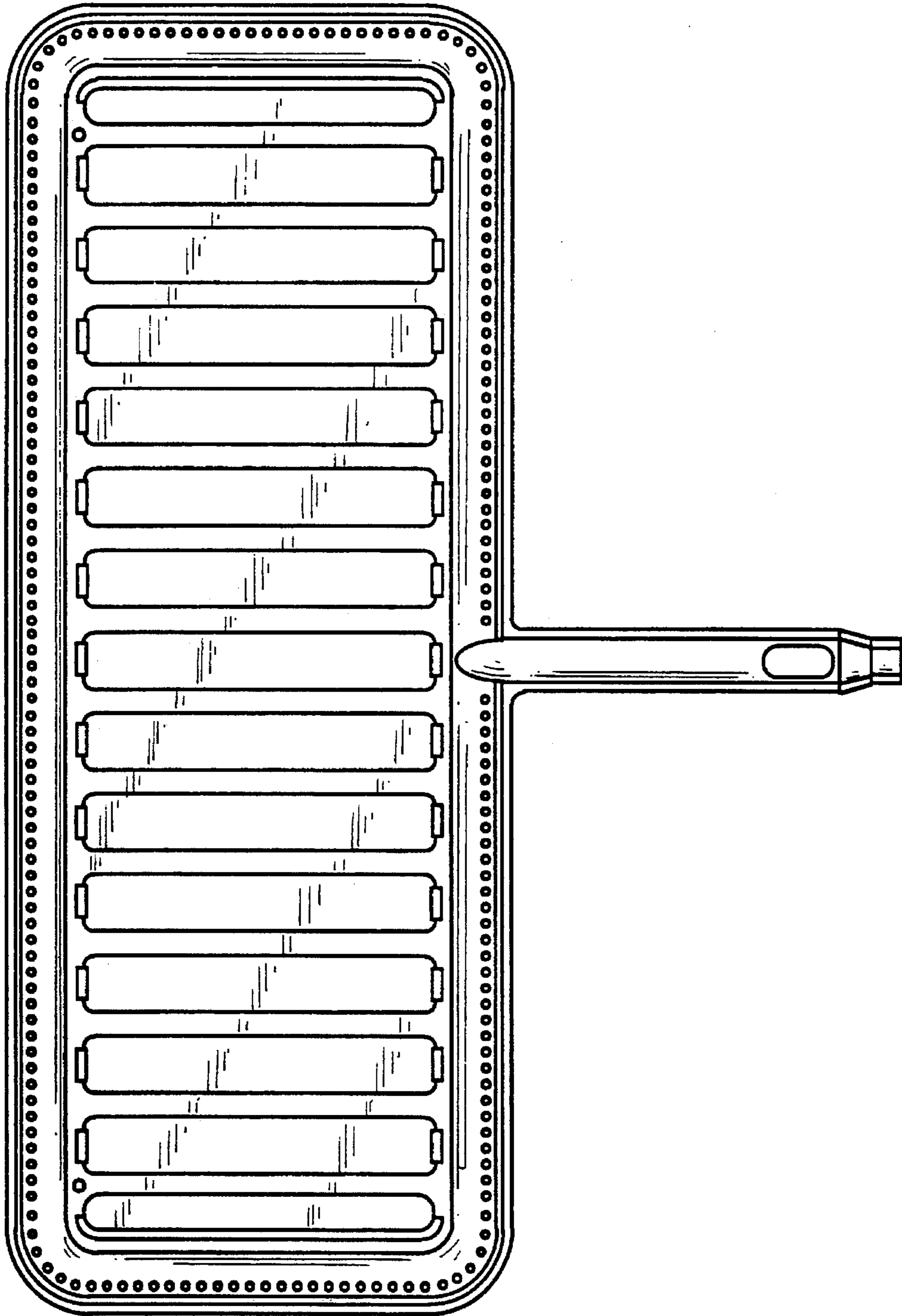

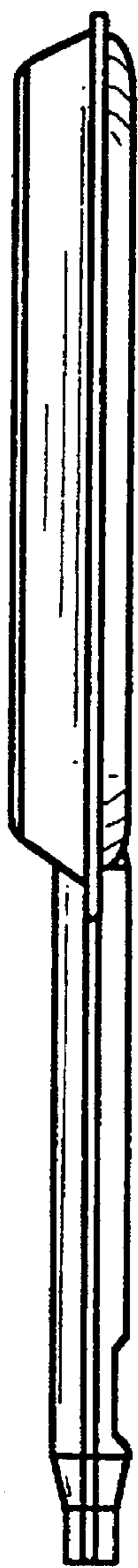
