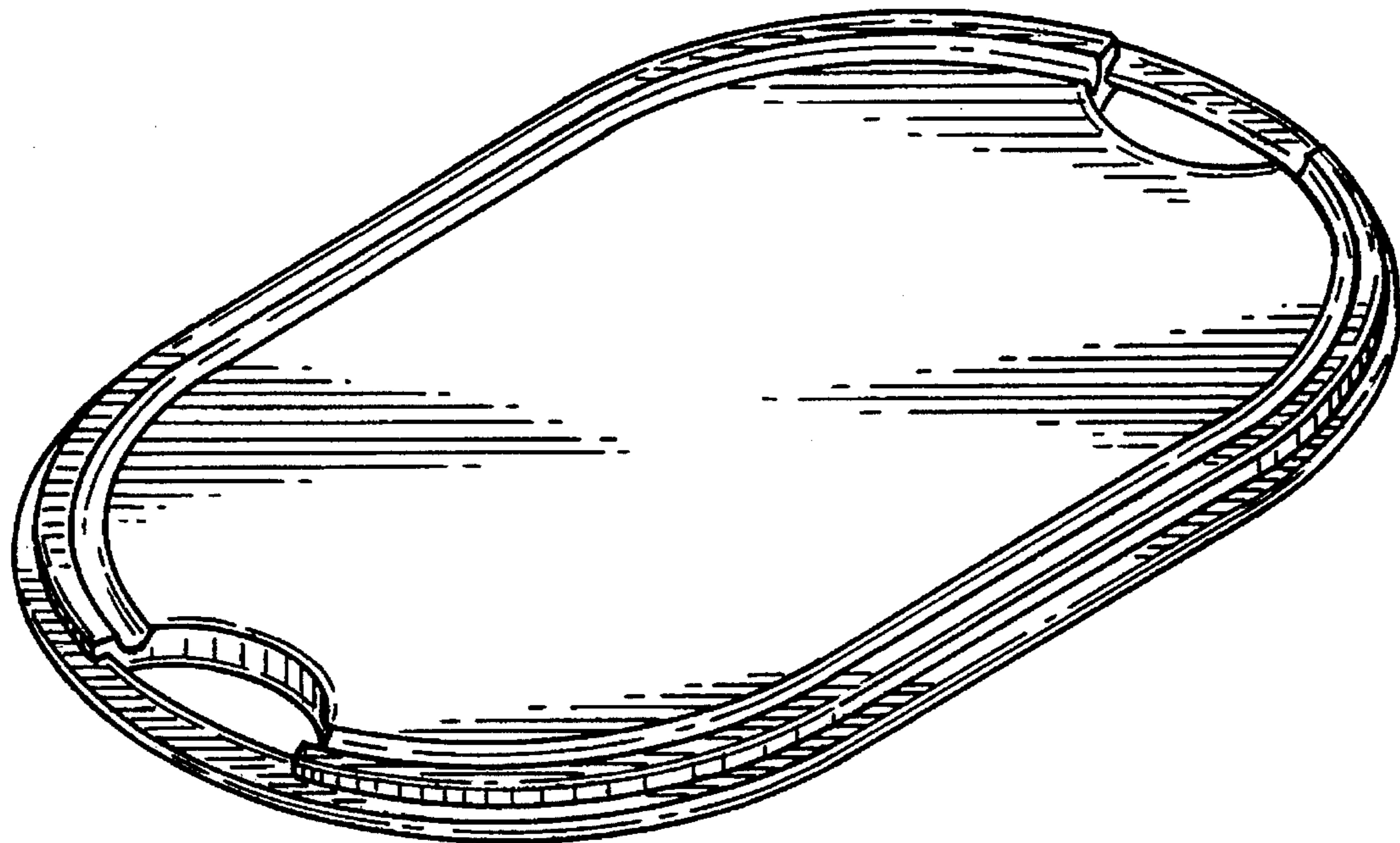
[57] CLAIM

DESCRIPTION

FIG. 1 is a top, end and front perspective view of a cutting board showing our new design;
FIG. 2 is a bottom, end and rear perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a right end view thereof;
FIG. 8 is a left end view thereof;
FIG. 9 is a cross-section on line 9—9 in FIG. 3; and,
FIG. 10 is a cross-section on line 10—10 in FIG. 3.

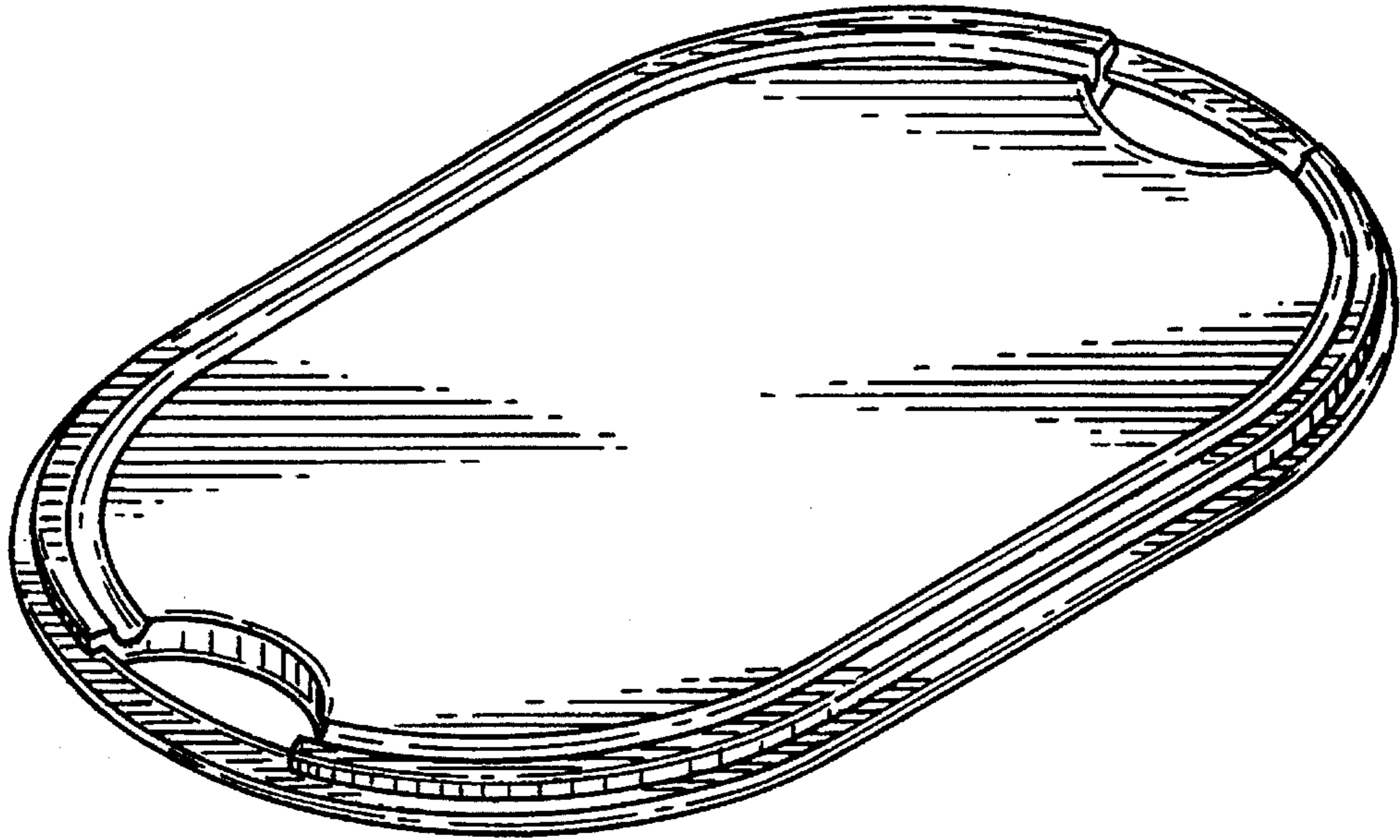

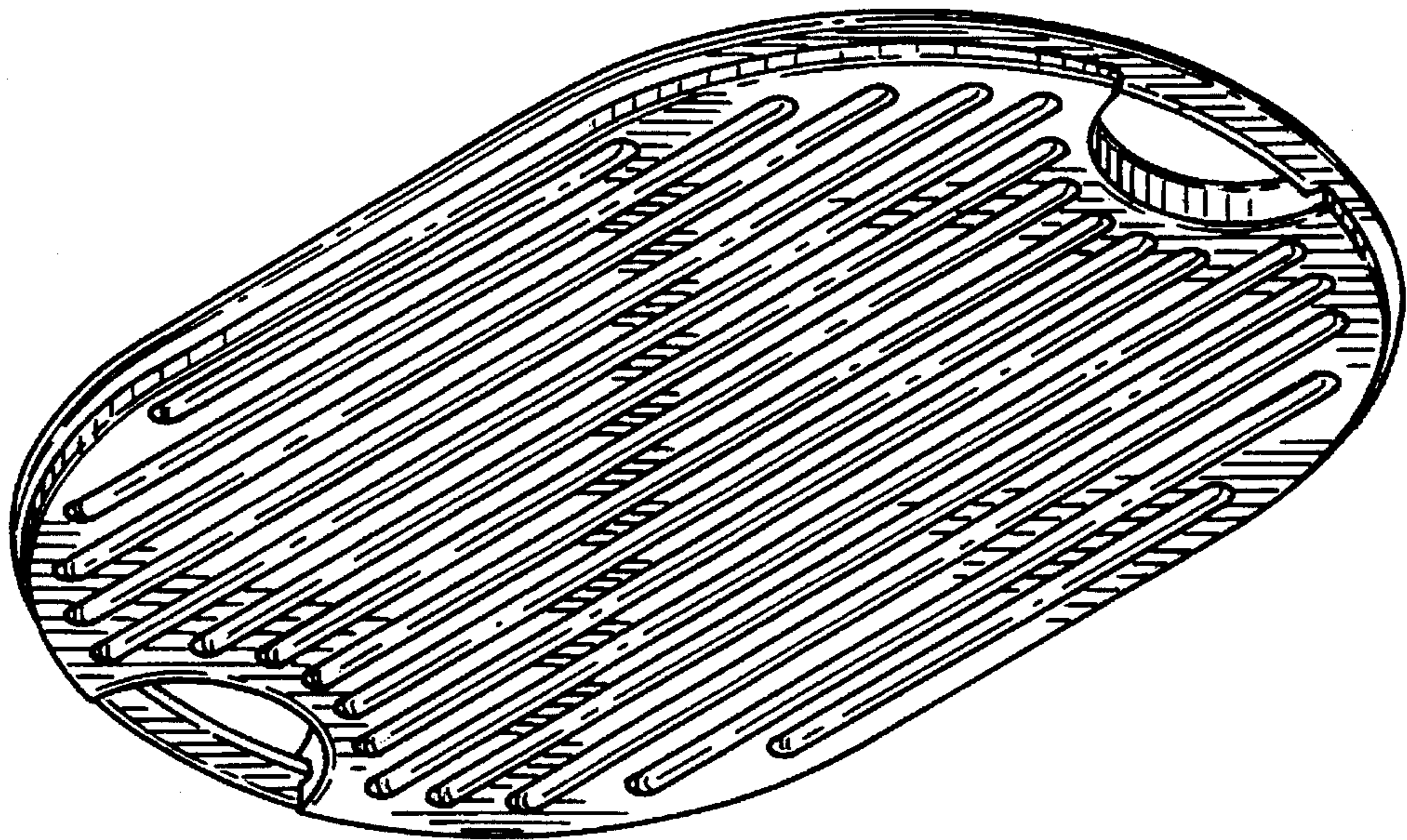
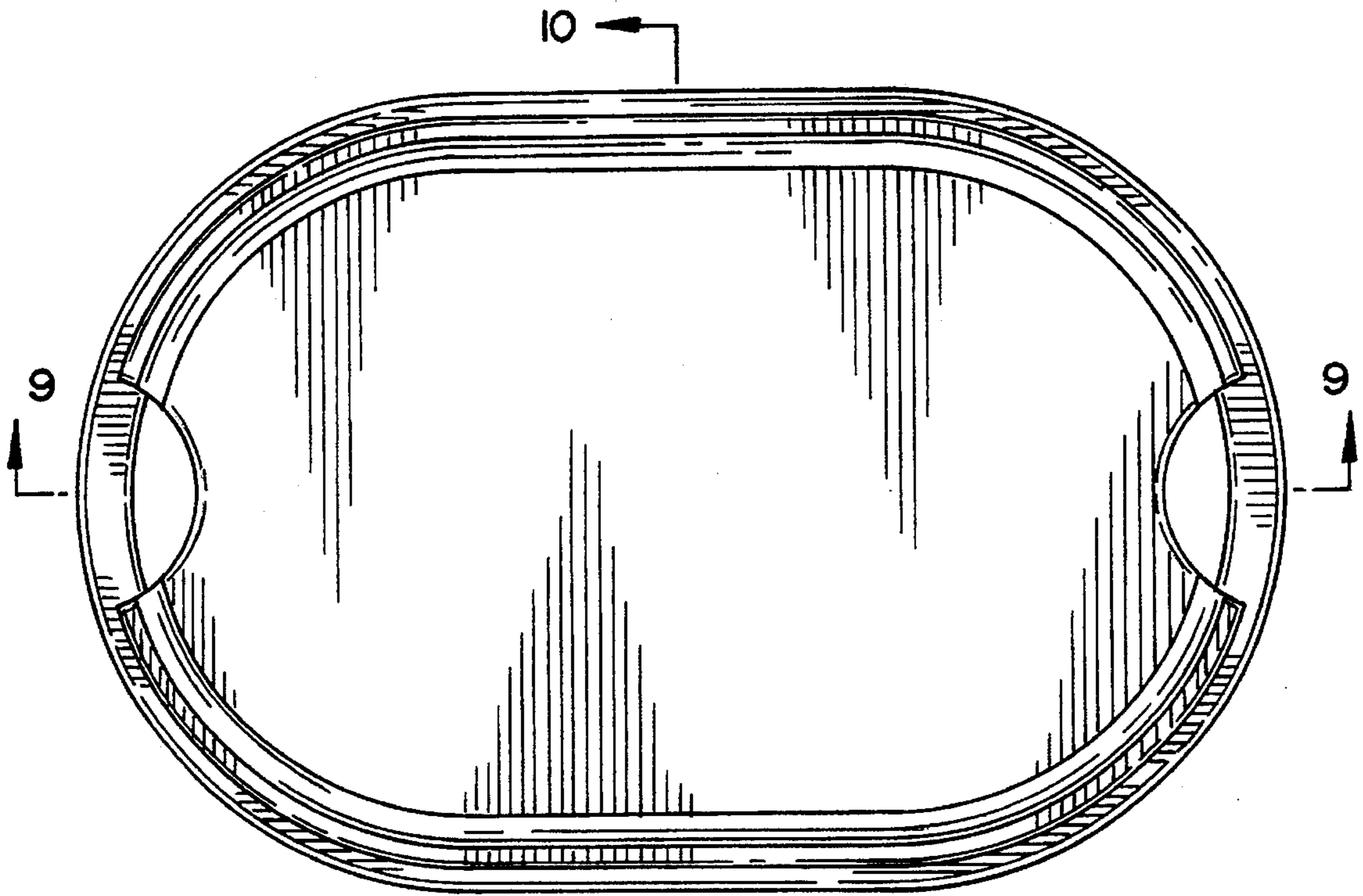

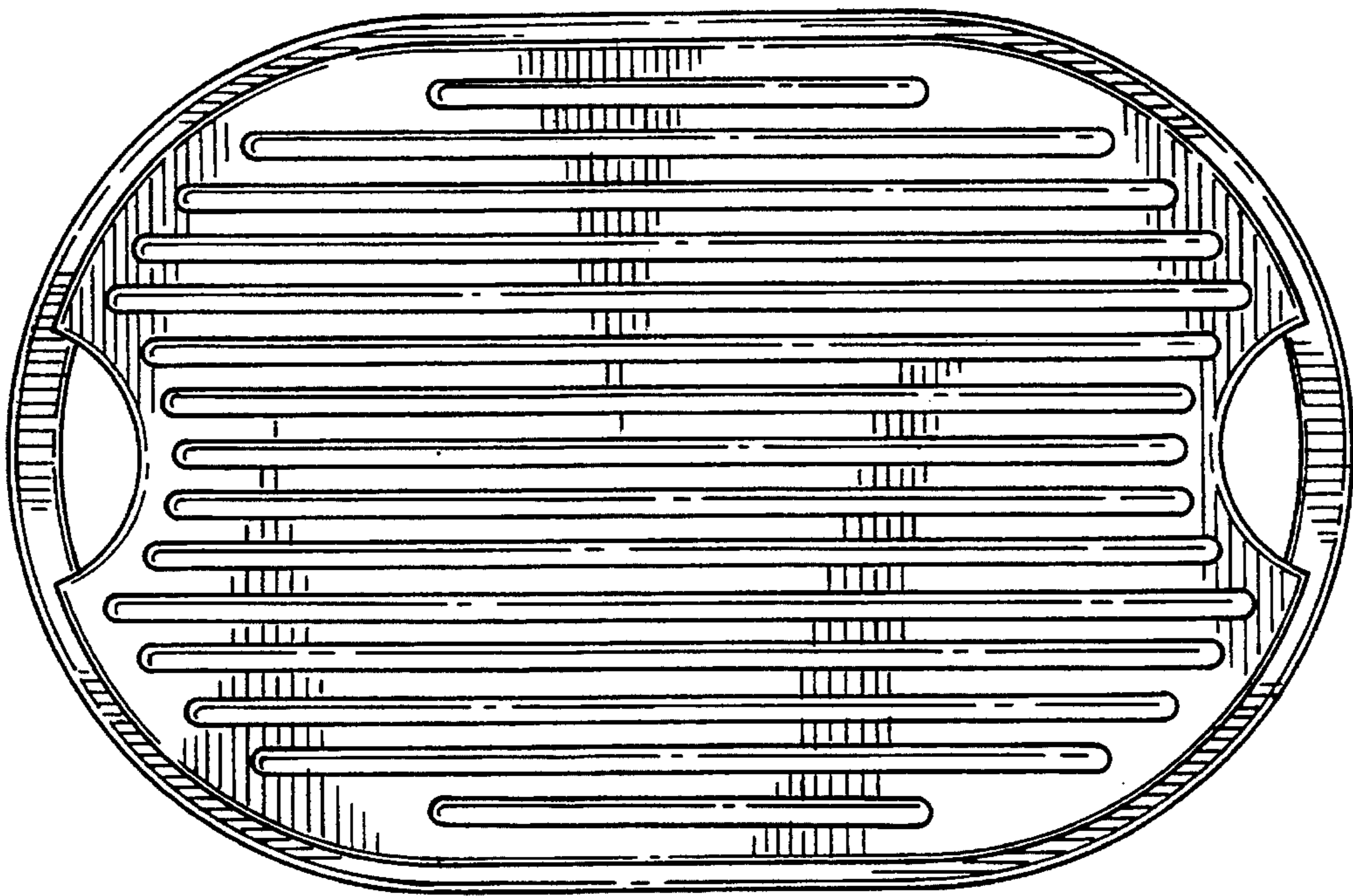

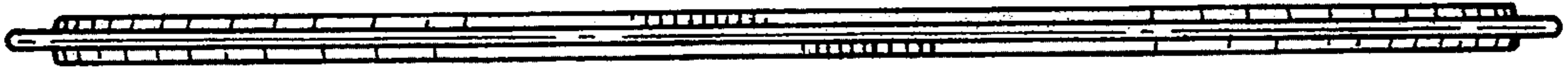

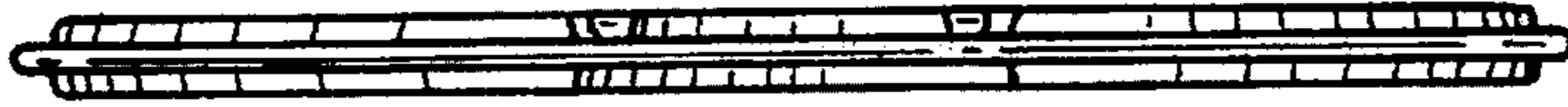

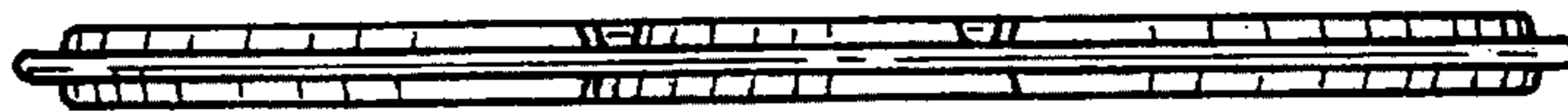
