FIG. 11 is a right side elevational view thereof.

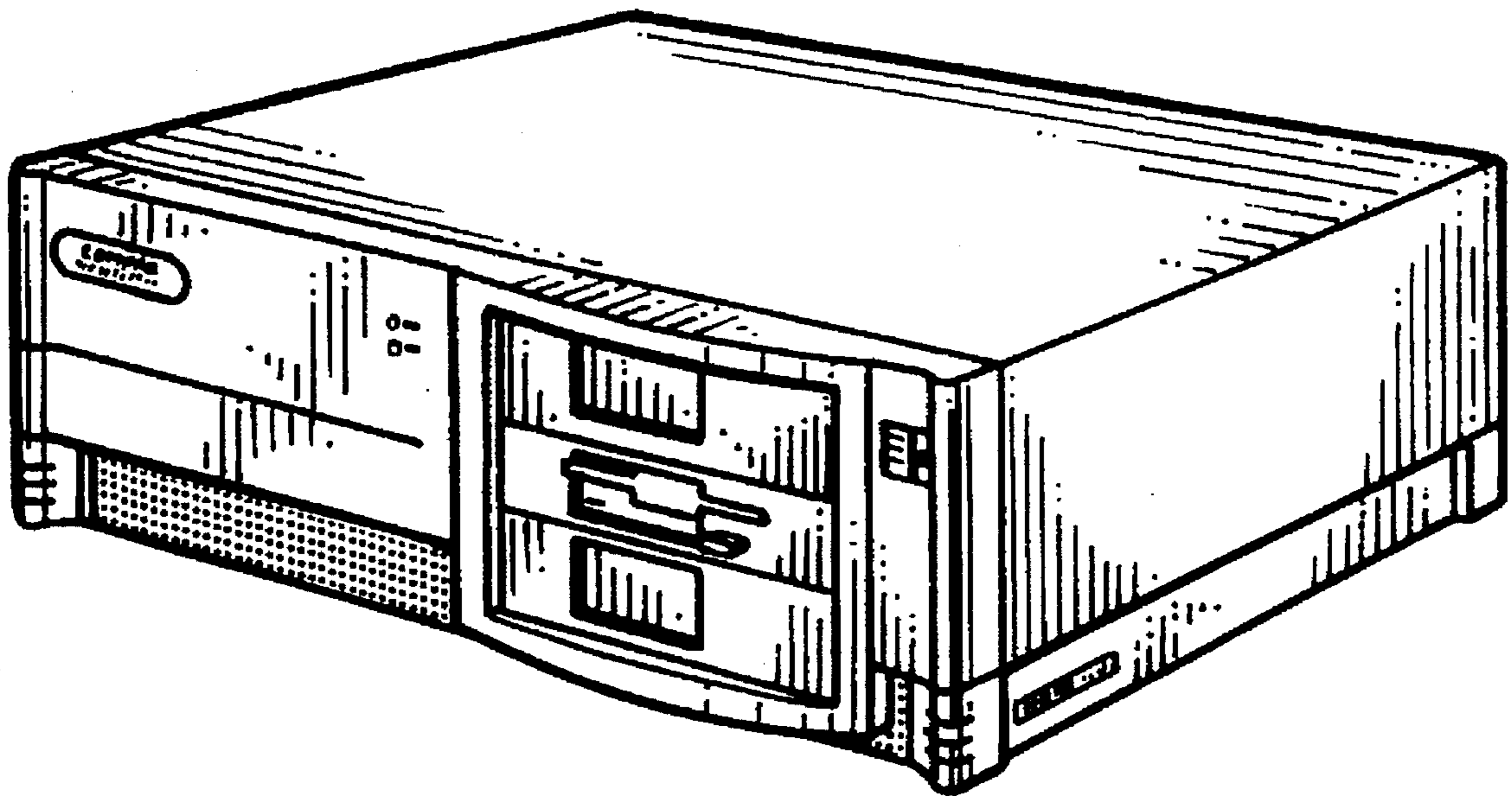

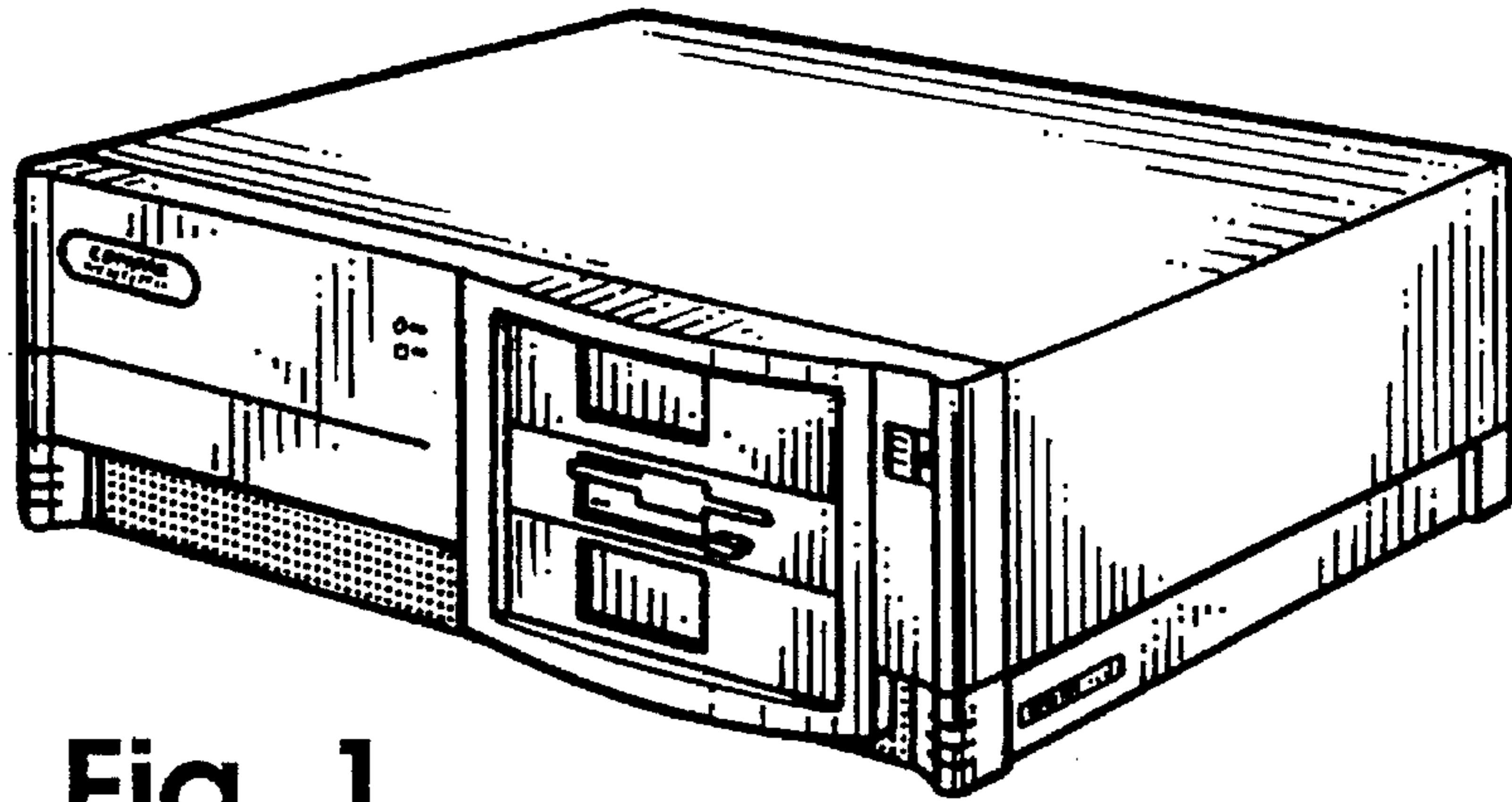

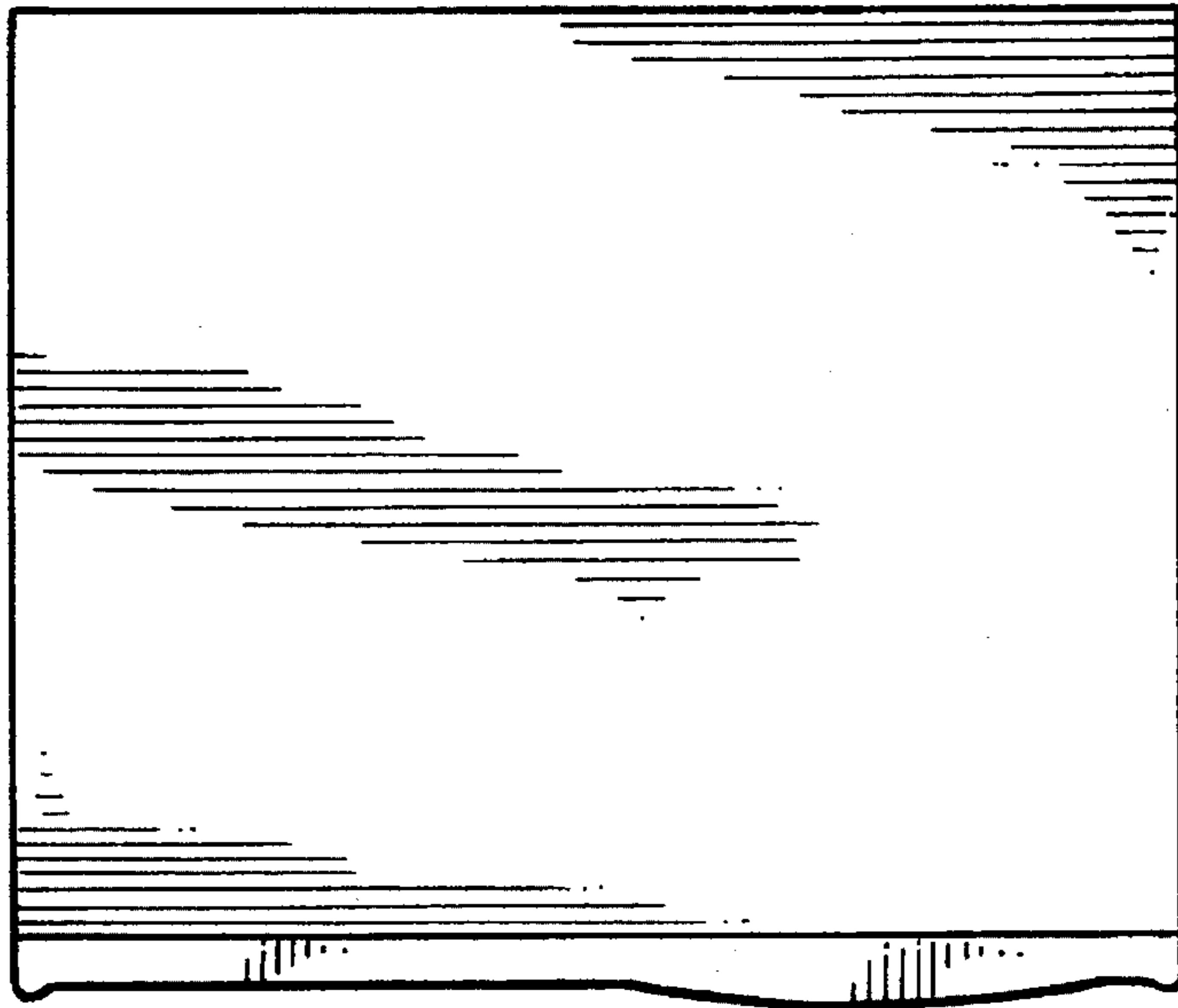
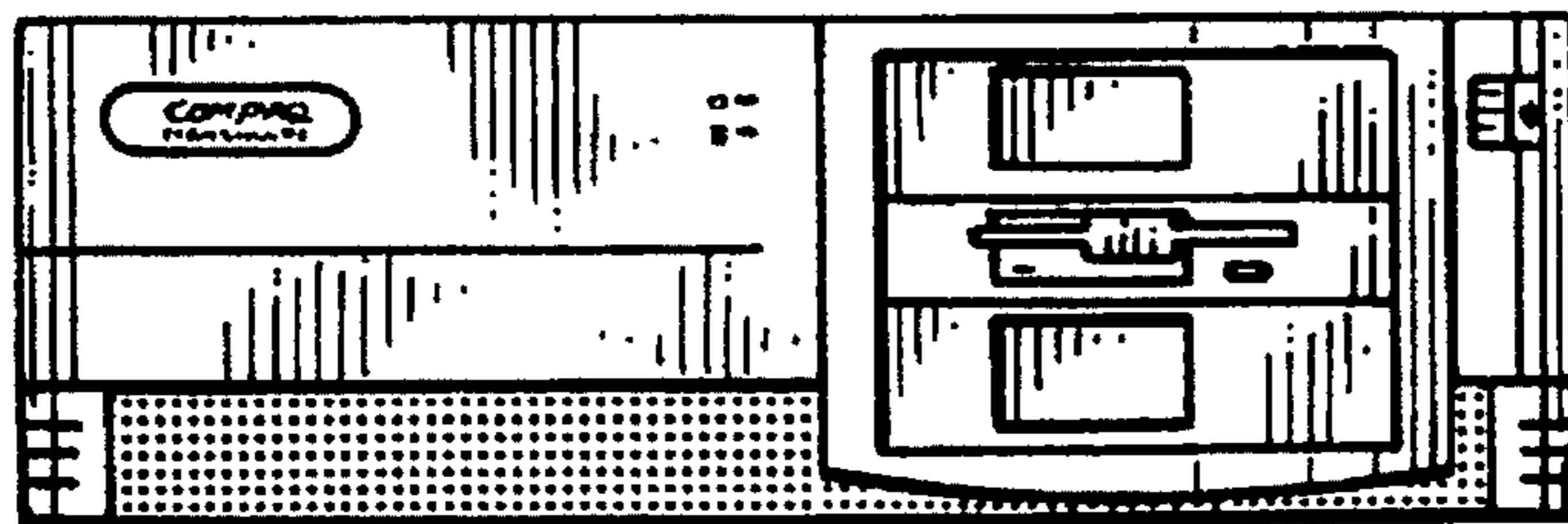

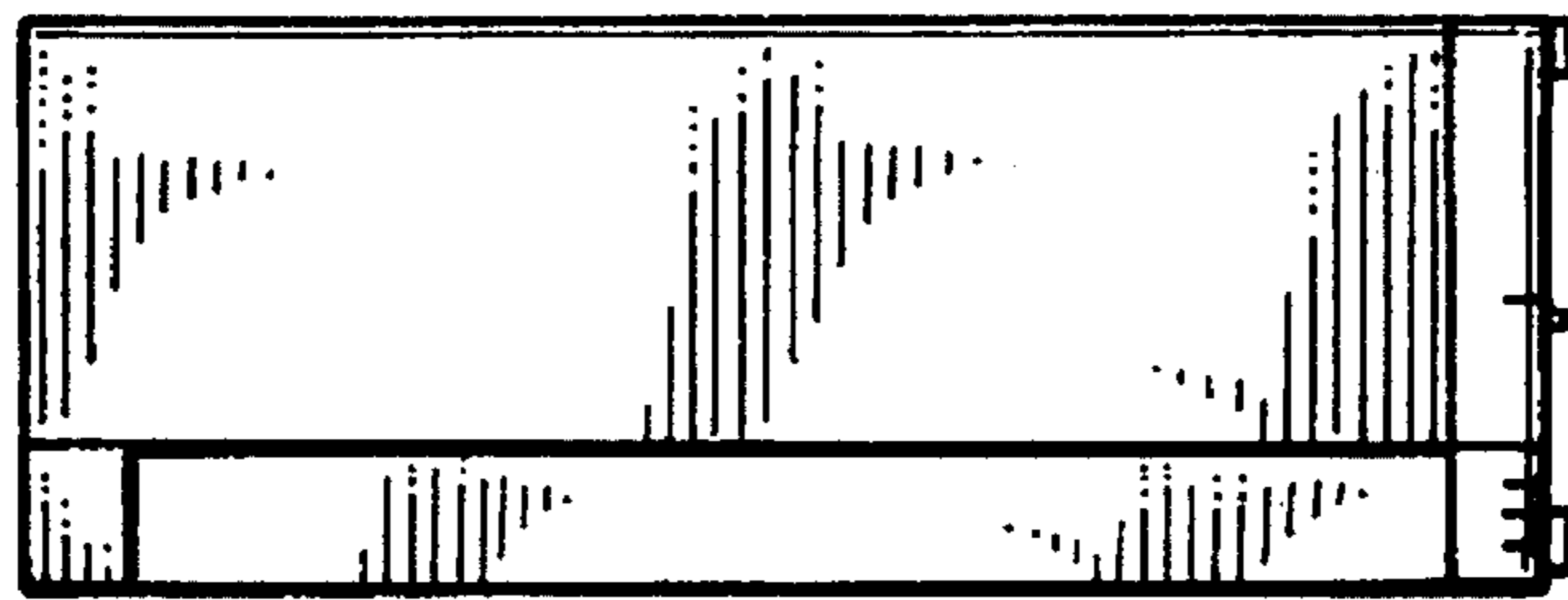

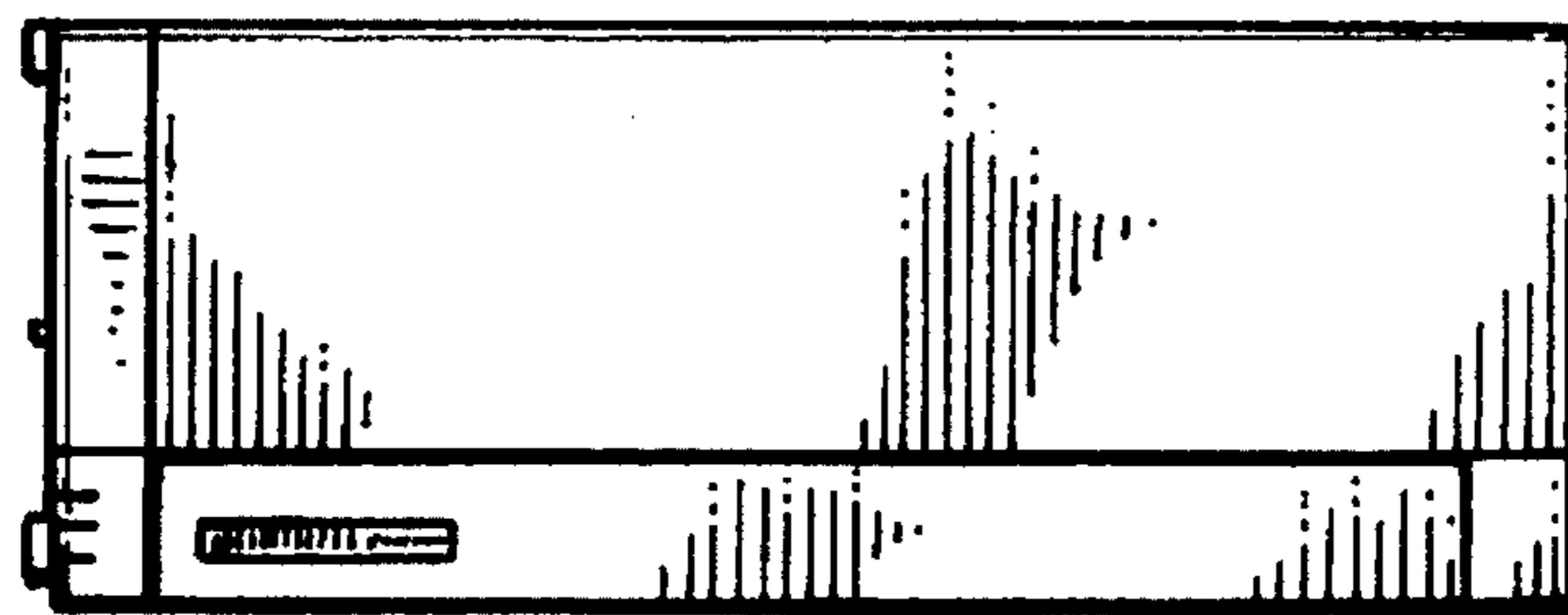

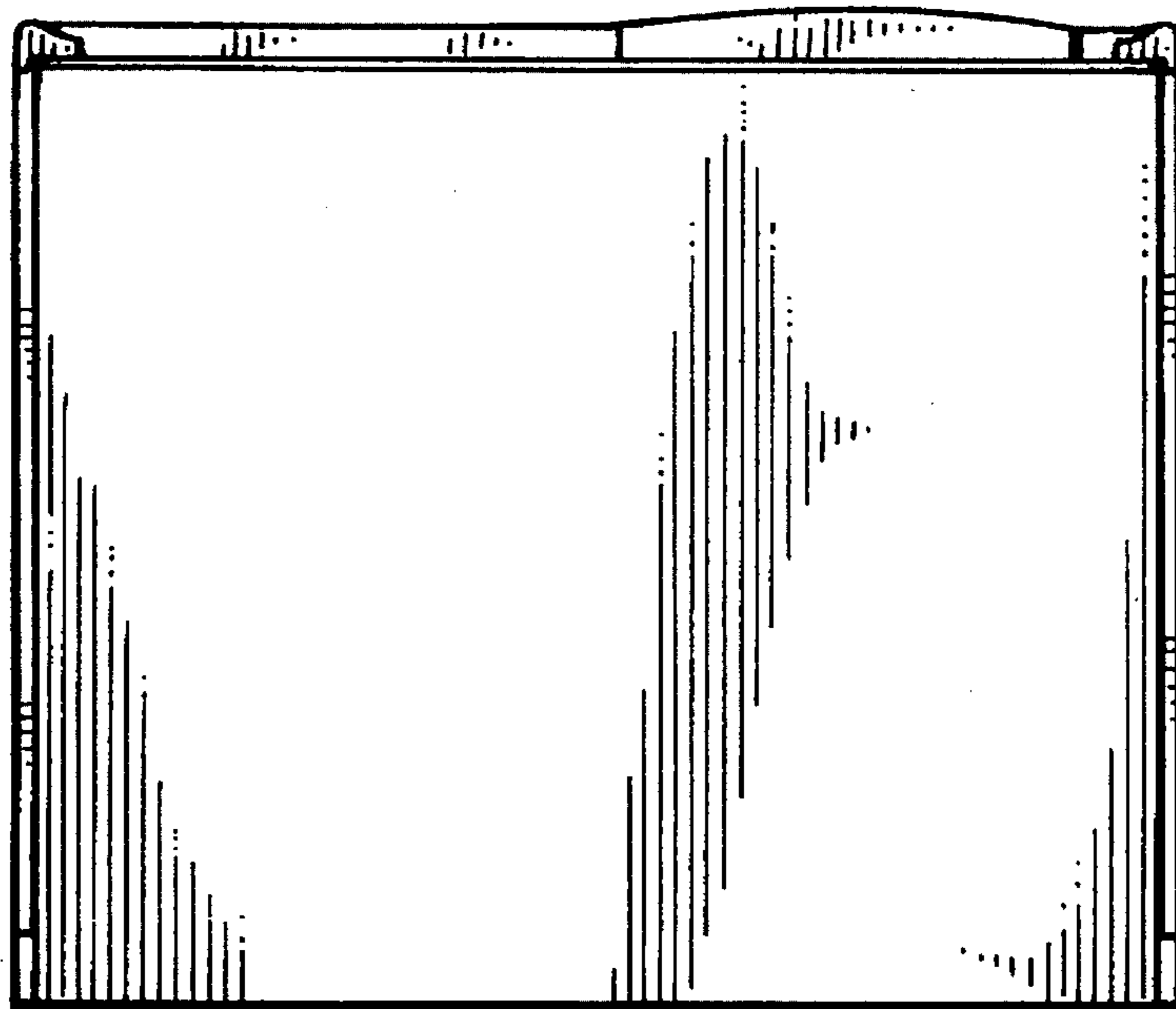

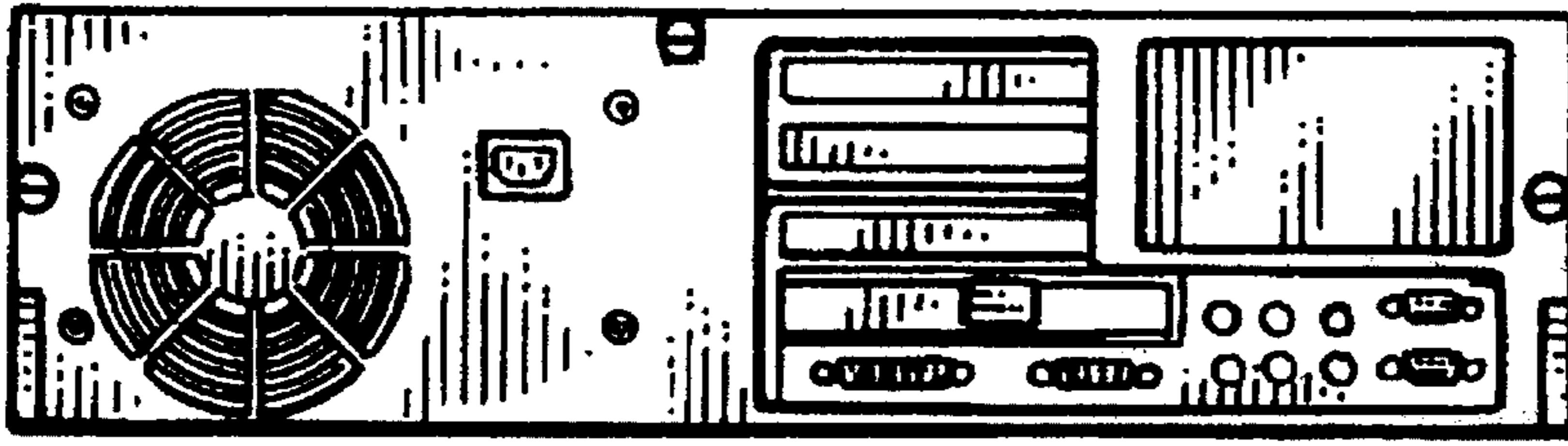

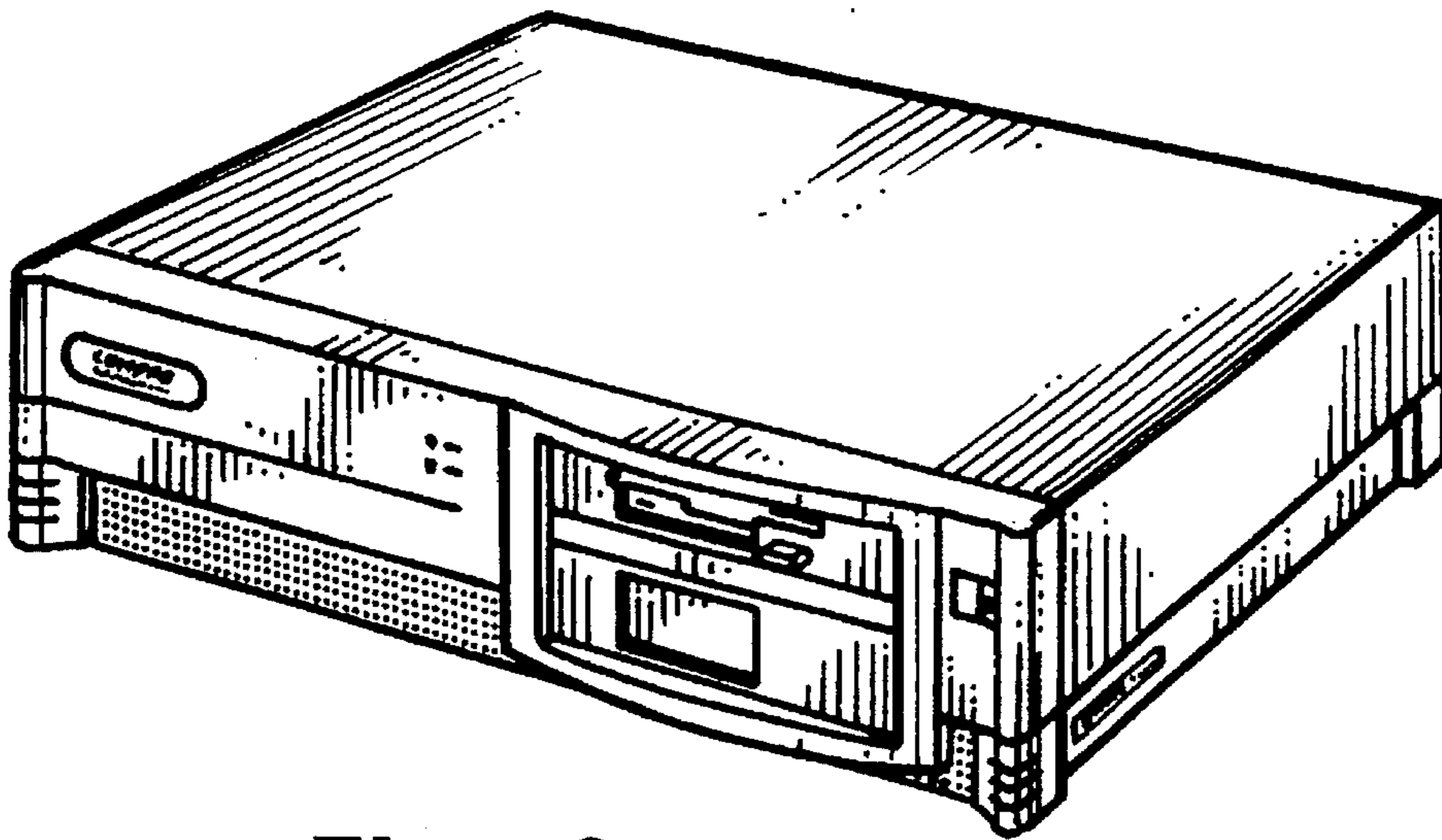

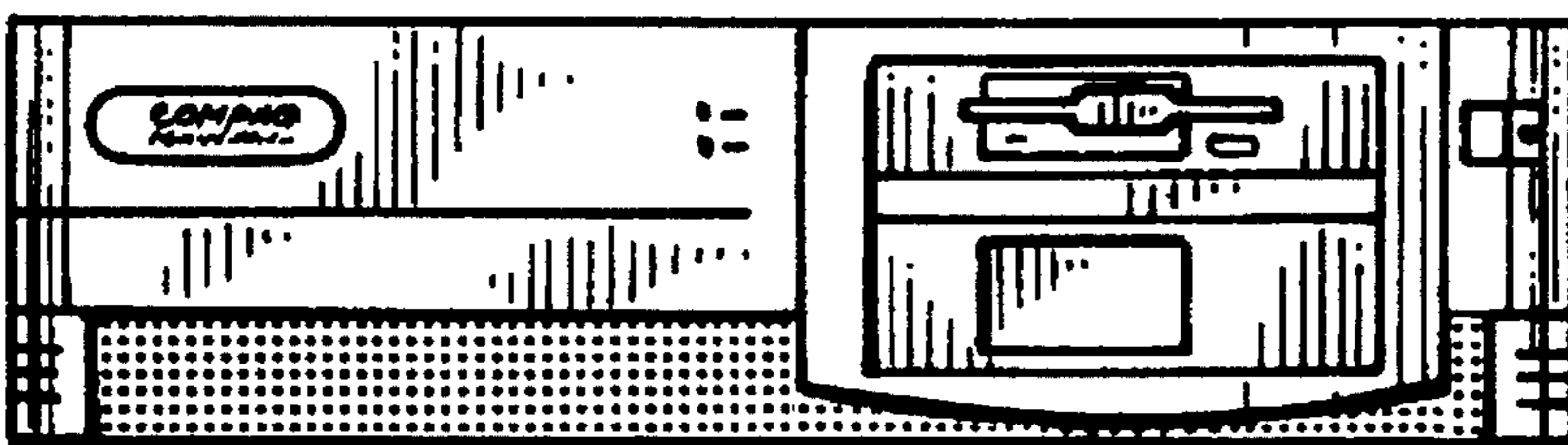

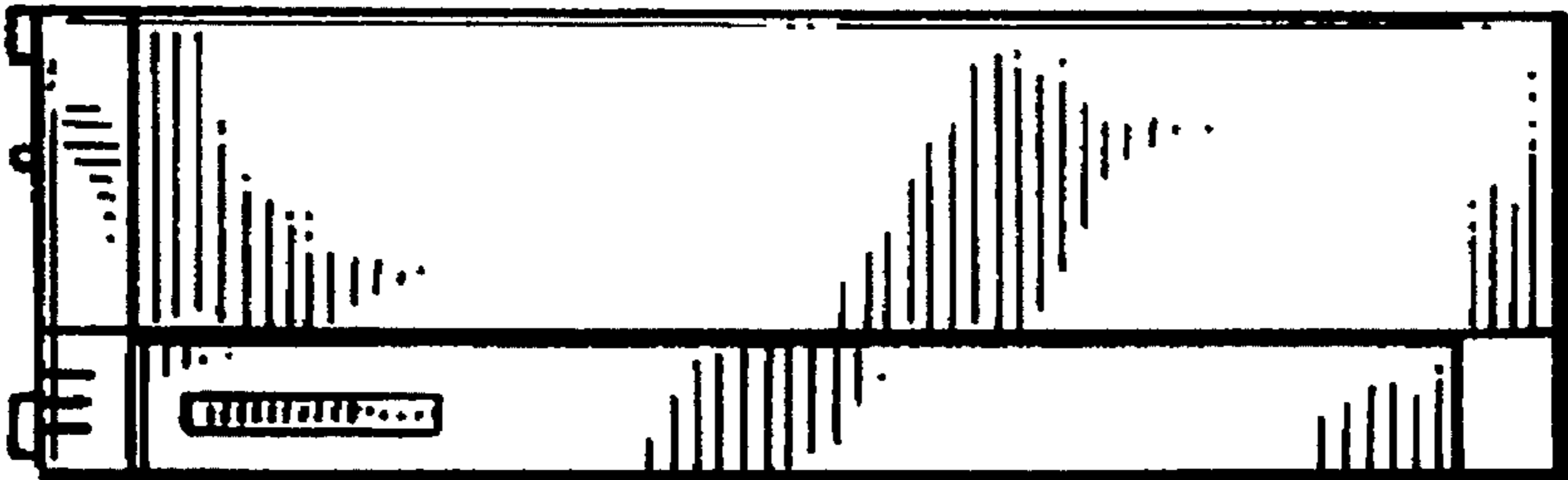
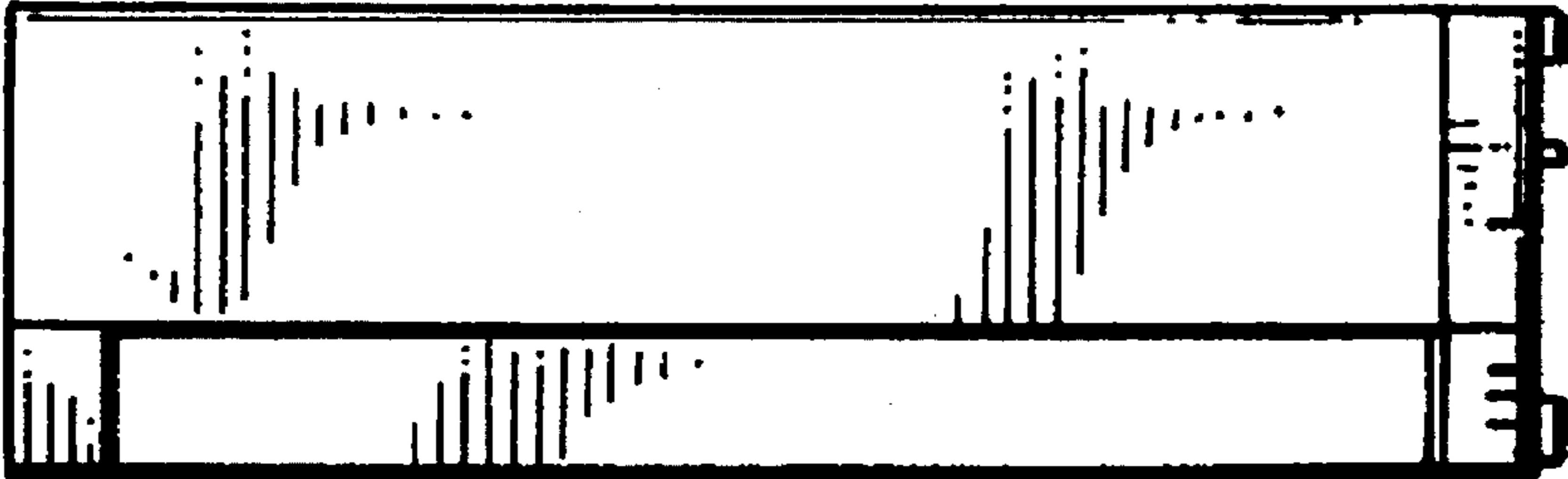
