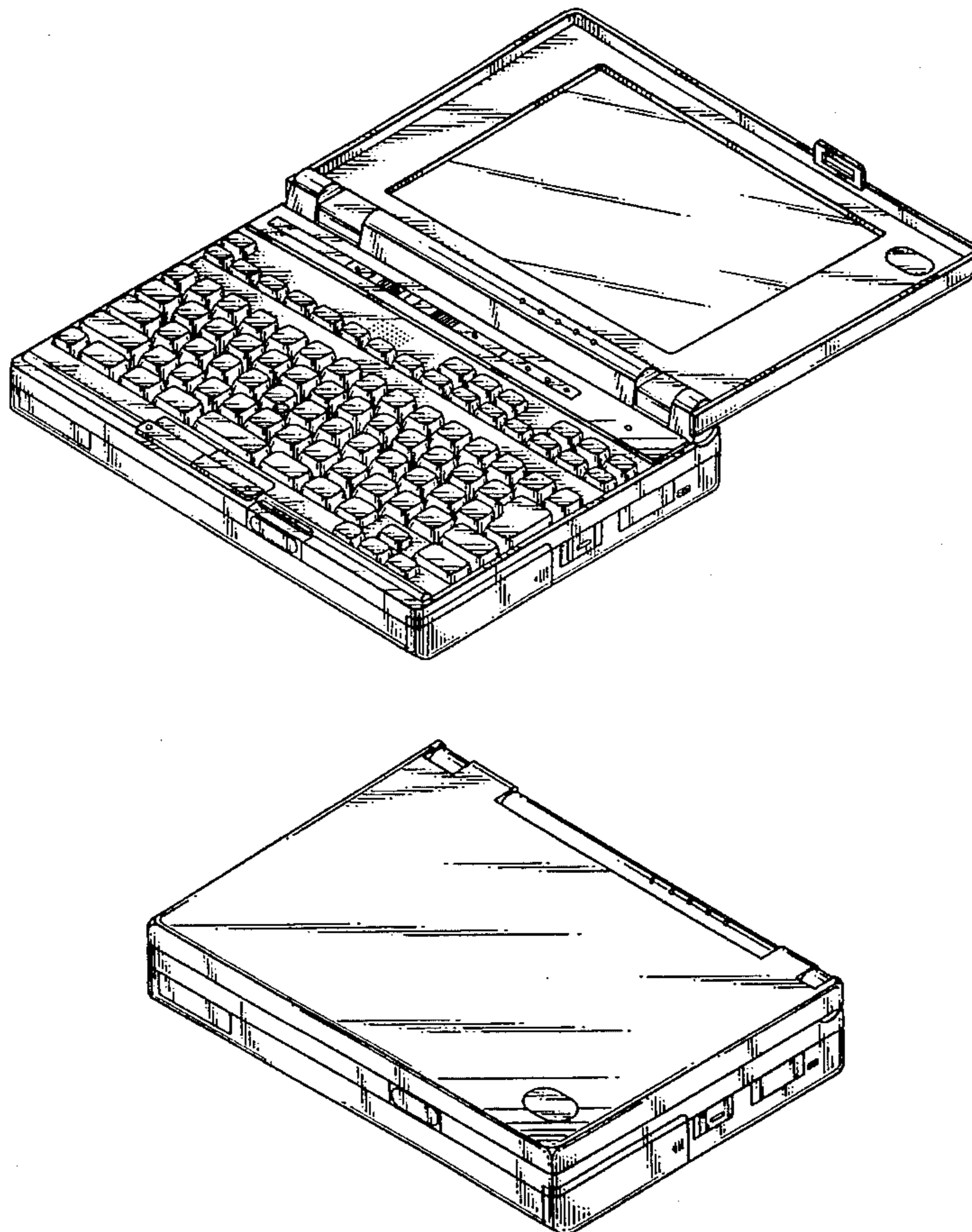

[57] **CLAIM**
The ornamental design for a personal laptop computer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the personal laptop computer of the present invention in an opened posture;
FIG. 2 is a front elevational view thereof in an opened posture;
FIG. 3 is a top plan view thereof in an opened posture;
FIG. 4 is a rear elevational view thereof in an opened posture;
FIG. 5 is a bottom plan view thereof in an opened posture;
FIG. 6 is a right side elevational view thereof in an opened posture;
FIG. 7 is a left side elevational view thereof in an opened posture;
FIG. 8 is a perspective view thereof in a closed posture;
FIG. 9 is a front elevational view thereof in a closed posture;
FIG. 10 is a top plan view thereof in a closed posture;
FIG. 11 is a rear elevational view thereof in a closed posture;
FIG. 12 is a bottom plan view thereof in a closed posture;
FIG. 13 is a right side elevational view thereof in a closed posture; and,
FIG. 14 is a left side elevational view thereof in a closed posture.

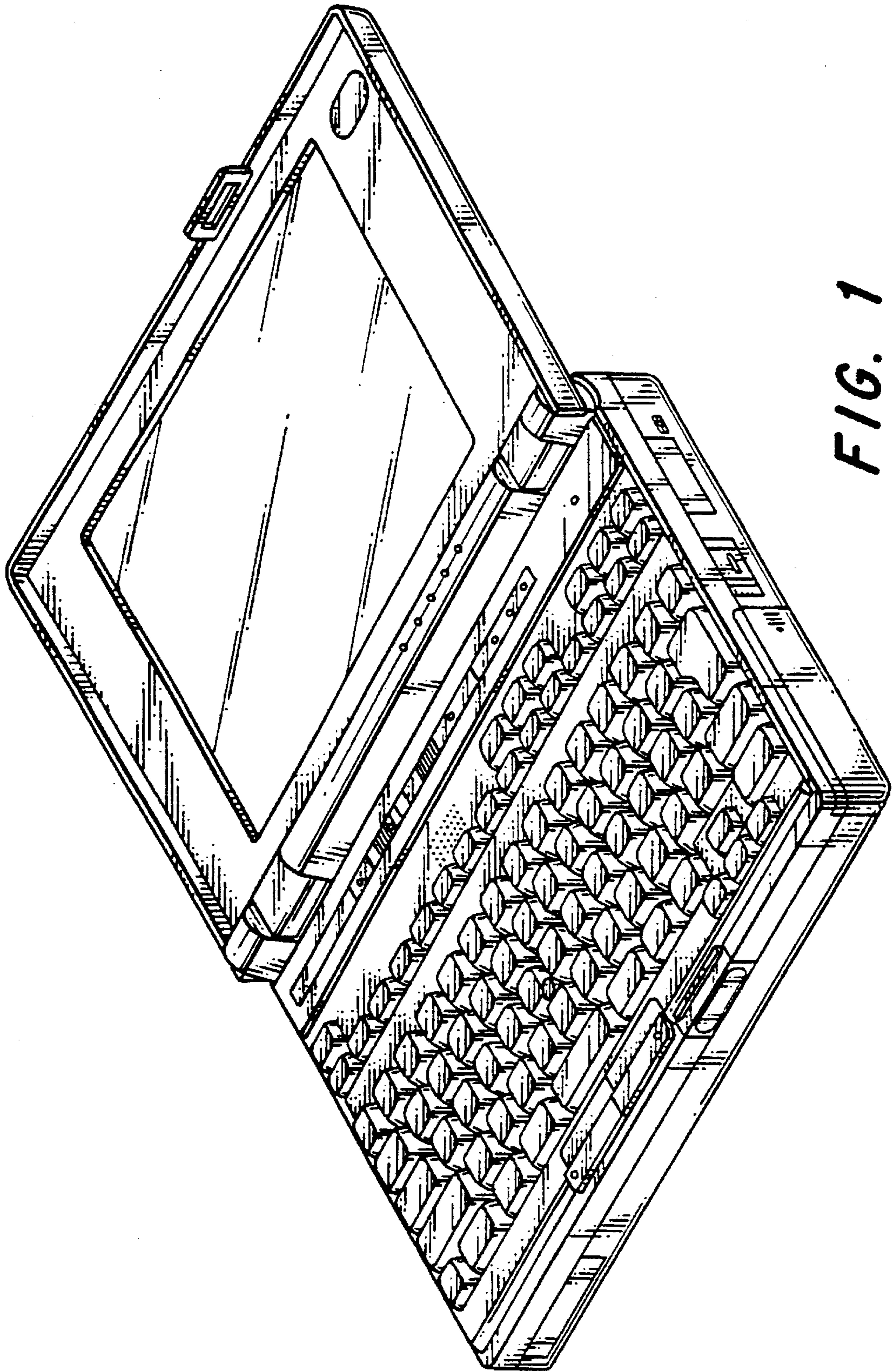

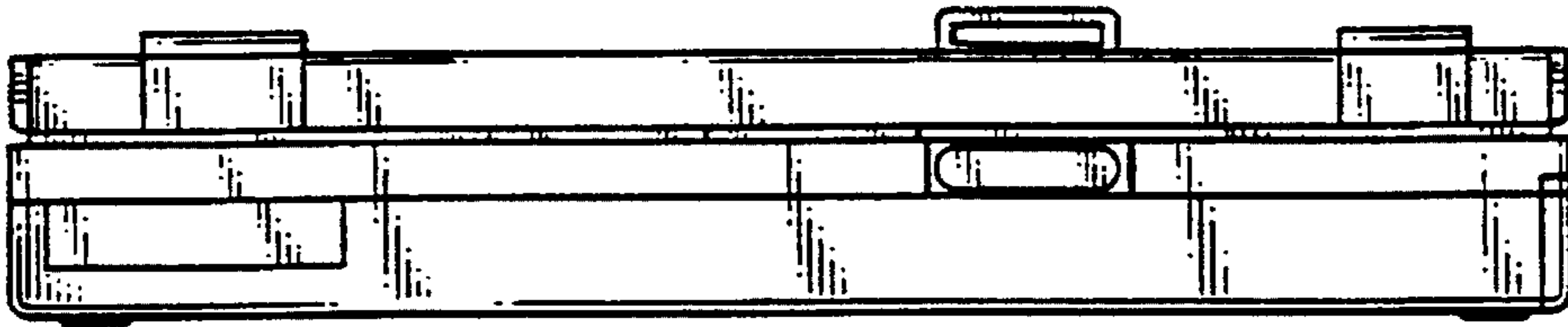

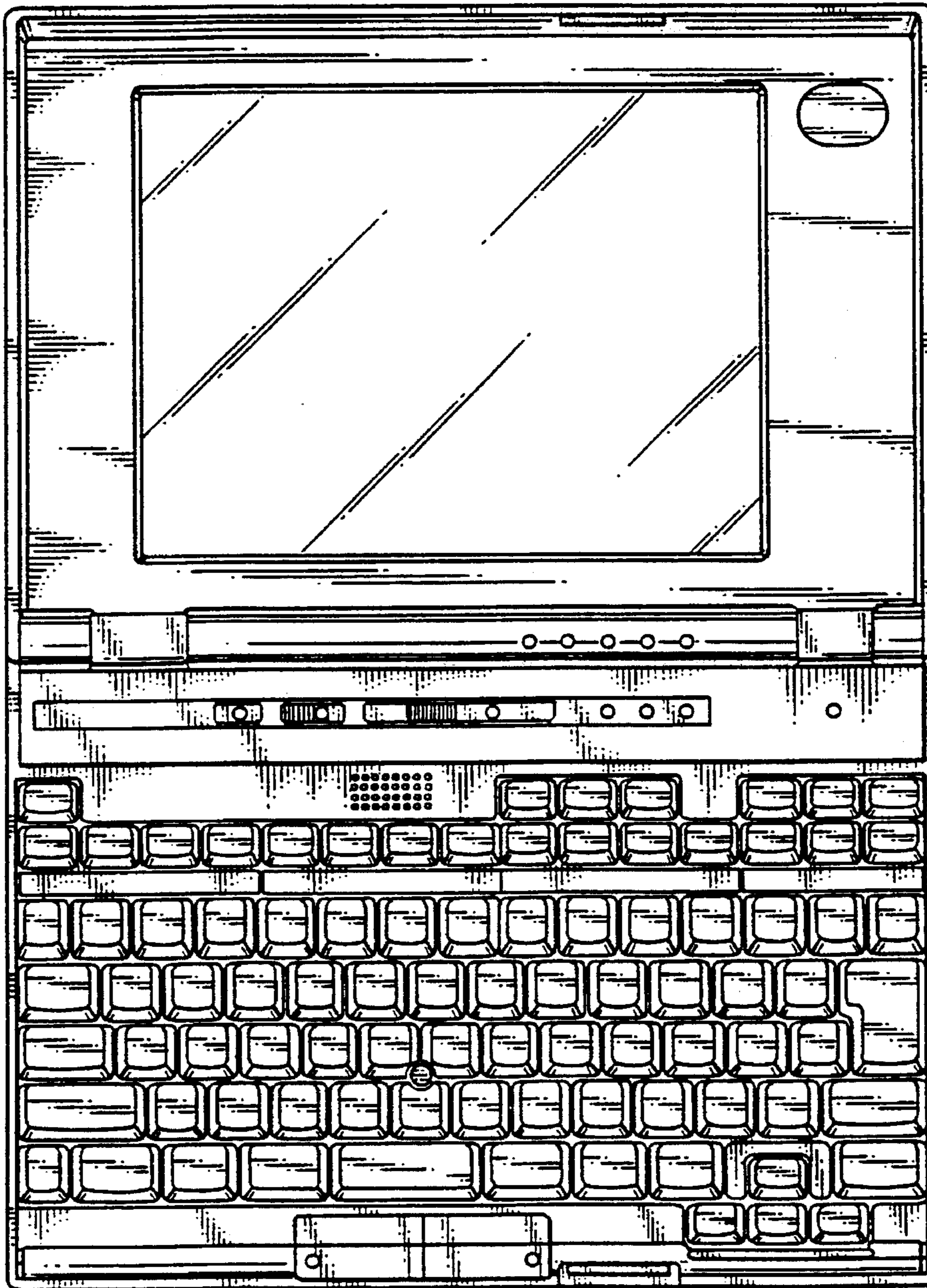

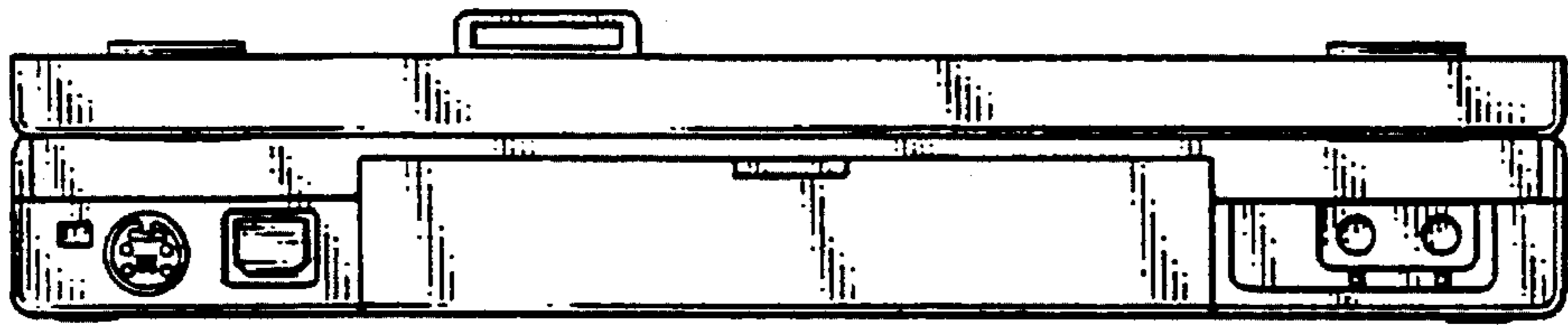

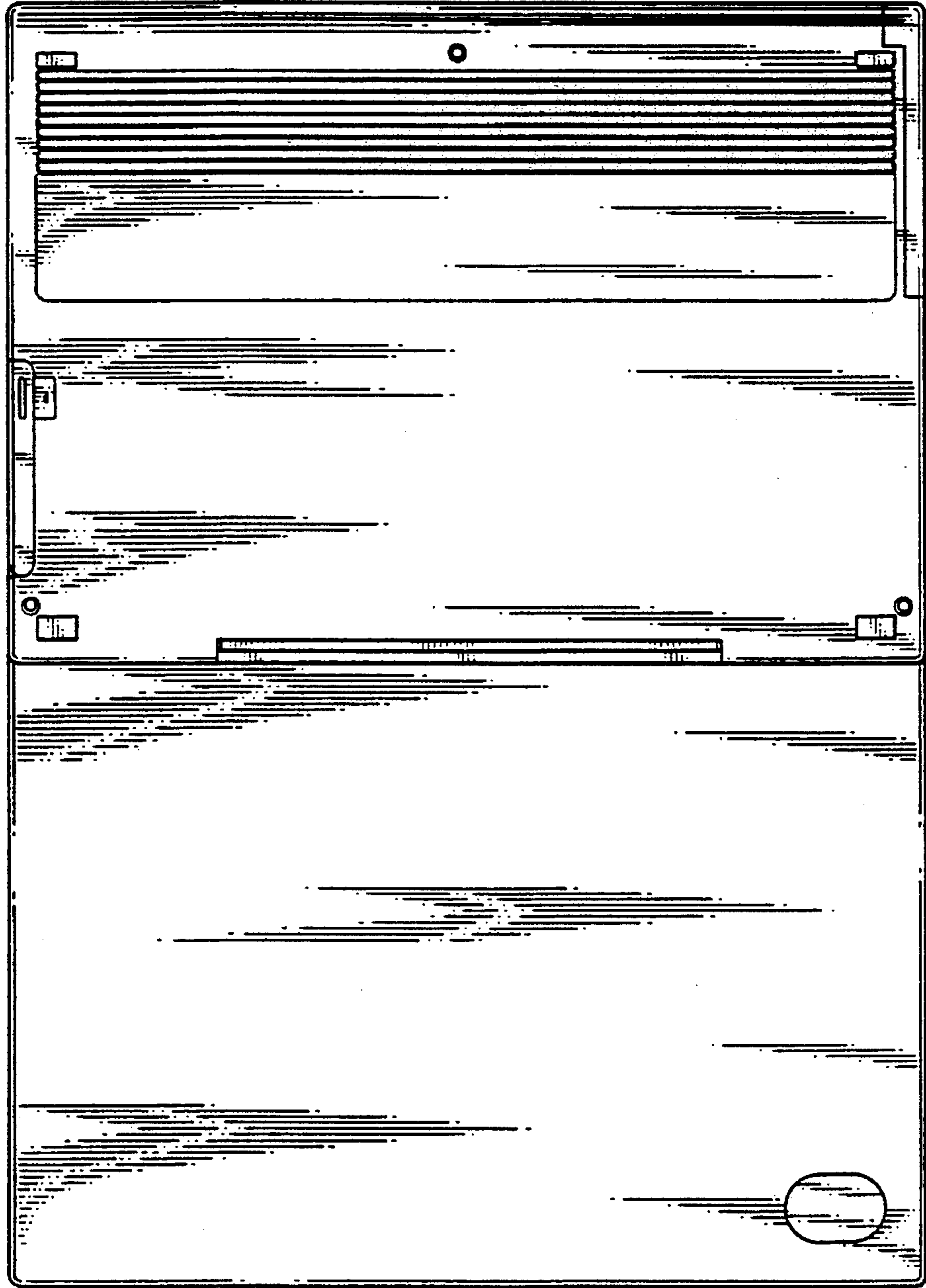

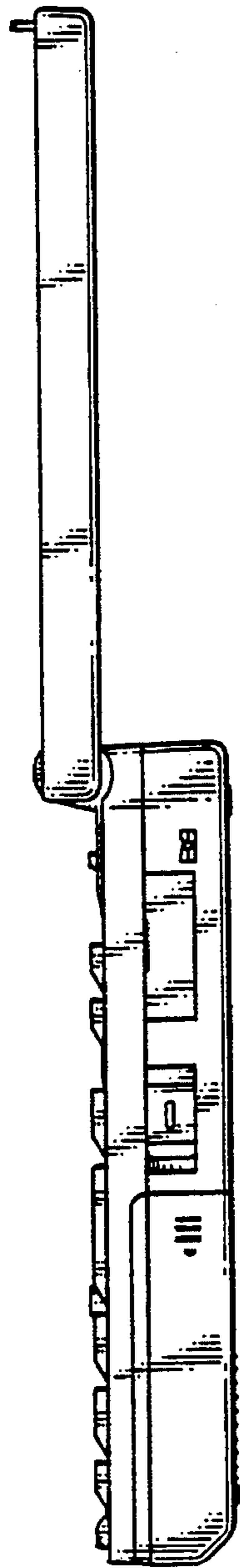

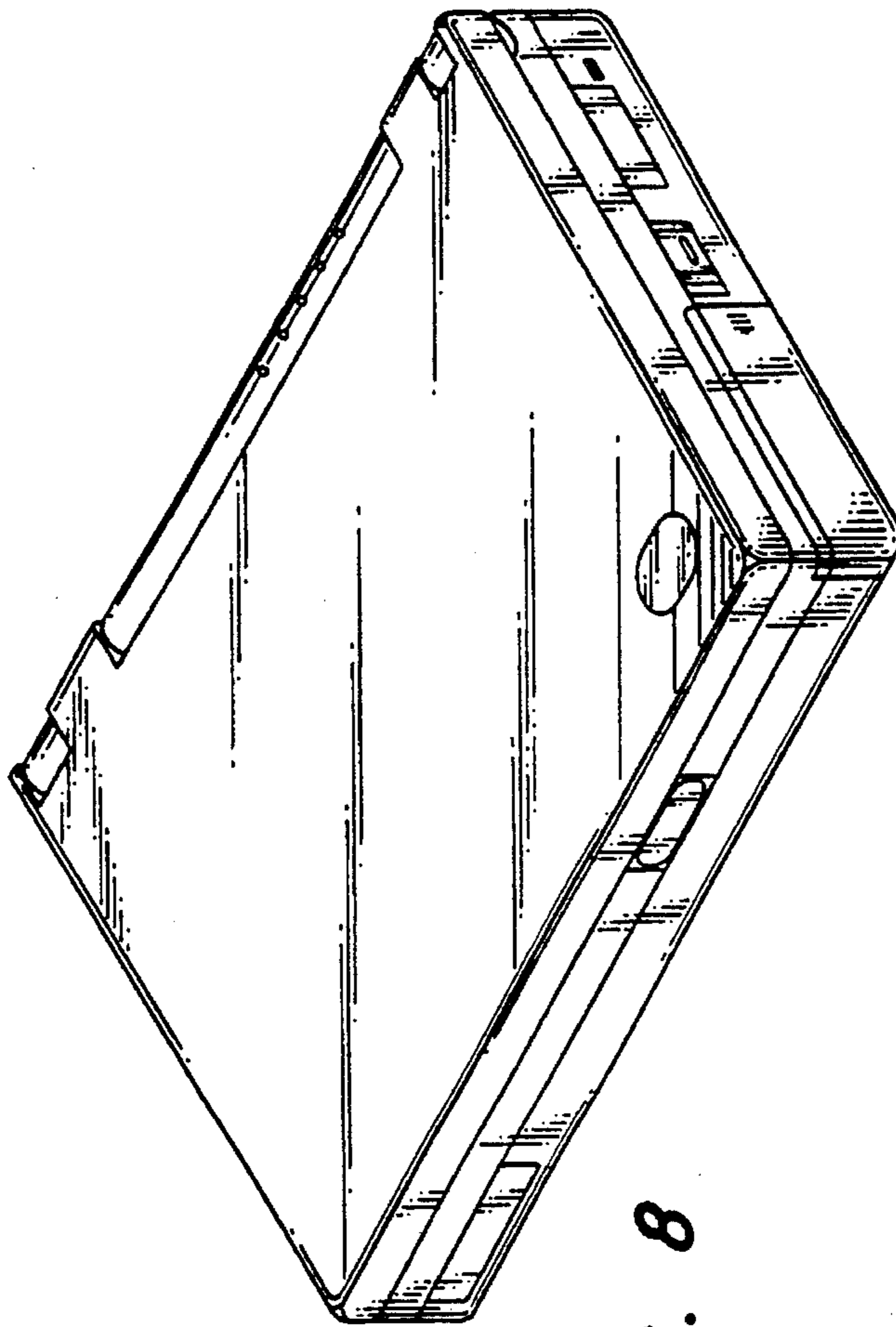

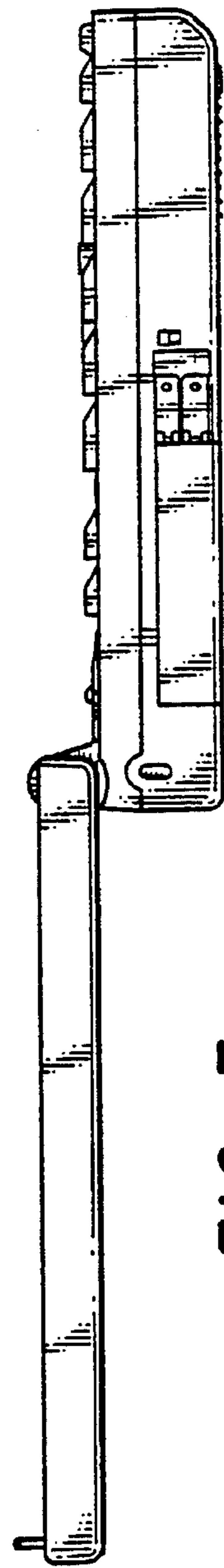

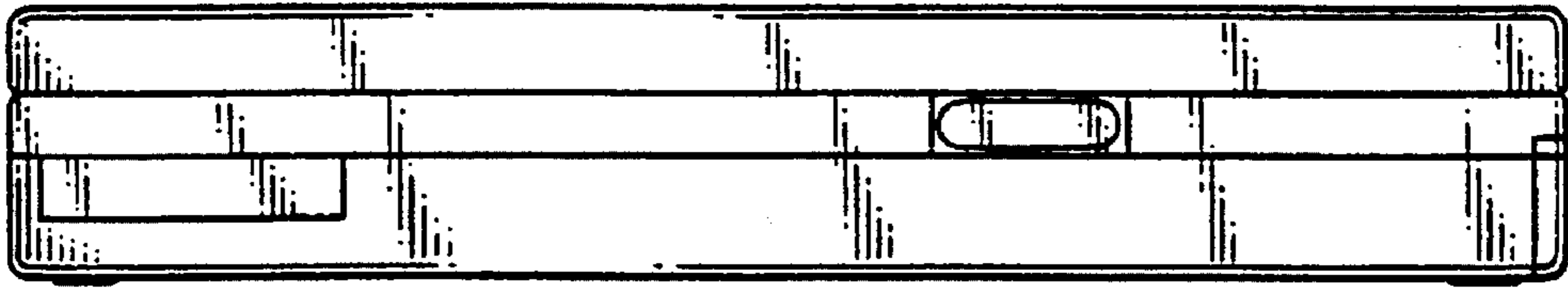

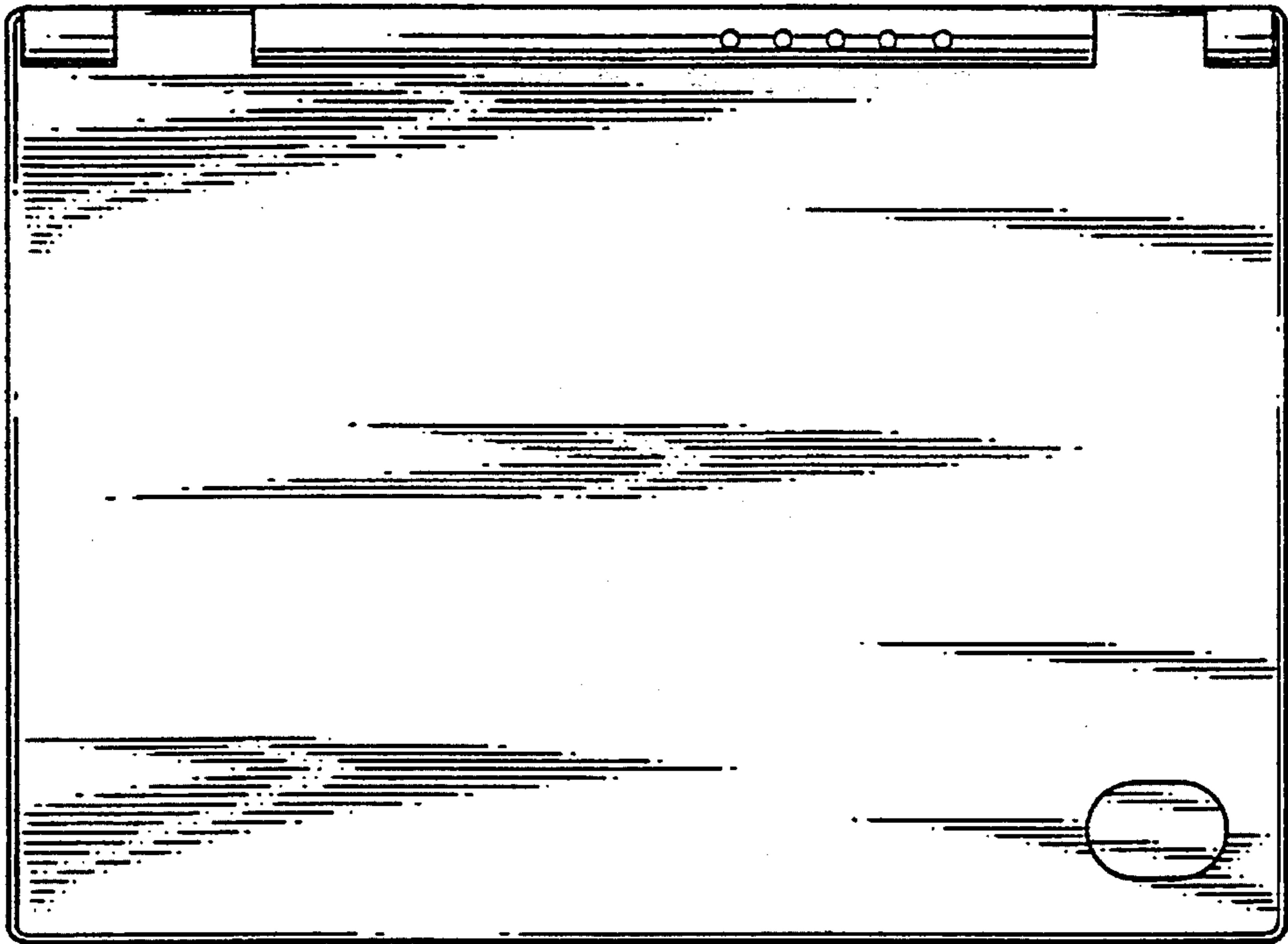

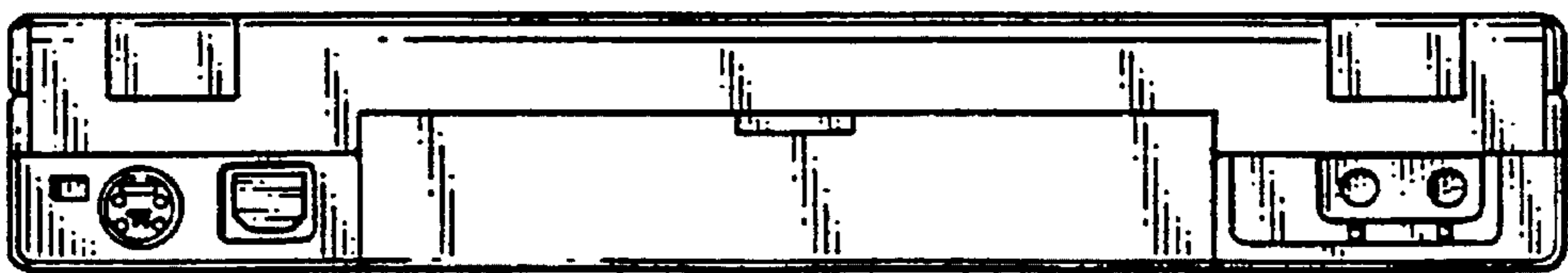

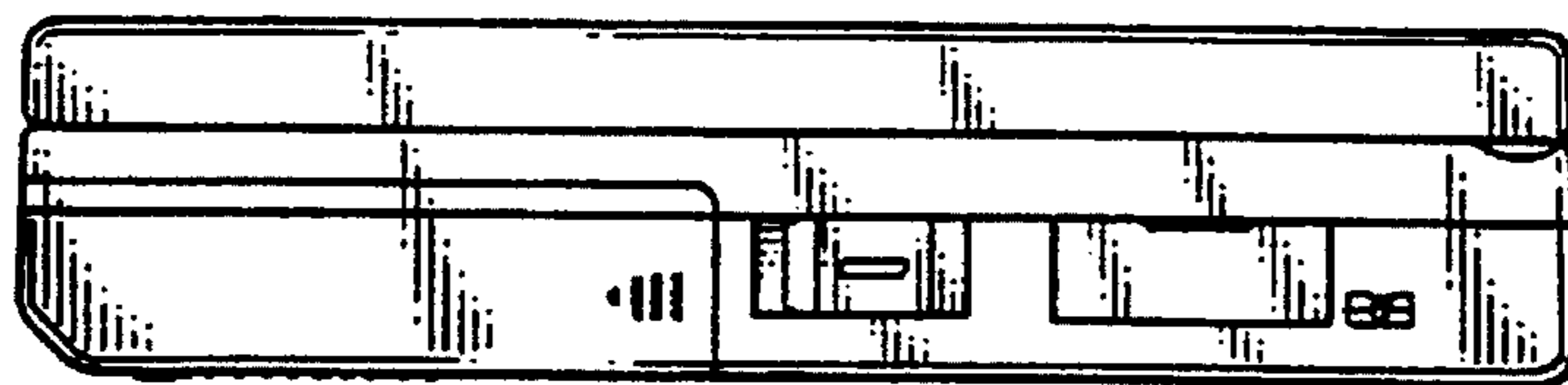

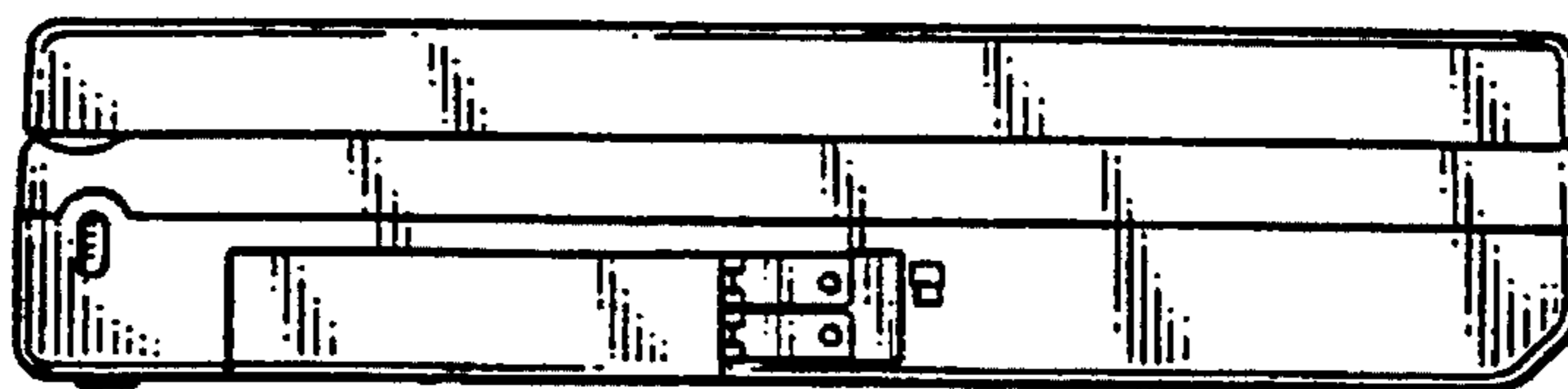
