The ornamental design for a video camera with video tape recorder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a video camera with video tape recorder showing my new design;

 FIG. 5 is a left side elevational view thereof;

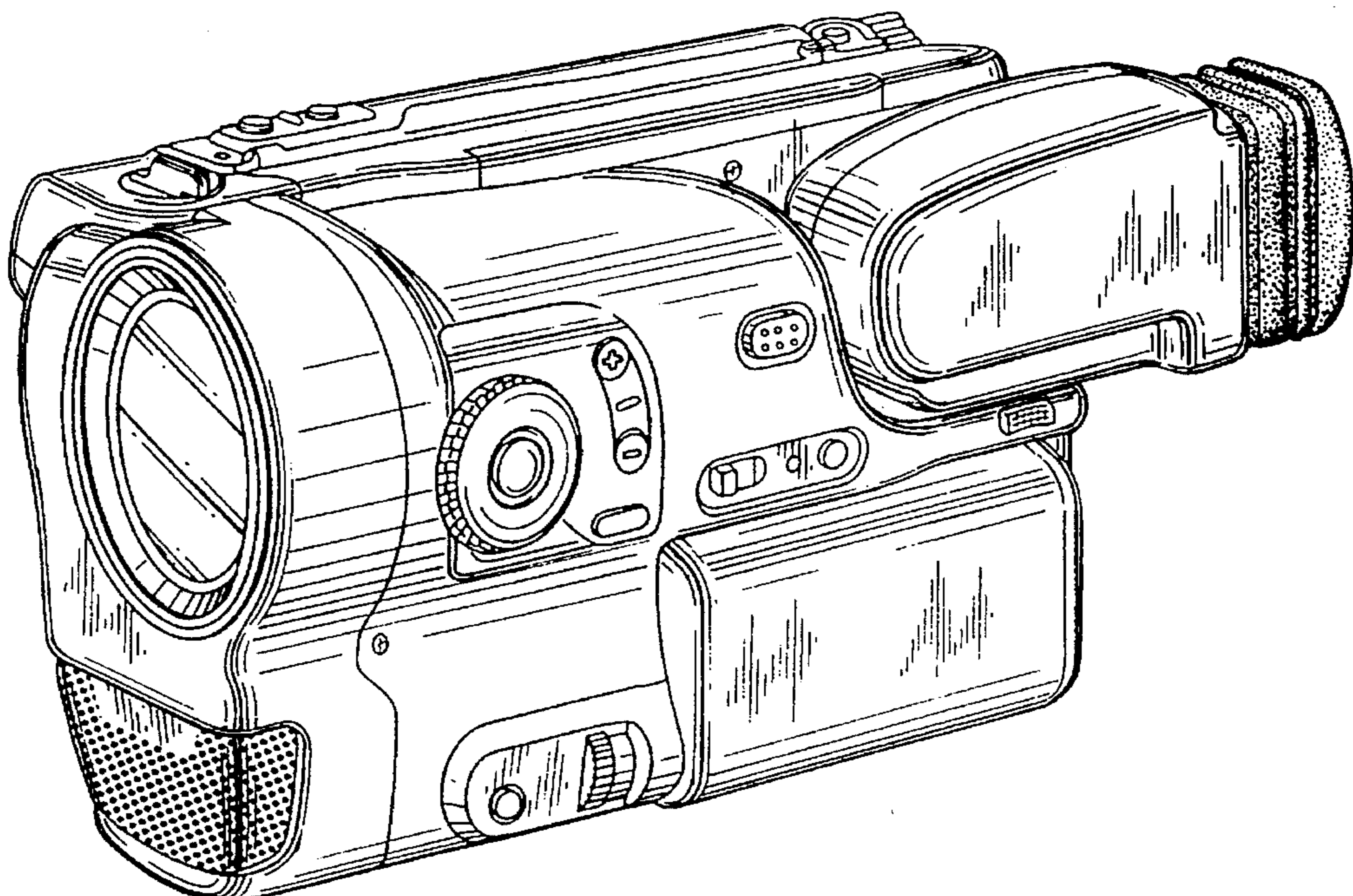

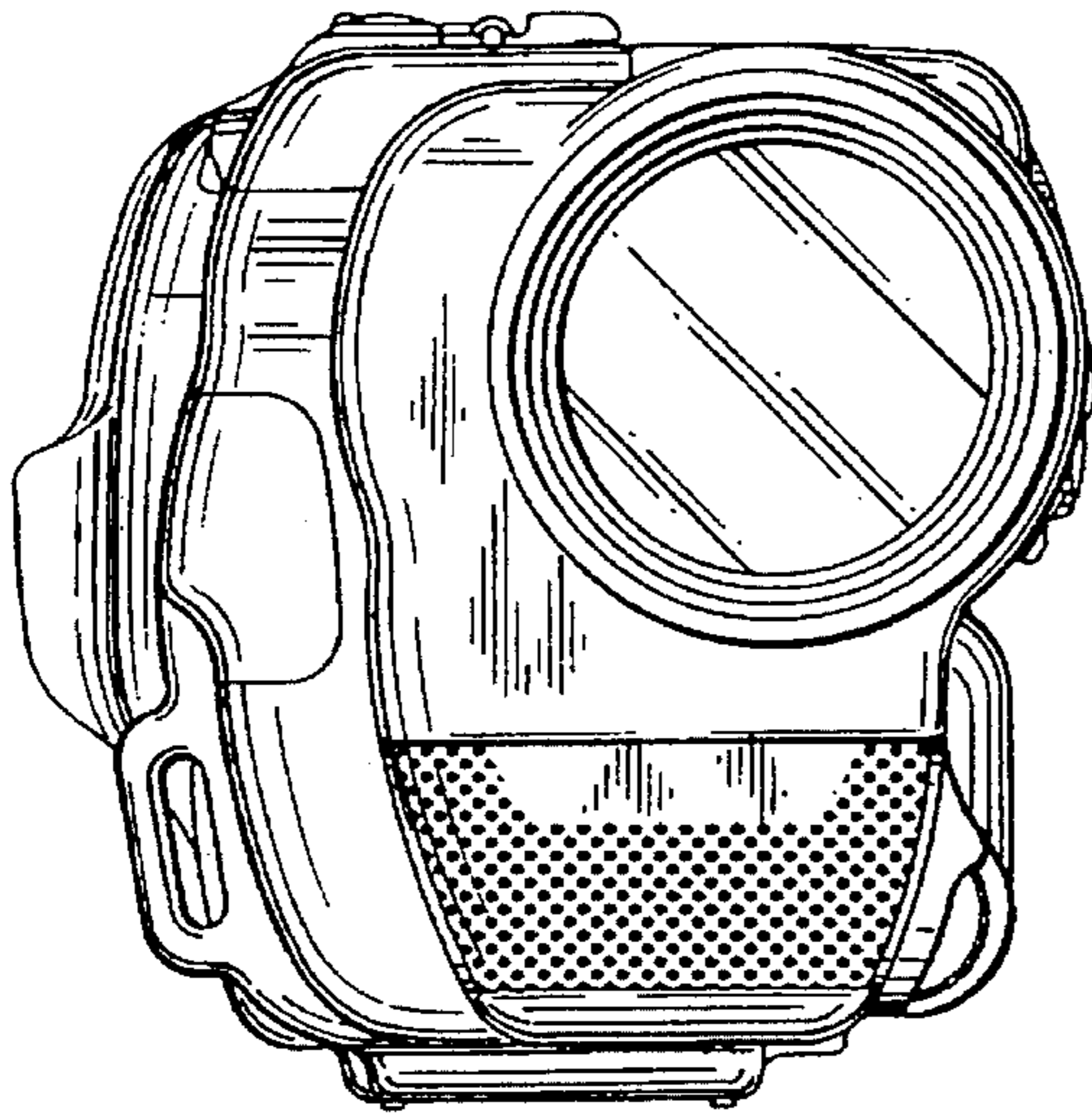

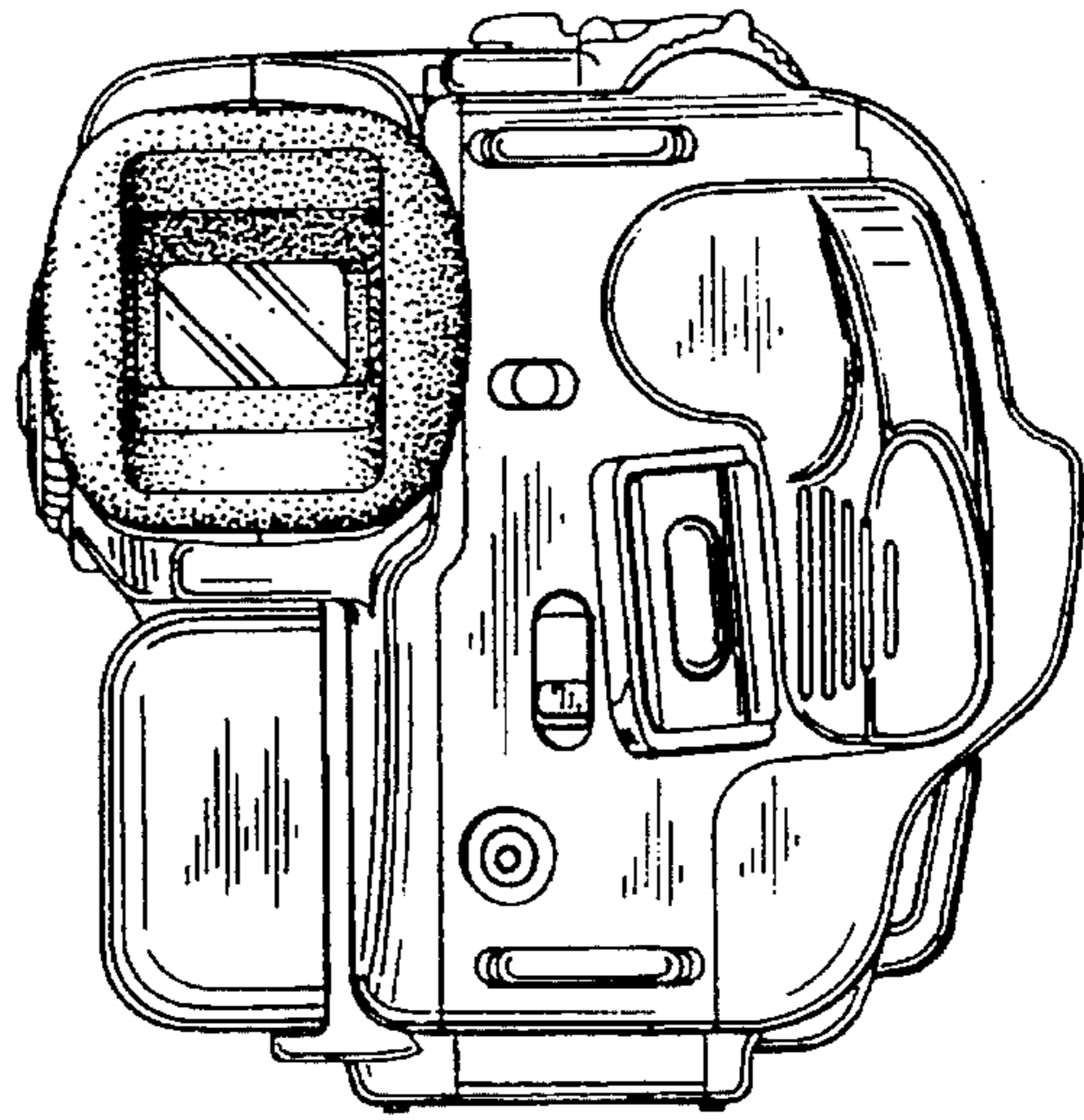

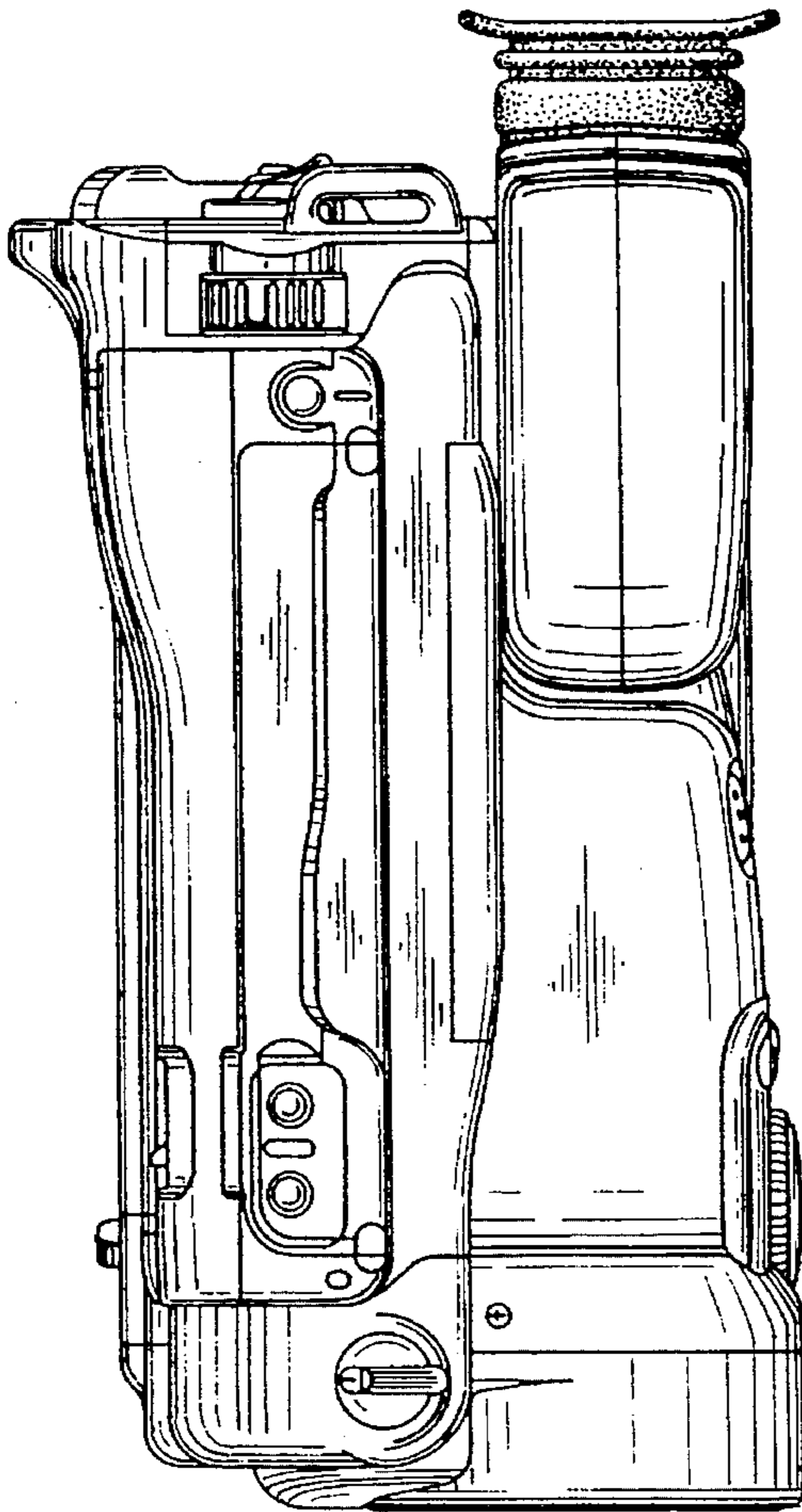

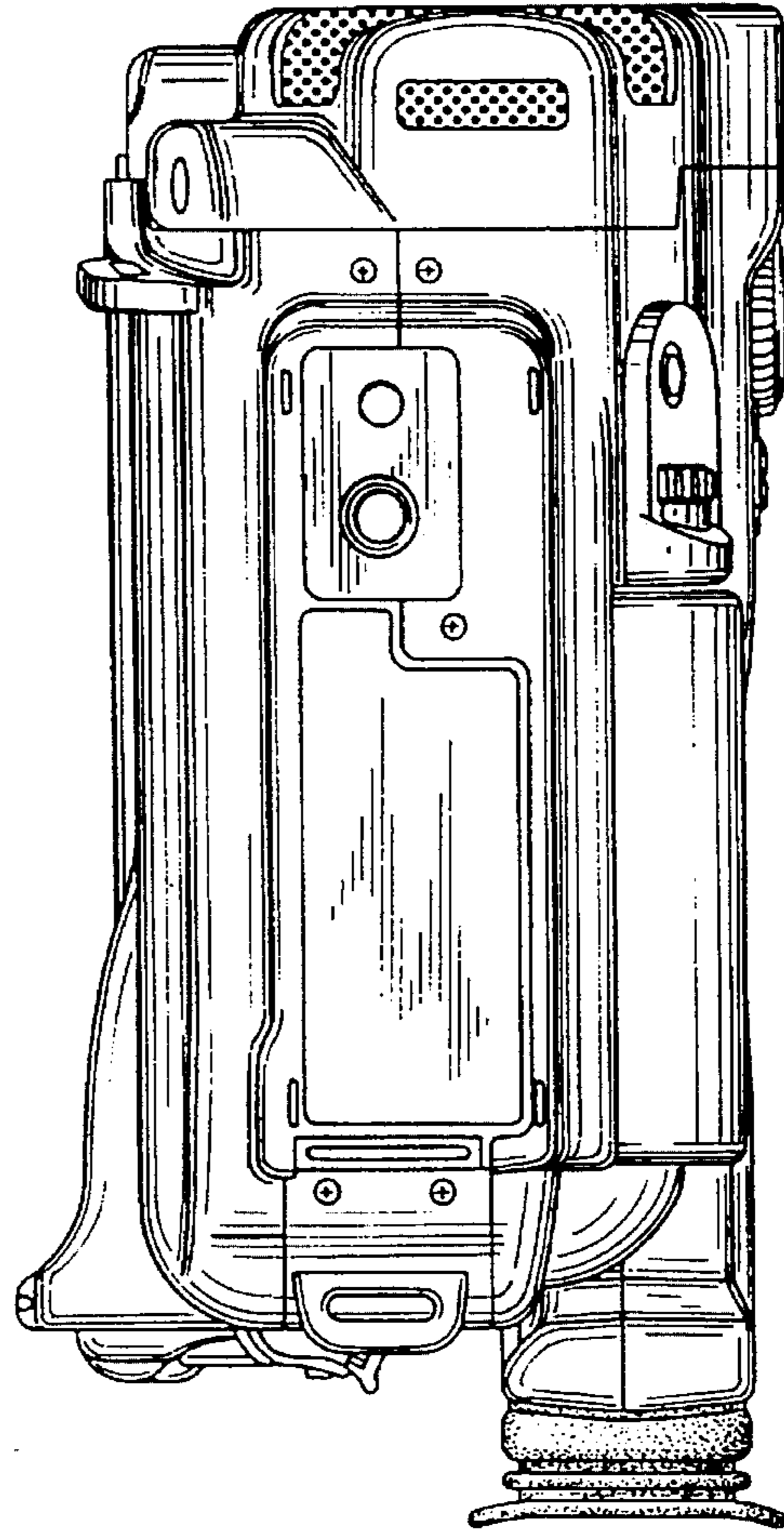

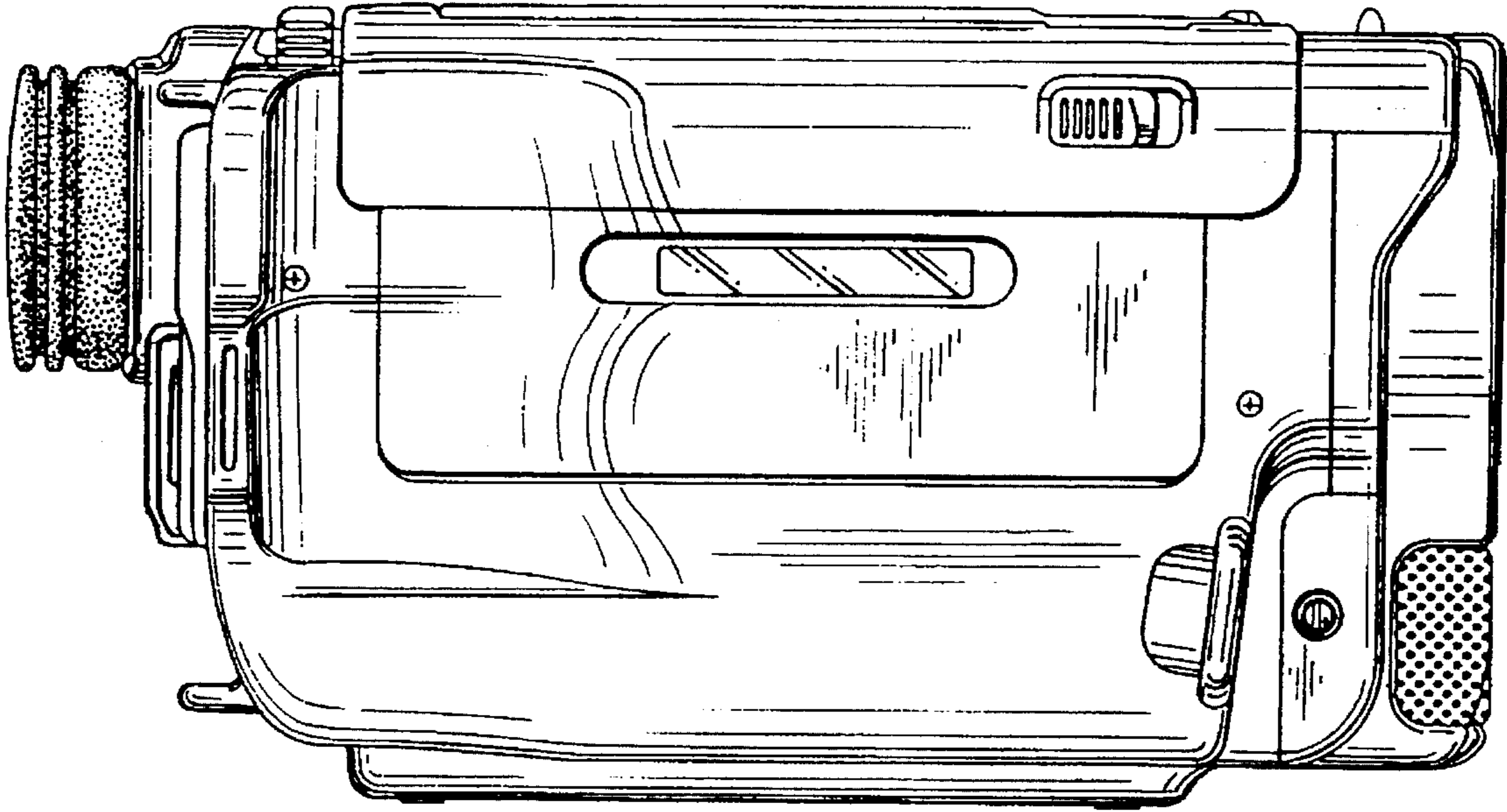

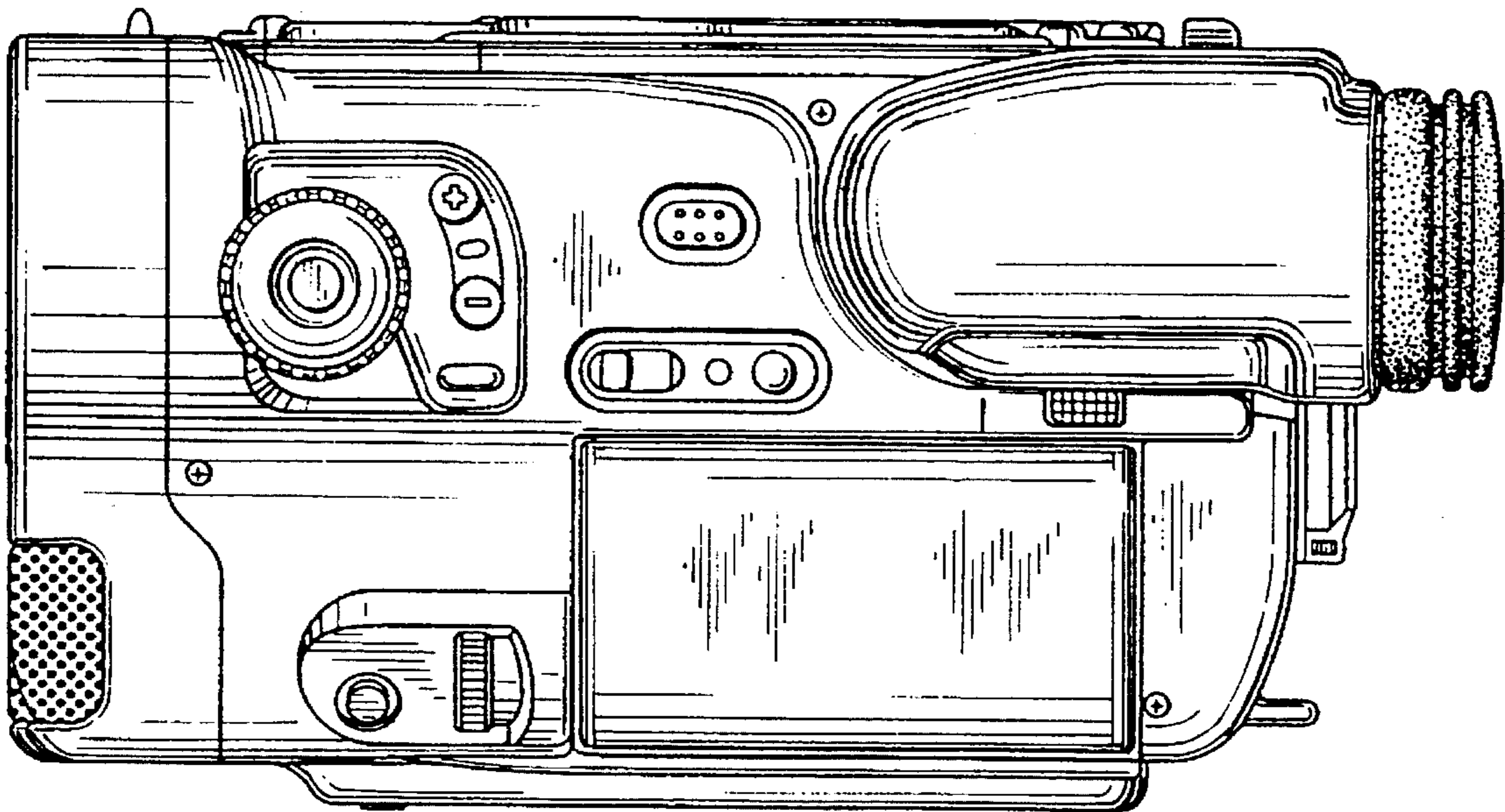
