The ornamental design for a golf club head, as shown and described.

## DESCRIPTION

FIG. 1 is a top, front and right side of the perspective view of a golf club head showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a bottom view thereof; and,

FIG. 8 is a cross-section taken on line 8—8 of FIG. 2.

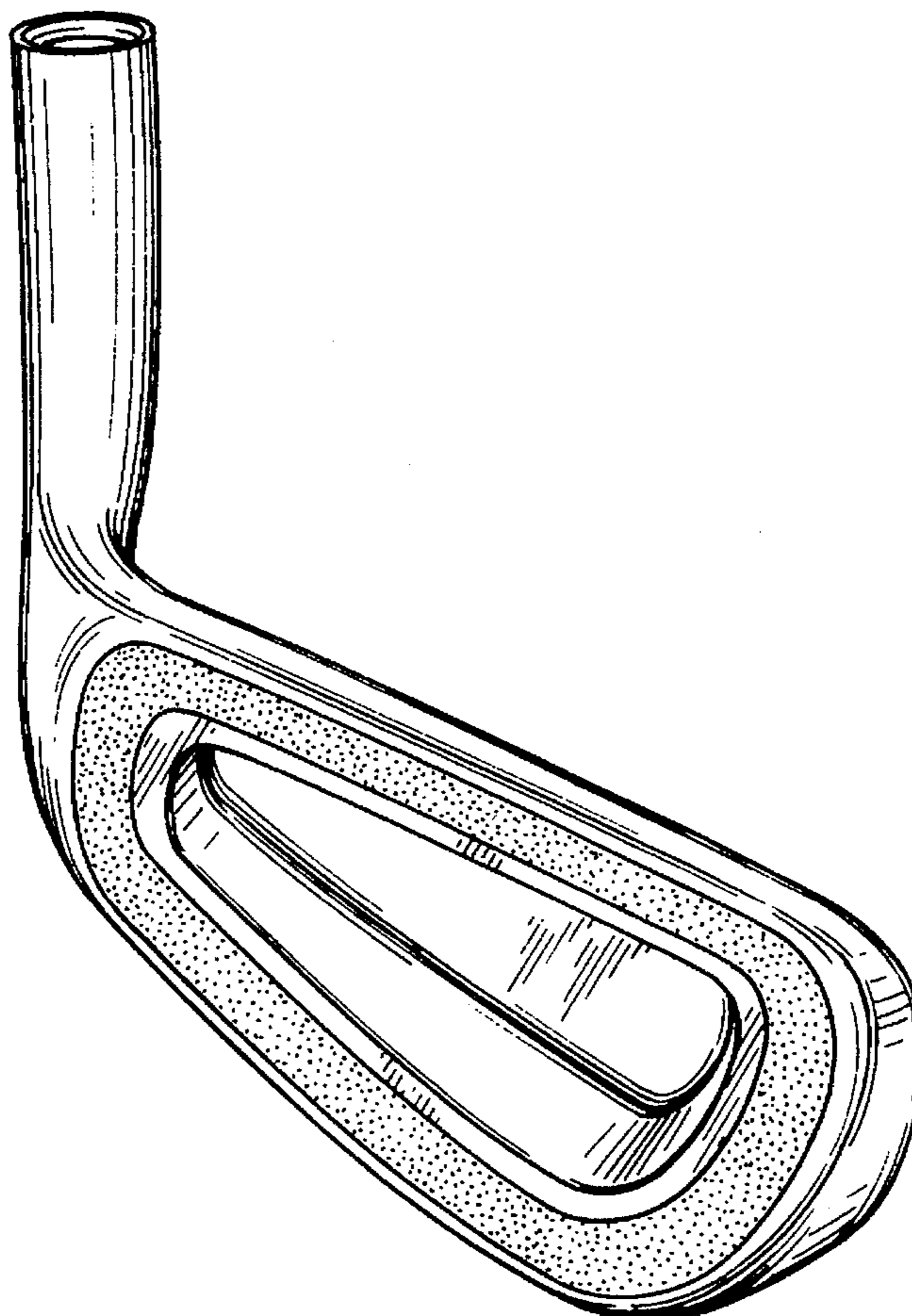

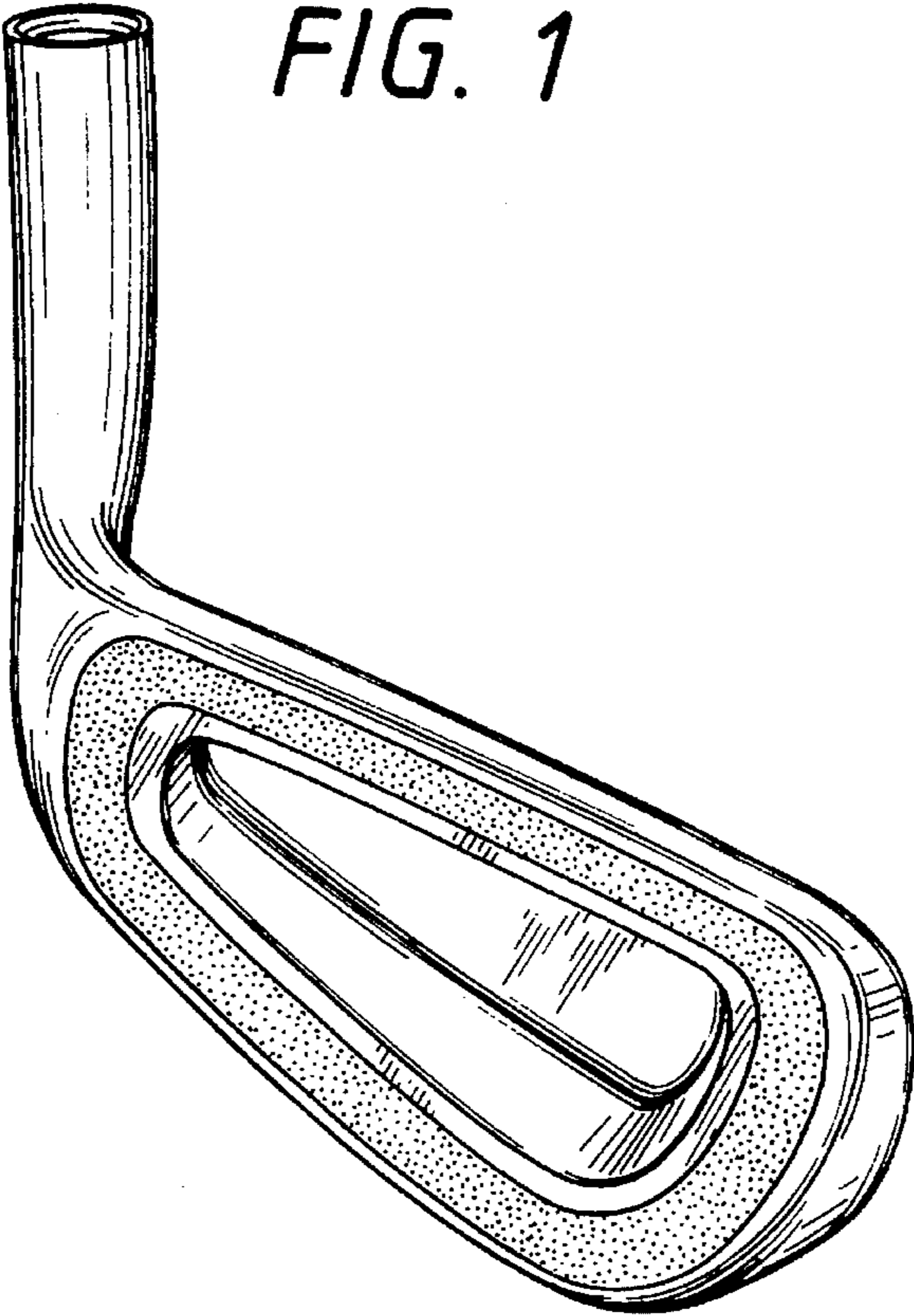

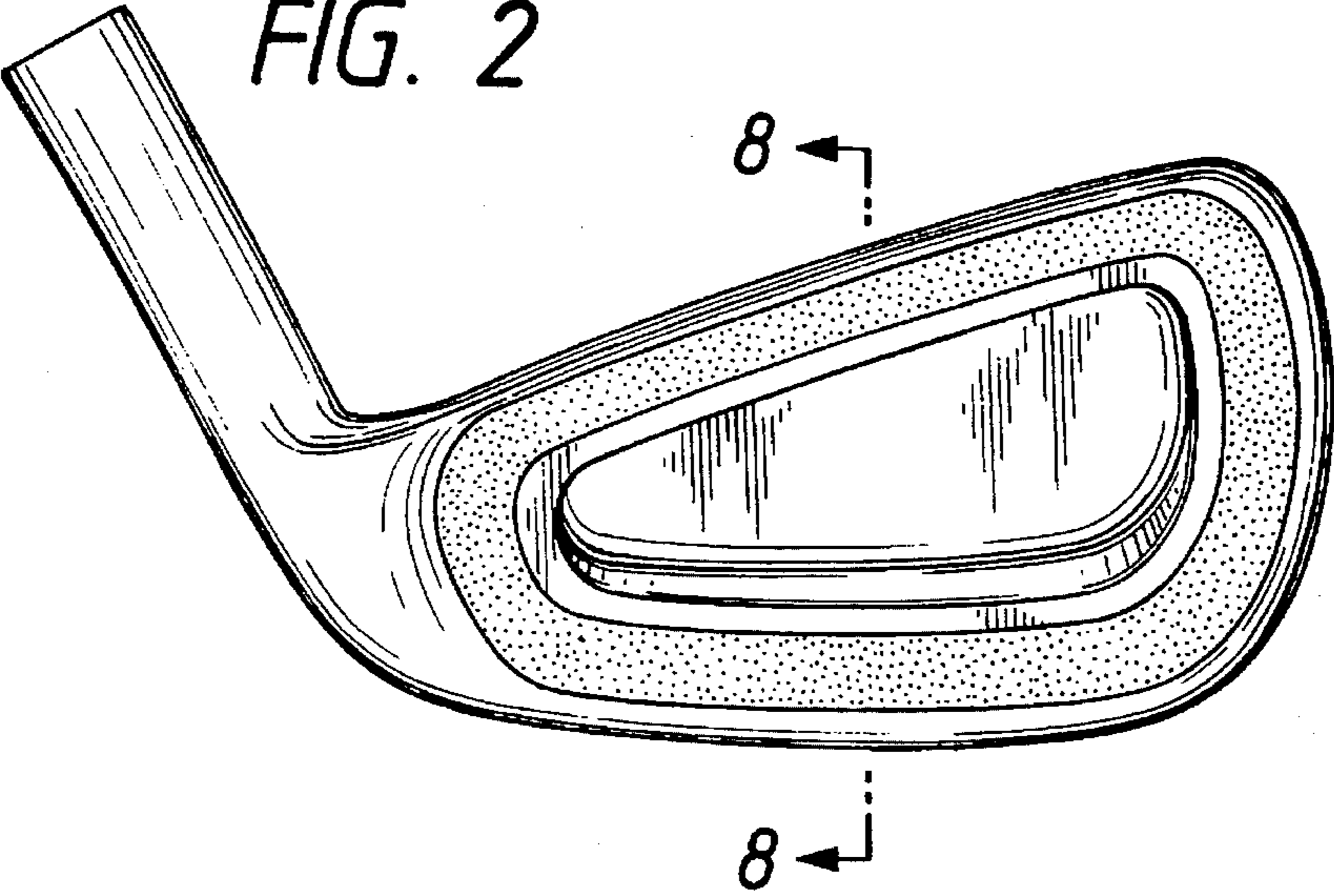

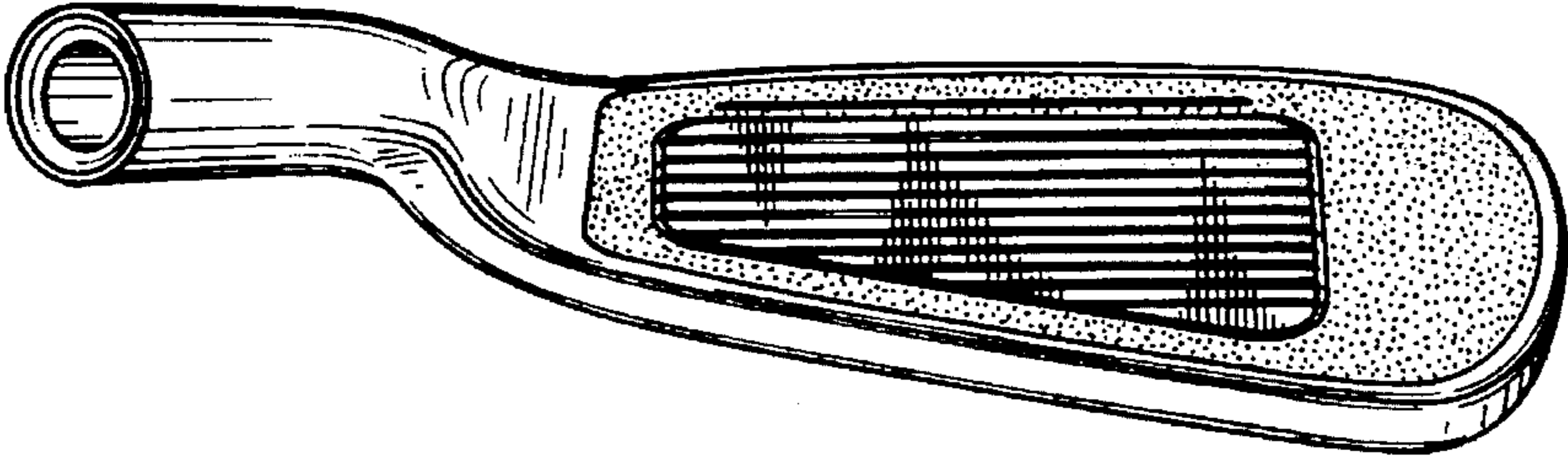

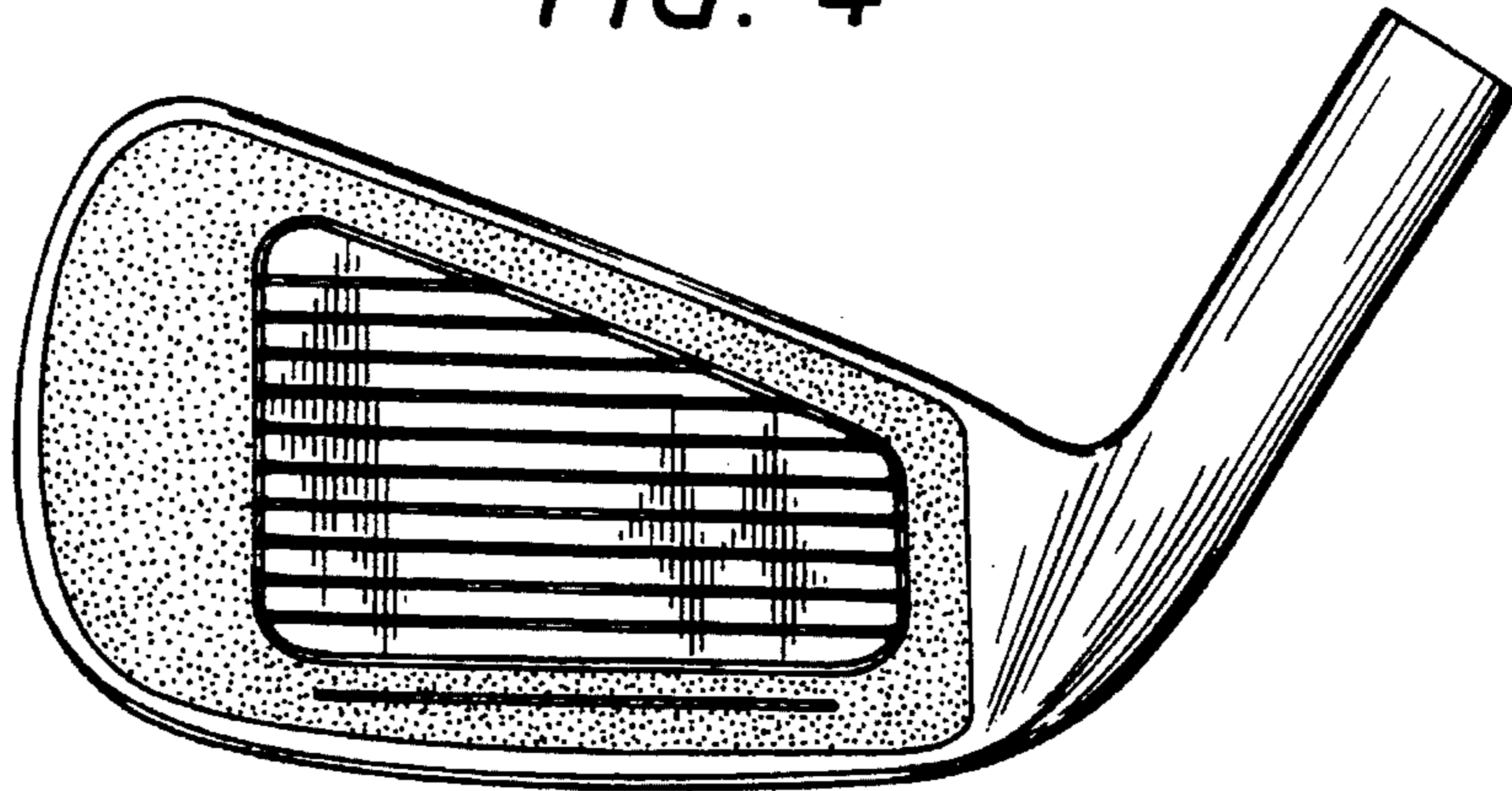

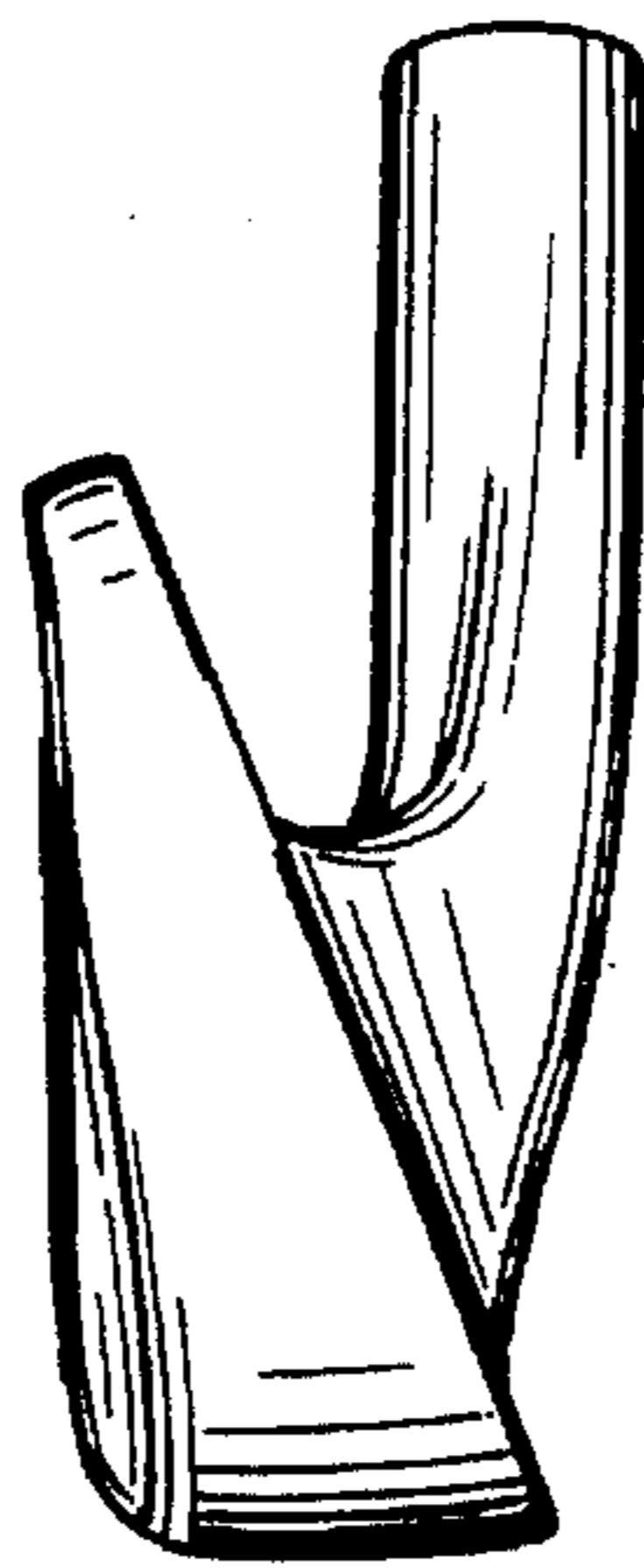

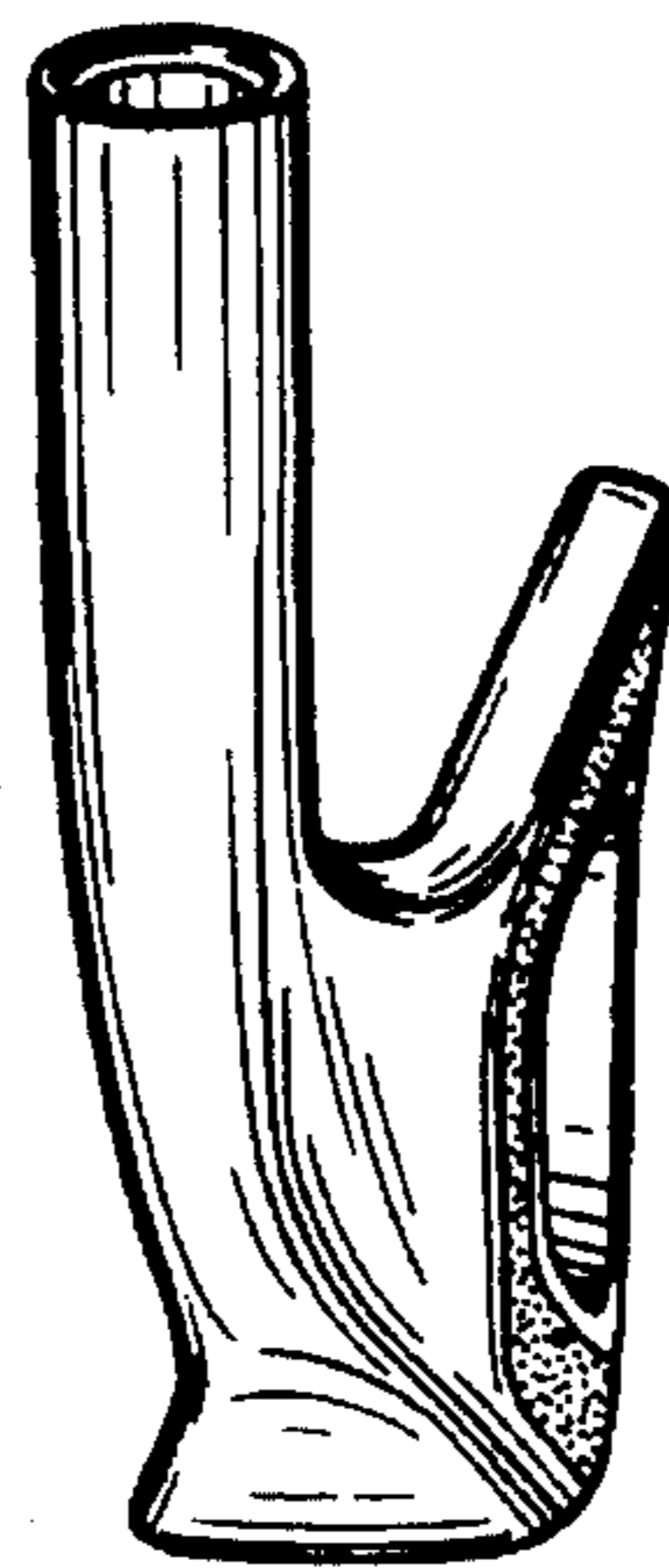

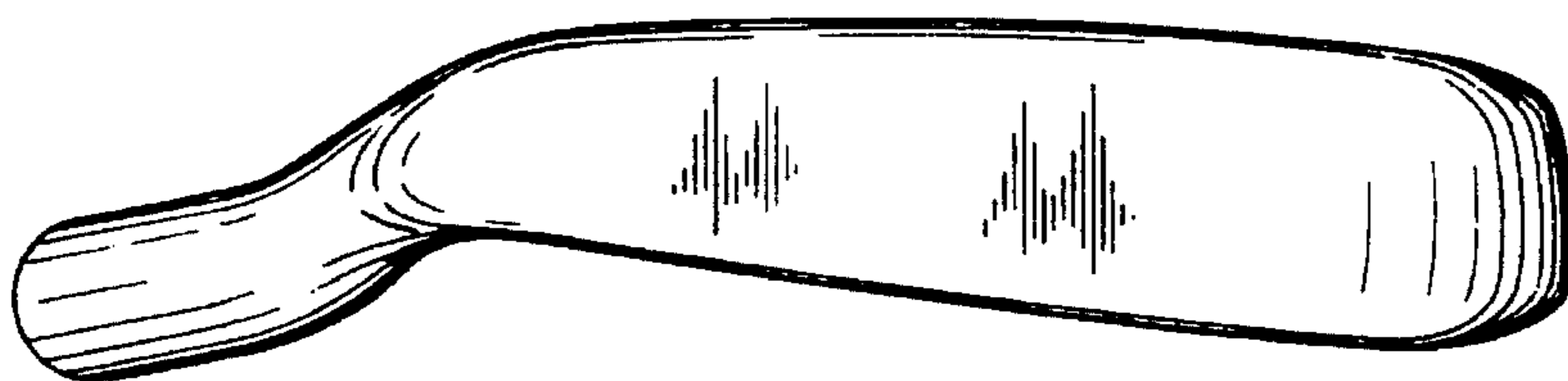
