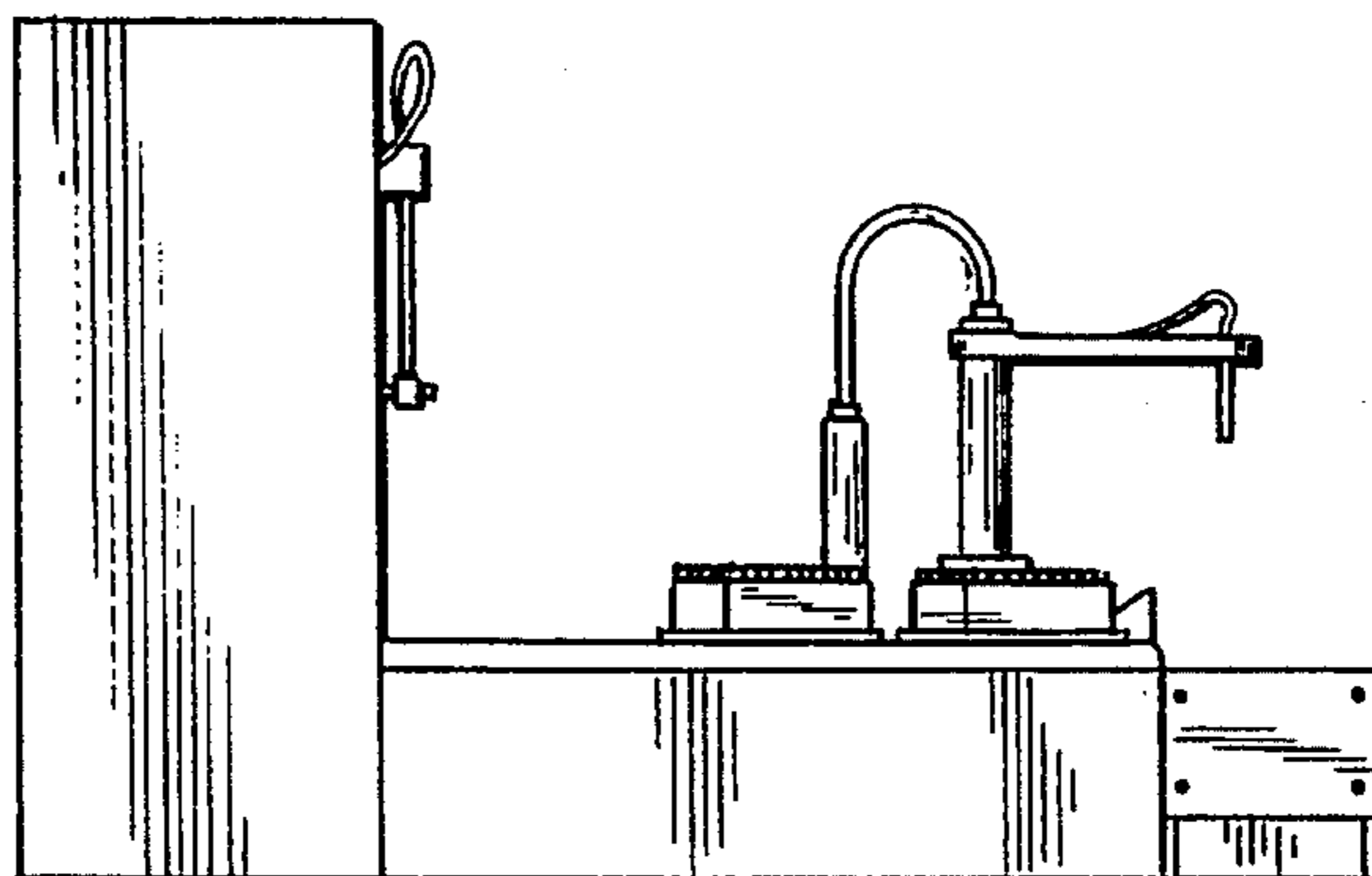
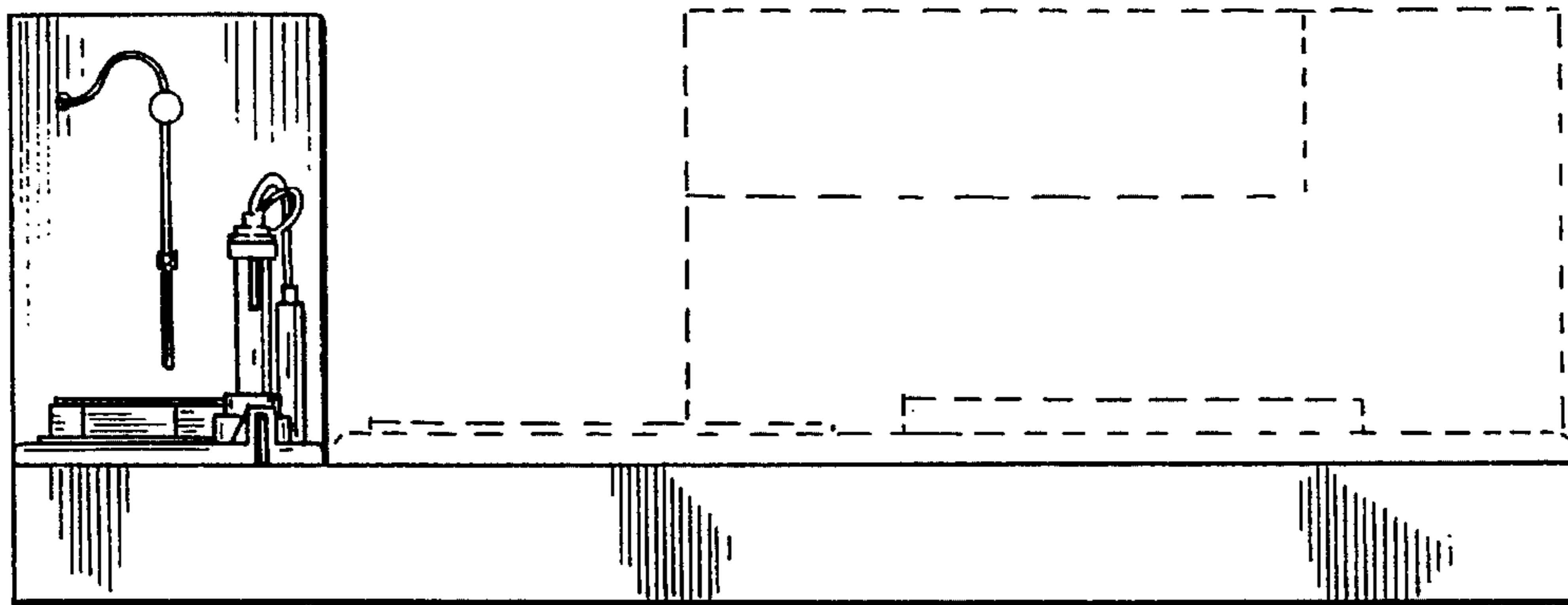
[57] CLAIM

The ornamental design for a liquid transfer module for a laboratory analyzer, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a liquid transfer module showing our new design with a laboratory analytical instrument illustrated in broken lines; FIG. 2 is a top plan view; FIG. 3 is a left side elevational view; FIG. 4 is a right side elevational view; and, FIG. 5 is a rear elevational view thereof. The broken line showing of the laboratory analyzer in FIGS. 1-2 is for illustrative purposes only, and forms no part of the claimed design.

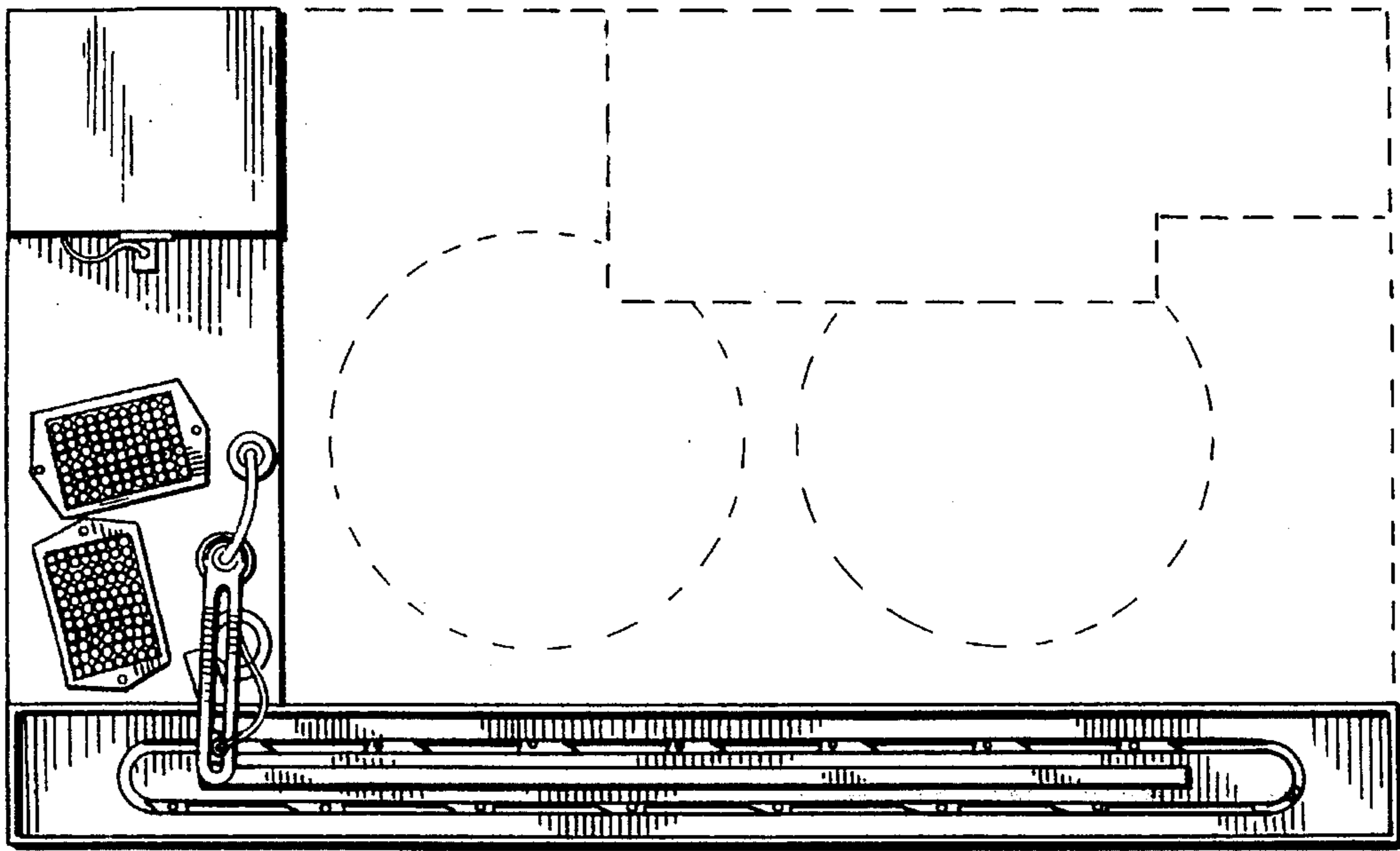

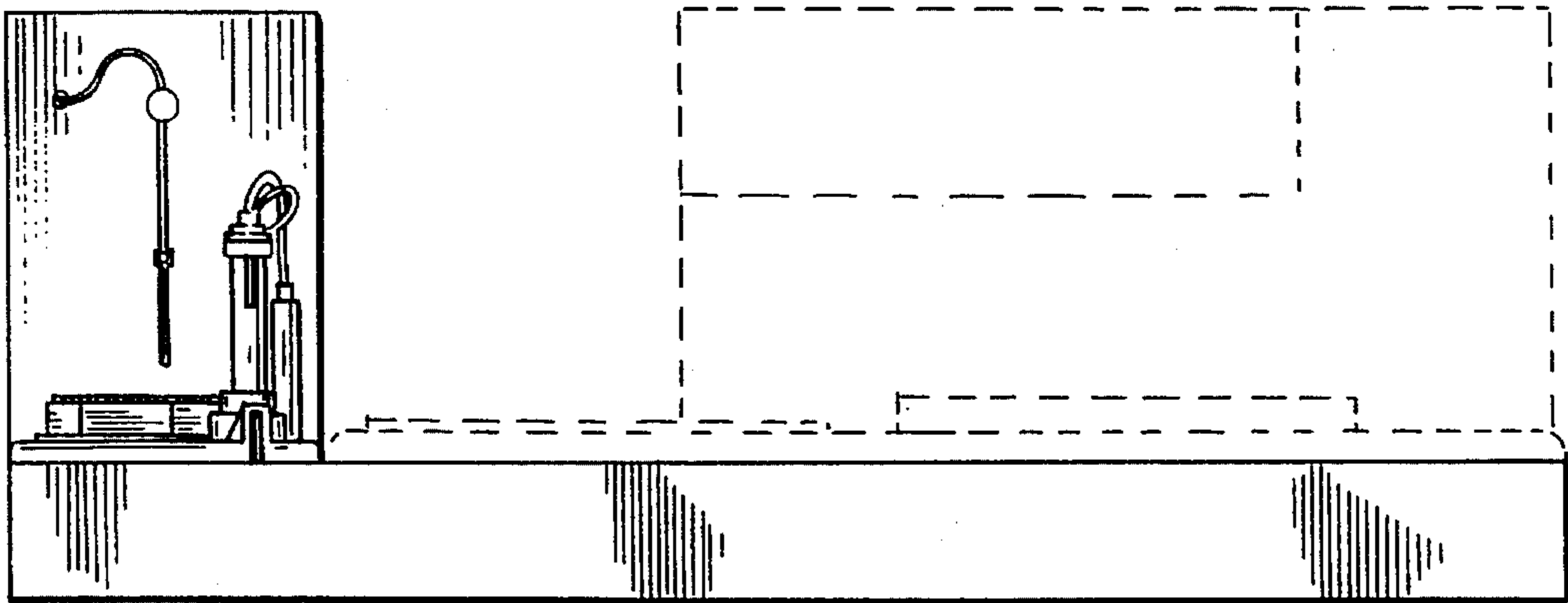

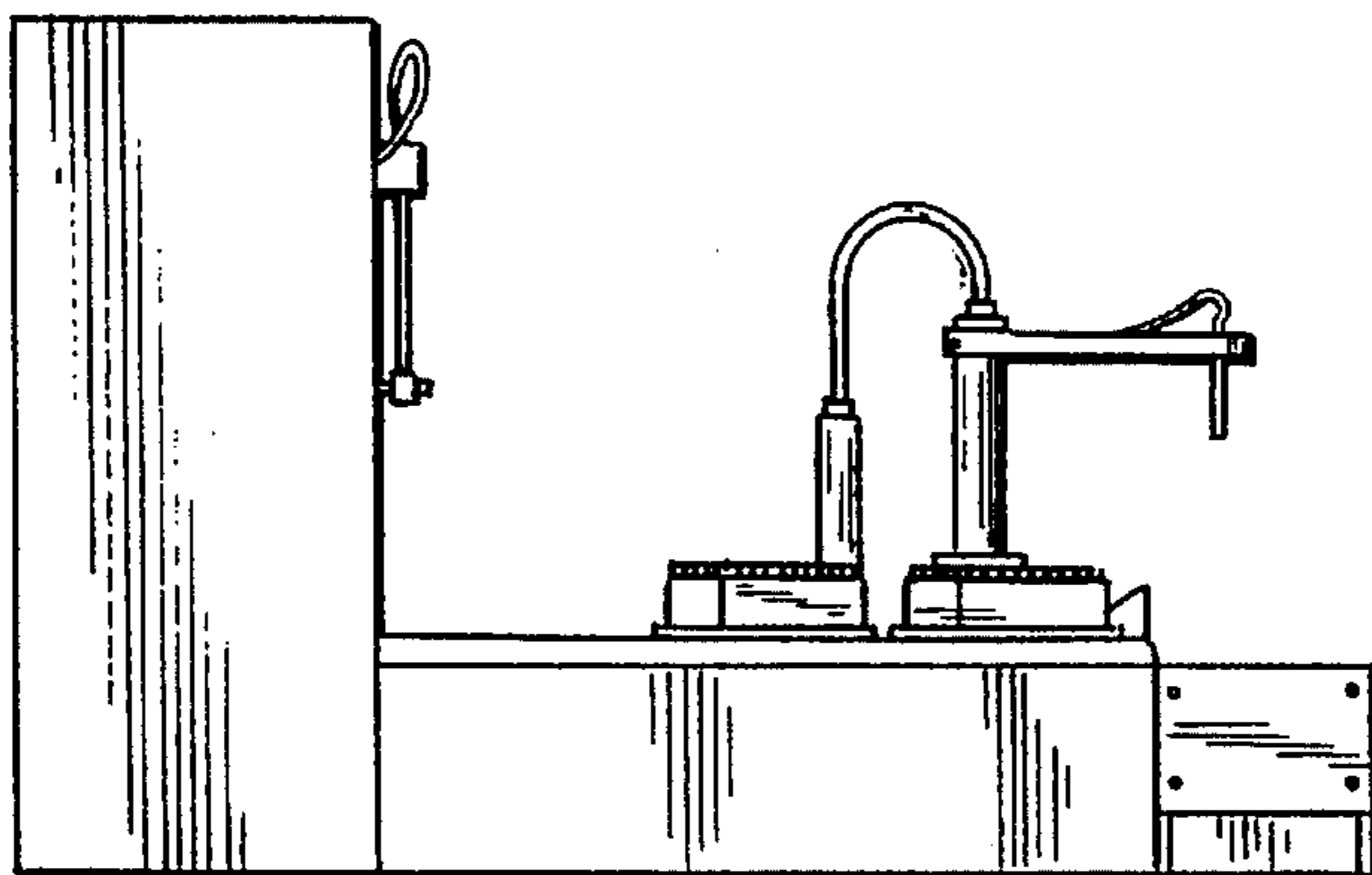

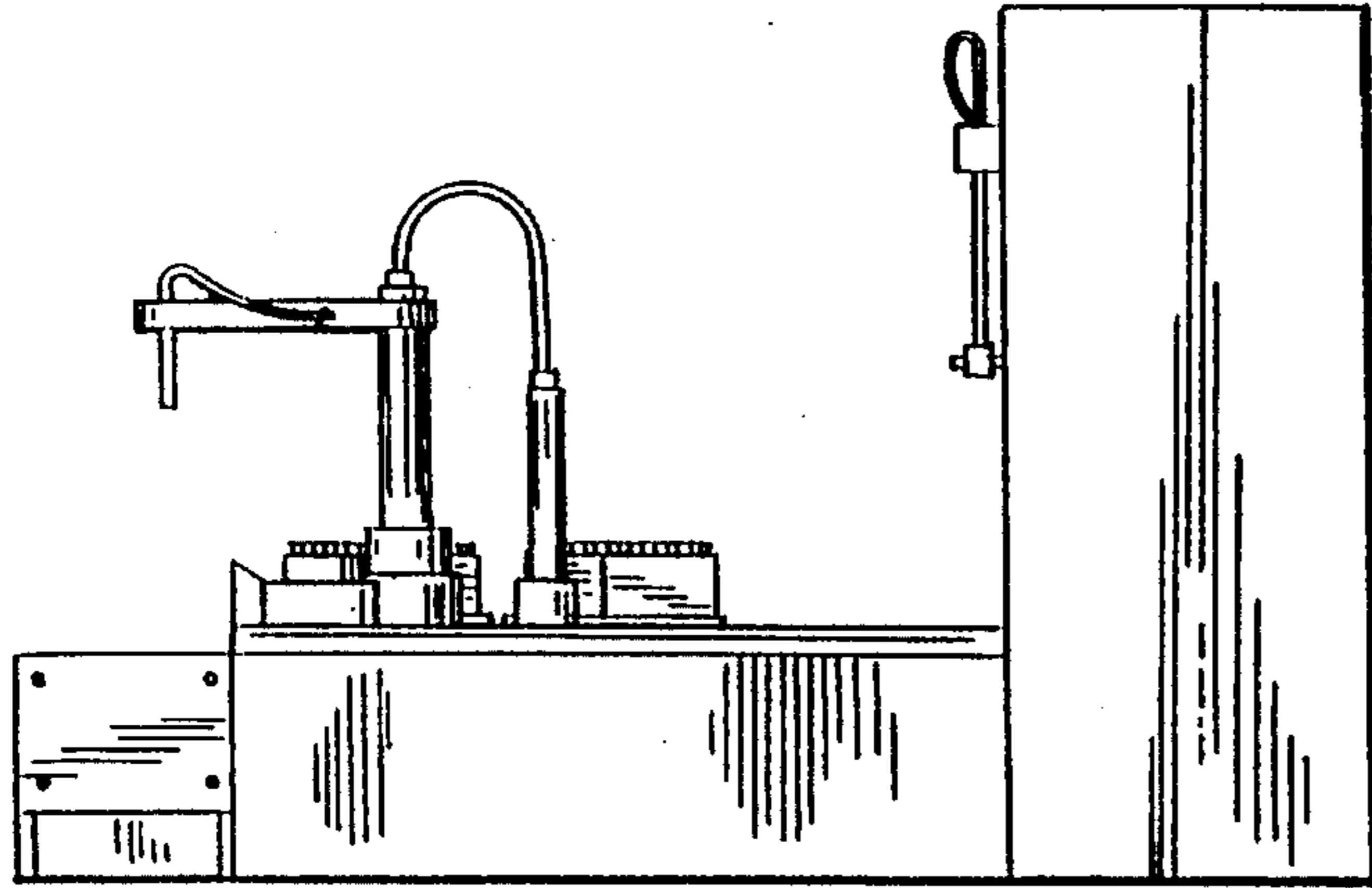

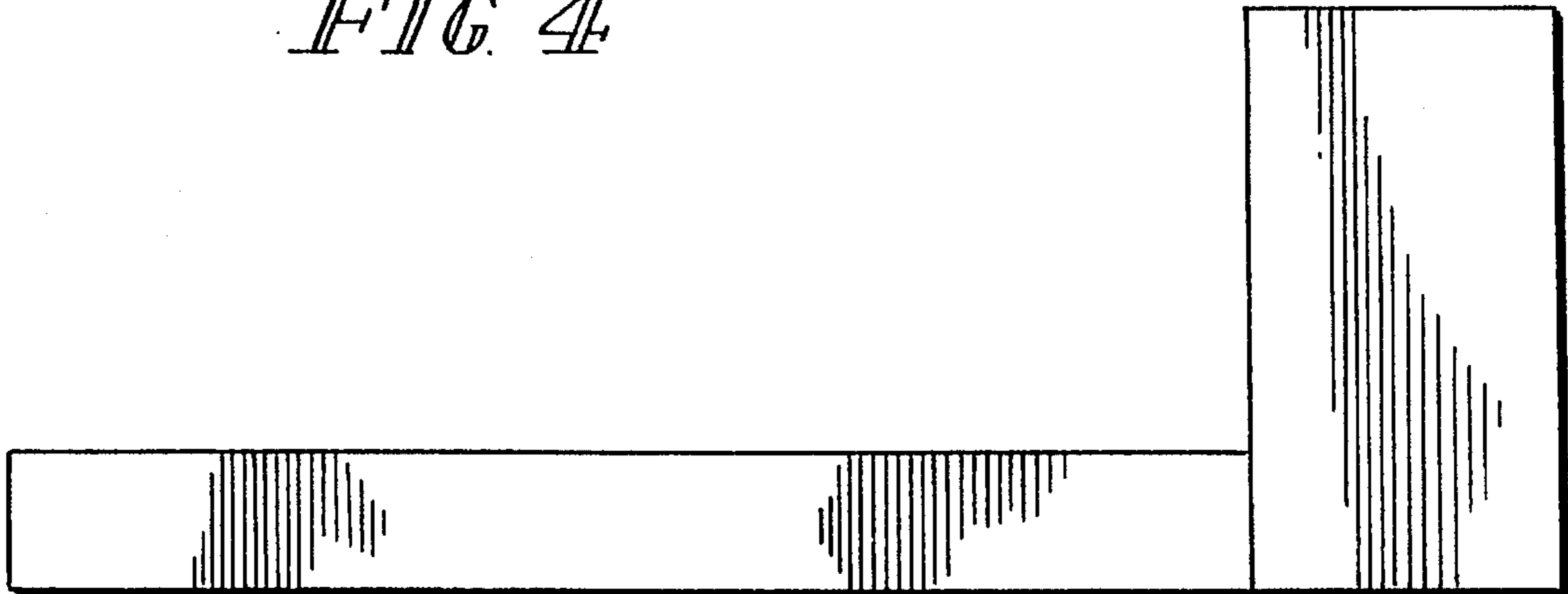
