**DESCRIPTION**

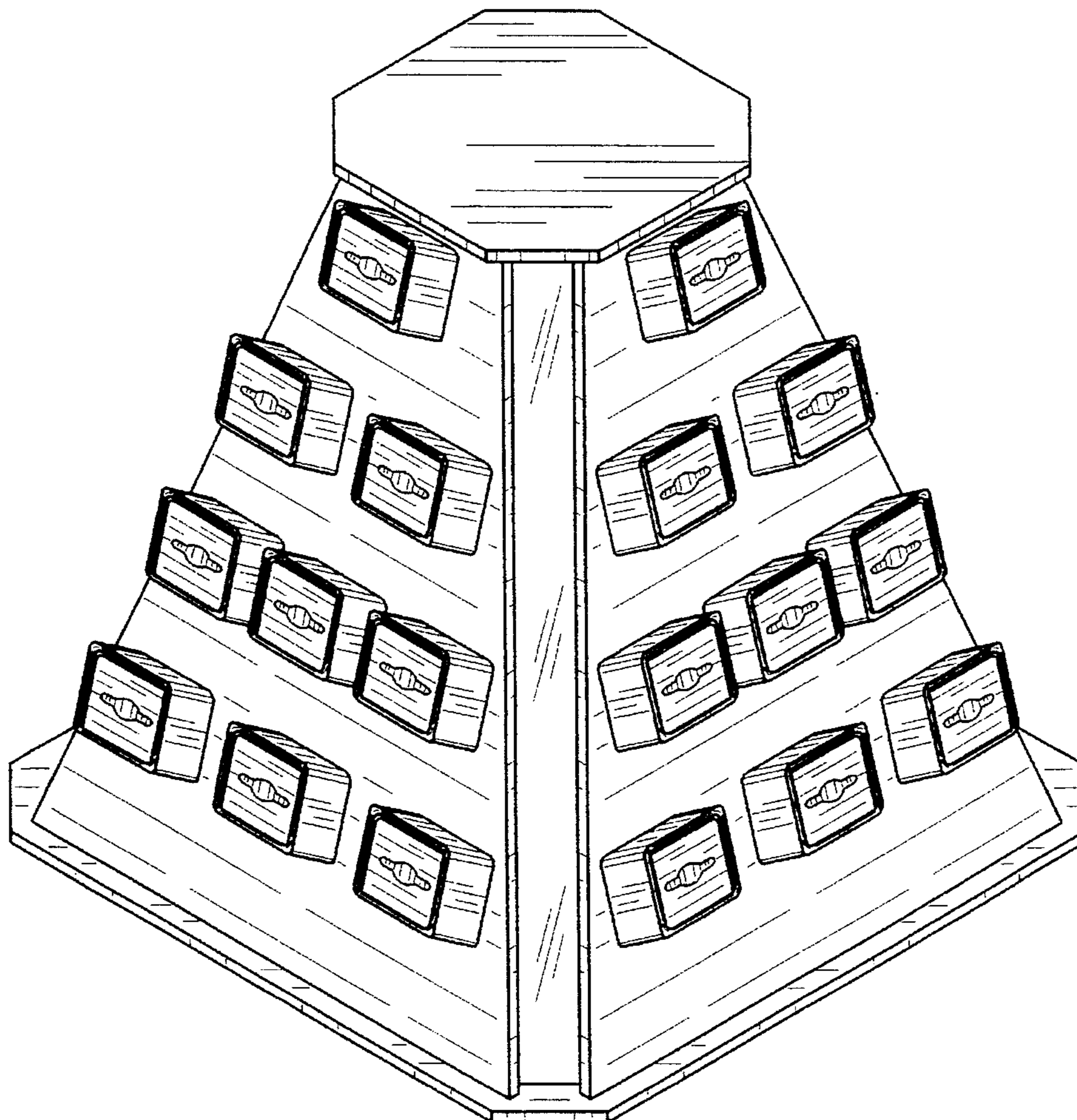
FIG. 1 is a perspective view of the jewelry display fixture embodying my new design;

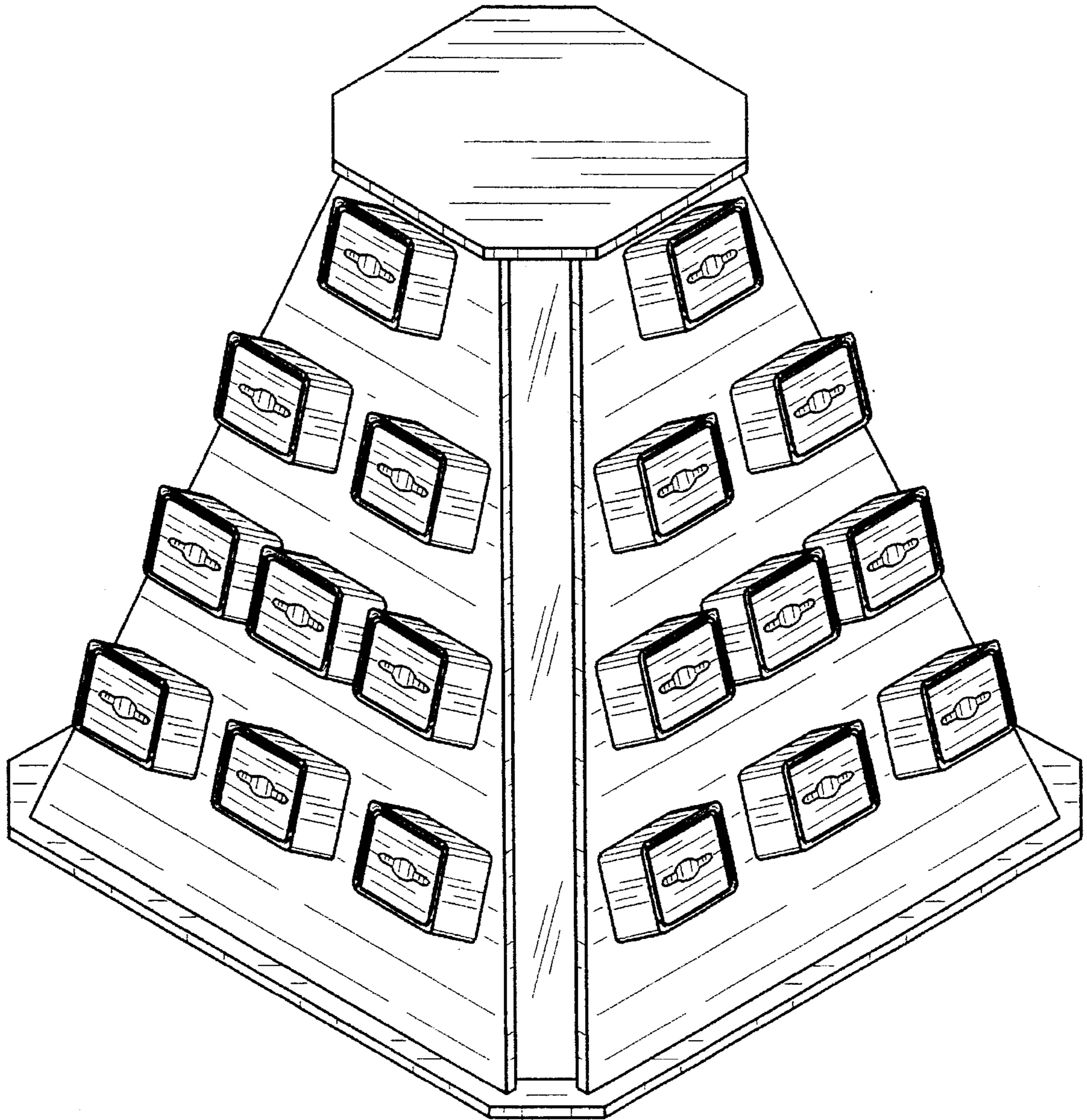

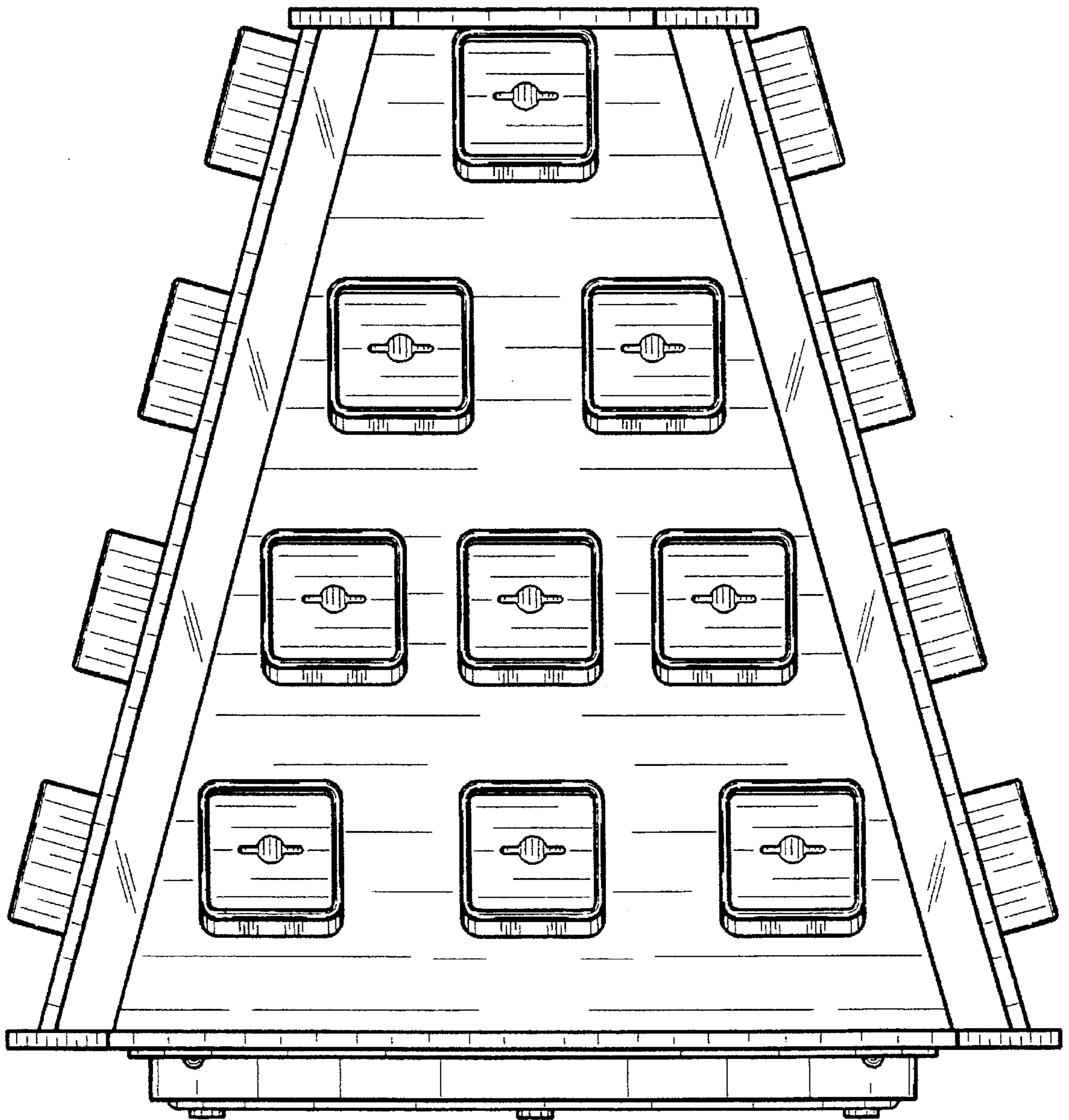

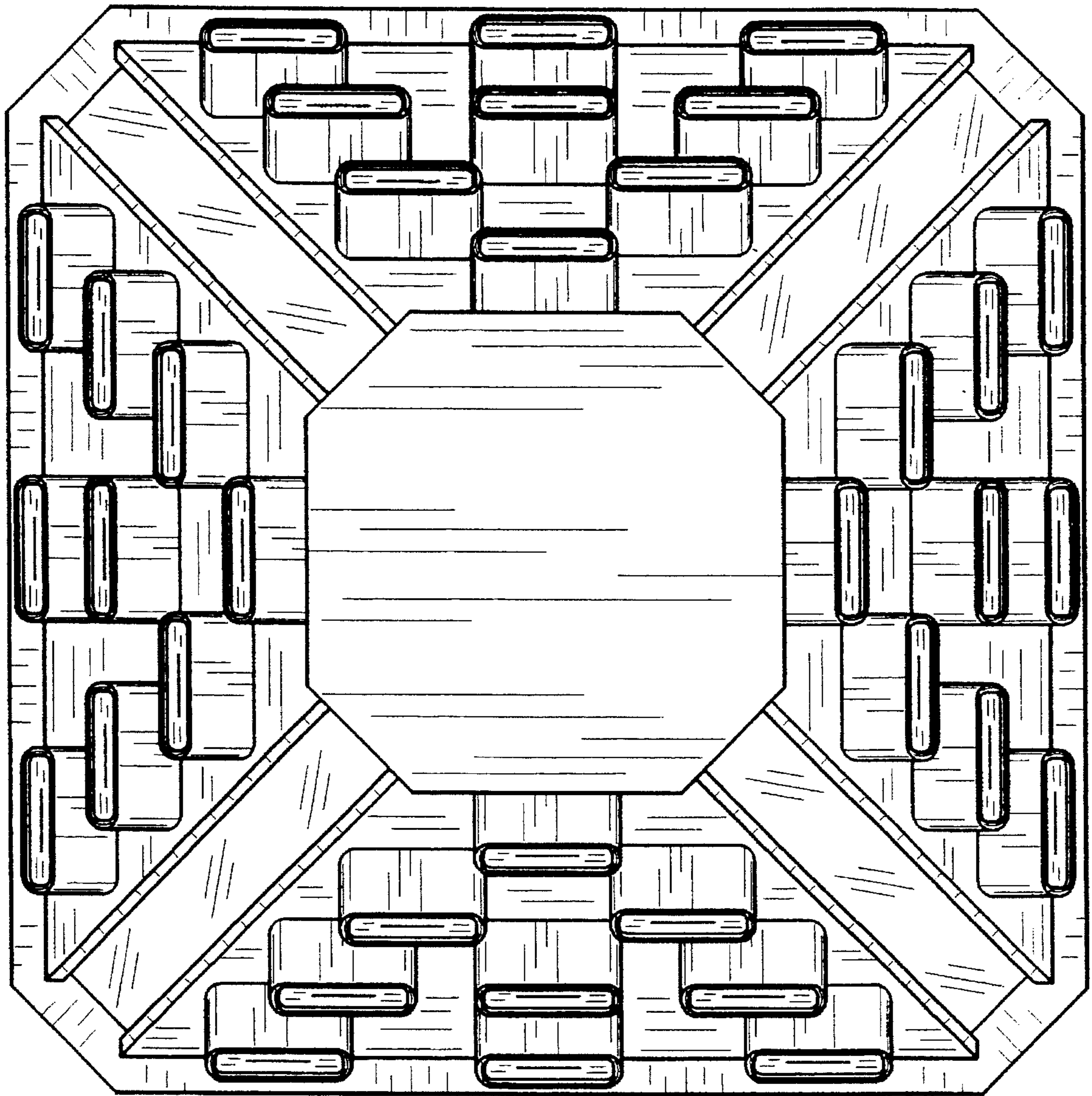

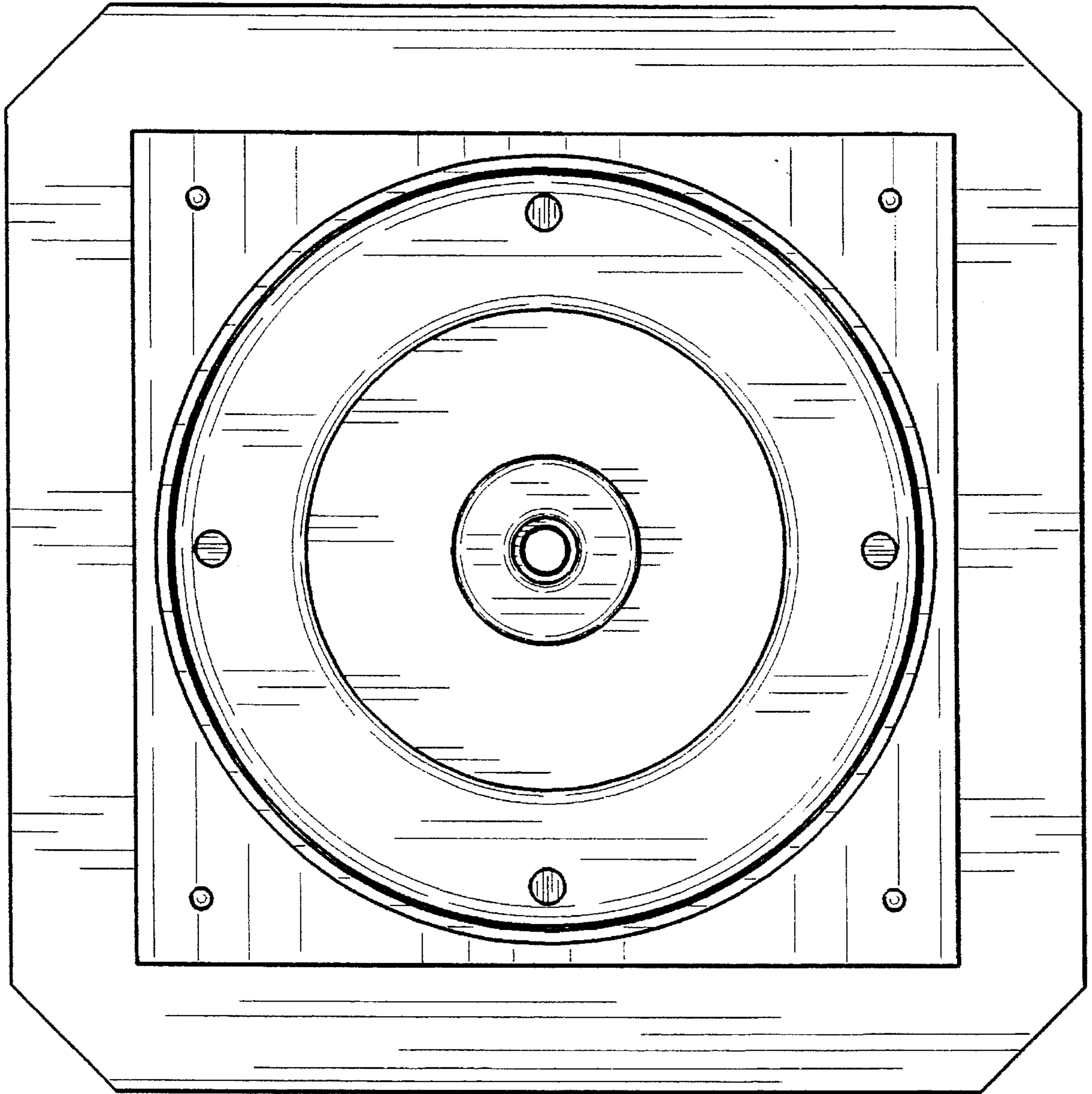
