[57] **CLAIM**

The ornamental design for a razor holder with suction cup mounting, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a razor holder with suction cup mounting showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a bottom view thereof; and,
FIG. 5 is a side view thereof, the opposite side being of mirror-image appearance.

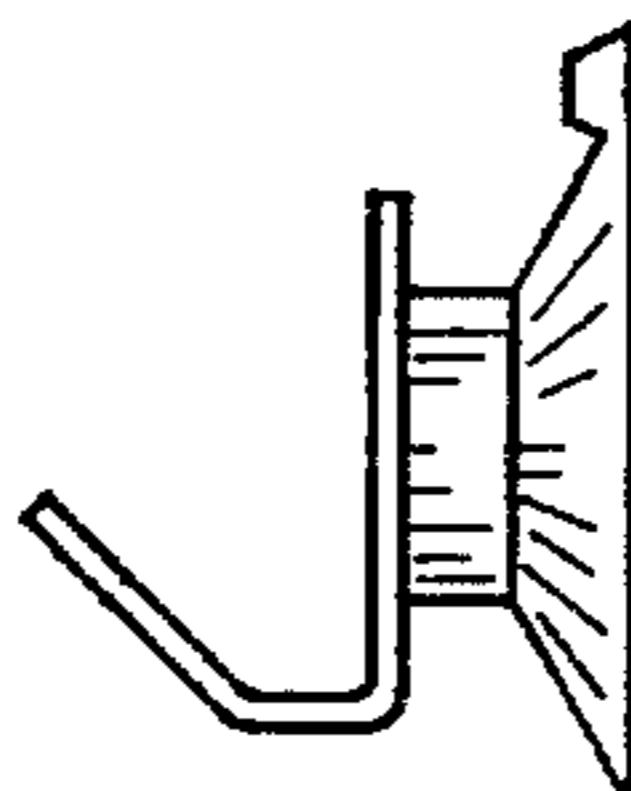
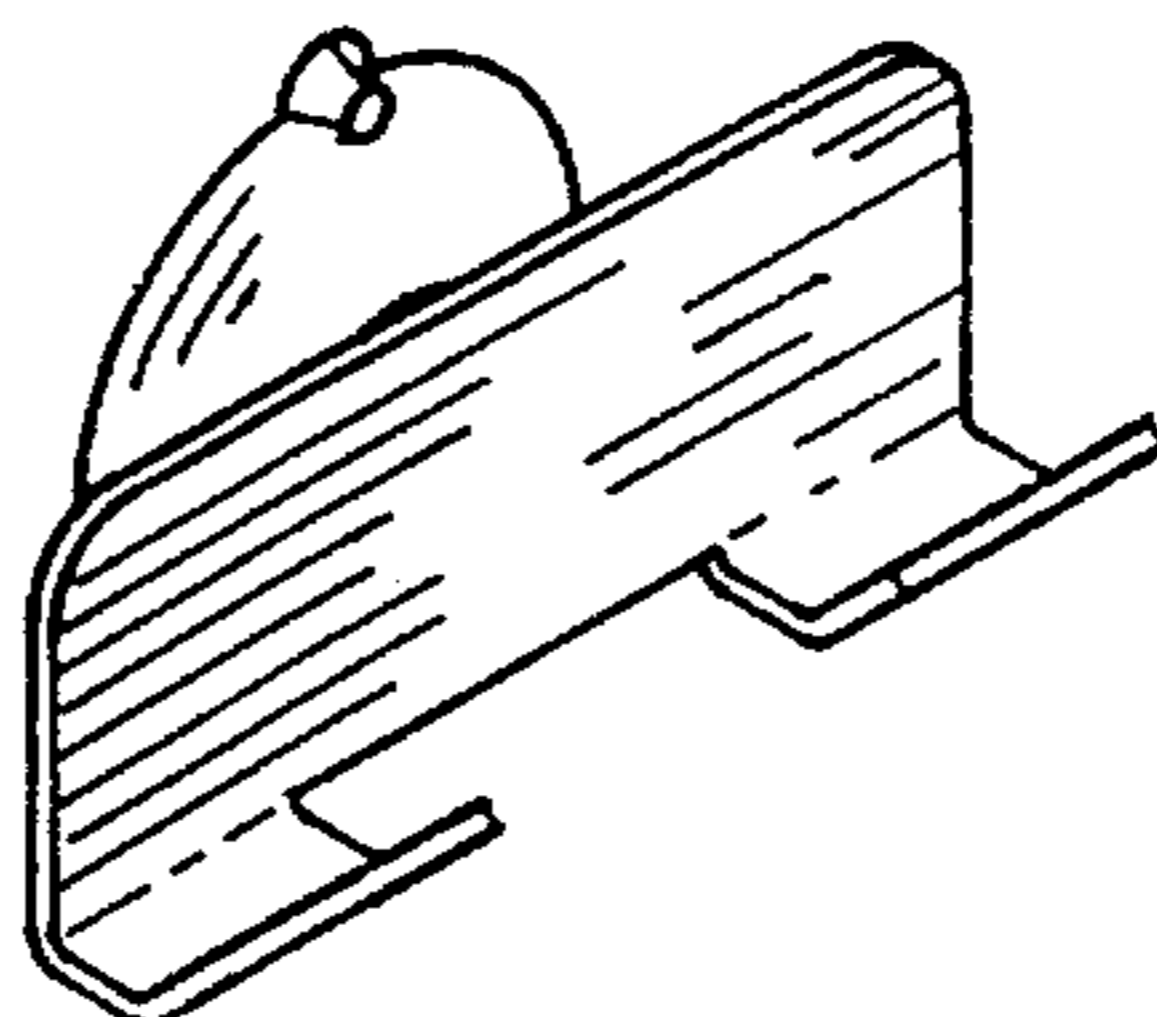

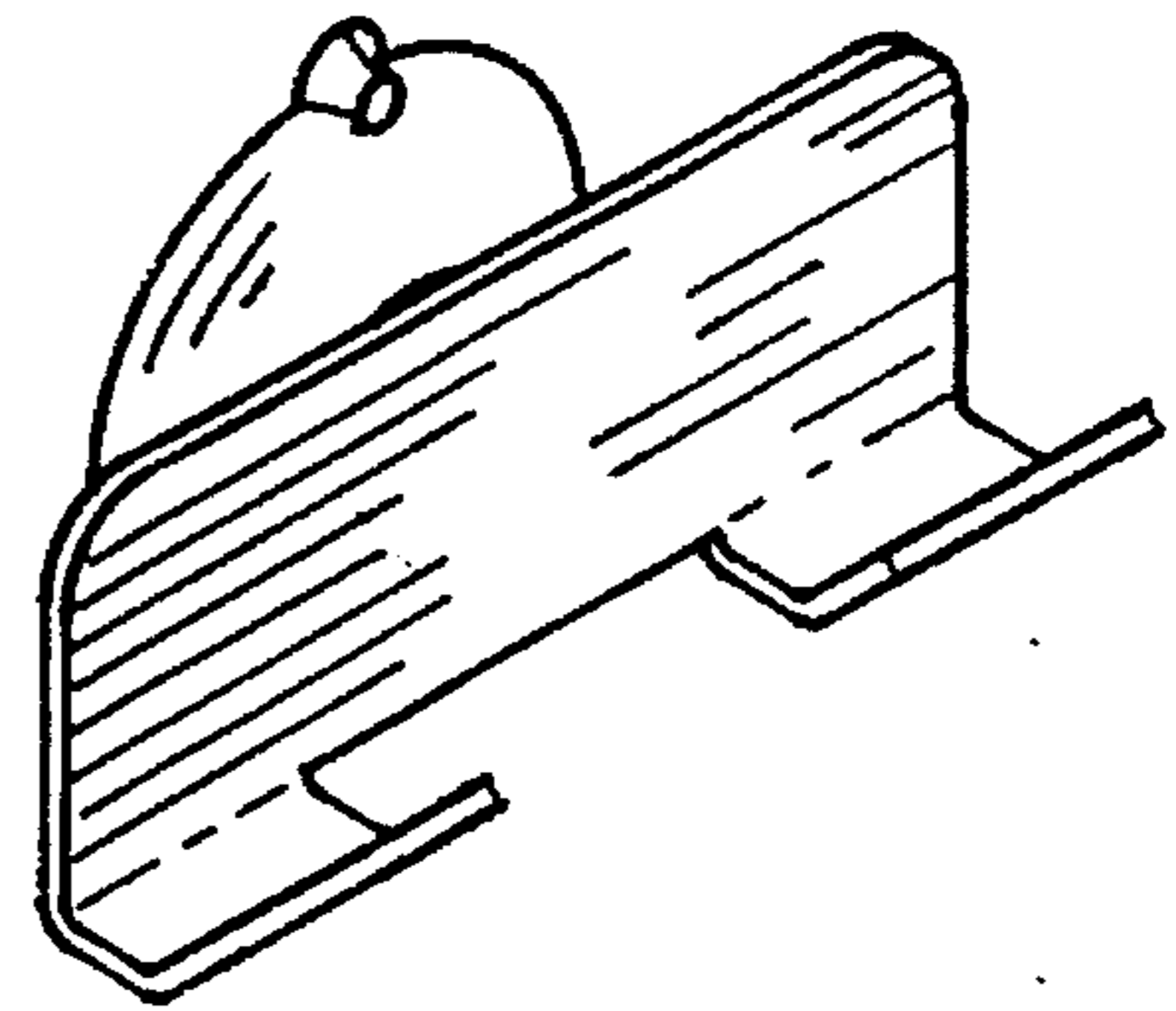

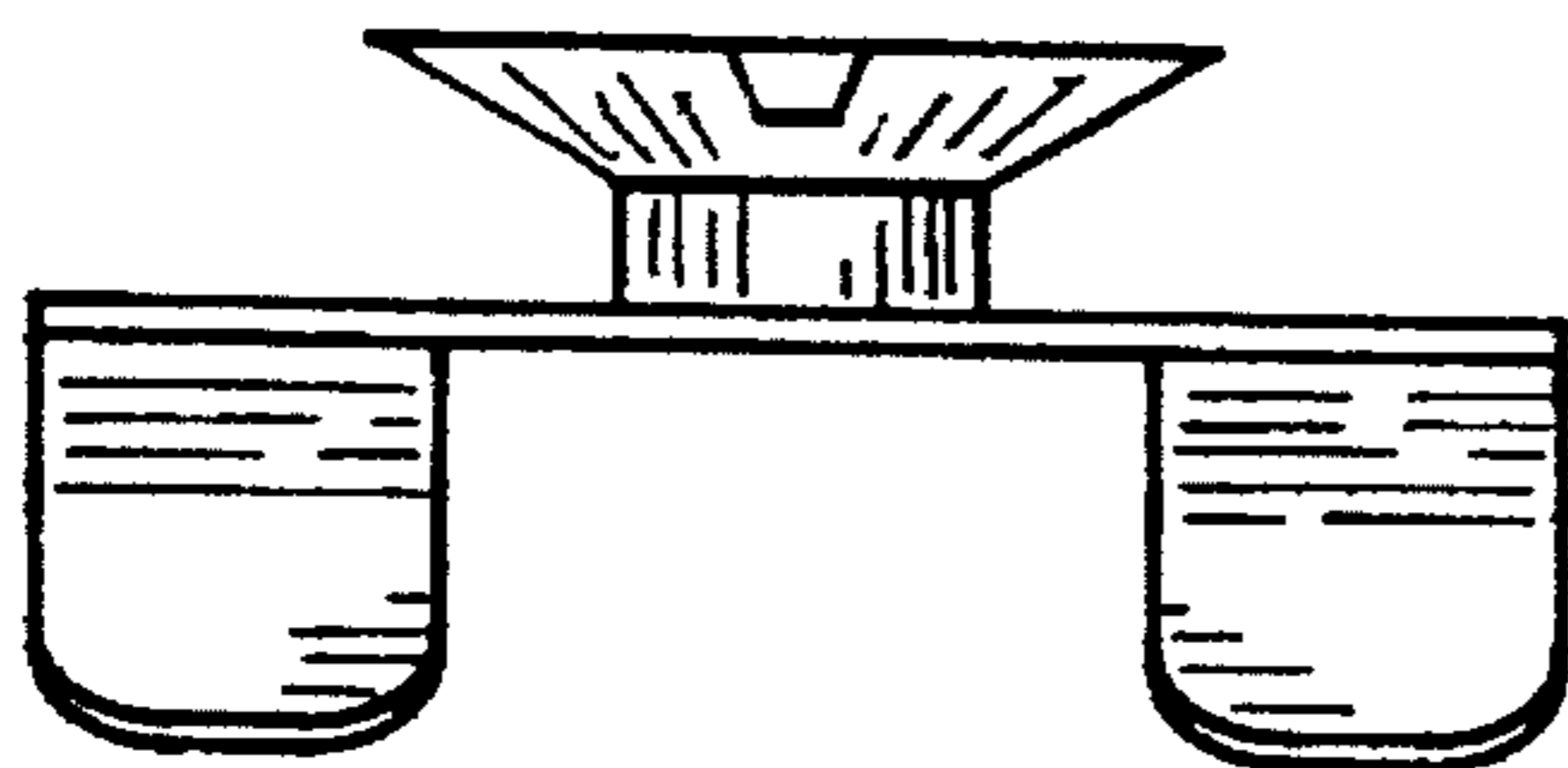

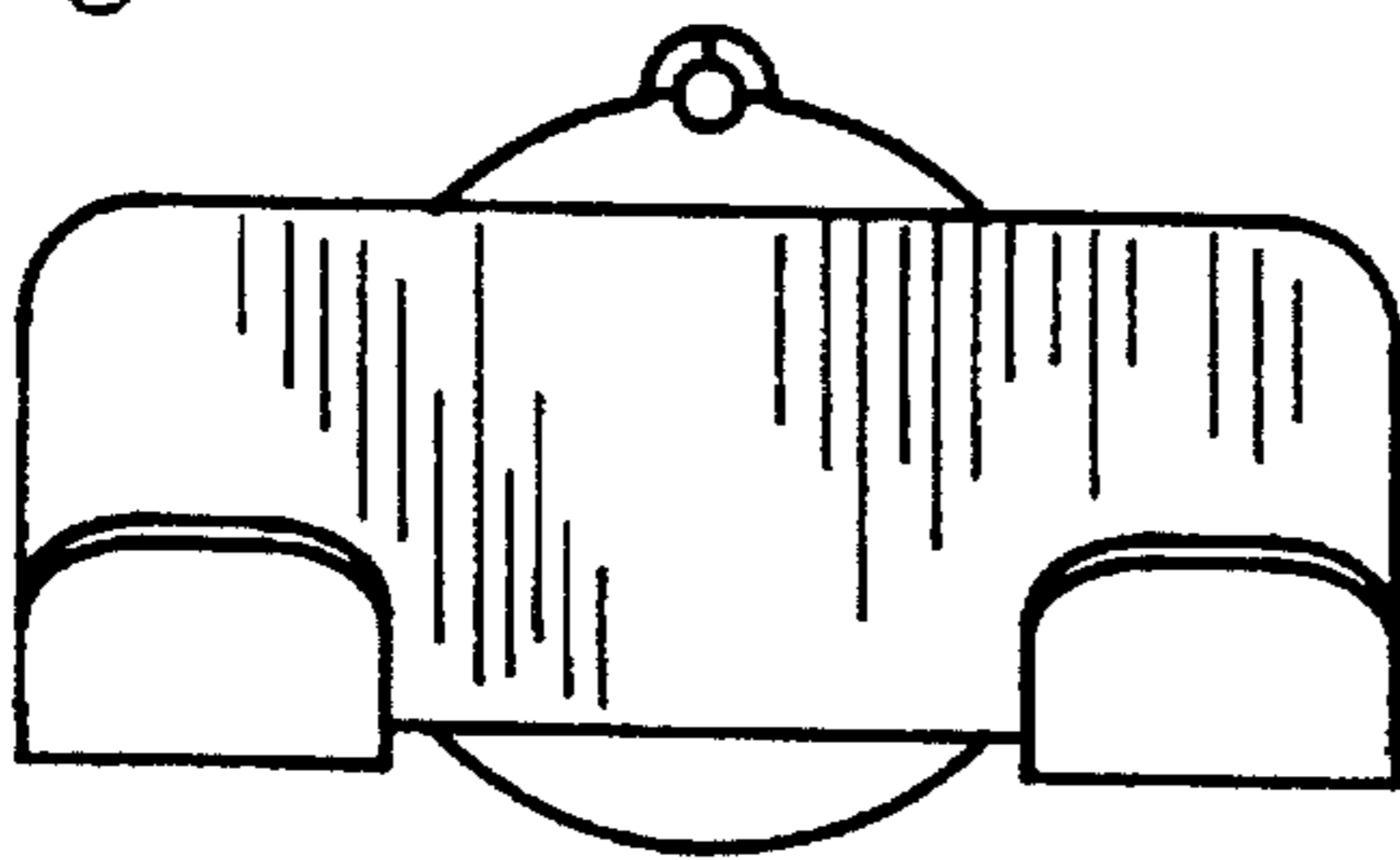

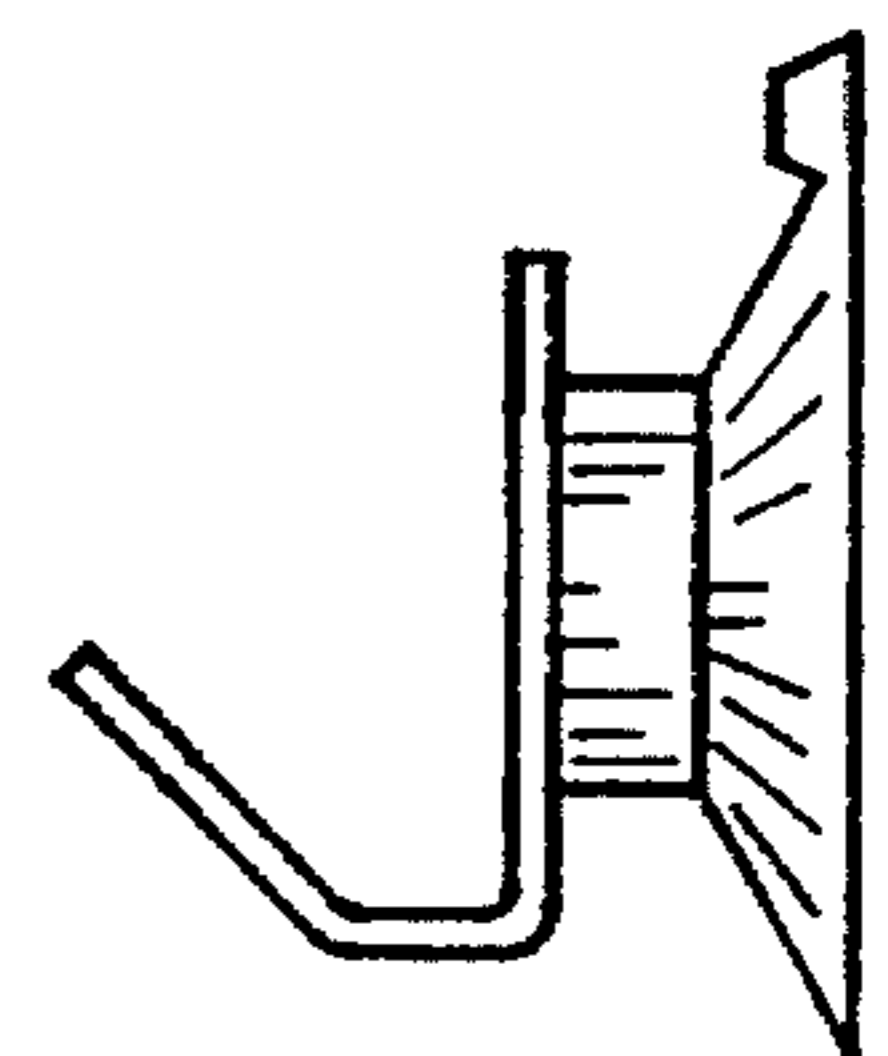
