[57] CLAIM

The ornamental design for a lid with partially removable gripping flange, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lid with partially removable gripping flange, showing my new design;
FIG. 2 is a top plan view of the lid depicted in FIG. 1;
FIG. 3 is a front elevational view of the lid depicted in FIG. 1;
FIG. 4 is a bottom plan view of the lid depicted in FIG. 1;
FIG. 5 is a sectional view of the lid taken along line 5—5 of FIG. 2;
FIG. 6 is a left elevational view of the lid depicted in FIG. 1;
FIG. 7 is a right elevational view of the lid depicted in FIG. 1;
FIG. 8 is a rear elevational view of the lid depicted in FIG. 1;
FIG. 9 is an enlarged partial view of the periphery of the left side of the lid depicted in FIG. 1; and,
FIG. 10 is an enlarged partial view of the periphery of the front of the lid depicted in FIG. 1.

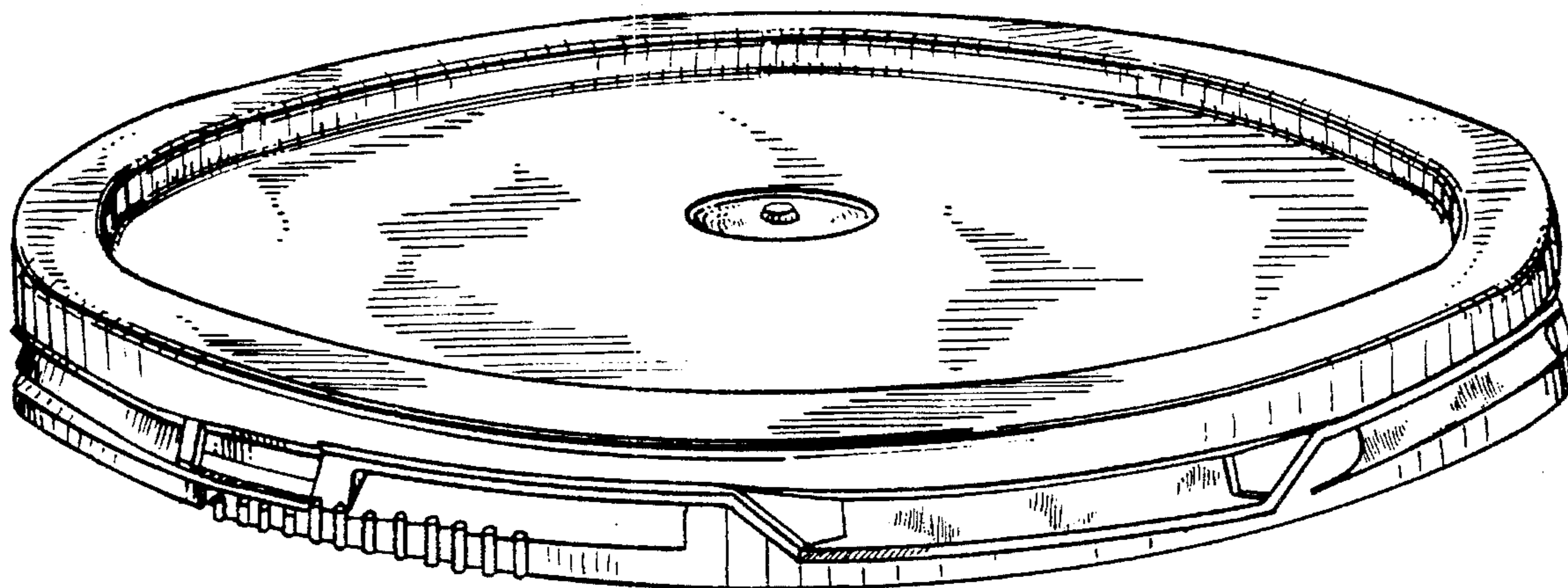

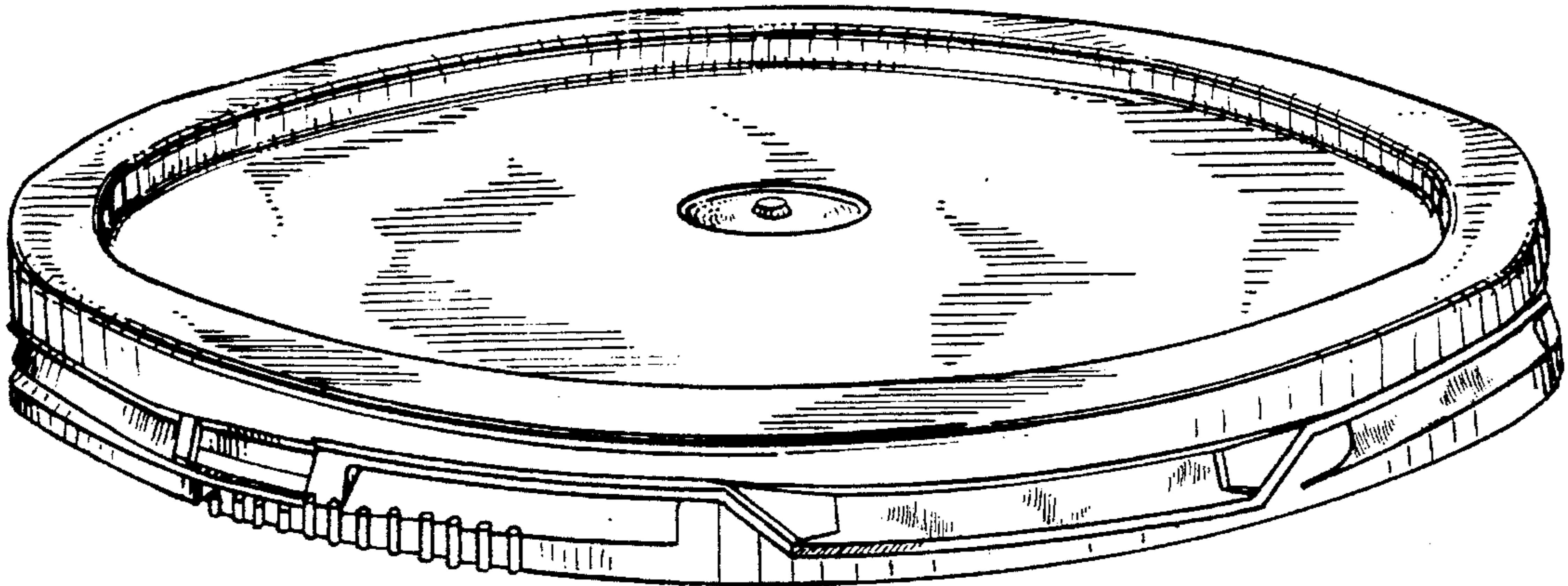

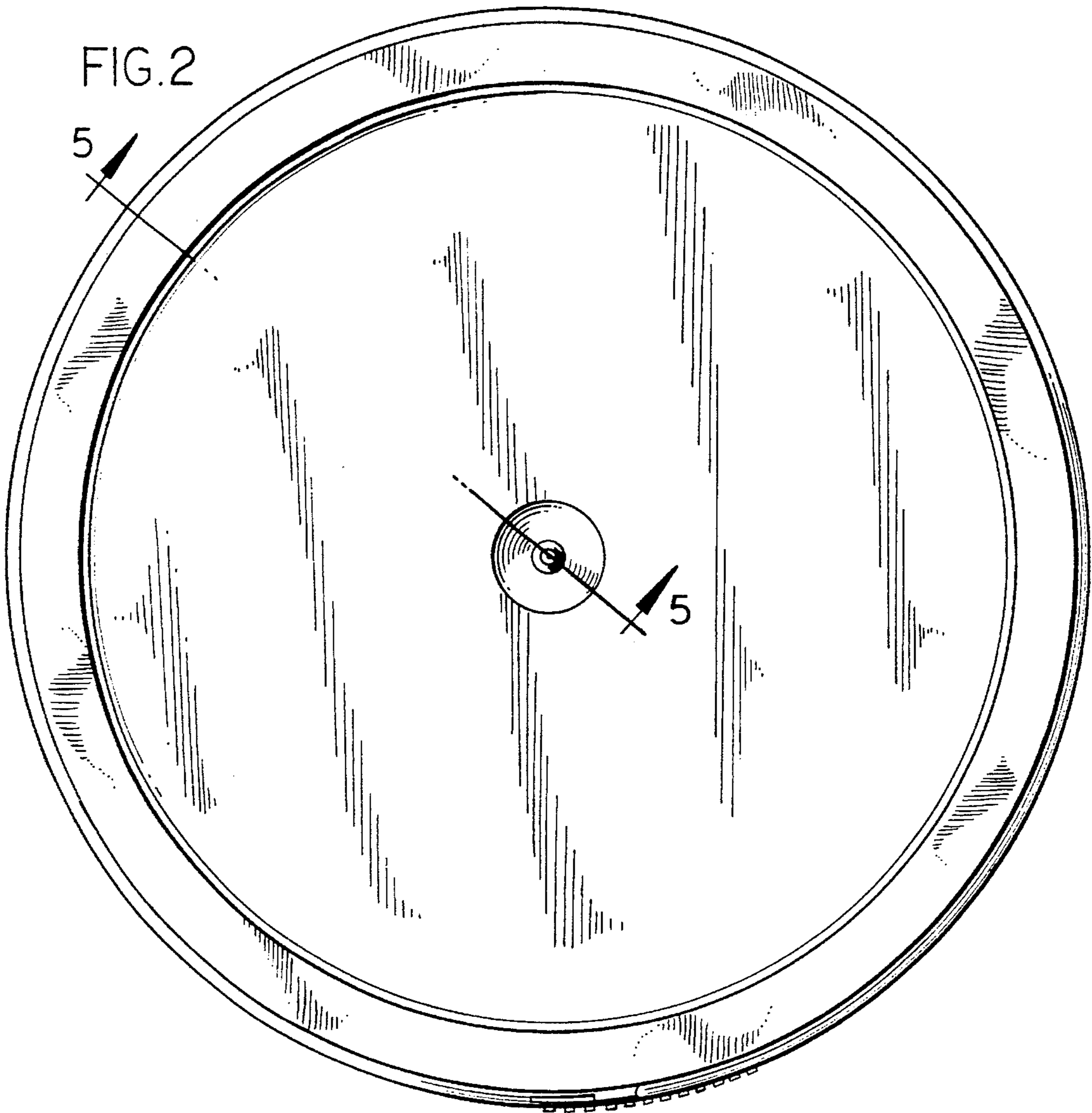

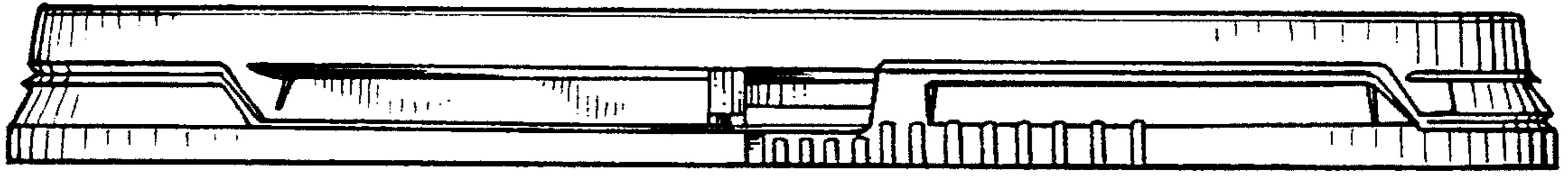

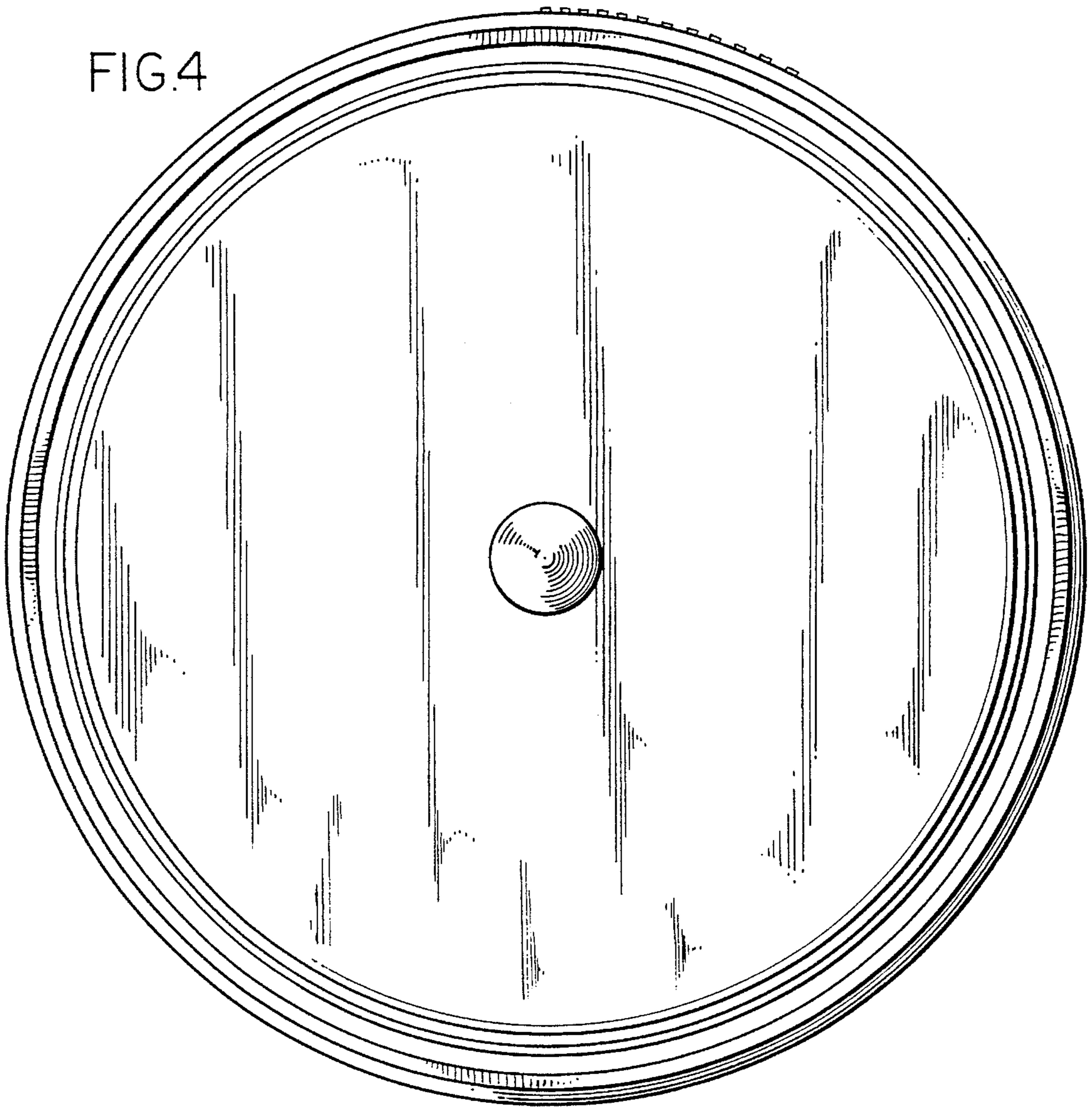

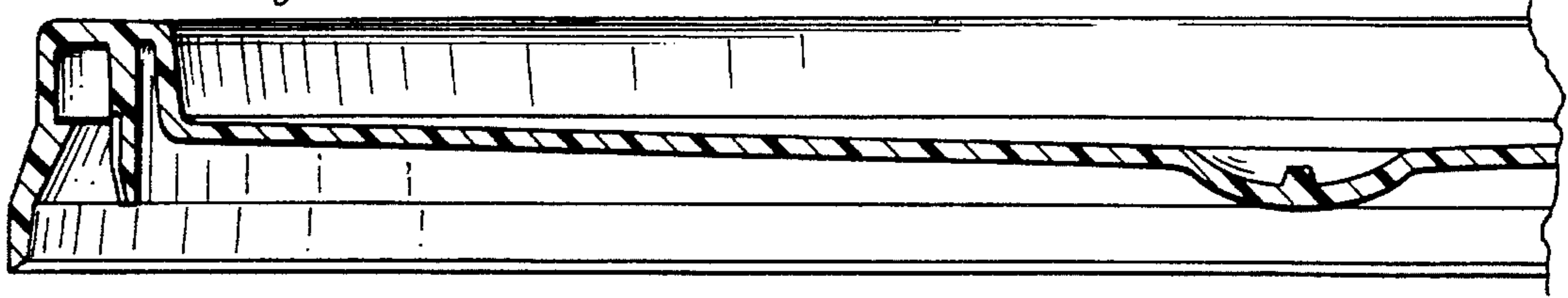

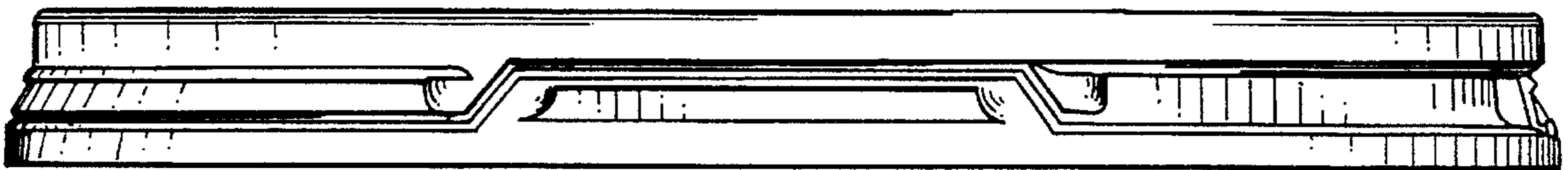

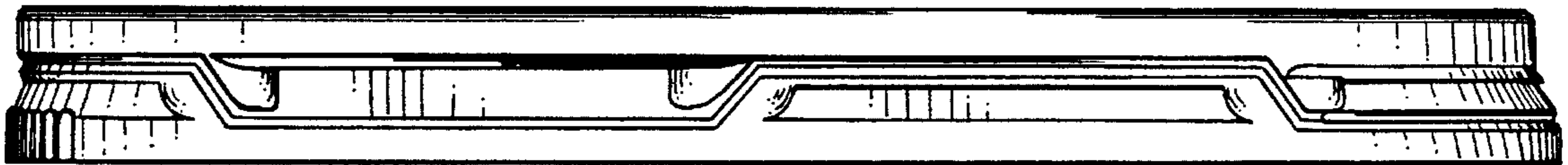
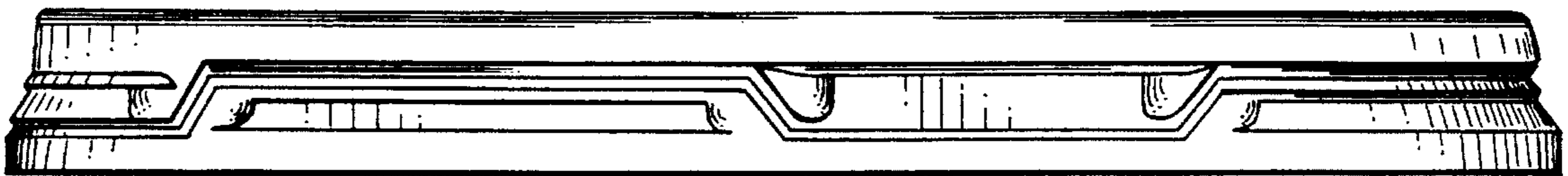

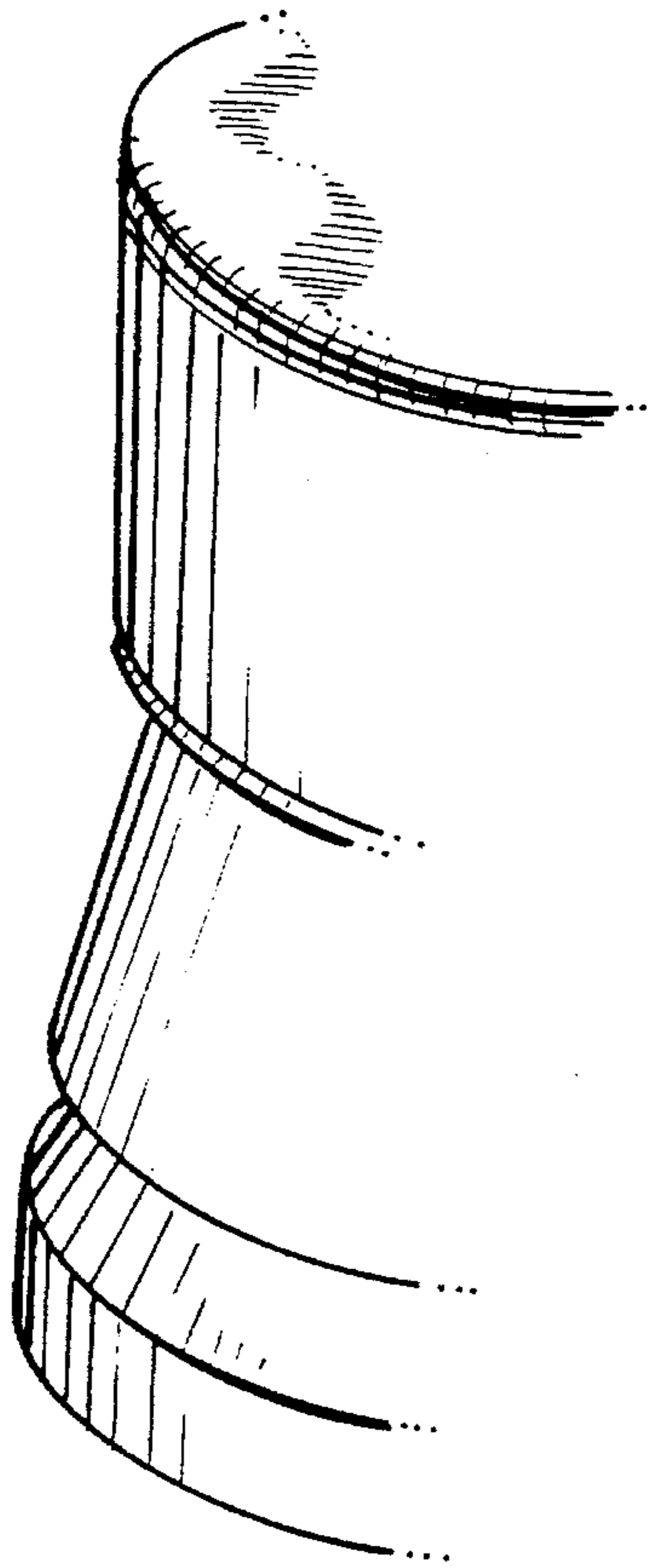

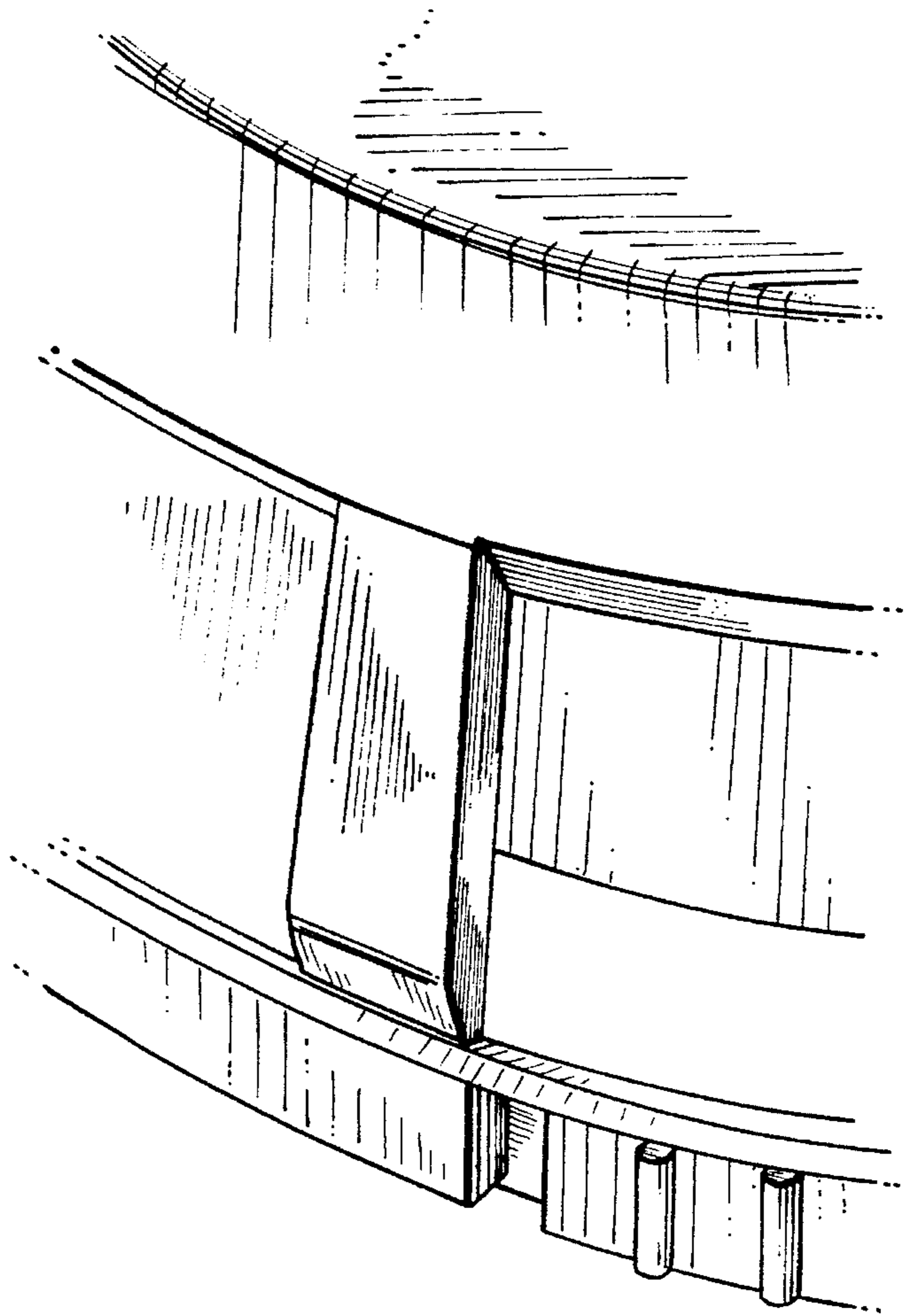
