DESCRIPTION

FIG. 8 is a top plan view thereof, the bottom is plane and unornamented;

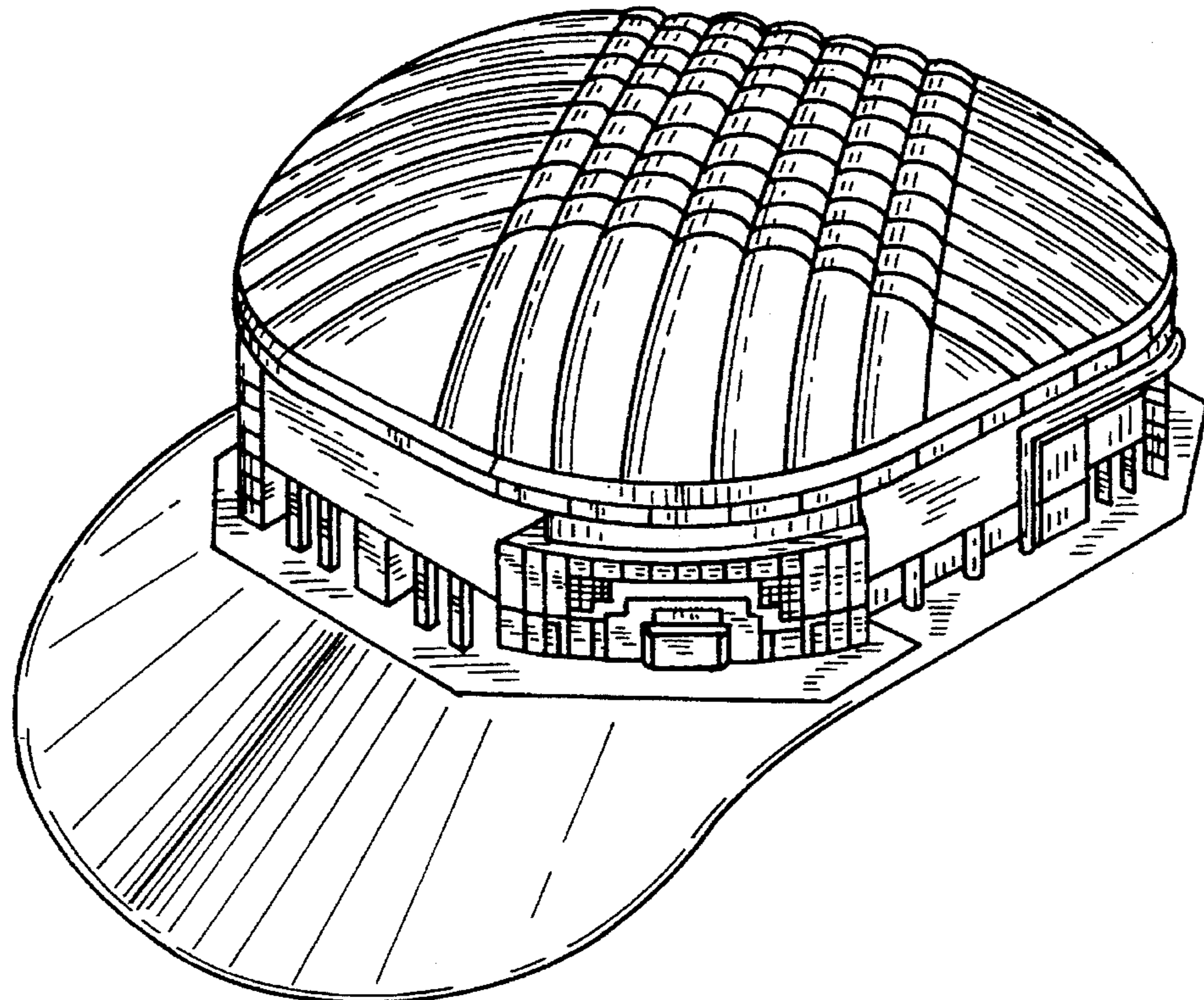
FIG. 9 is a front perspective view of a third embodiment of a baseball cap showing my new design;

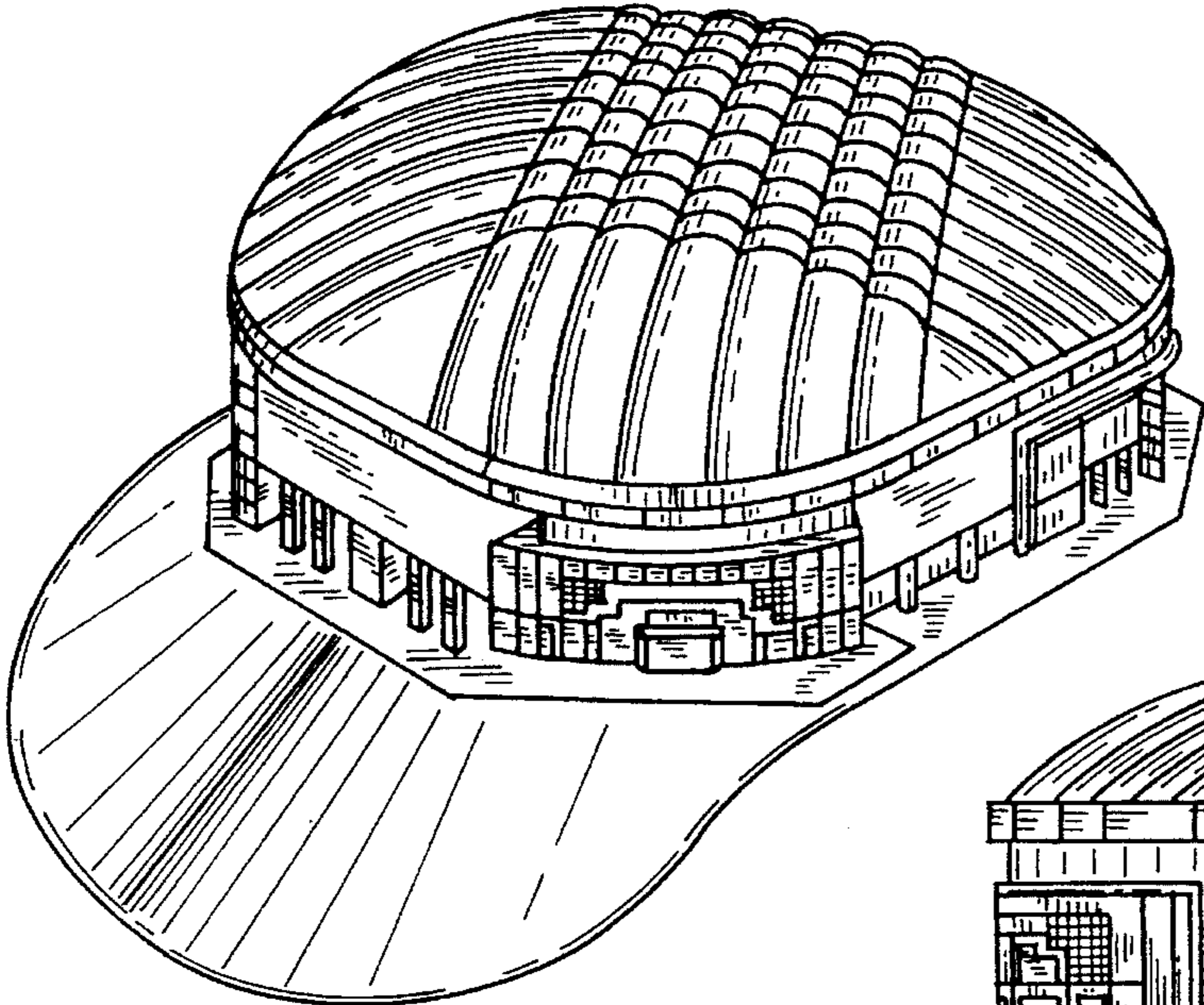

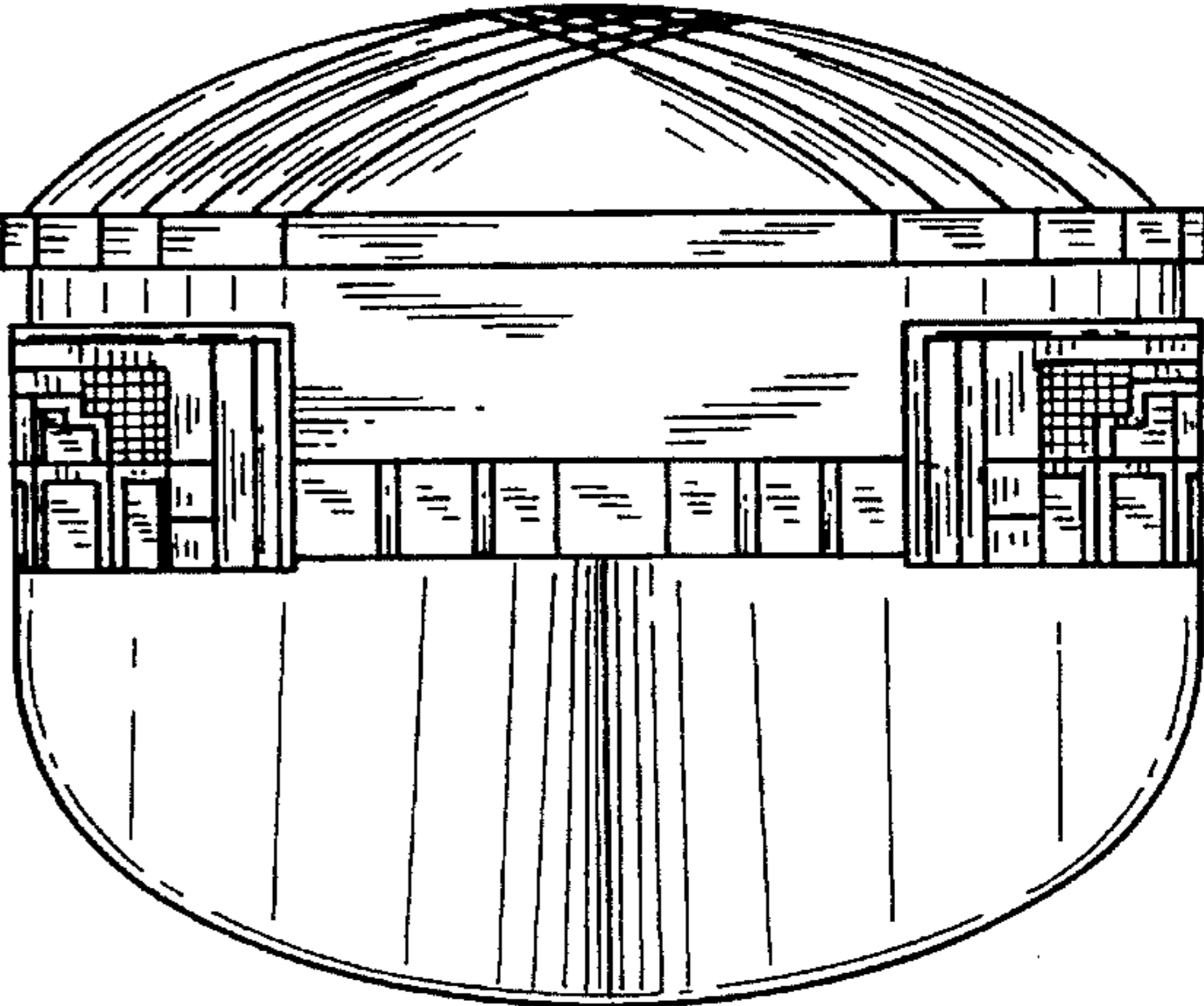

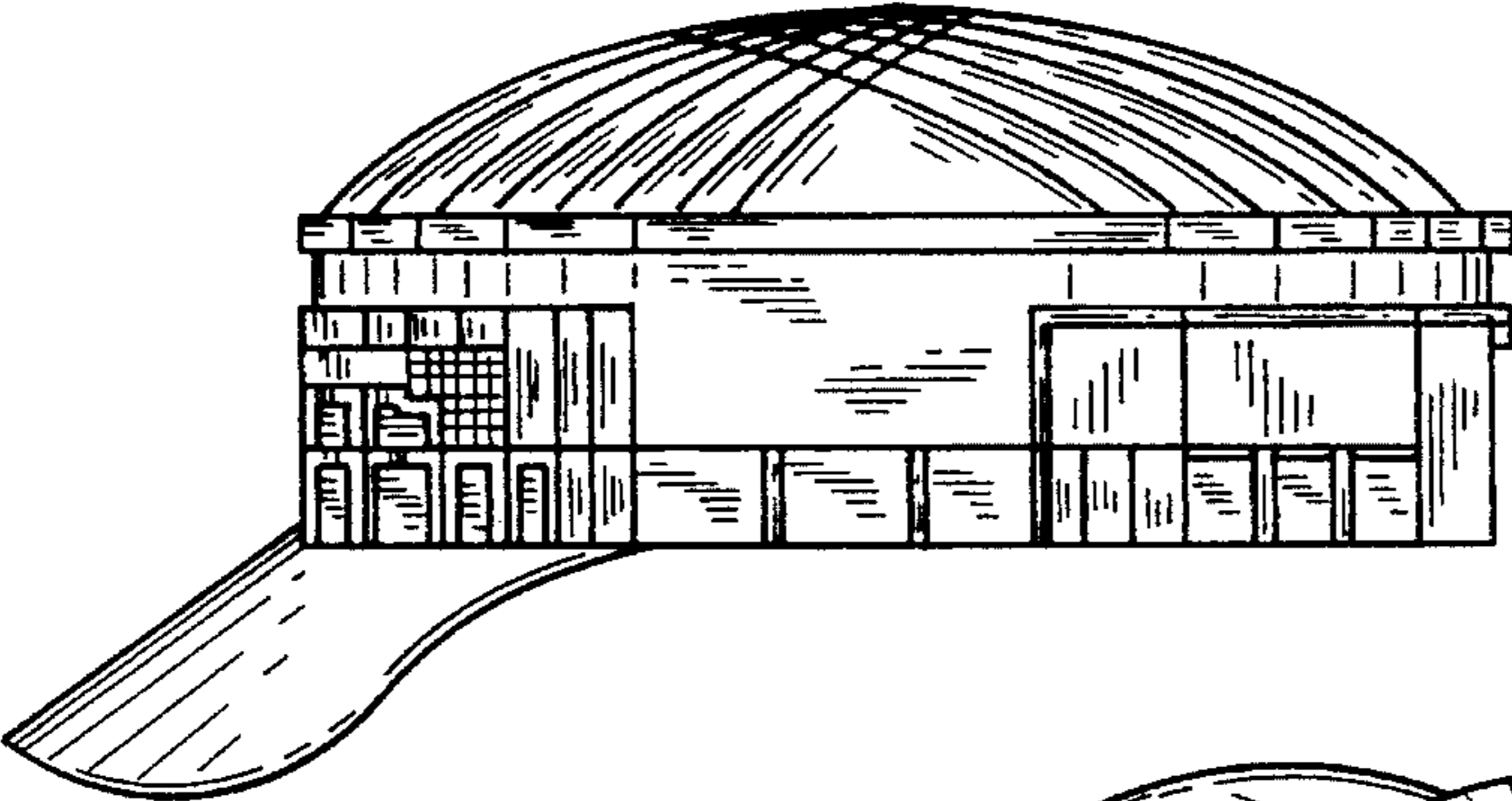
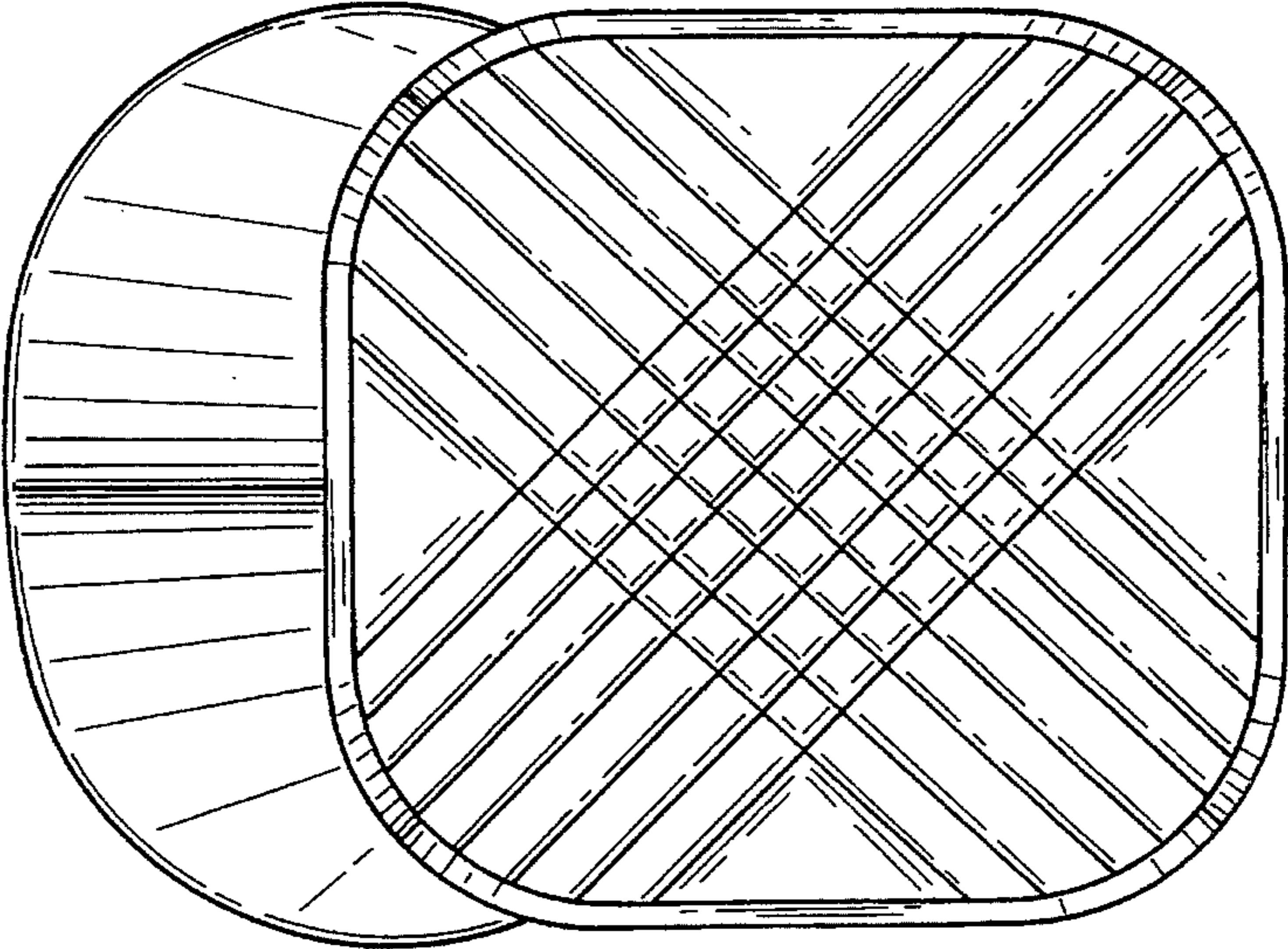

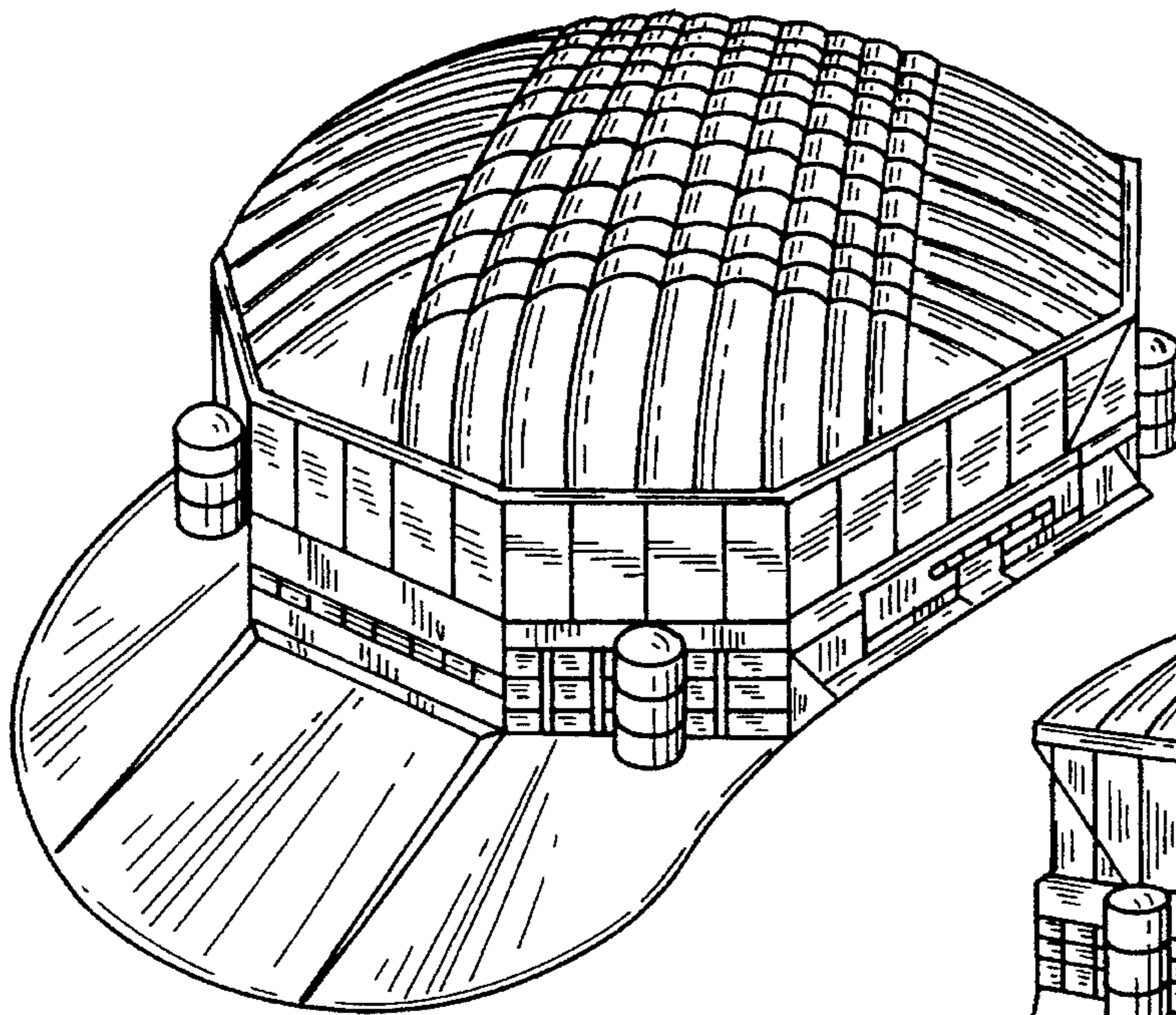

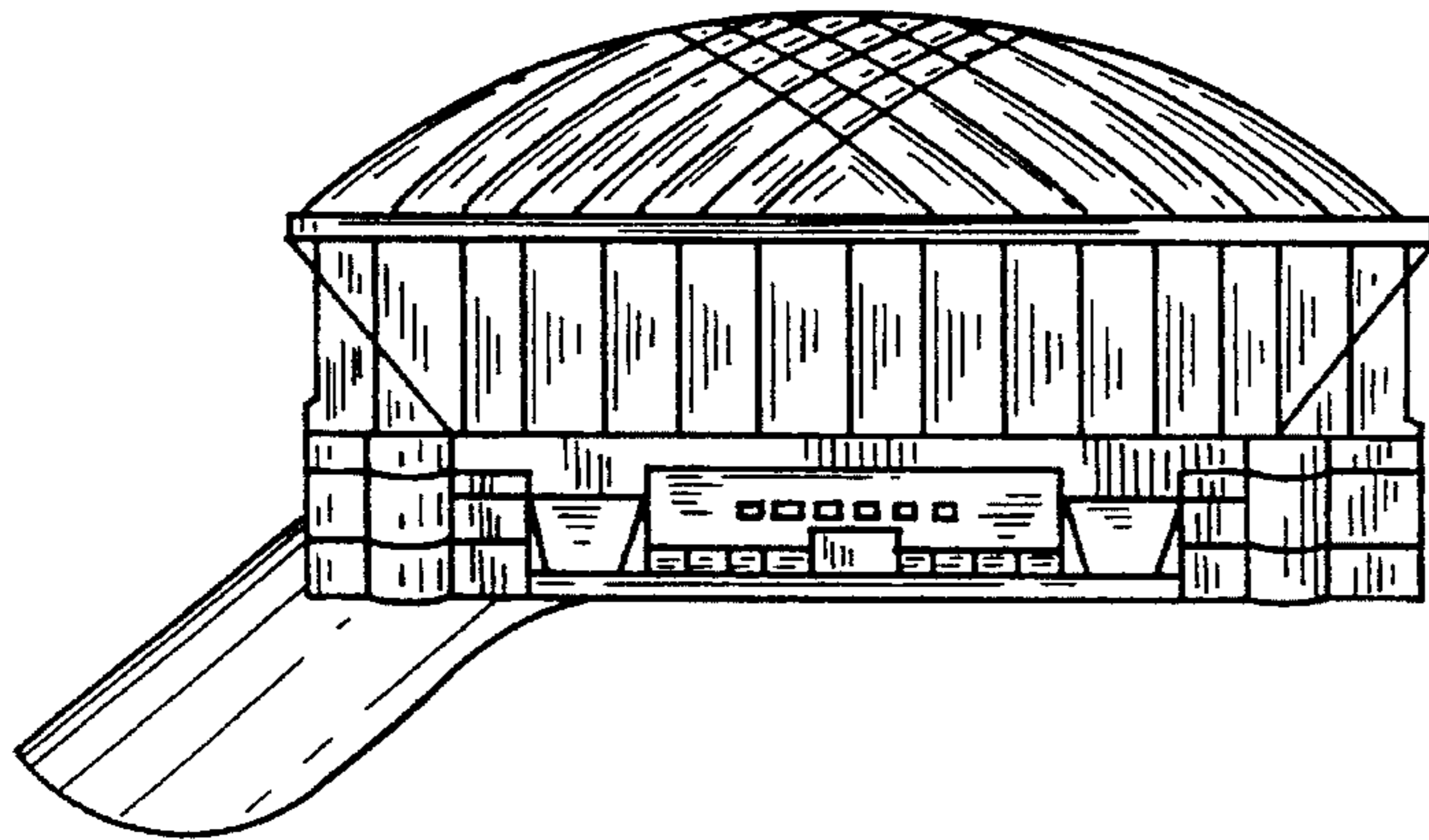
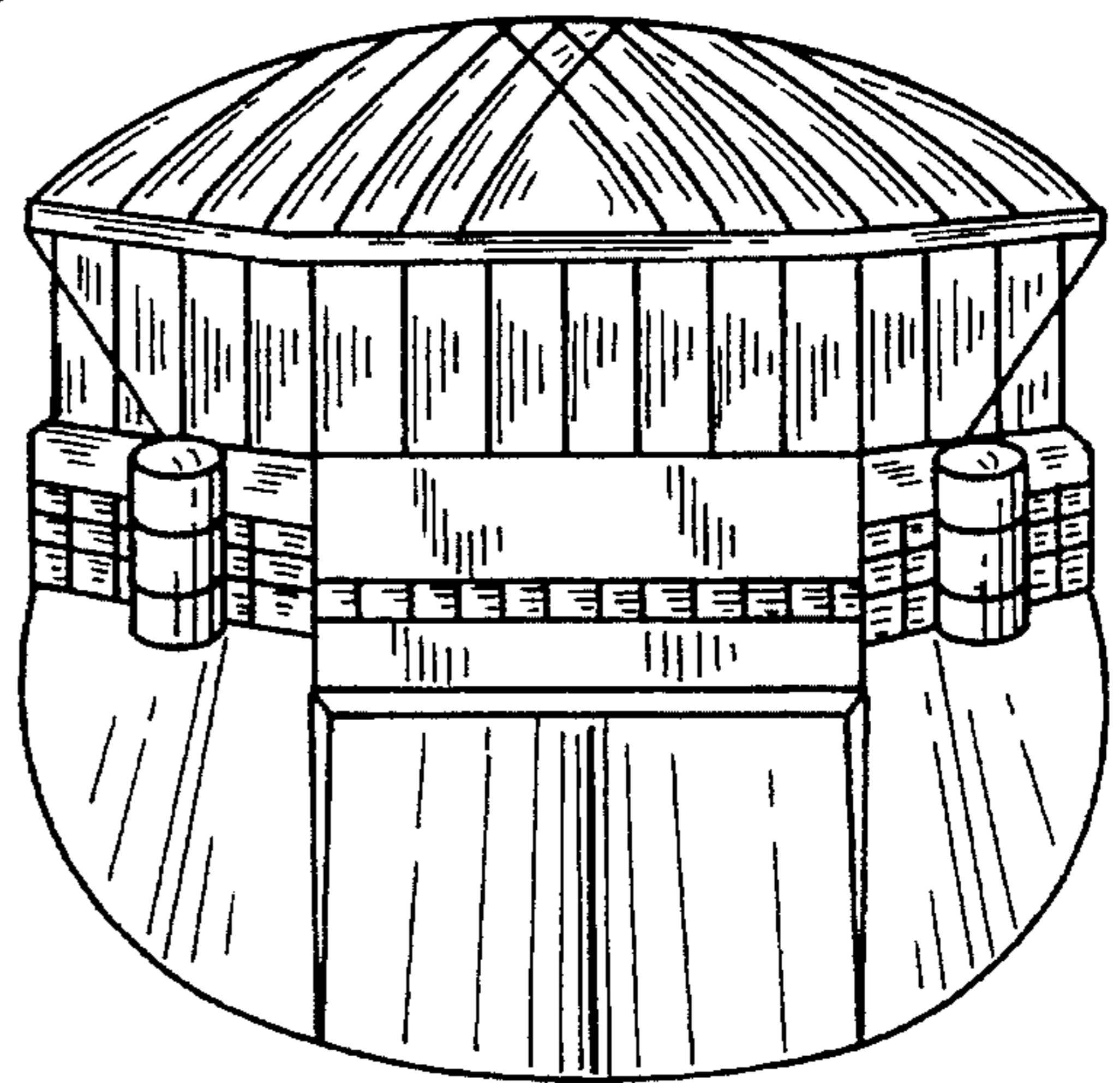
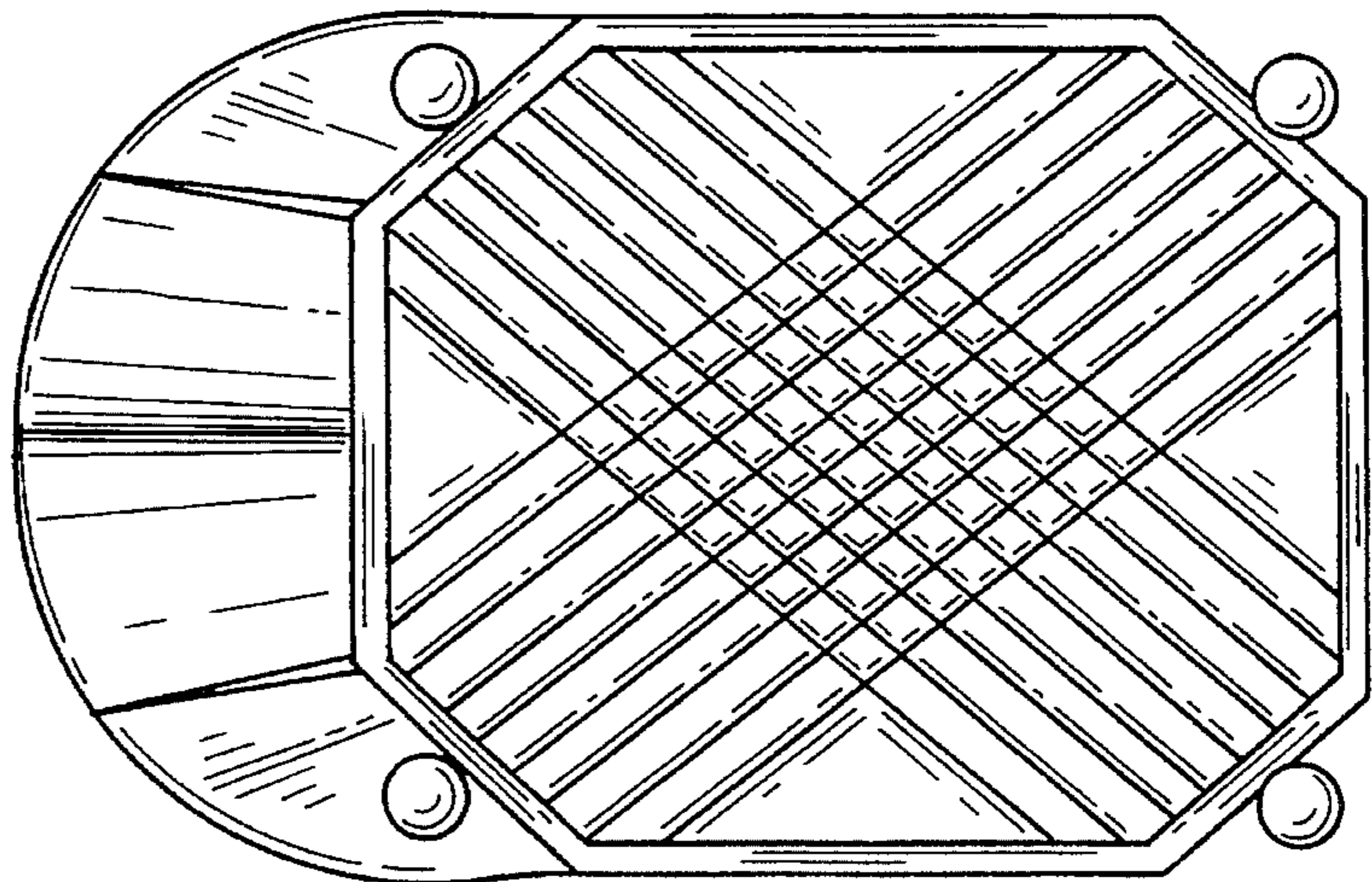

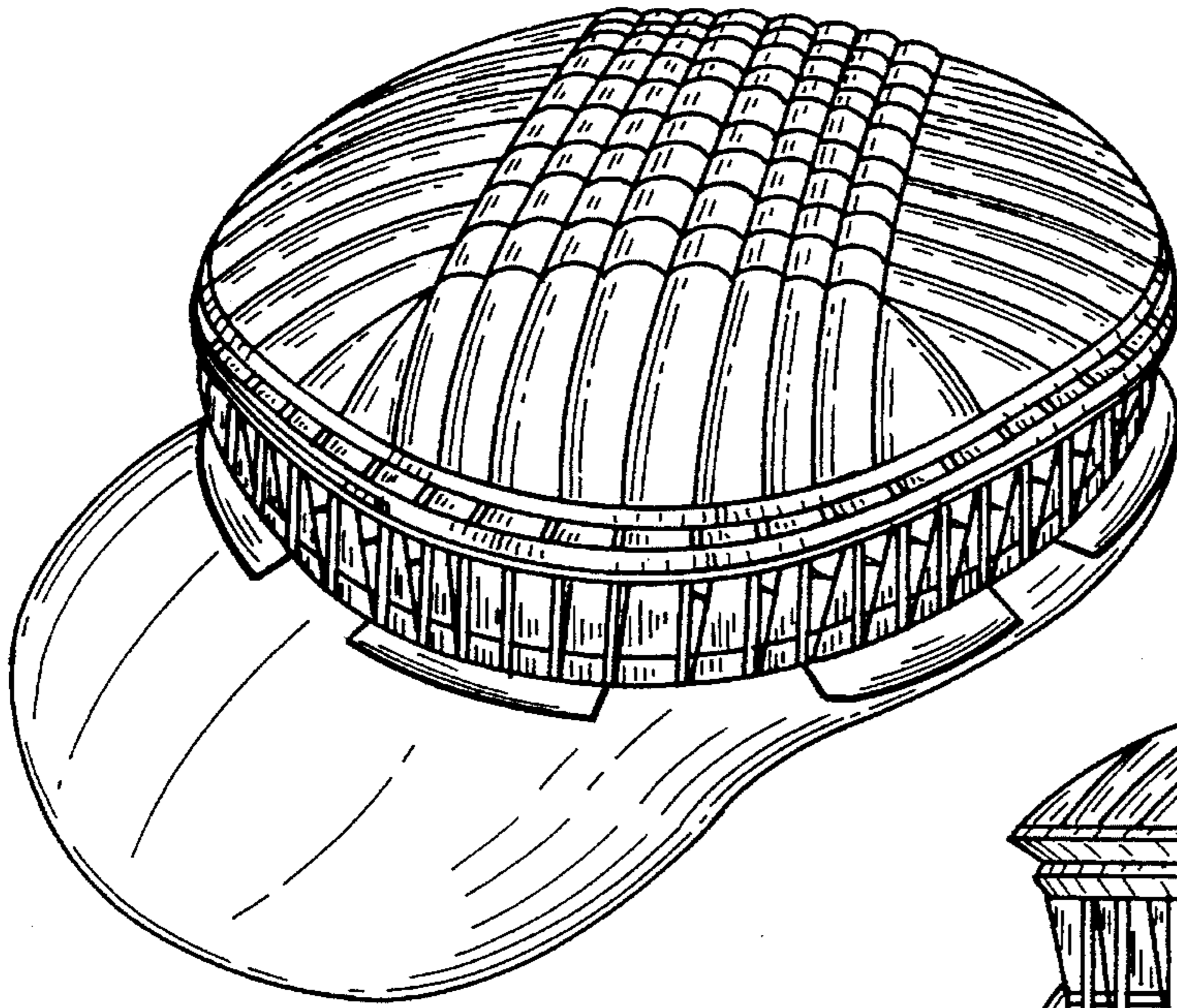

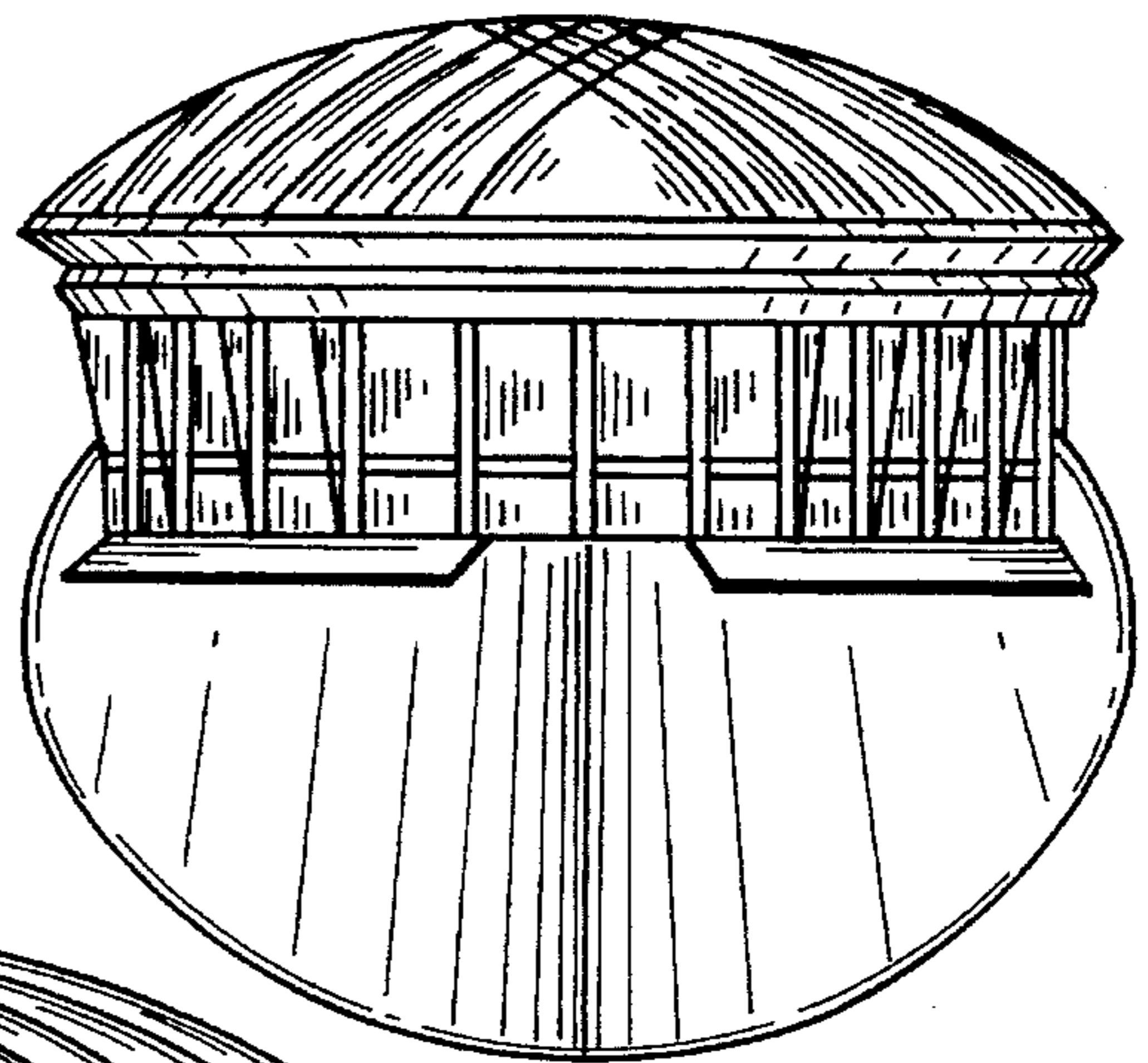

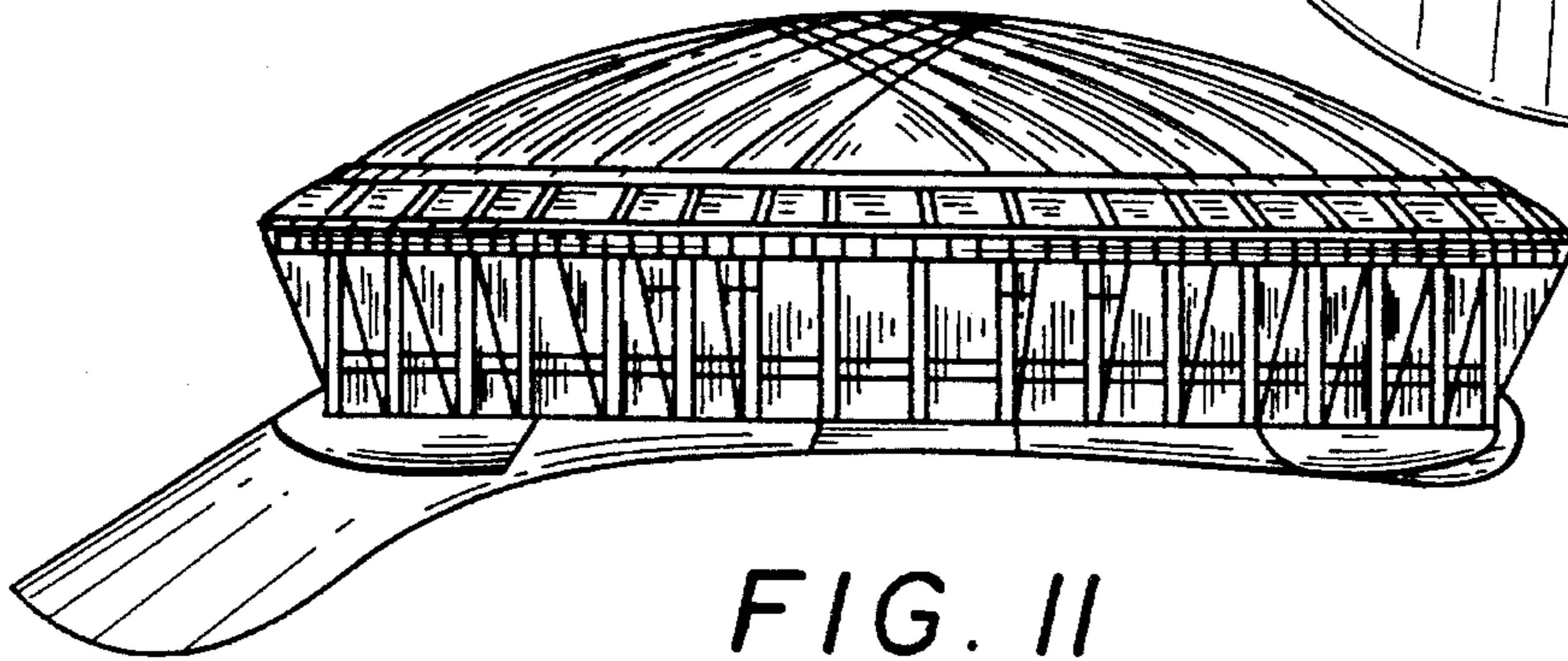

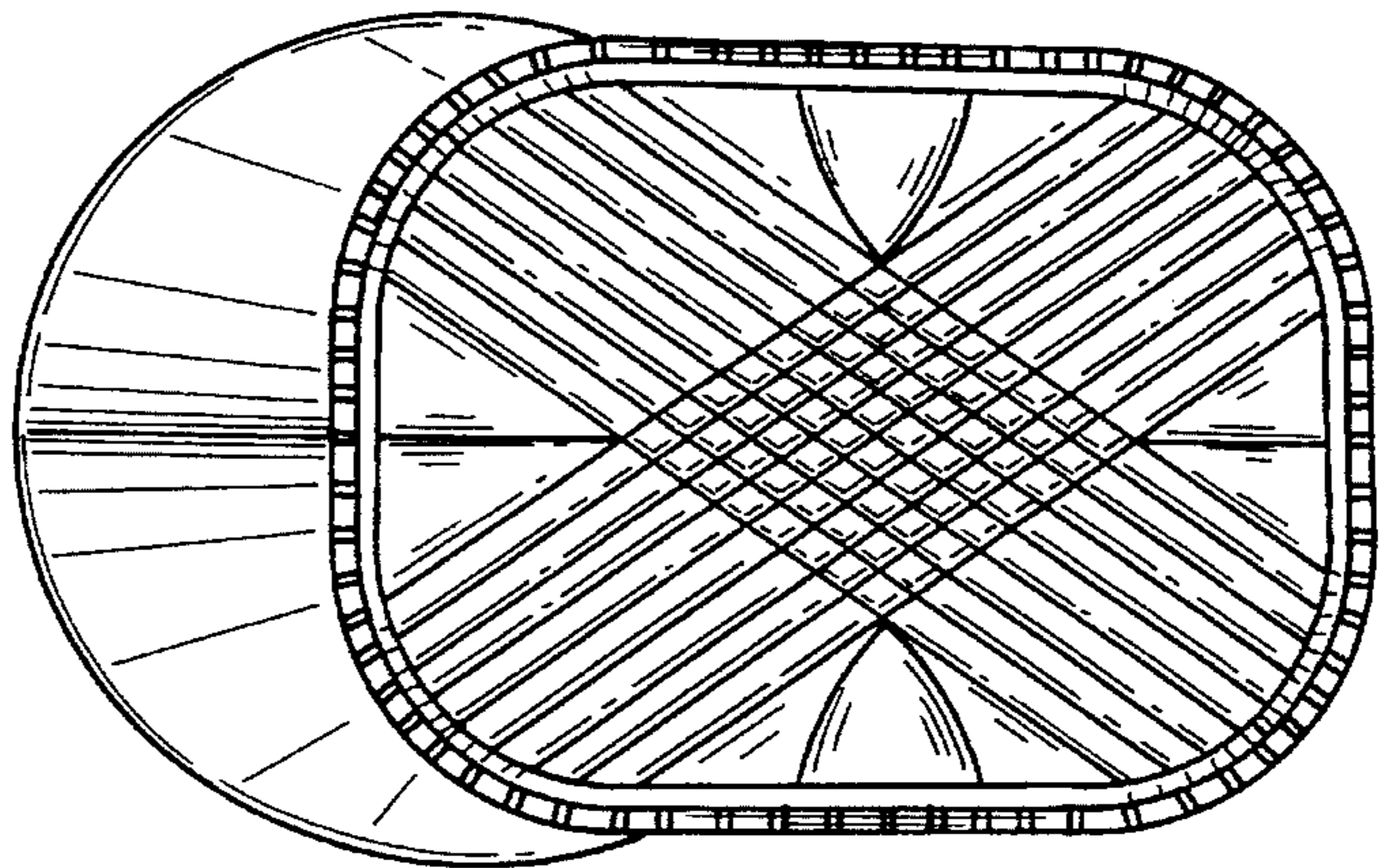
