## DESCRIPTION

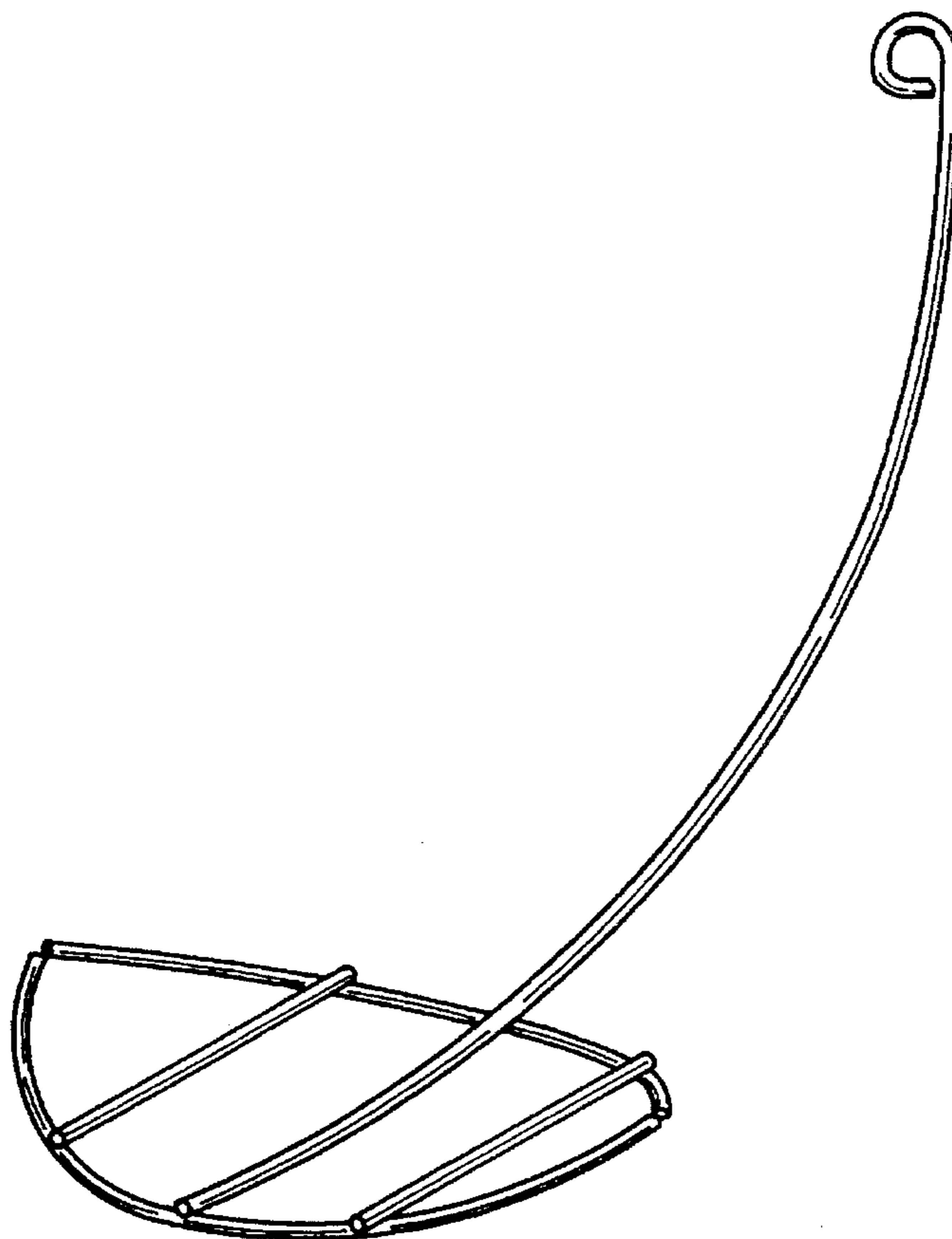
FIG. 1 is a perspective view of a barbecue grill ash sweep showing our new design;

 FIG. 6 is a rear elevational view thereof; and,

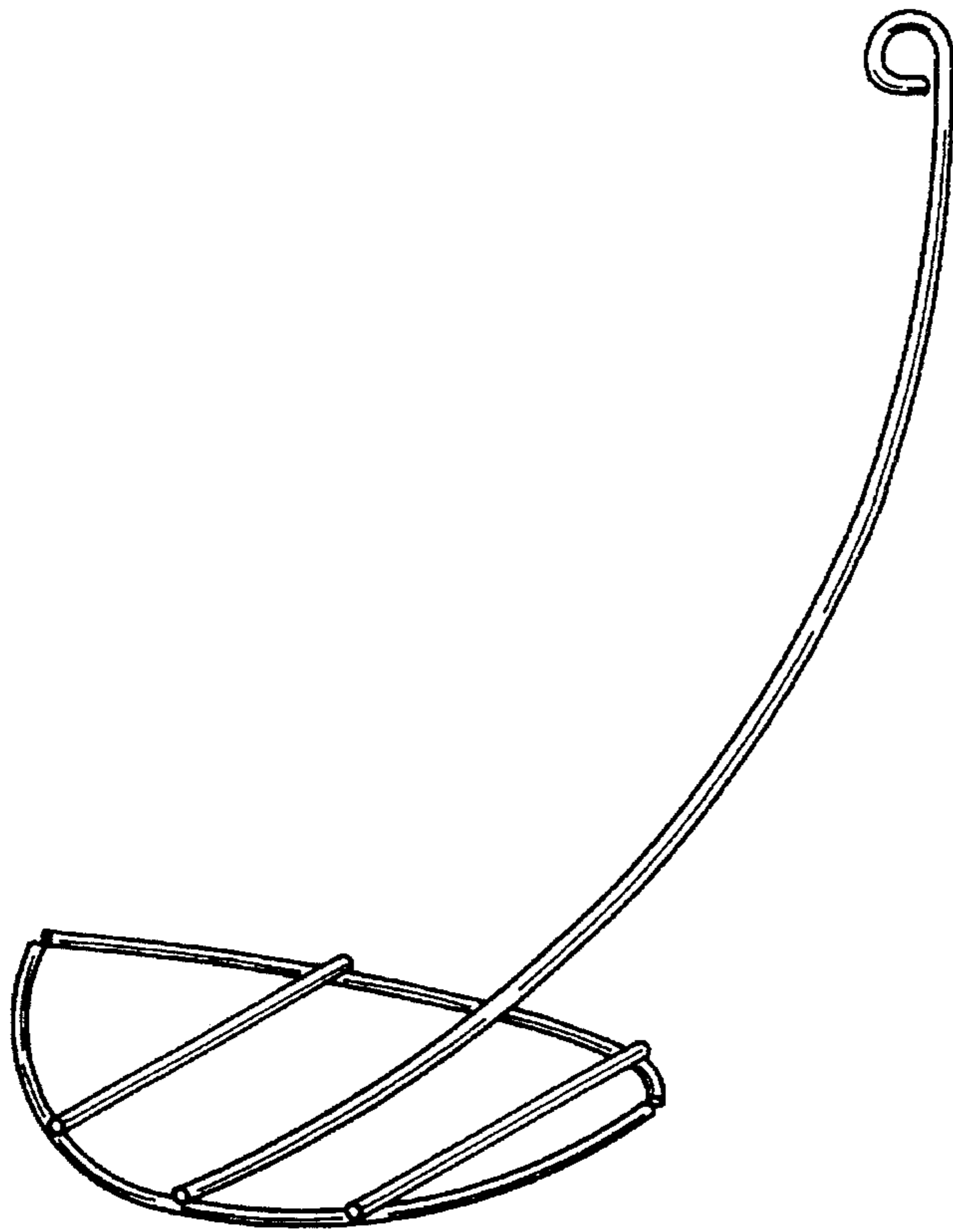

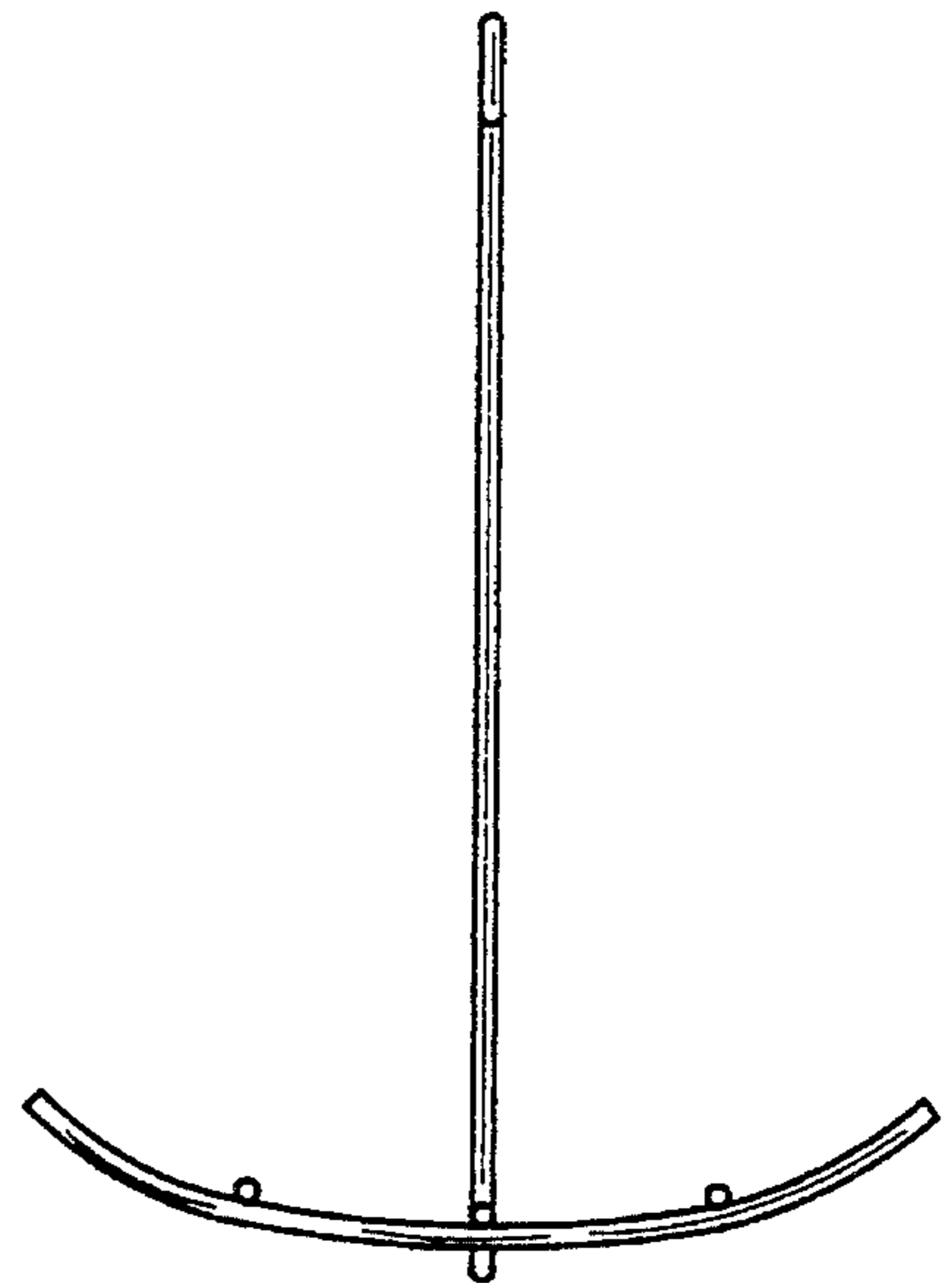

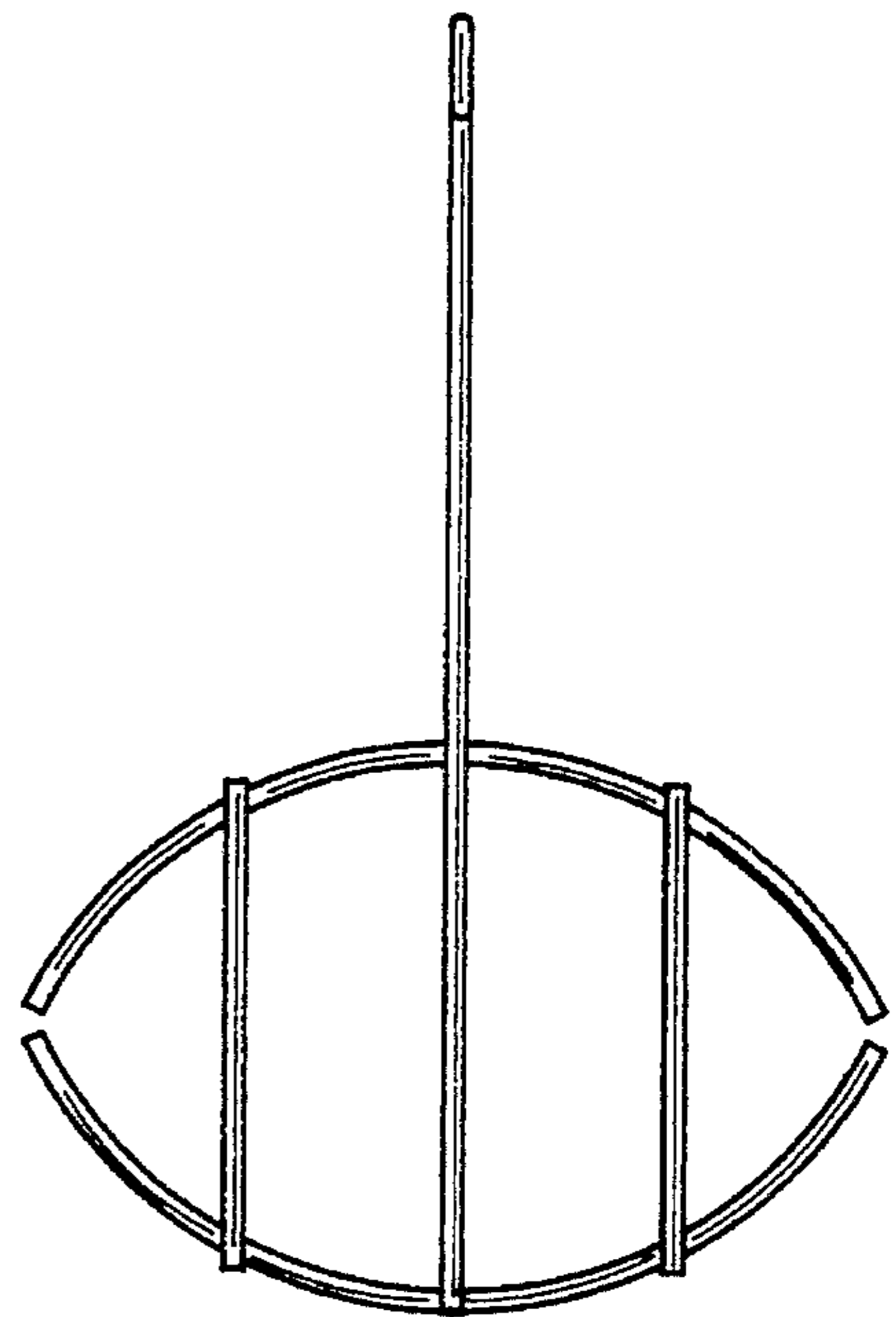

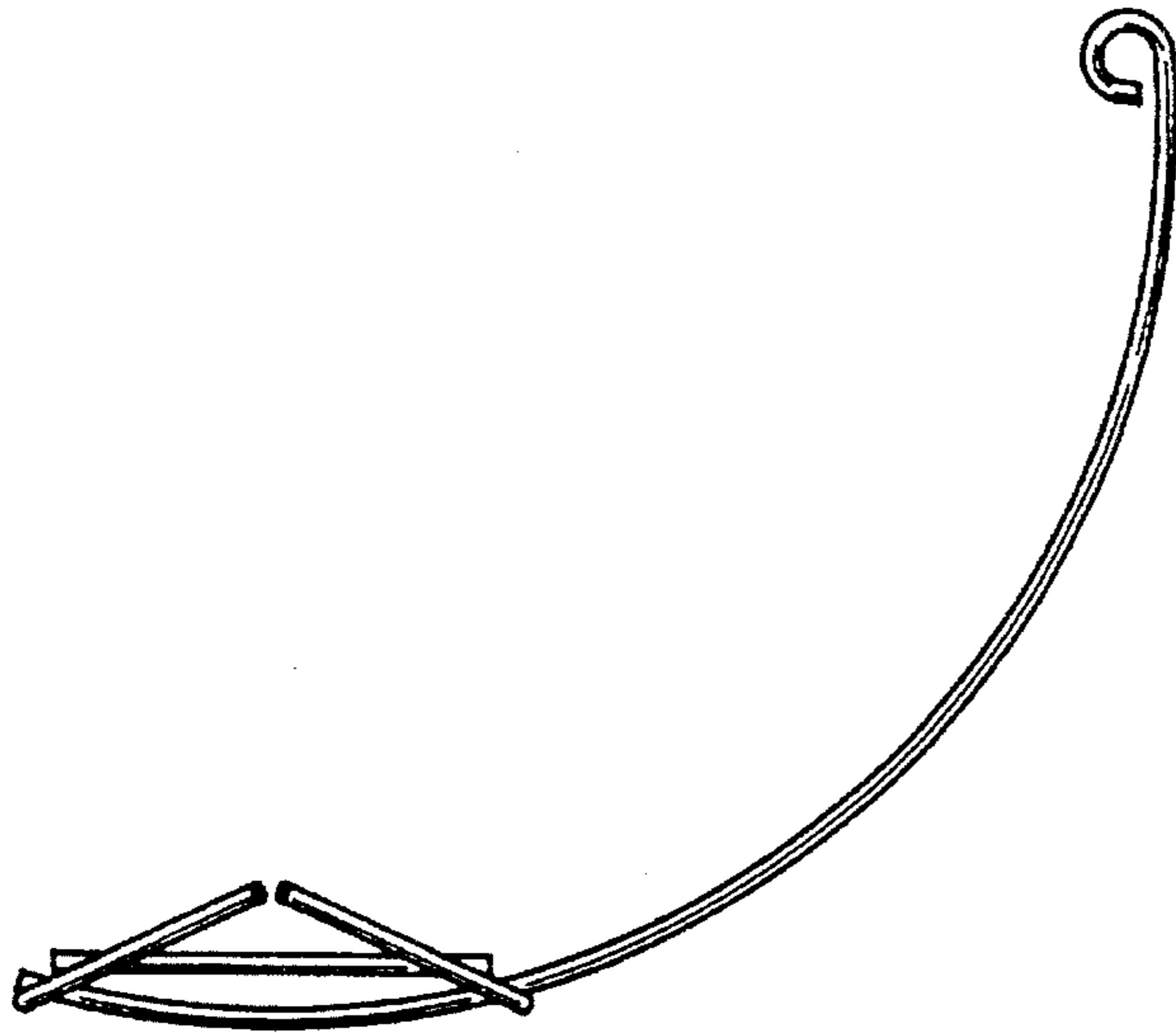

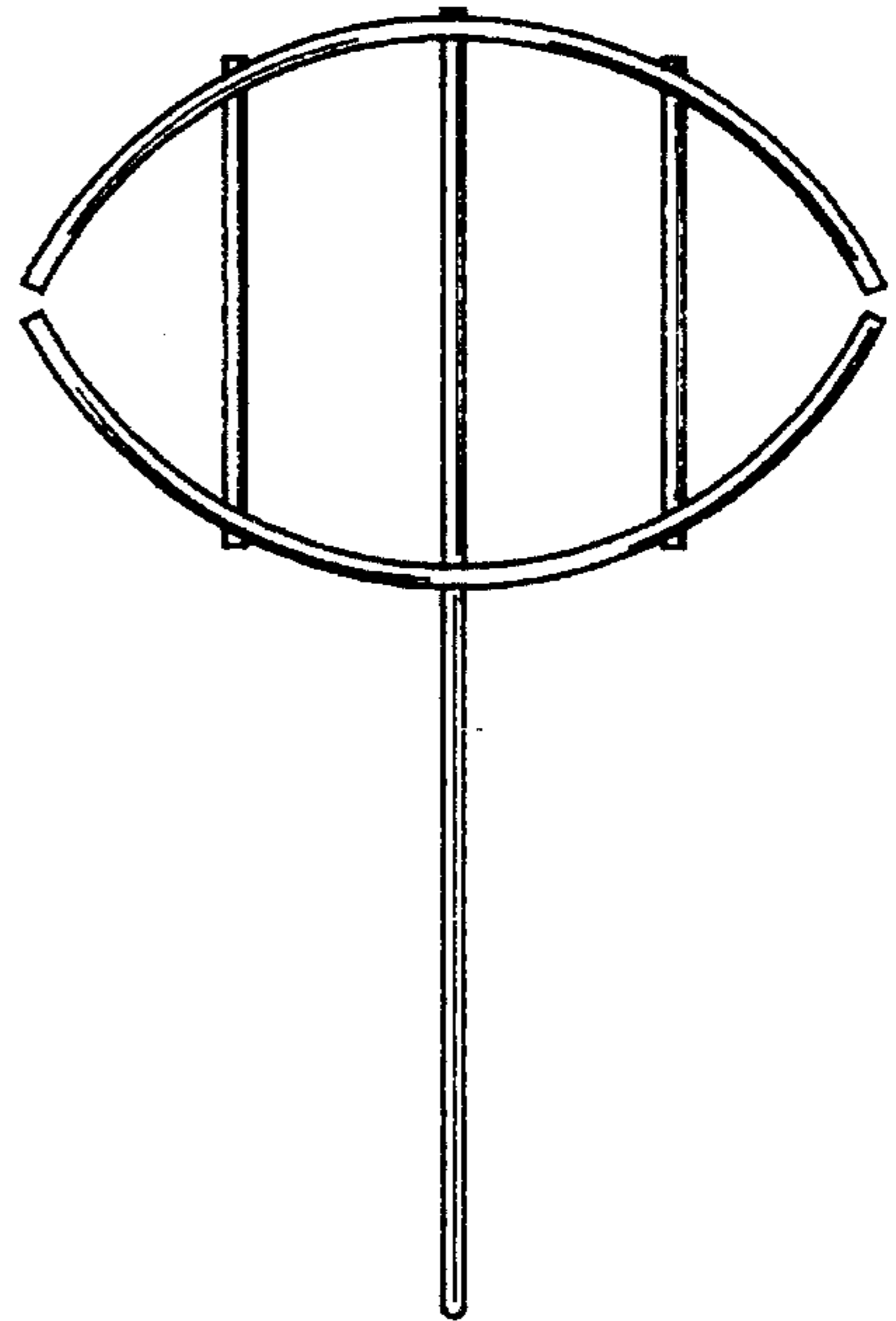

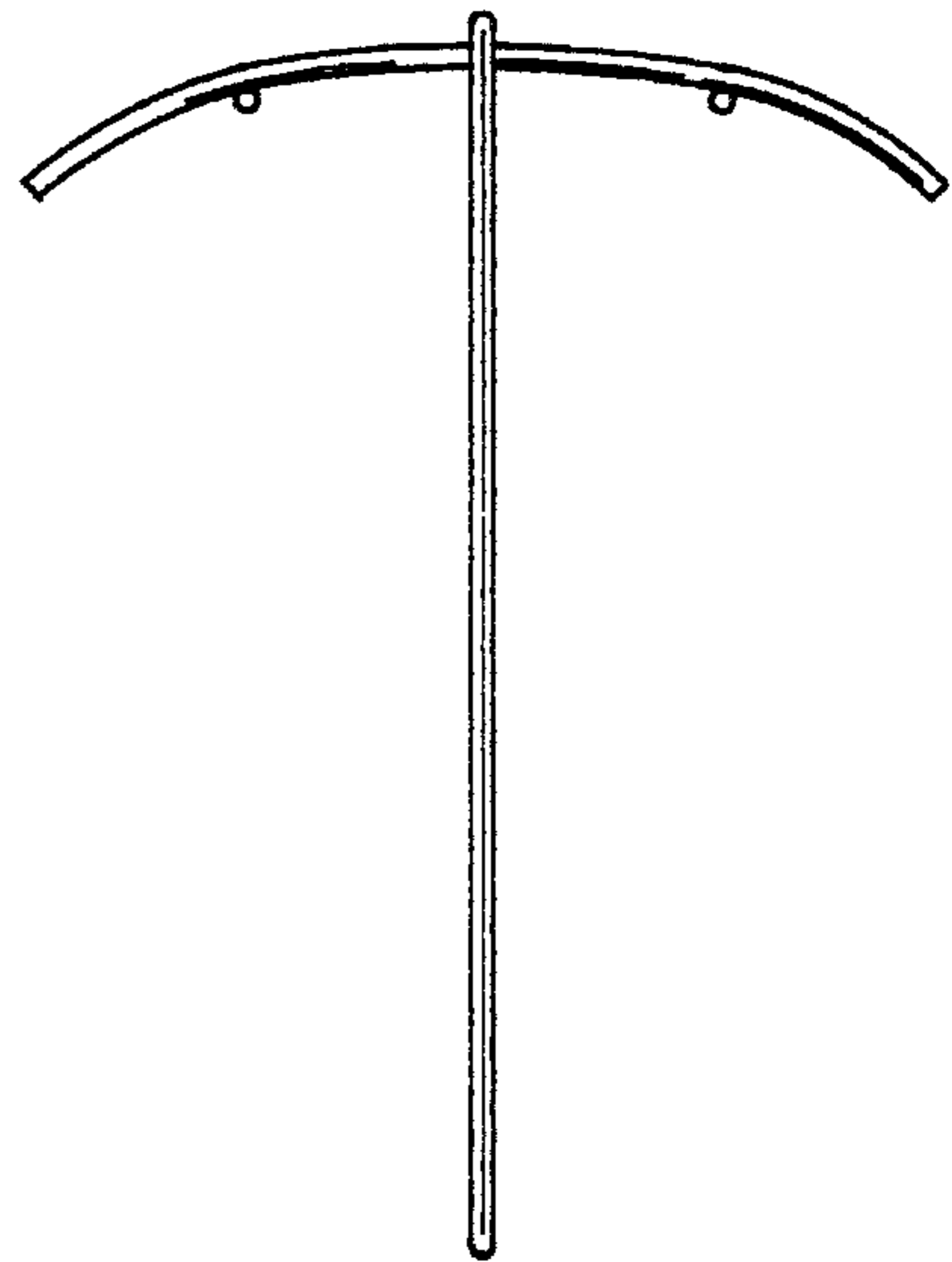

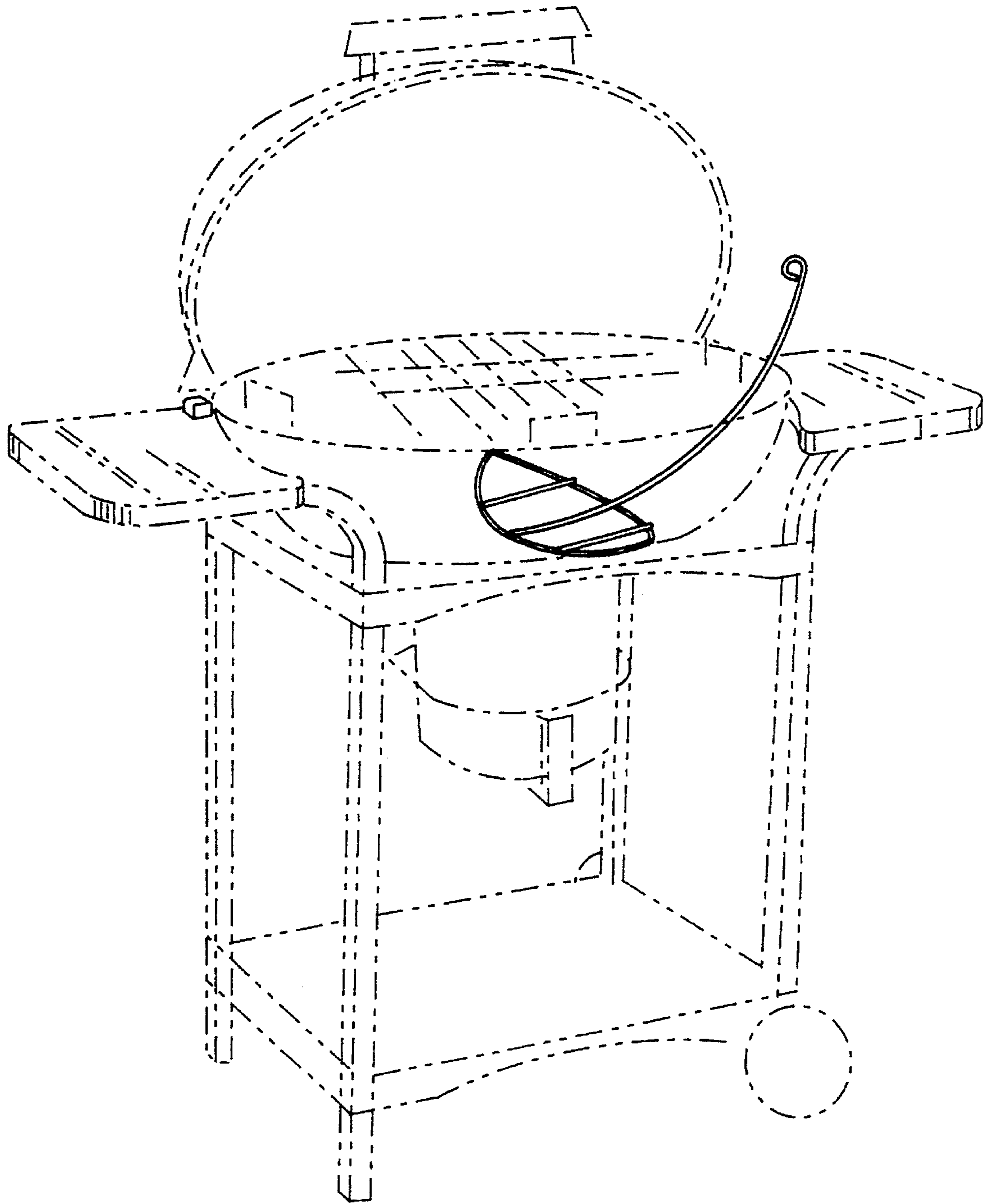
