 FIG. 12 is a perspective view of the front and right side thereof.

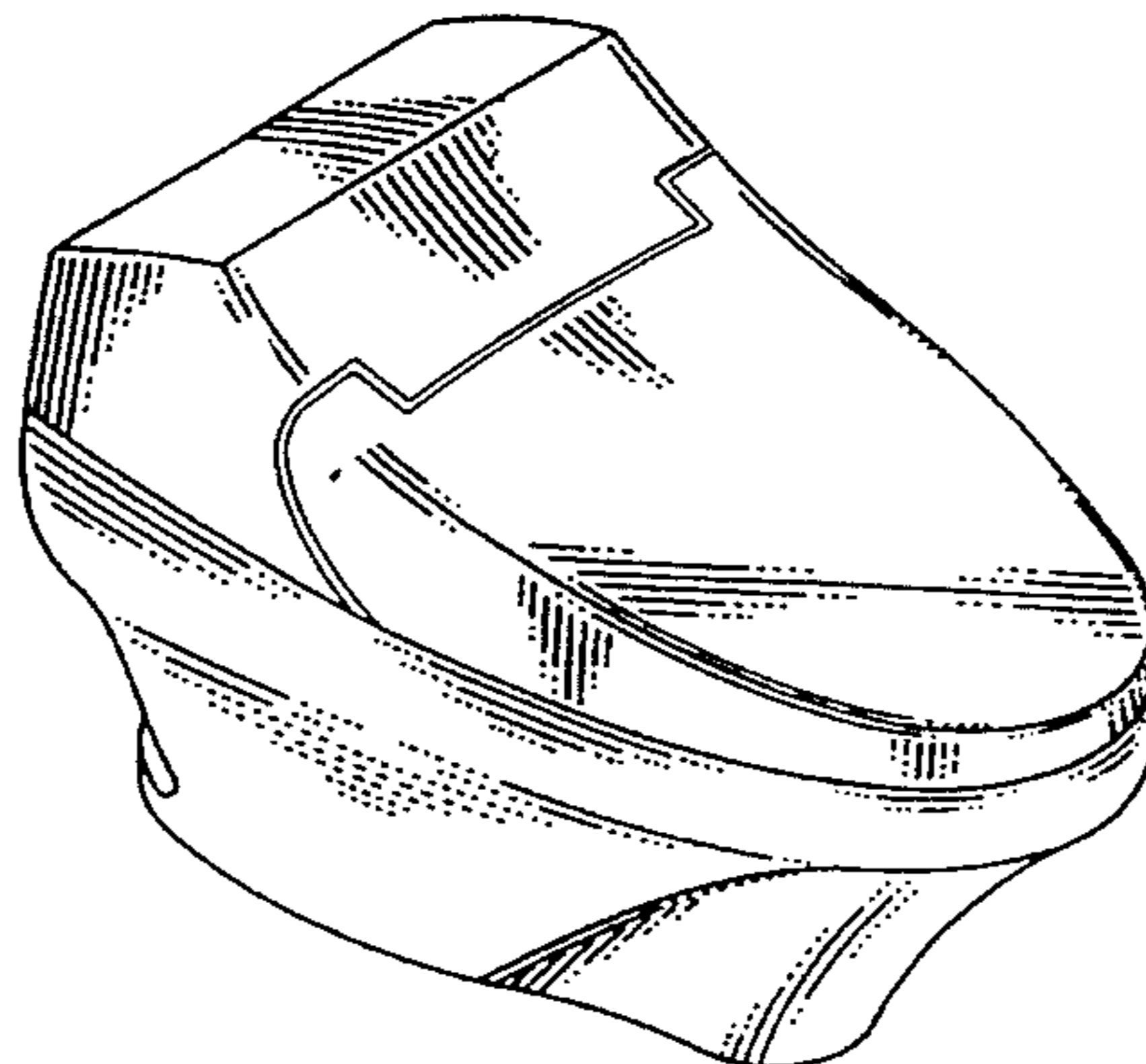
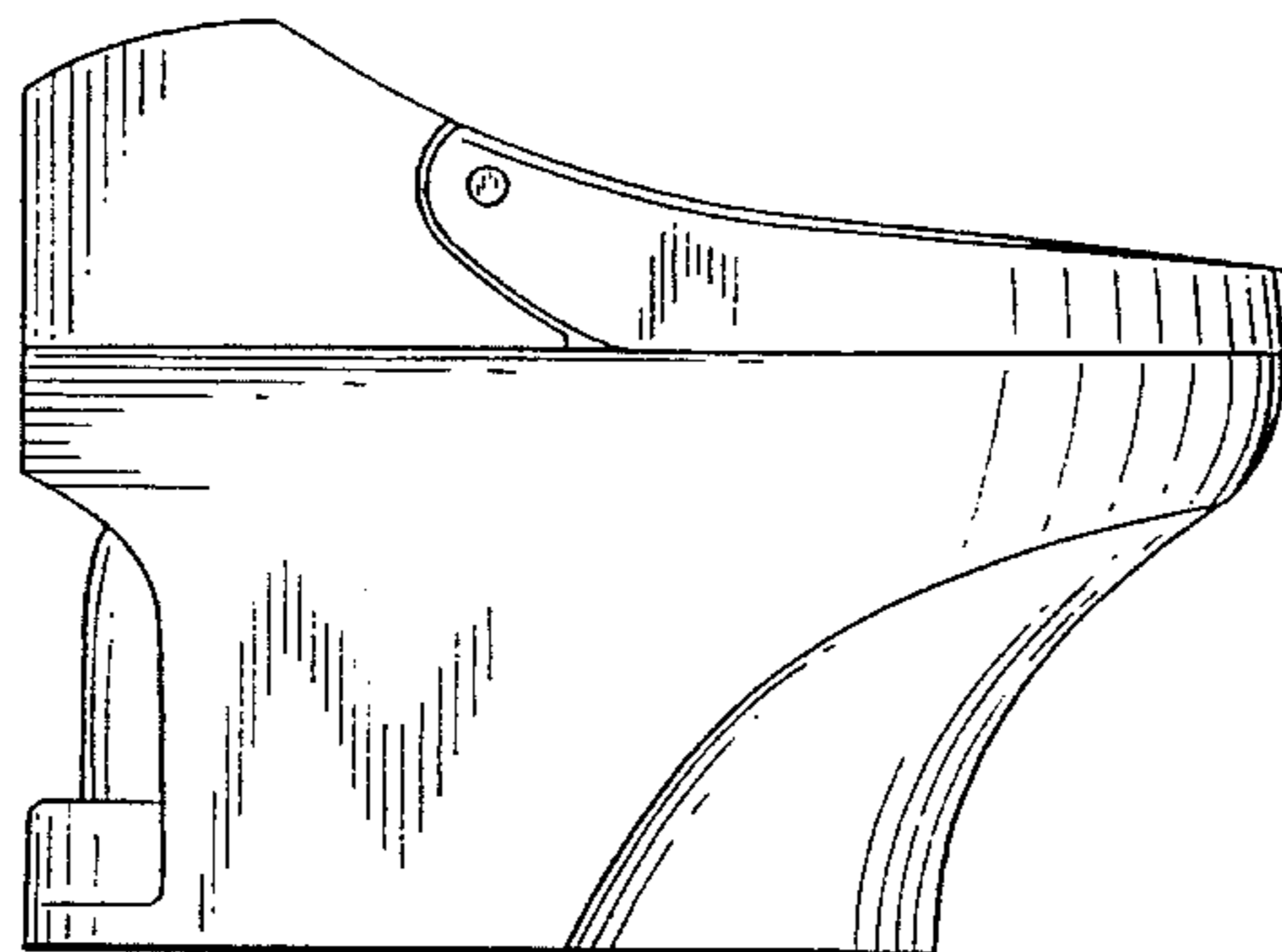

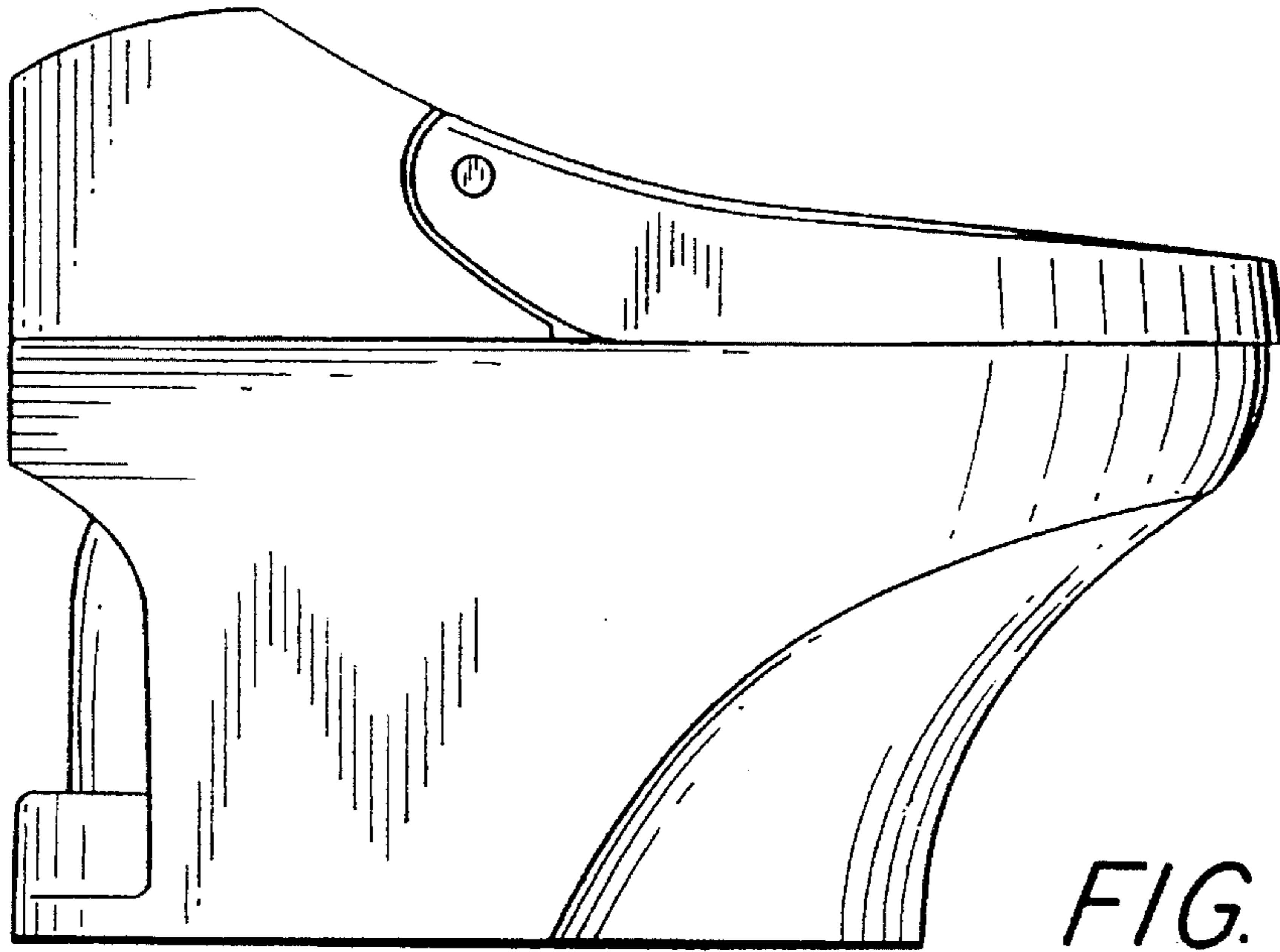

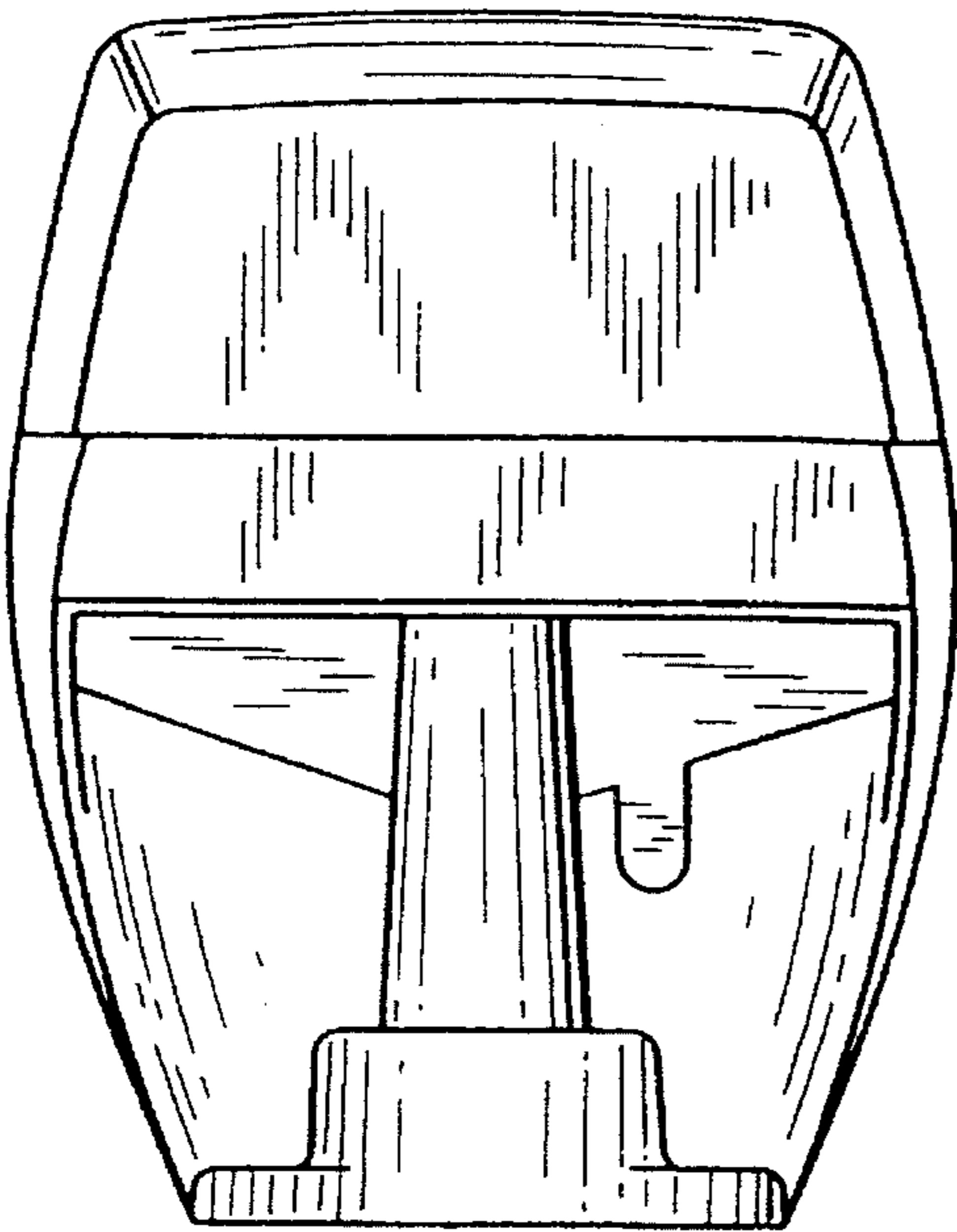

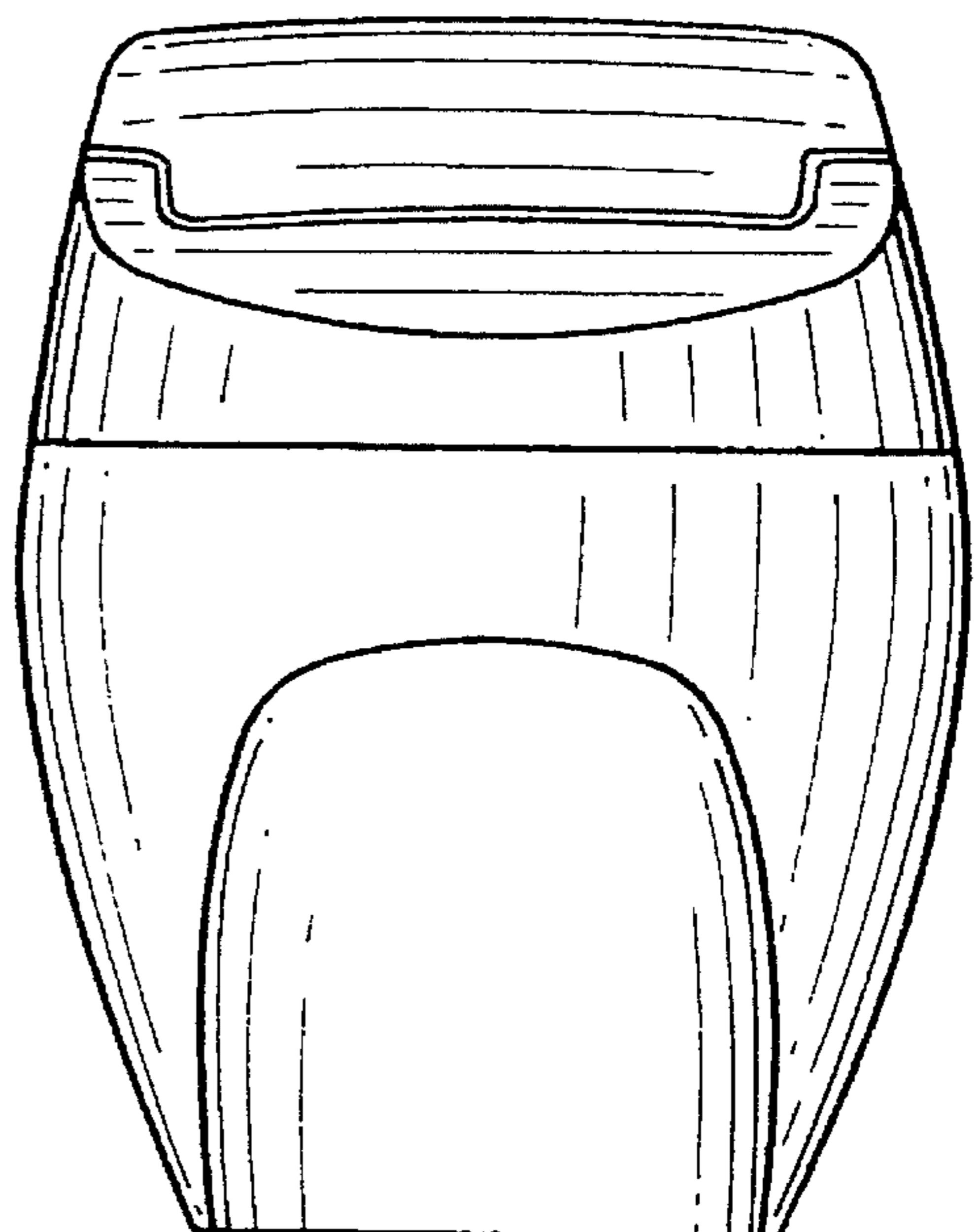

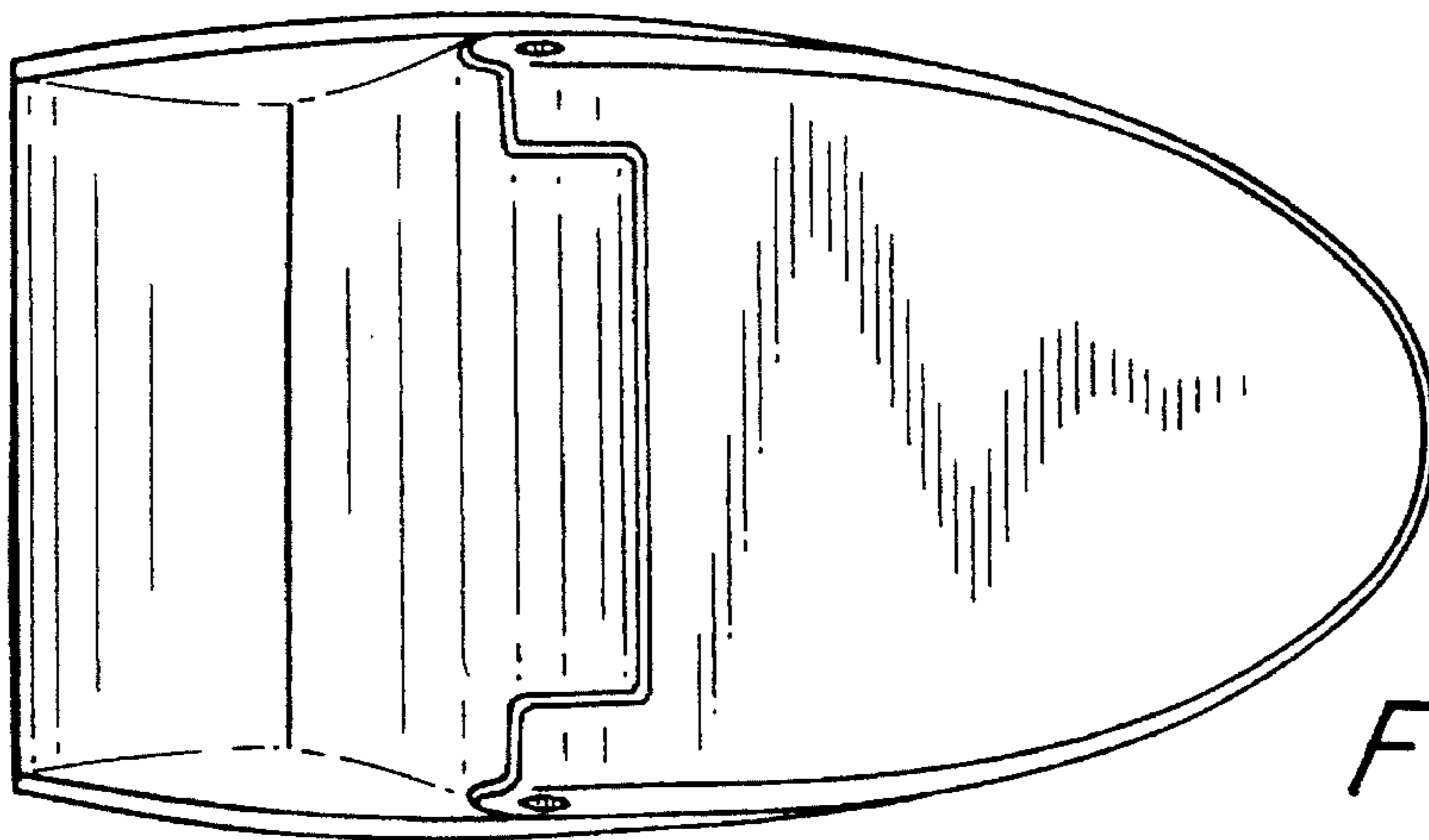

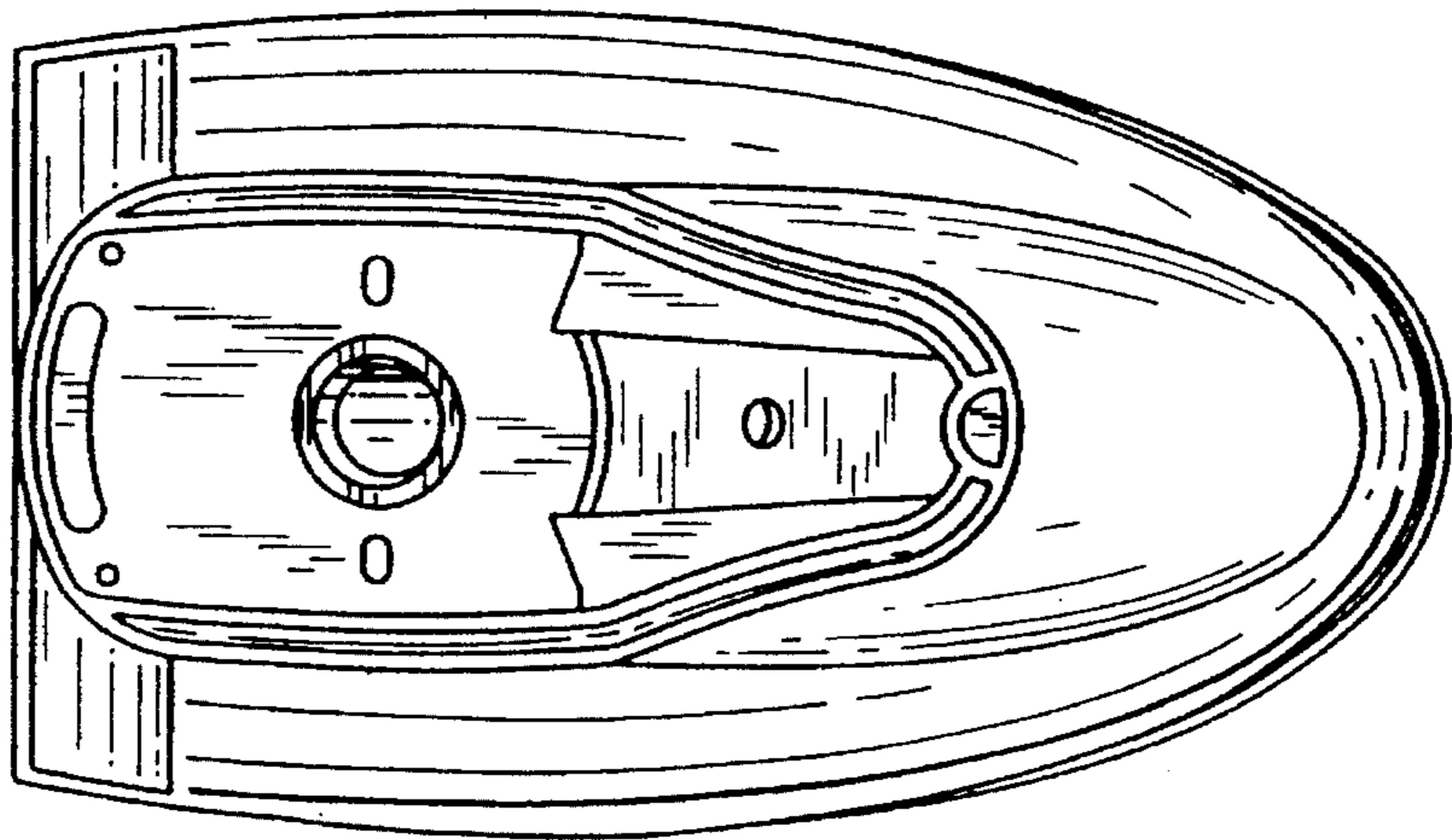

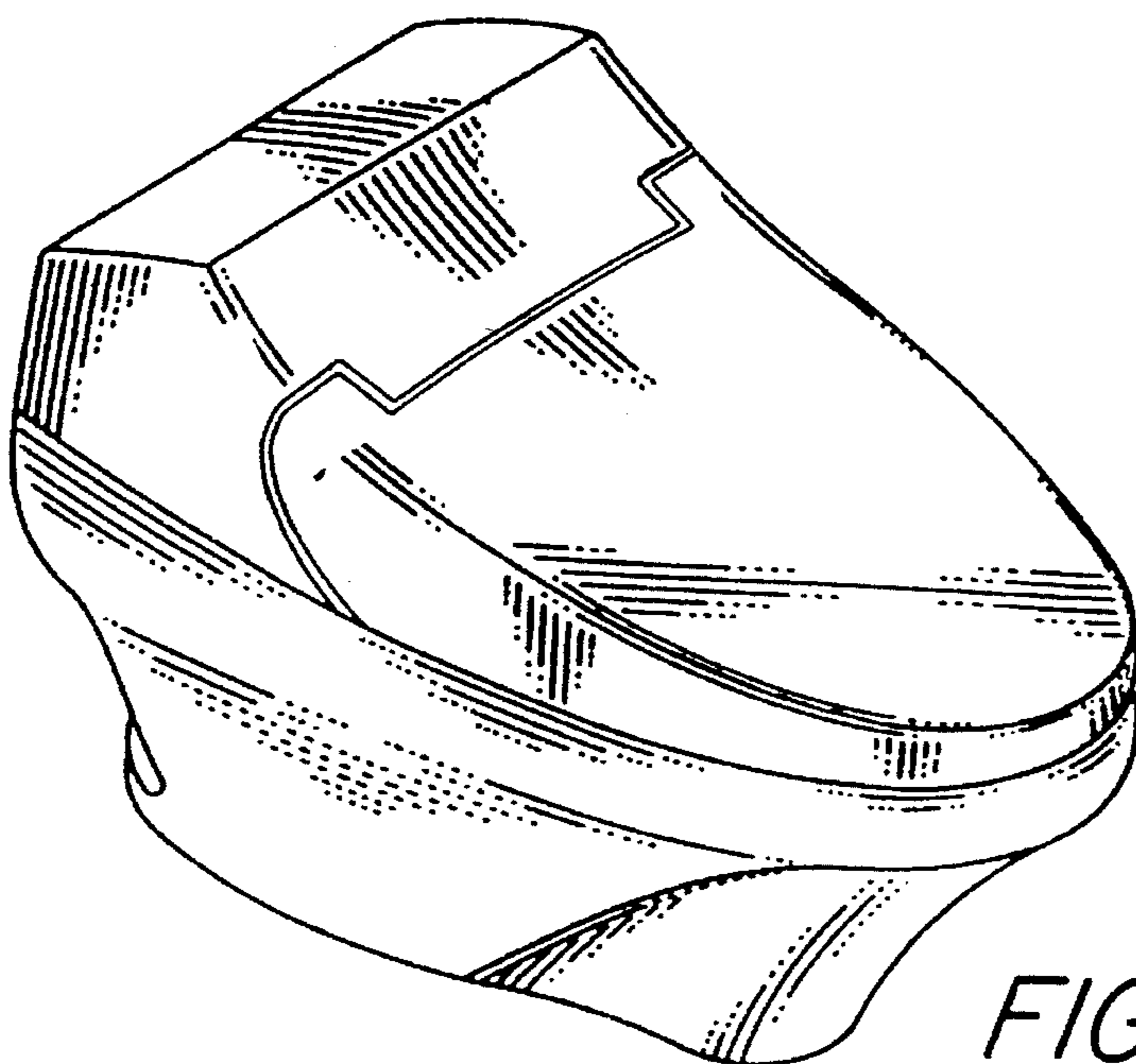

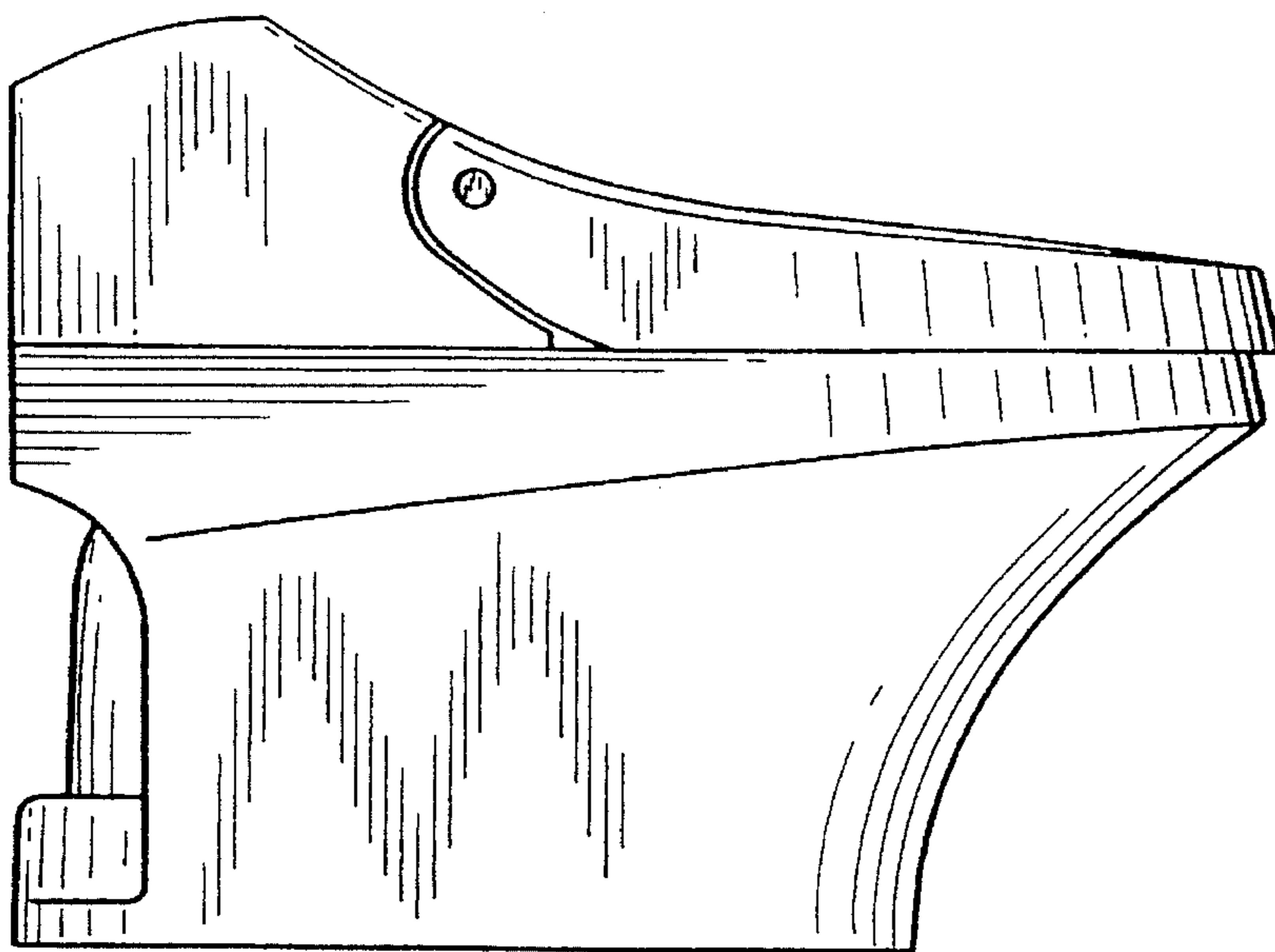

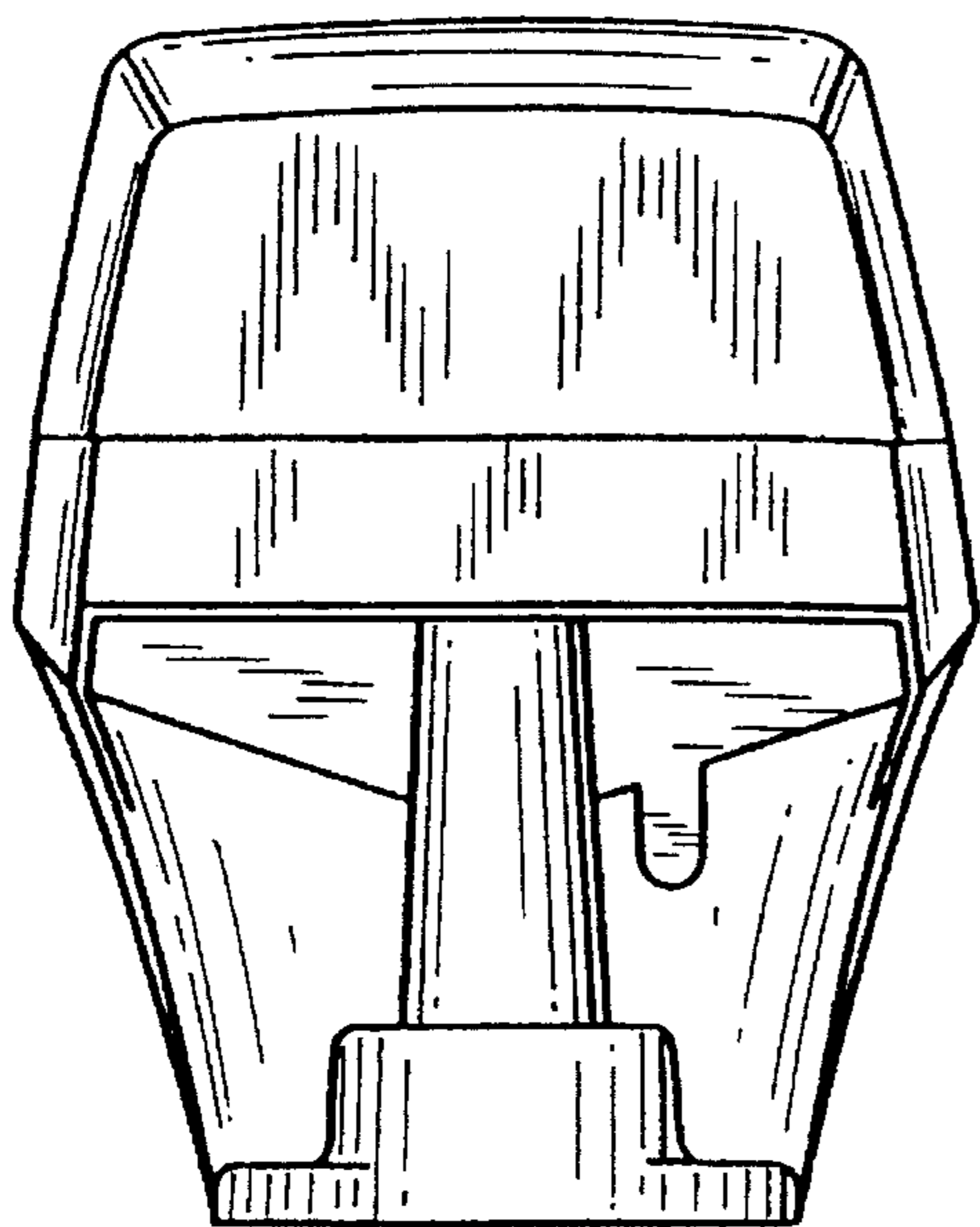

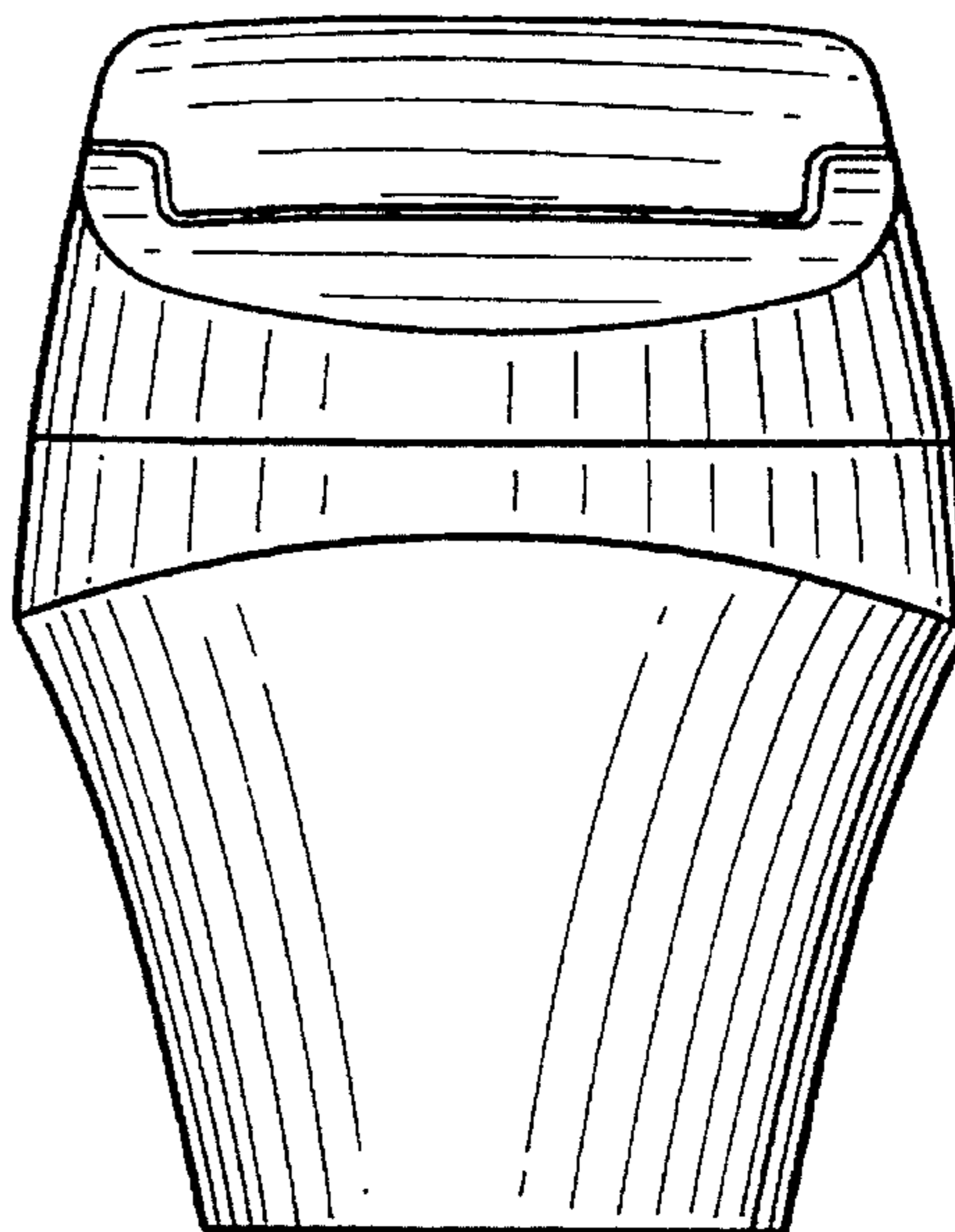

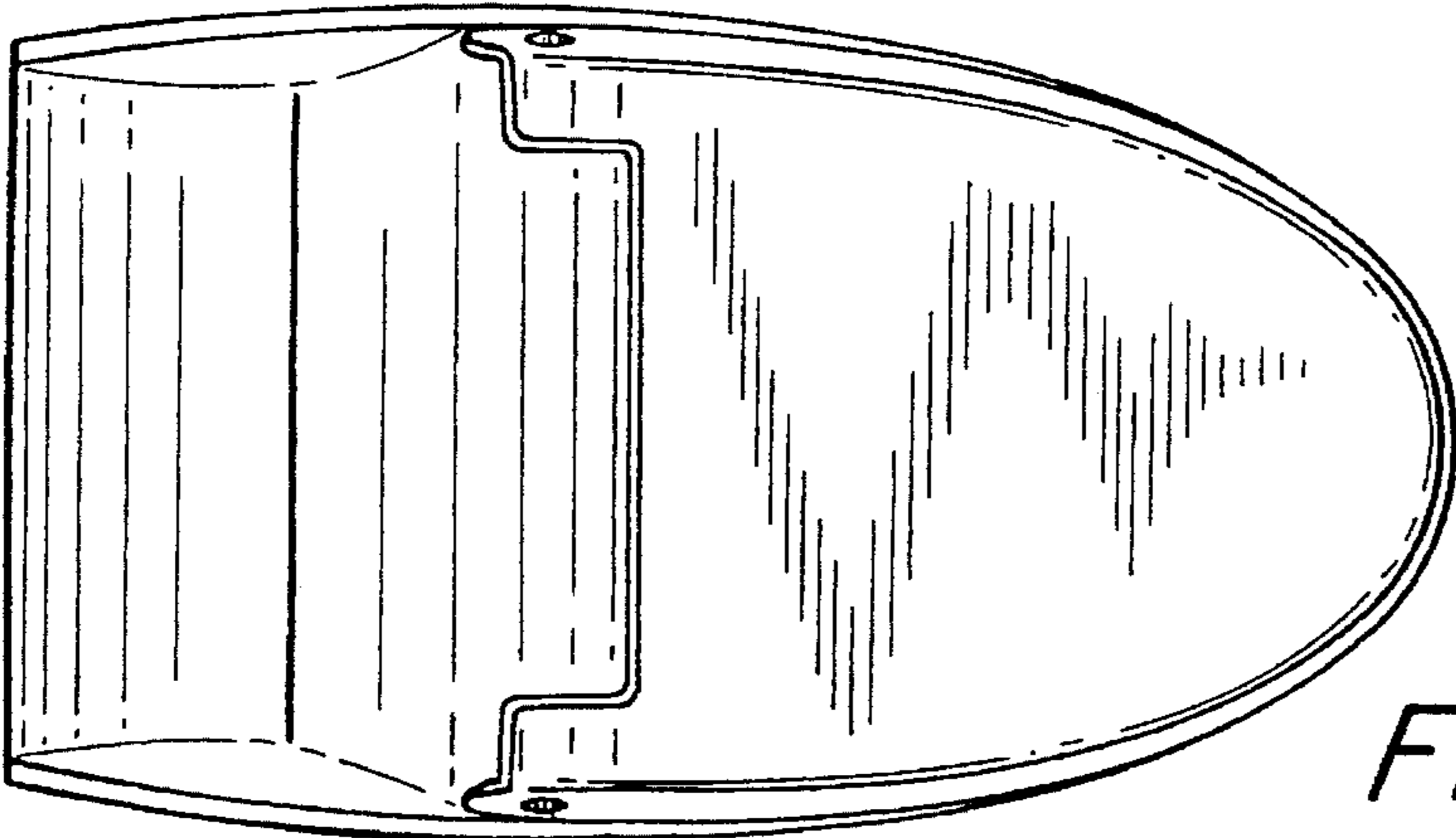

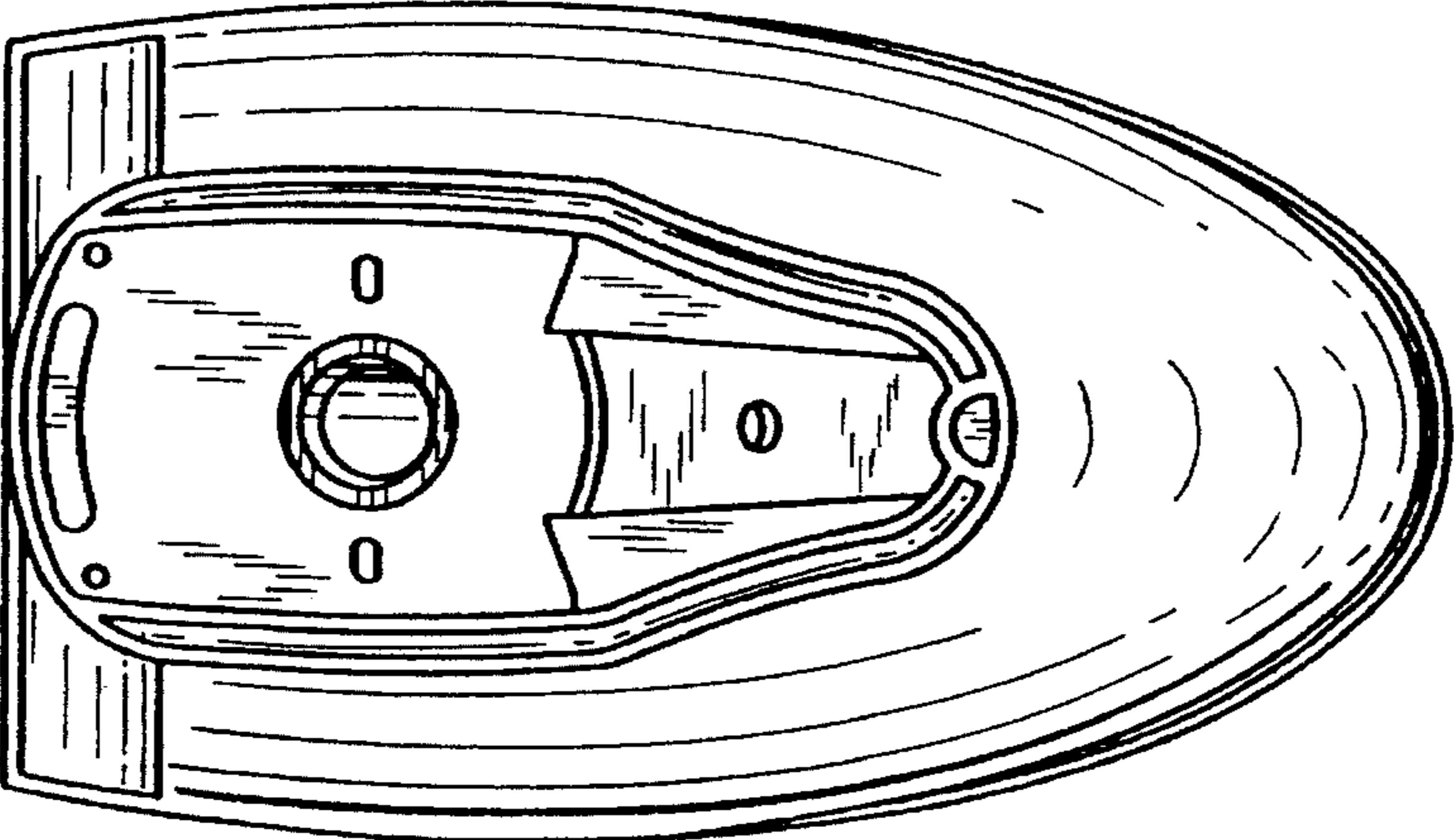

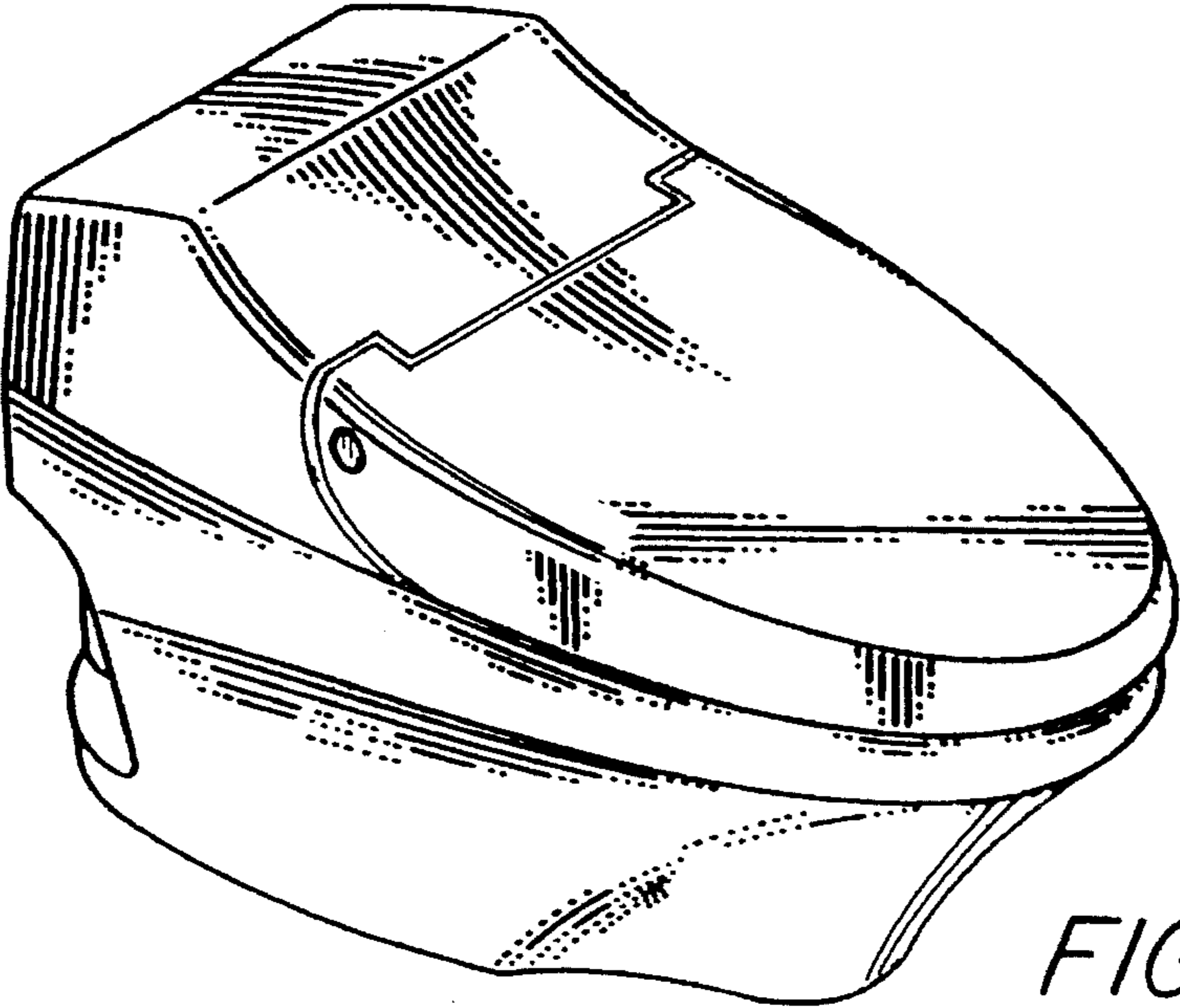
