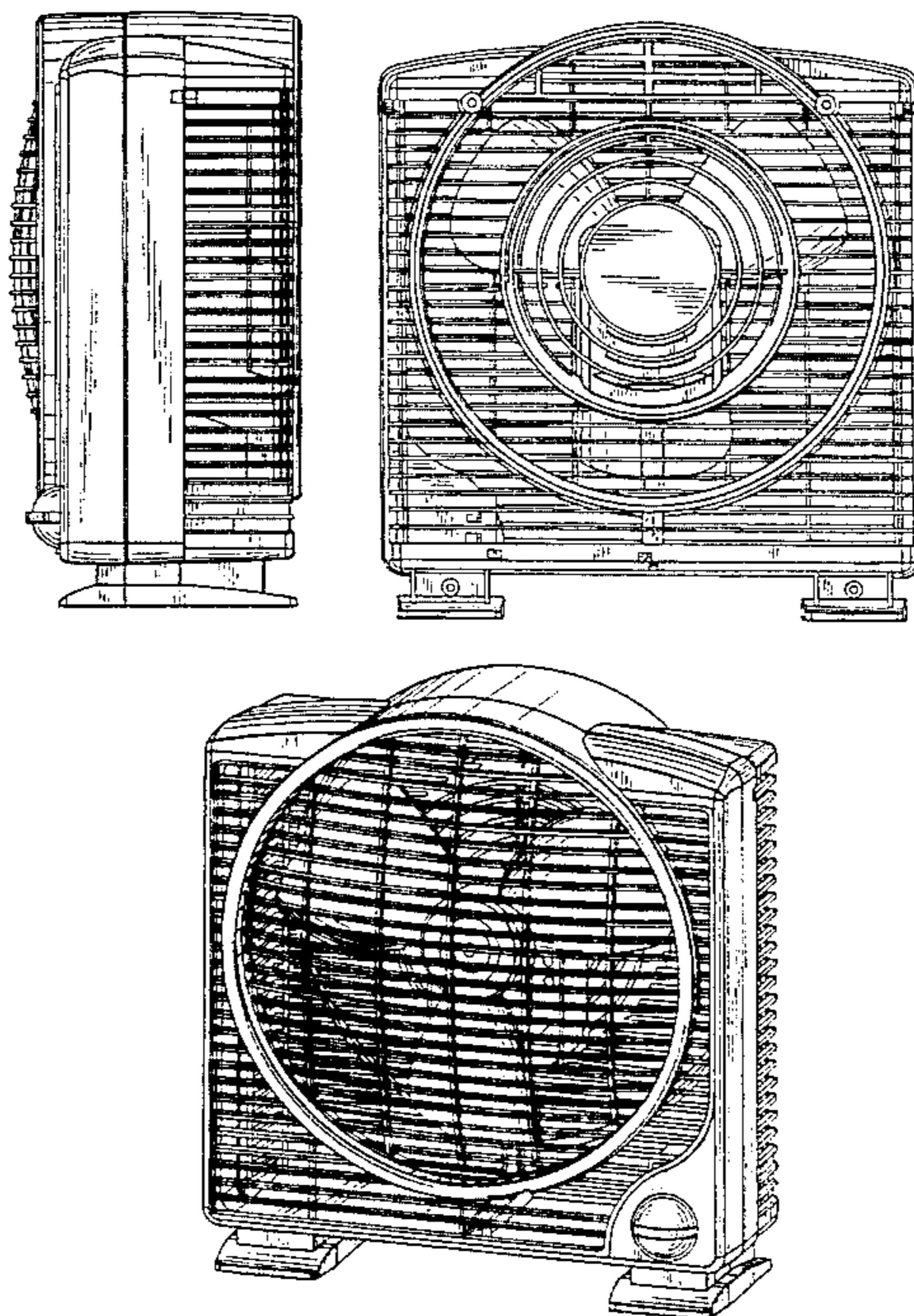
### [57] CLAIM

### DESCRIPTION

FIG. 1 is a front view of the design for a electric fan in accordance with the present invention;  
FIG. 2 is a side view thereof;  
FIG. 3 is a rear view thereof;

FIG. 5 is a bottom view thereof, the opposite side being substantially identical to that shown except for the bottom control switch panel; and,

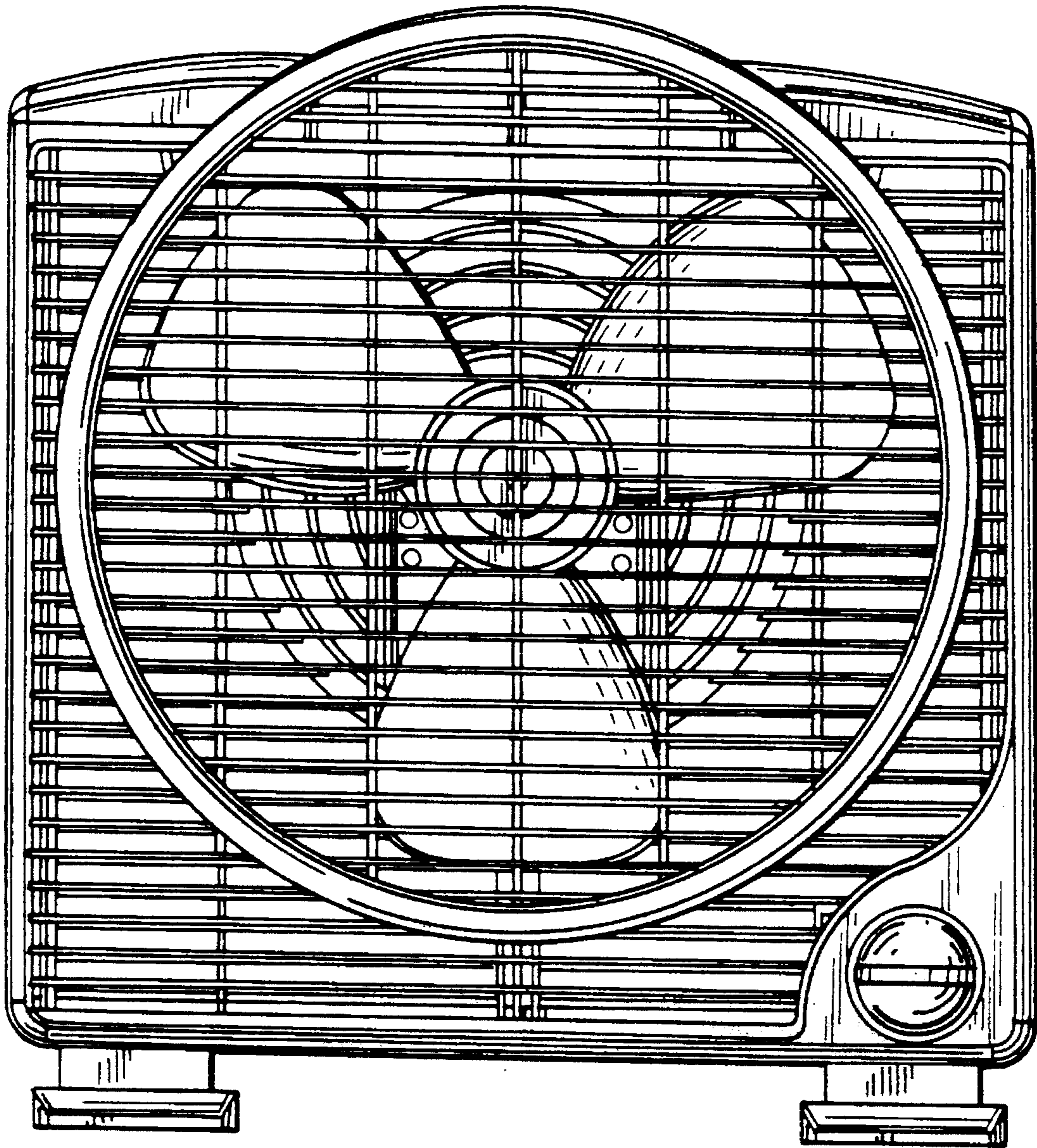

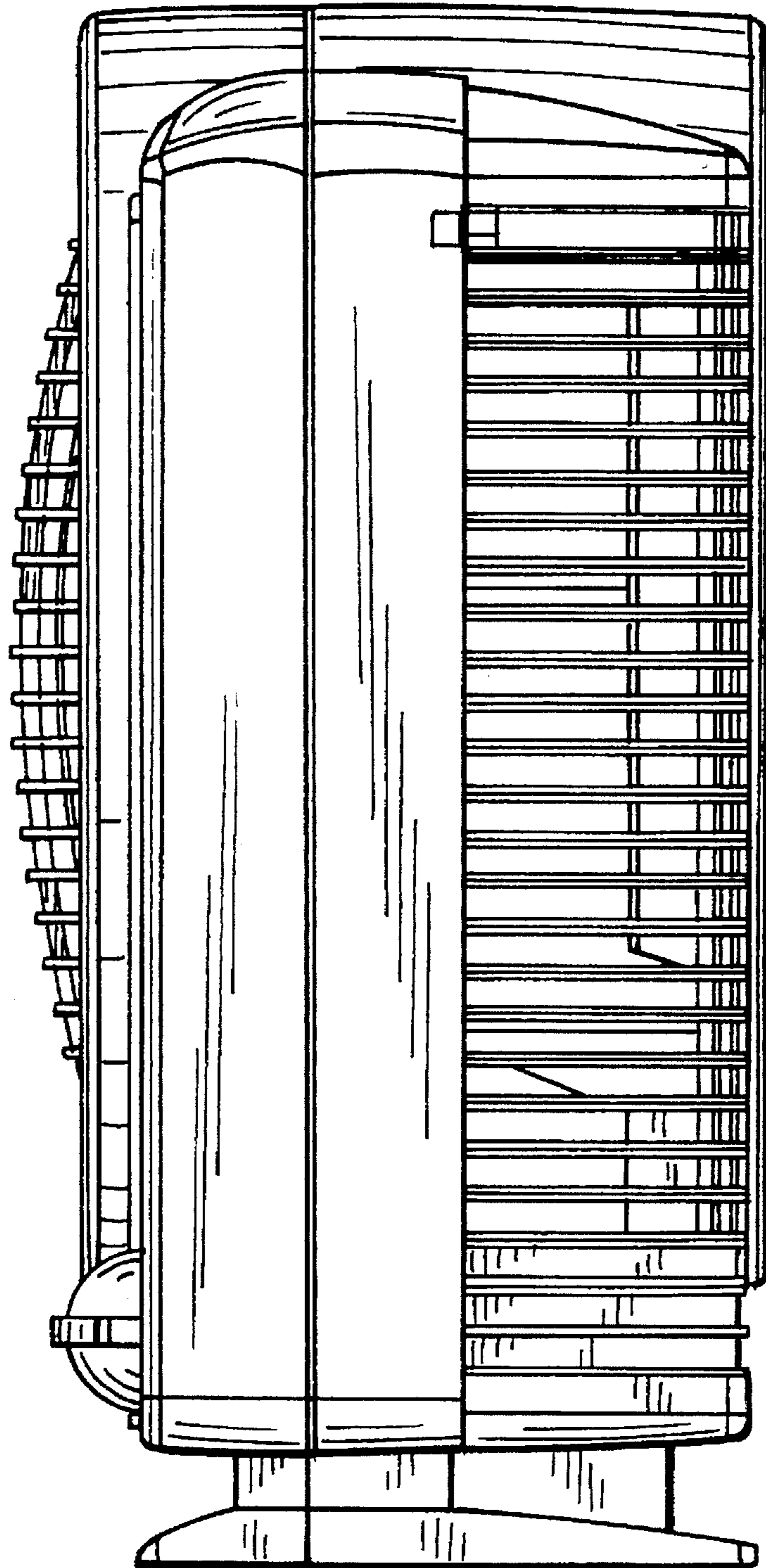

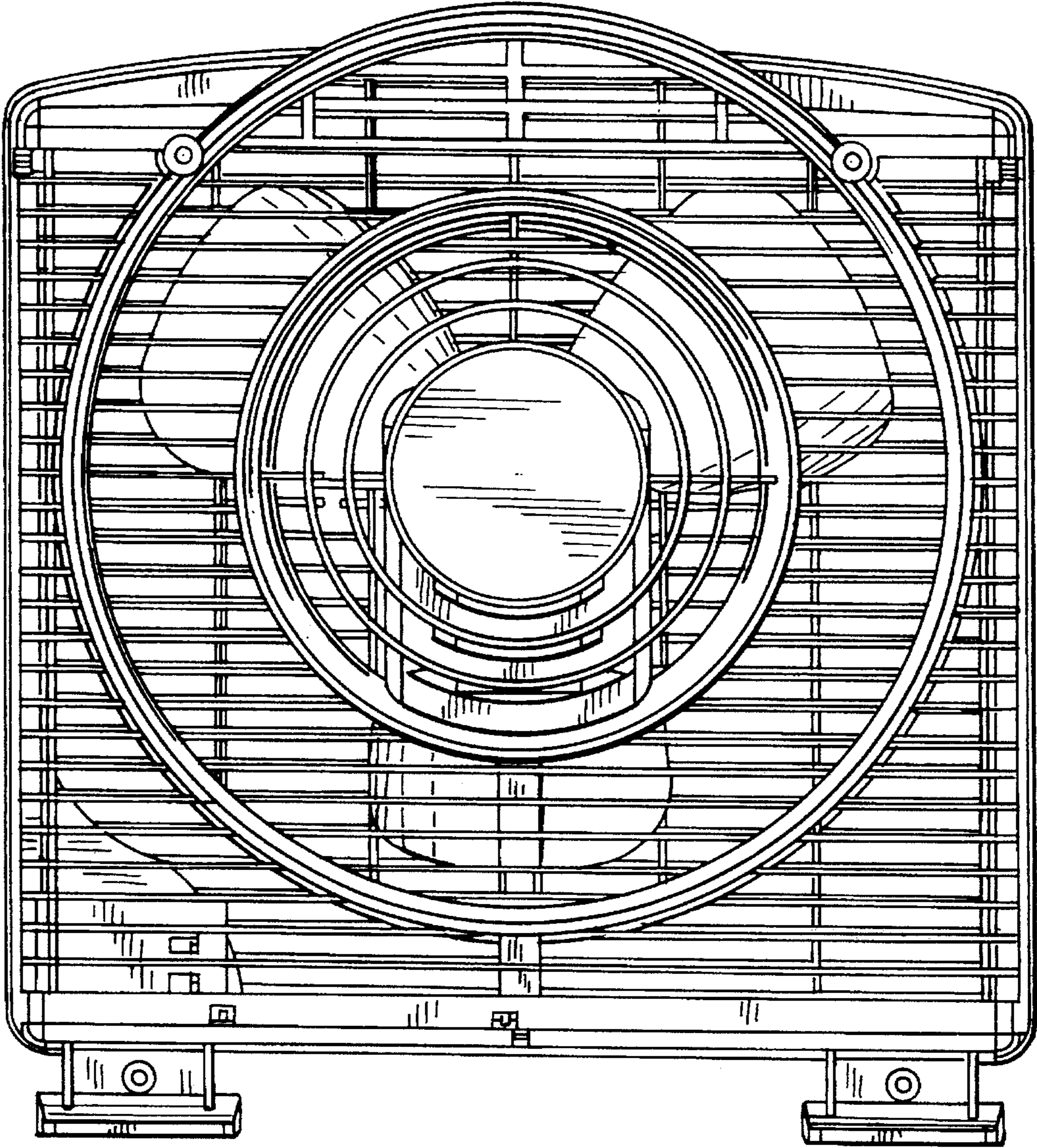

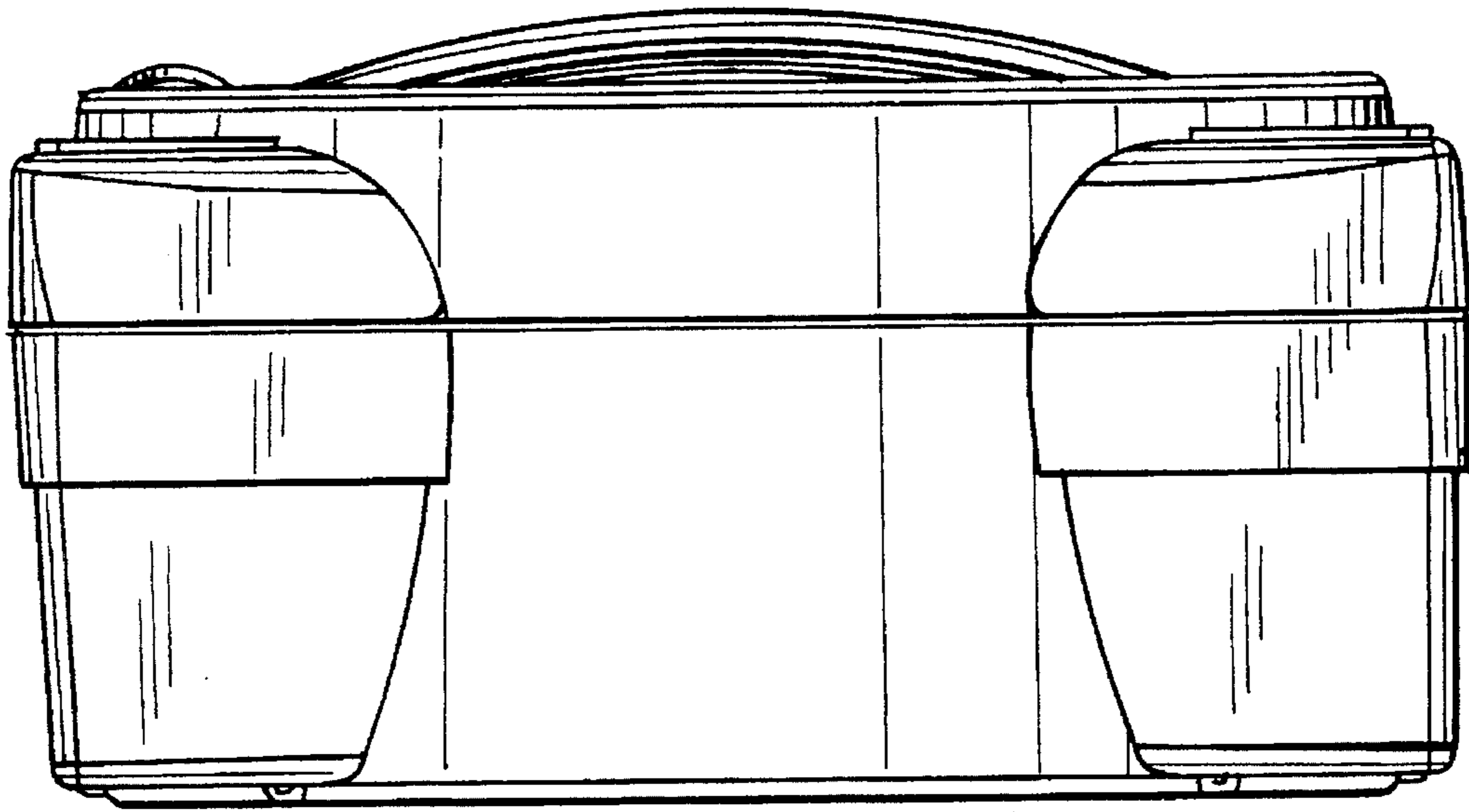

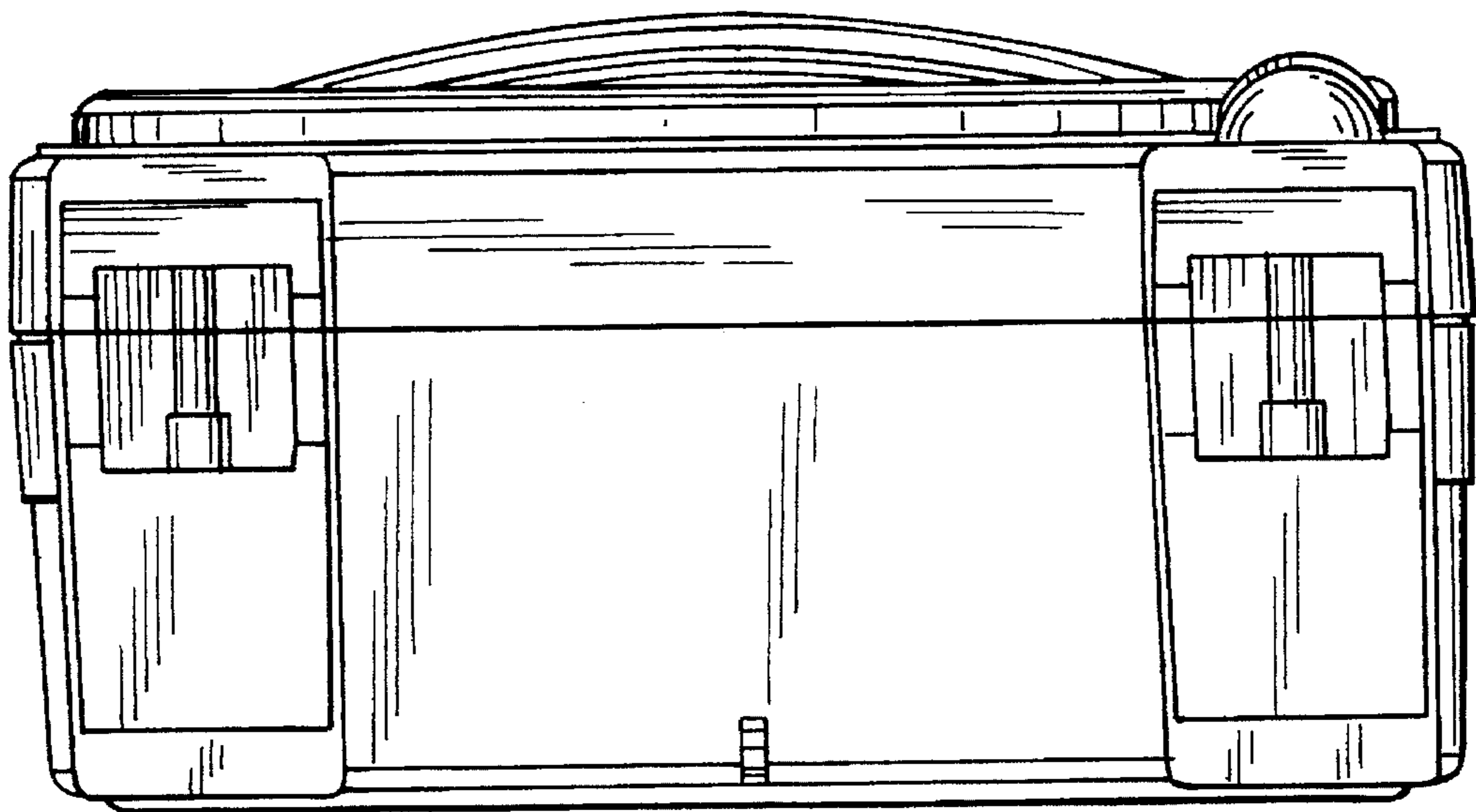

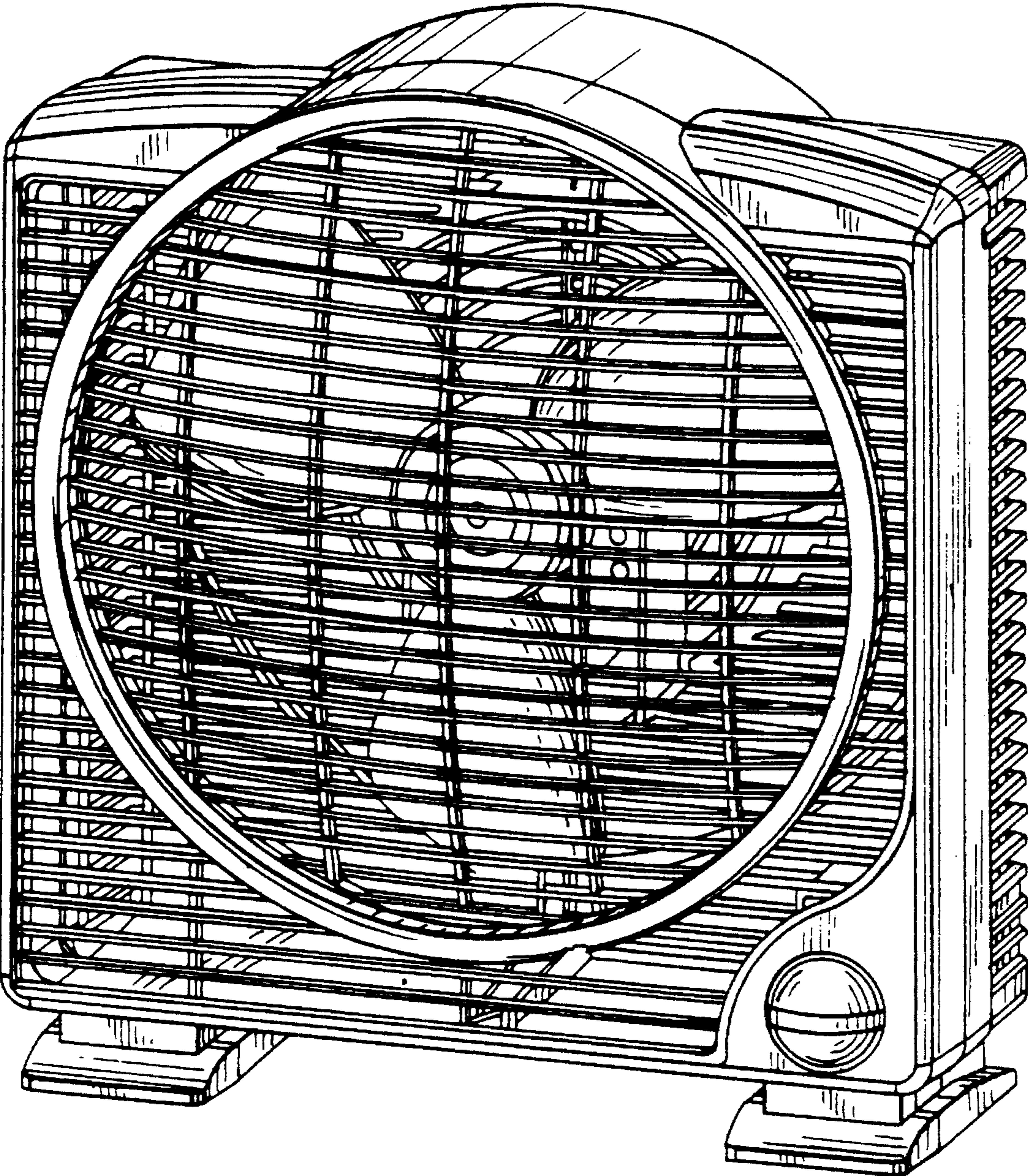
