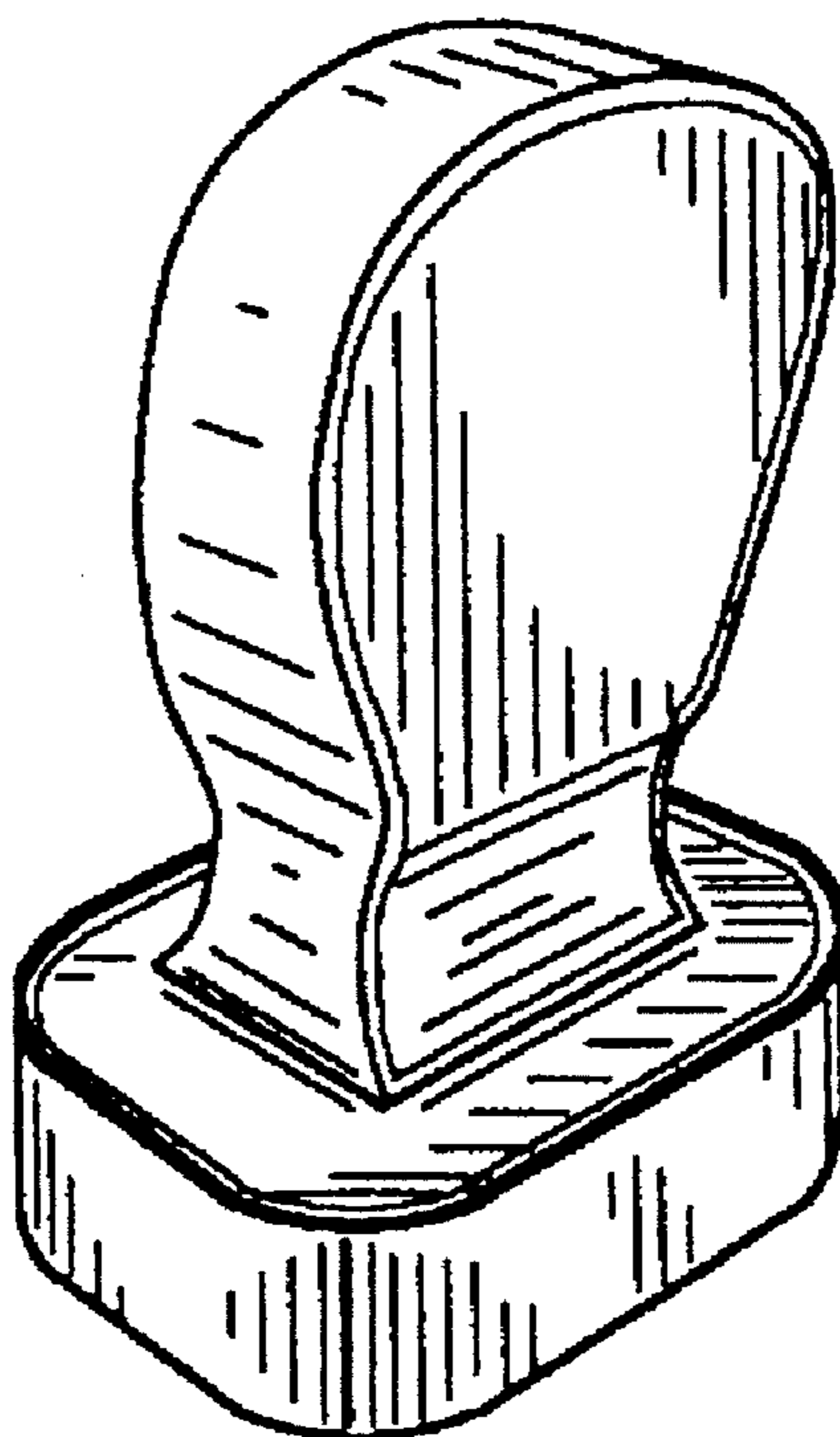
[57] **CLAIM**

The ornamental design for a skin dermabrader, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a skin dermabrader showing my new design;  
FIG. 2 is a top plan view thereof.  
FIG. 3 is a front elevational view thereof.  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a rear elevational view thereof;

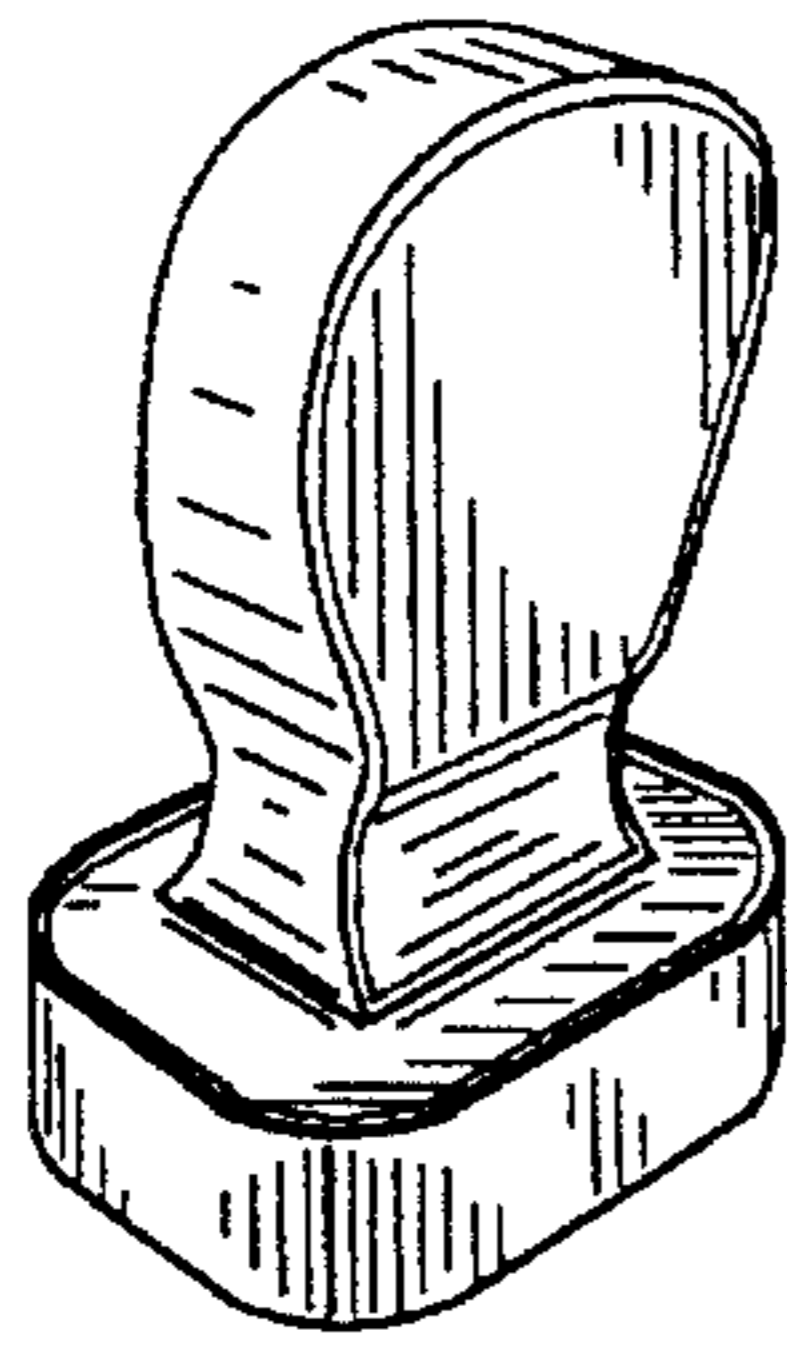

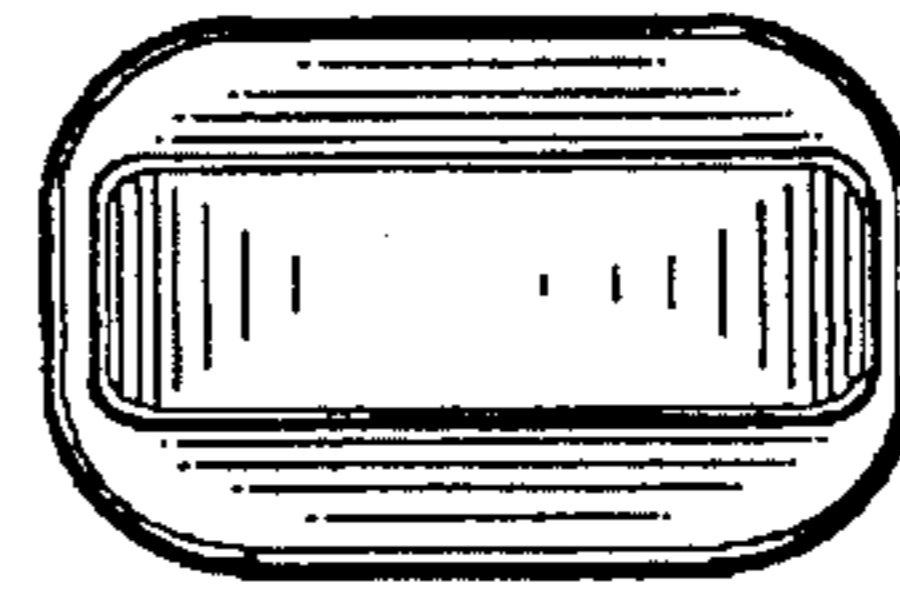

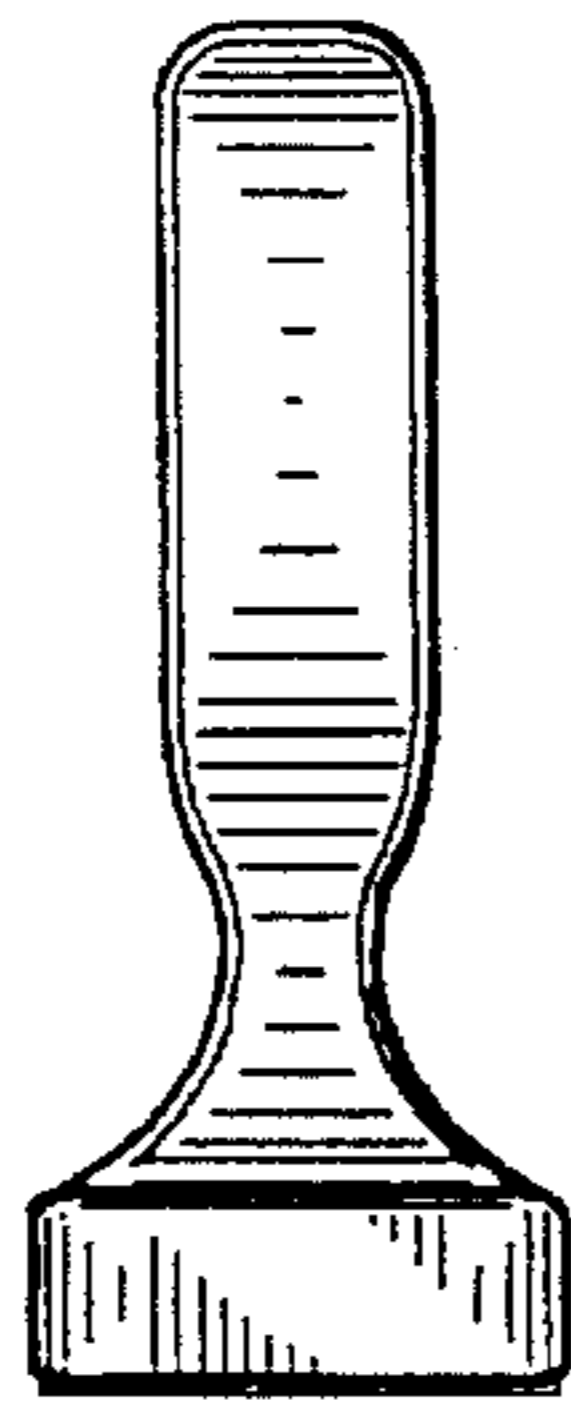

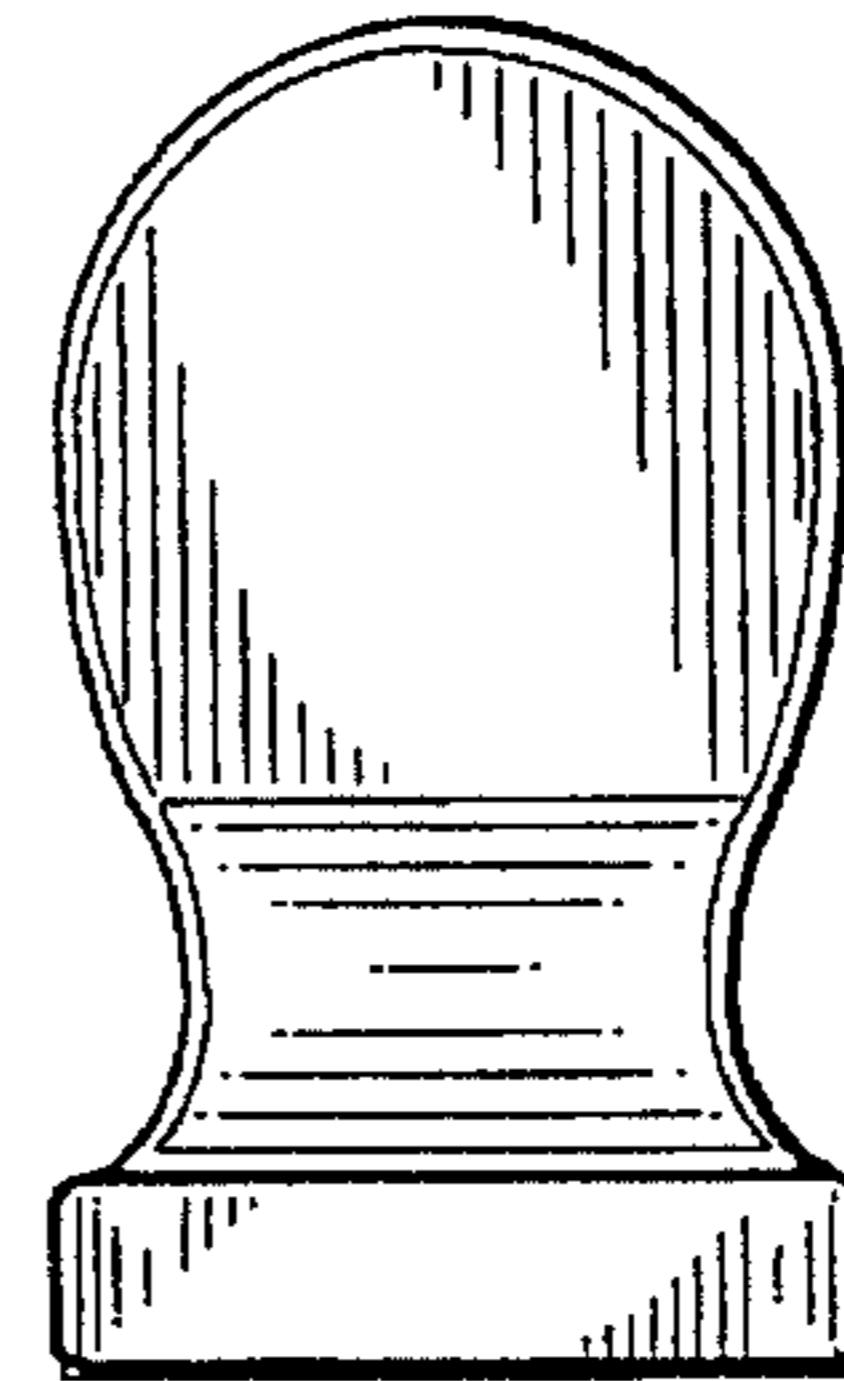

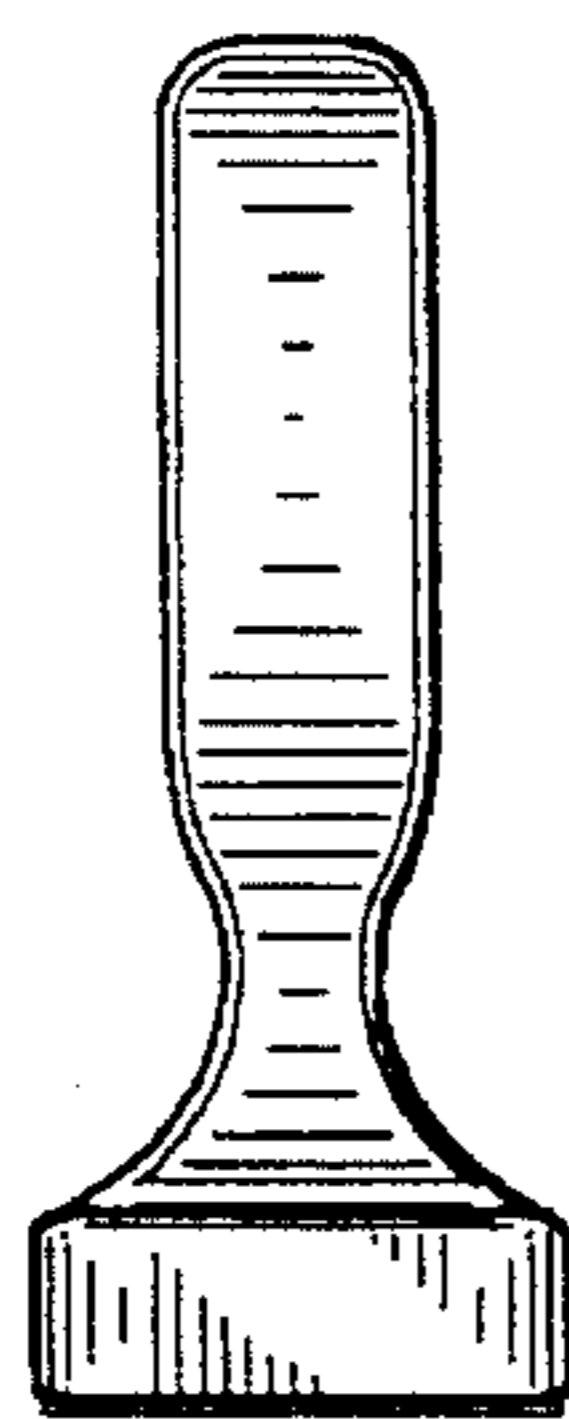

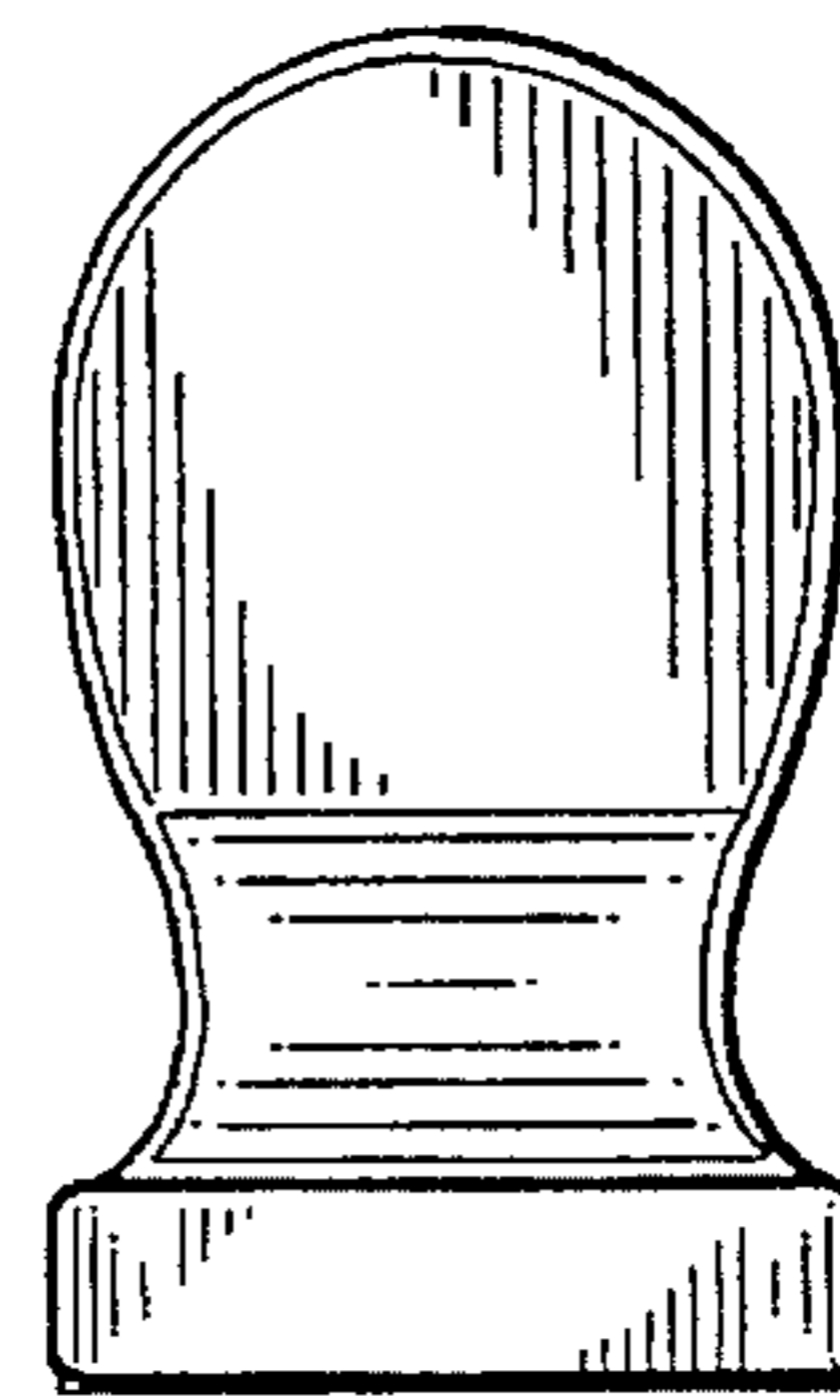

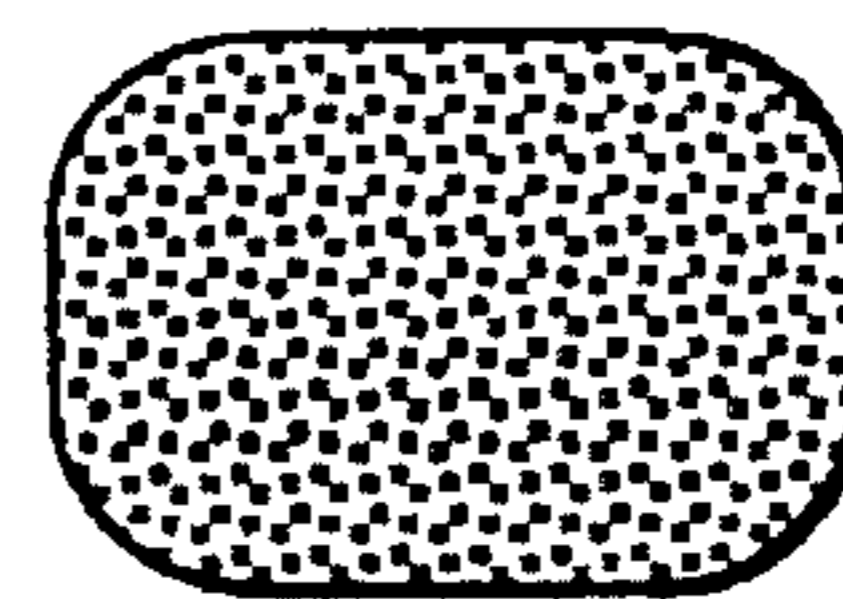
