FIG. 2 is a side elevational view thereof, the opposite side being a mirror image thereof;

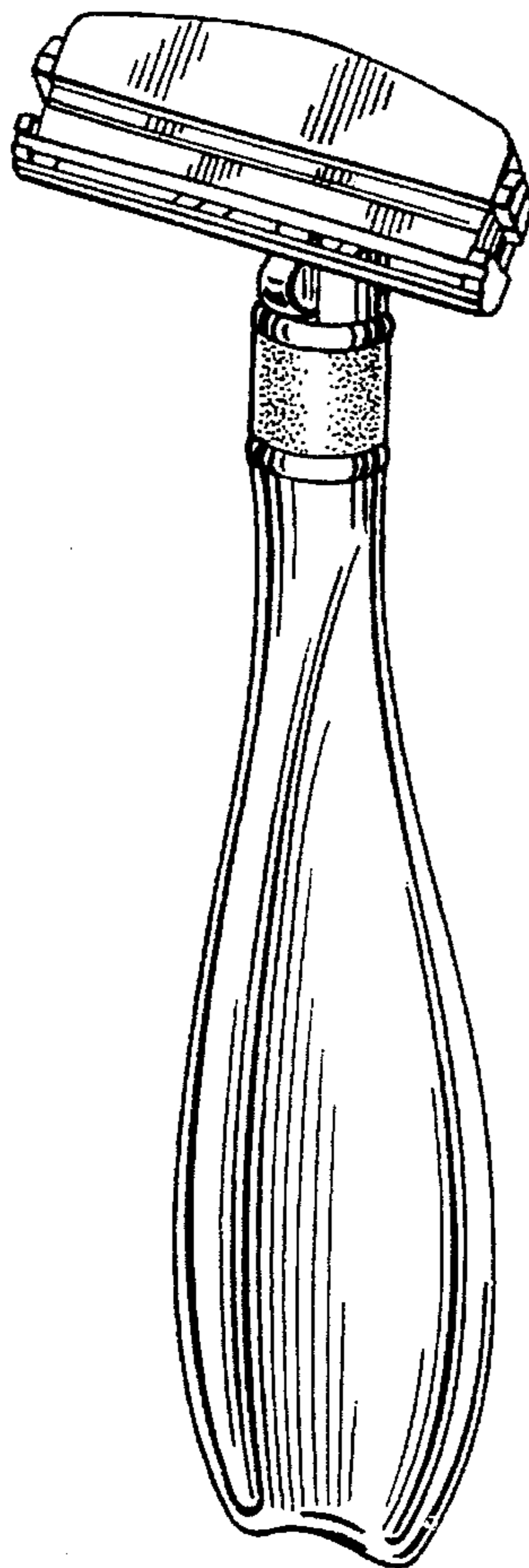
FIG. 3 is a top plan view thereof;

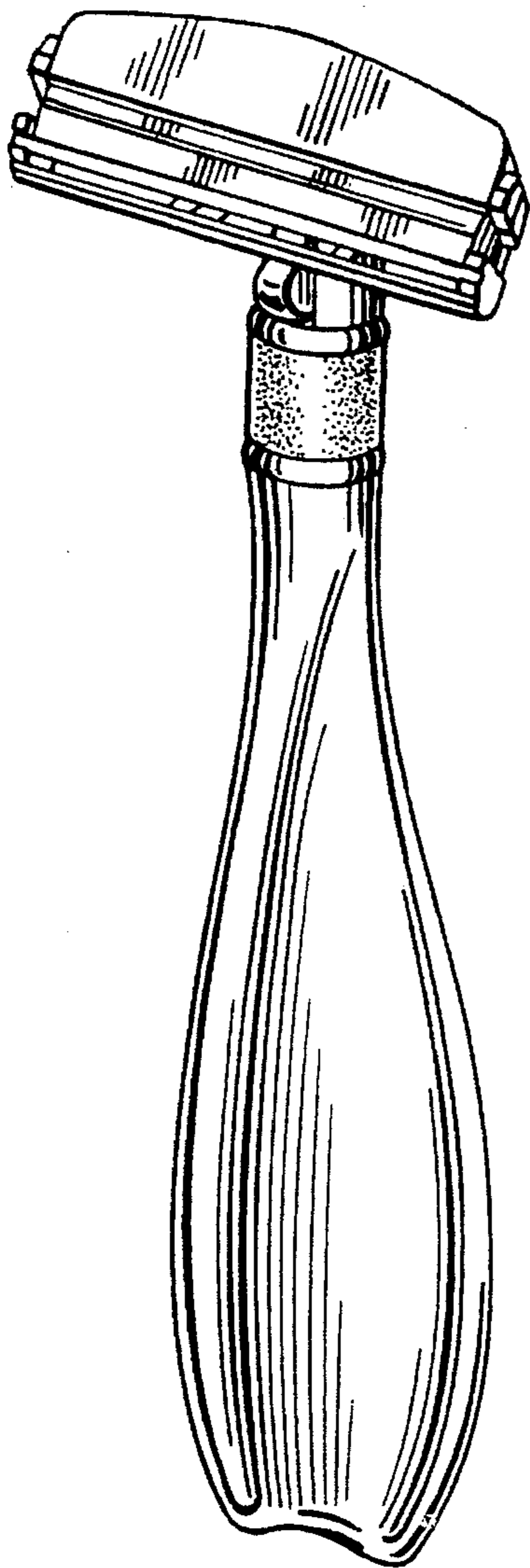

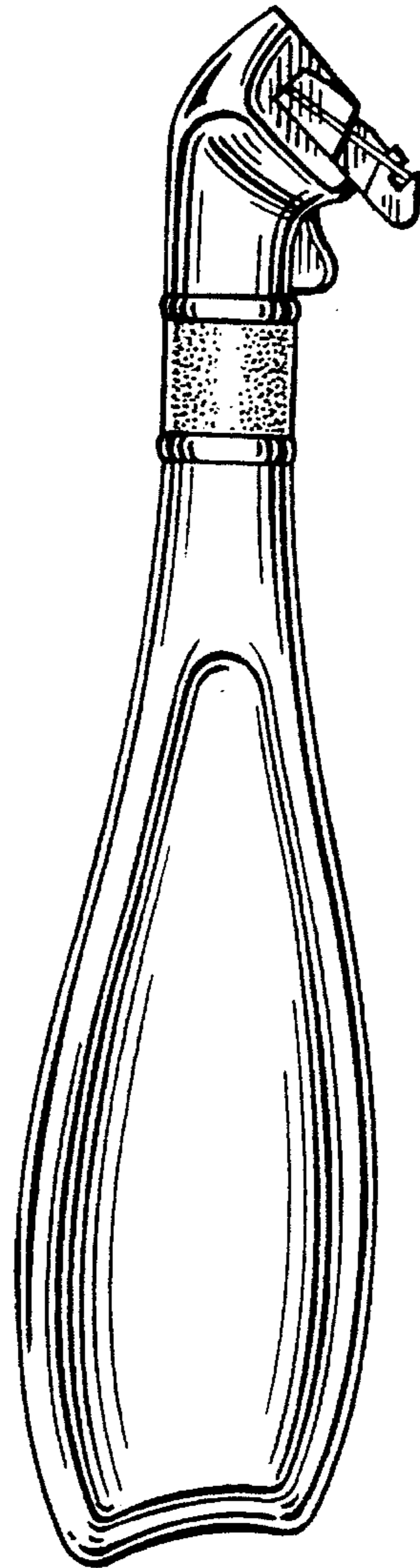

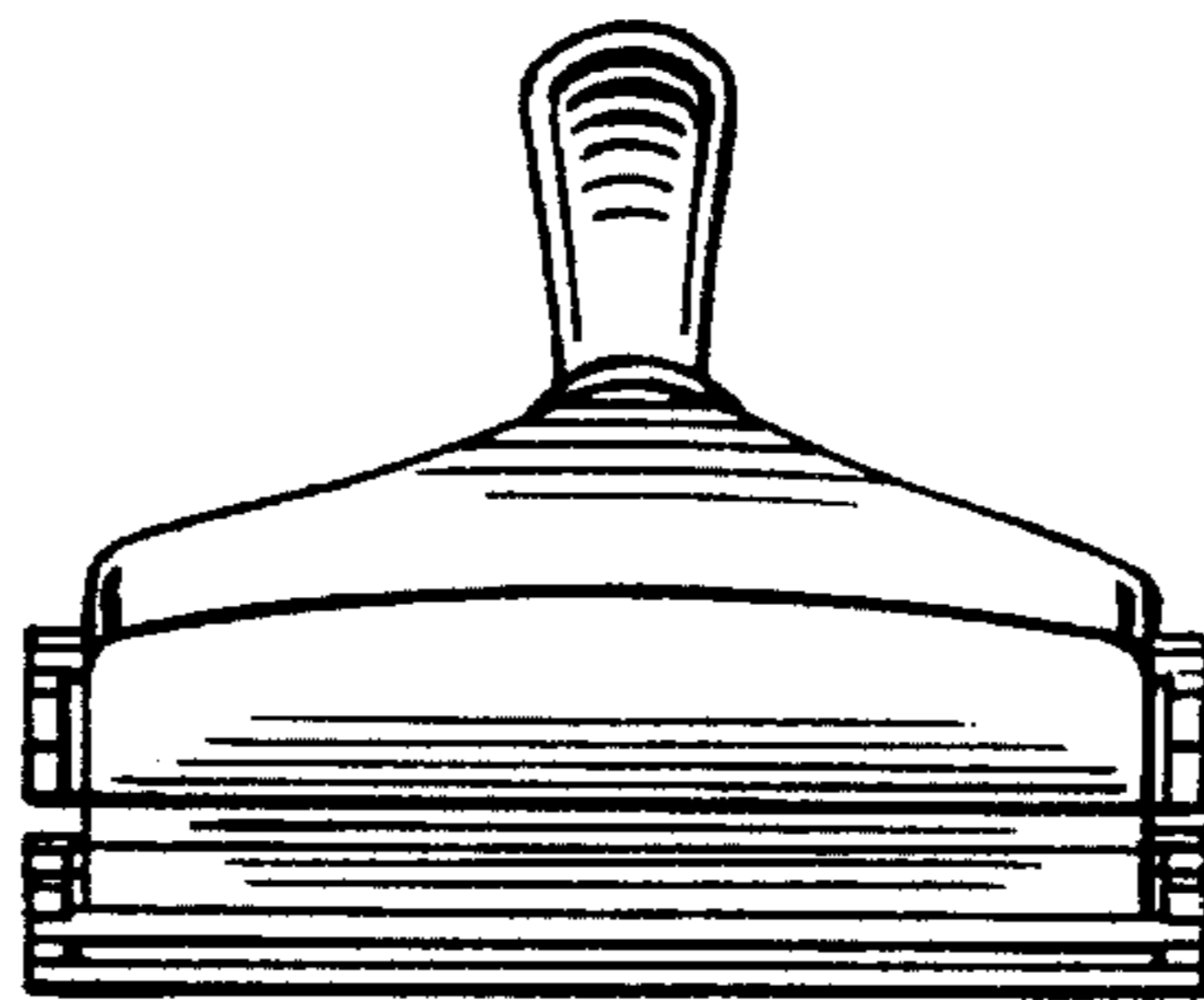

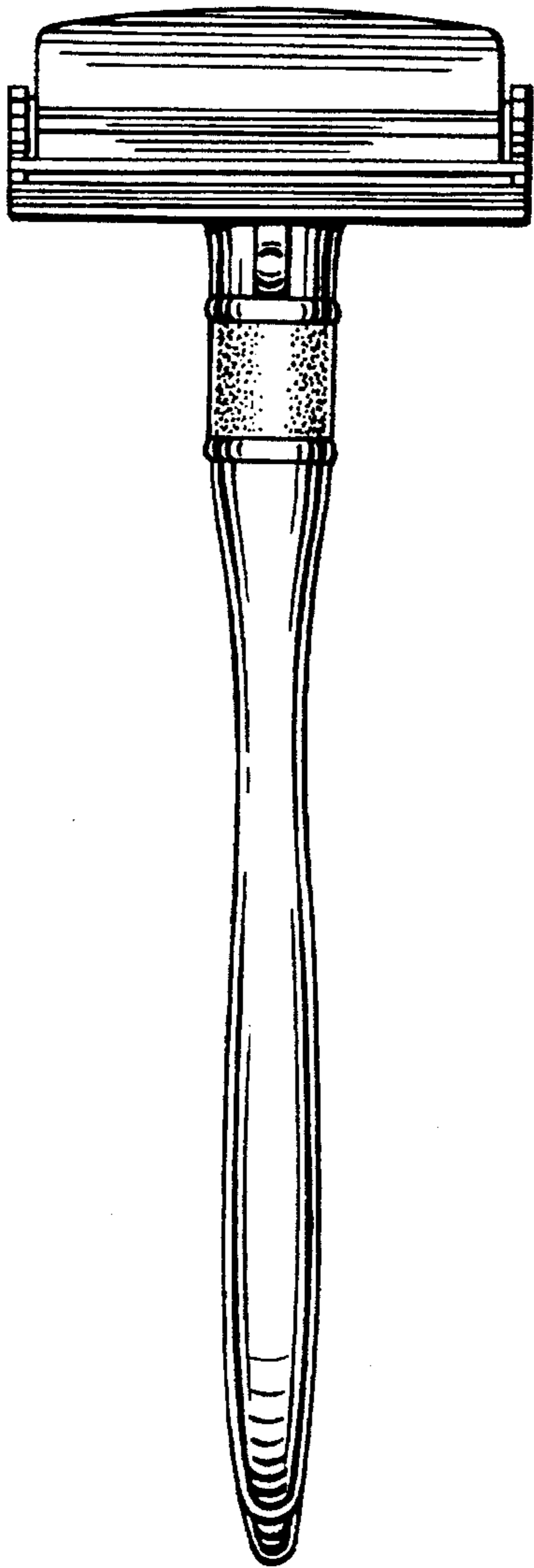

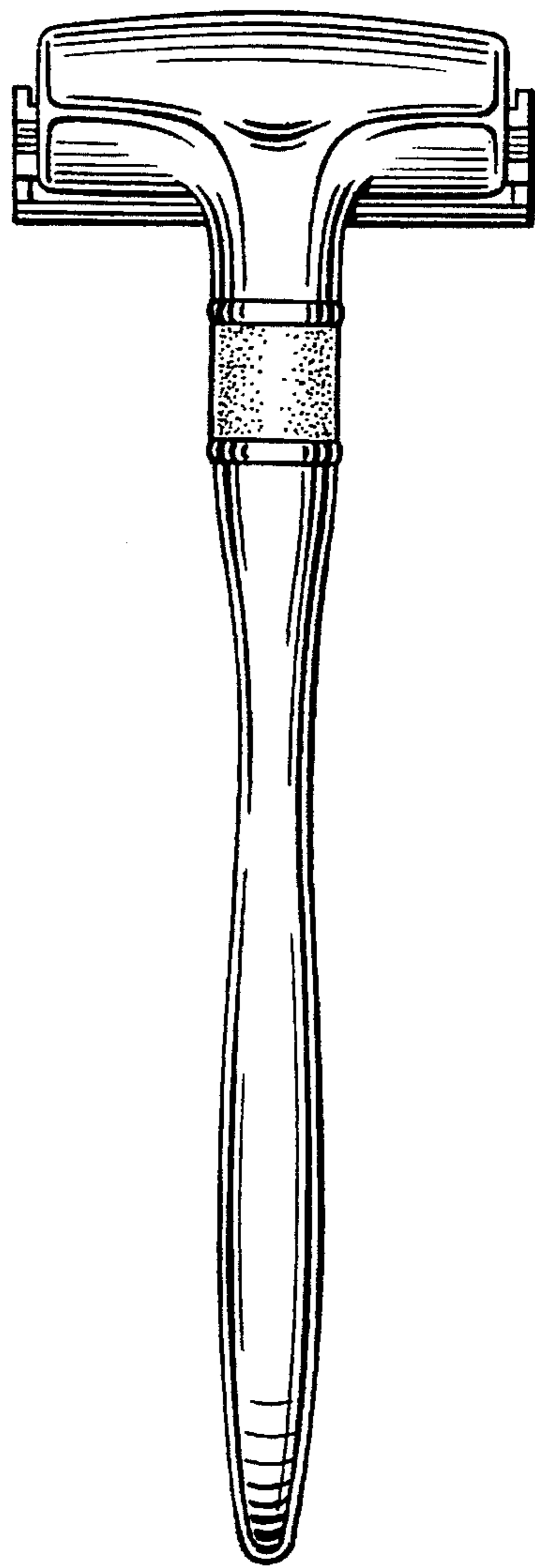

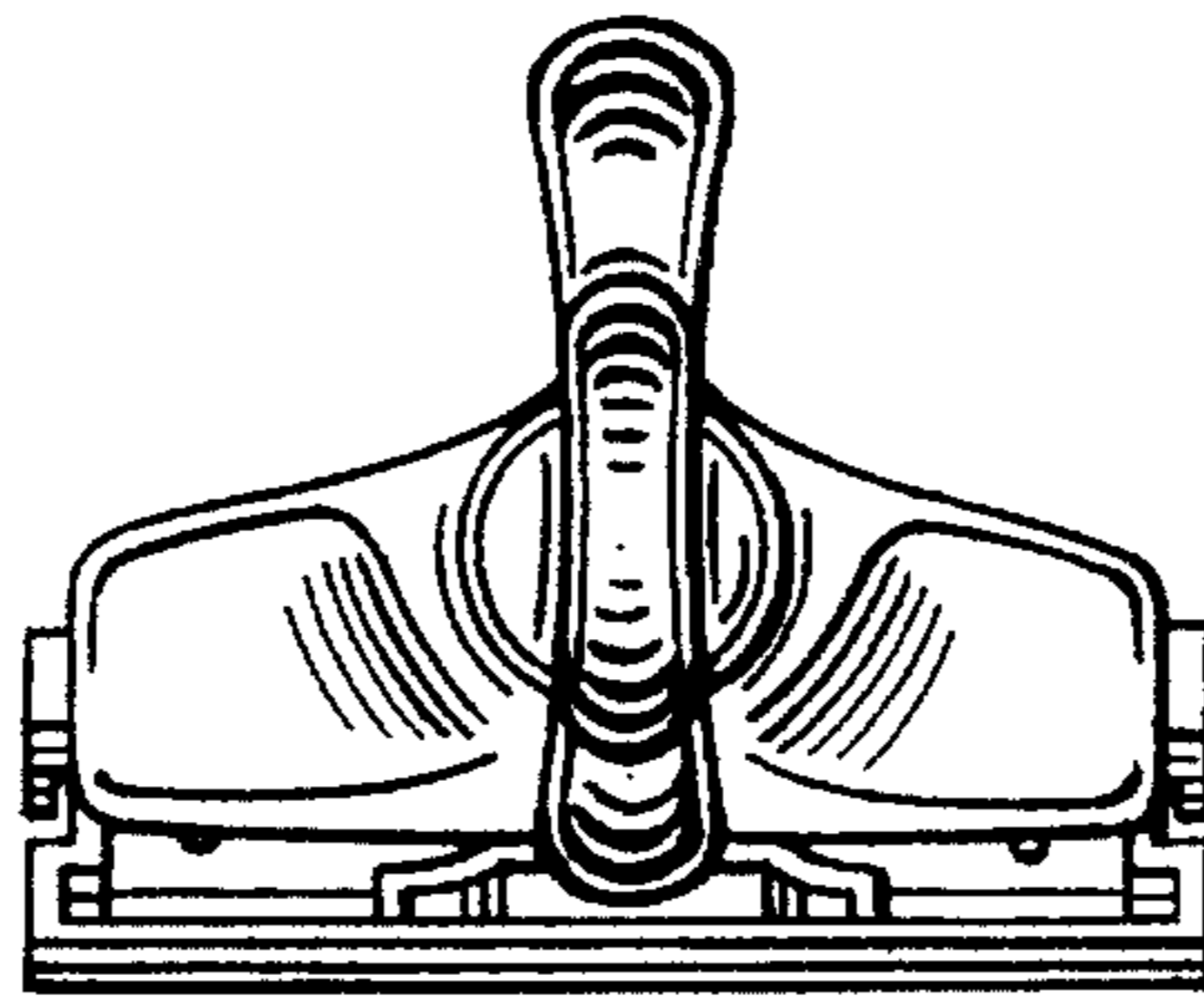
