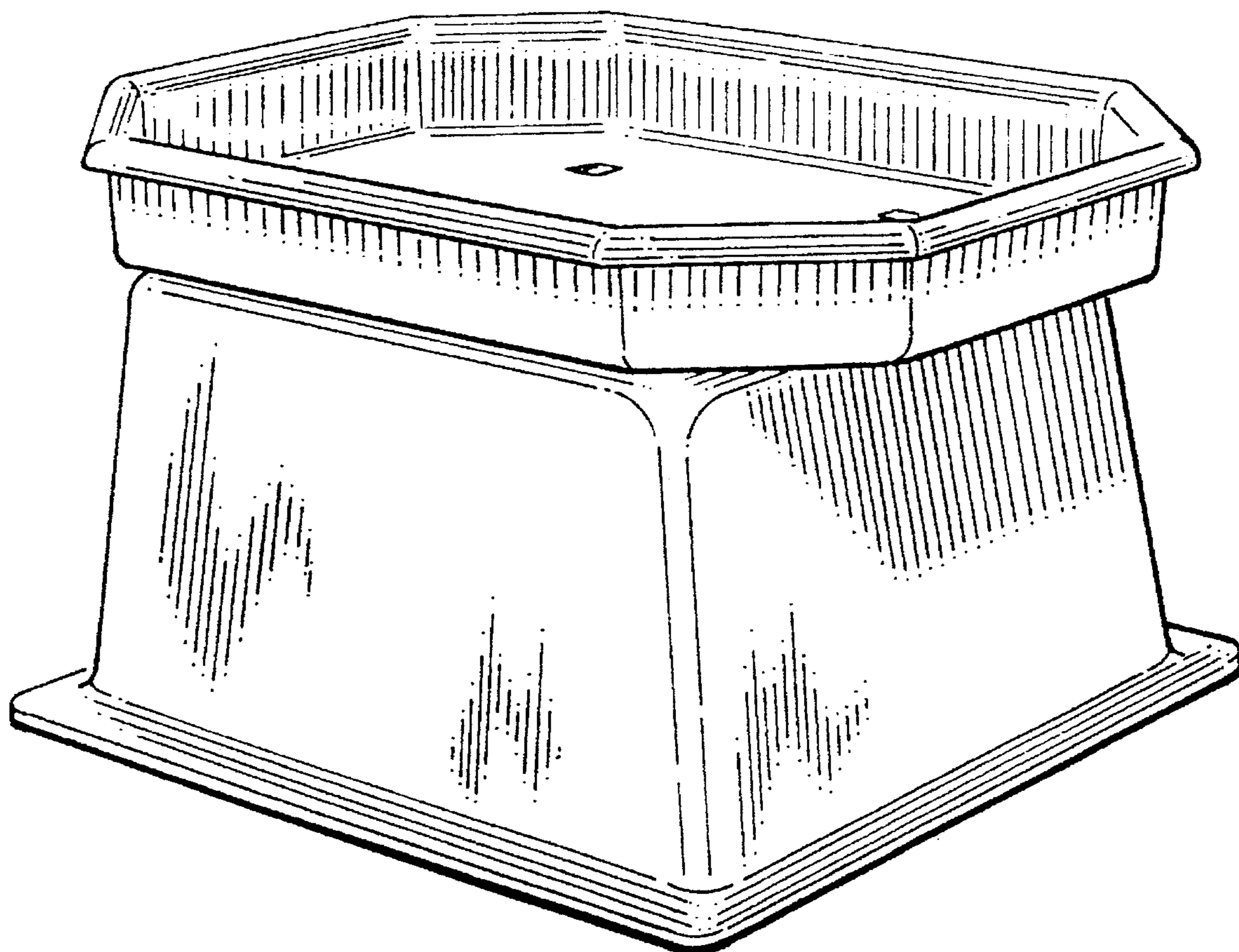
[57] CLAIM

The ornamental design for a pet furniture for sleeping, grooming or bathing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet furniture for sleeping, grooming or bathing showing my new design;
 FIG. 2 is a left side elevational view thereof, the rear being identical;
 FIG. 3 is a front elevational view thereof, the rear being identical;
 FIG. 4 is a bottom plan view of the base portion;
 FIG. 5 is a top plan view of the bed portion;
 FIG. 6 is a bottom plan view of FIG. 1; and,
 FIG. 7 is a top plan view of FIG. 1.

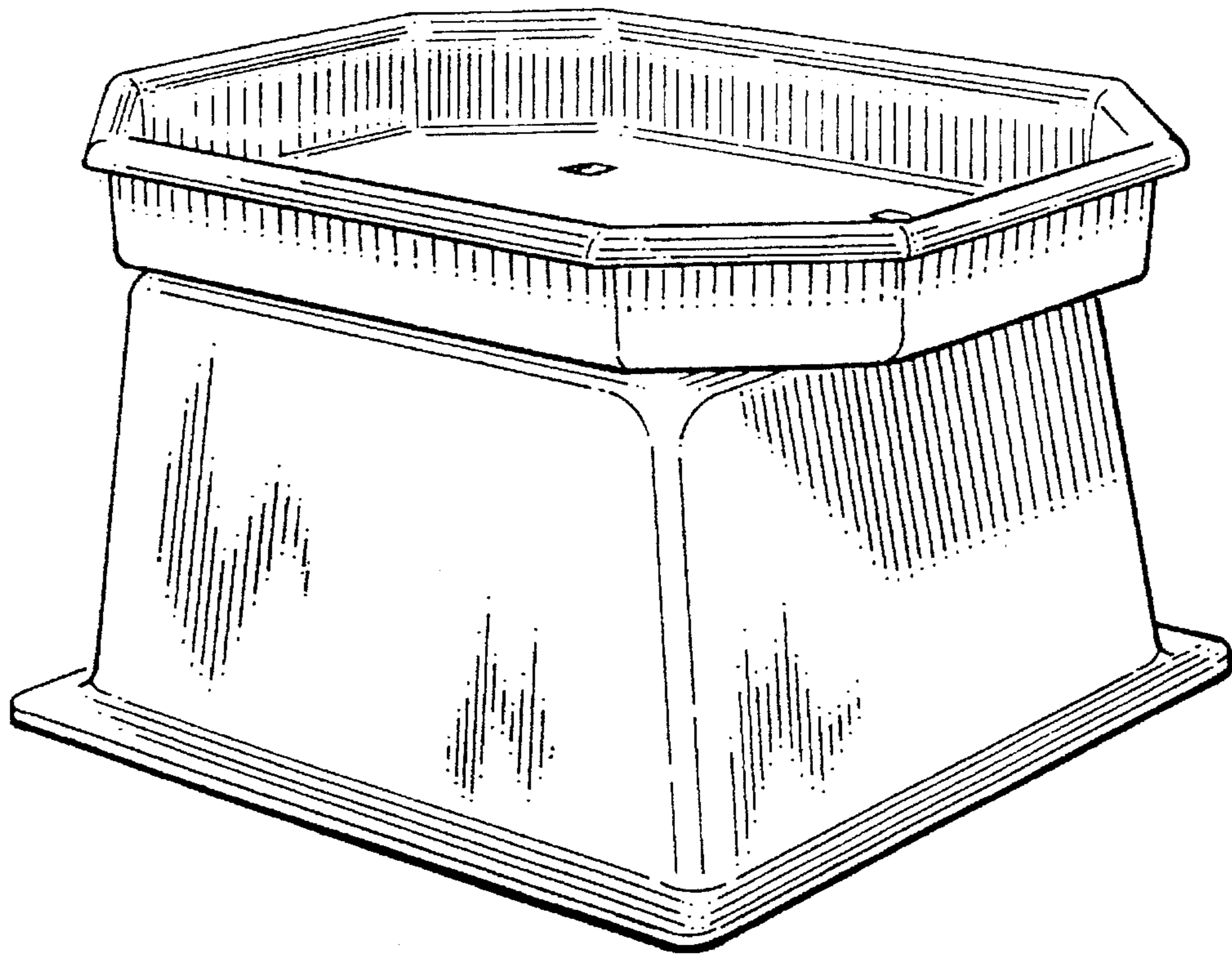

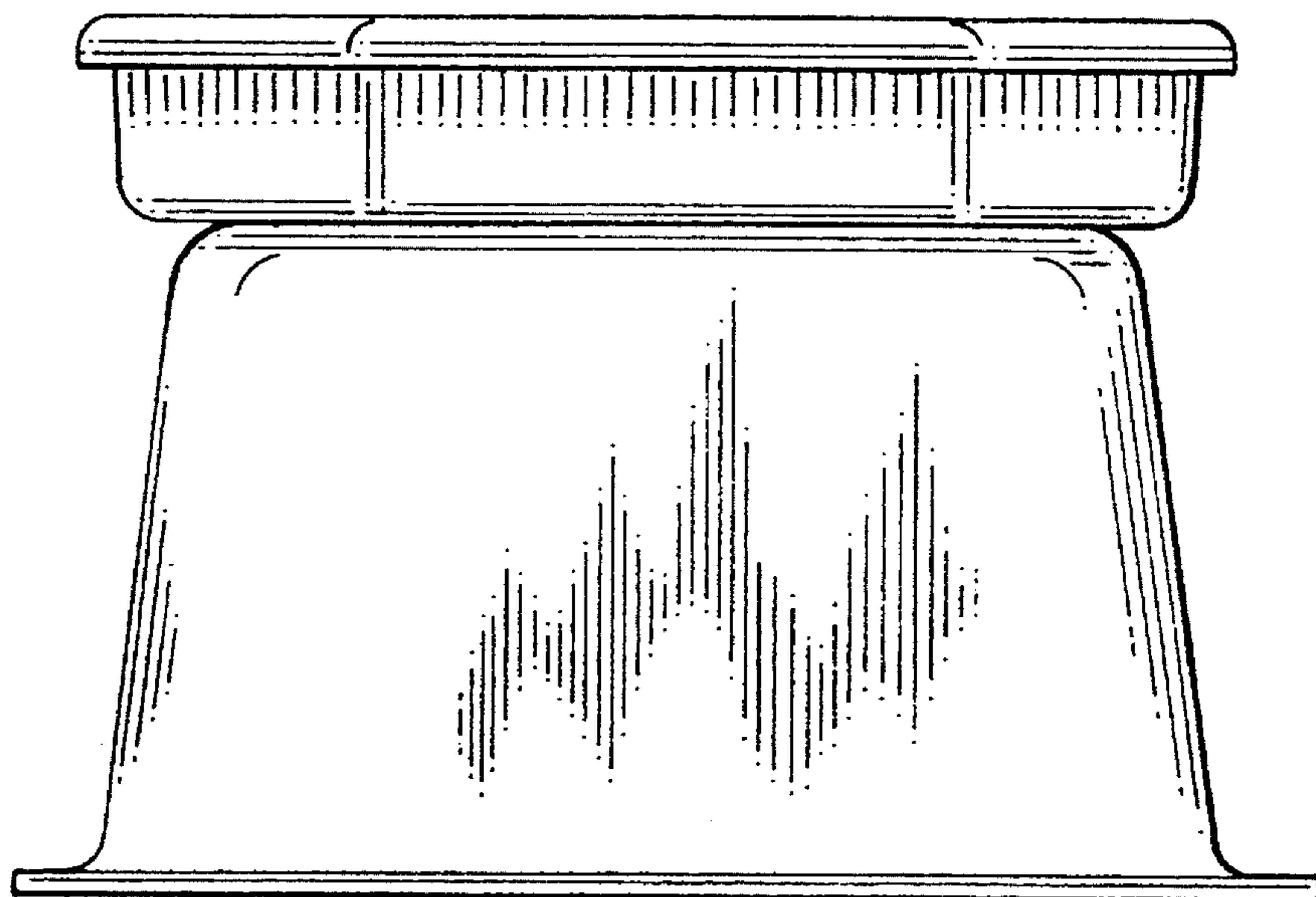

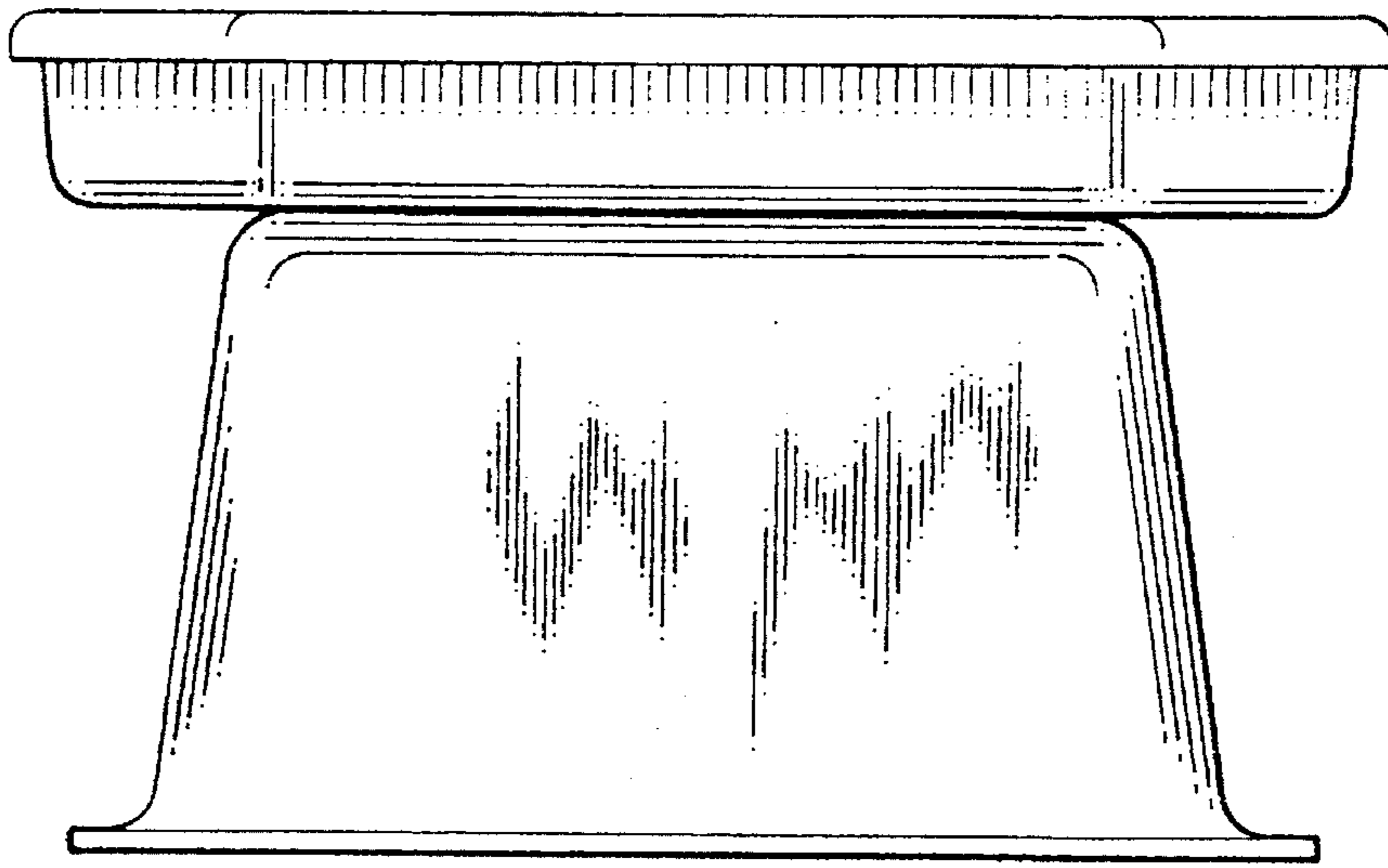

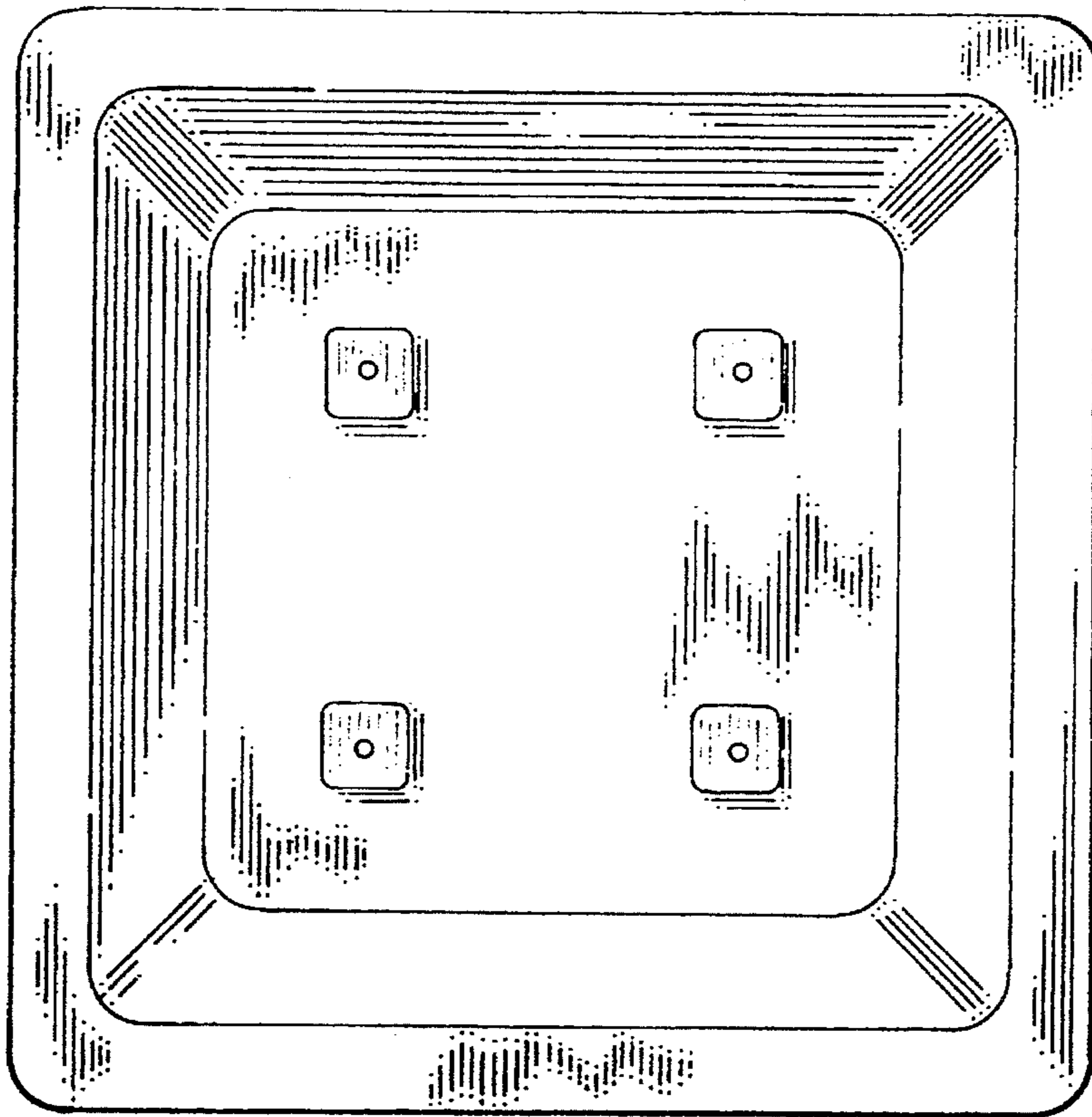

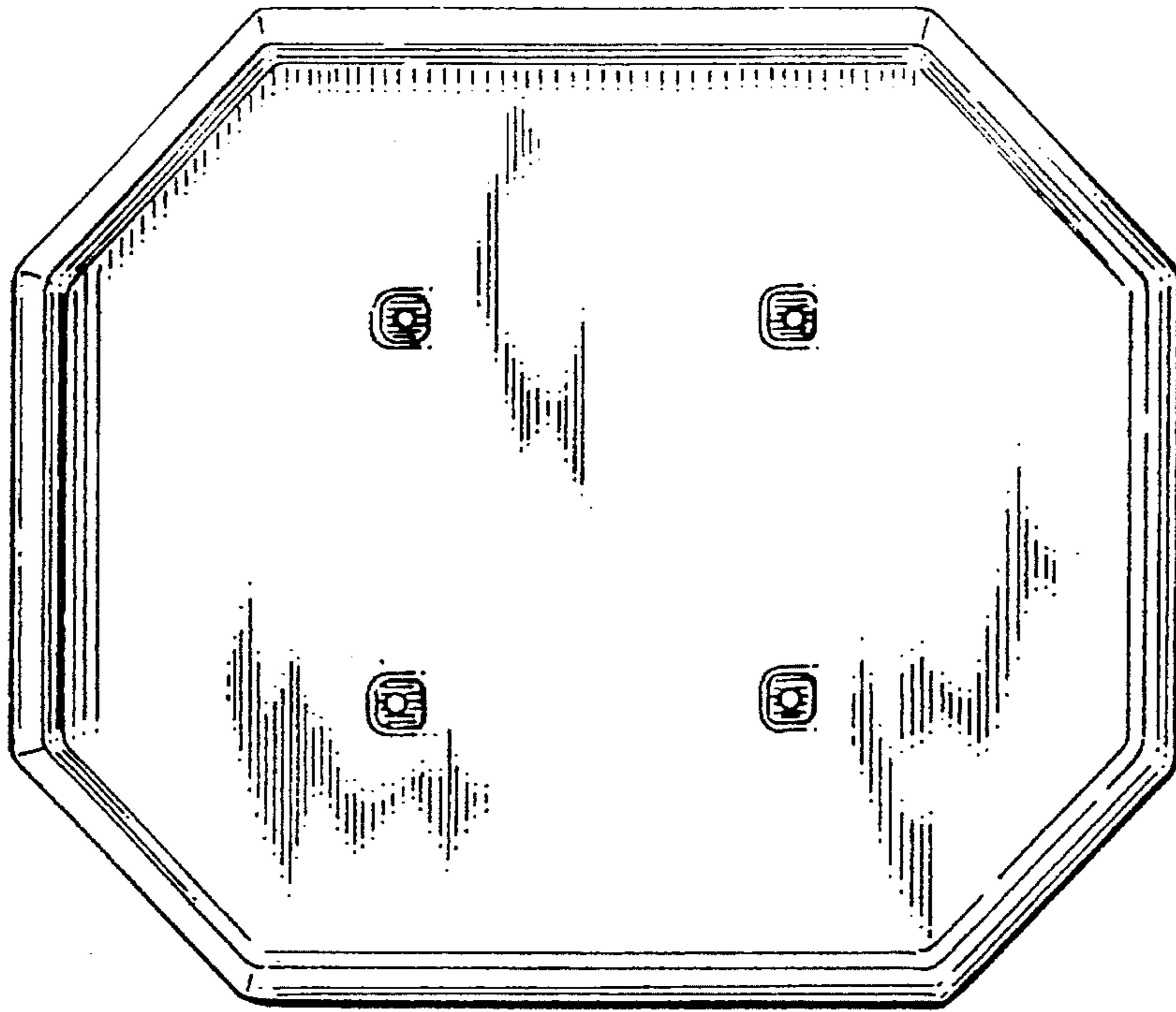

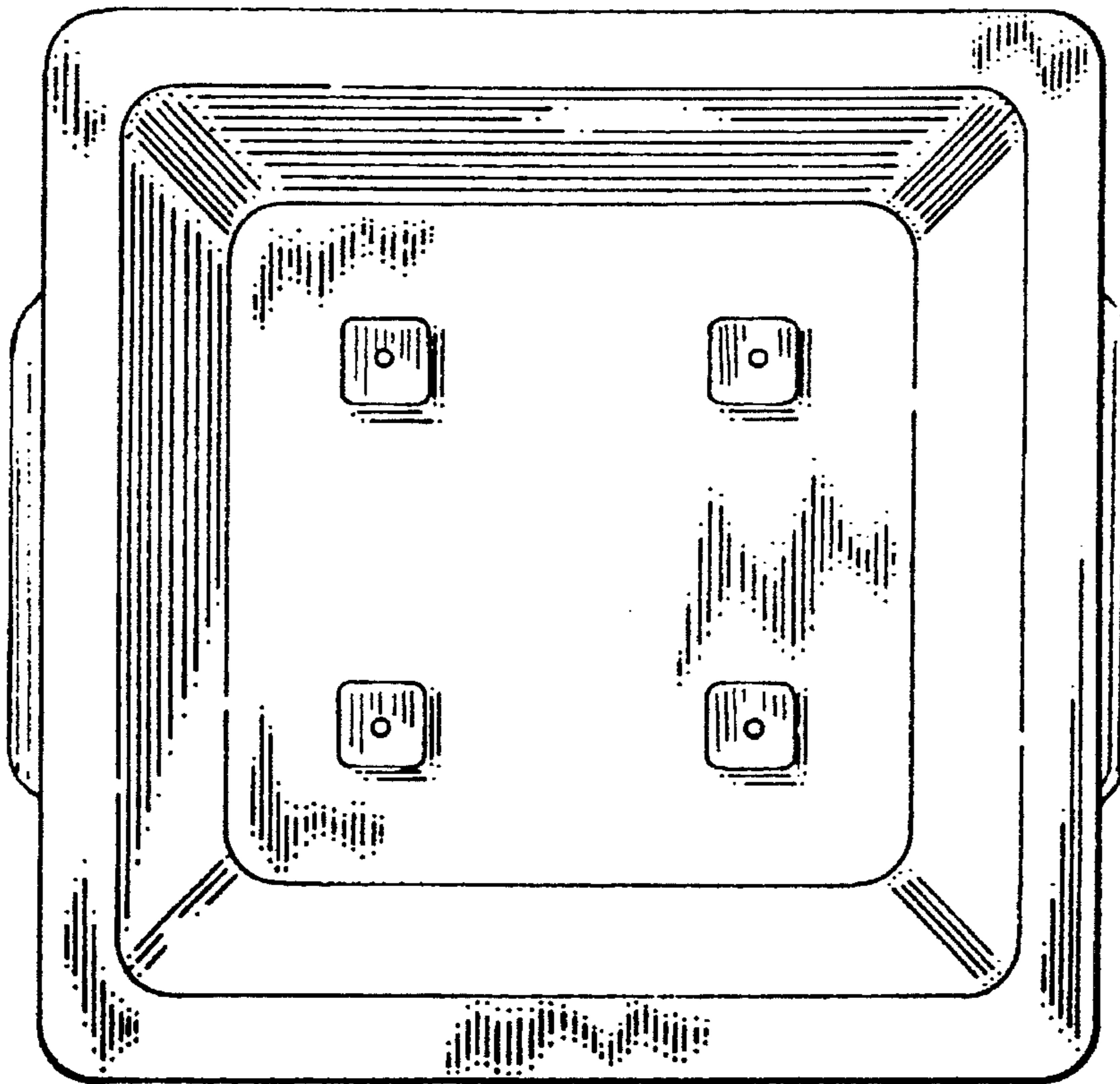

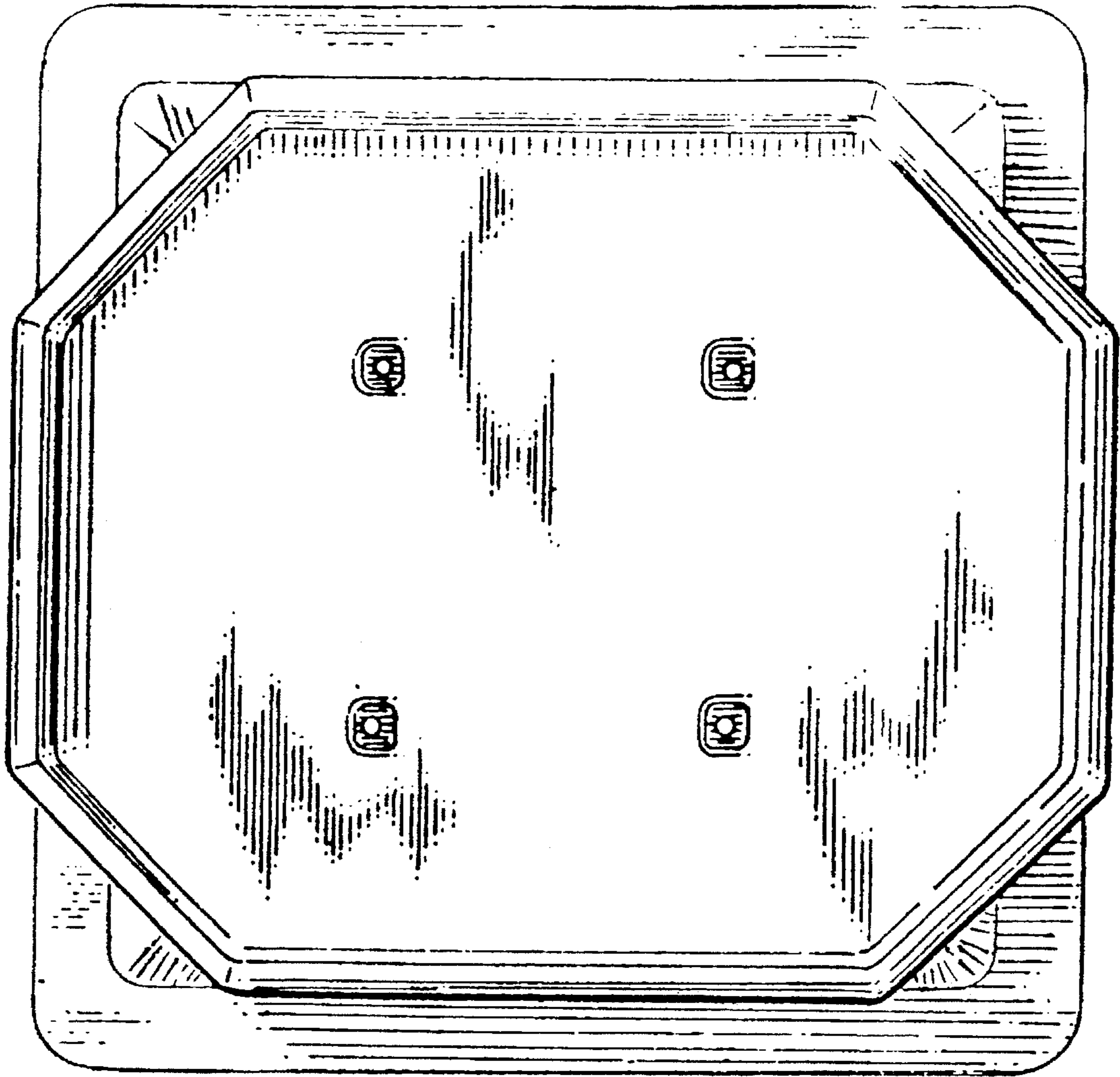
