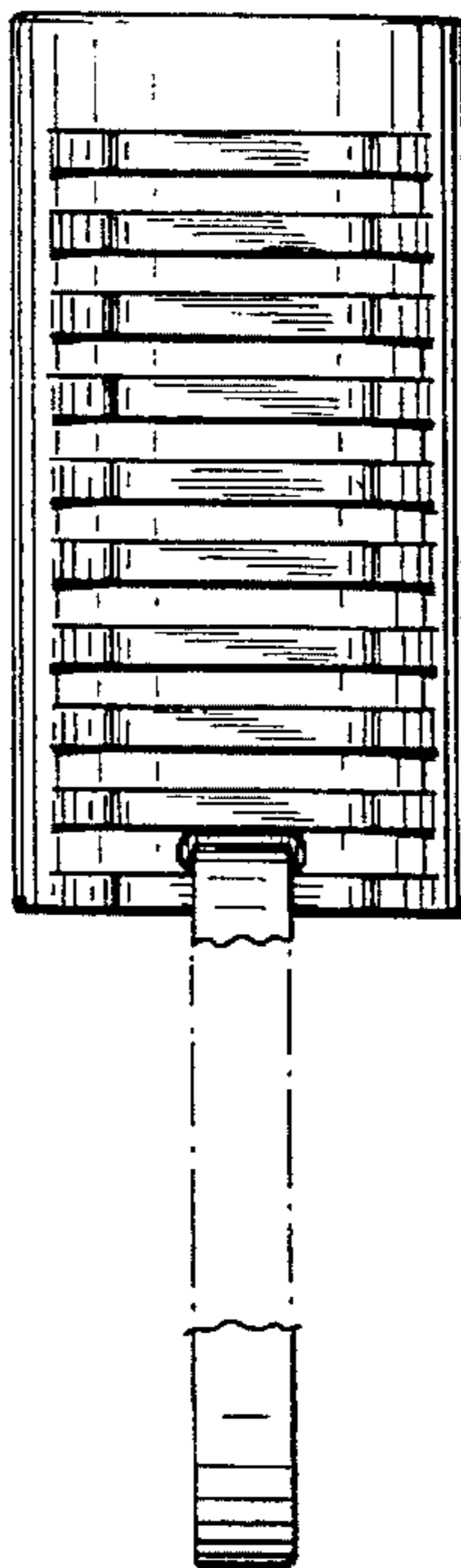
[57] **CLAIM**

The ornamental design for an umbrella handle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of one embodiment of an umbrella handle showing my new design;
 FIG. 2 is a right side elevational view of the handle shown in FIG. 1, a left side elevational view being a mirror image thereof;
 FIG. 3 is a rear elevation view of the handle shown in FIG. 1;
 FIG. 4 is a top plan view of the handle shown in FIG. 1;
 FIG. 5 is a bottom plan view of the handle shown in FIG. 1;
 FIG. 6 is a front elevational view of a second embodiment of an umbrella handle showing my new design;
 FIG. 7 is a right side elevational view of the handle shown in FIG. 6, a left side elevational view being a mirror image thereof;
 FIG. 8 is a rear elevational view of the handle shown in FIG. 6;
 FIG. 9 is a top plan view of the handle shown in FIG. 6;
 FIG. 10 is a bottom plan view of the handle shown in FIG. 6;
 FIG. 11 is a front elevational view of a third embodiment of an umbrella handle showing my new design;
 FIG. 12 is a right side elevational view of the handle shown in FIG. 11, a left side elevational view being a mirror image thereof;
 FIG. 13 is a rear elevational view of the handle shown in FIG. 11;
 FIG. 14 is a top plan view of the handle shown in FIG. 11;

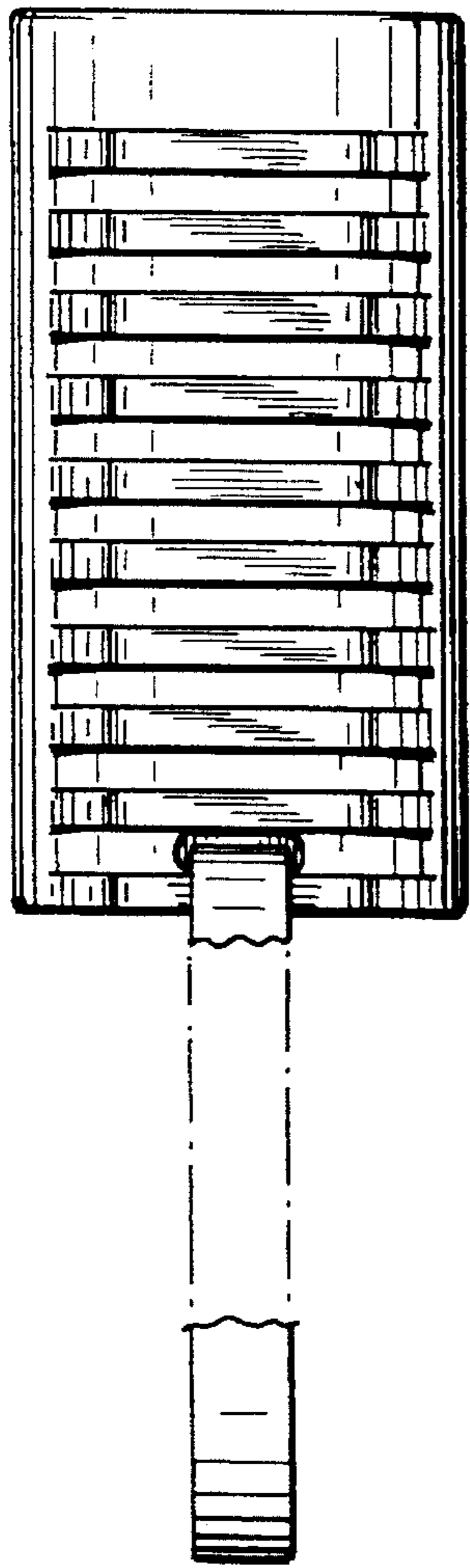

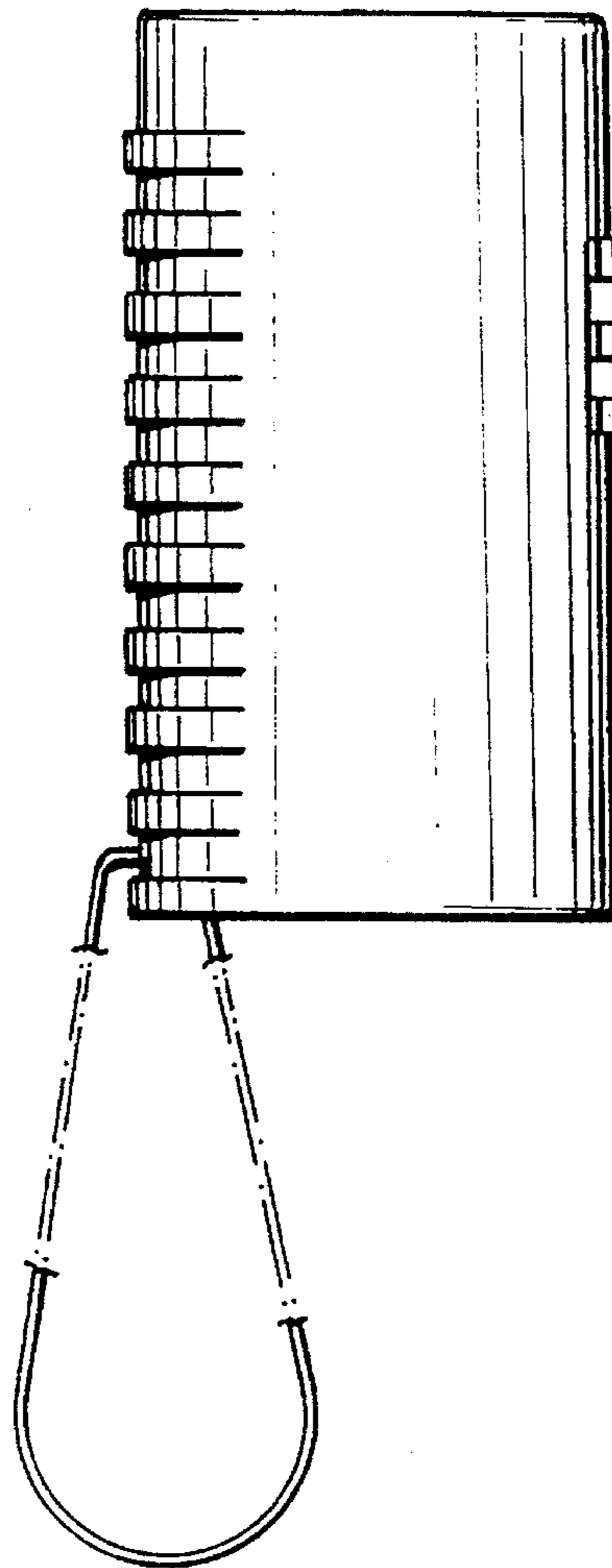

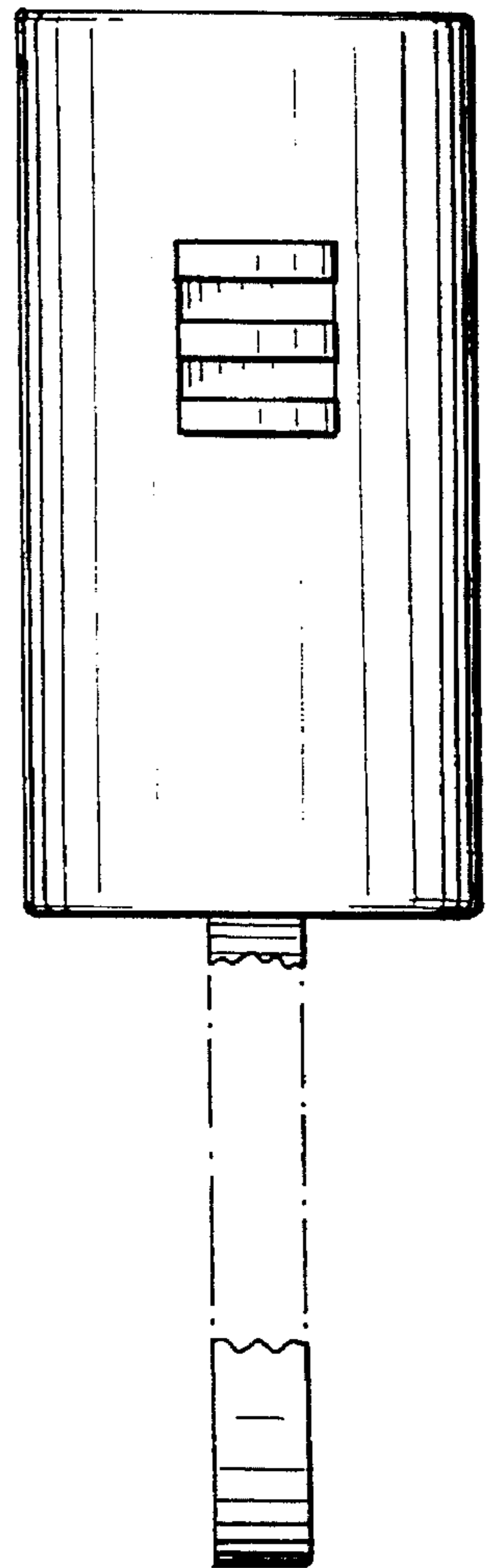

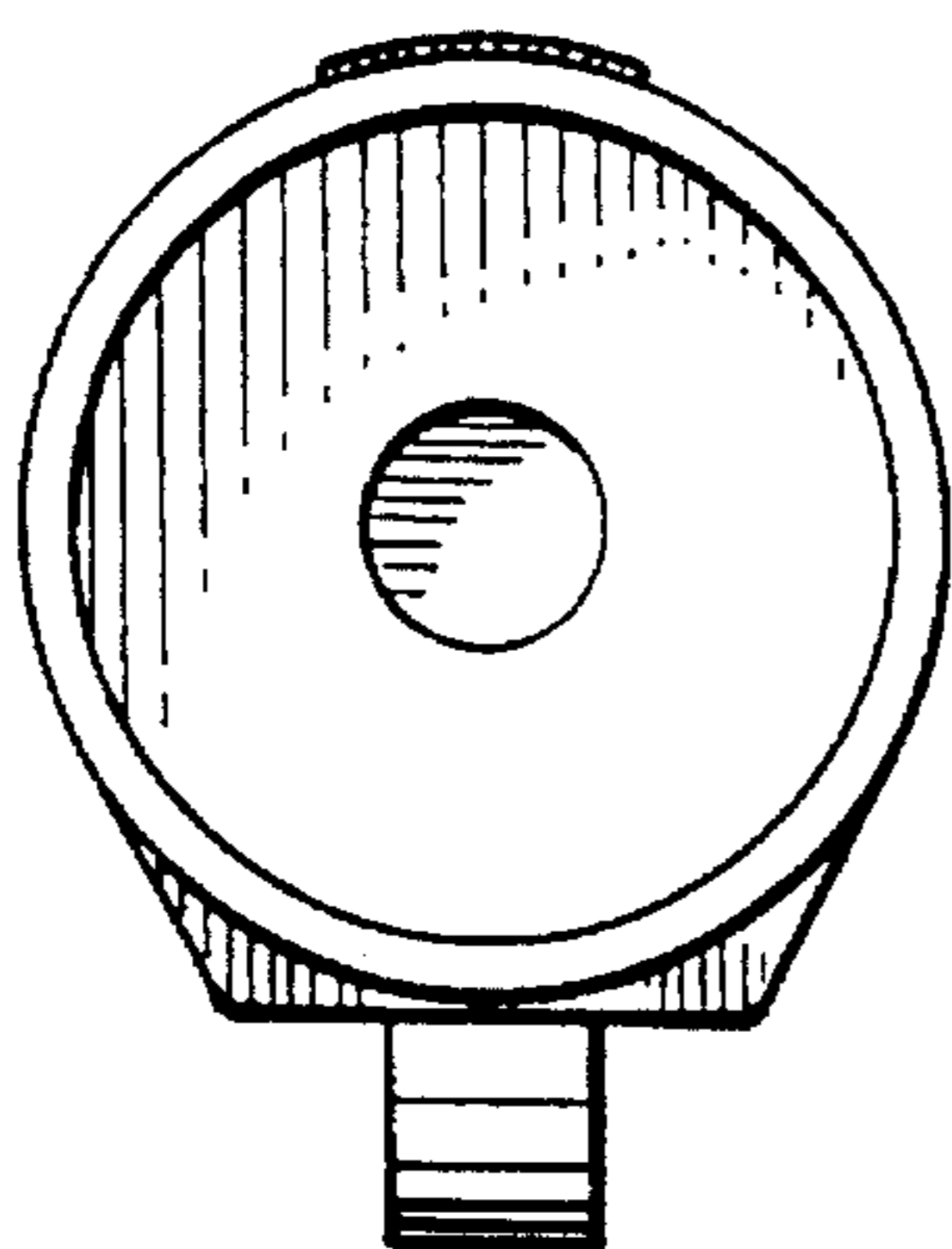

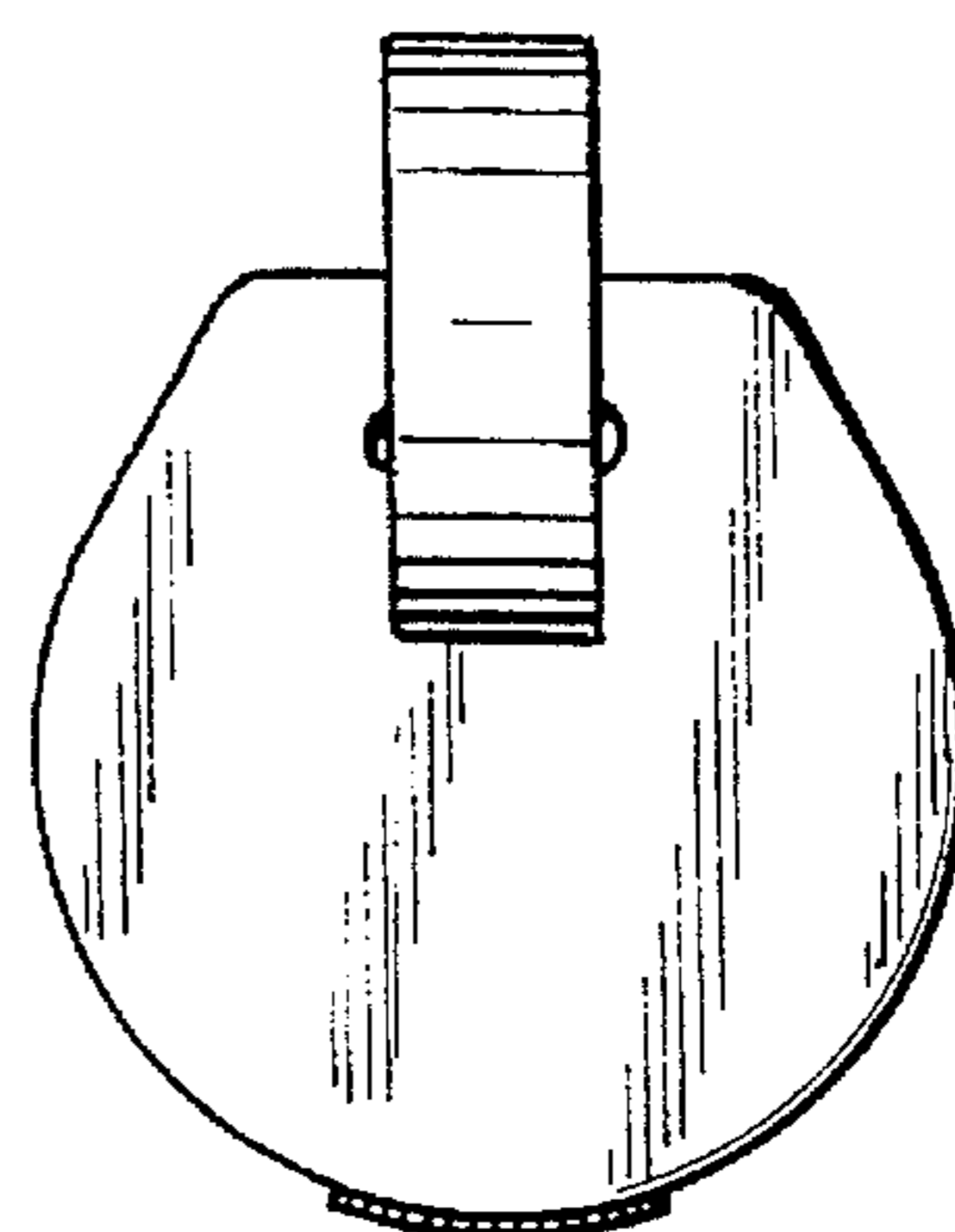

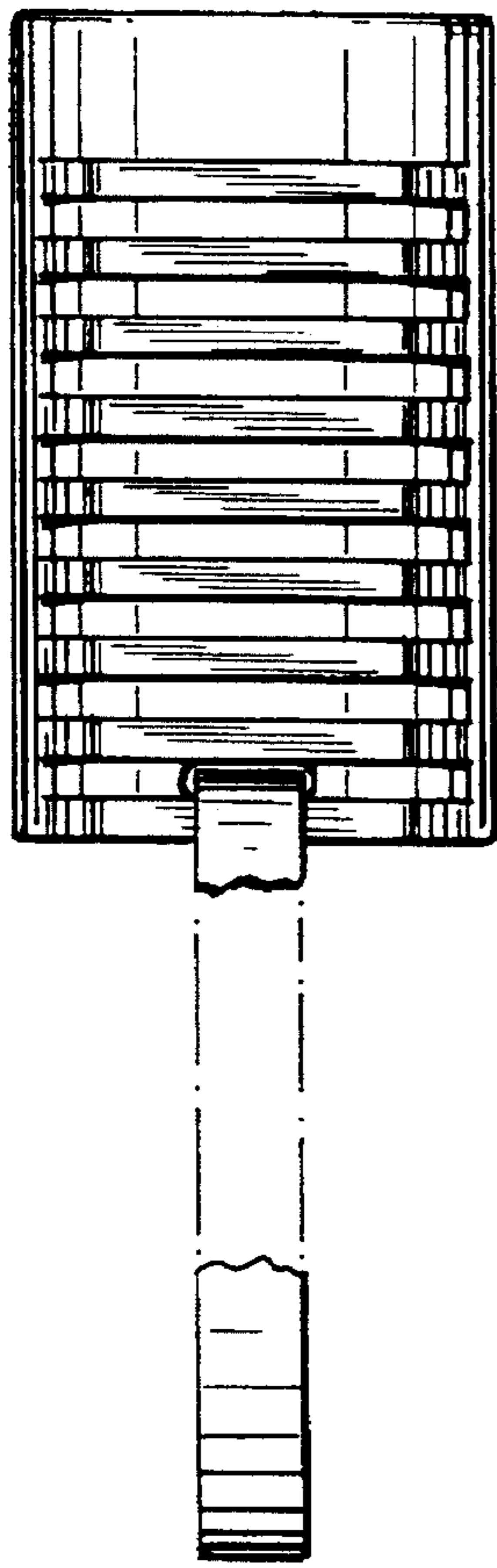

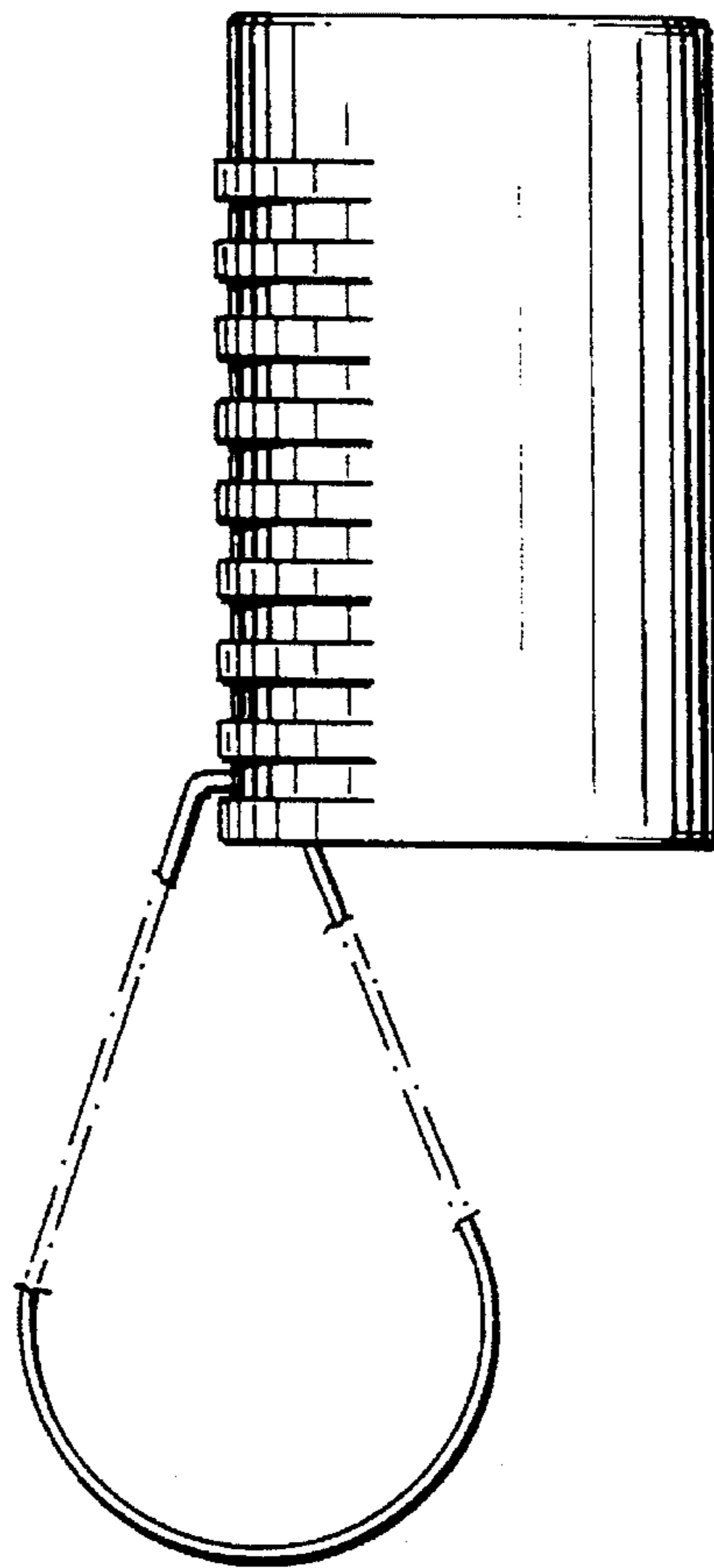

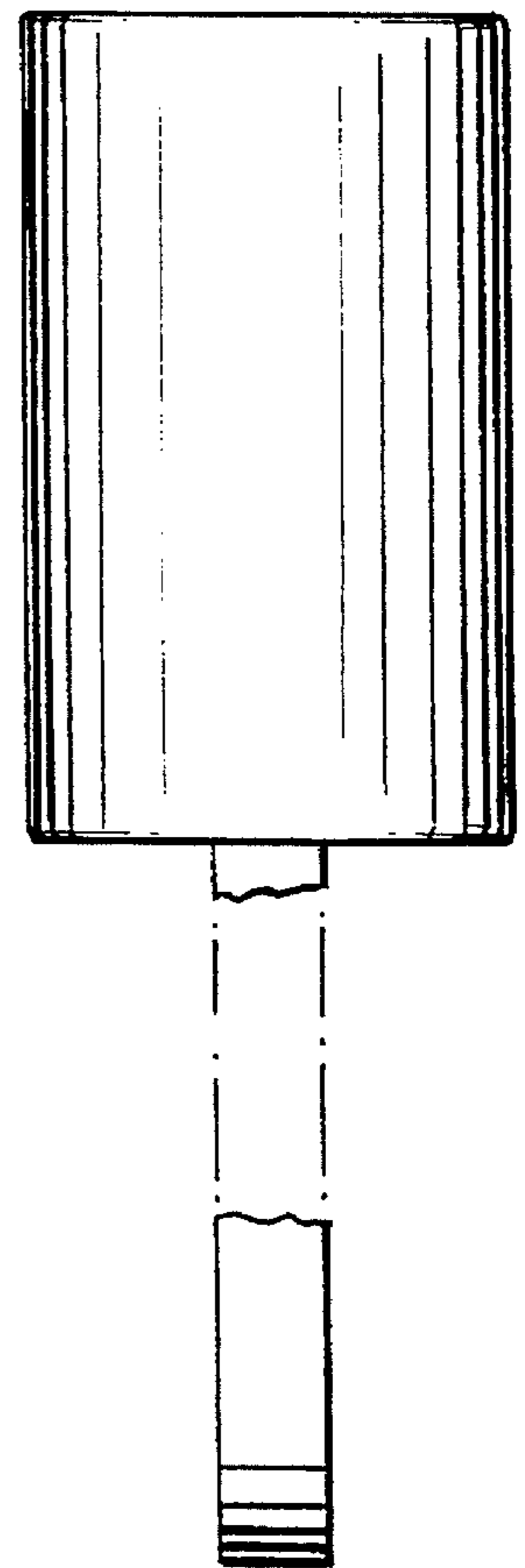

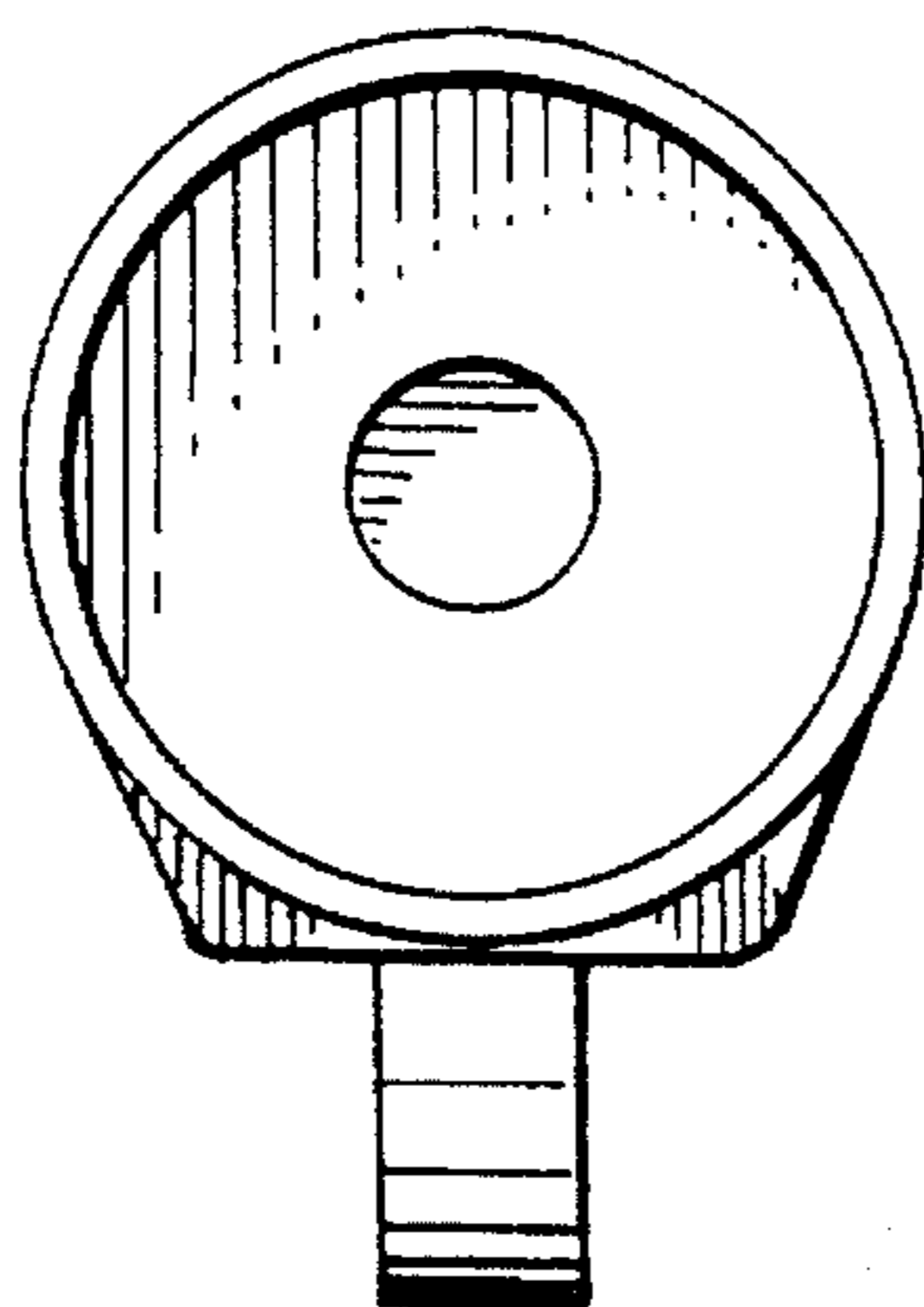

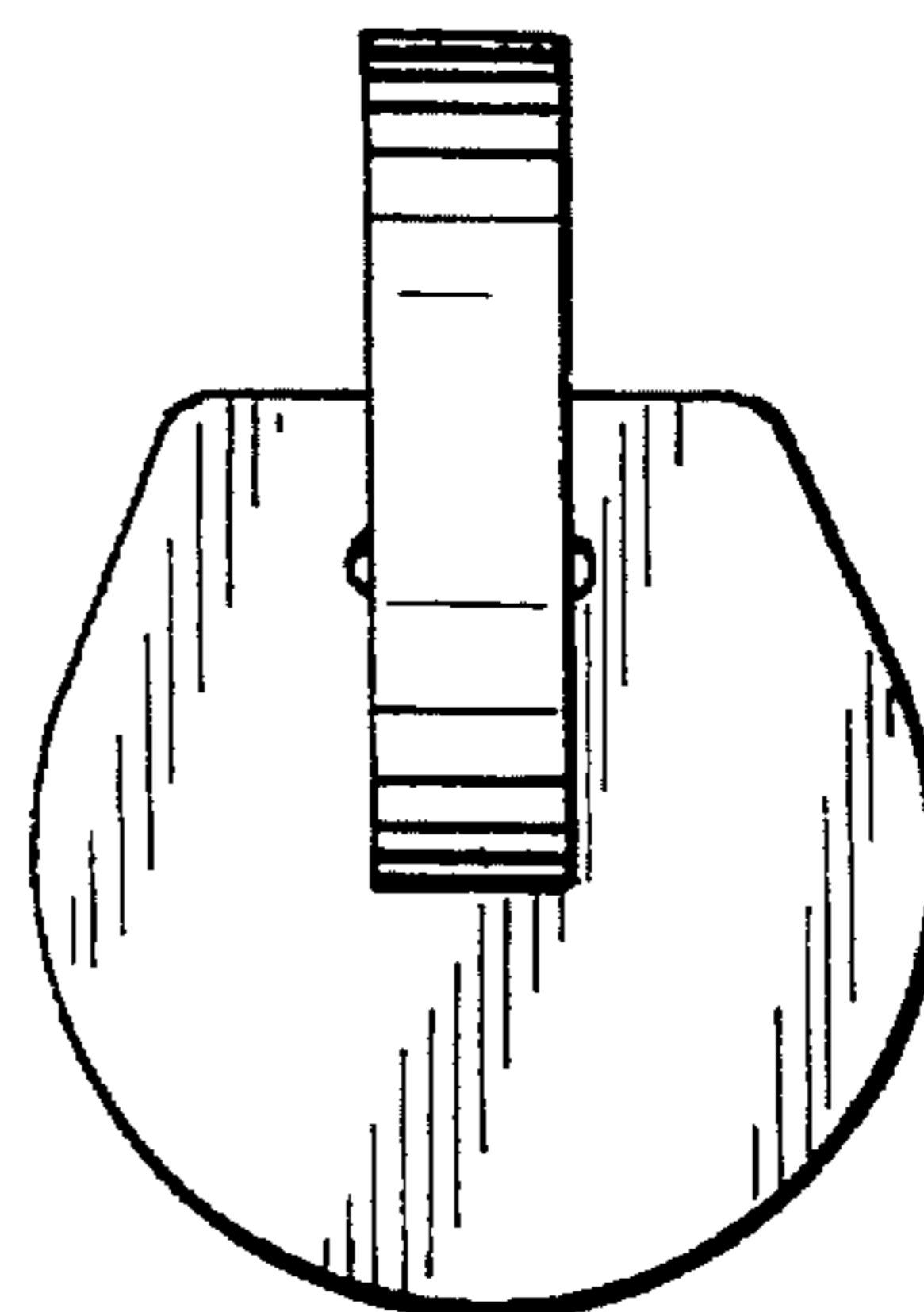

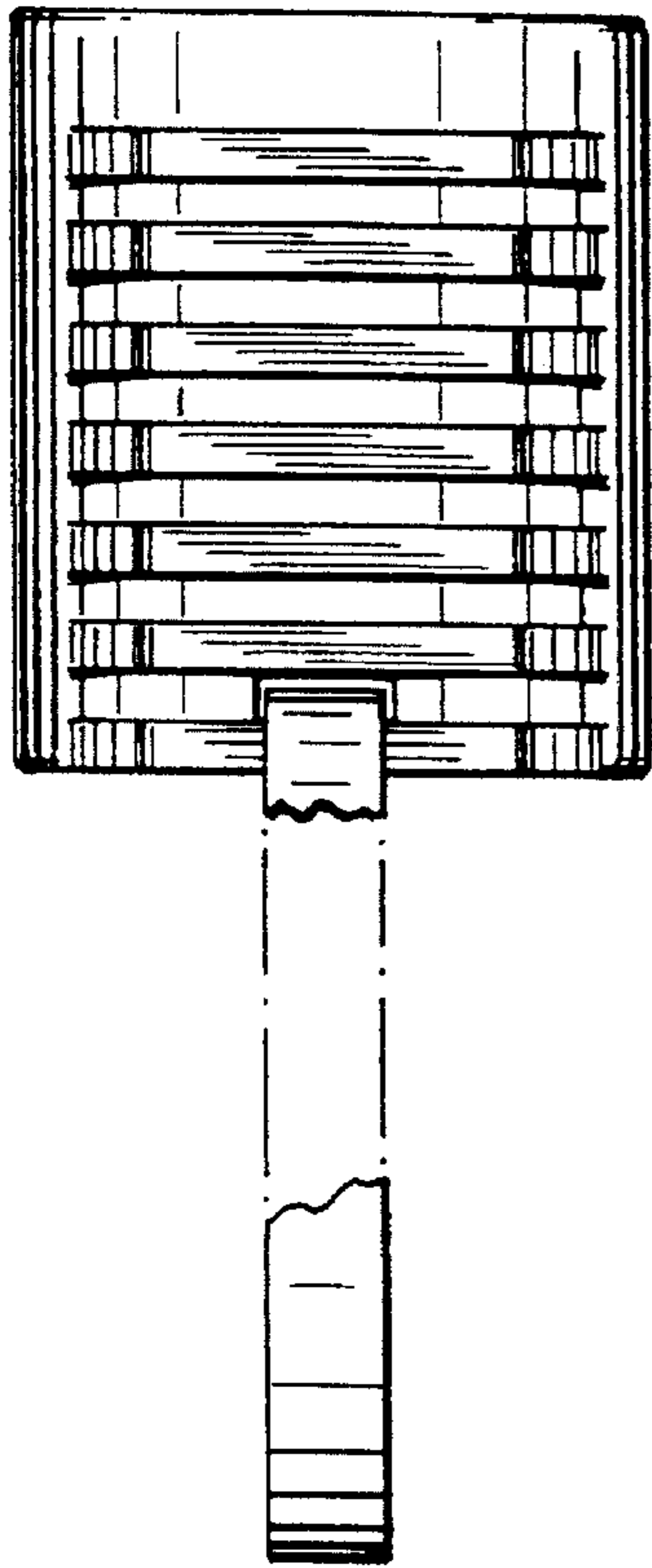

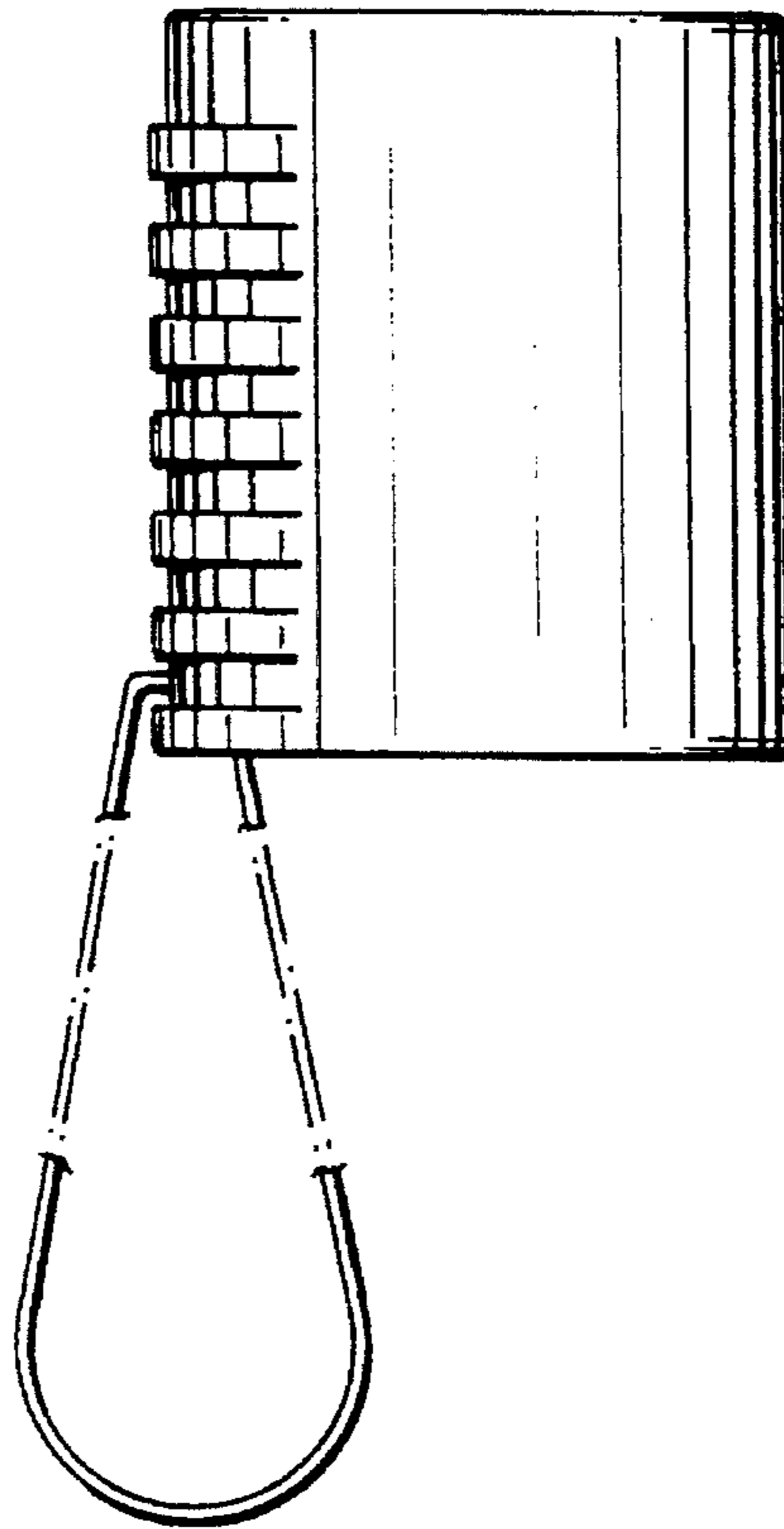

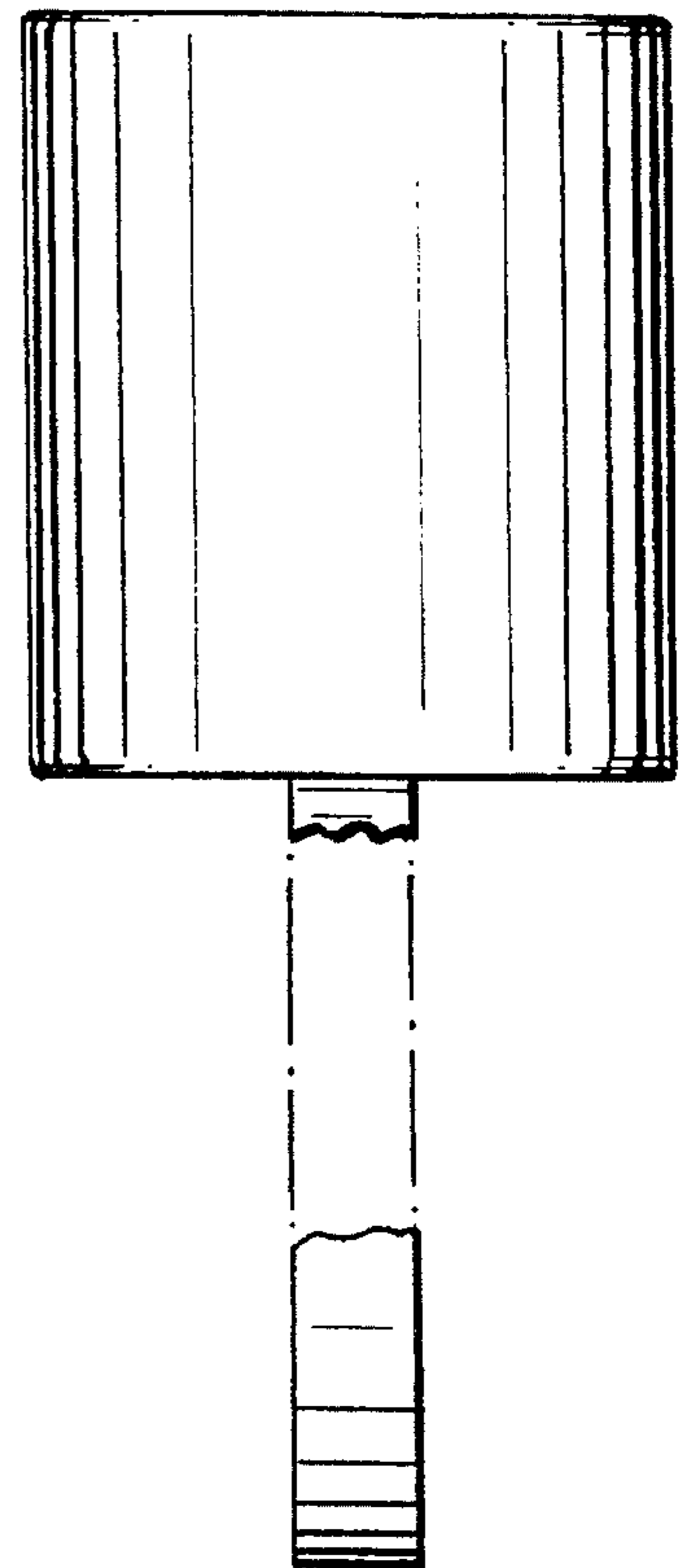

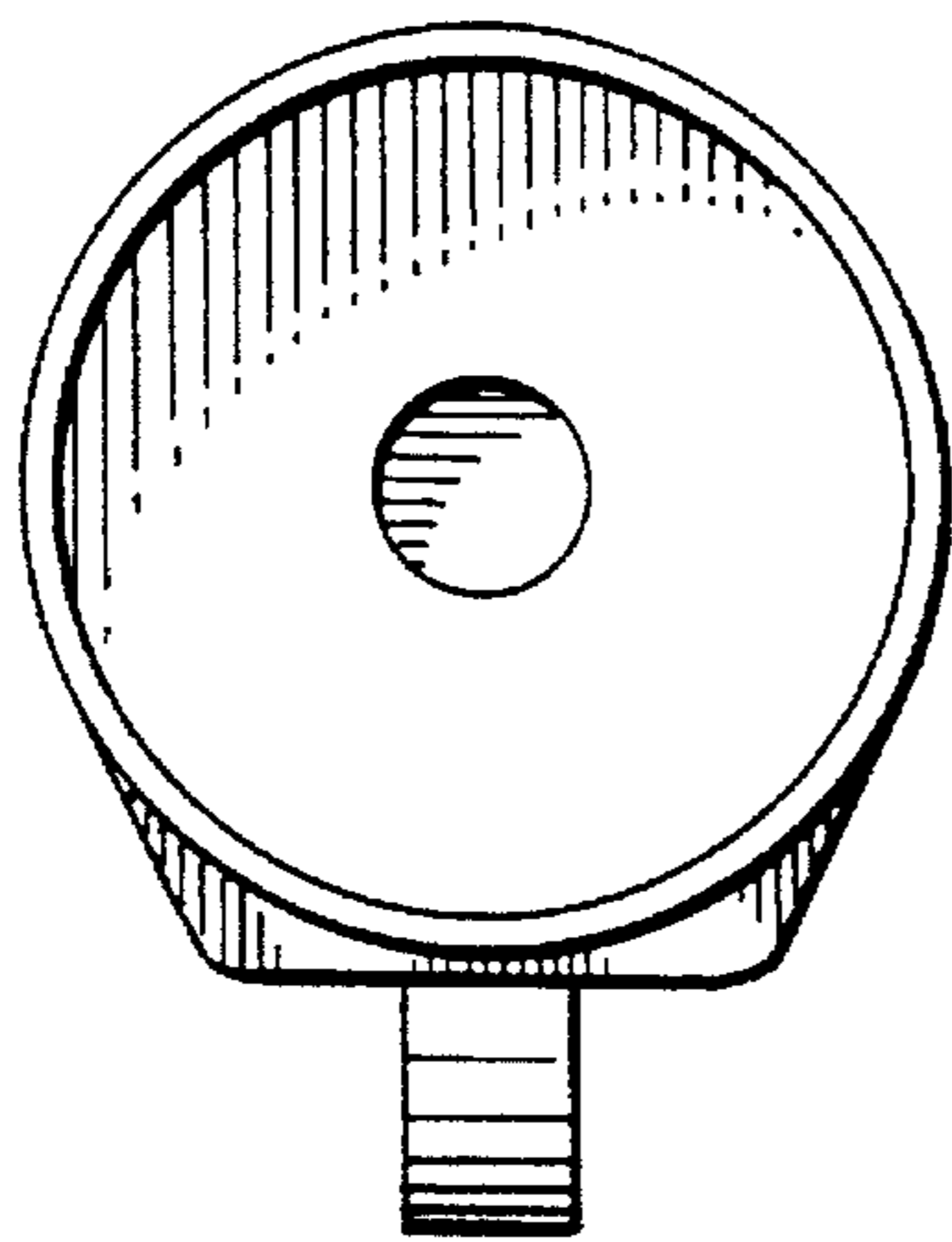

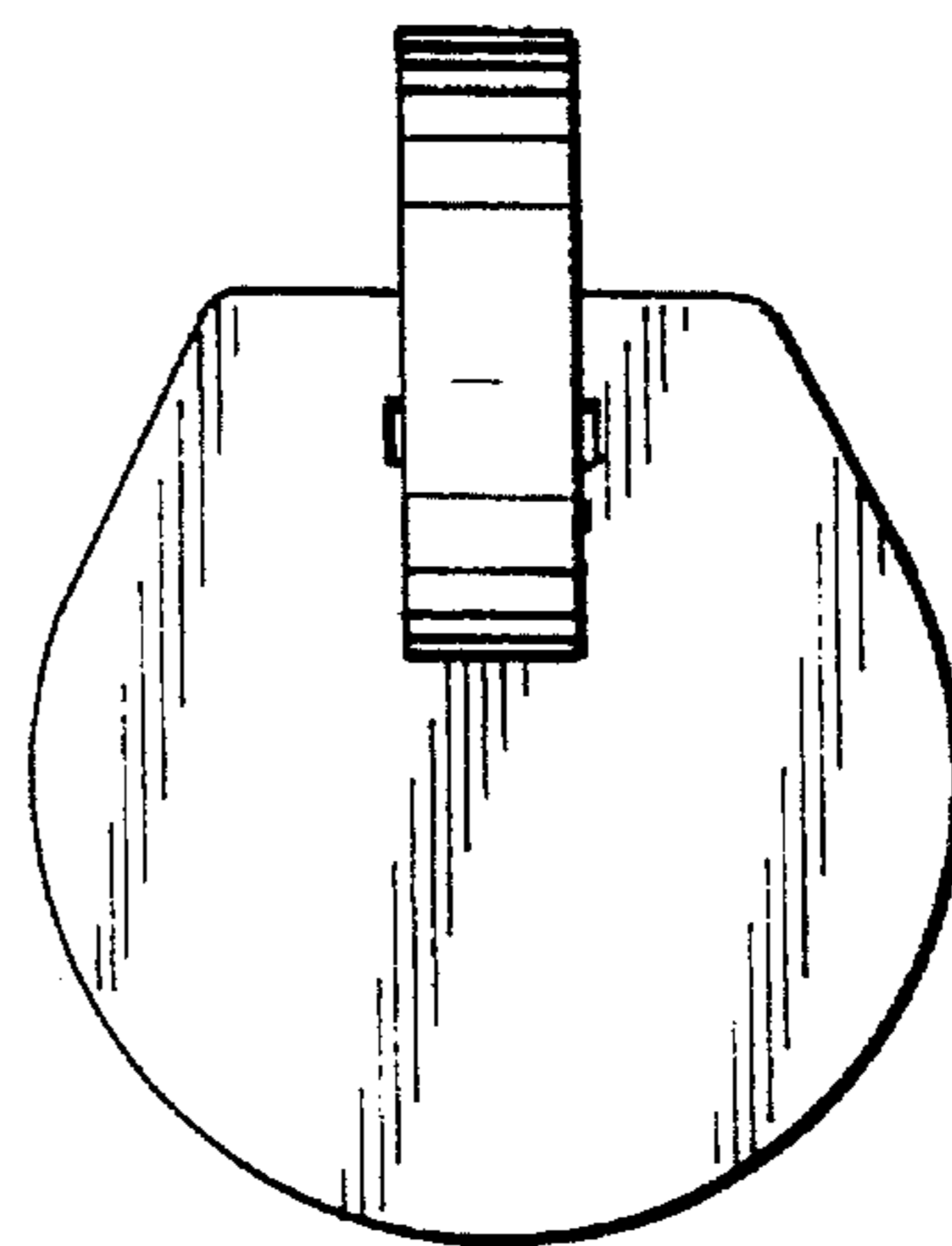
